The ornamental design for a vehicle undercarriage spray wand, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vehicle undercarriage spray wand showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

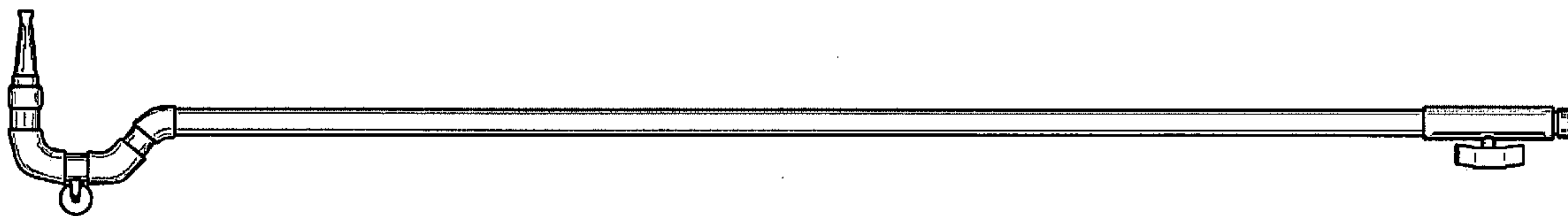
FIG. 4 is a side view thereof;

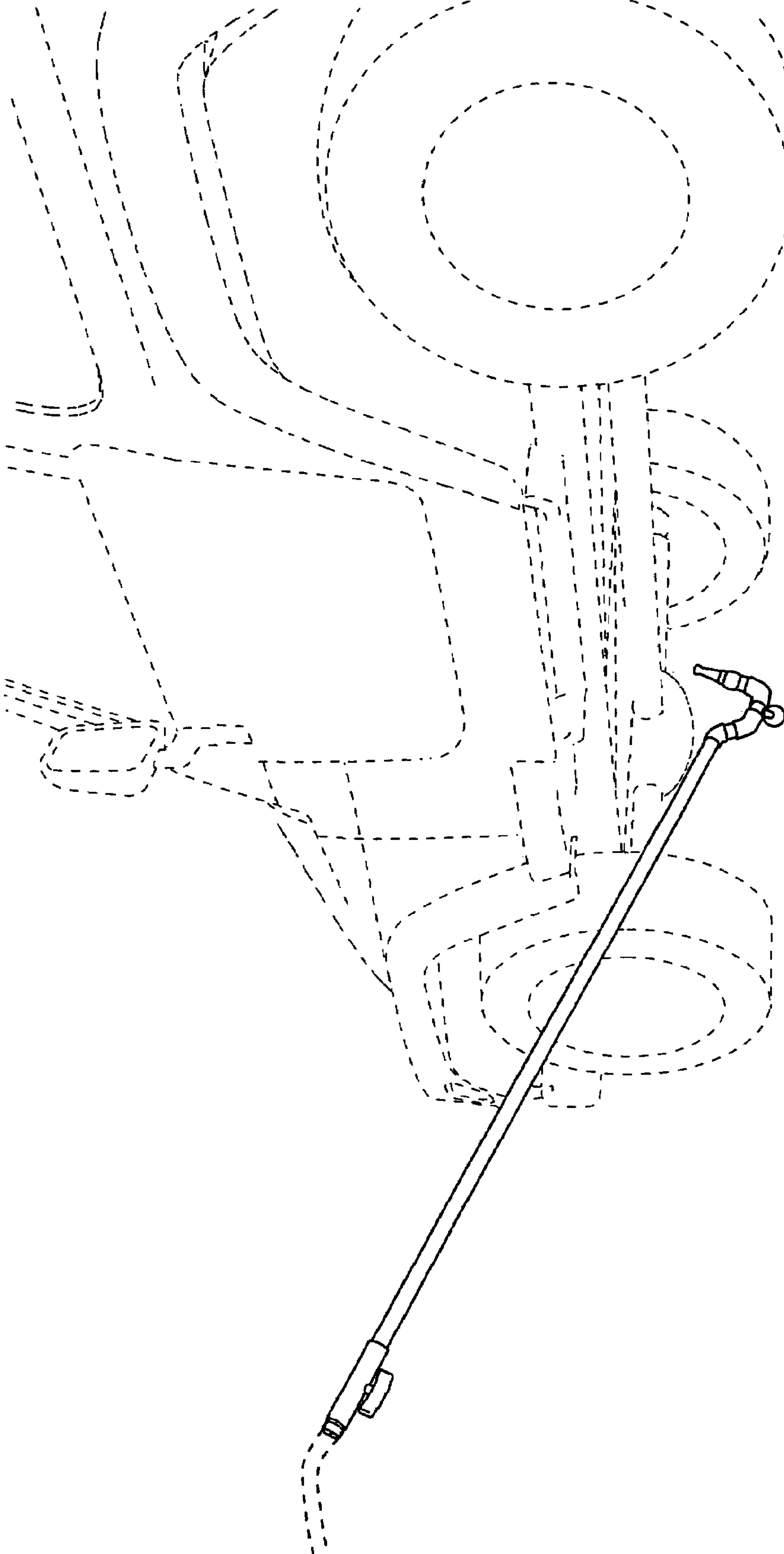

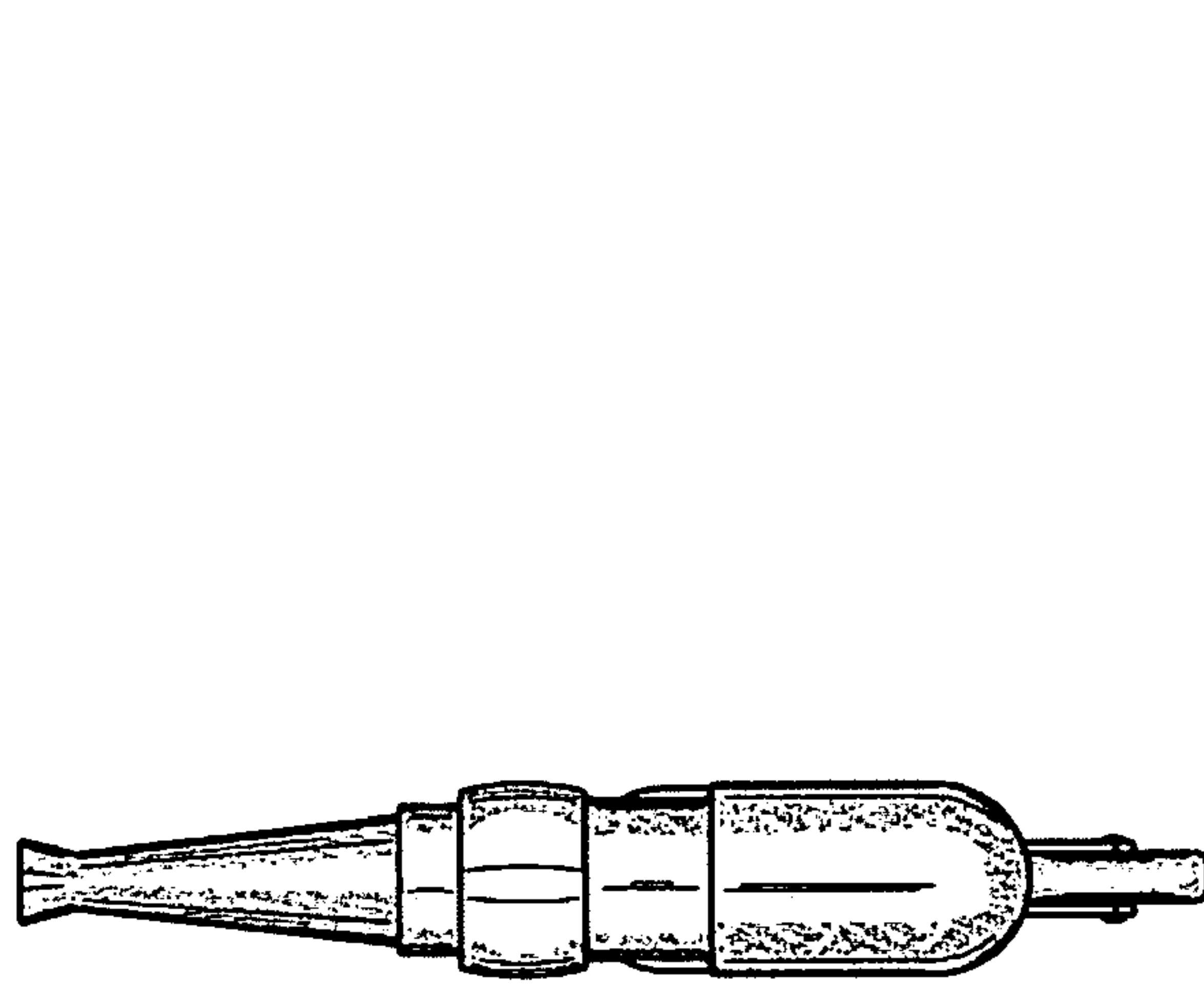

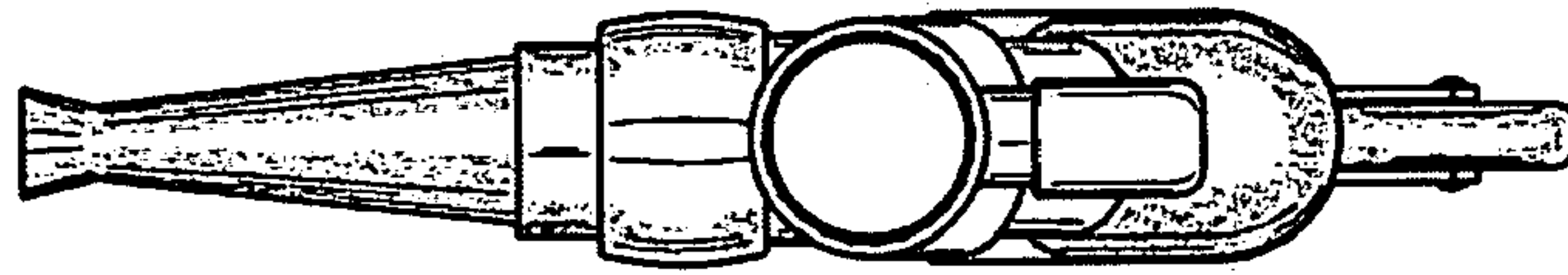

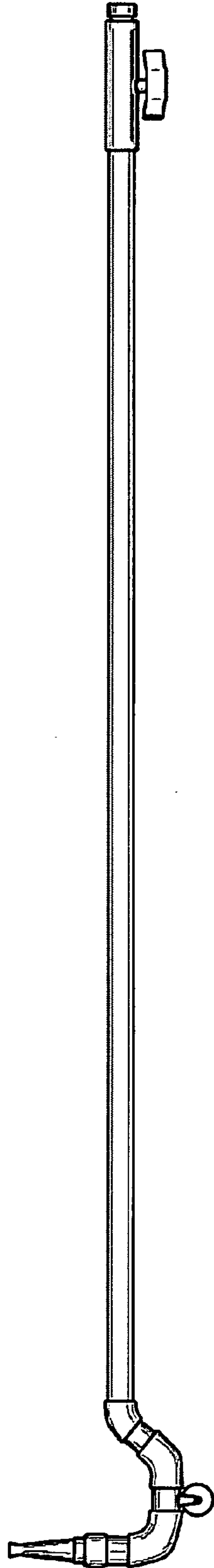

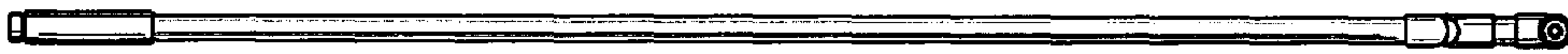
