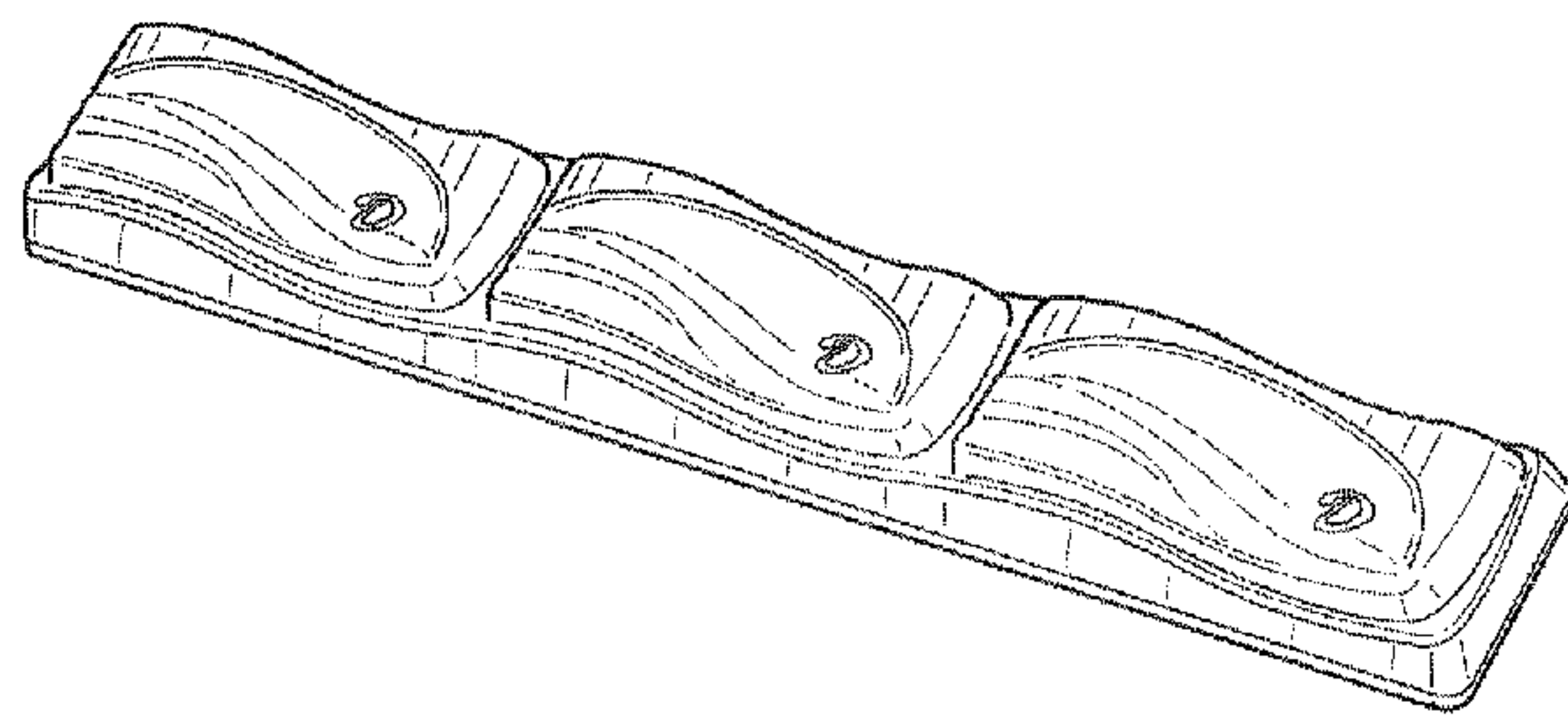
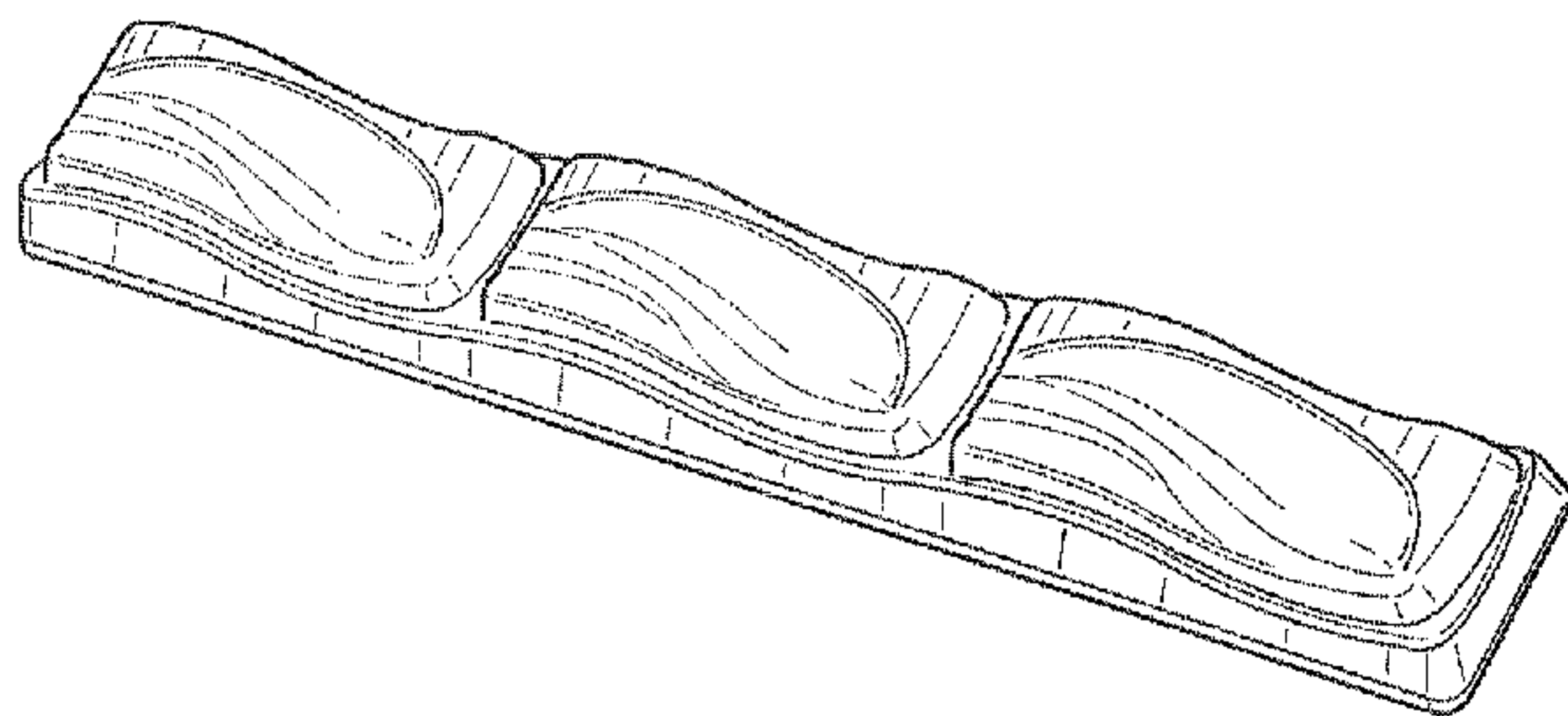
(57) **CLAIM**

The ornamental design for a chocolate bar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a chocolate bar showing our new design, according to a first embodiment;
FIG. 2 is a top view of the design shown in FIG. 1;
FIG. 3 is a bottom view of the design shown in FIG. 1;
FIG. 4 is a front view of the design shown in FIG. 1;
FIG. 5 is a rear view of the design shown in FIG. 1;

FIG. 8 is a perspective view of a chocolate bar showing our new design, according to a second embodiment;

FIG. 10 is a perspective view of a chocolate bar showing our new design, according to a third embodiment;

FIG. 19 is a front view of the design shown in FIG. 17, the bottom, rear, left and right views being identical to those in FIGS. 12 and 14-16, respectively.

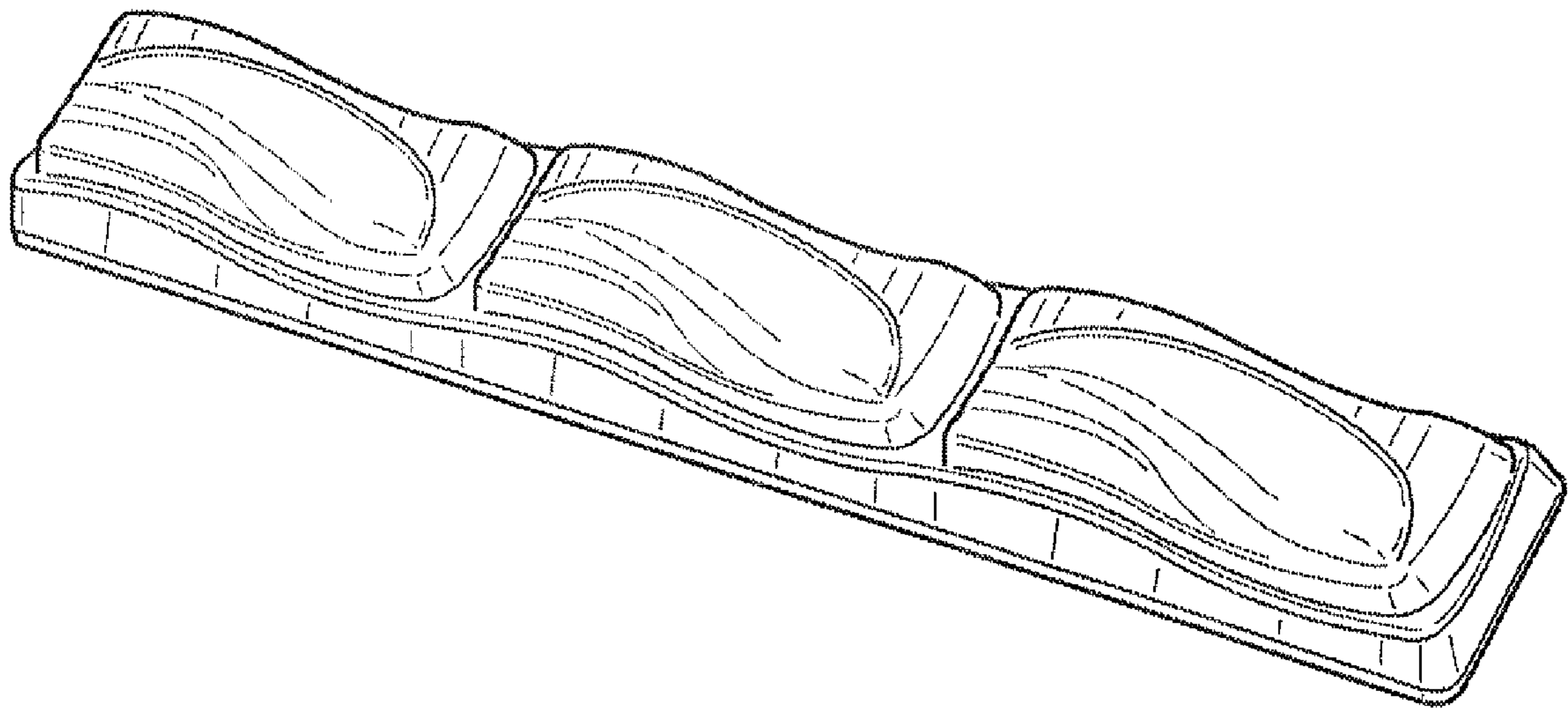

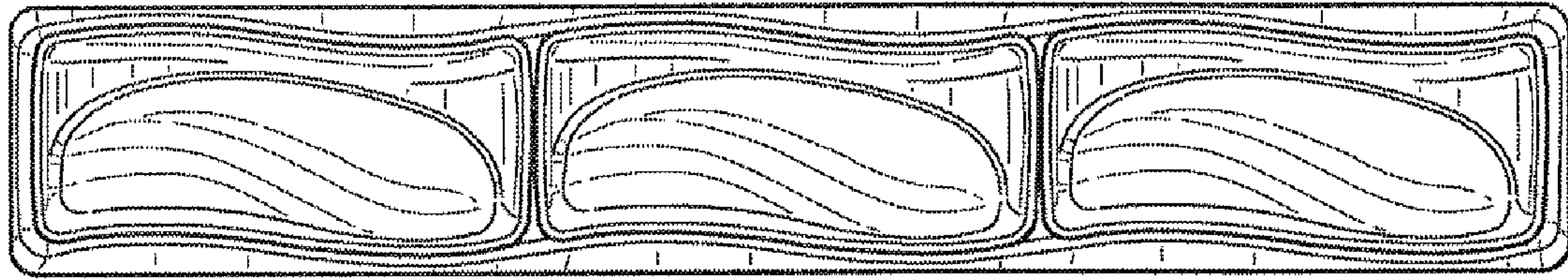

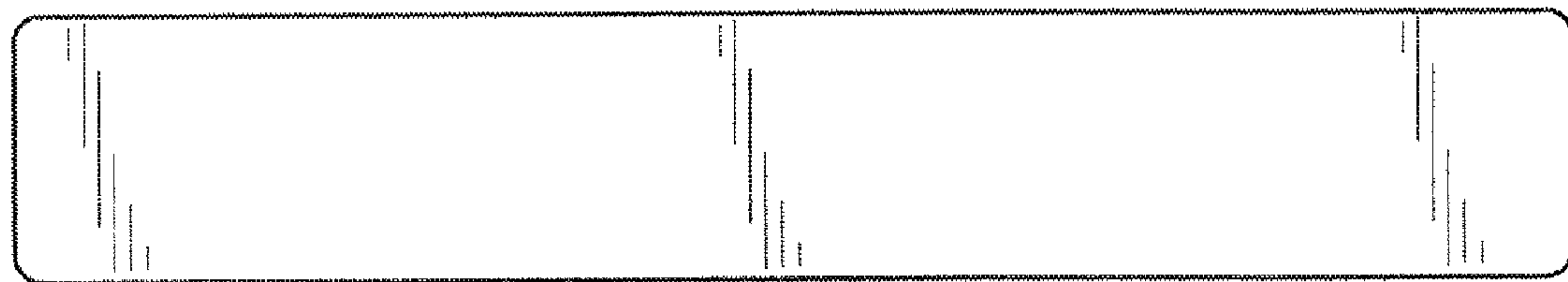

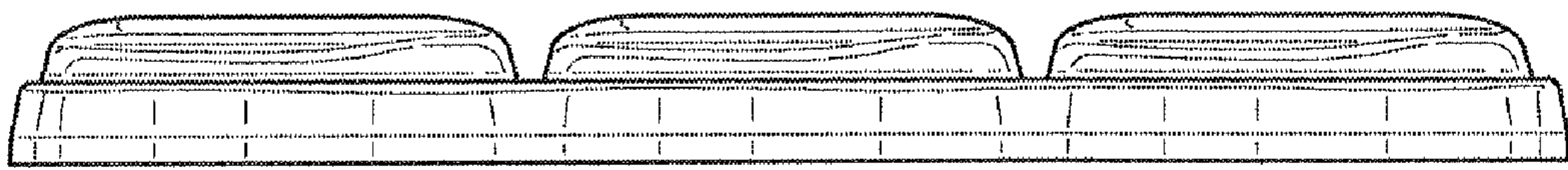

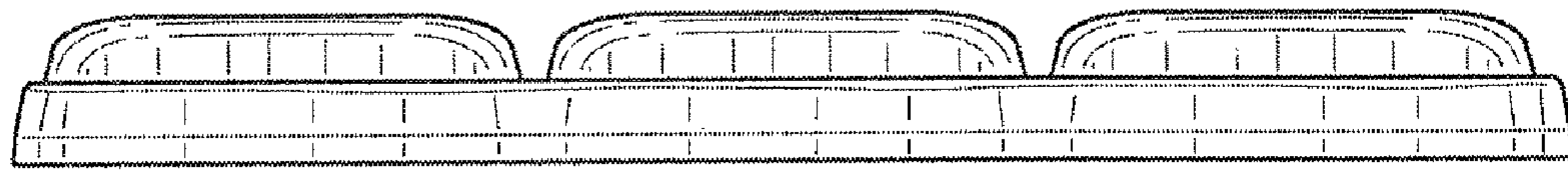

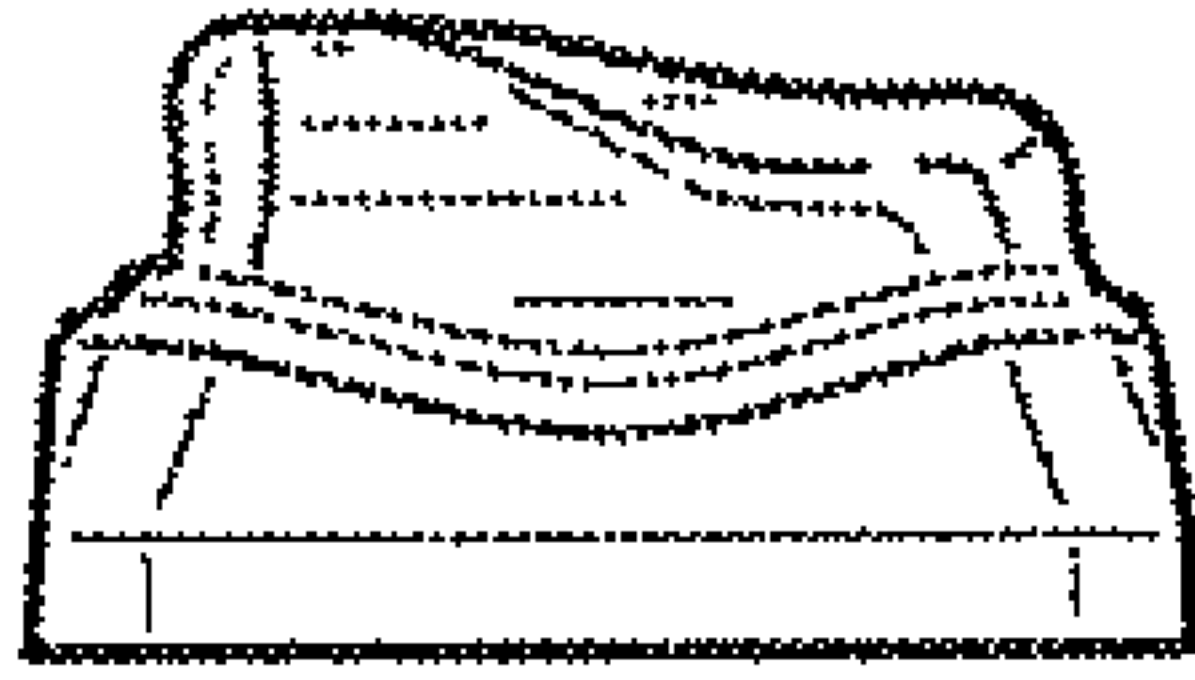

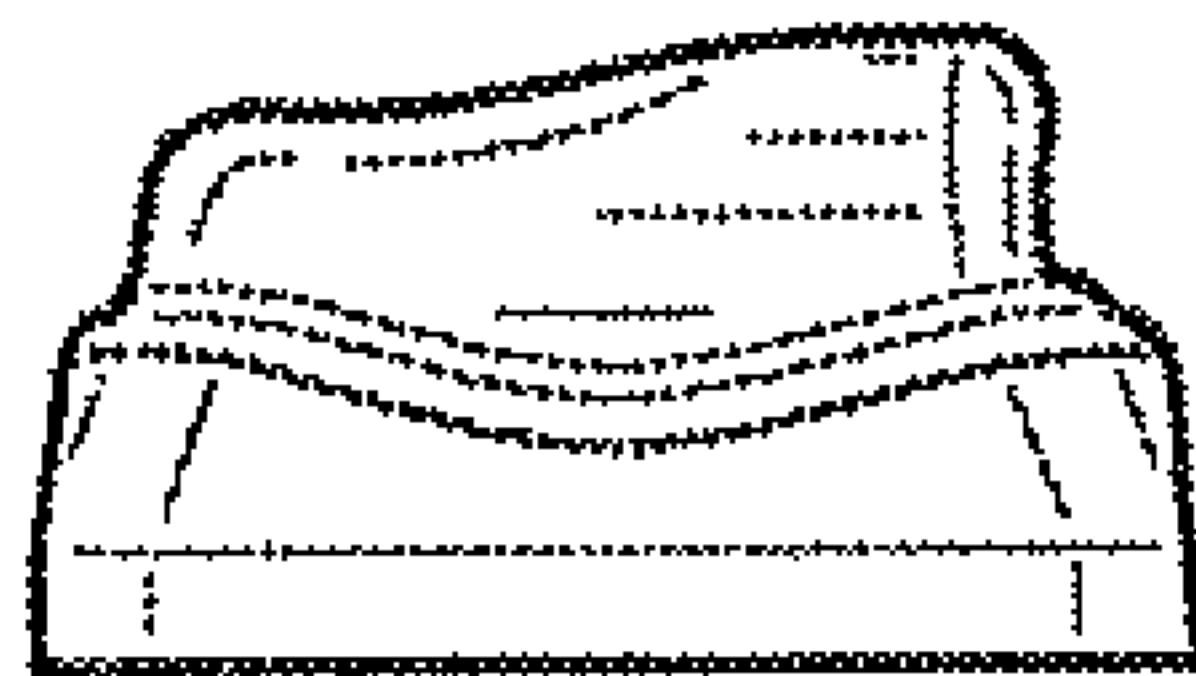

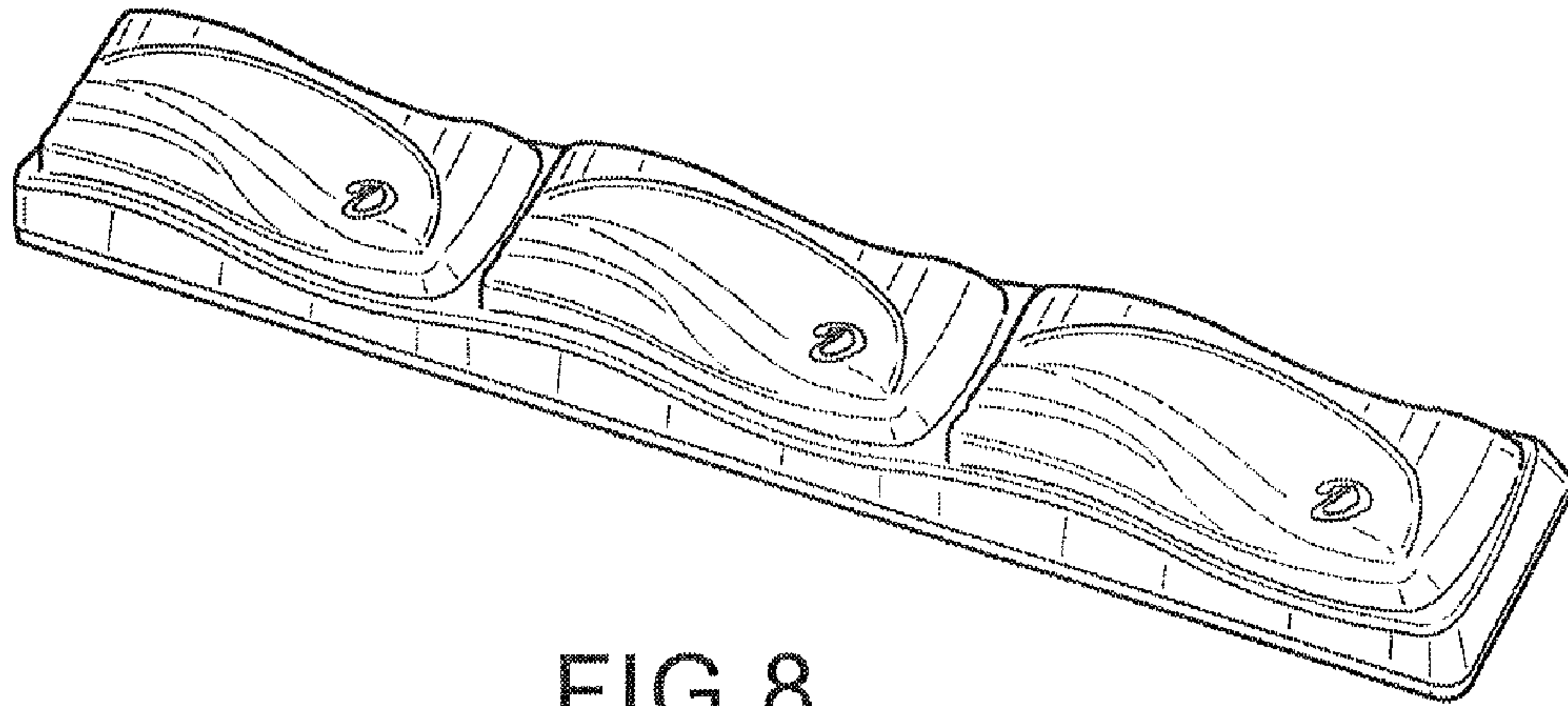

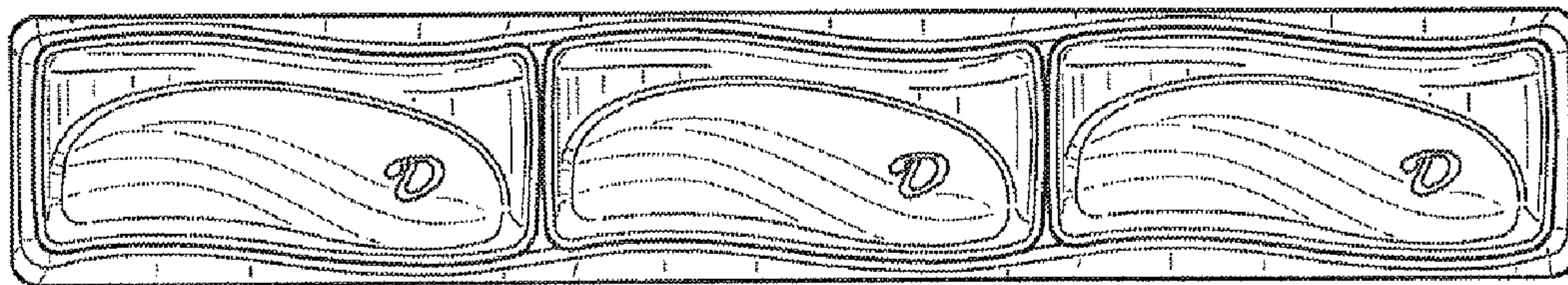

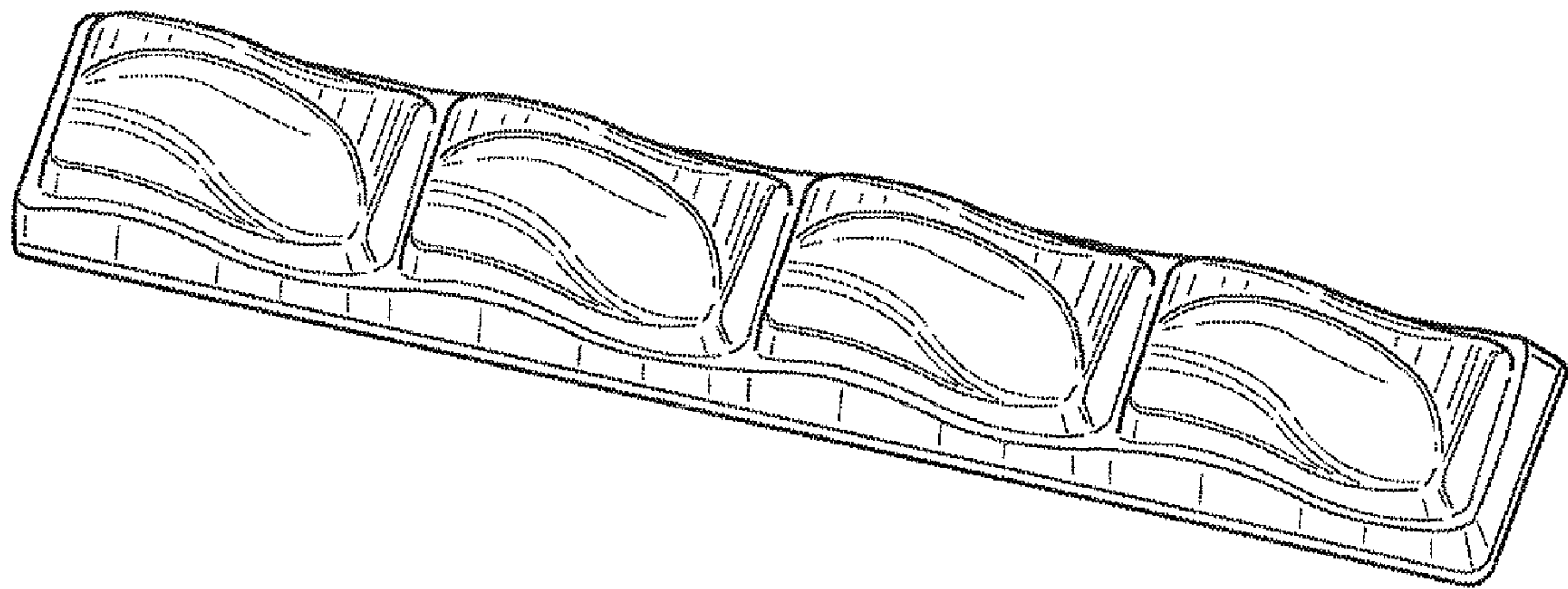

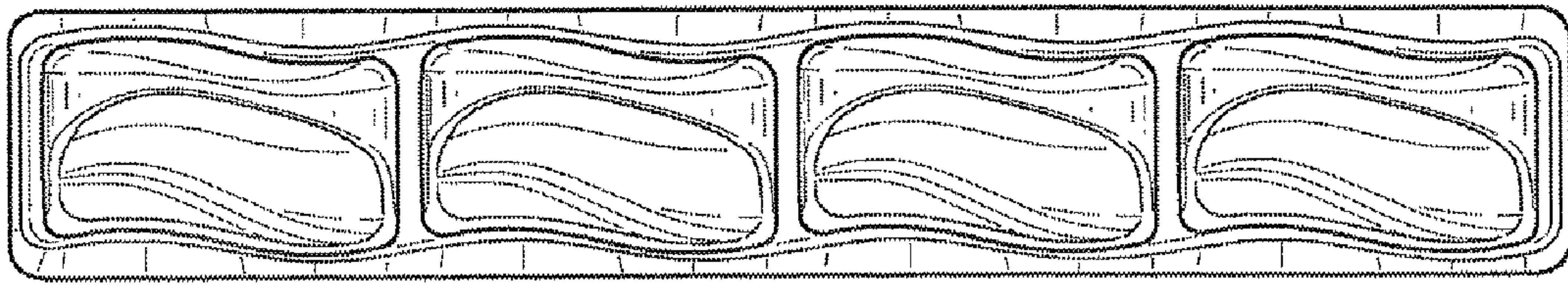

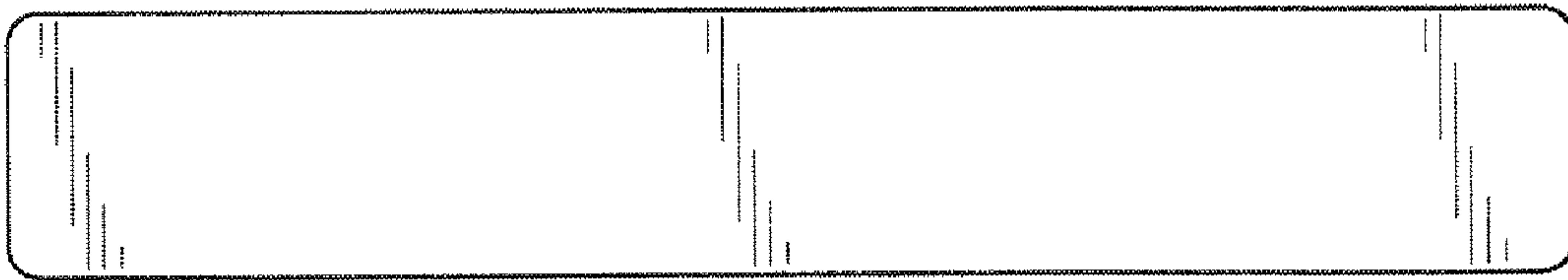

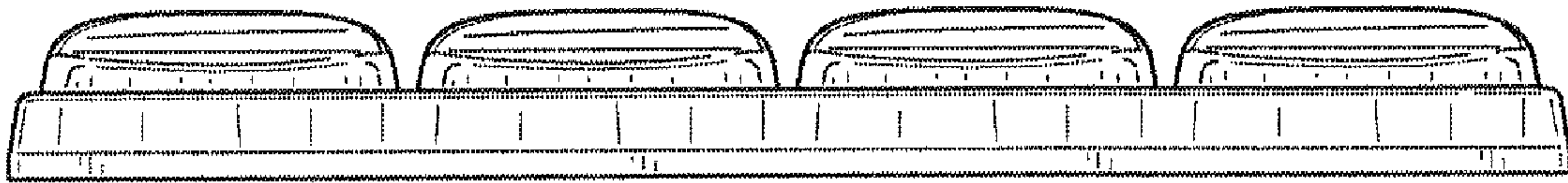

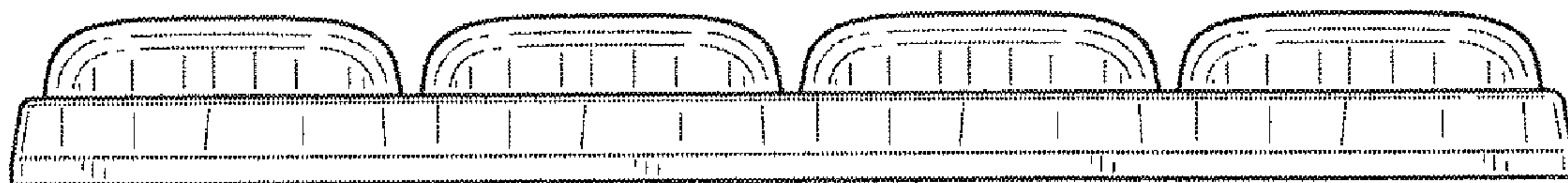

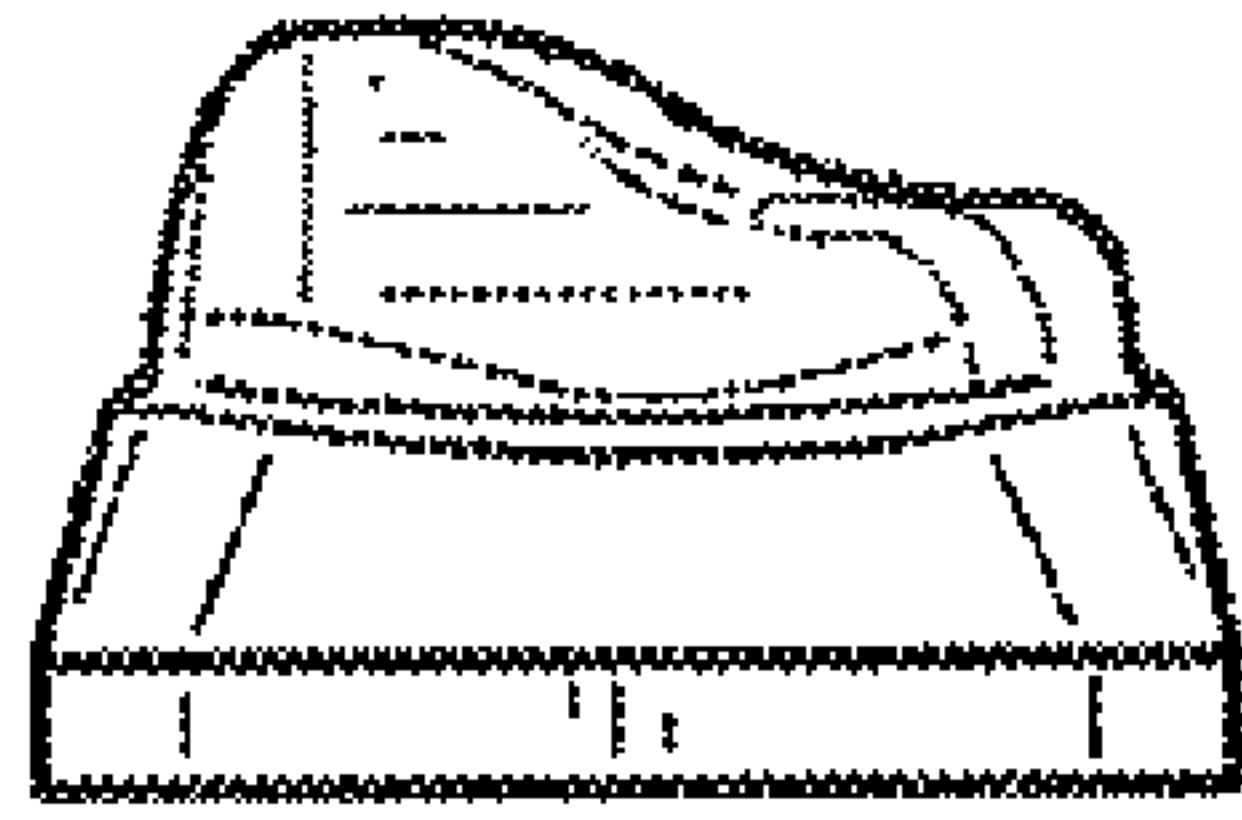

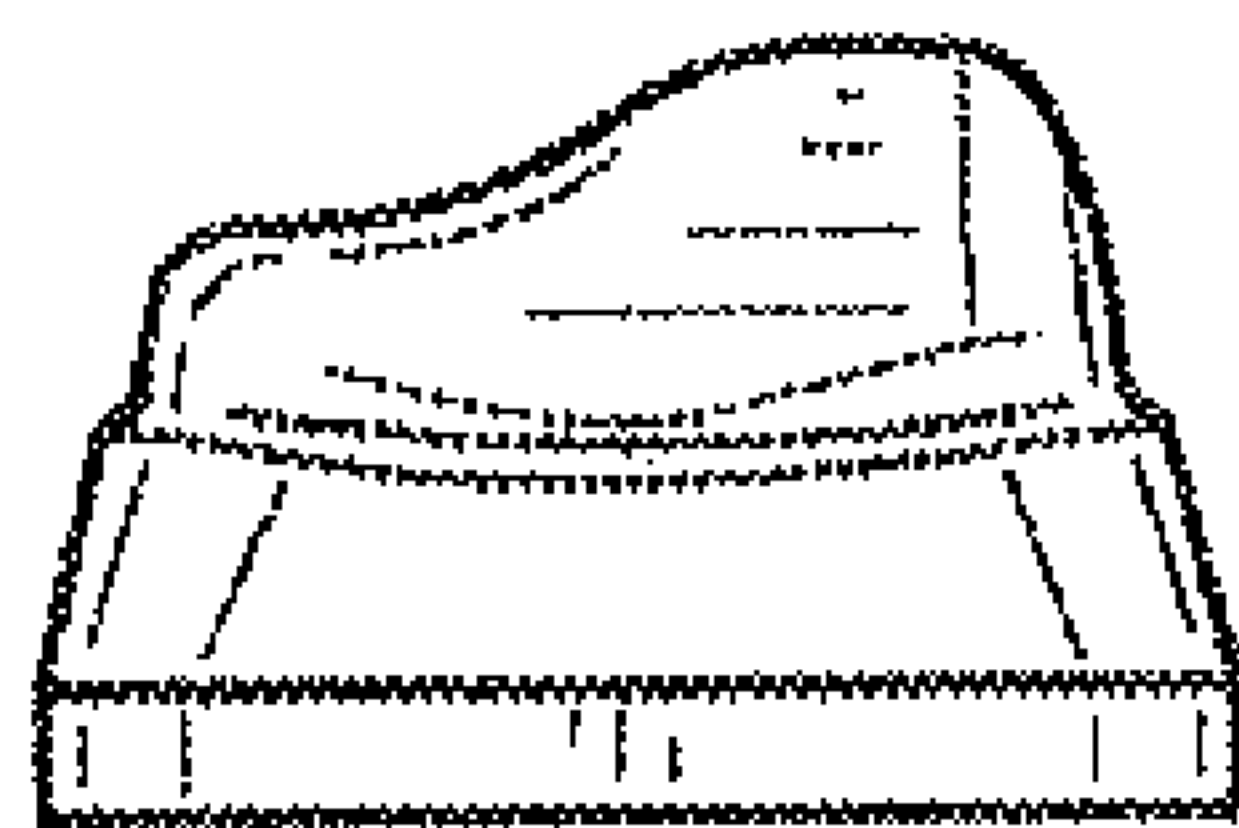

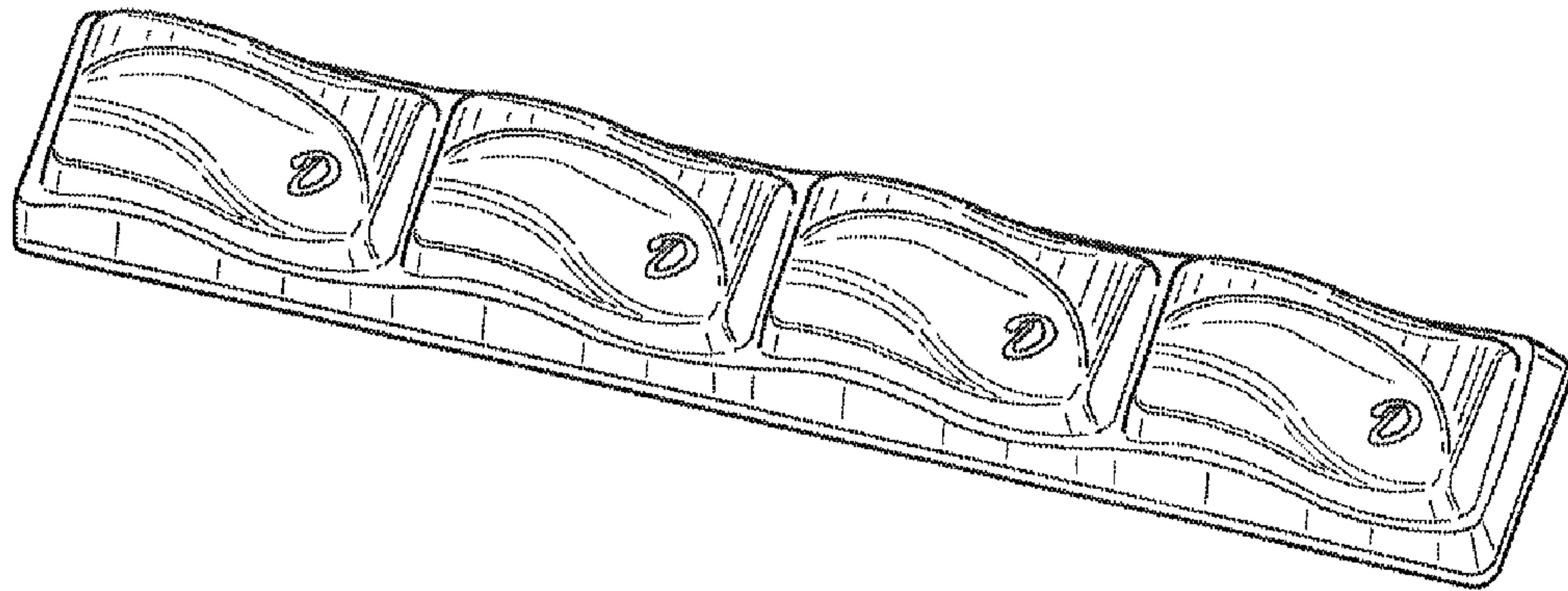

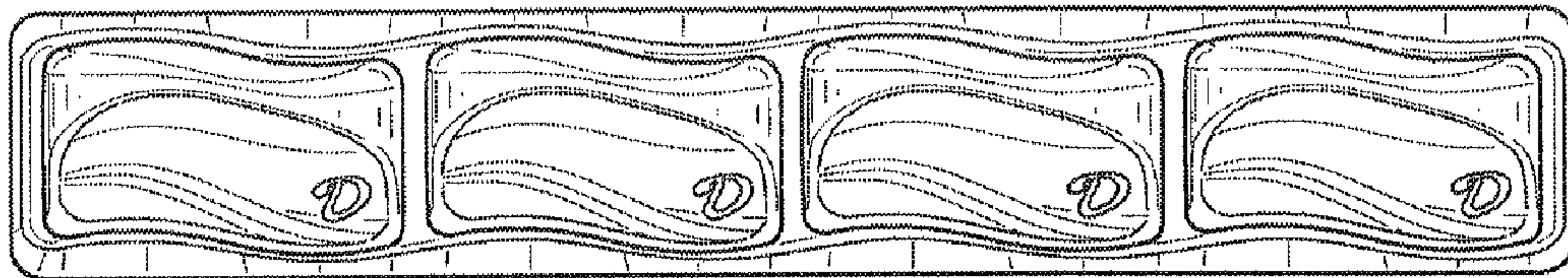

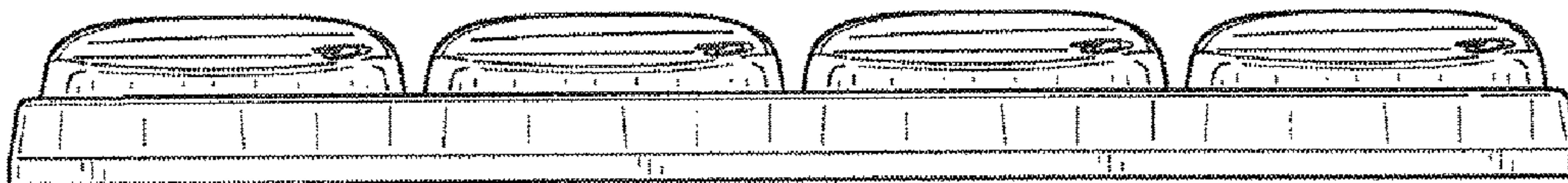
