(57) **CLAIM**

The ornamental design for a sectional gatherable bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view of the first embodiment of a sectional gatherable bag in an uncompressed state, the right side view being a mirror image thereof.

FIG. 2 is a left side perspective view of a sectional gatherable bag in a partially compressed state, the right side perspective view being a mirror image thereof.

FIG. 3 is a left side perspective view of a sectional gatherable bag in an compressed state, the right side perspective view being a mirror image thereof

FIG. 4 is a top front perspective view of FIG. 1, the bottom front perspective view being a mirror image.

FIG. 5 is a top rear perspective view of FIG. 1, the bottom rear perspective view being a mirror image.

FIG. 6 is a top front perspective view of FIG. 2 & FIG. 3, the bottom front perspective view being a mirror image.

FIG. 7 is a top rear perspective view of FIG. 2 & FIG. 3, the bottom rear perspective view being a mirror image.

FIG. 8 is a left side perspective view of the First embodiment of a sectional gatherable bag in a substantially uncompressed state now showing a different quality fabric for the bottom non-gatherable section, the right side perspective view being a mirror image thereof.

FIG. 9 is a left side perspective view of the second embodiment of a sectional gatherable bag in a partially compressed state now showing a different quality fabric for the bottom non-gatherable section, the right side perspective view being a mirror image thereof.

FIG. 10 is a left side perspective view of the First embodiment of a sectional gatherable bag in a compressed state now showing a different quality fabric for the bottom non-gatherable section, the right side perspective view being a mirror image thereof.

FIG. 11 is a top front perspective view of FIG. 8, the bottom rear perspective view being a mirror image.

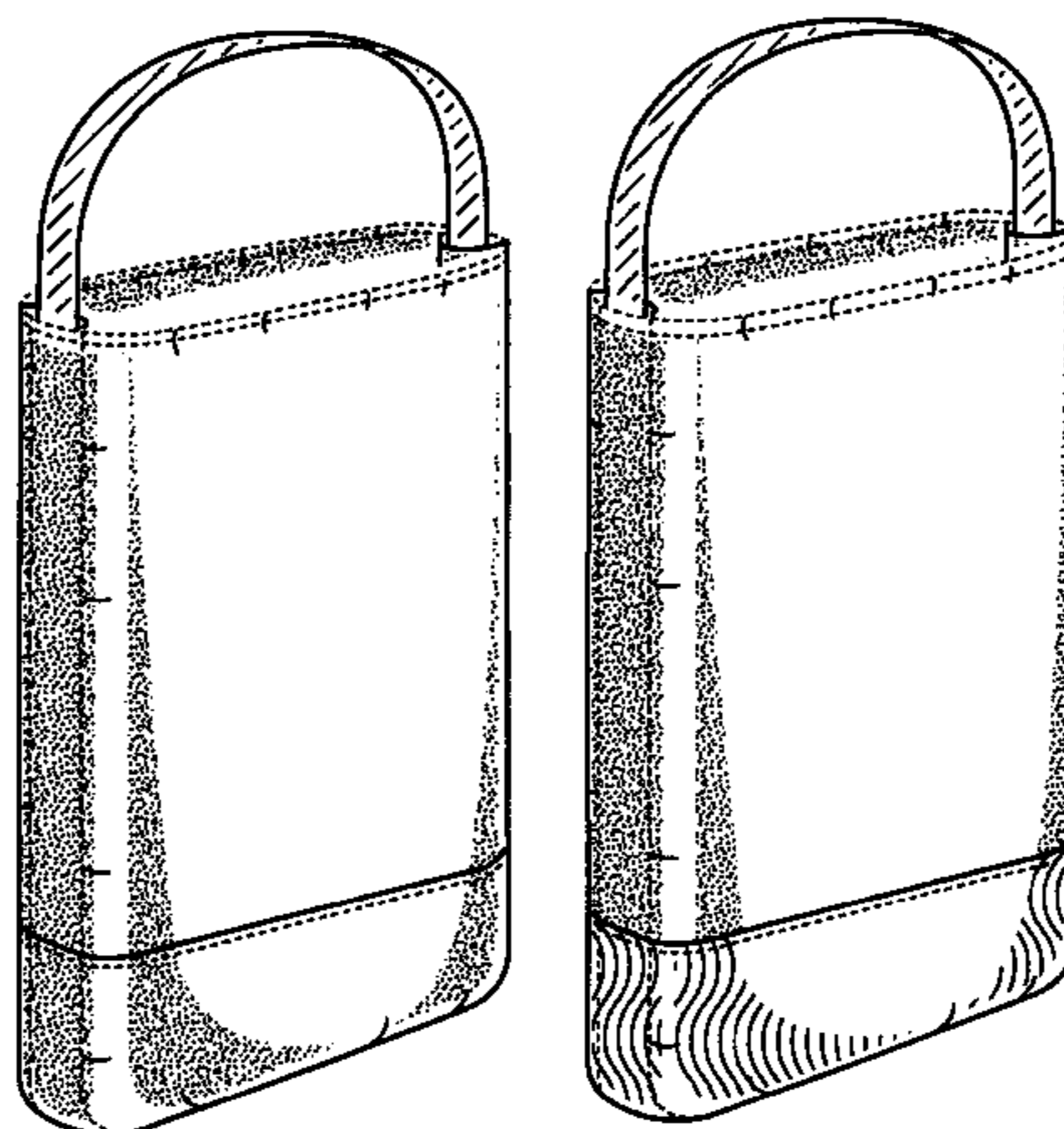
FIG. 12 is a top rear perspective view of FIG. 8, the bottom rear perspective view being a mirror image.

FIG. 13 is a top front perspective view of FIG. 9 & FIG. 10, the bottom front perspective view being a mirror image; and,

FIG. 14. is a top rear perspective view of FIG. 9 & FIG. 10., the bottom rear perspective view being a mirror image.

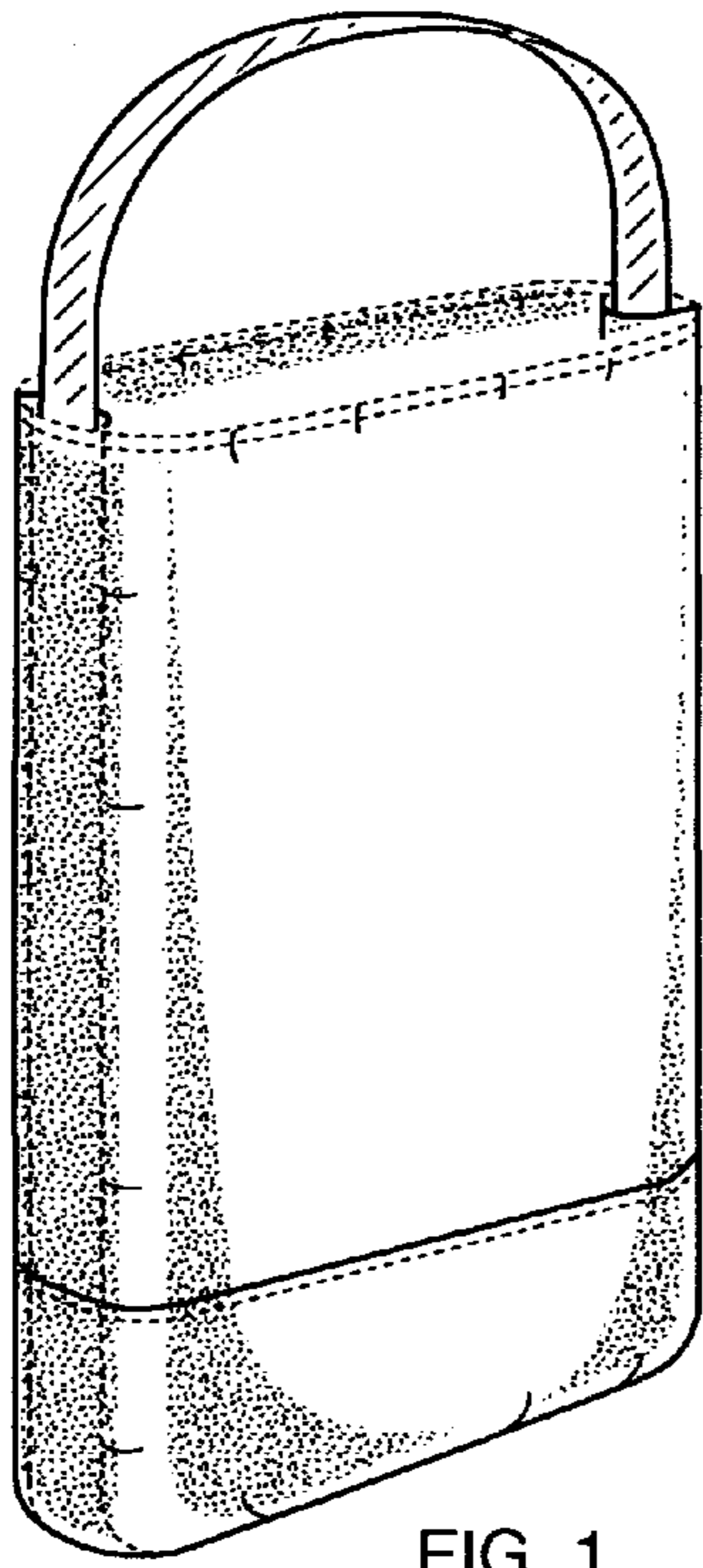

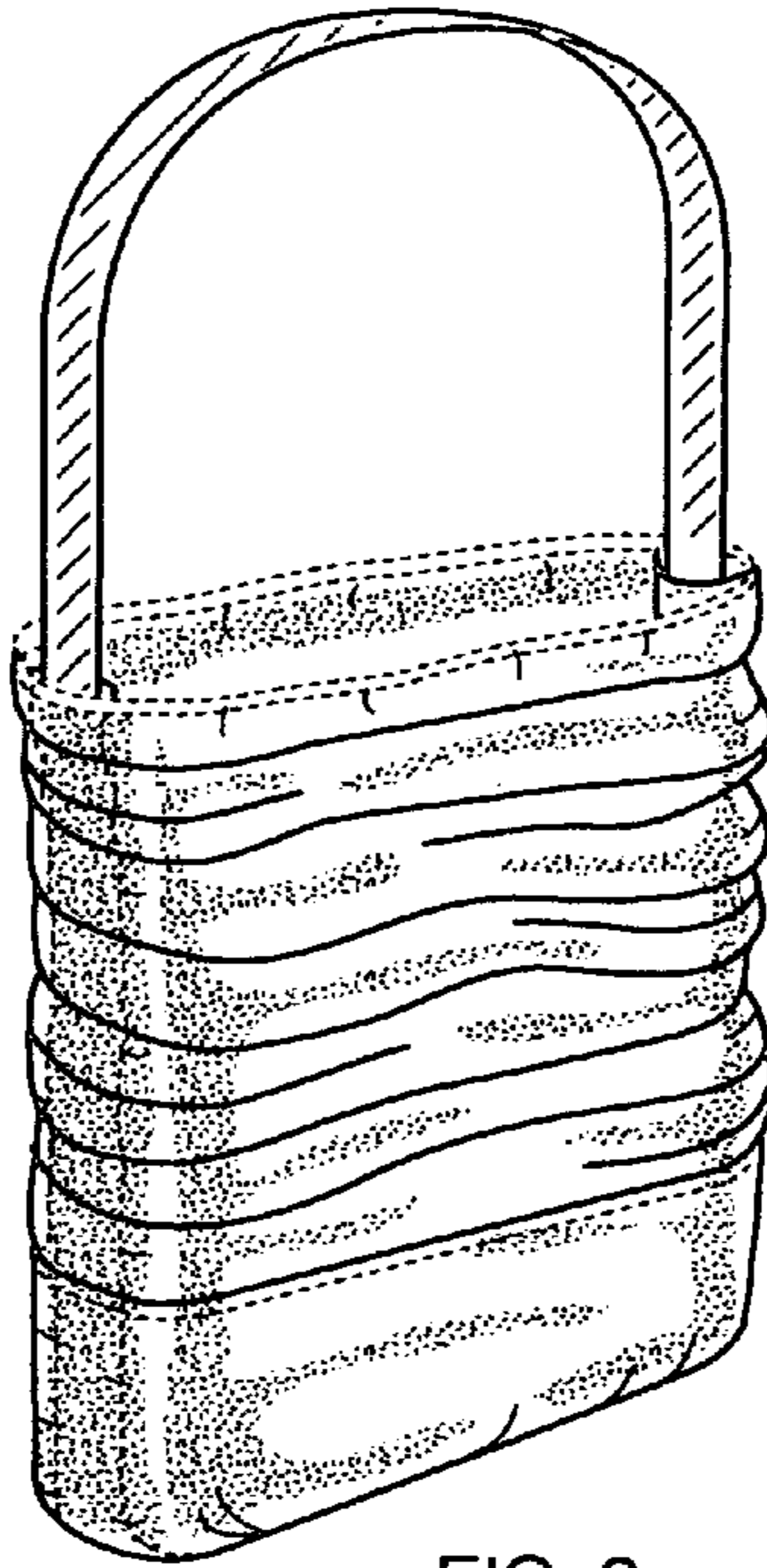

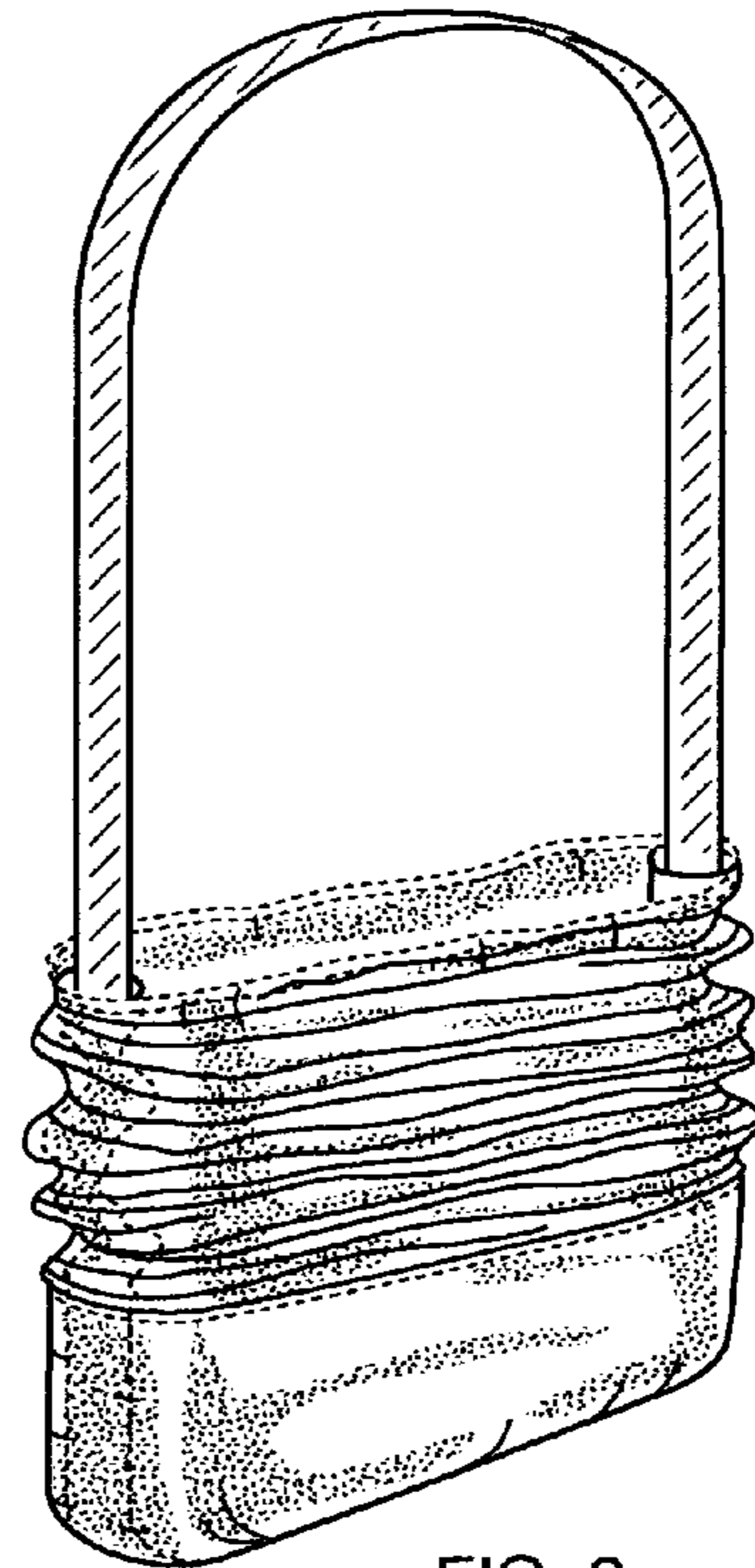

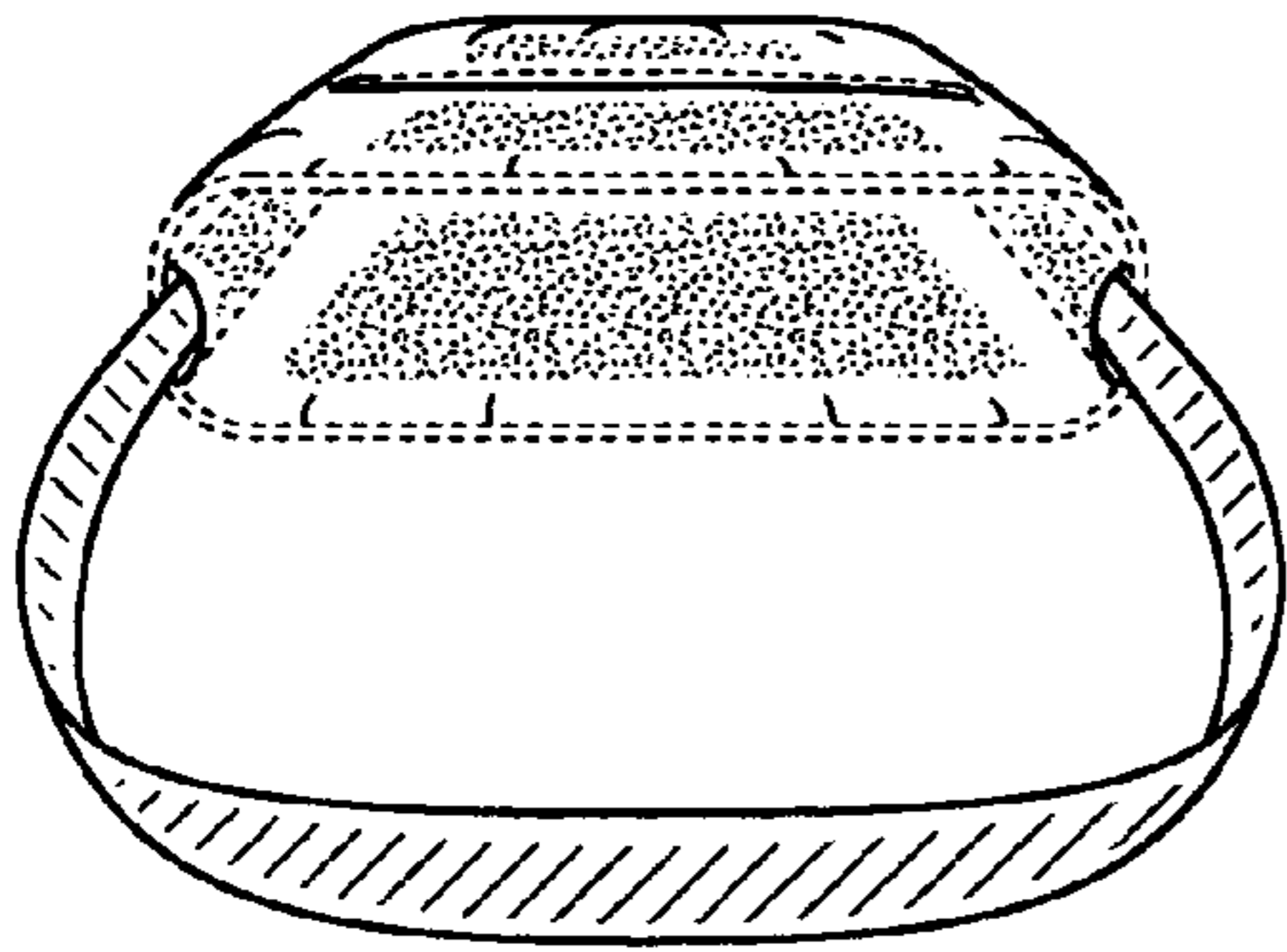

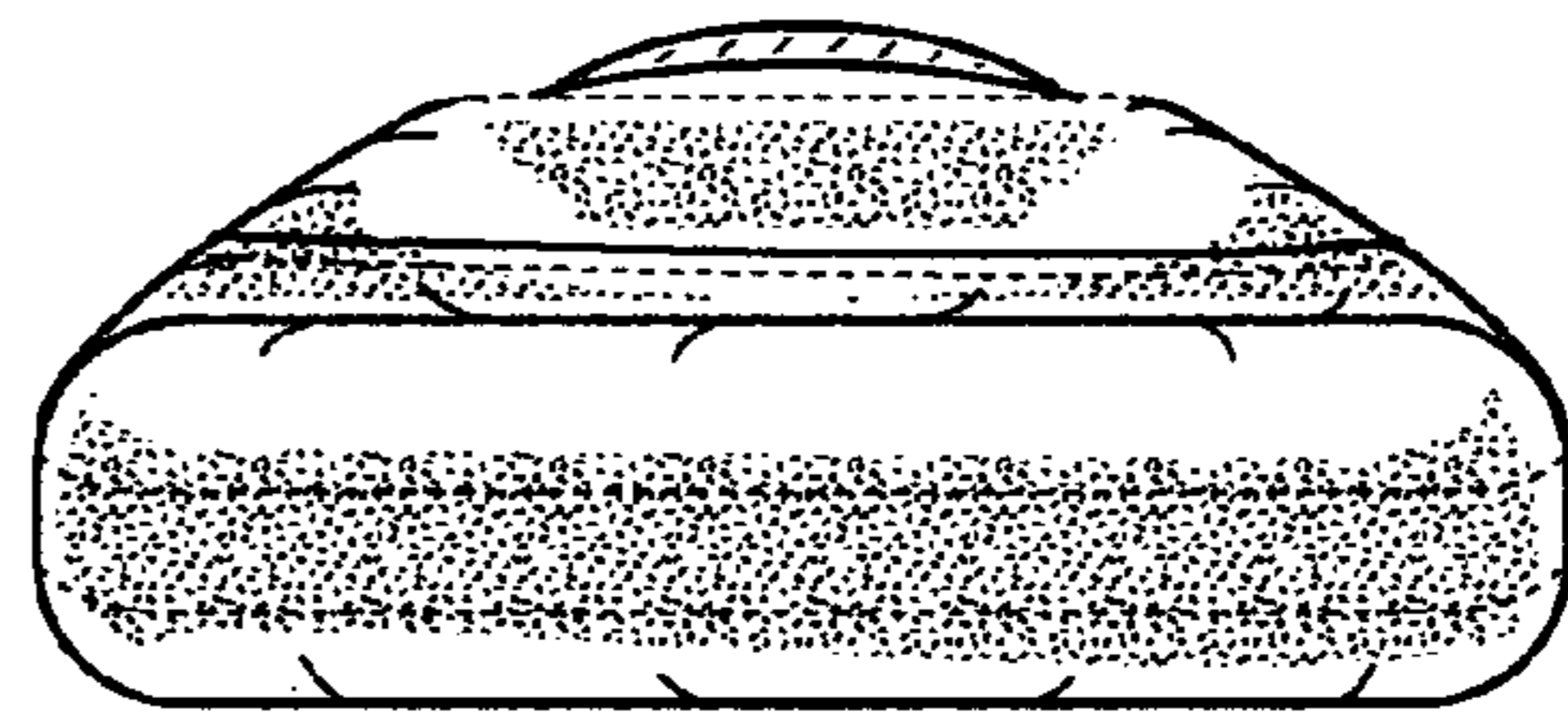

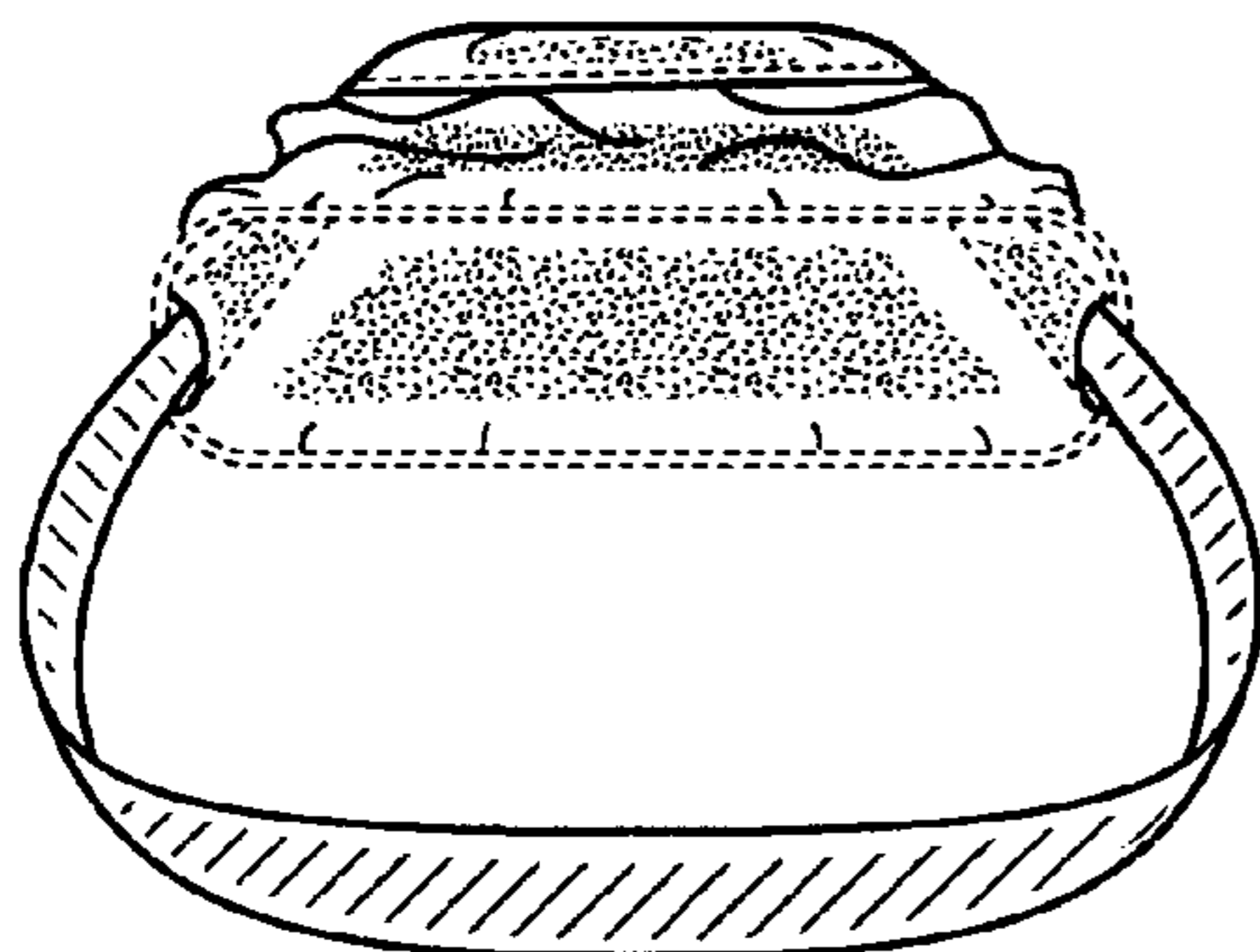

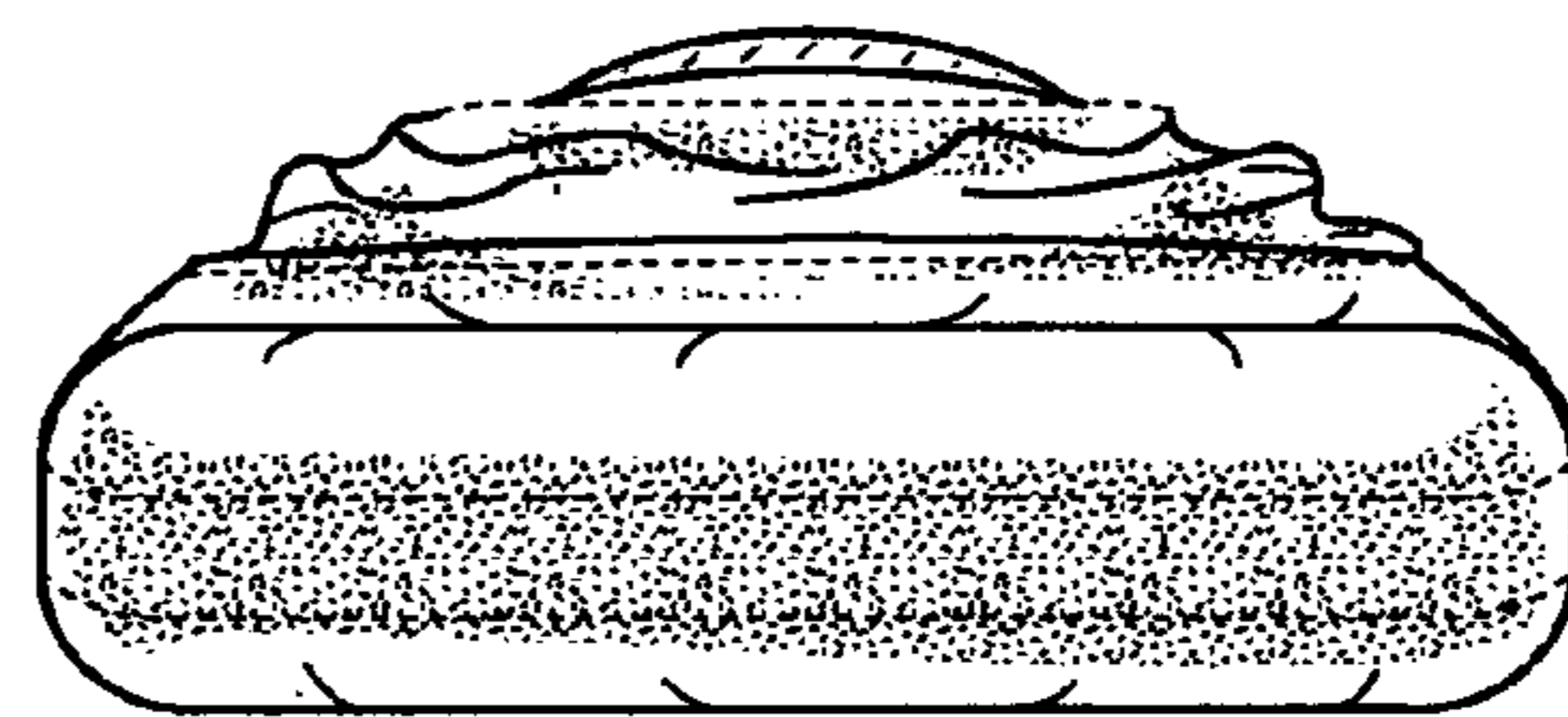

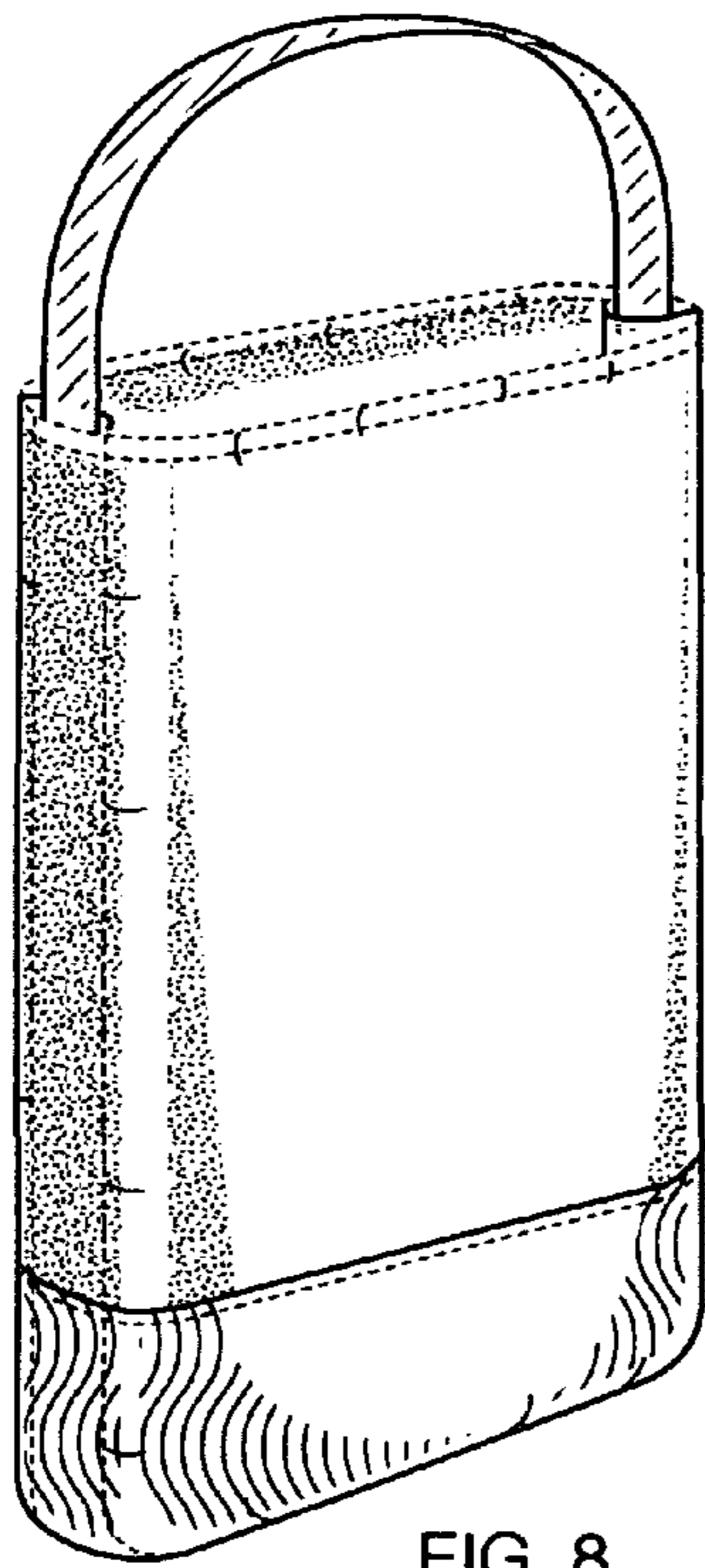

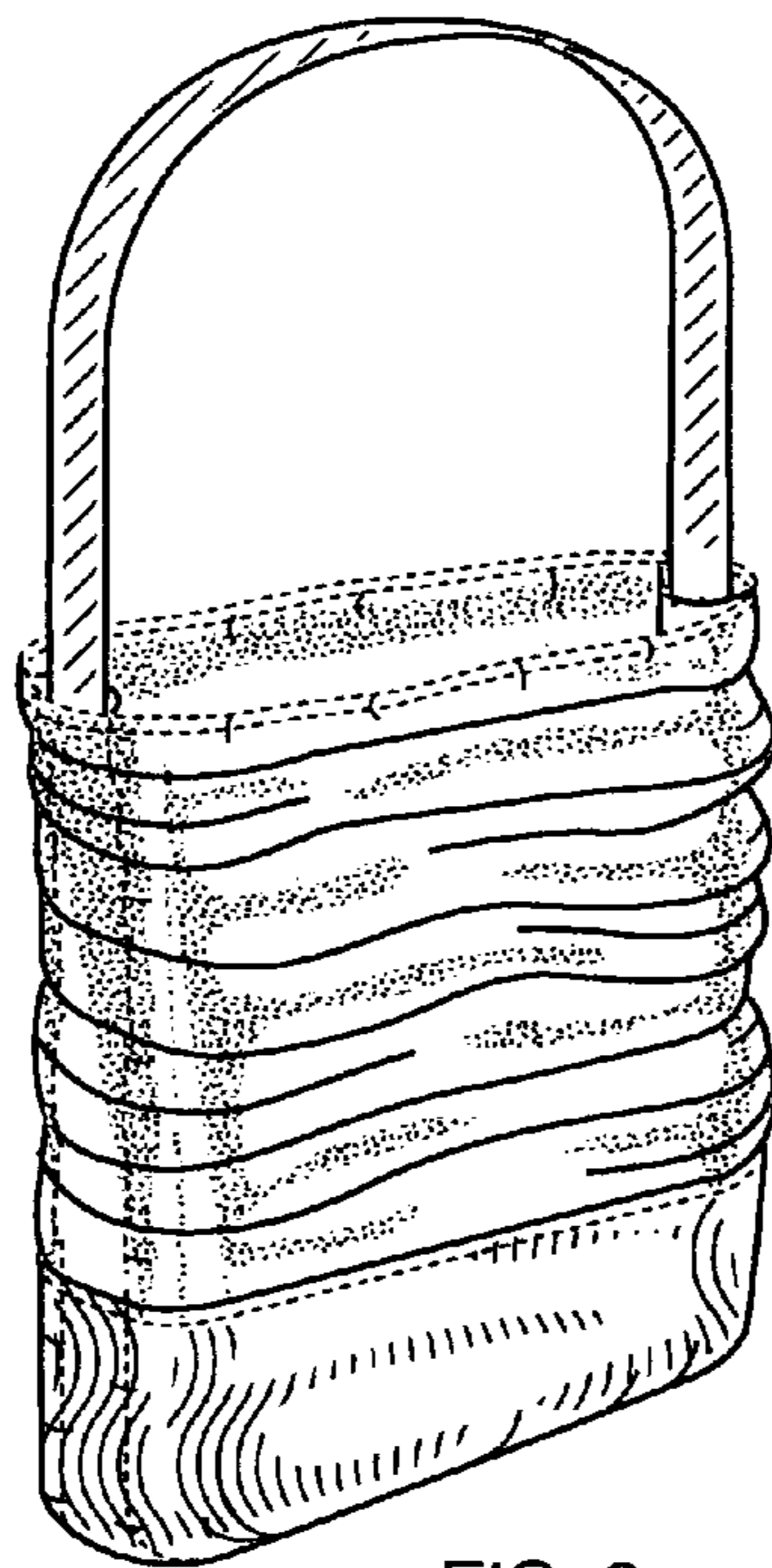

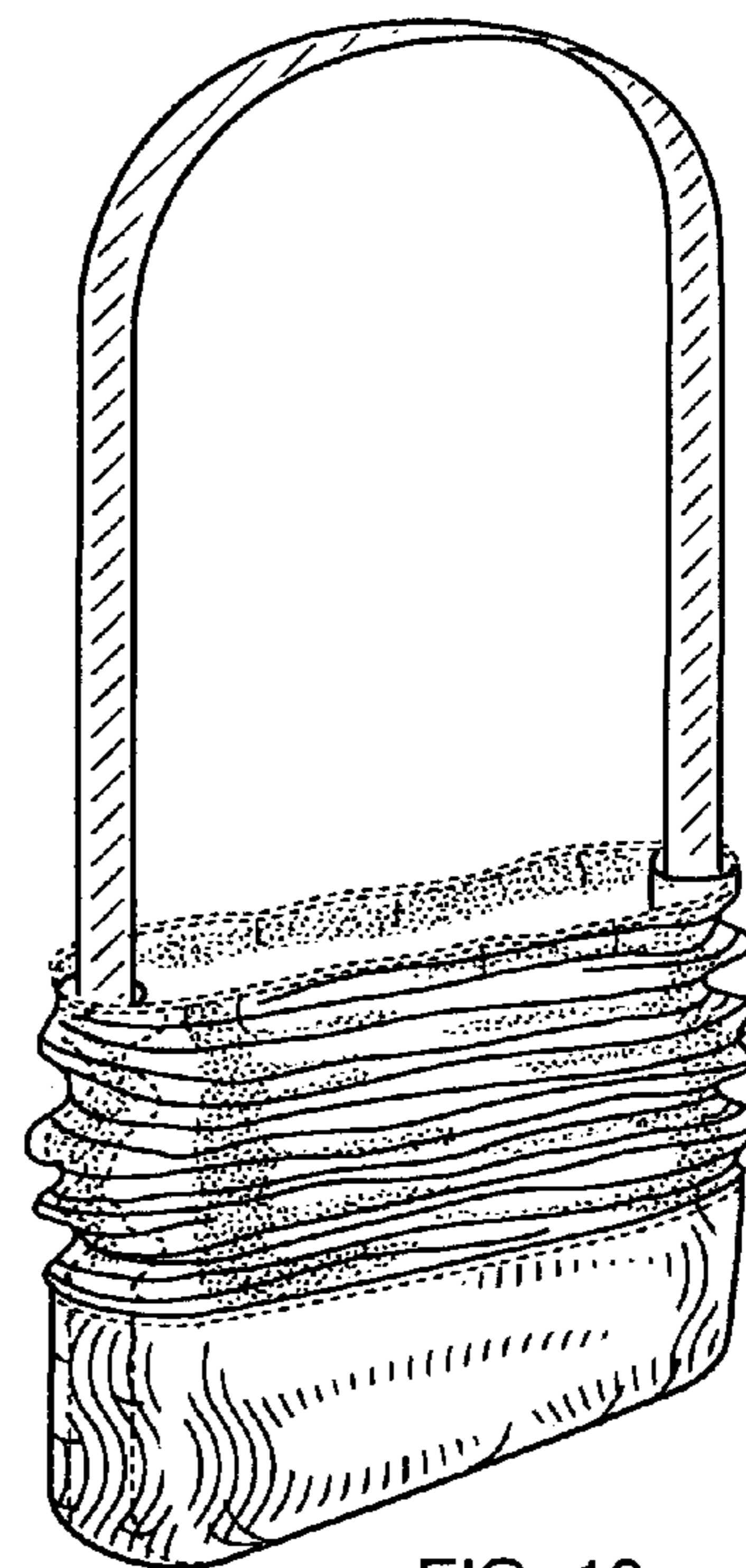

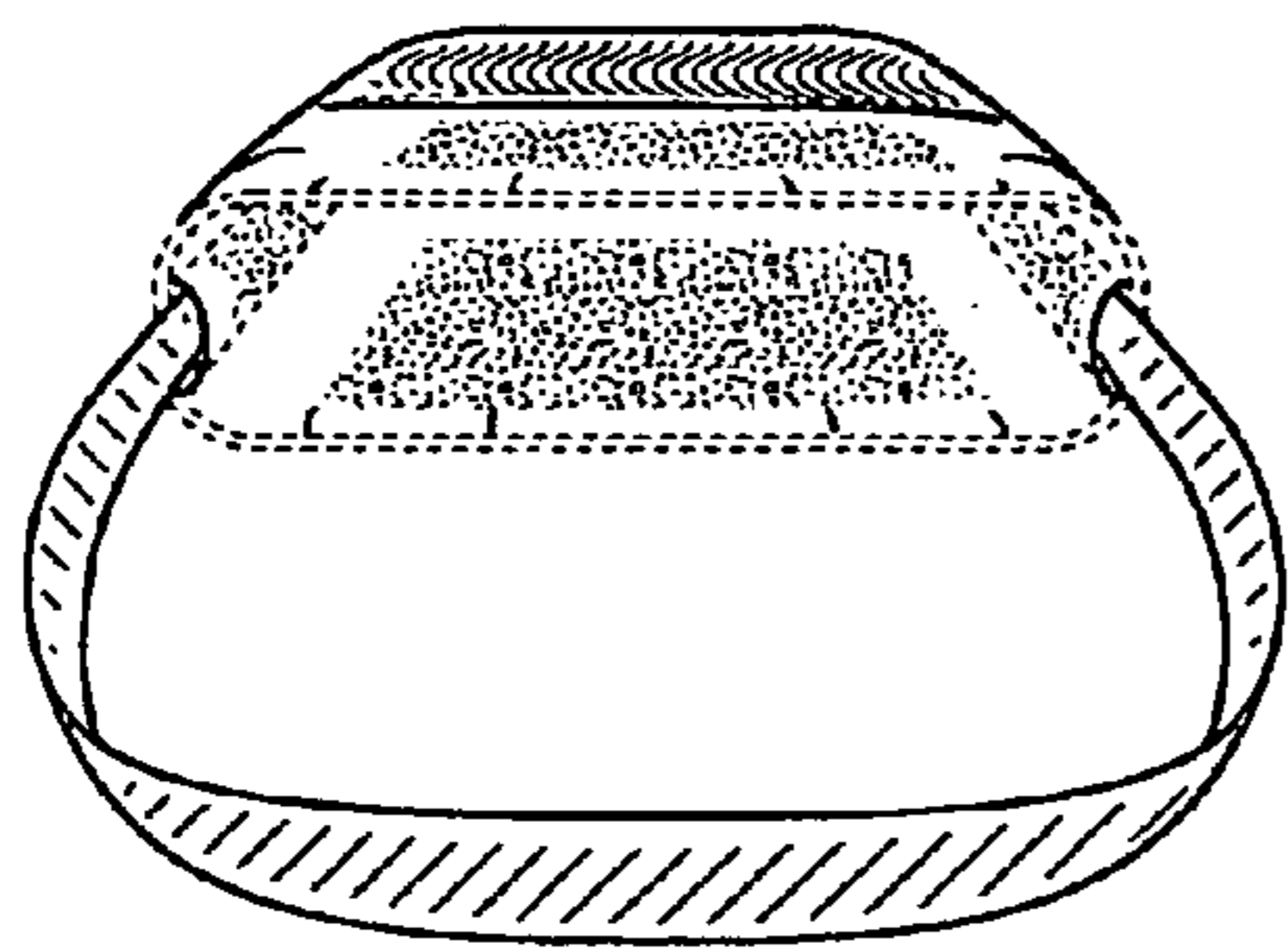

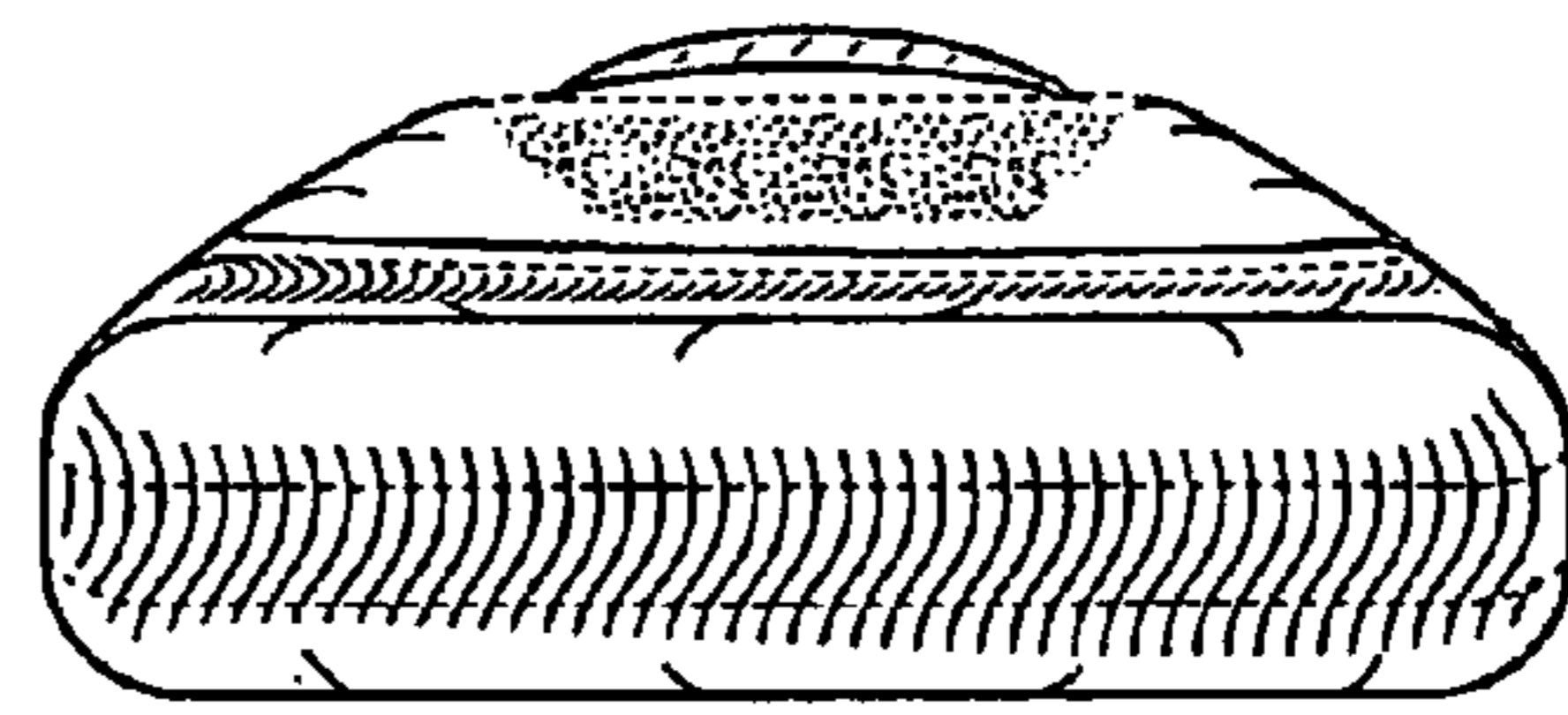

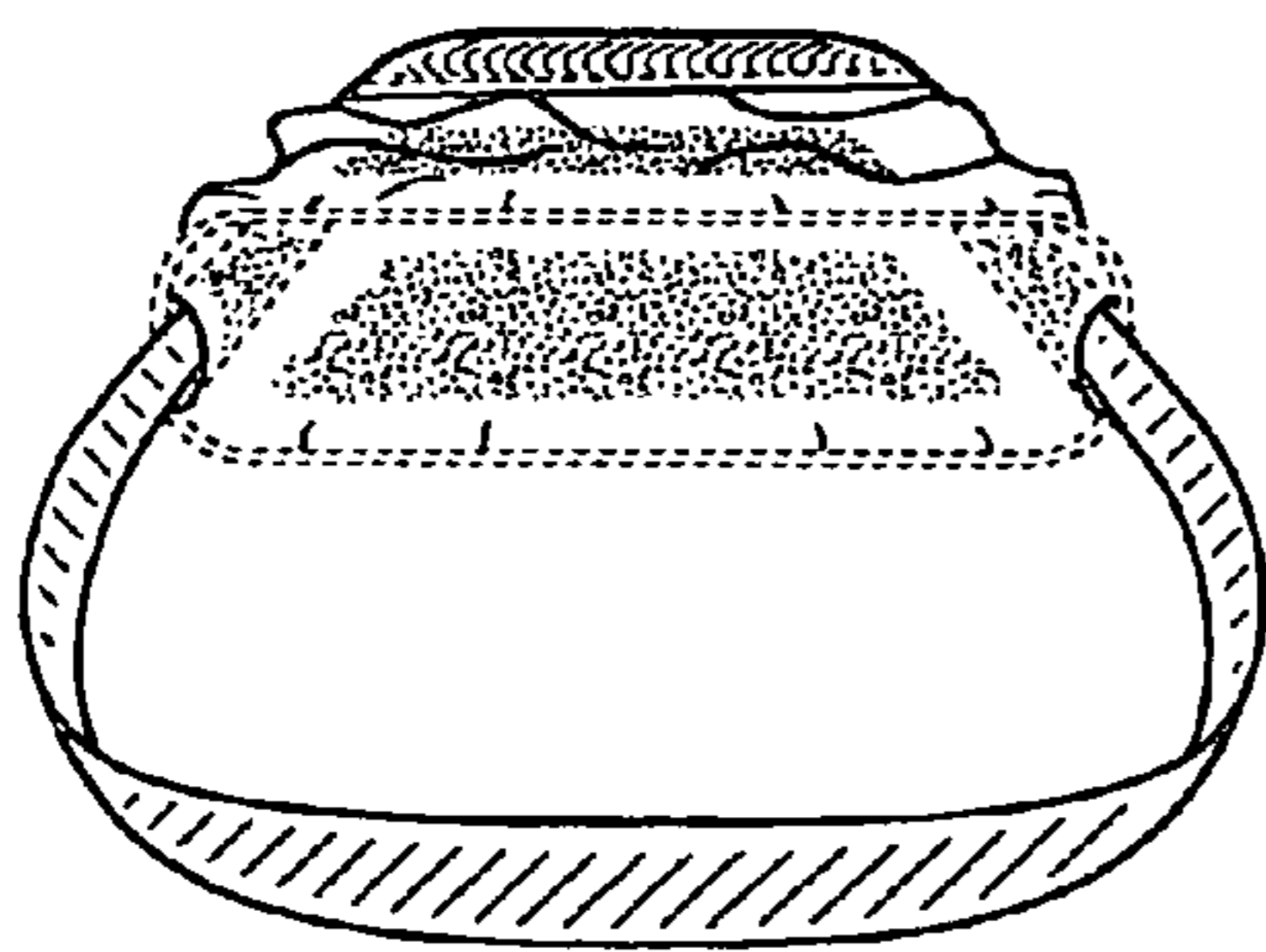

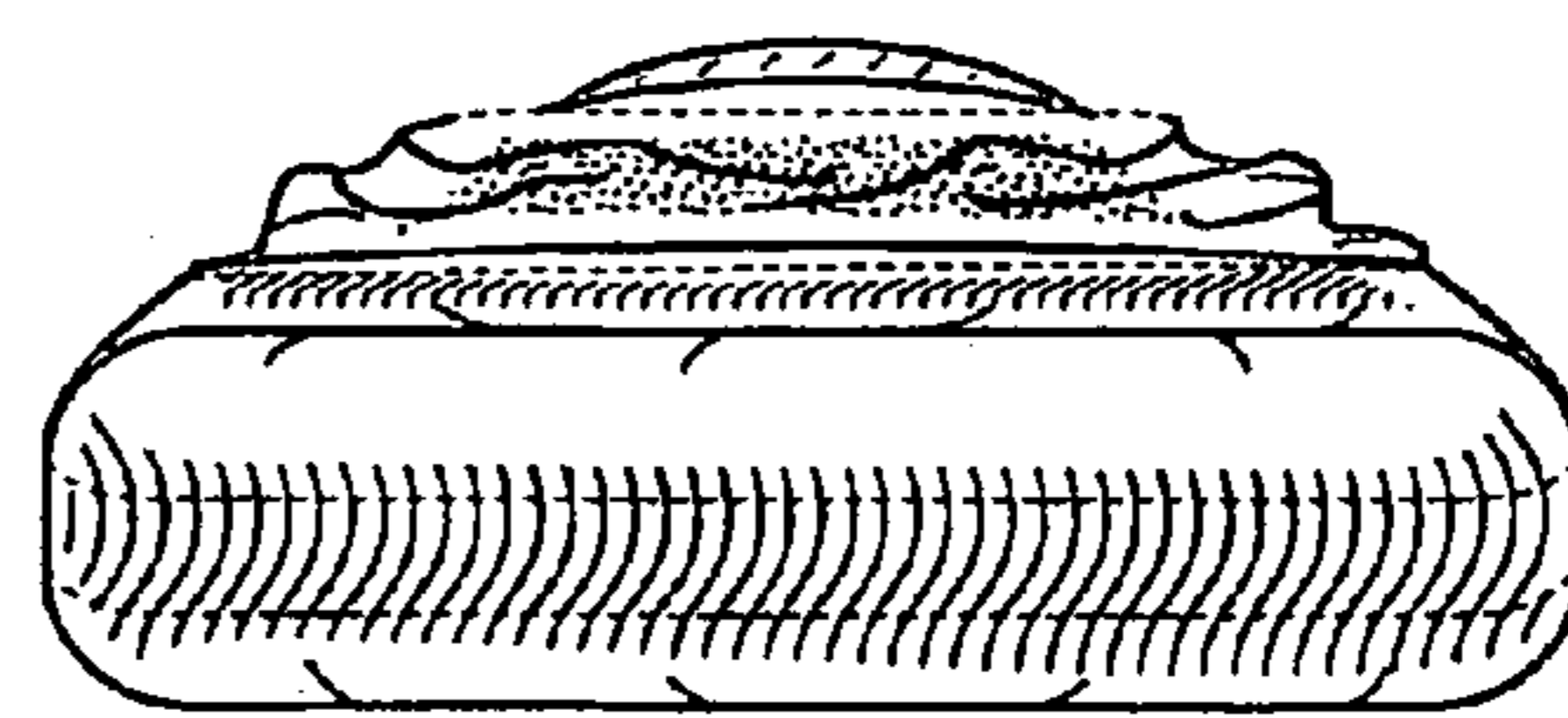
