The ornamental design for a stretchable notebook computer case, as shown and described.

**DESCRIPTION**

FIG. 5 is a bottom plan view thereof;

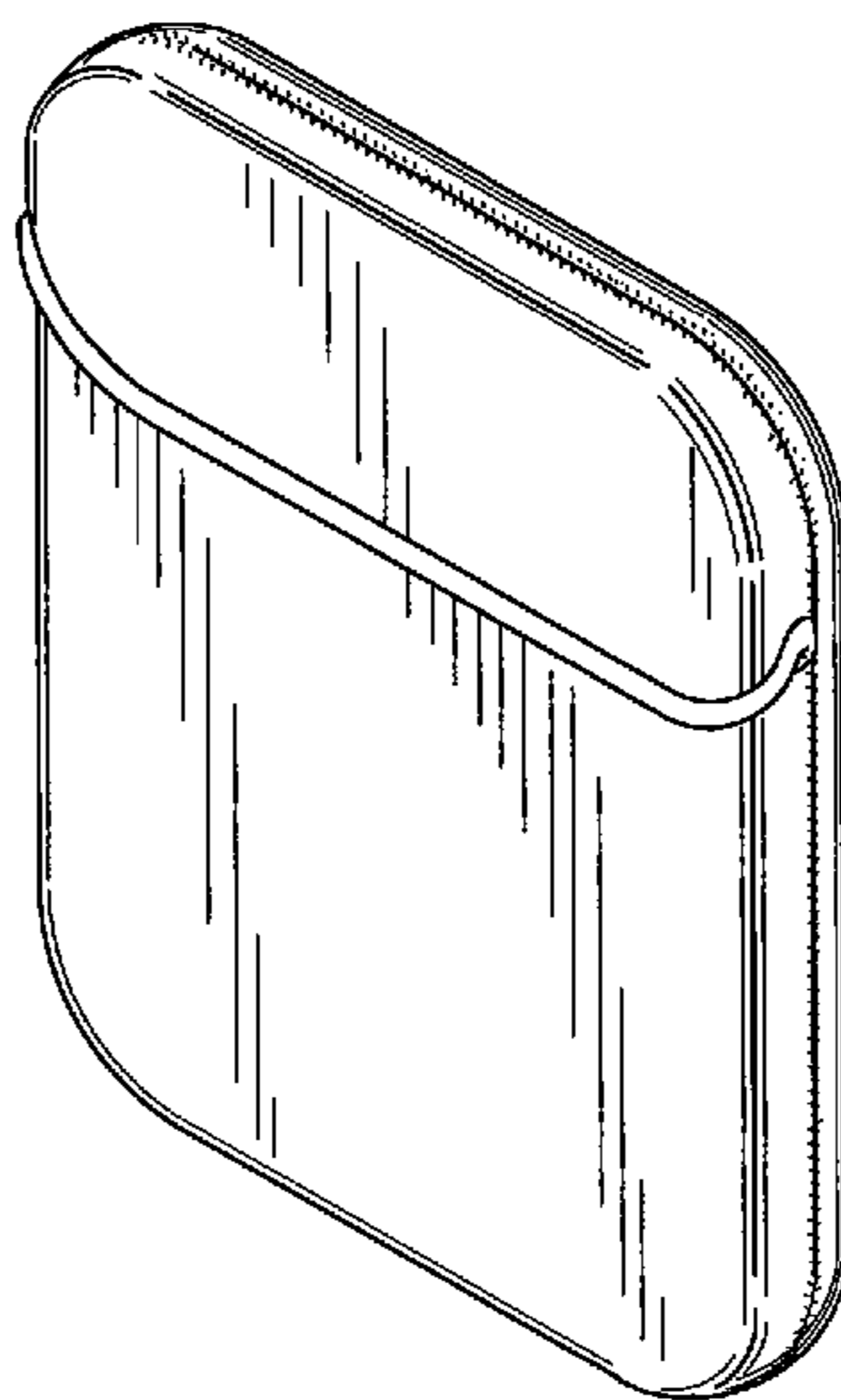
FIG. 6 is a right elevation view thereof;

FIG. 7 is a rear elevation view thereof; and,

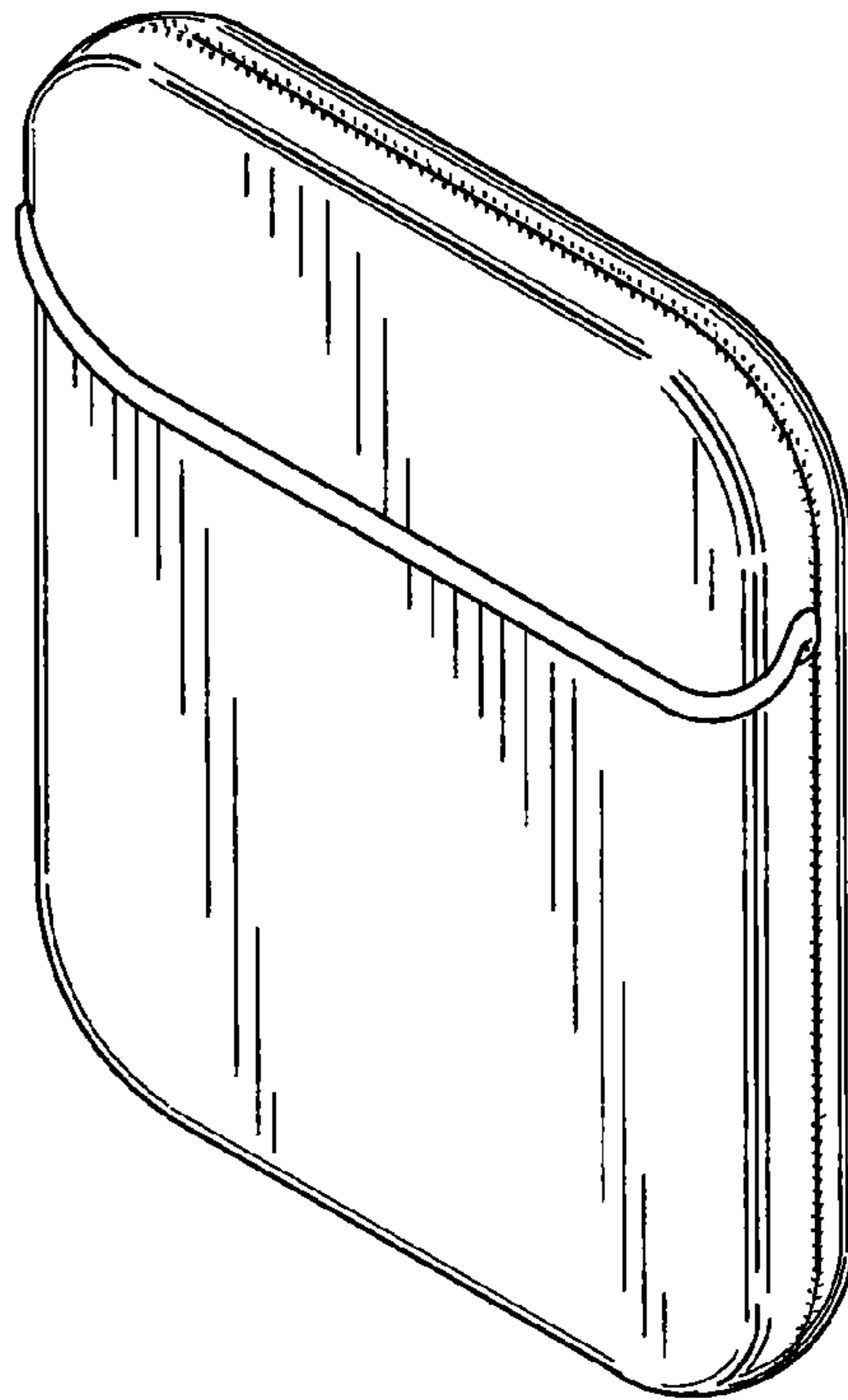
FIG. 8 is a left elevation view thereof.

The dashed lines in FIG. 2 represent environment and form no part of the claimed design.

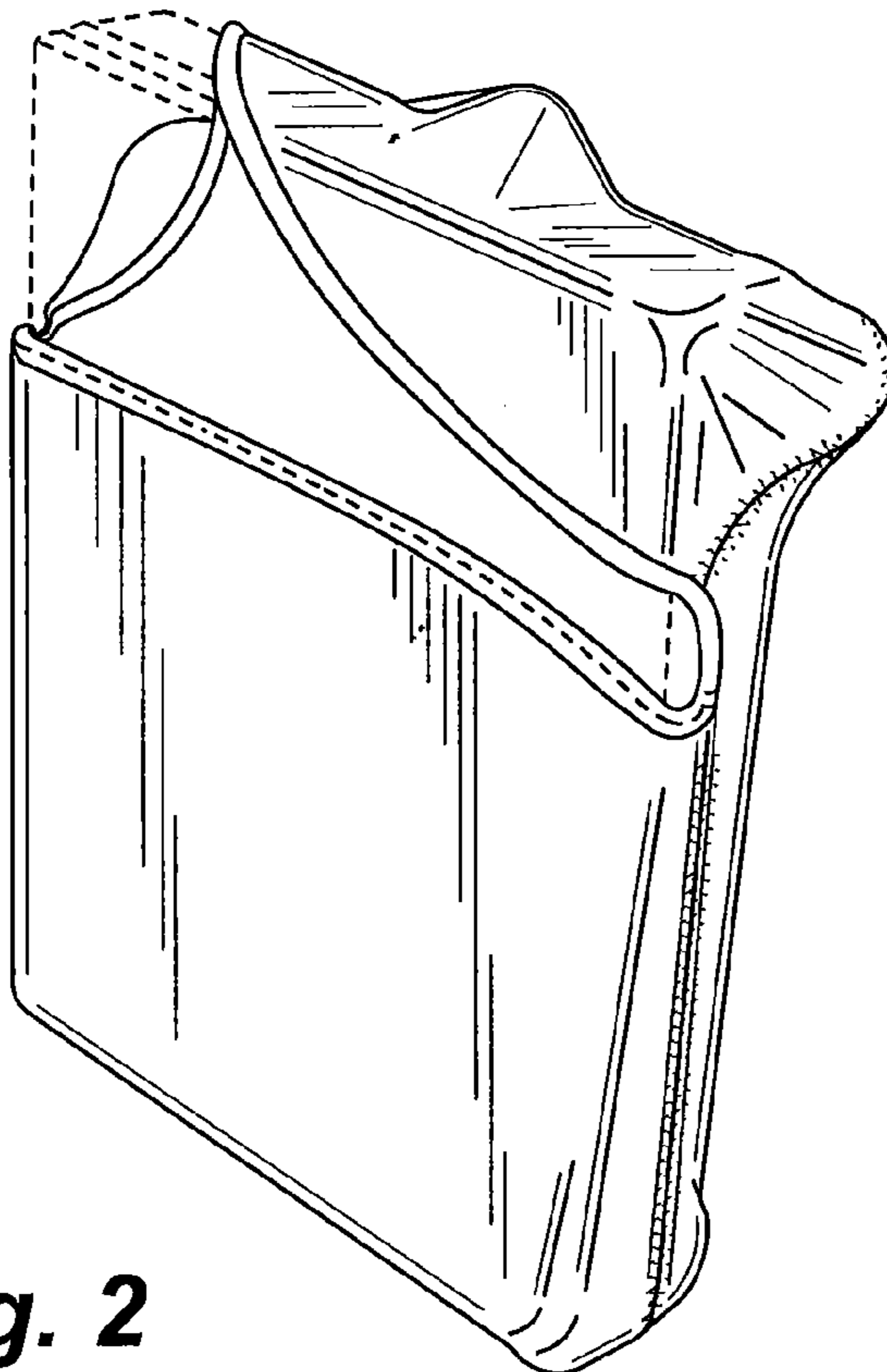

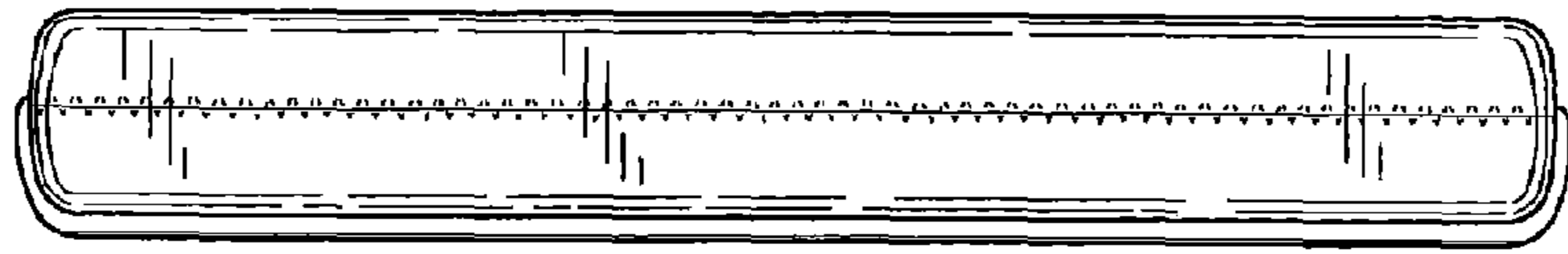

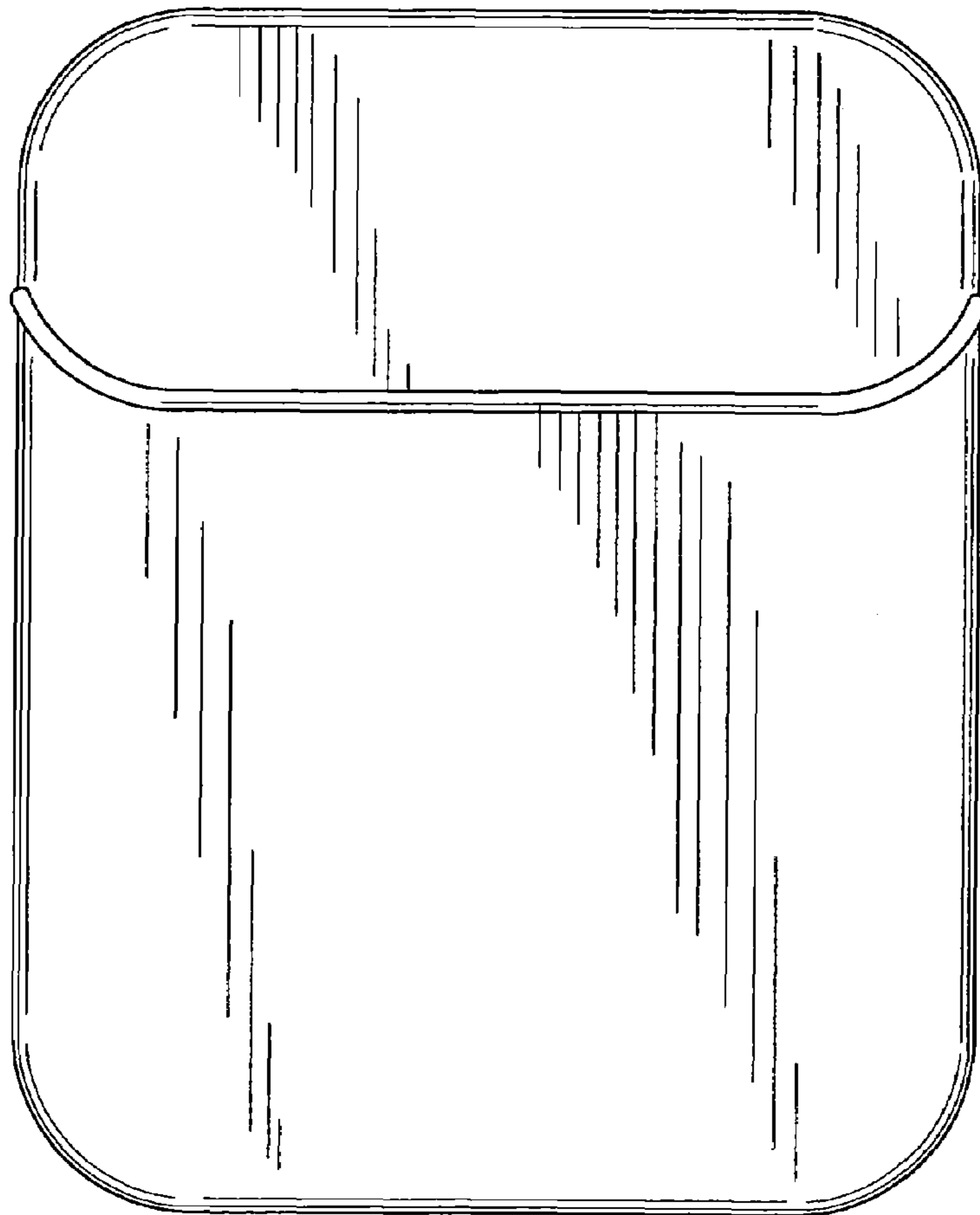

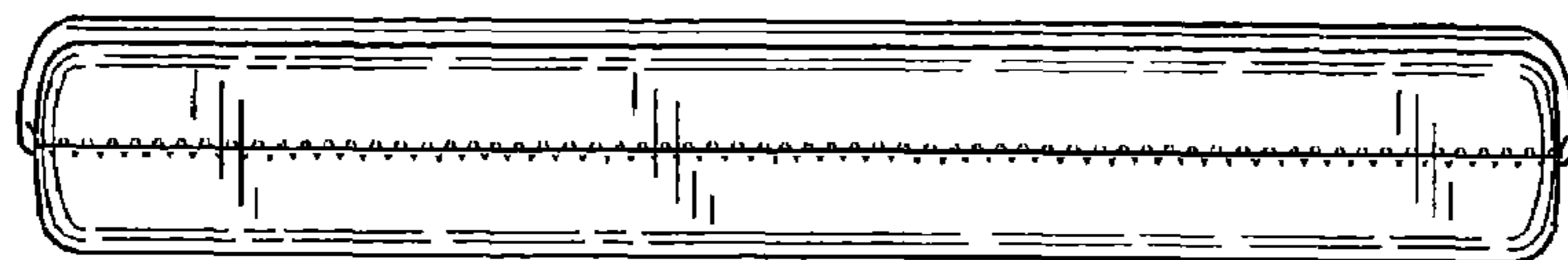




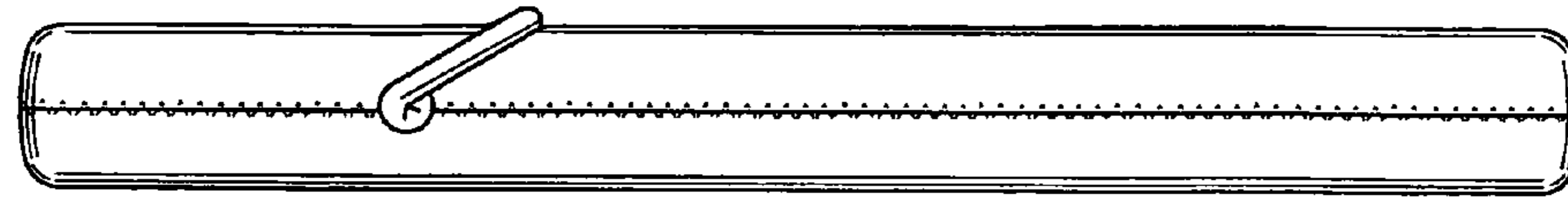

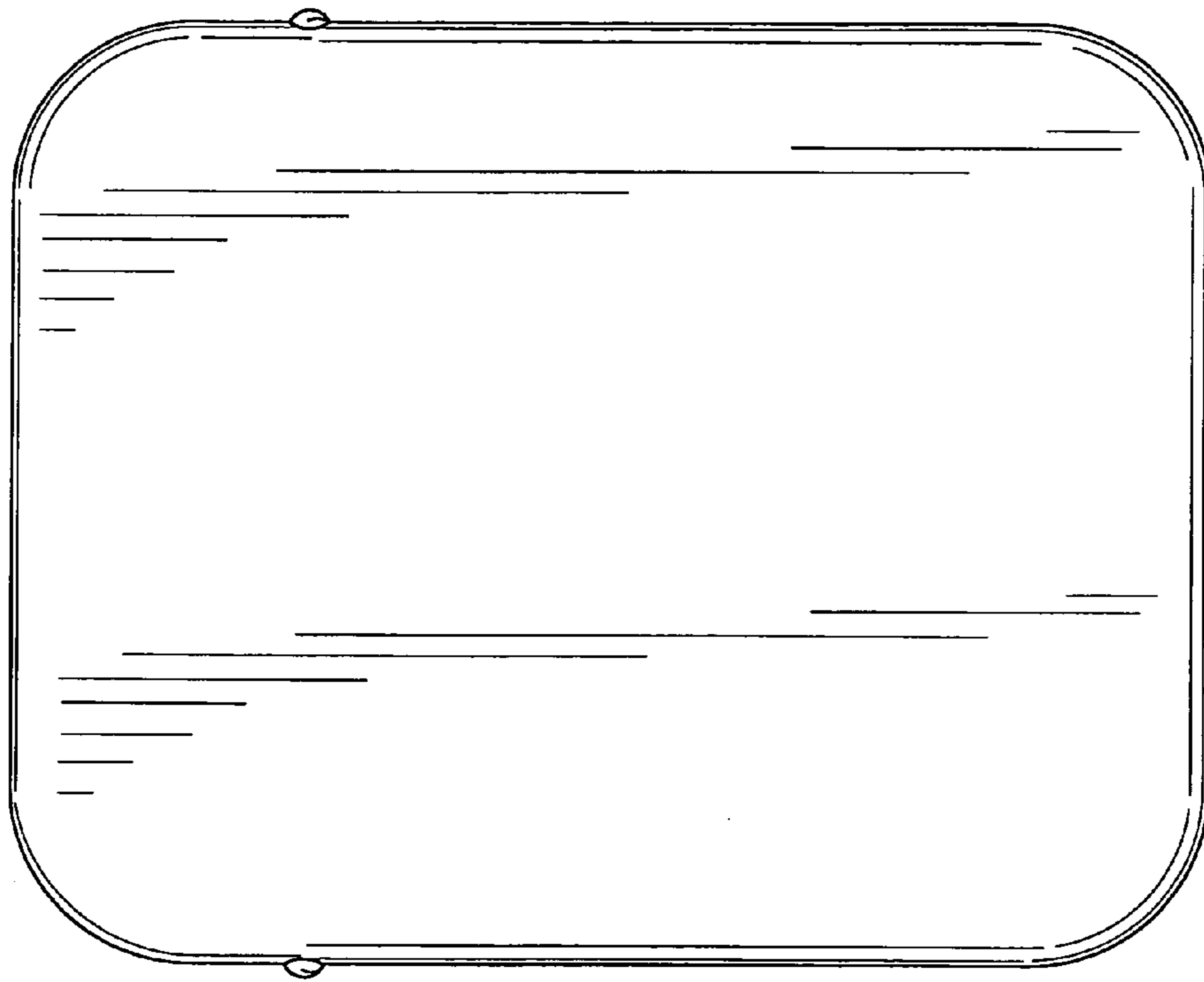

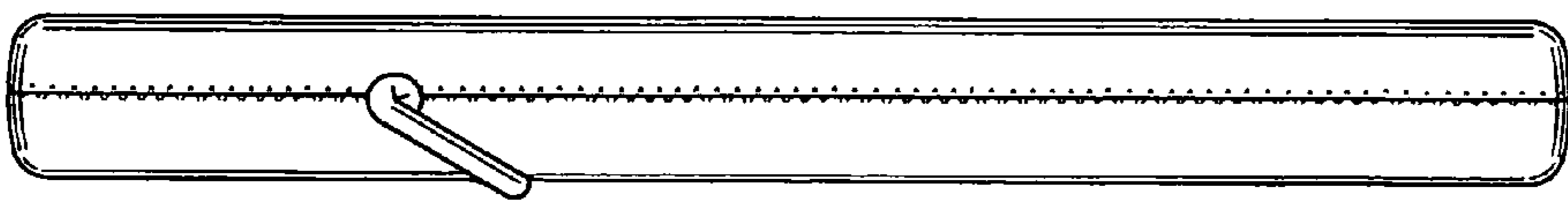
