The ornamental design for an arched handle for cookware lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the “arched handle for cookware lid”, showing my new design;

FIG. 2 is a top plan view thereof;

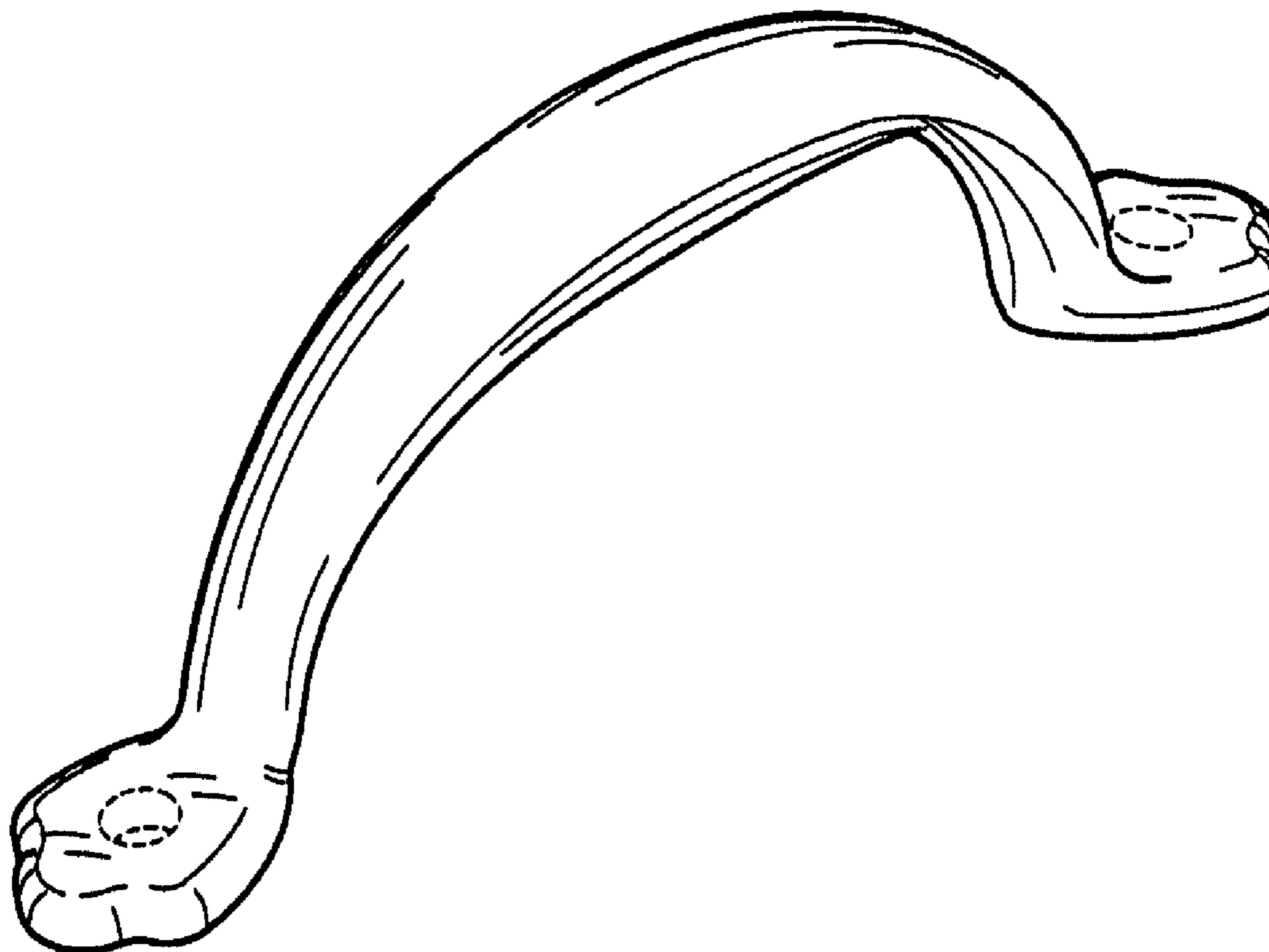
FIG. 3 is a front elevational view thereof;

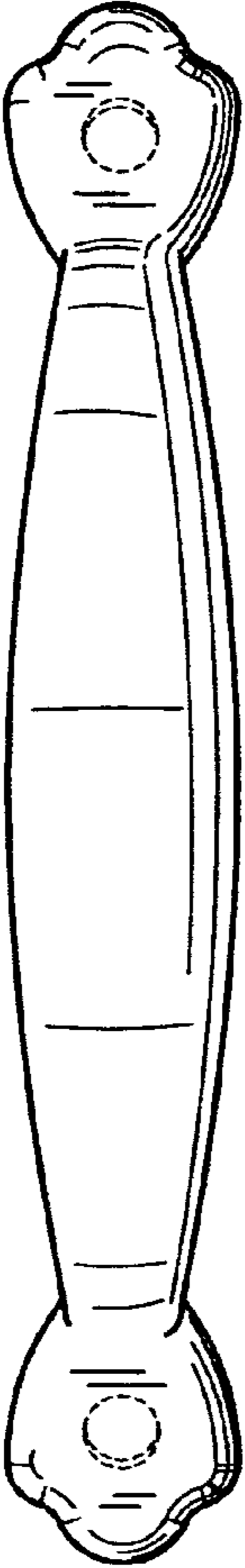

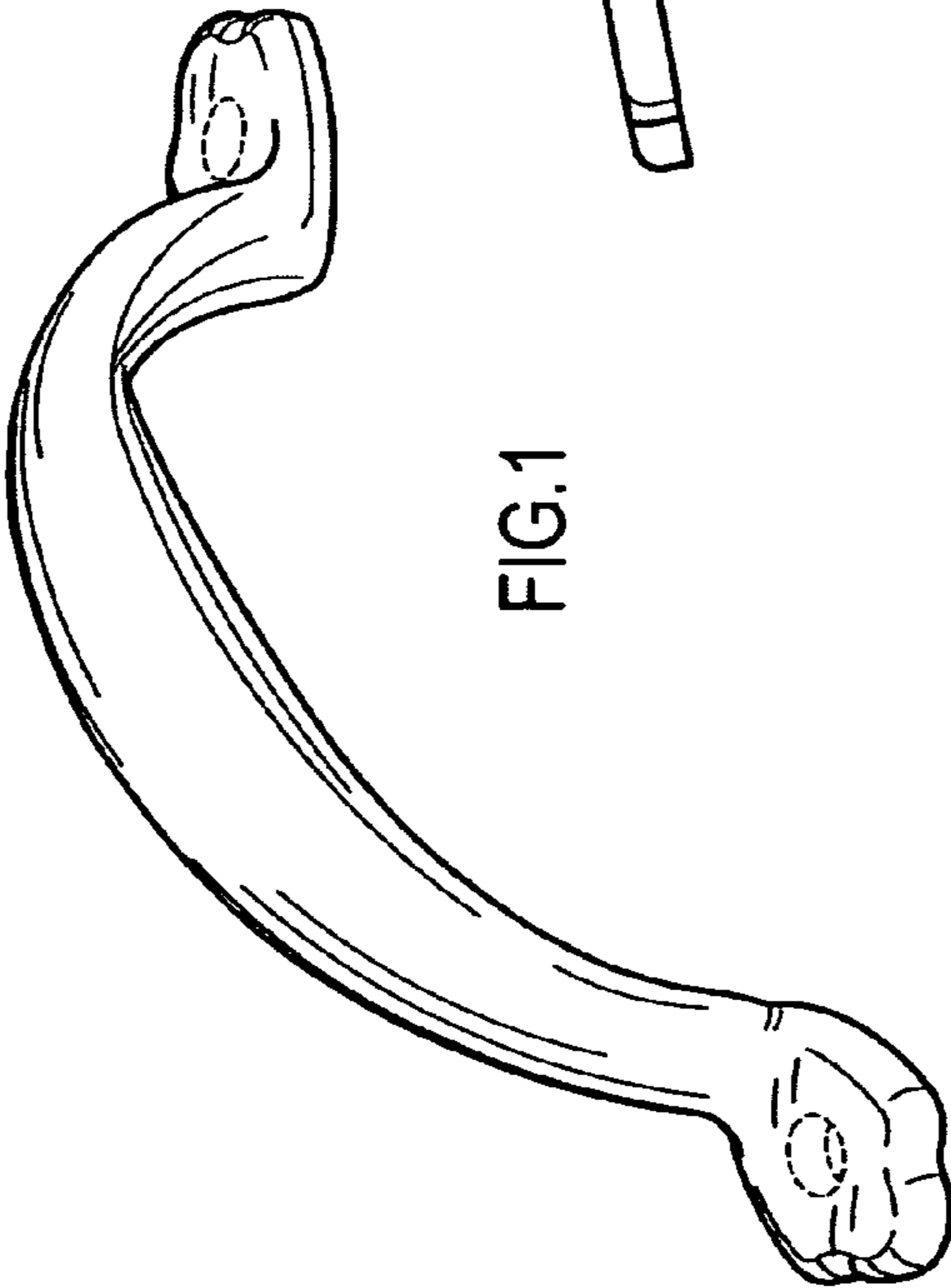

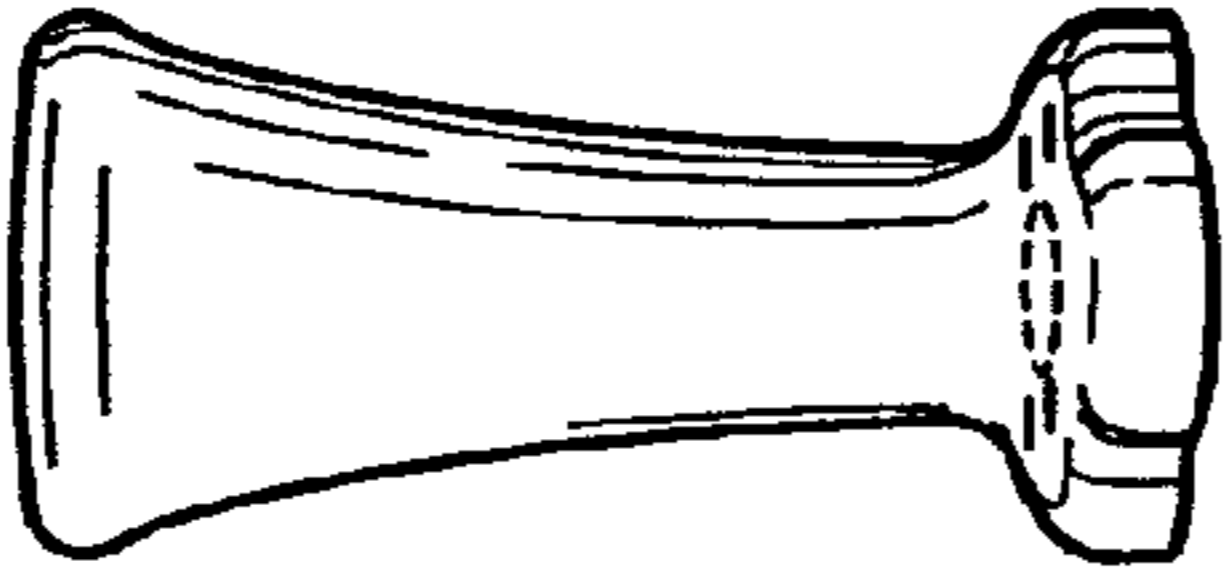

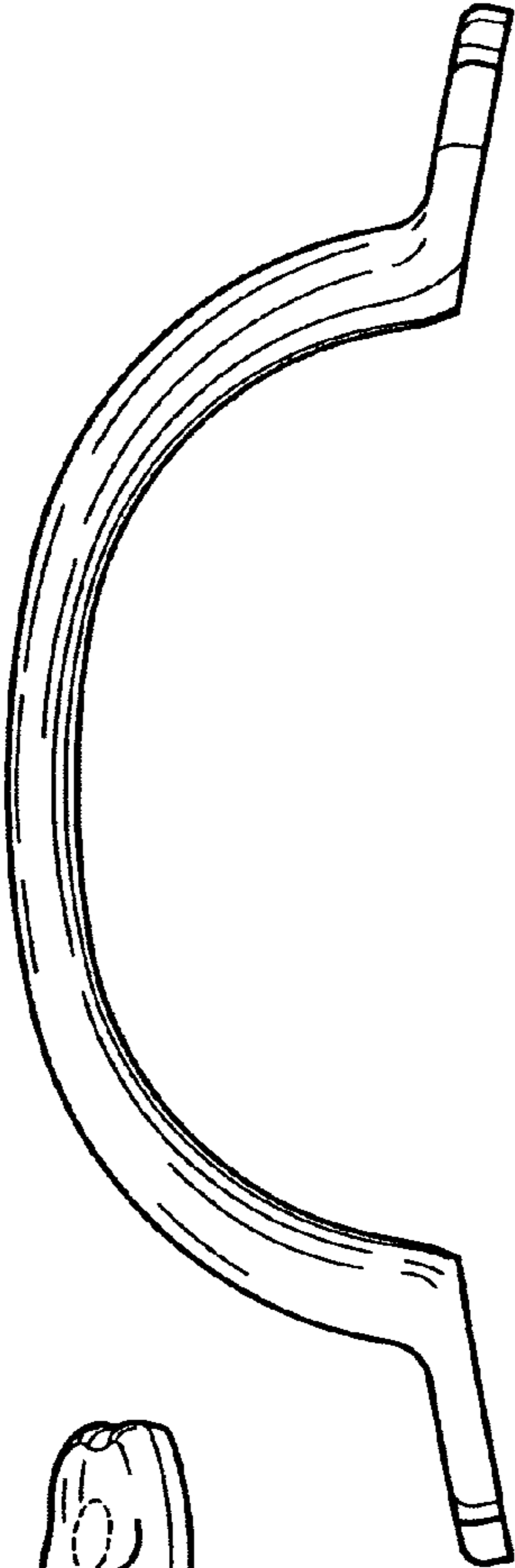

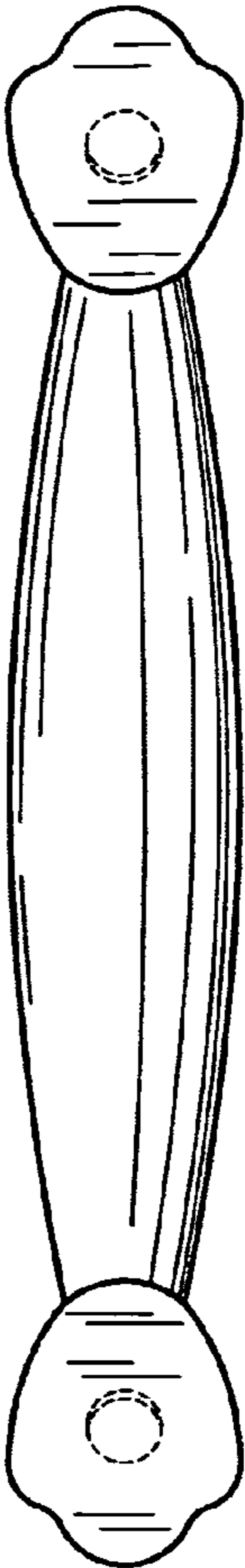
