Also on the shank first end is a body component, two arm components, two leg components and a head component to which the tine is attached, all configured as shown.

FIG. 6 is a front end view of the roasting stick for open fire roasting of FIG. 1; and,

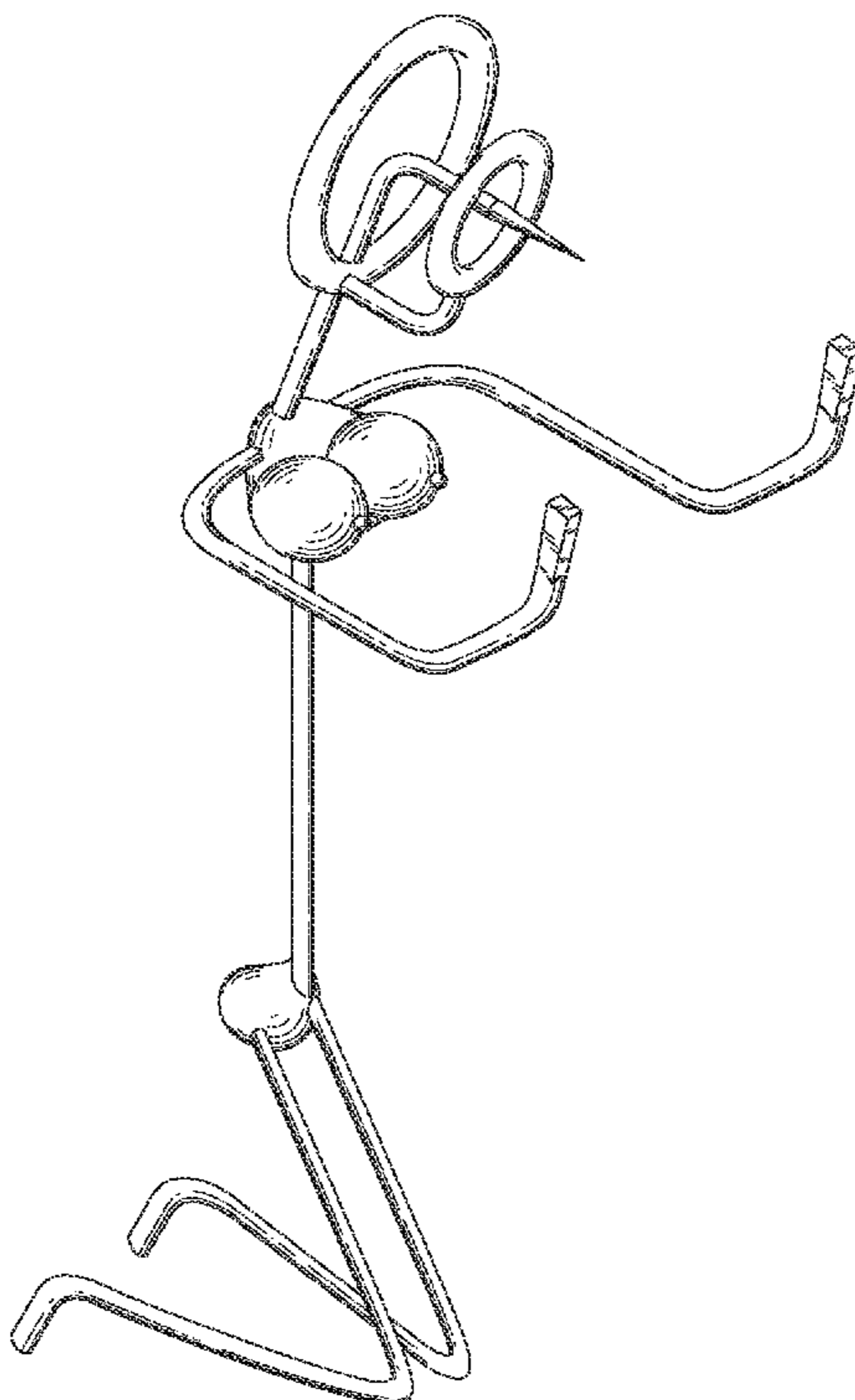
FIG. 7 is a back end view of the roasting stick for open fire roasting of FIG. 1.

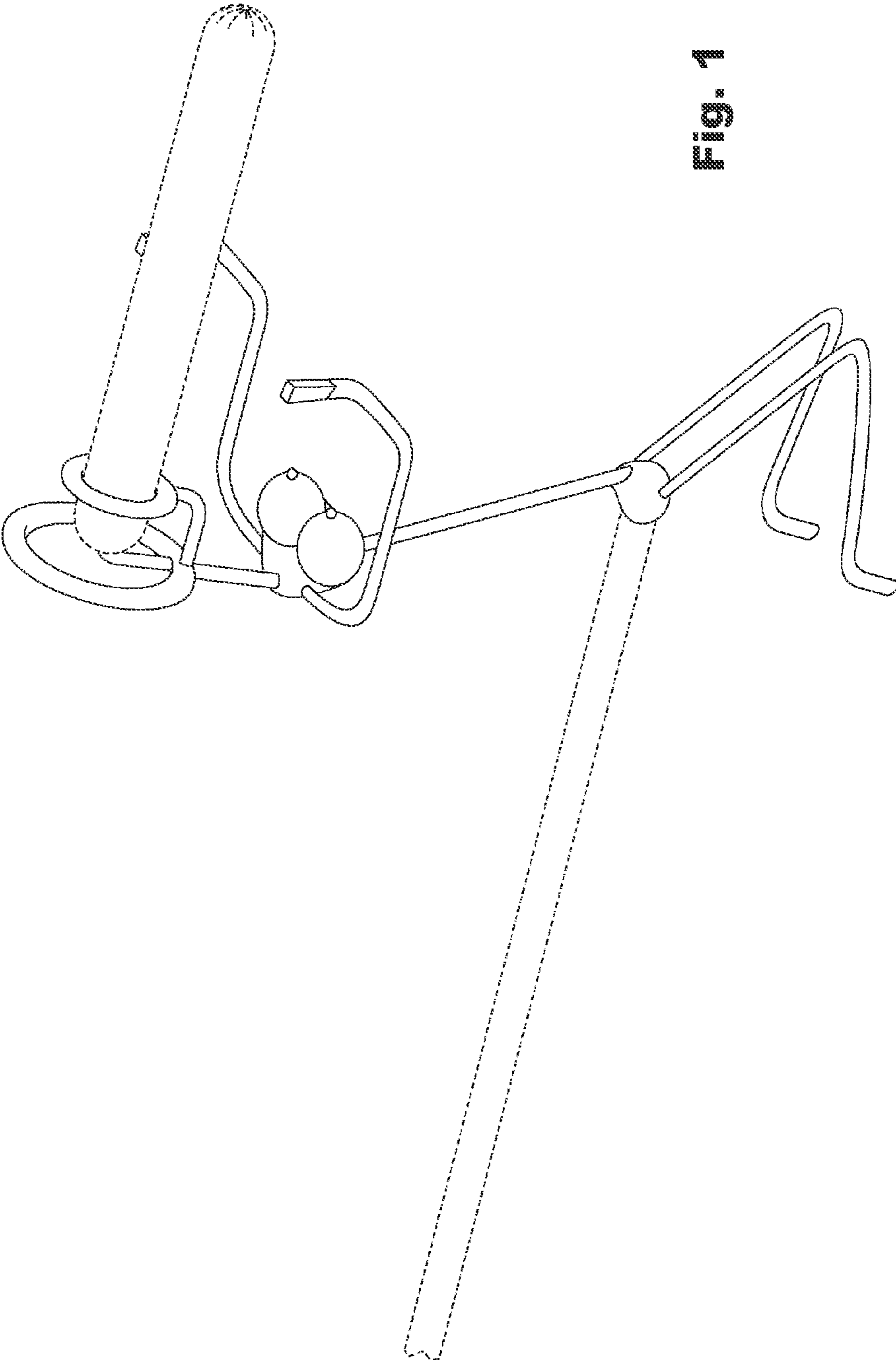

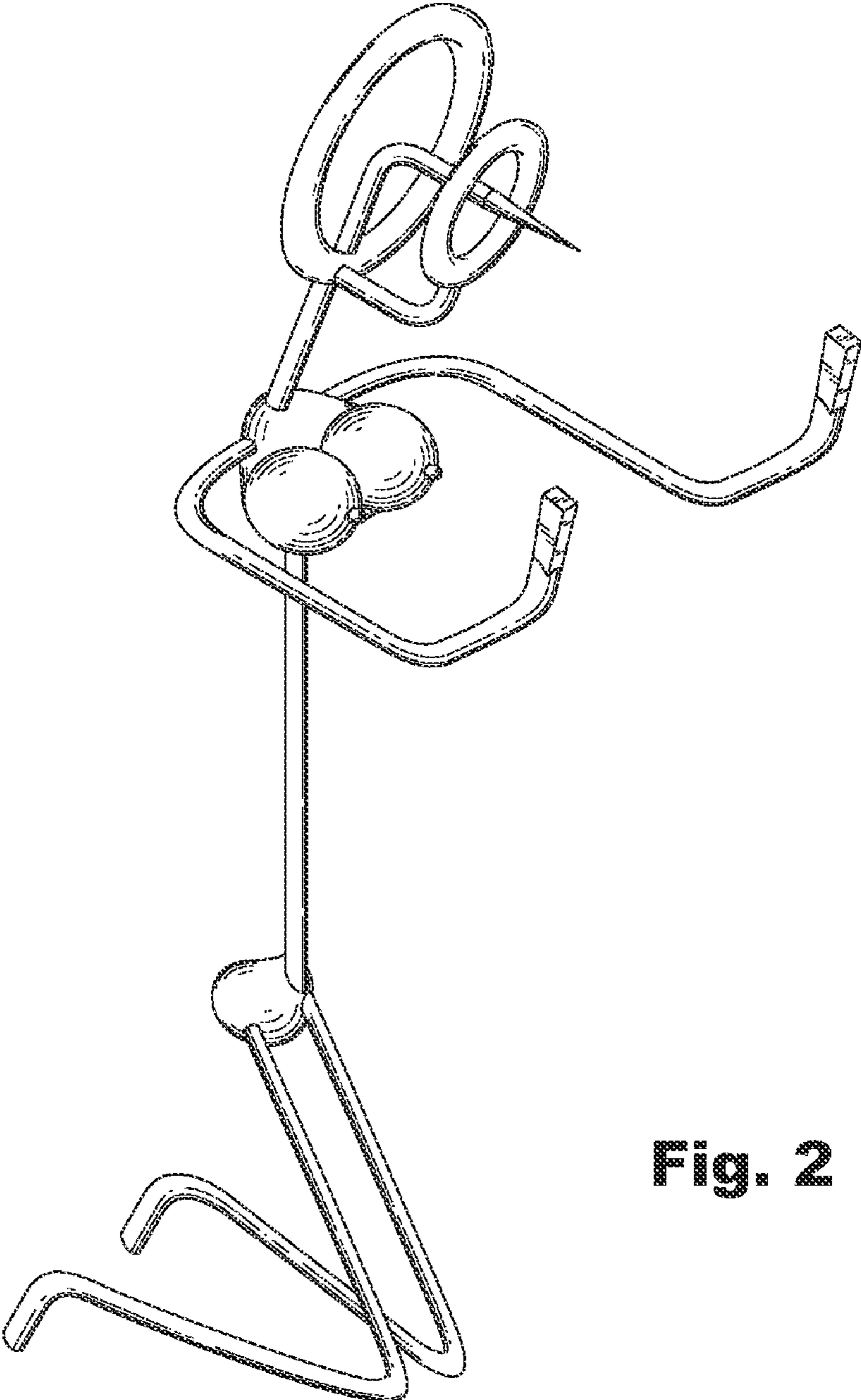

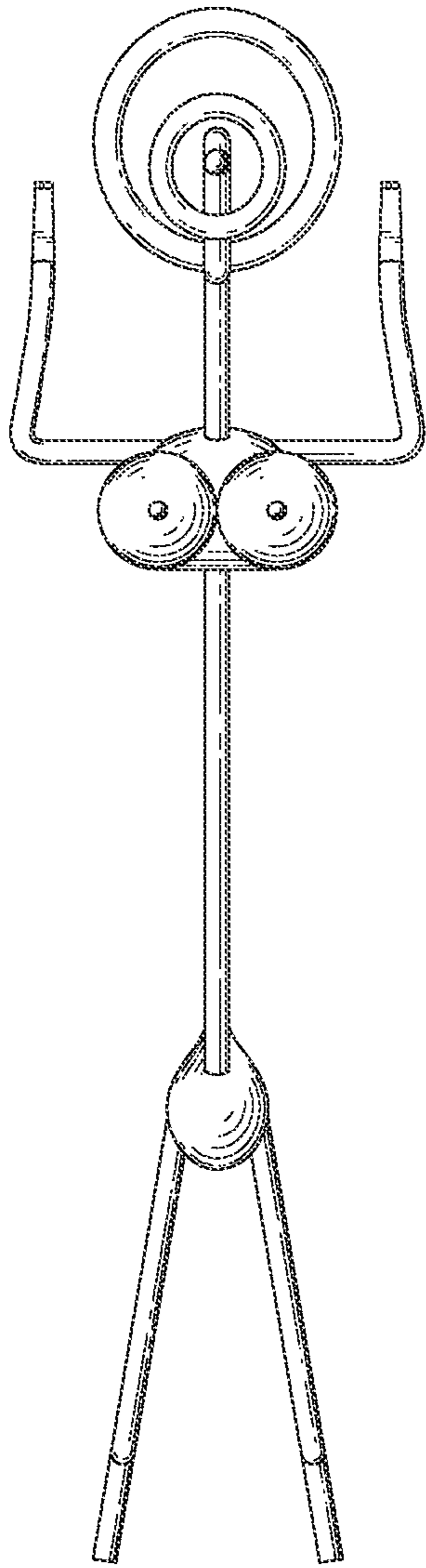

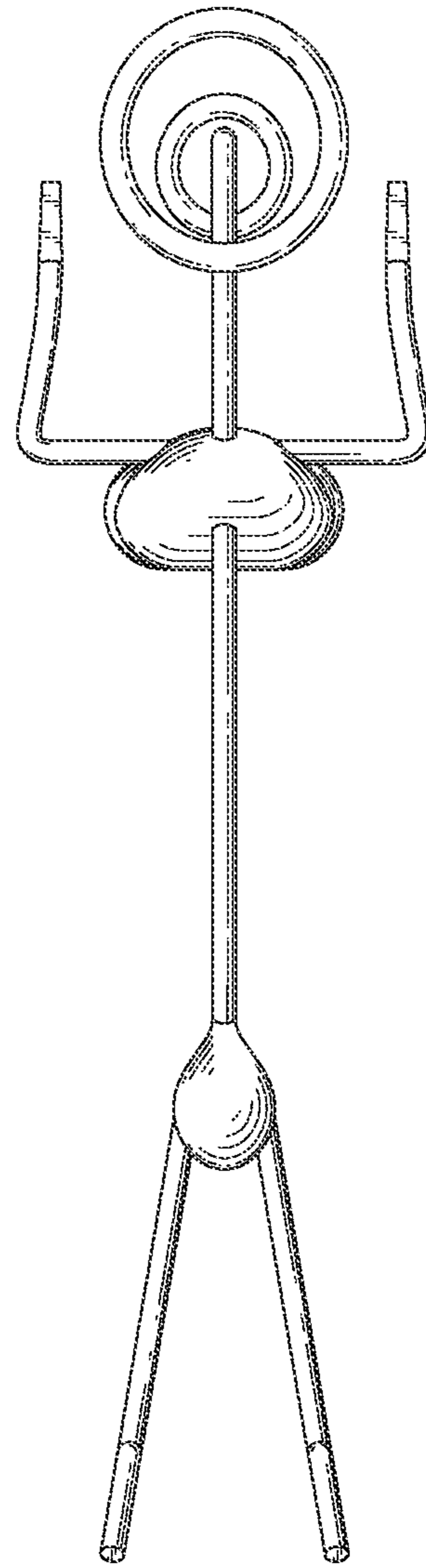

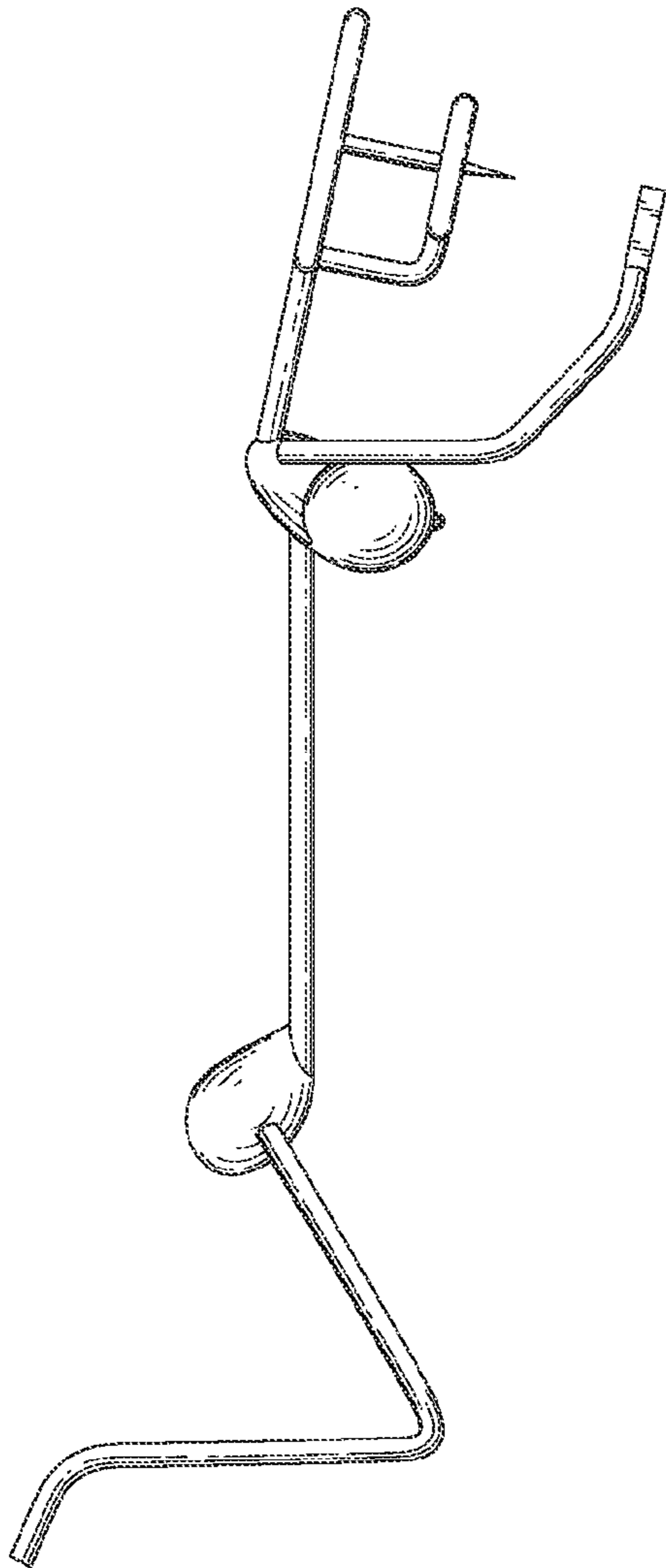

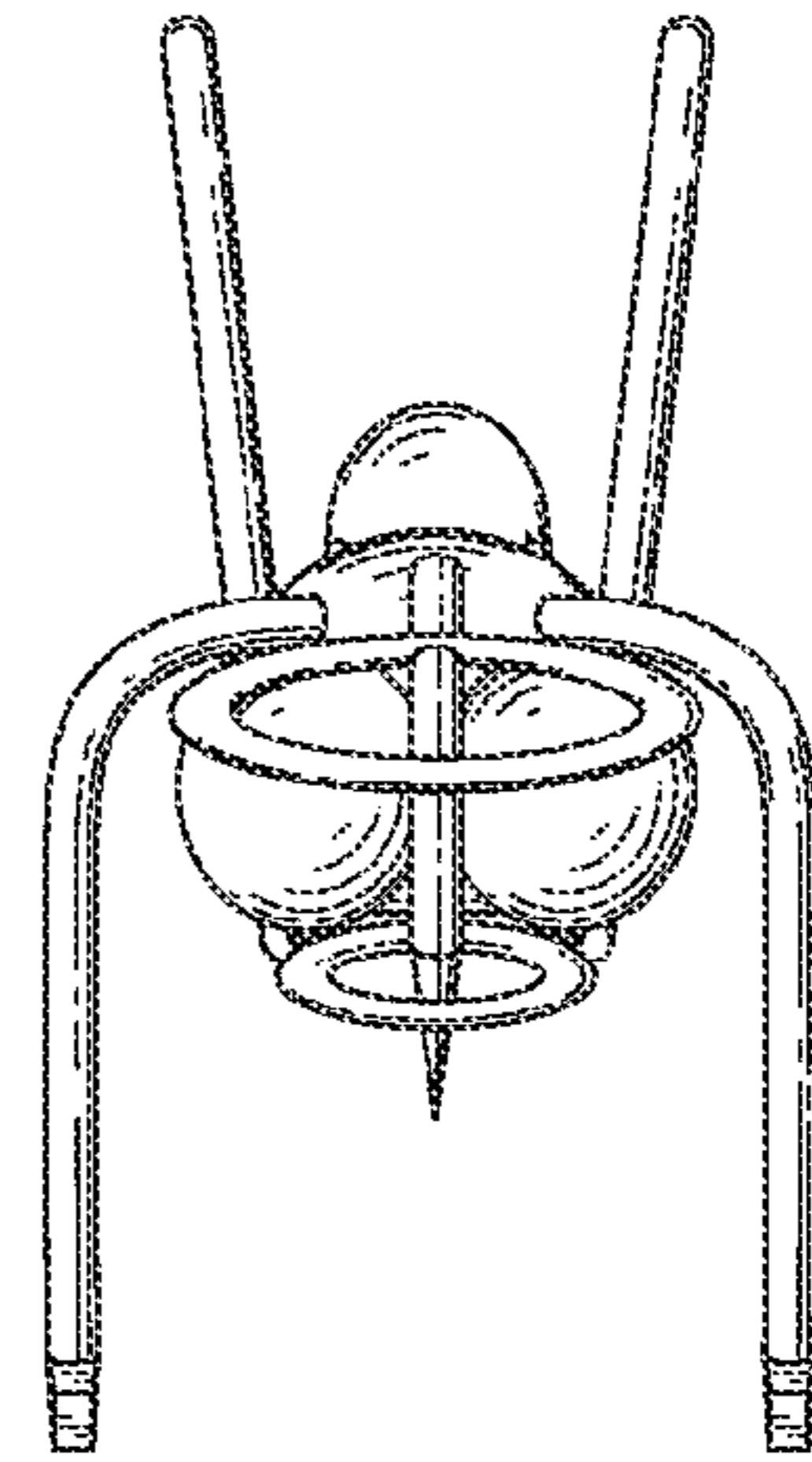

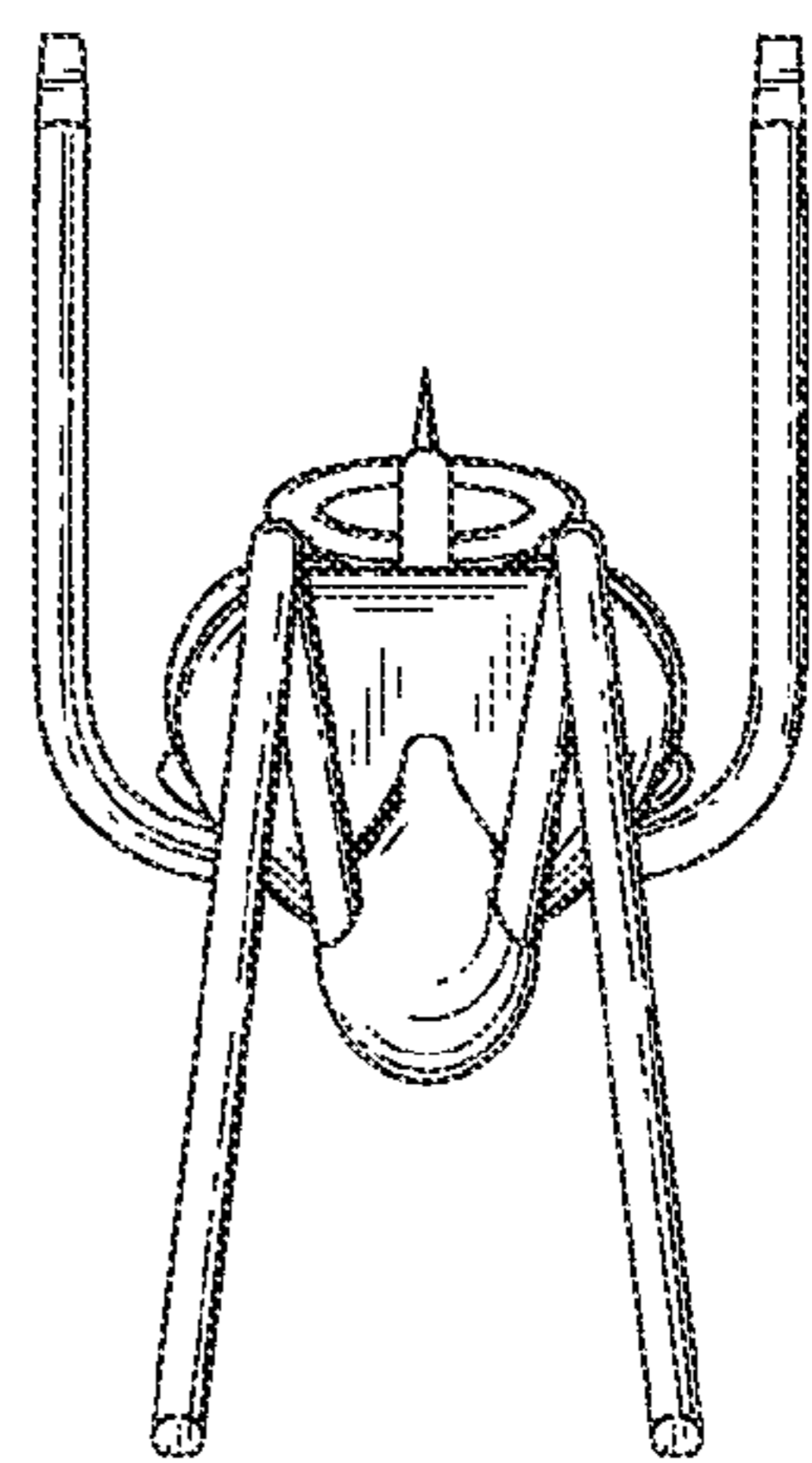
