The ornamental design for a container with swirled side walls, as shown and described.

**DESCRIPTION**

FIG. 1 is a top isometric view of a container with swirled side walls, showing my design.

FIG. 2 is a top view thereof.

FIG. 3 is a front elevation view thereof.

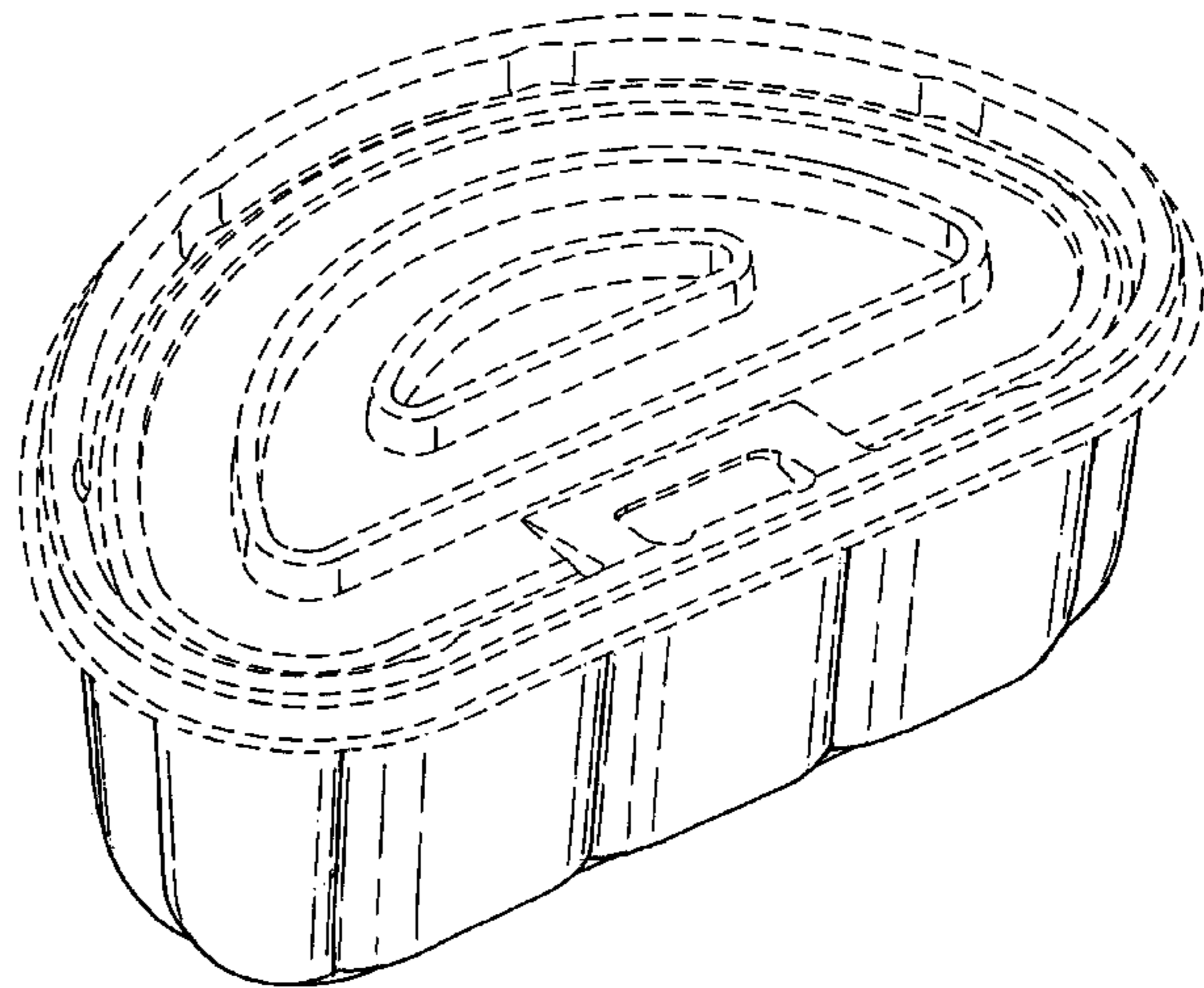
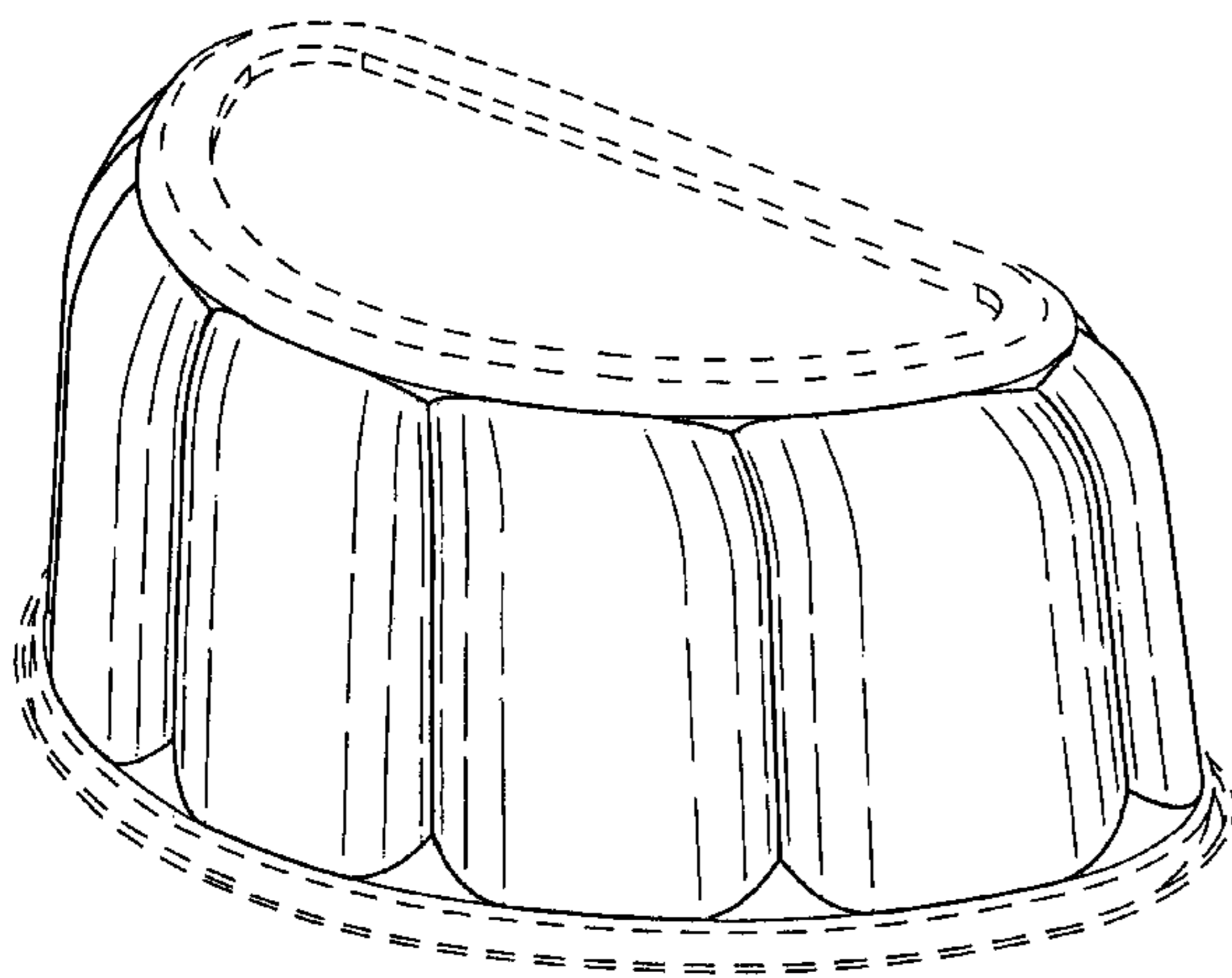
FIG. 4 is a right side elevation view thereof, the left side elevation being a mirror image thereto.

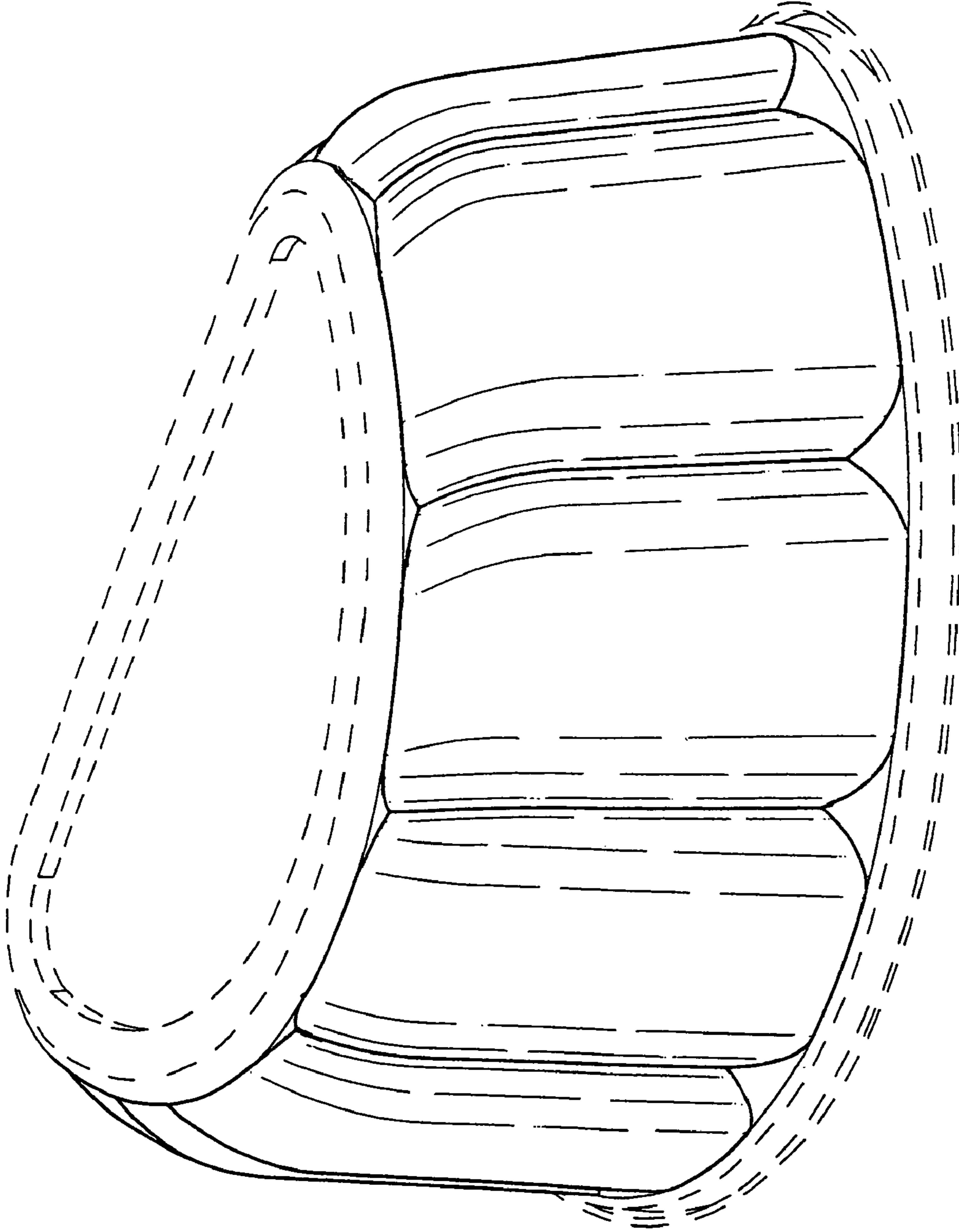

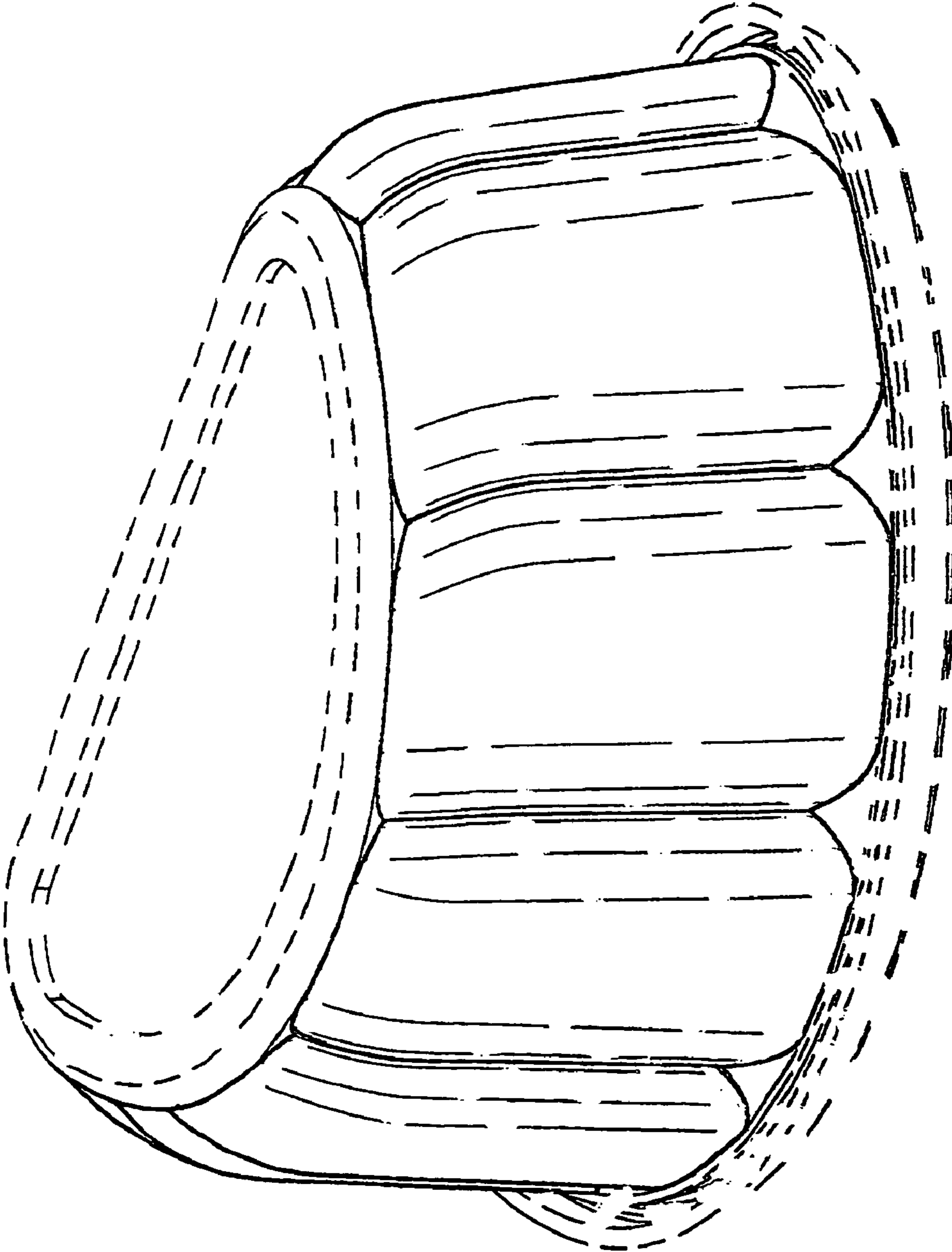

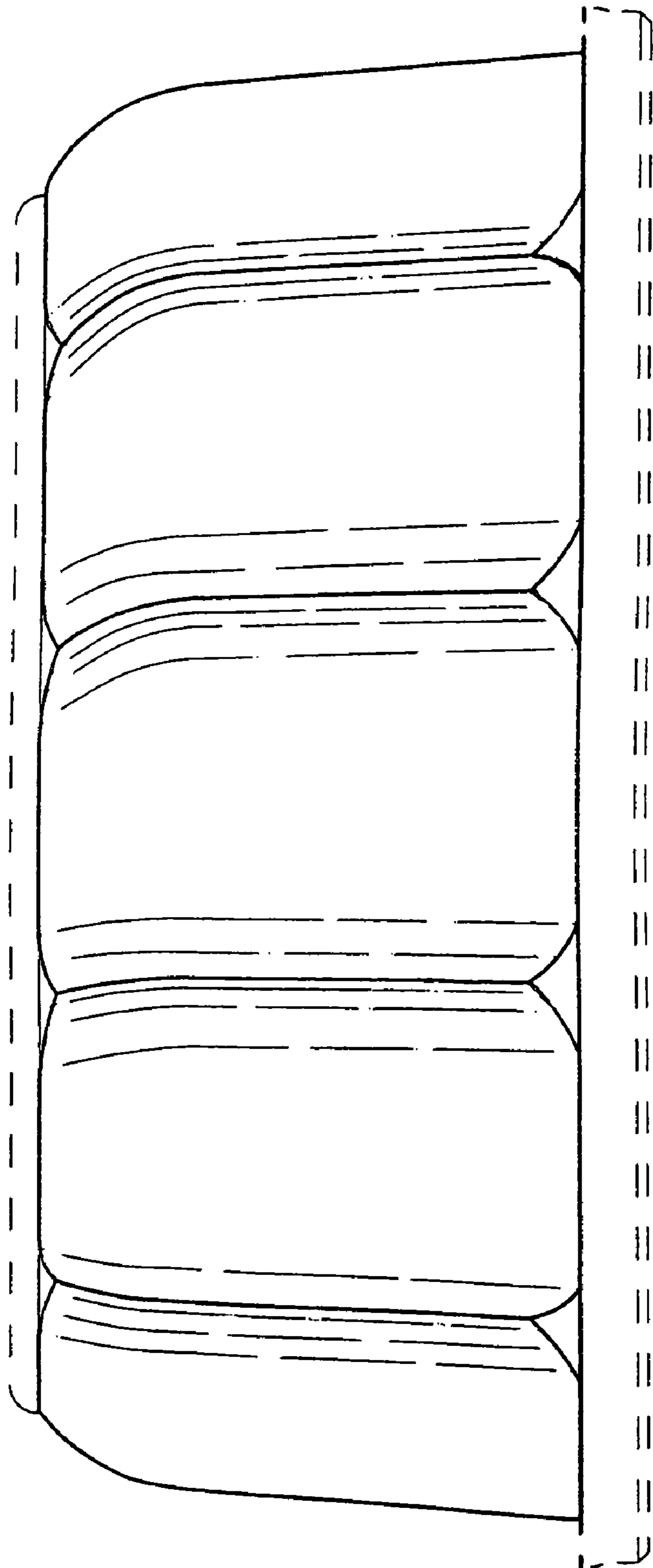

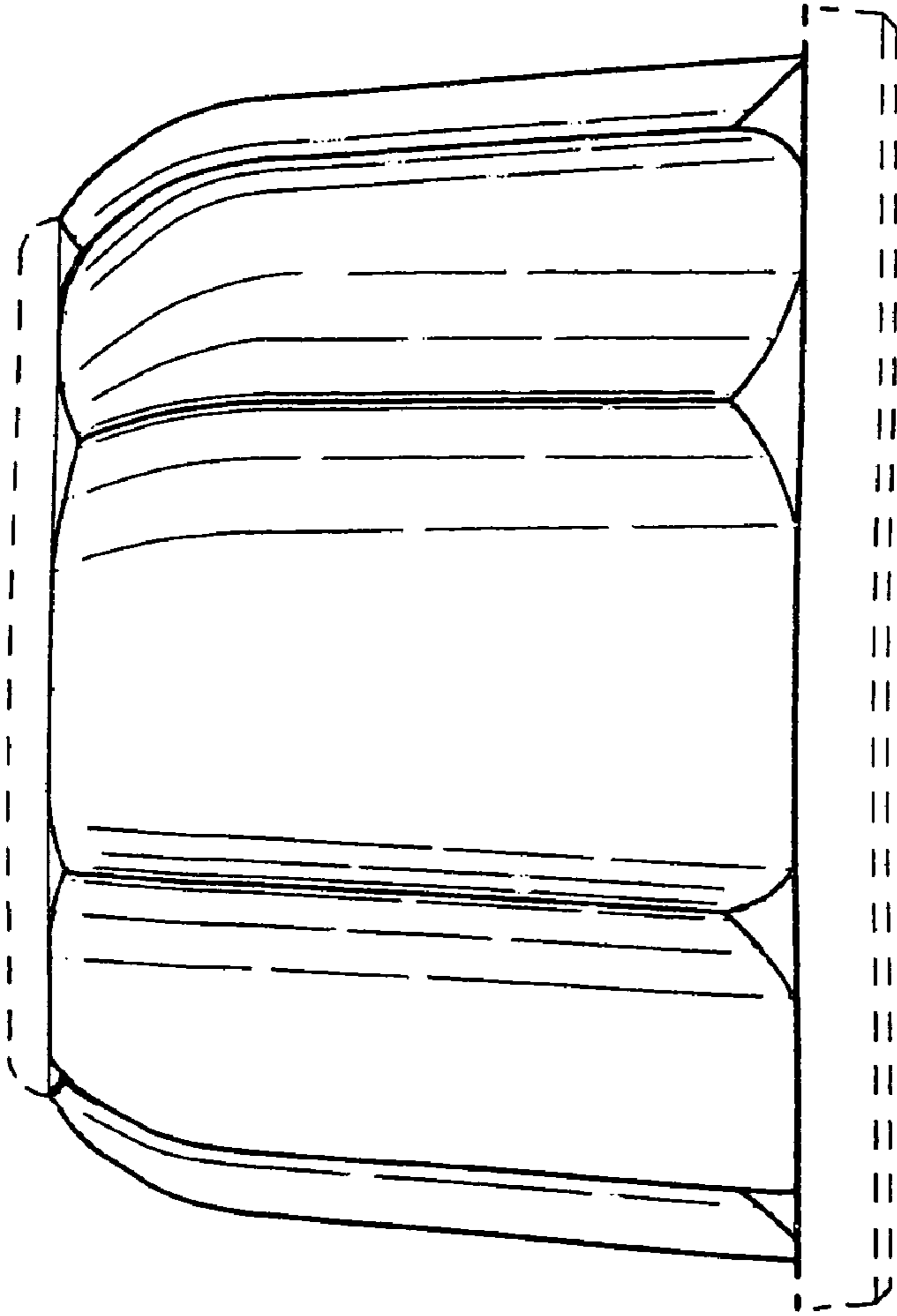

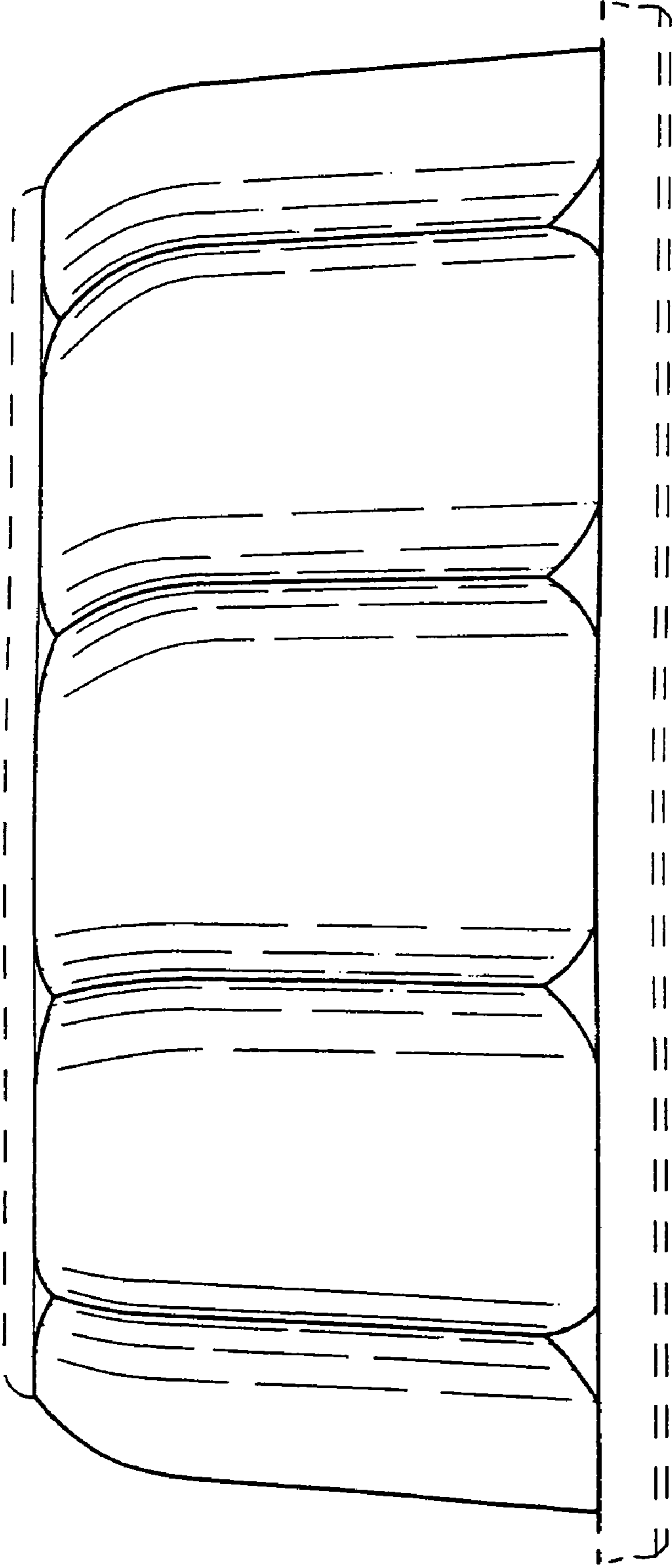

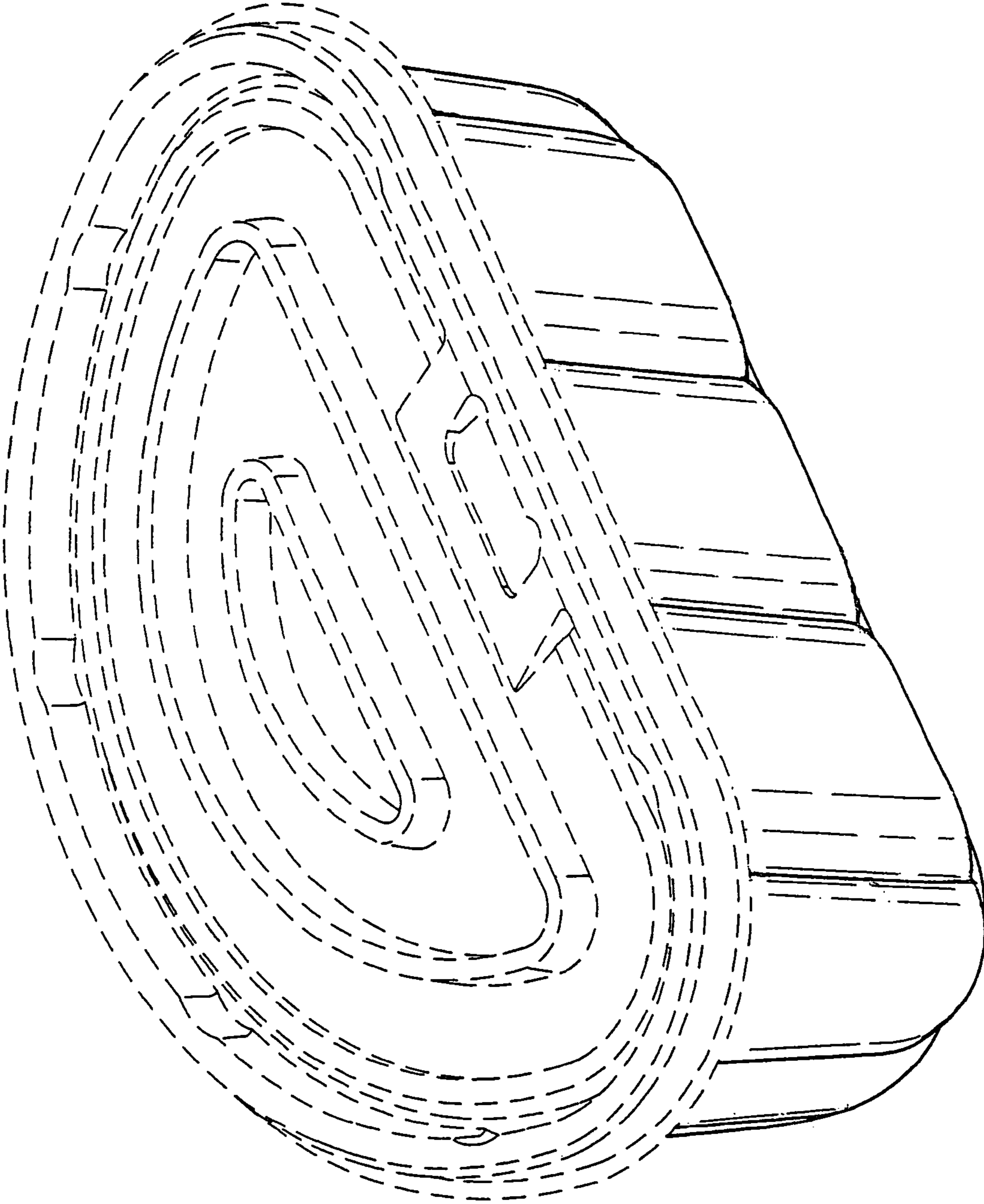
