(57) **CLAIM**

The ornamental design for a jar, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a jar showing my new design;

FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image thereof;

FIG. 3 is a right side elevation view thereof, the left side elevation view being a mirror image thereof;

FIG. 4 is a top view thereof; and,

FIG. 5 is a bottom view thereof.

The broken line showing of a pour spout in FIGS. 1-3 and the bottom of the jar in FIG. 4 is included for the purpose of illustrating only and forms no part of the claimed design.

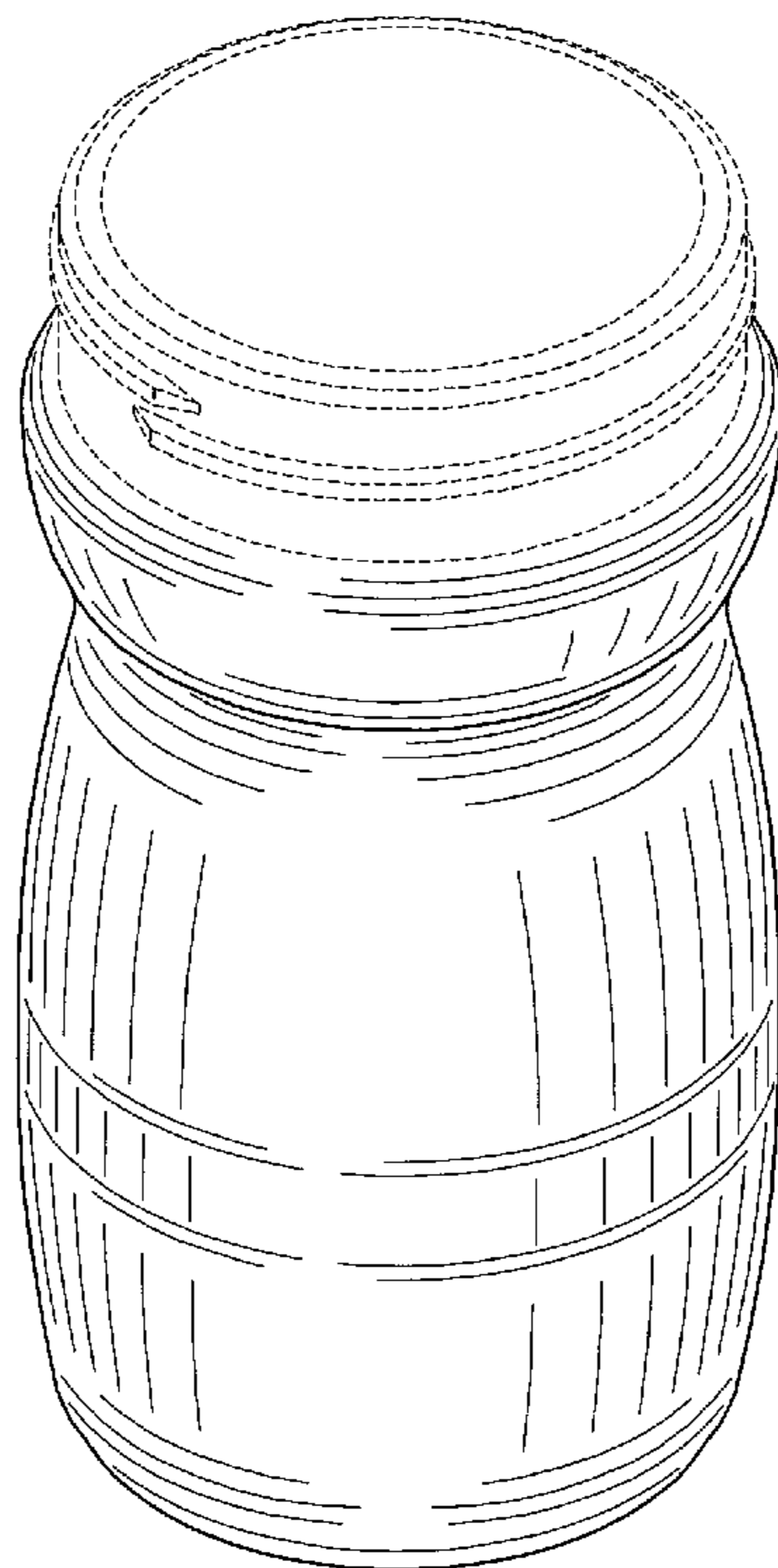

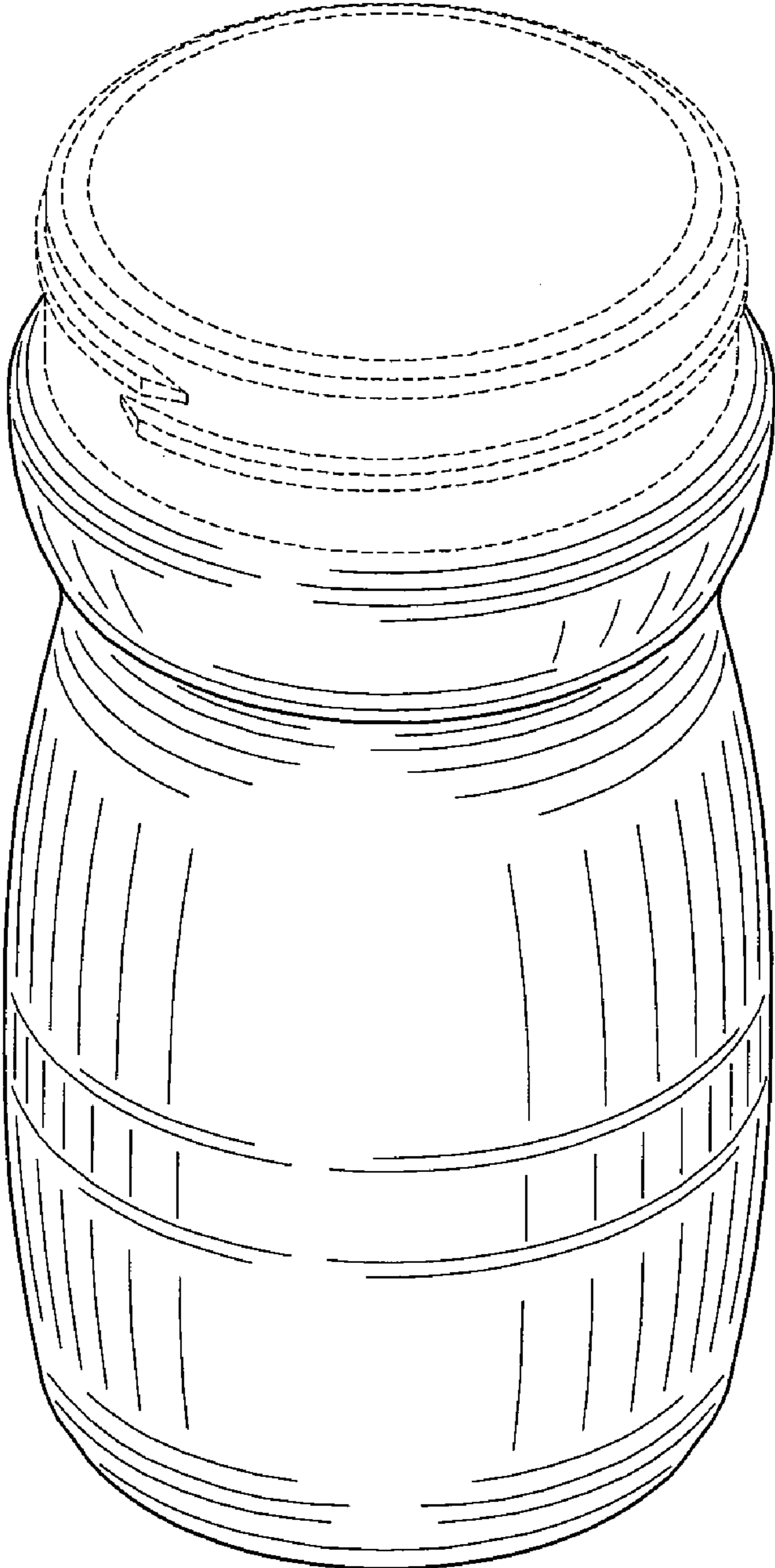

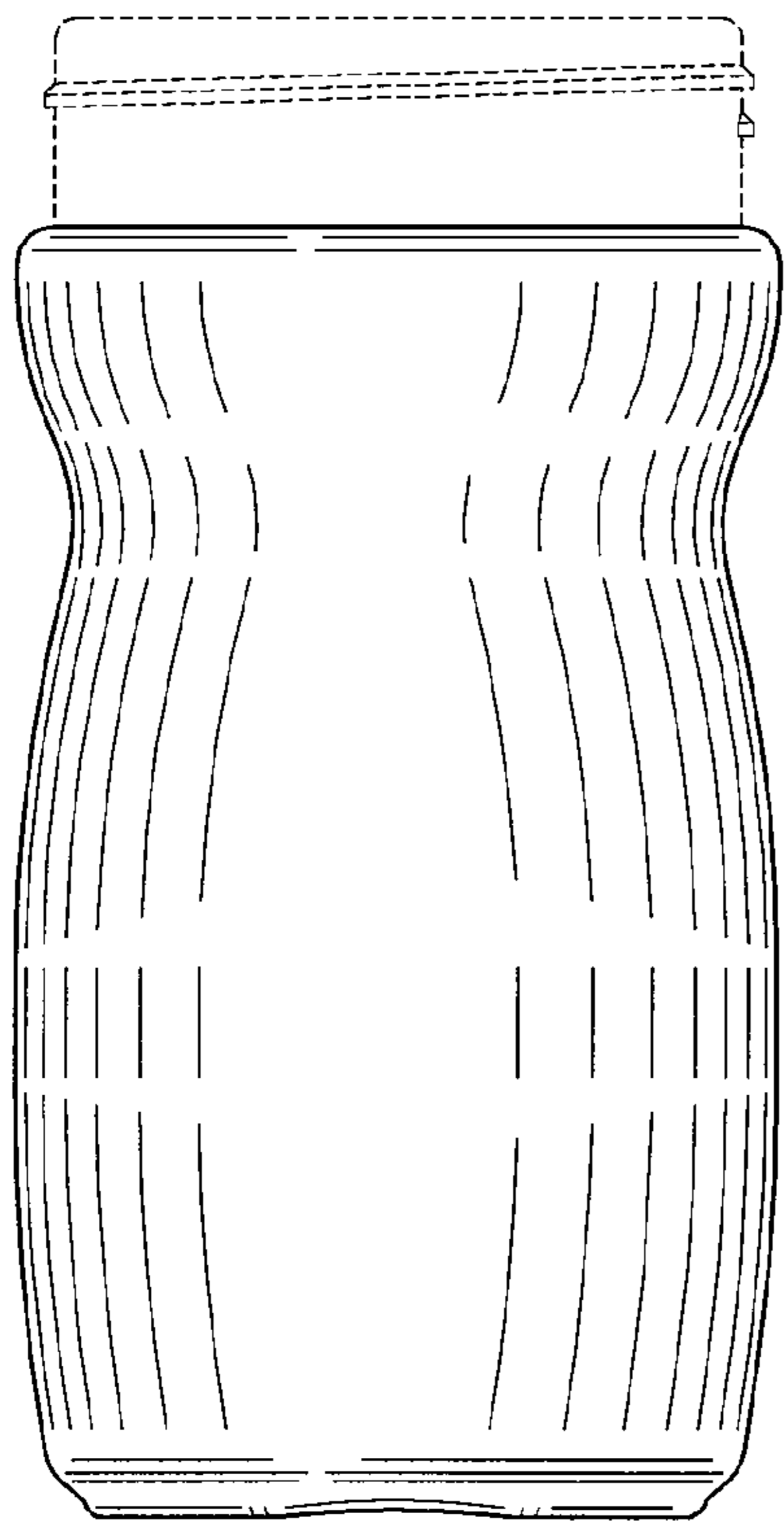

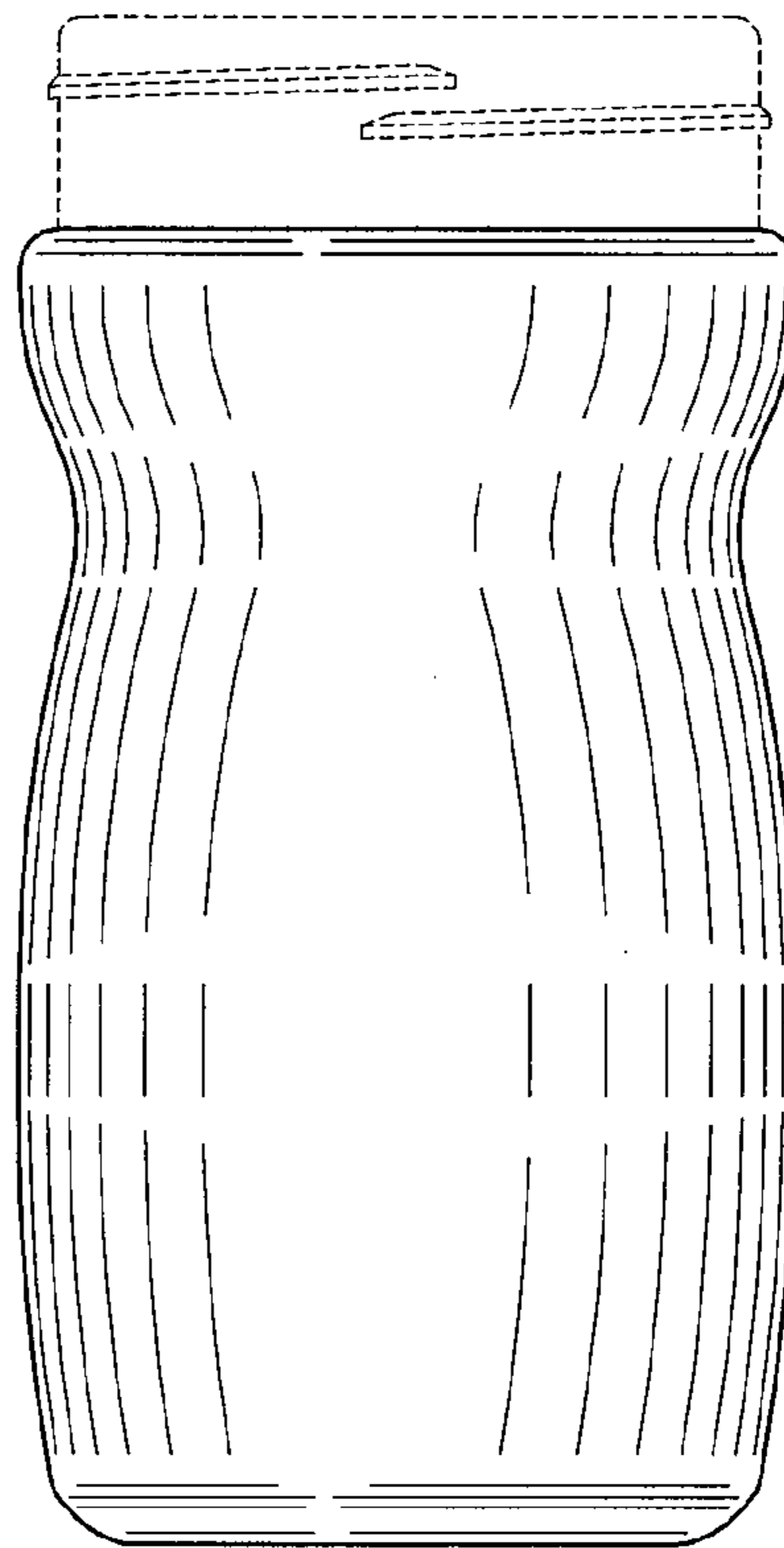

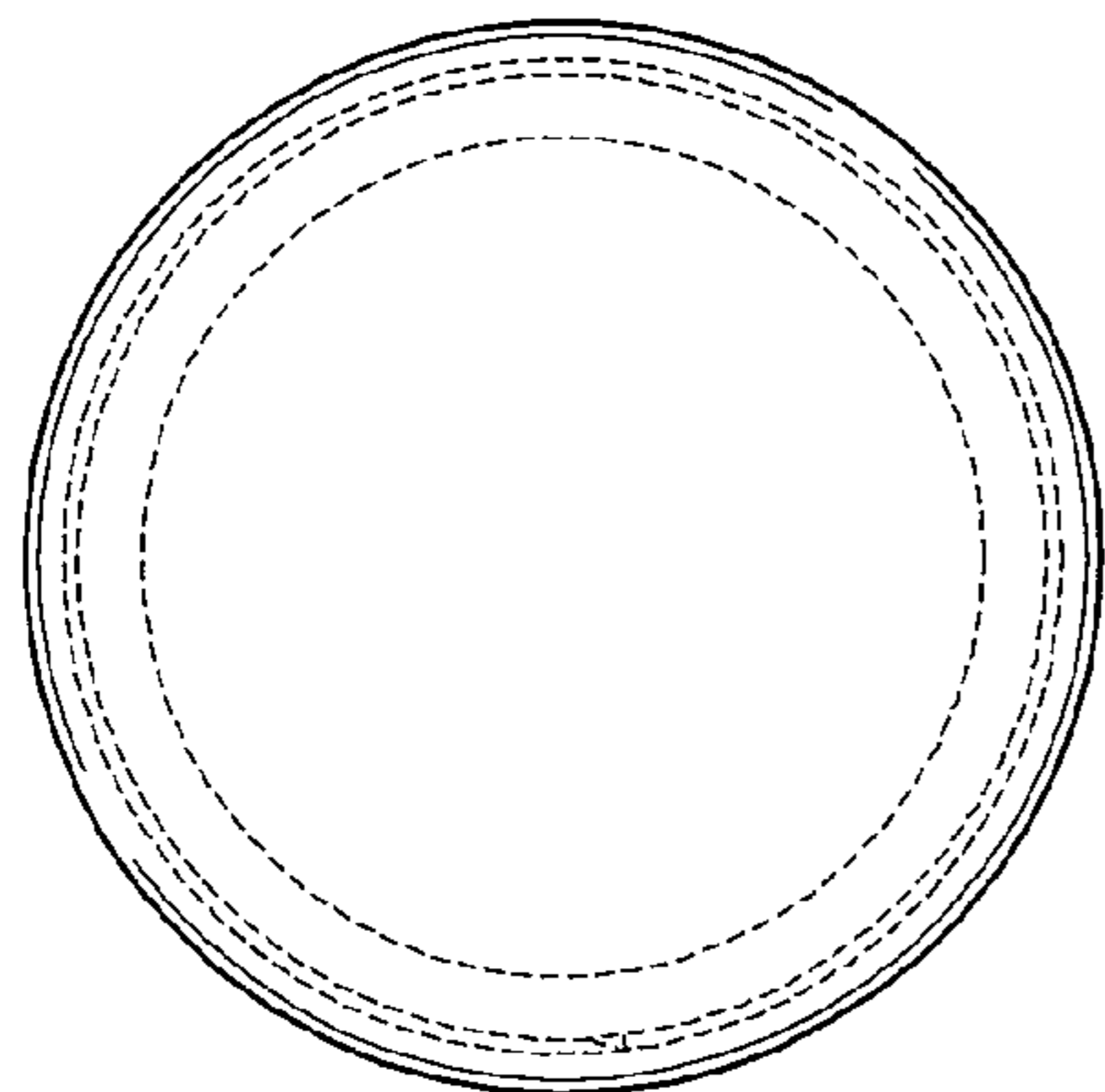
