FIG. 3 is a front view;

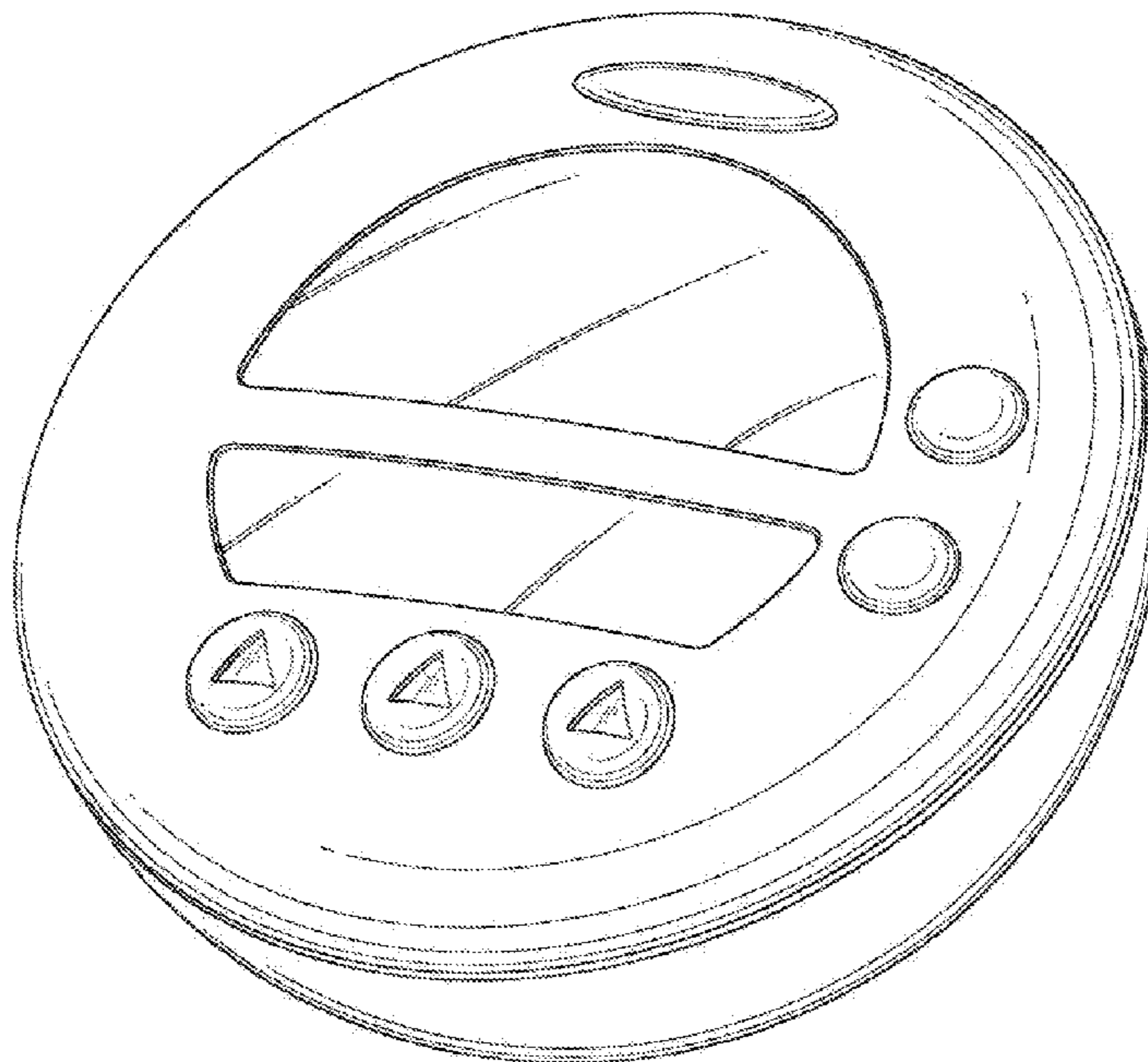
FIG. 4 is a rear view;

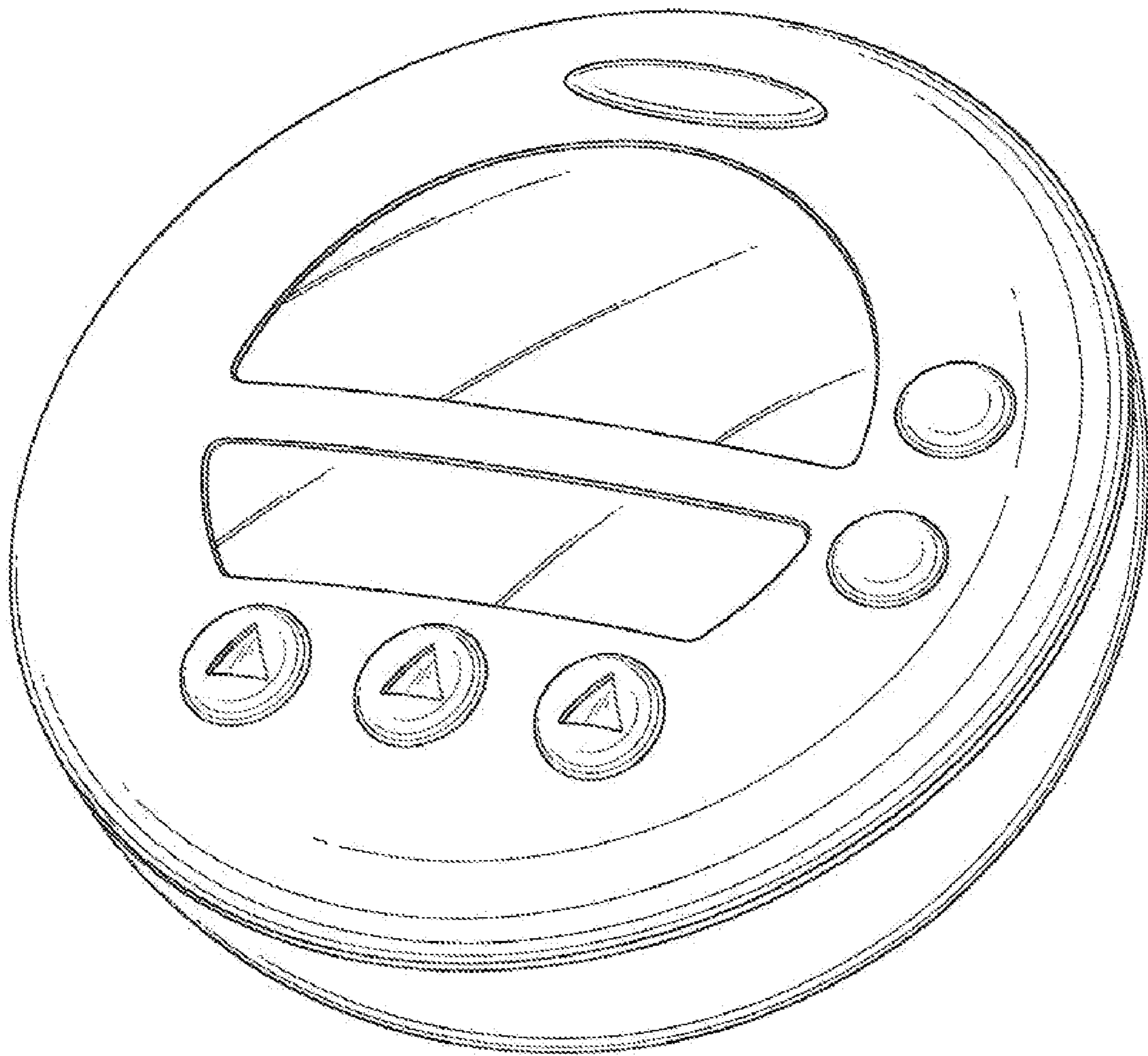

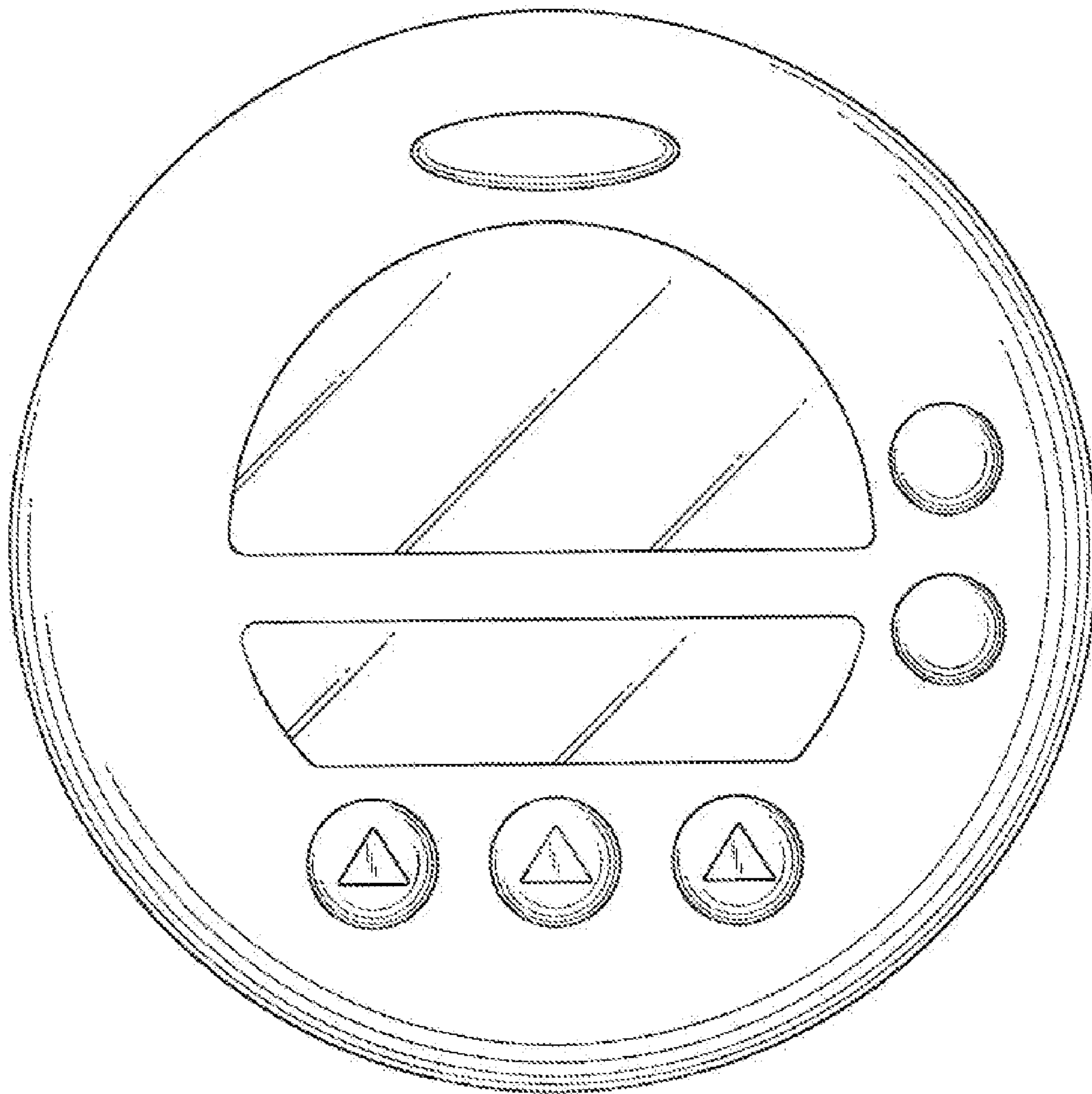

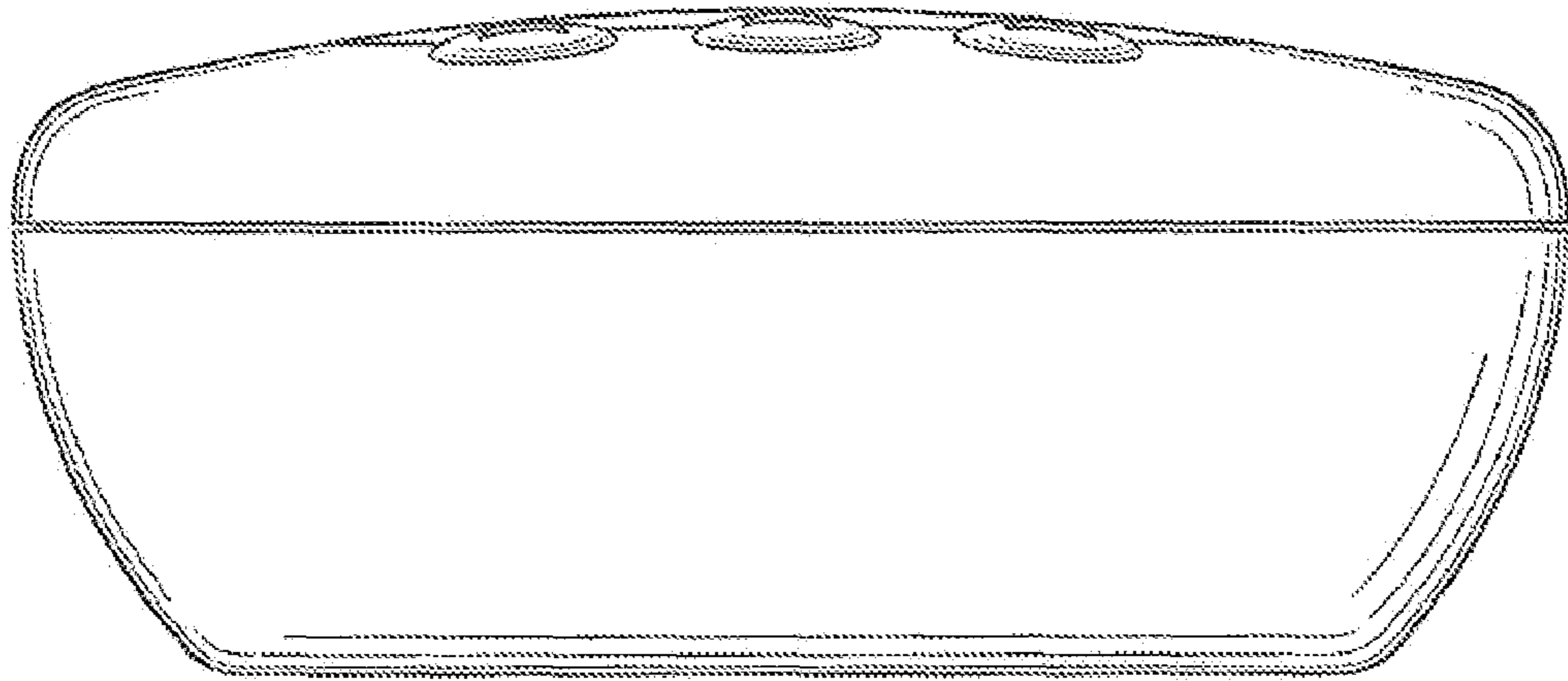

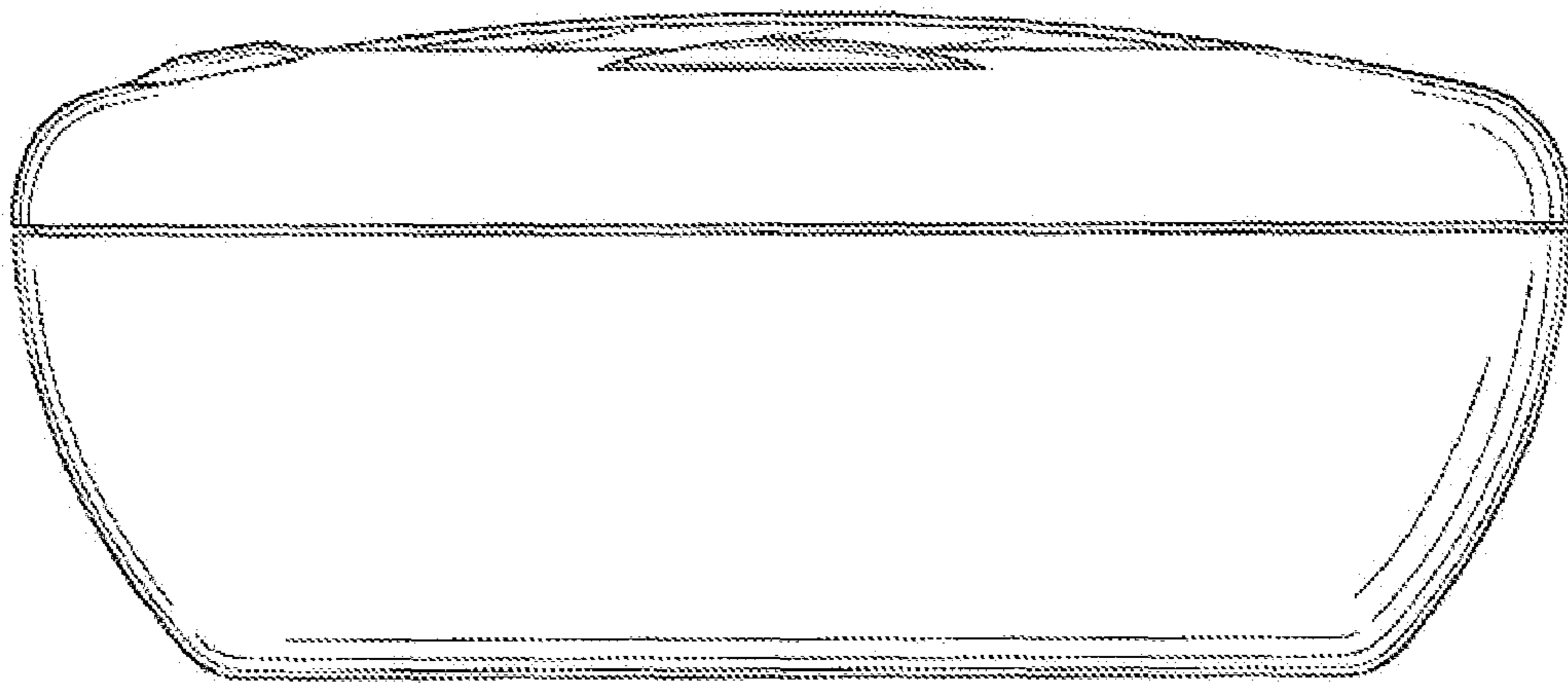

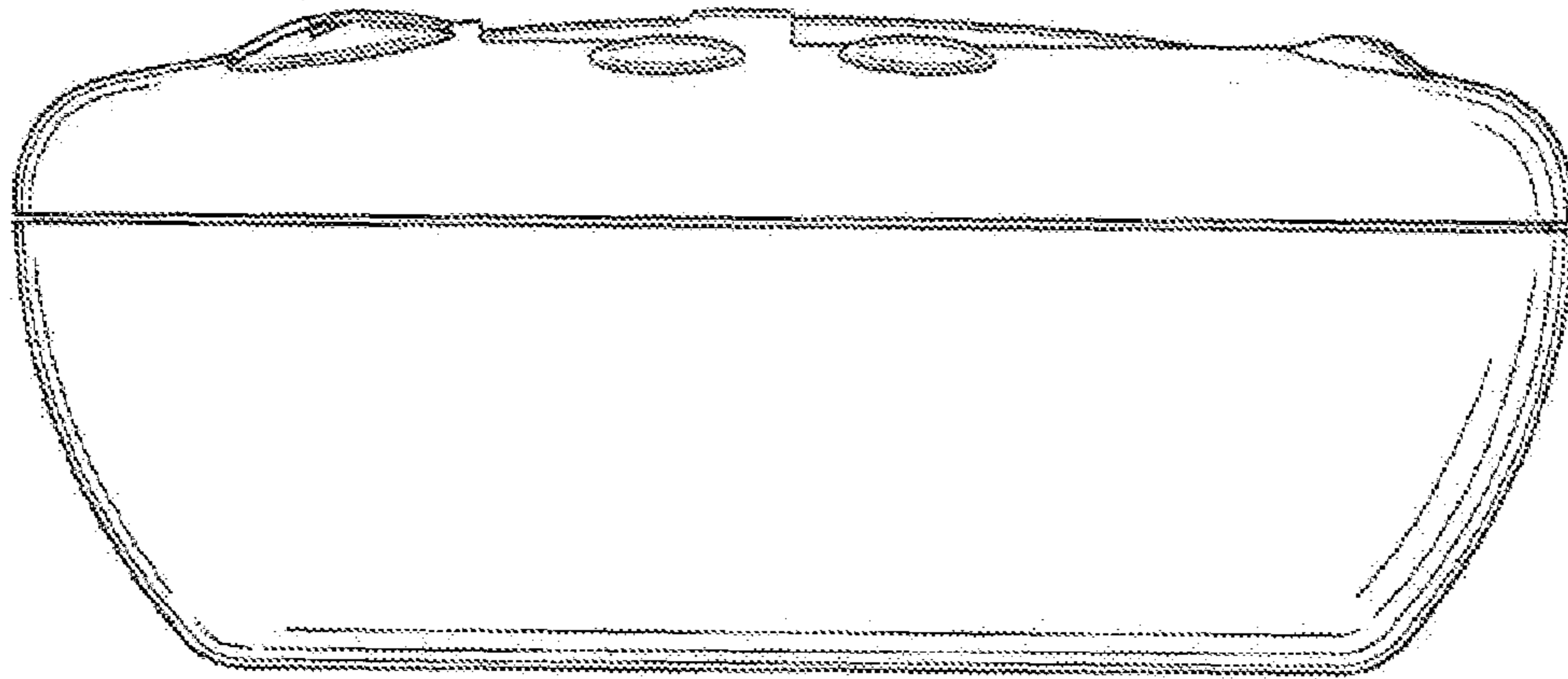

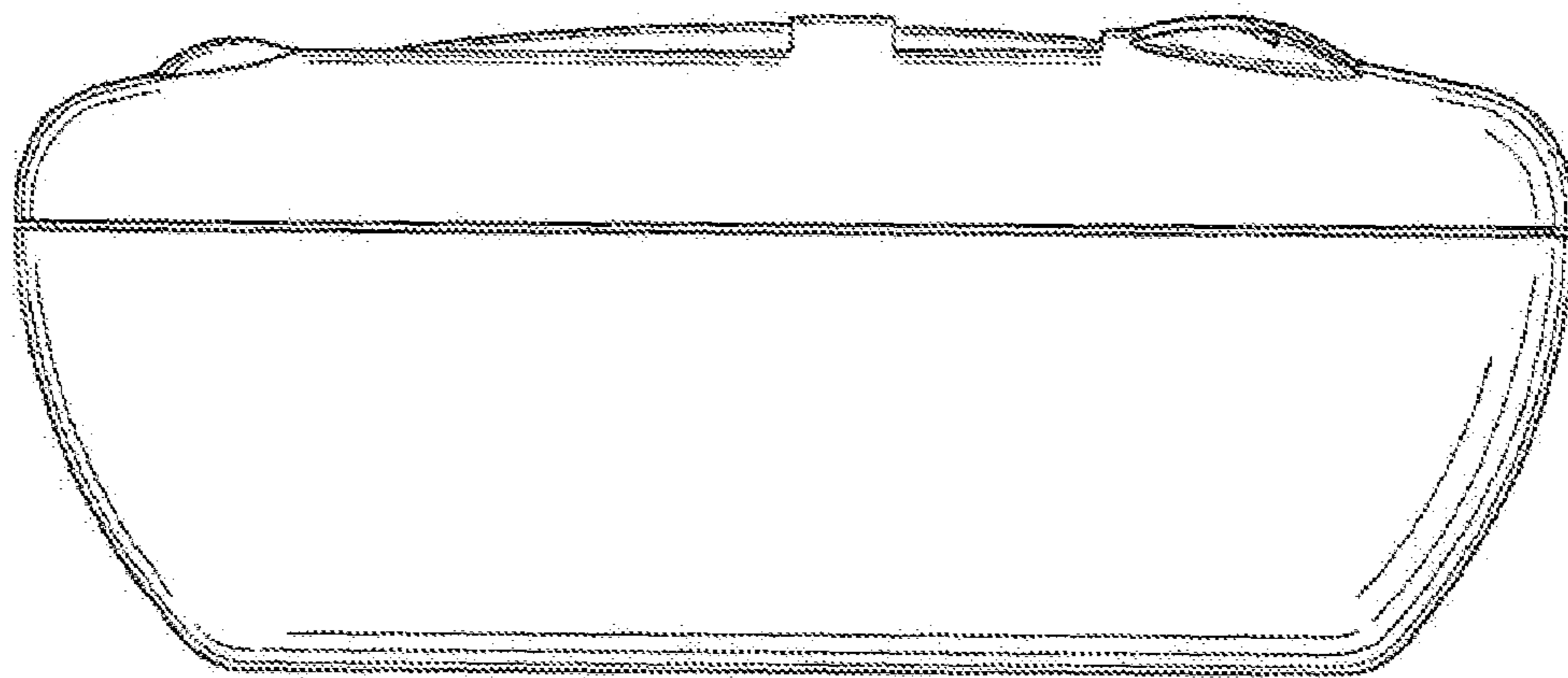

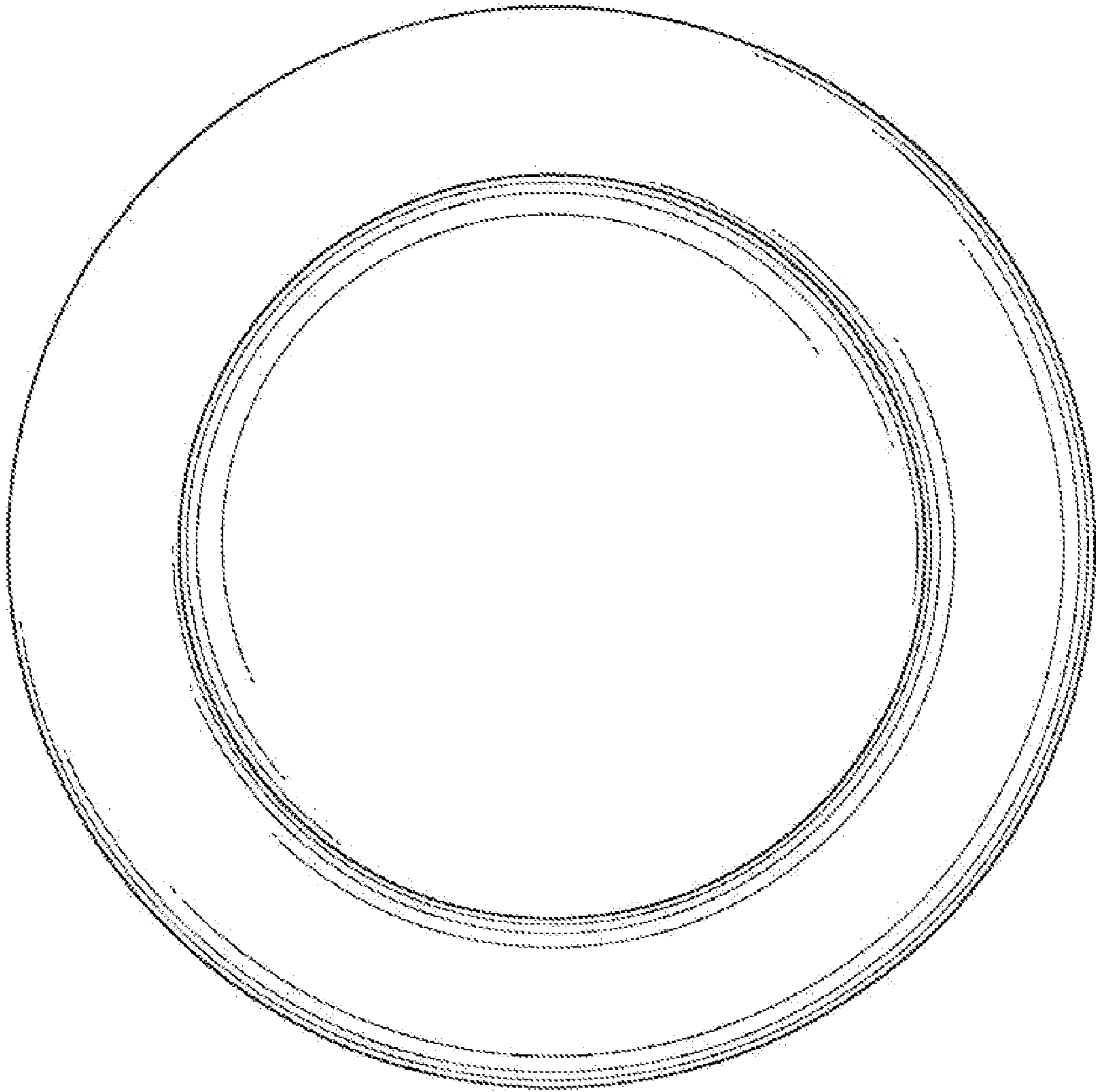
