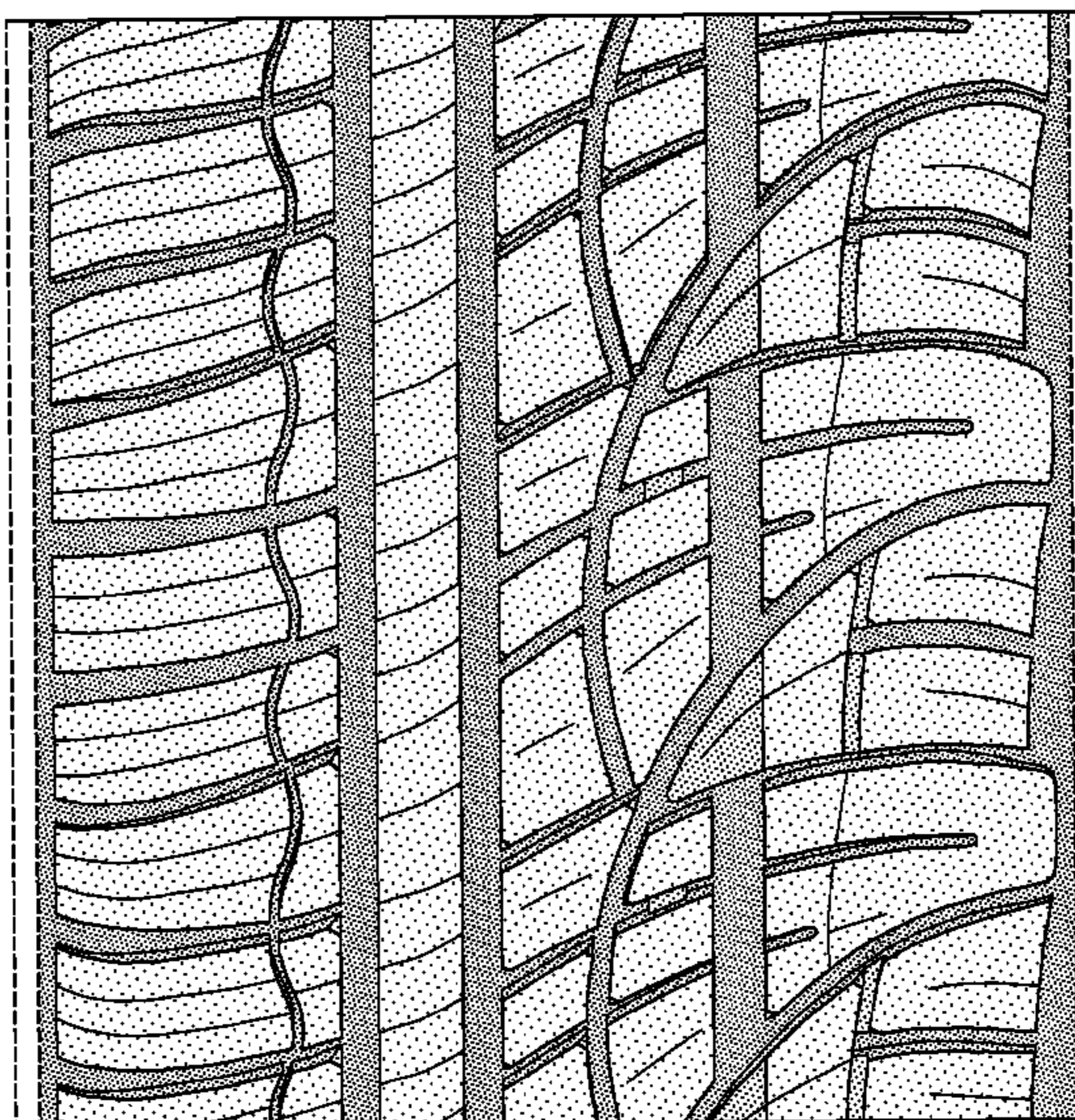
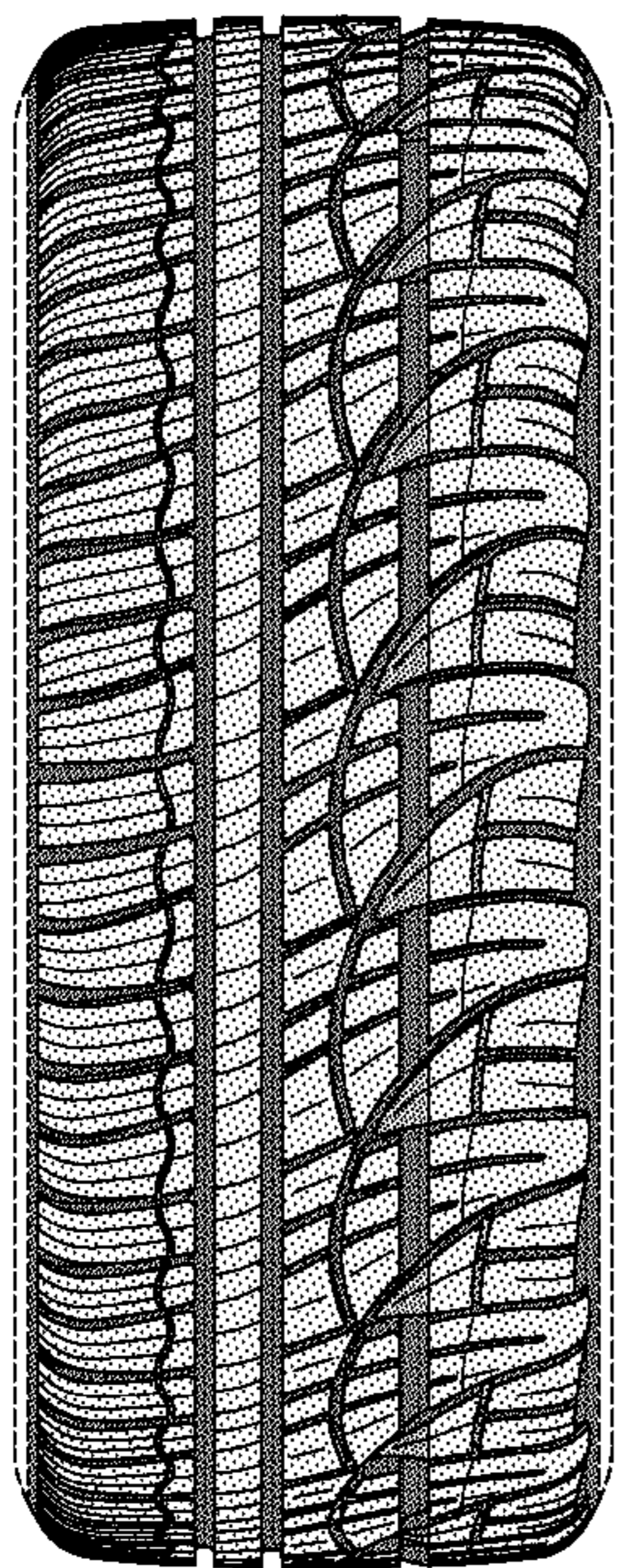

FIG. 7 is a front elevational view of a second embodiment, it
being understood that an enlarged fragmentary view thereof
would be substantially identical to that shown in FIG. 5, with
the exception of the inclusion of the sidewall in solid lines.

In the drawings, the broken line showing of the sidewall, inner
bead and the peripheral boundary between the tire tread and
the sidewall in FIGS. 1 through 4 depict environmental sub-
ject matter and form no part of the claimed design.

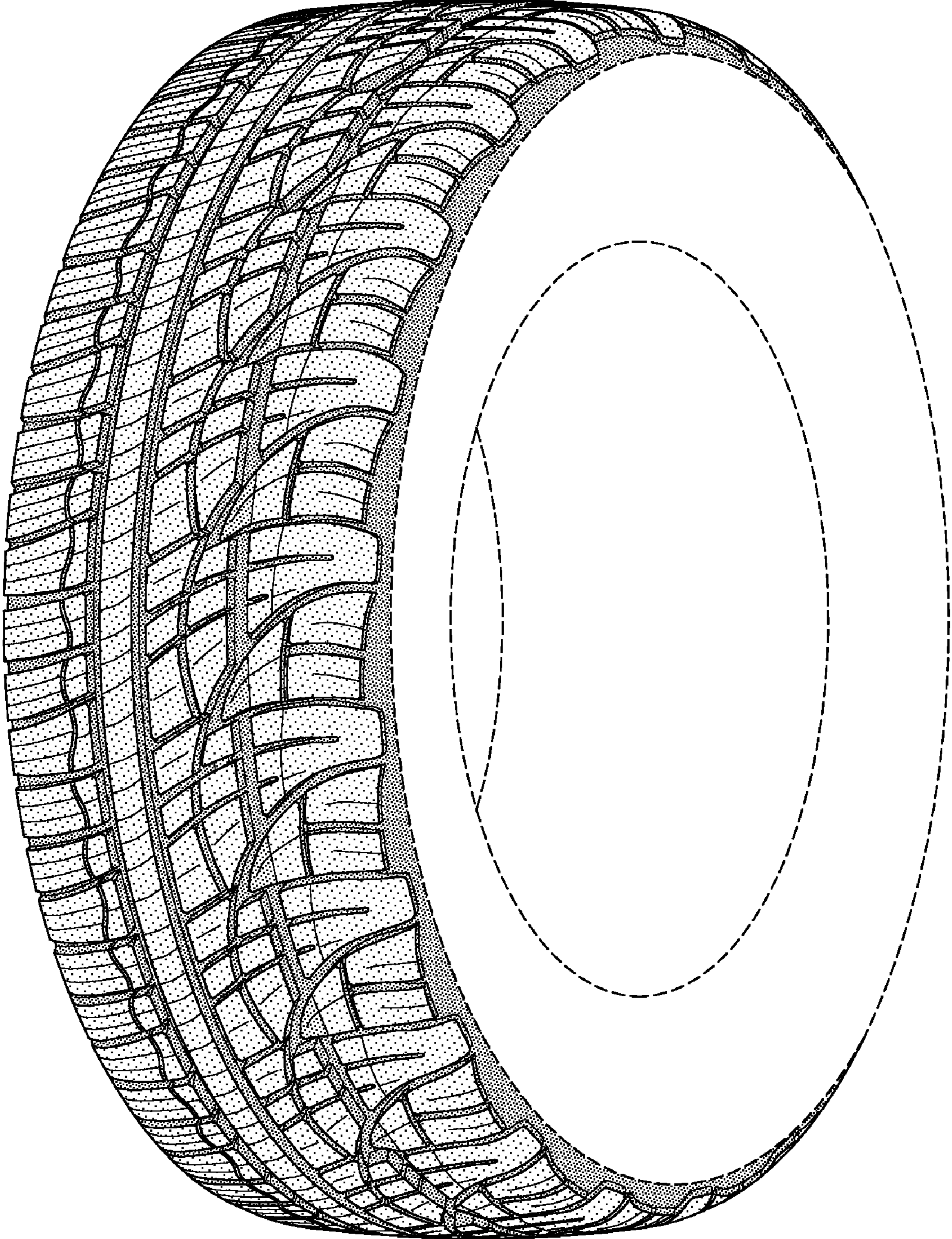

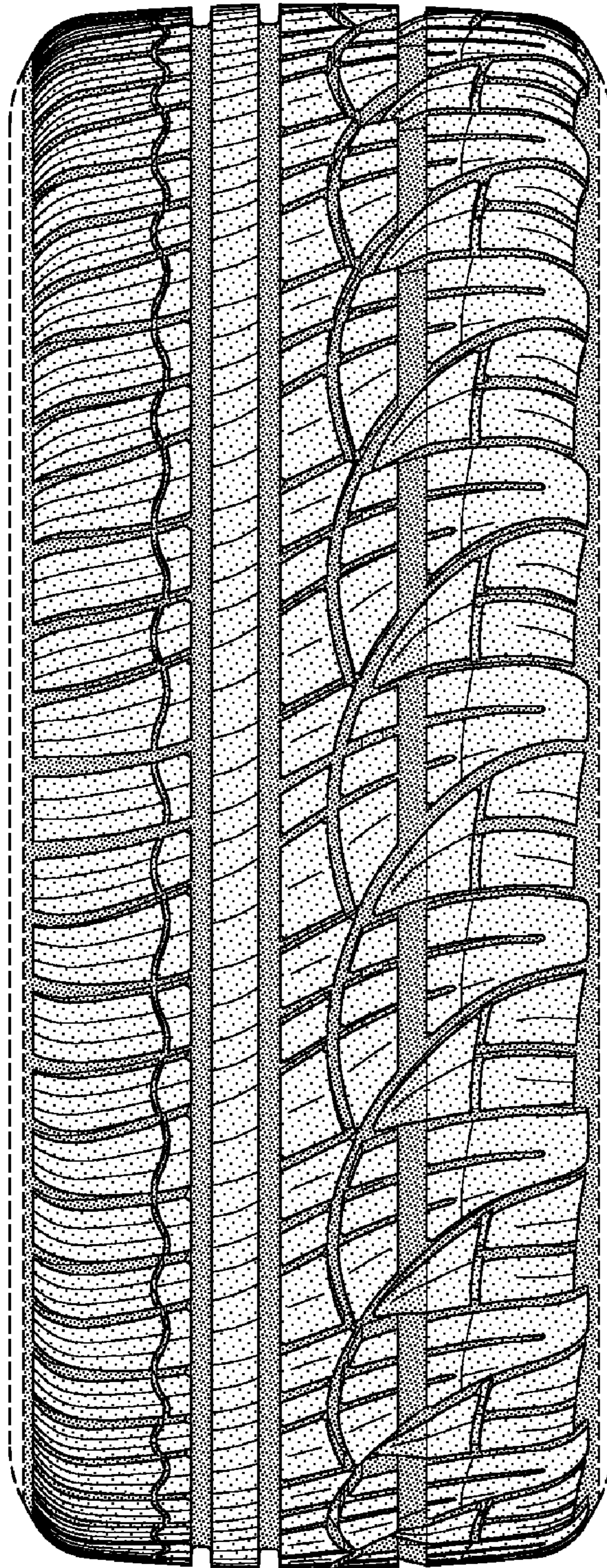

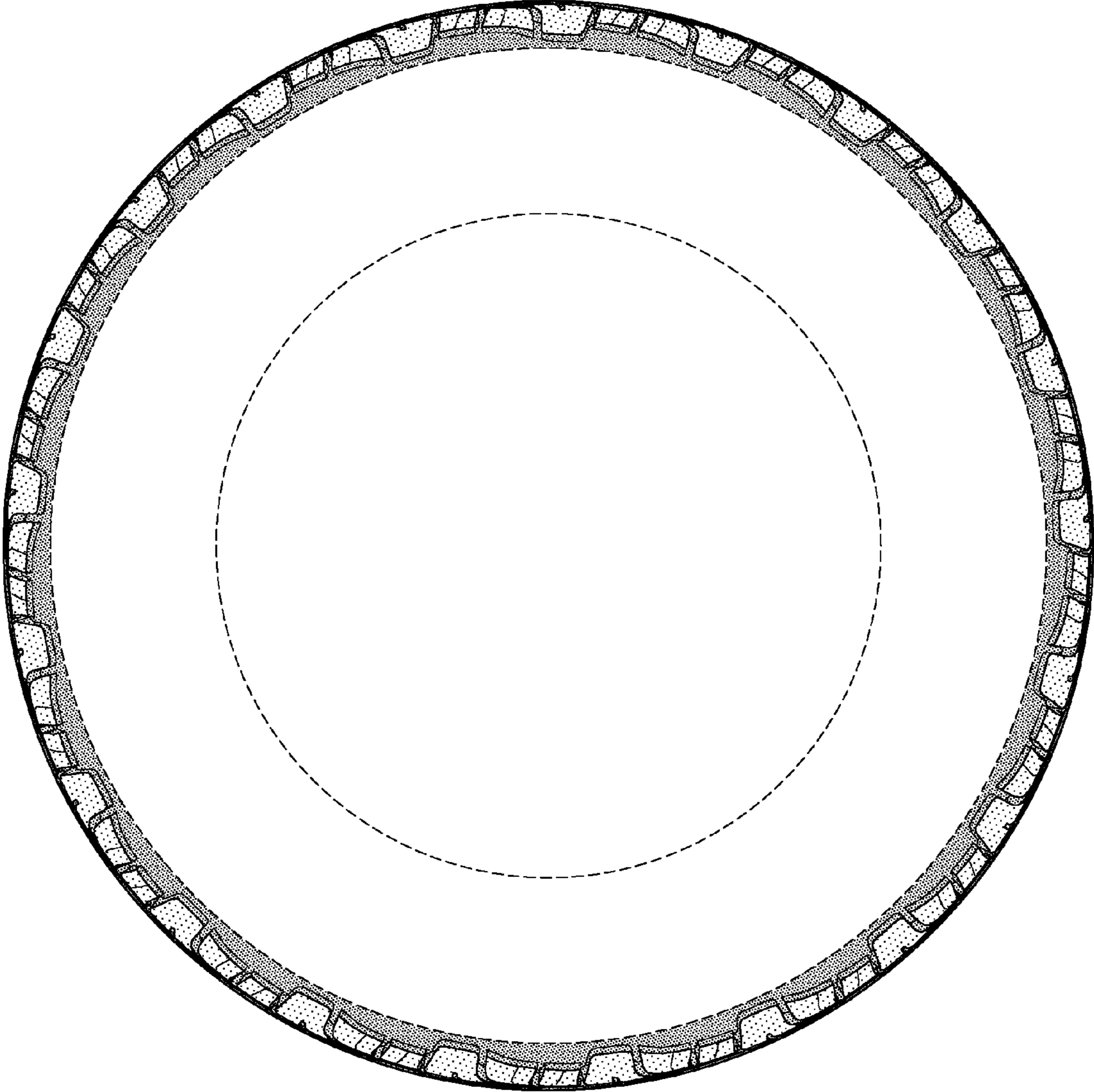

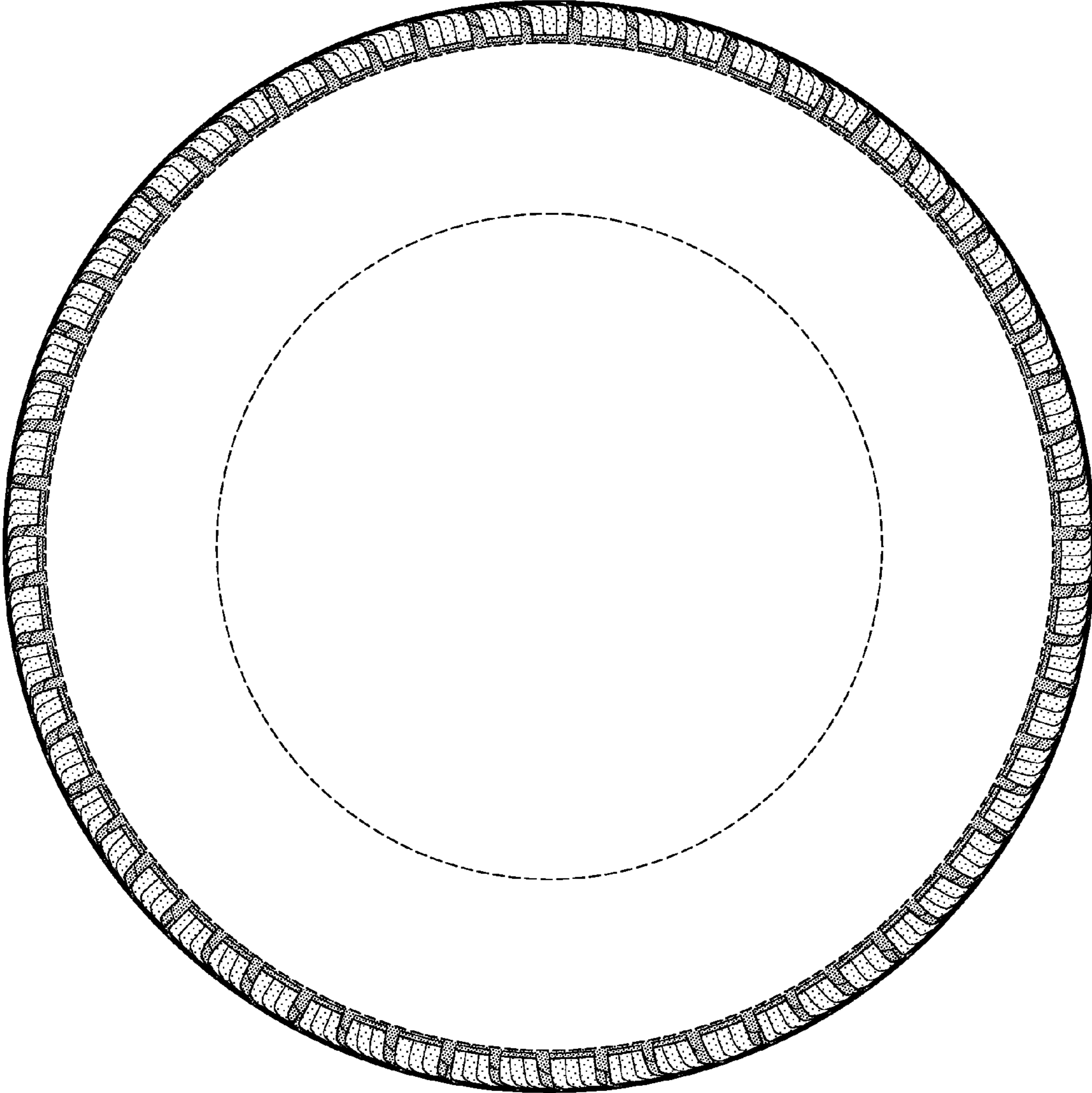

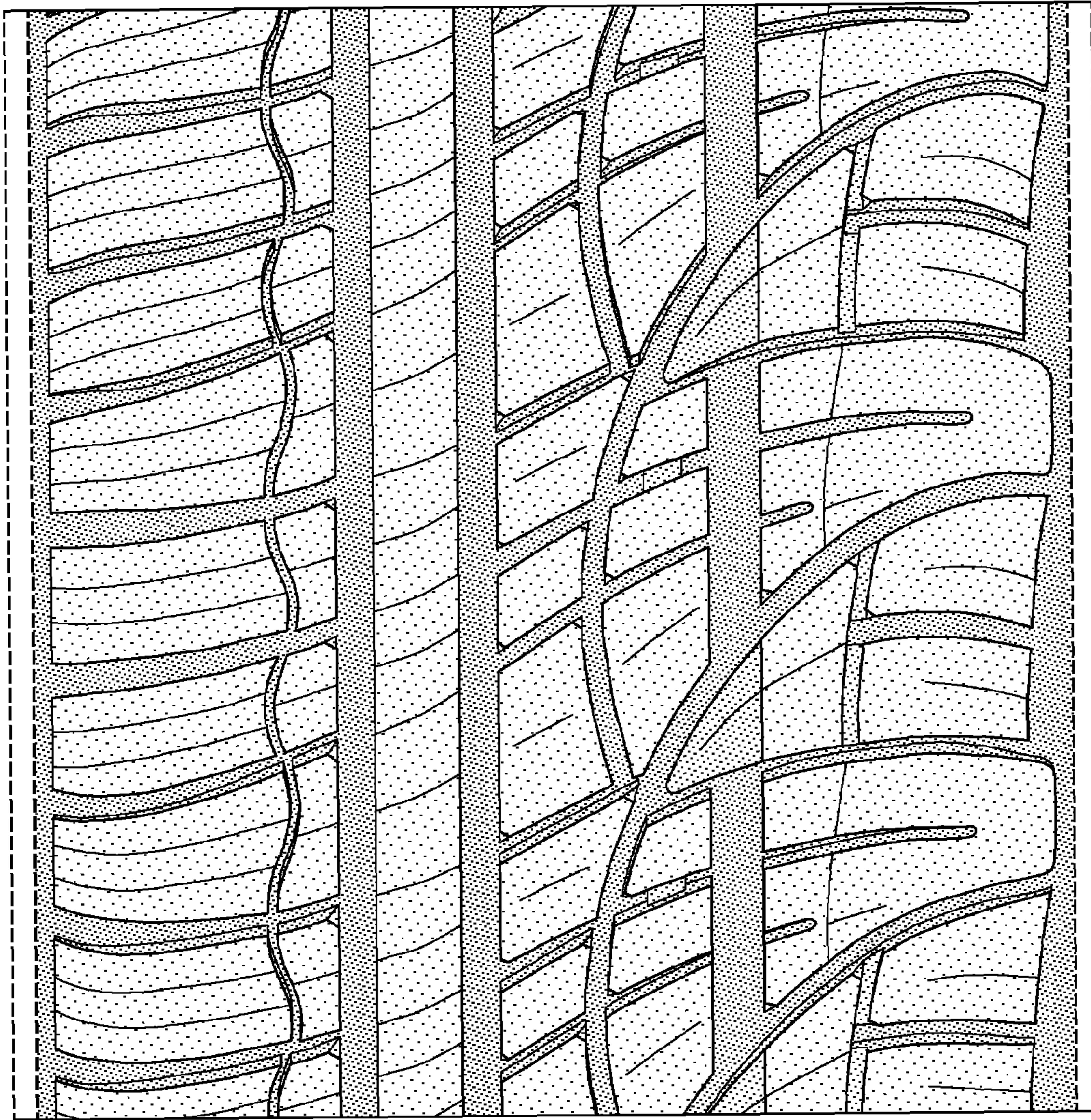

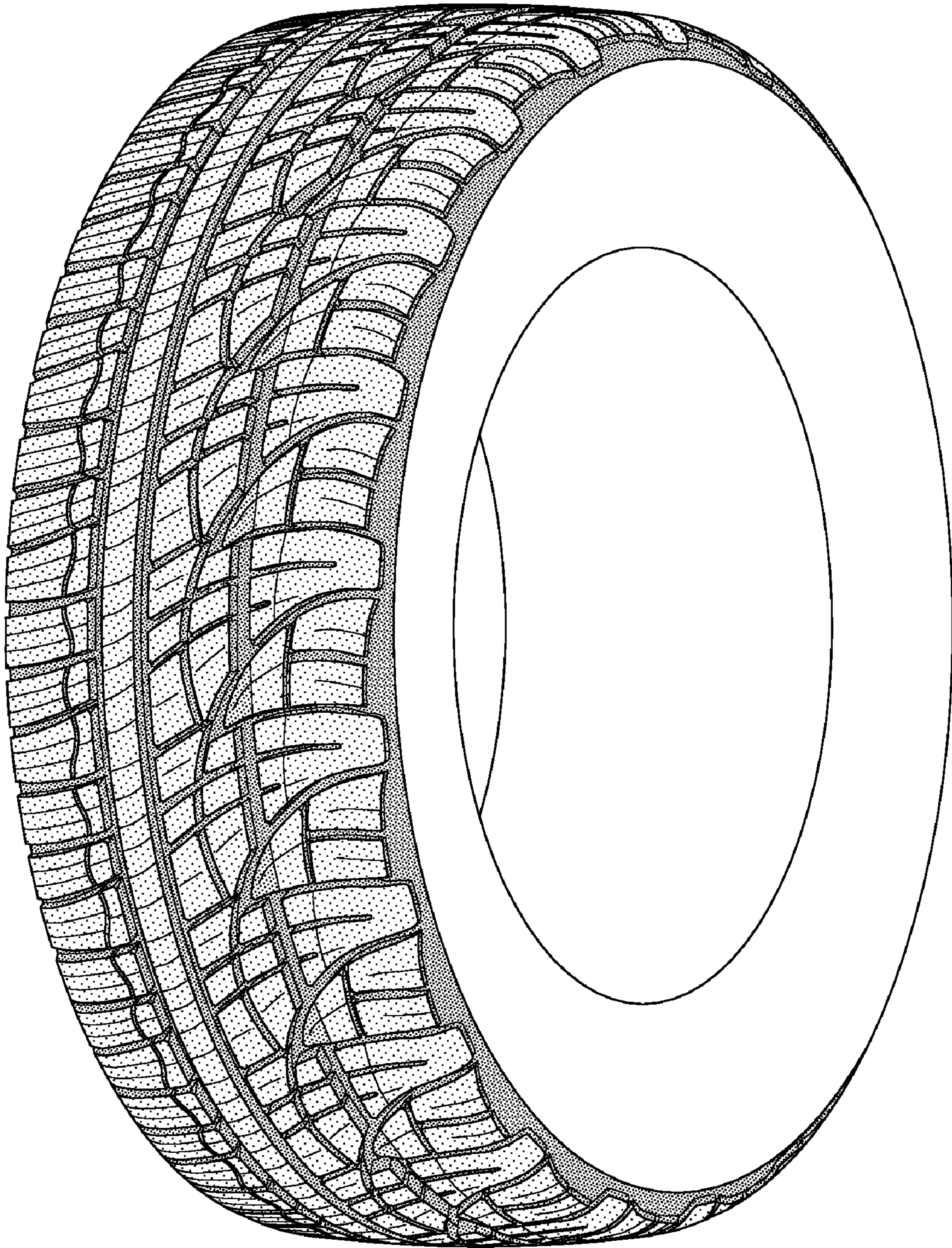

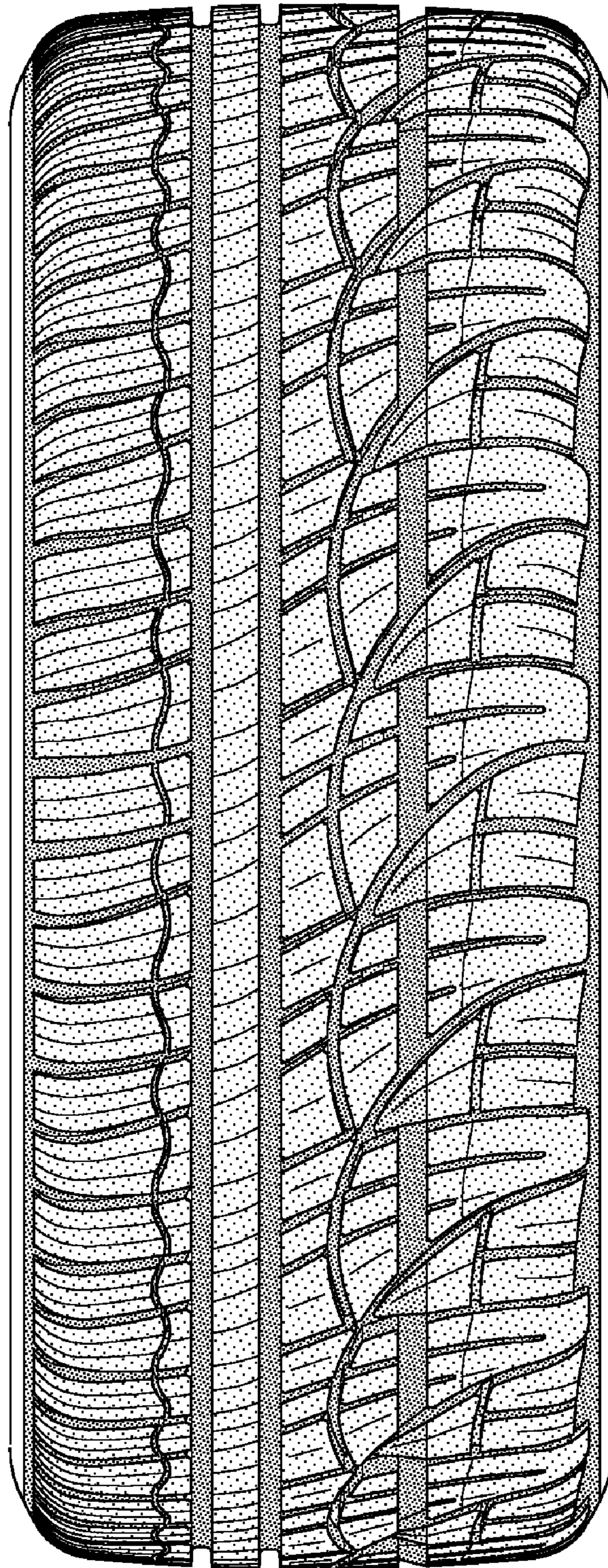
