FIG. 5 is a front elevational view thereof;

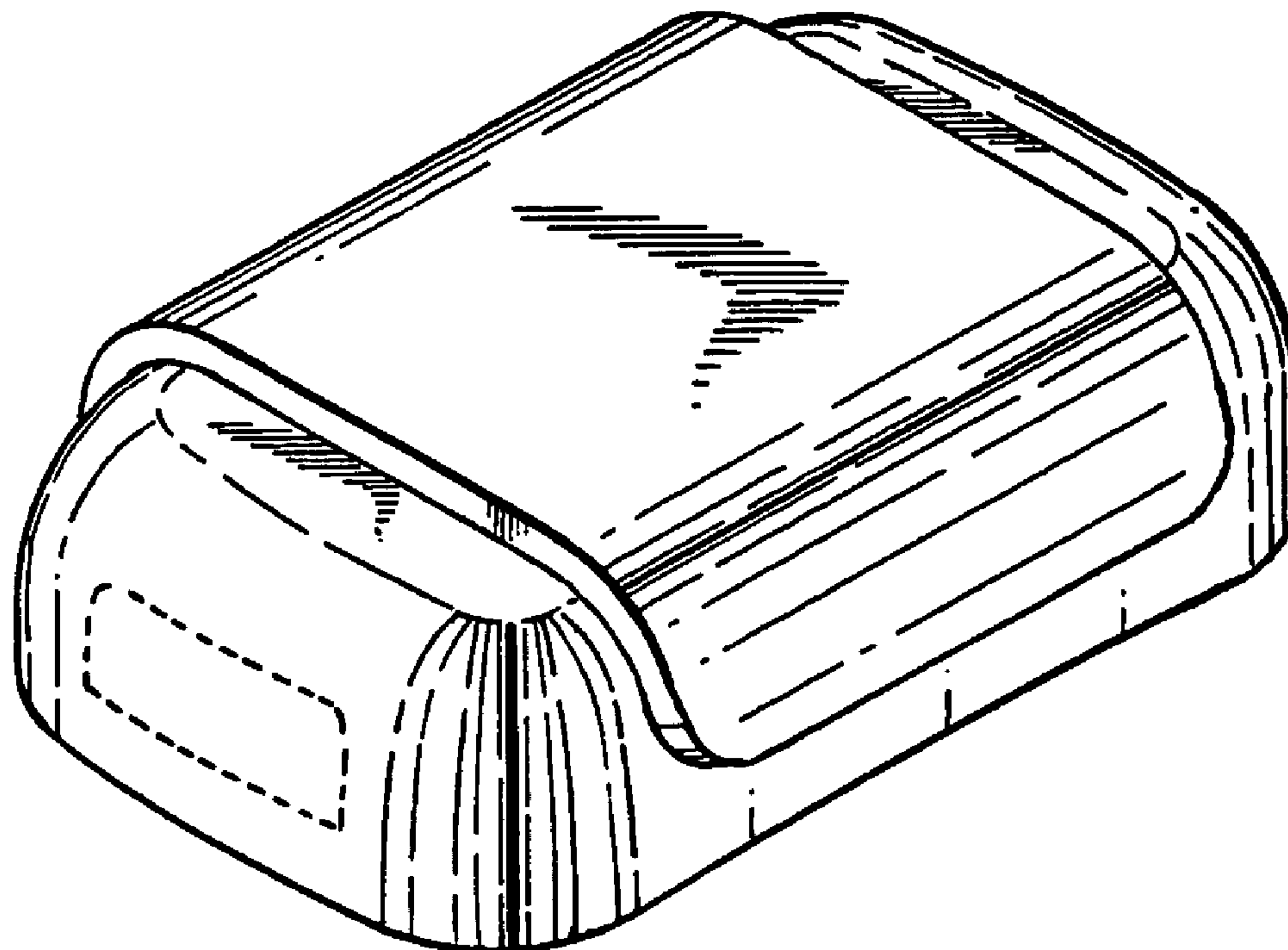
FIG. 6 is a rear elevational view thereof;

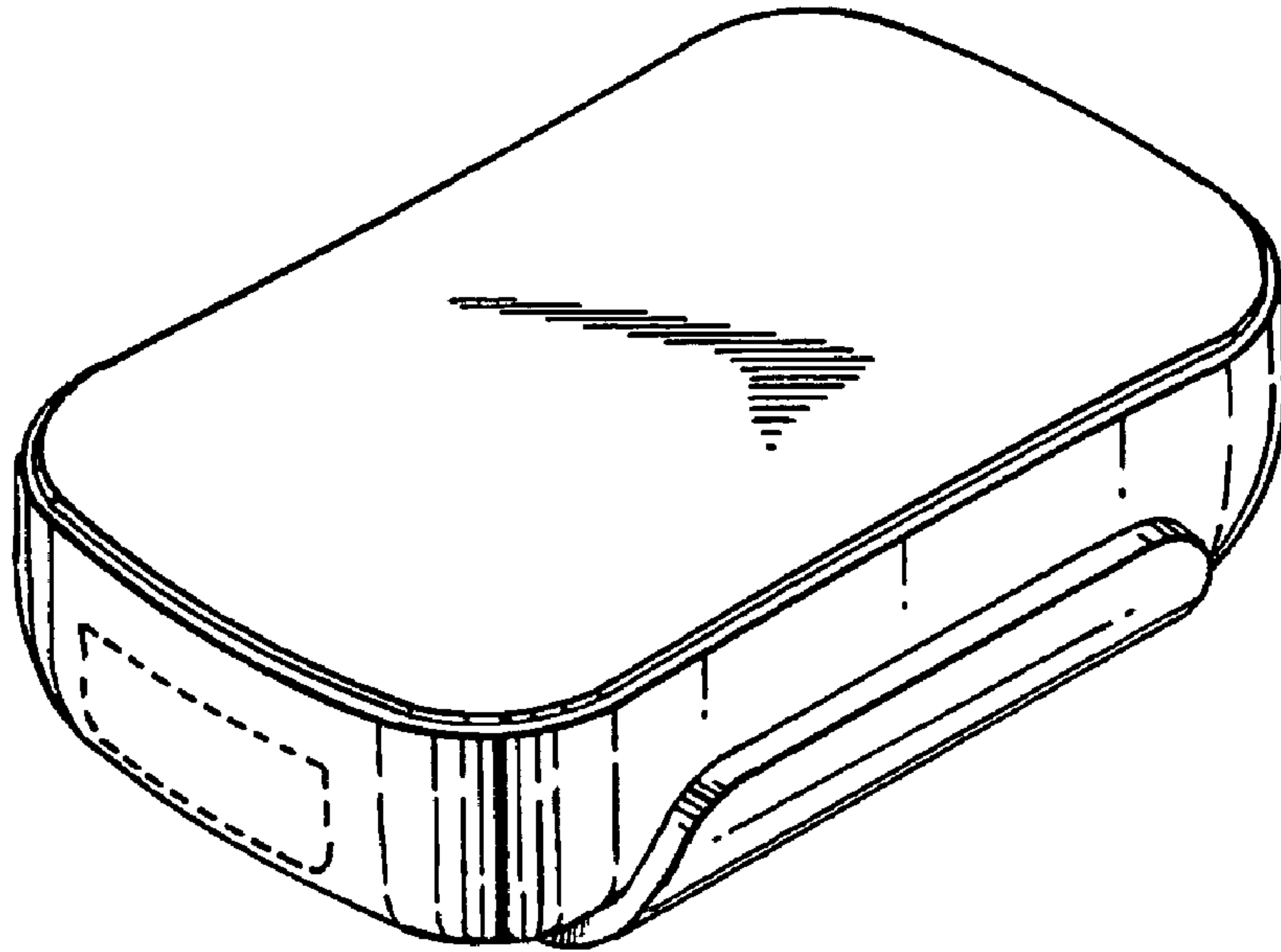
FIG. 7 is a left elevational view thereof; and,

FIG. 8 is a right elevational view thereof.

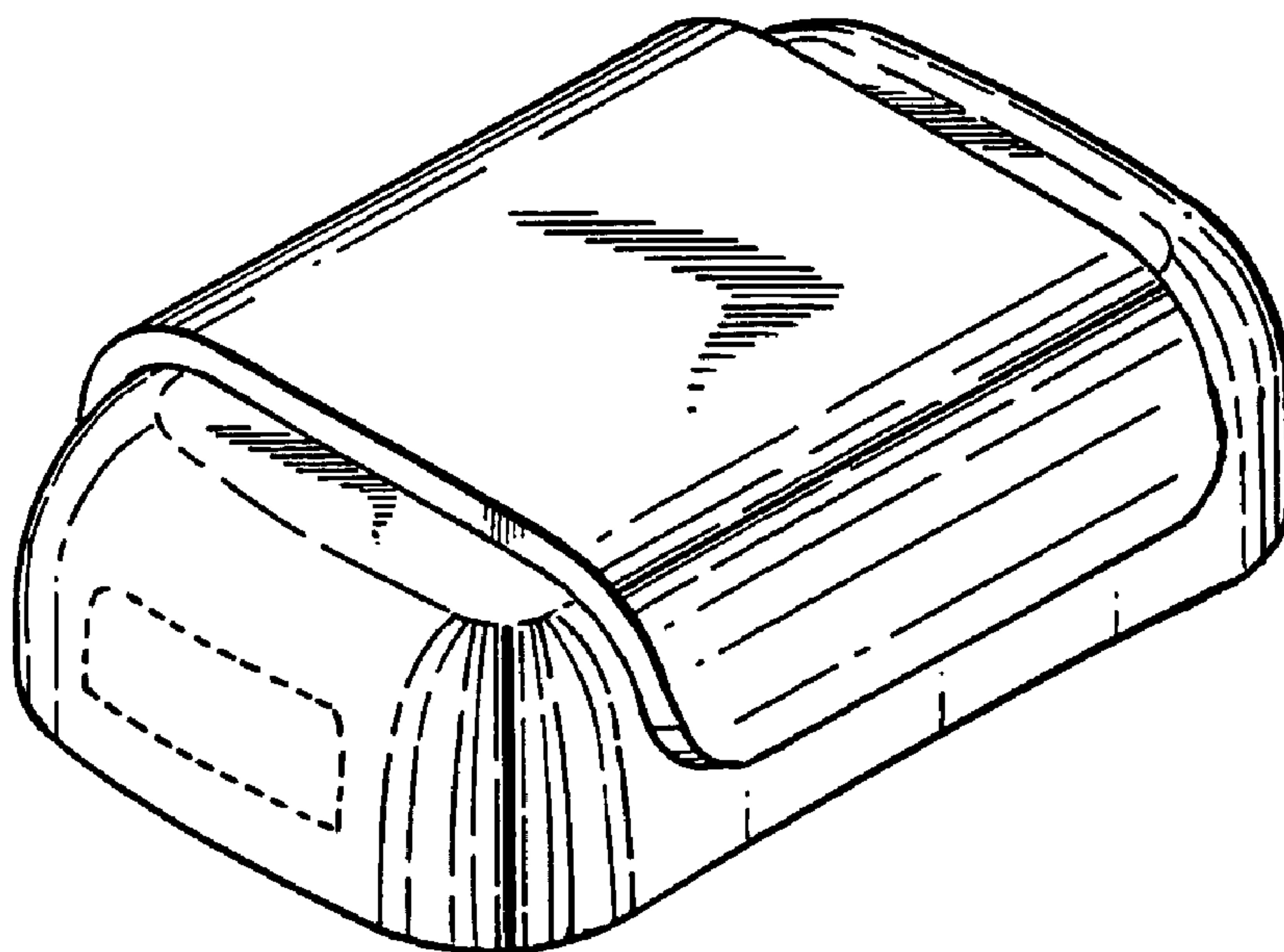

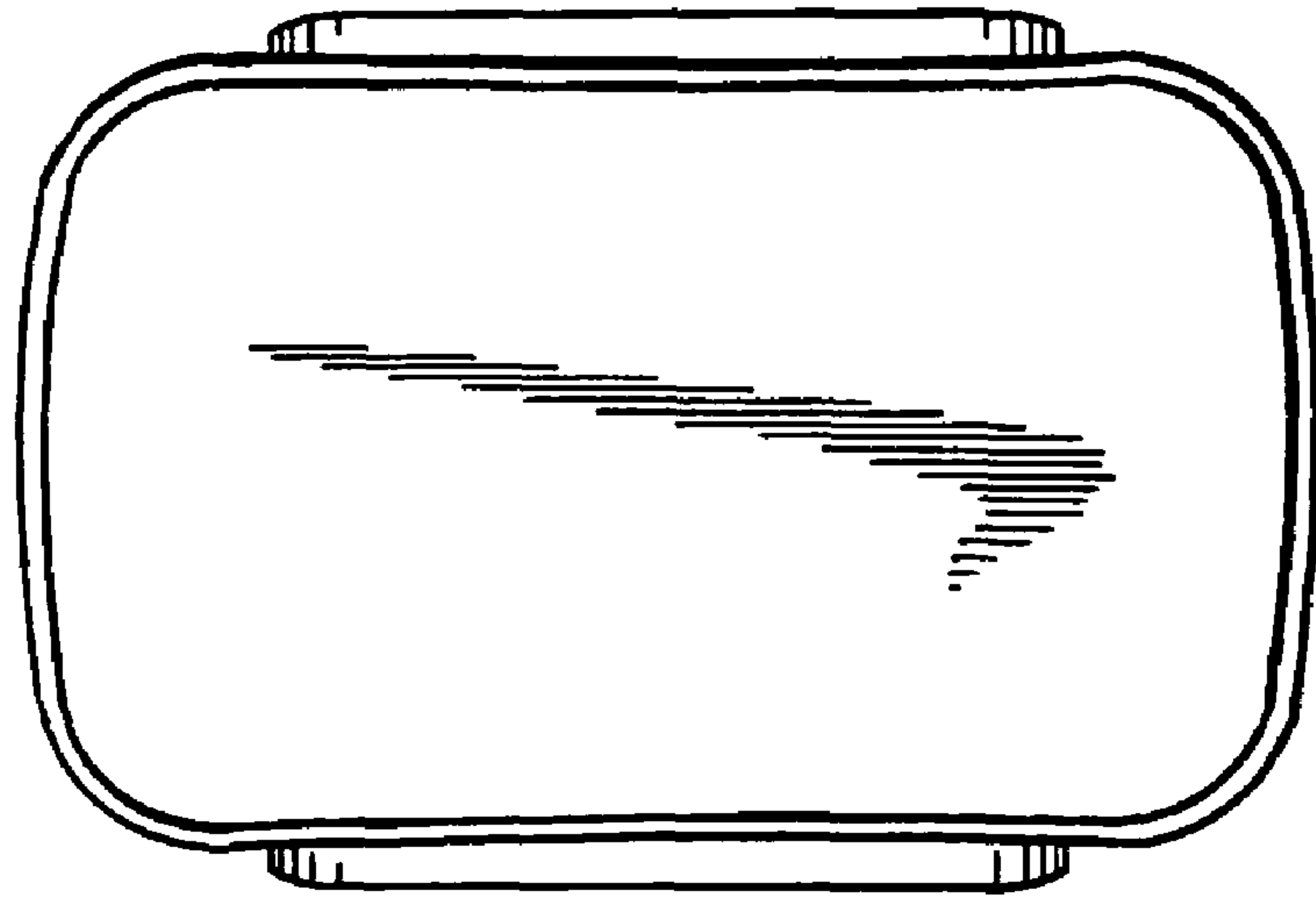




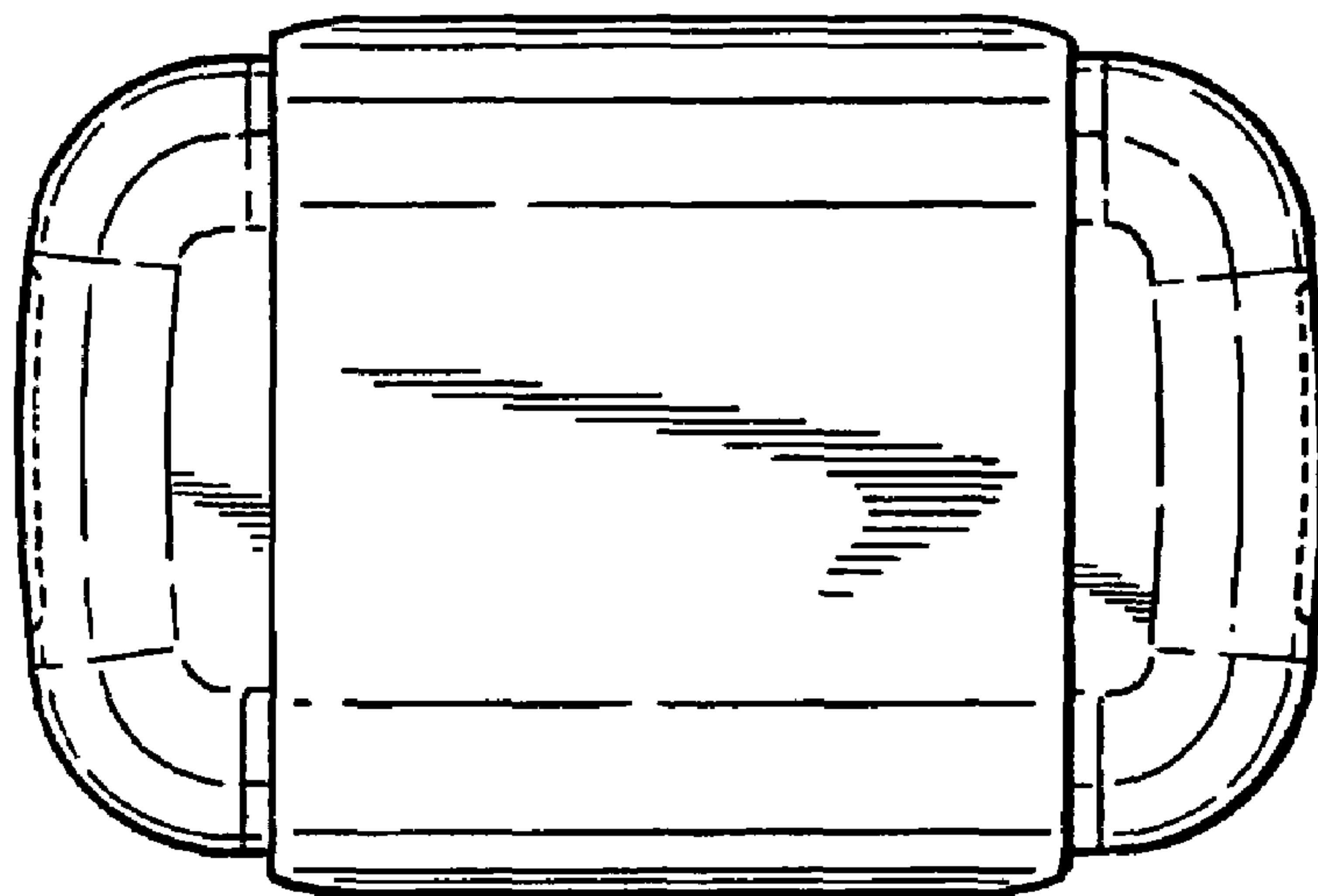

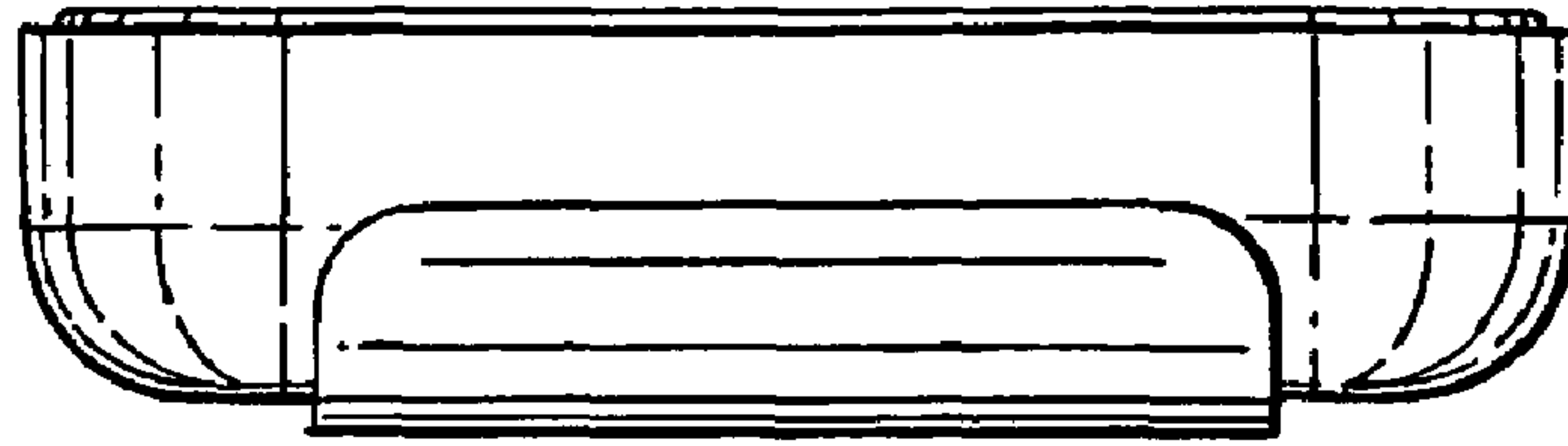

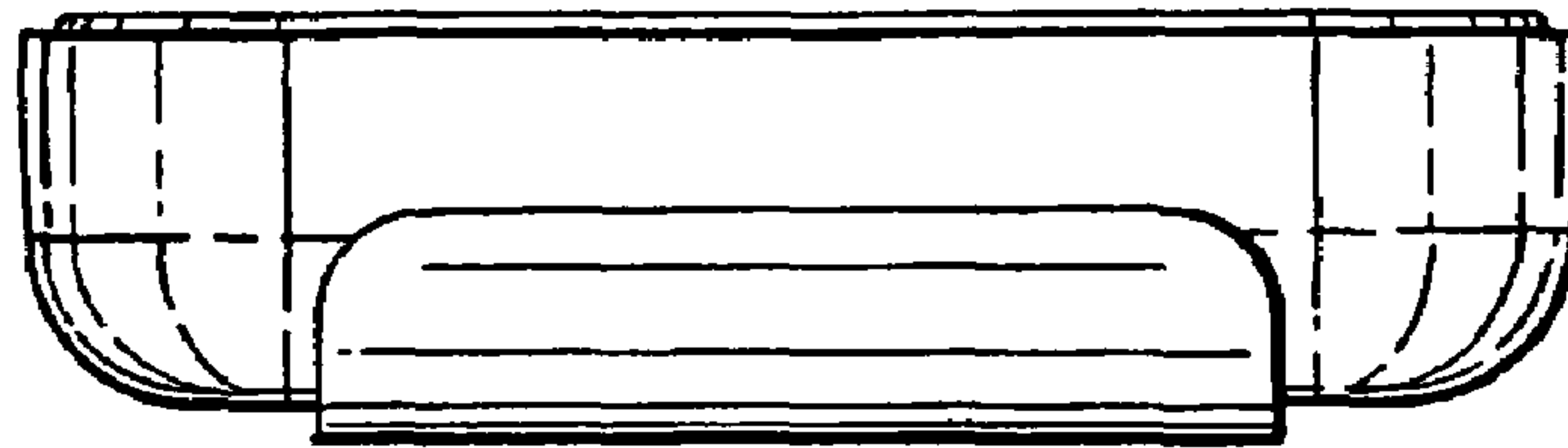

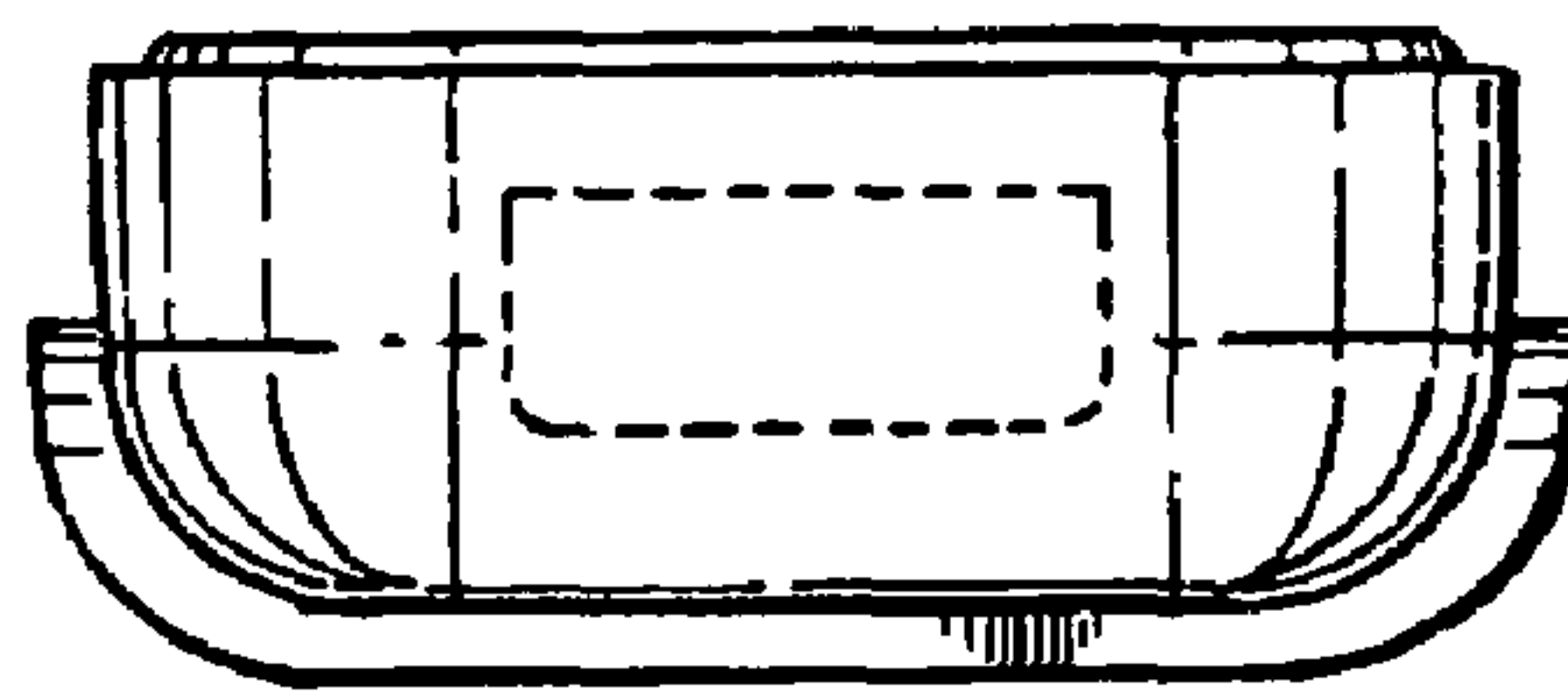

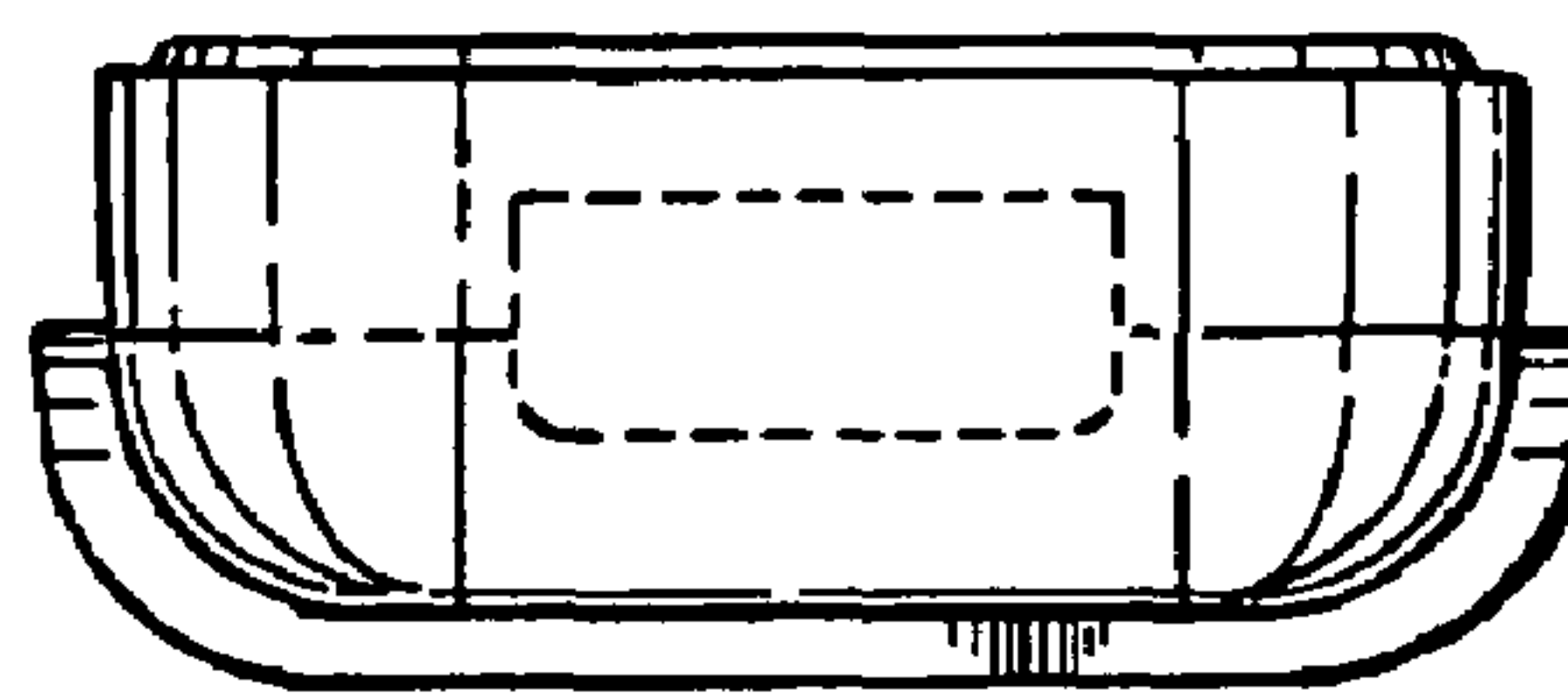
