The ornamental design for a display image for a mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view perspective view of a display image for a mobile phone; and,

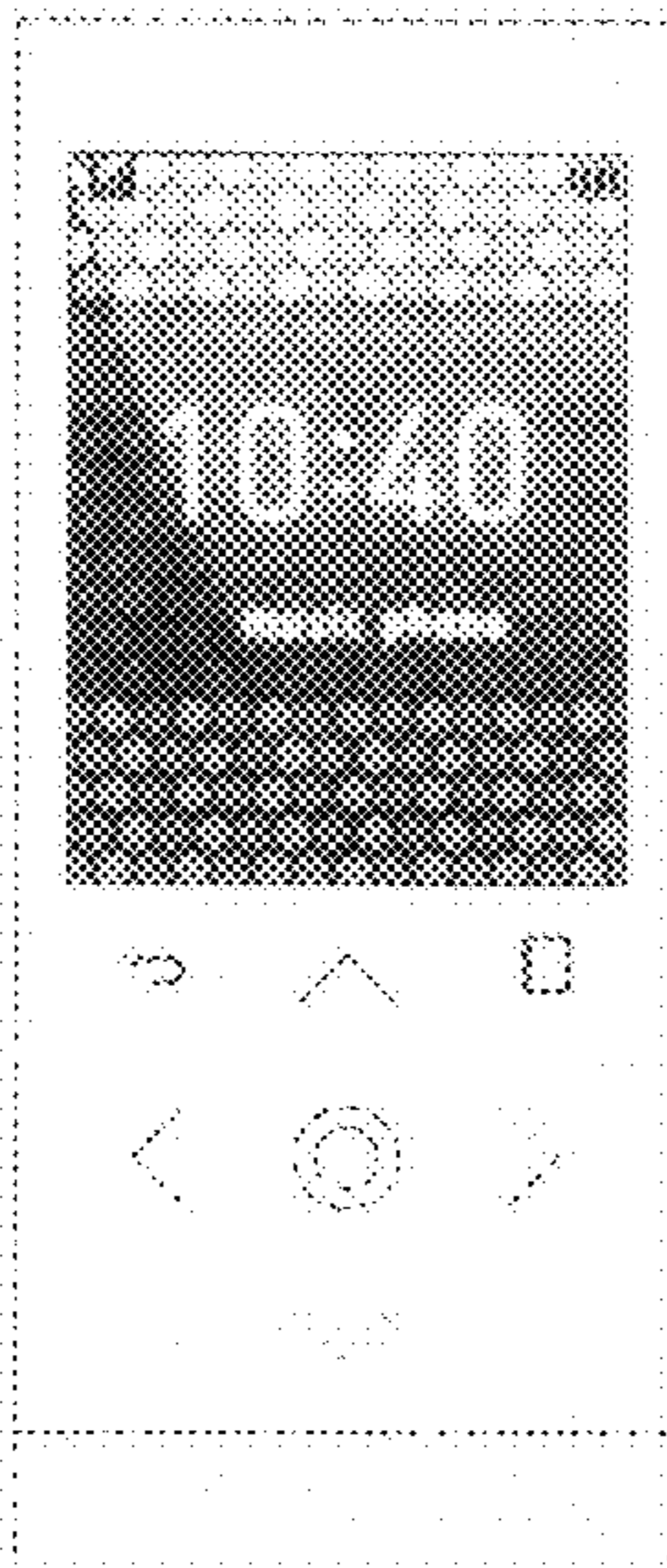

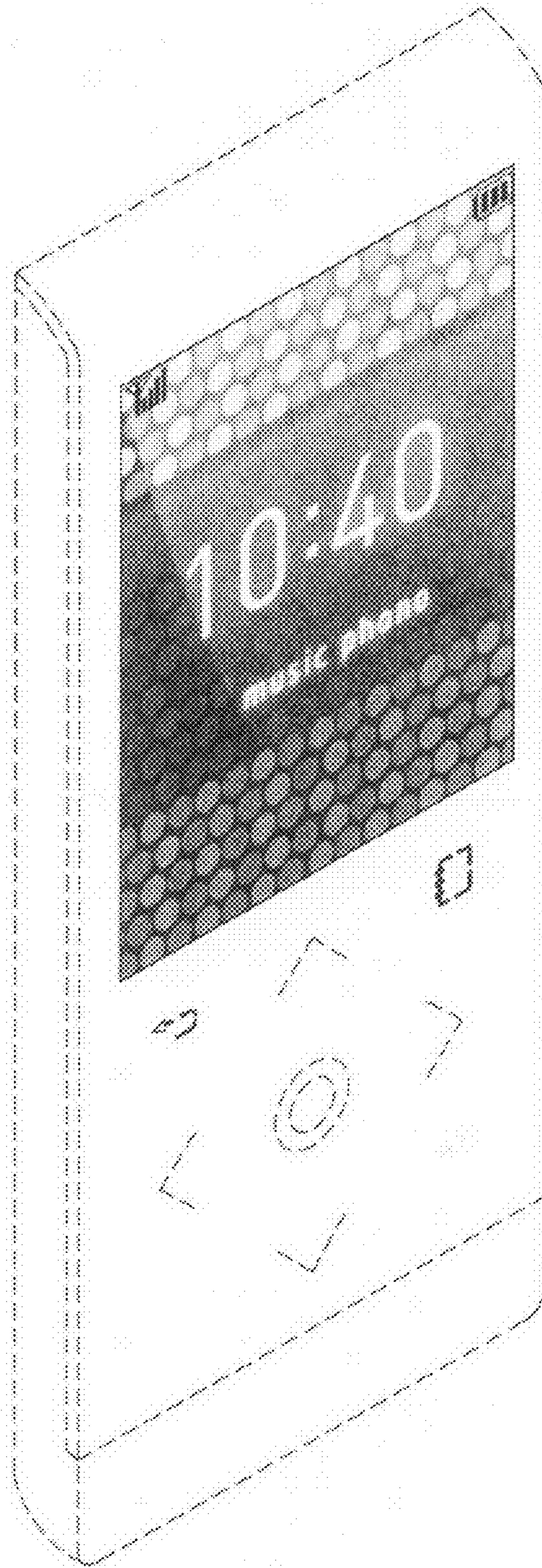
