(57) **CLAIM**

The ornamental design for a display image for a mobile phone, as shown and described.

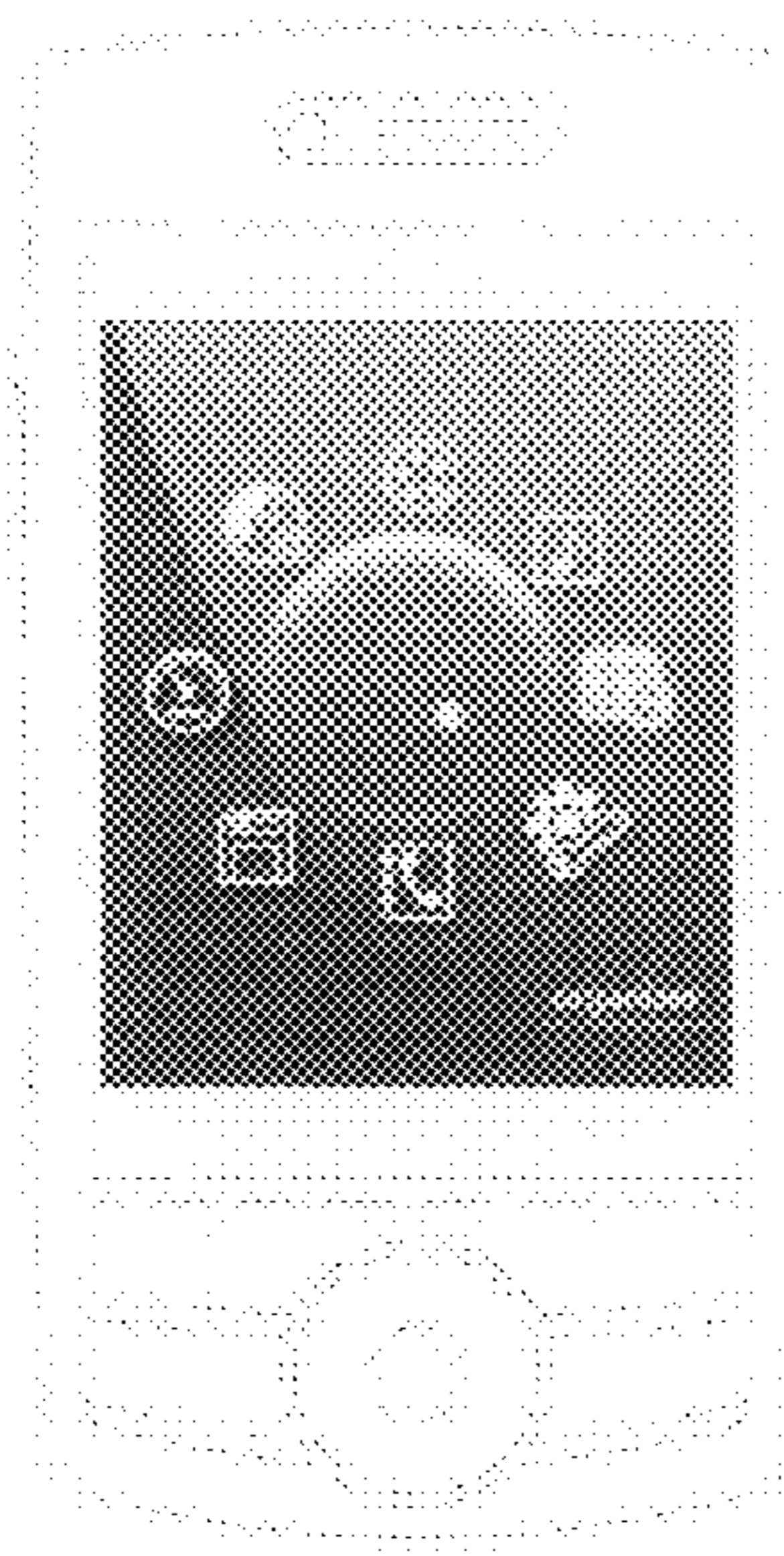

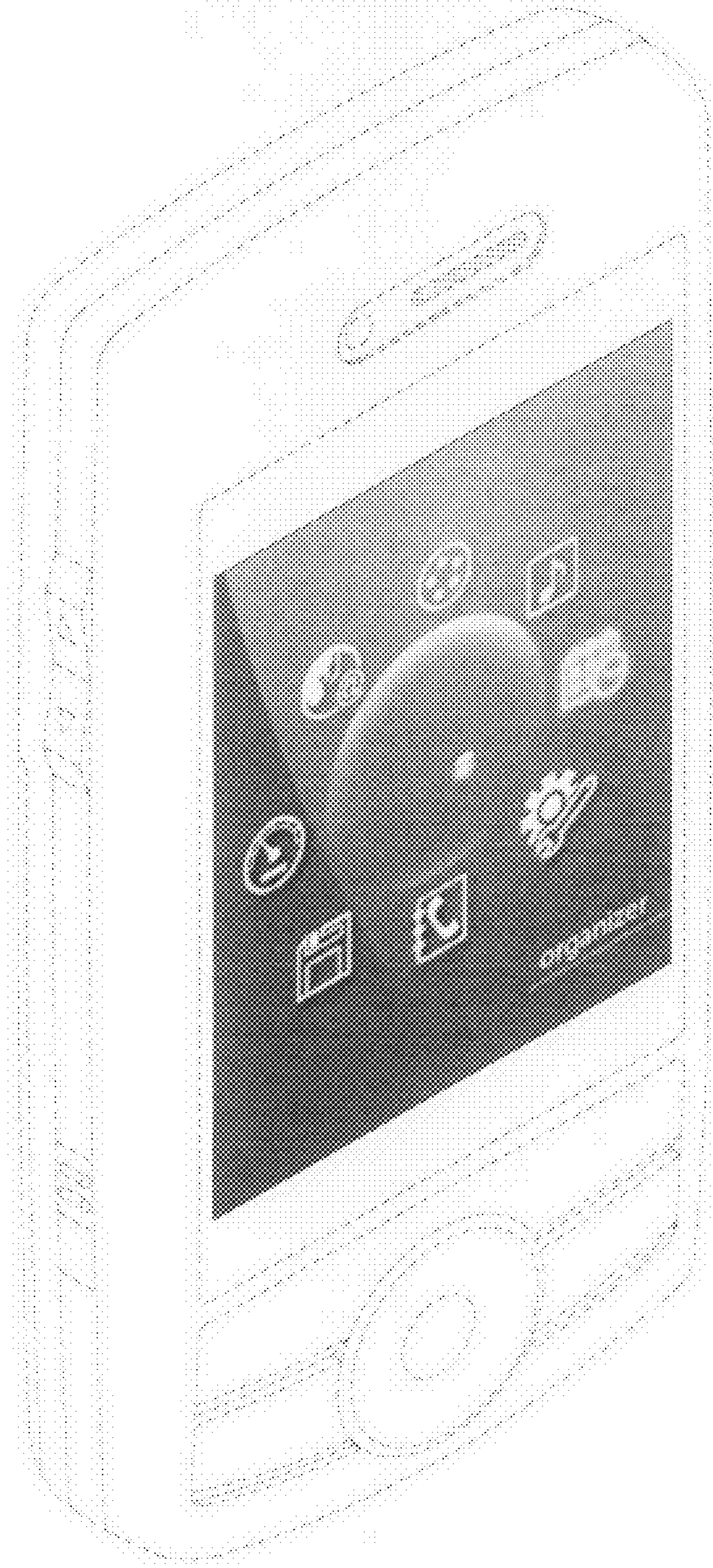
