We claim the ornamental design for a painting/palette knife,
as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a painting/palette knife,
according to an embodiment of the invention;

FIG. 2 is a top view of the painting/palette knife of FIG. 1;

FIG. 3 is bottom view of the painting/palette knife of FIG. 1;

FIG. 4 is a side view of the painting/palette knife of FIG. 1;

FIG. 5 is a rear view of the painting/palette knife of FIG. 1;

FIG. 6 is a front view of the painting/palette knife of FIG. 1.

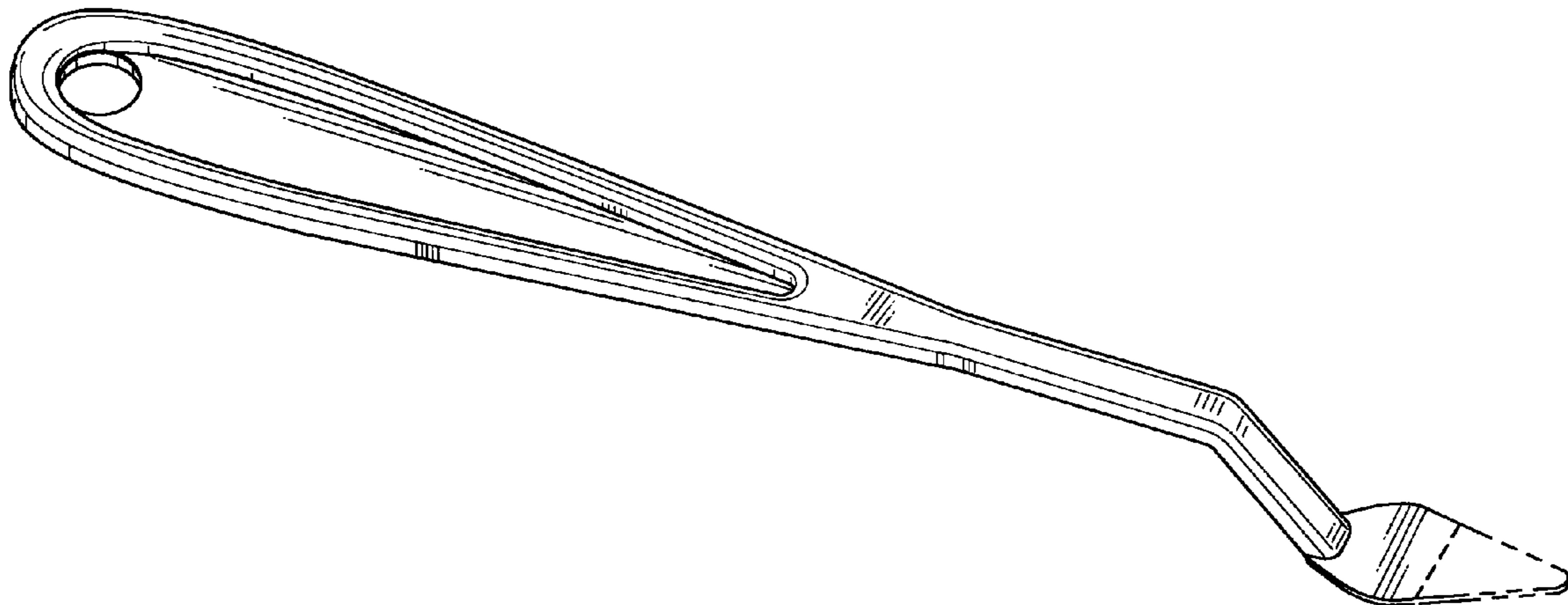

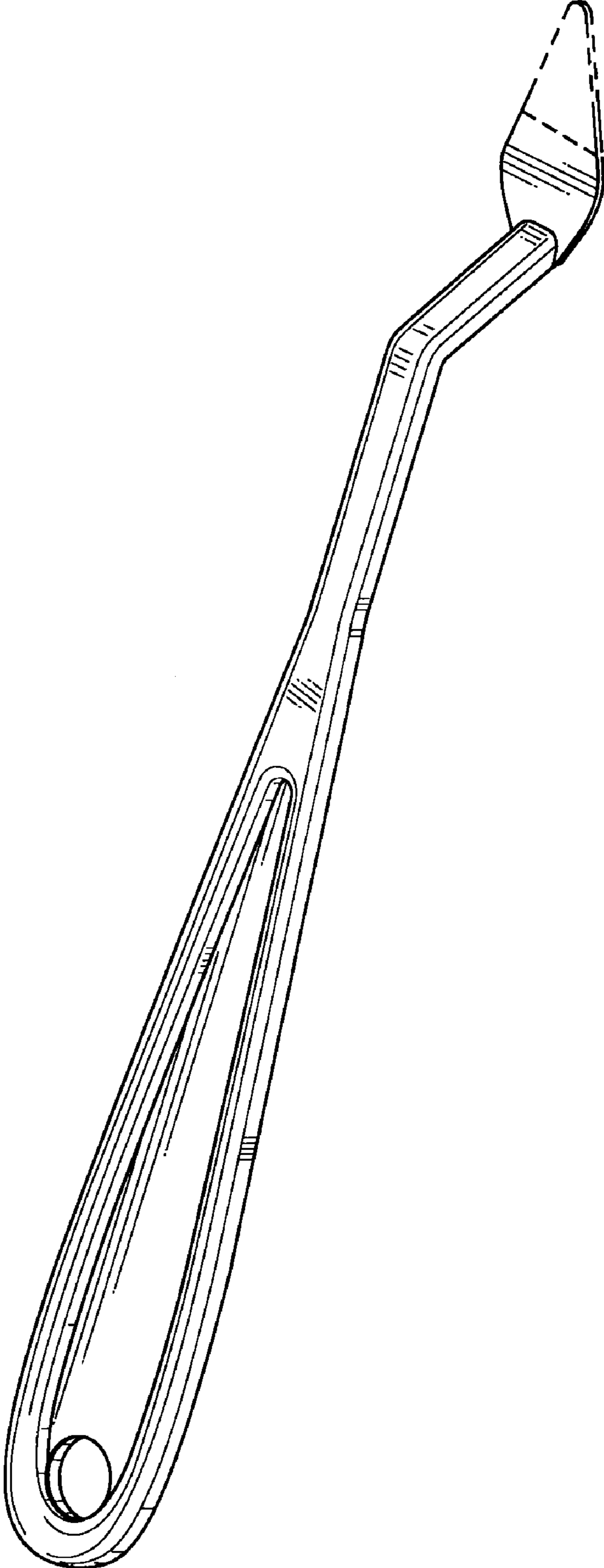

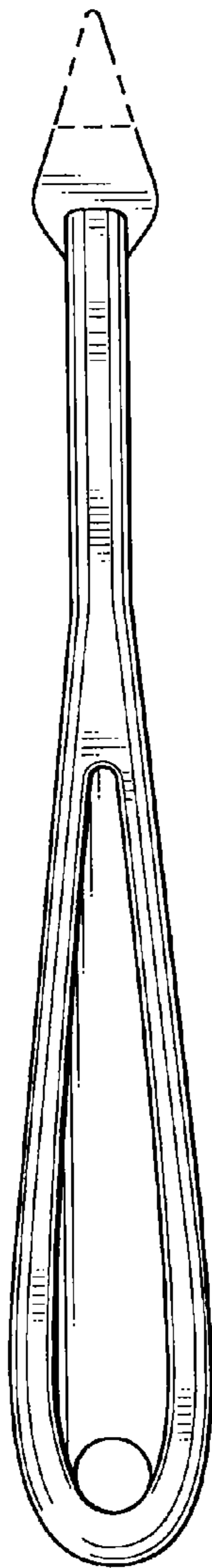

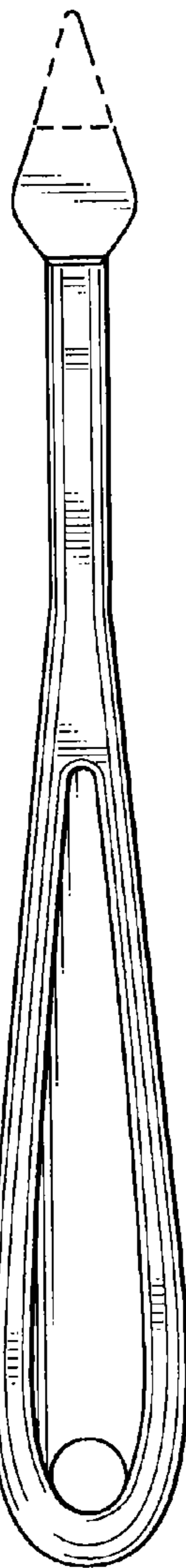

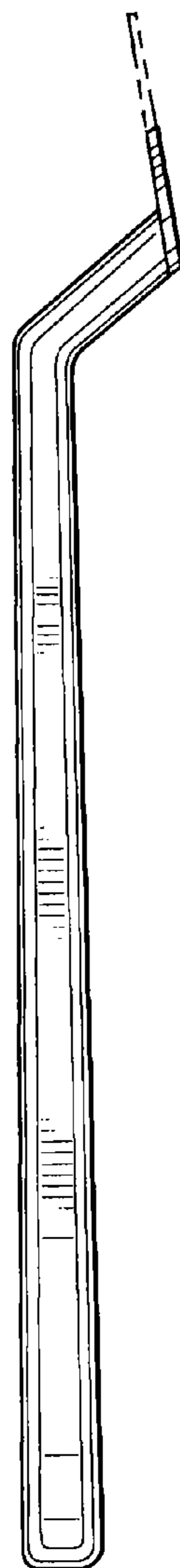

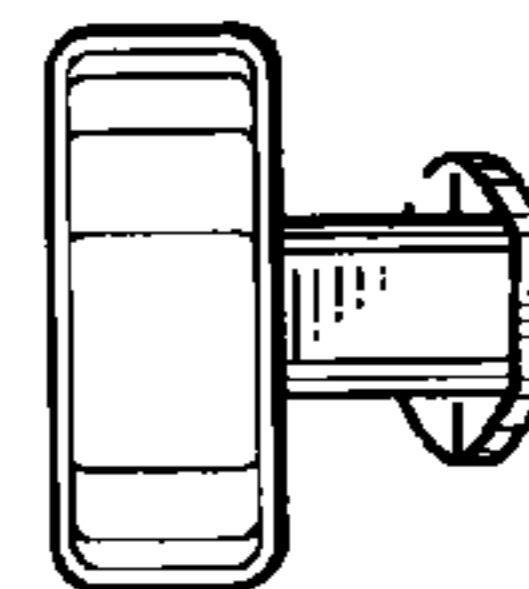
