**DESCRIPTION**

FIG. 3 is a top plan view;

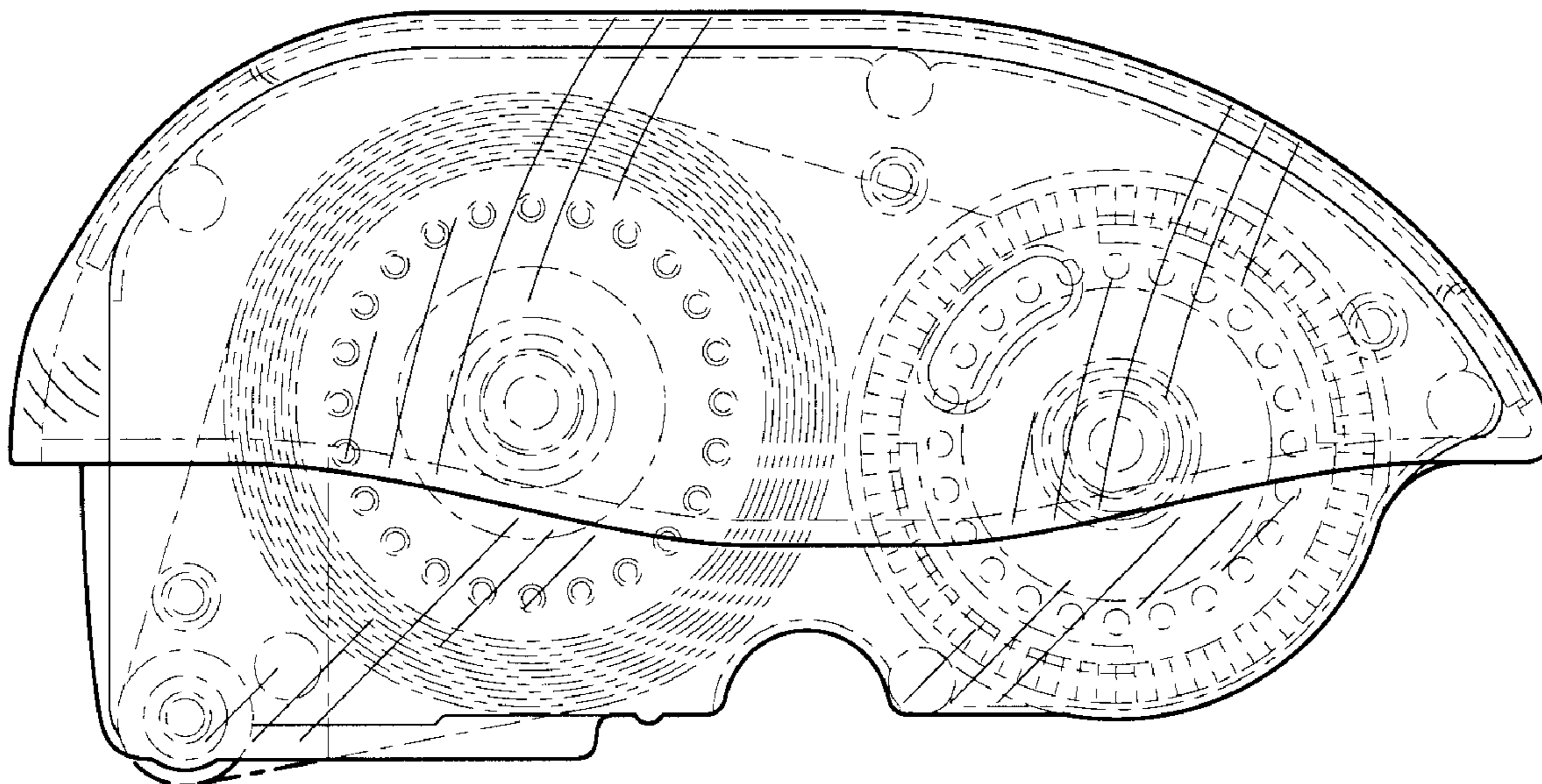
FIG. 4 is a bottom plan view;

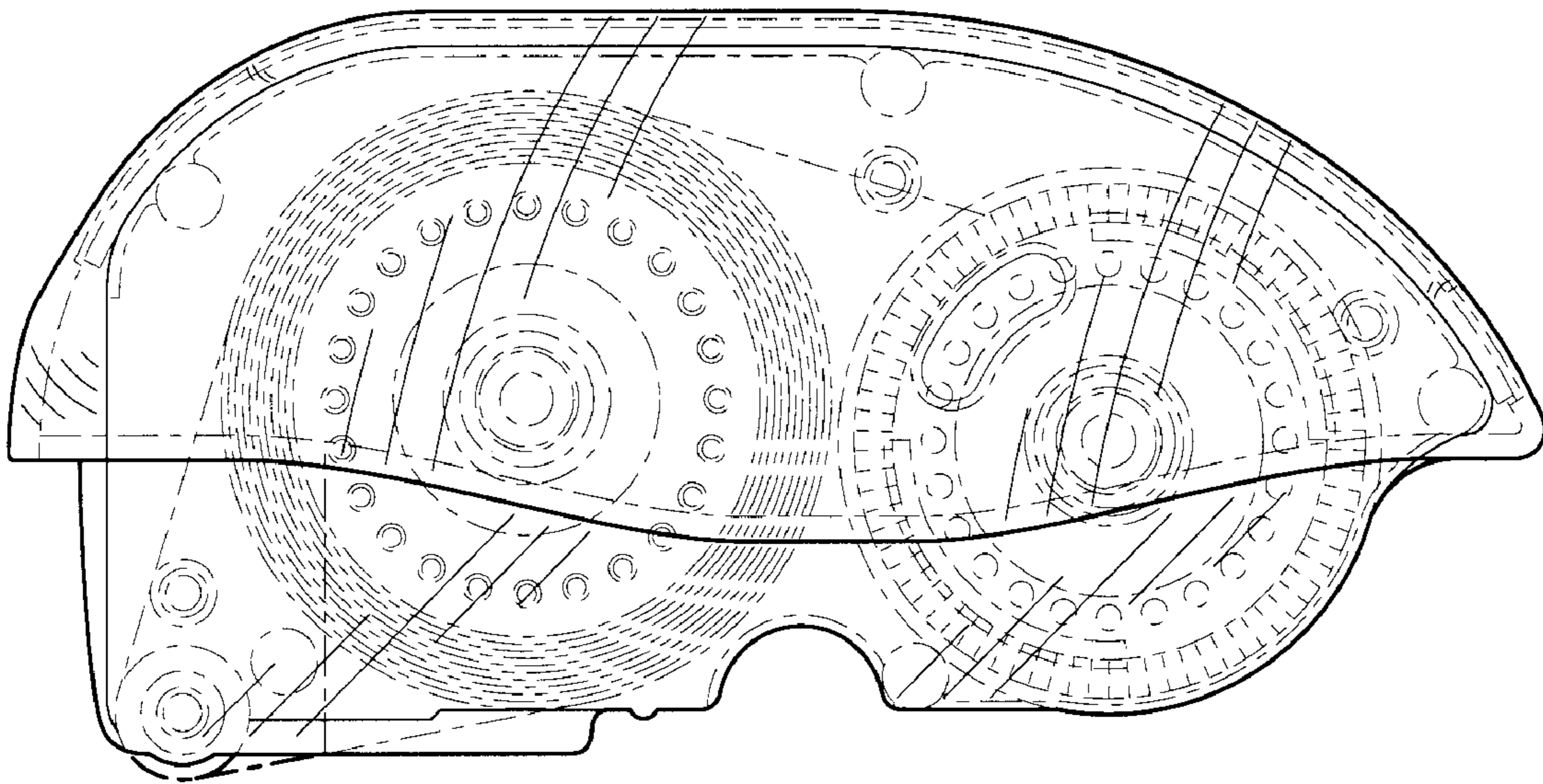

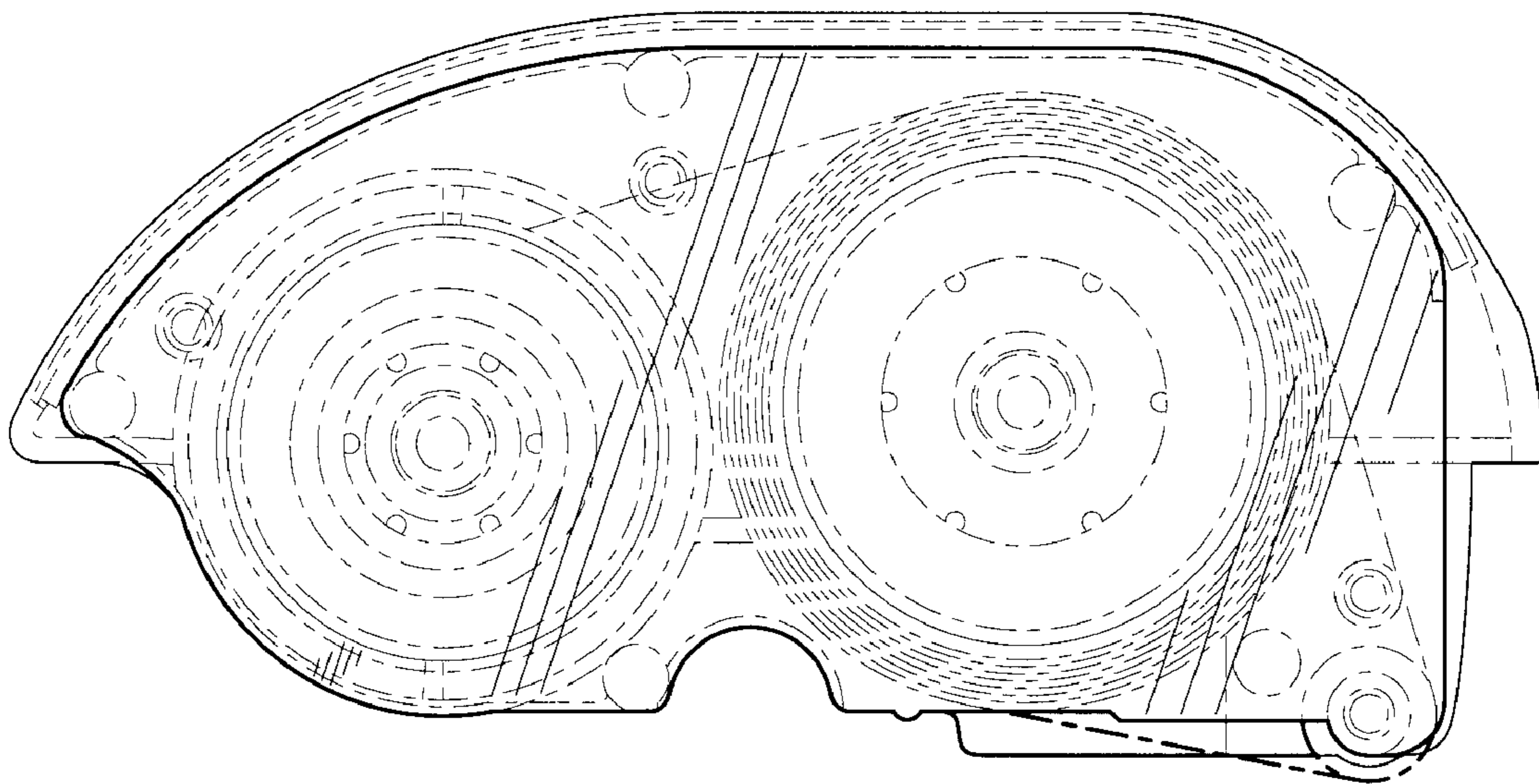

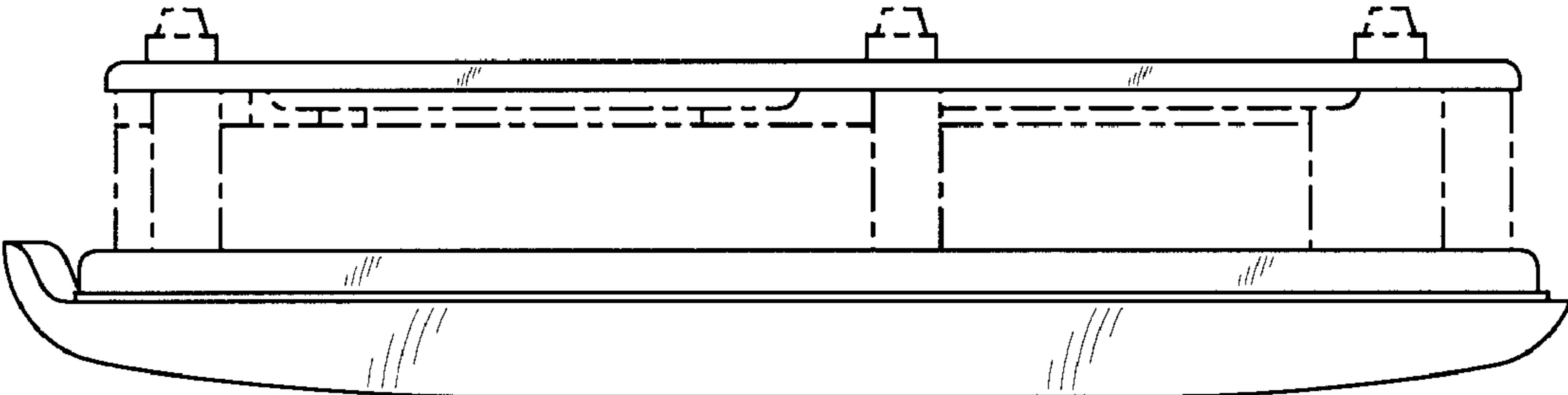

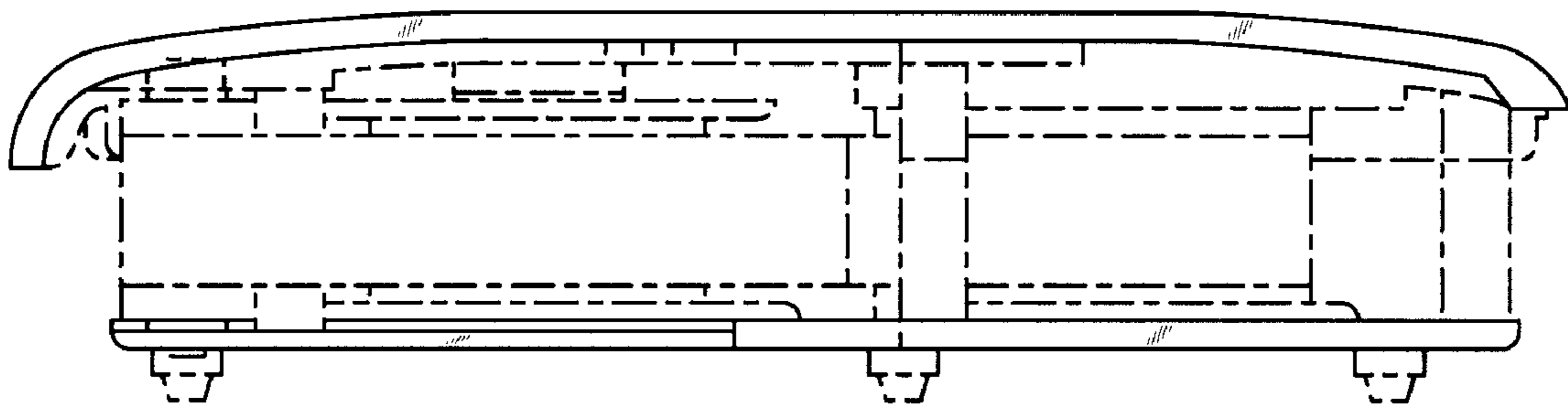

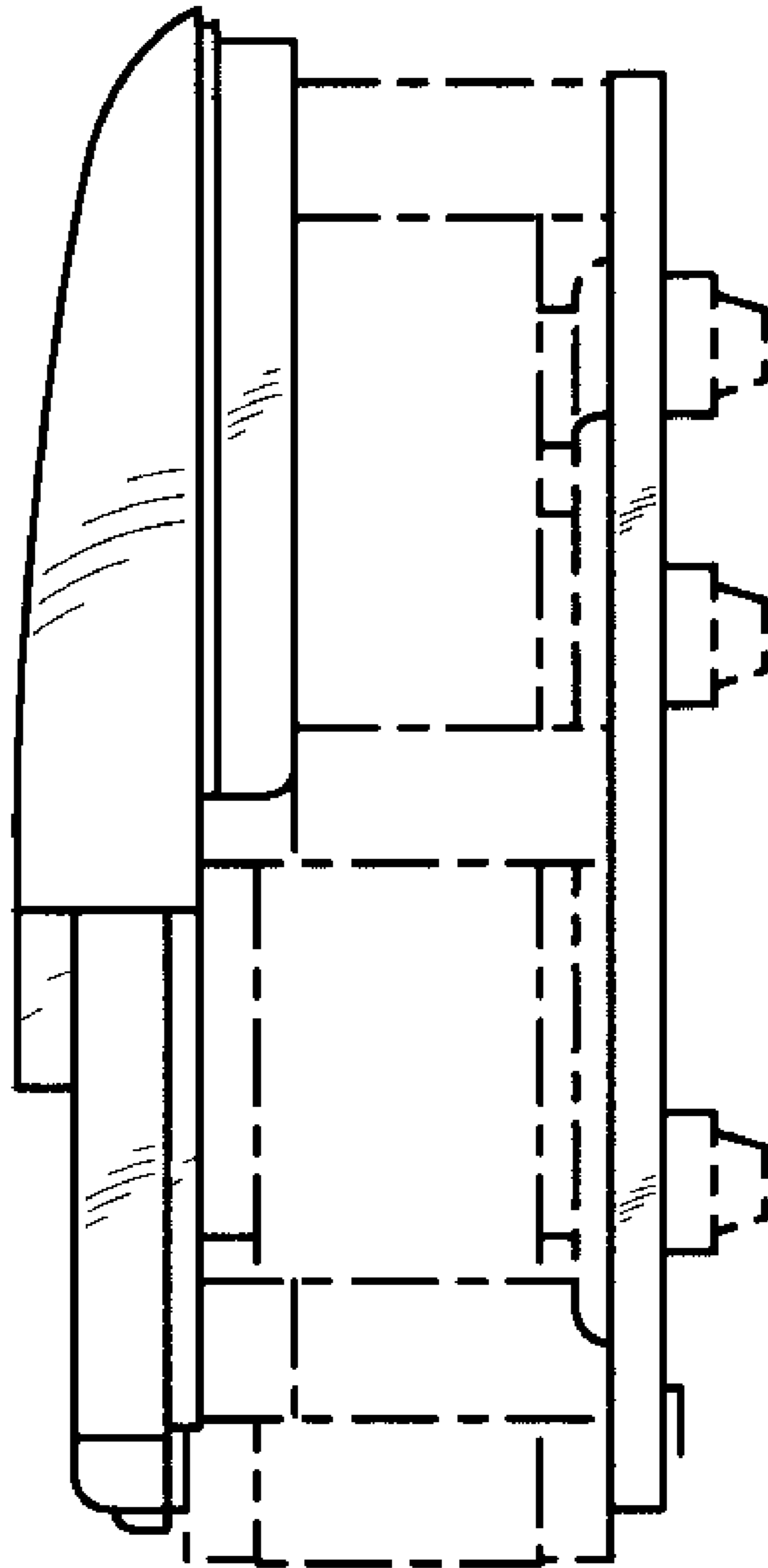

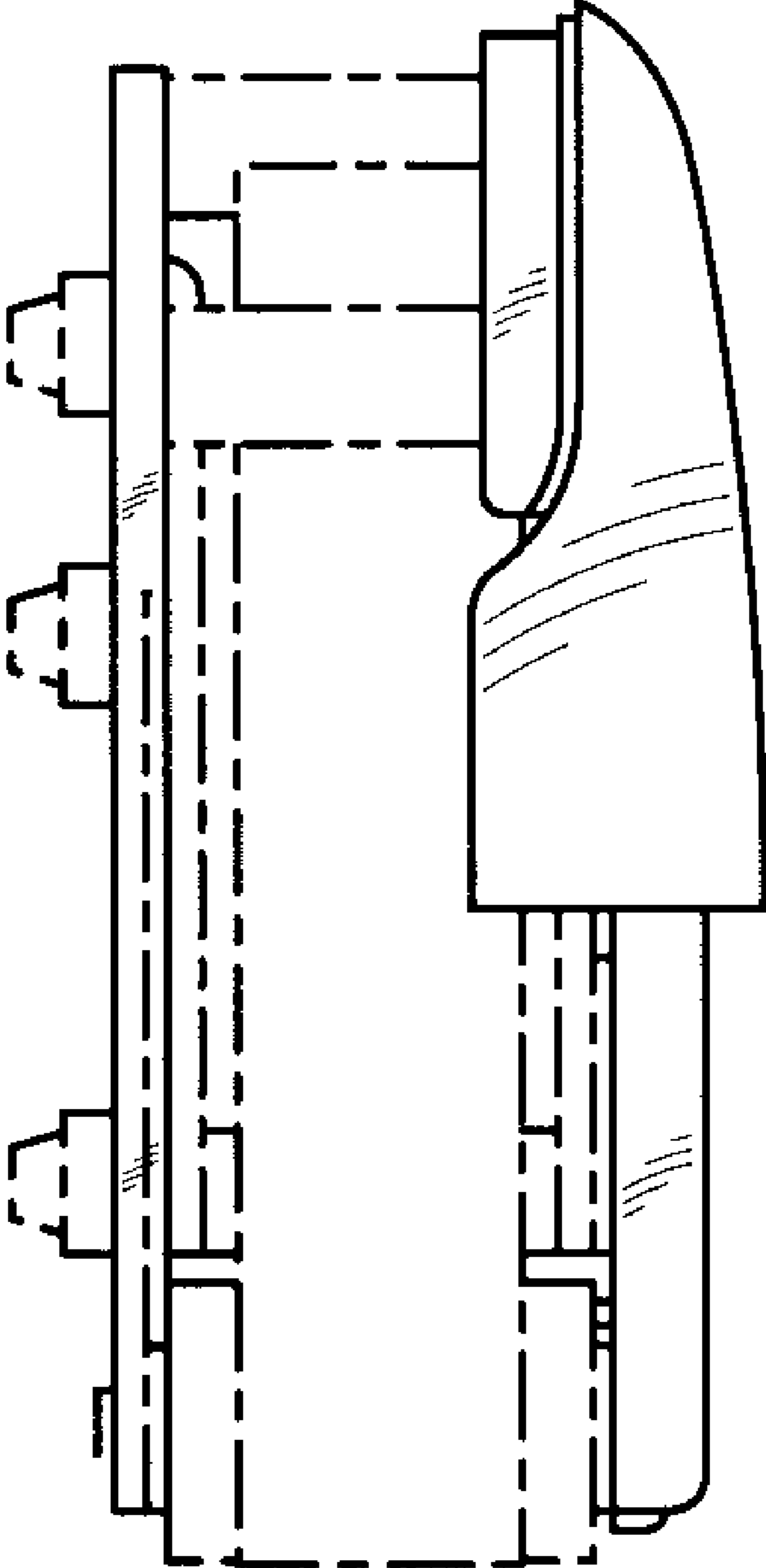
