(57) **CLAIM**

I claim the ornamental design for a golf tee, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right isometric view of a golf tee showing my new design;

FIG. 2 is a top, rear and left isometric view thereof;

FIG. 3 is a left elevation view thereof;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a rear elevation view thereof;

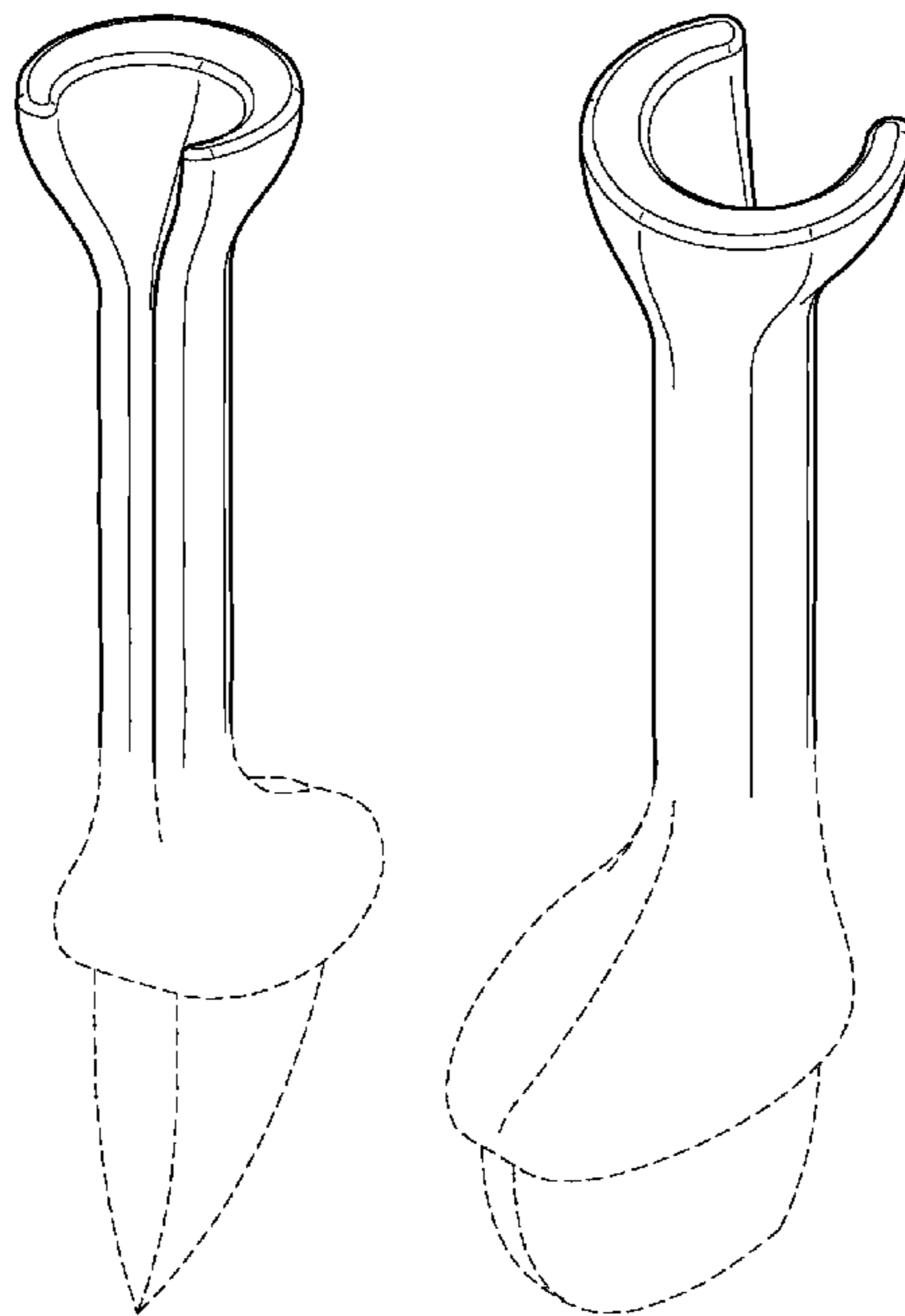
FIG. 6 is a right elevation view thereof;

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a top plan view thereof.

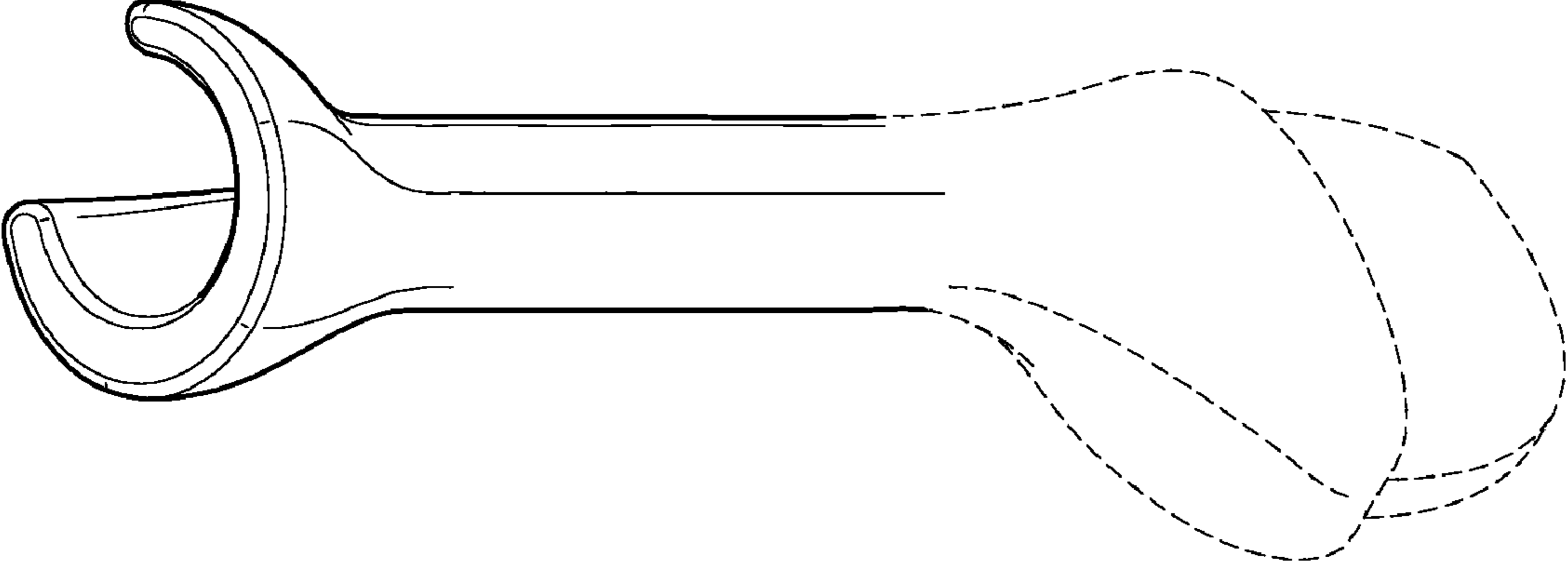

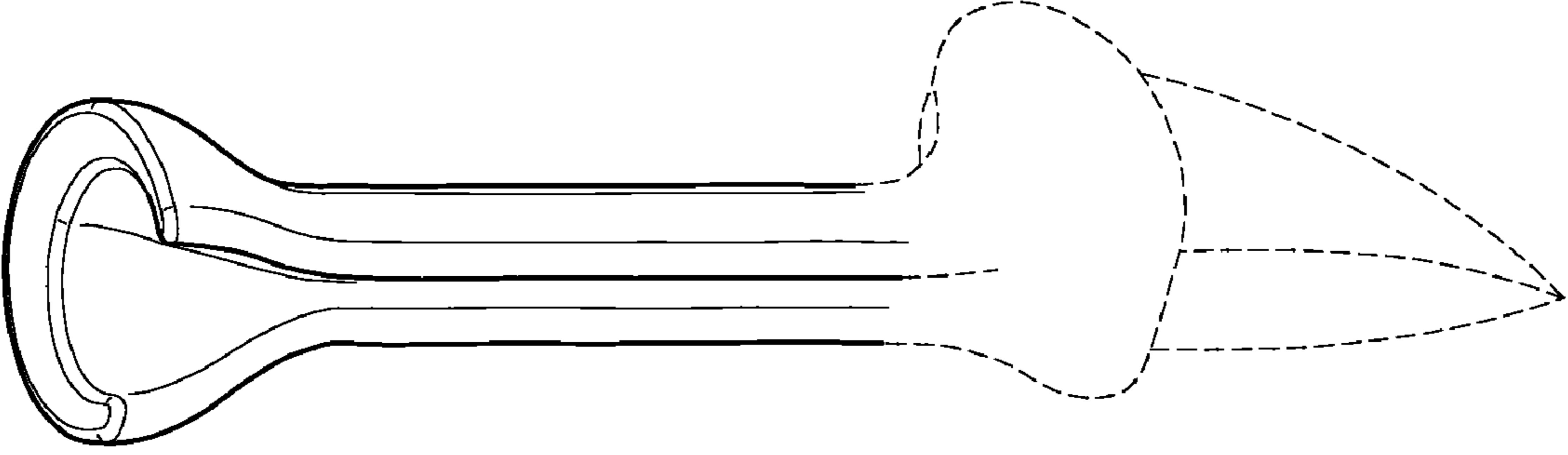

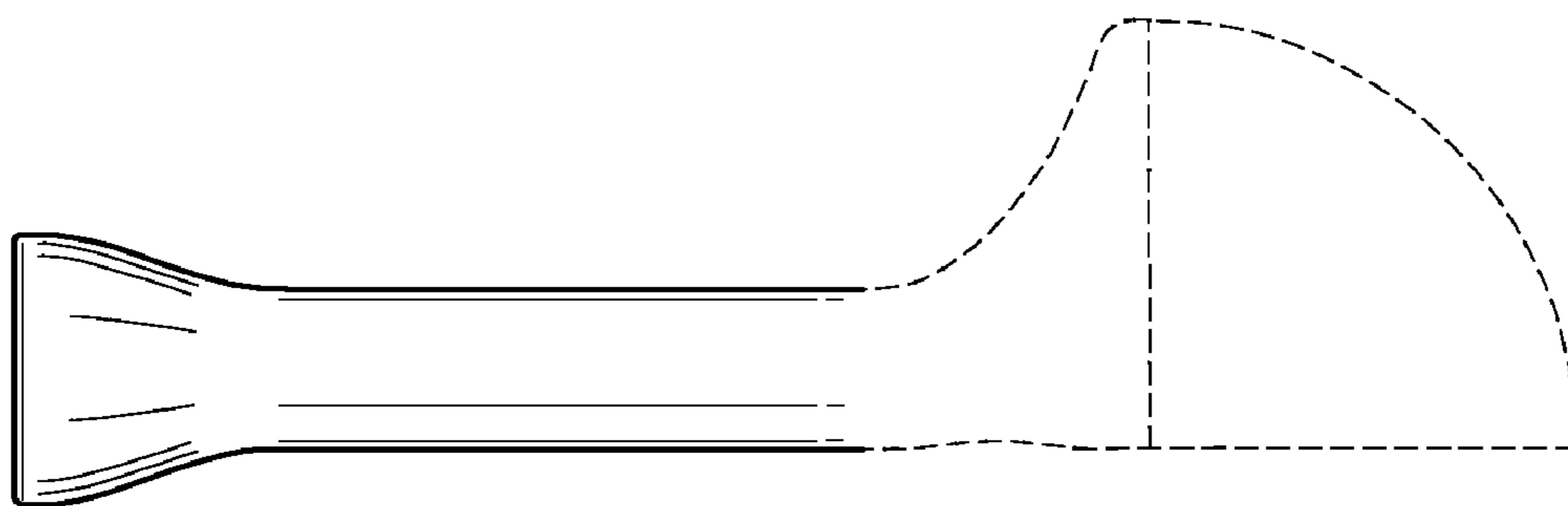

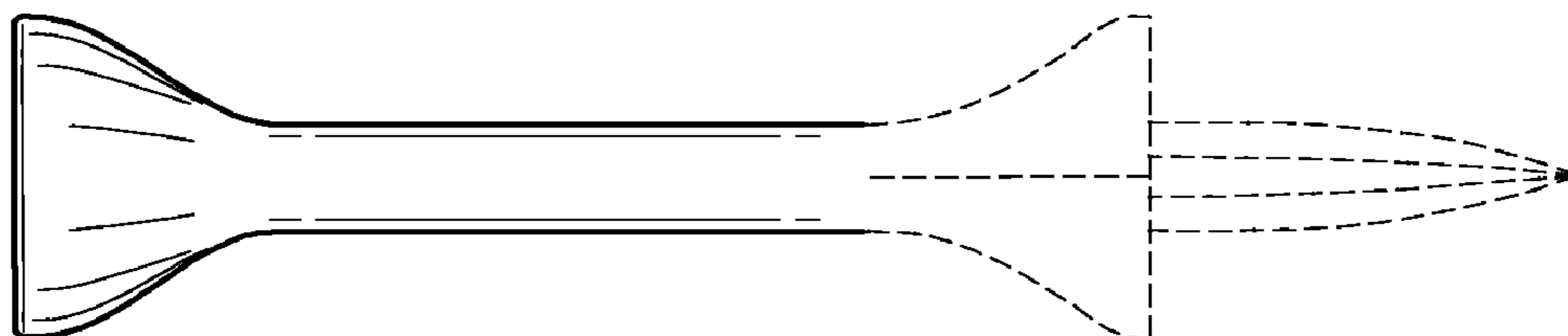

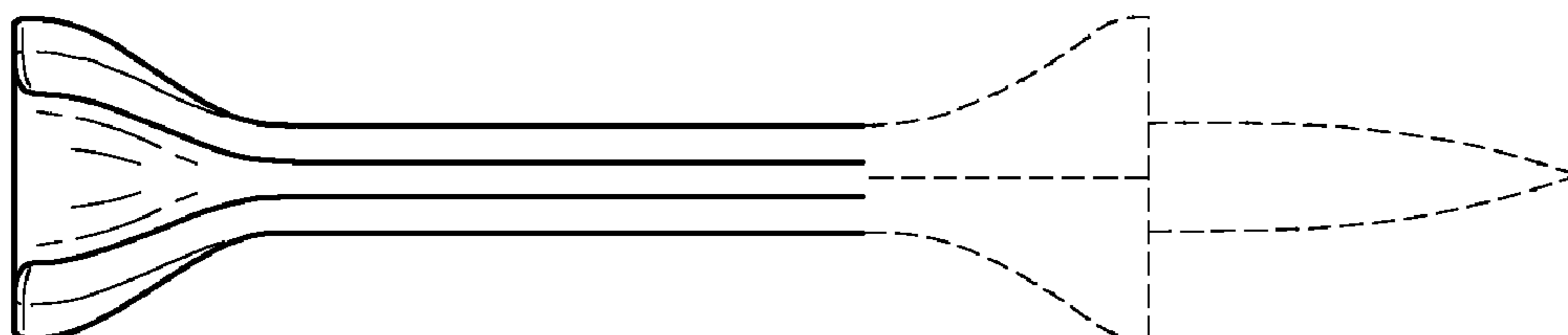

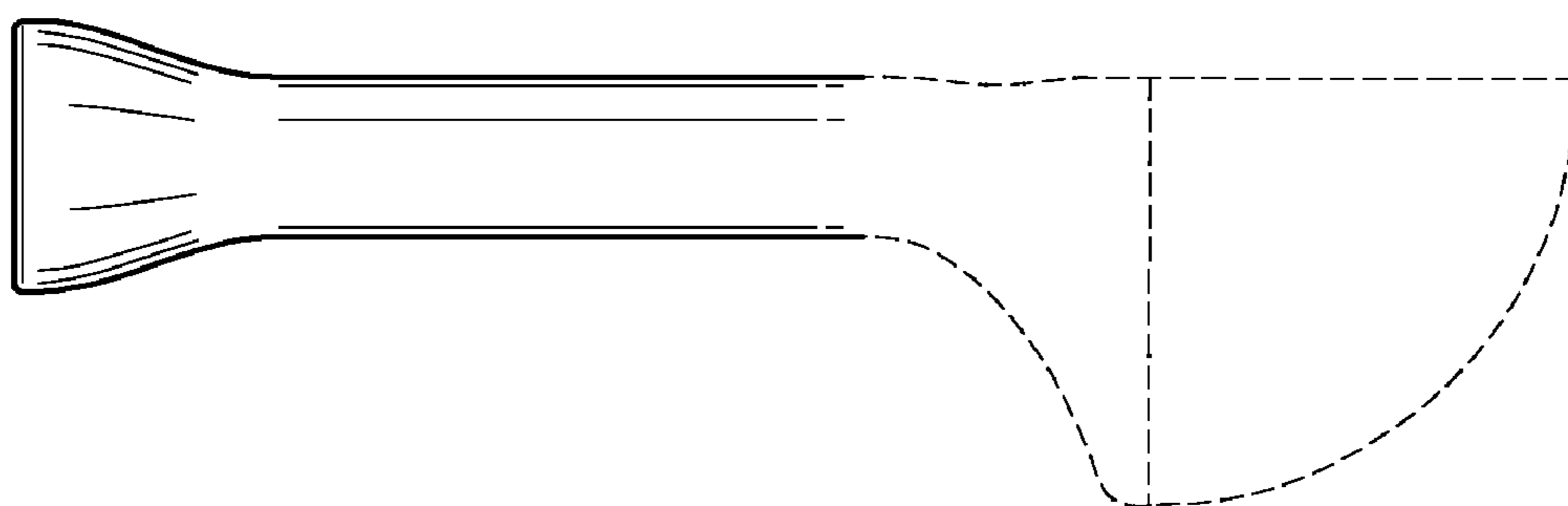

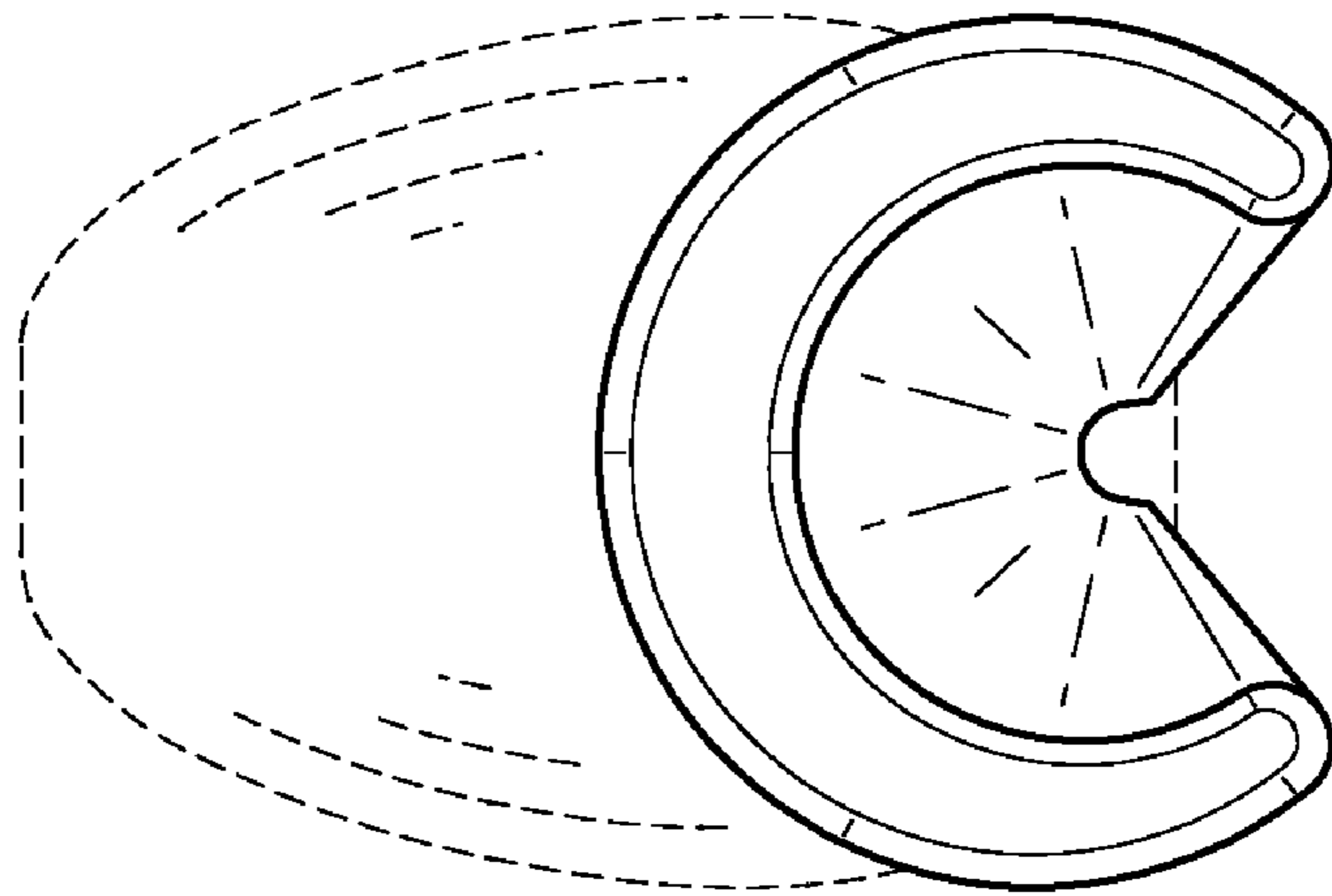

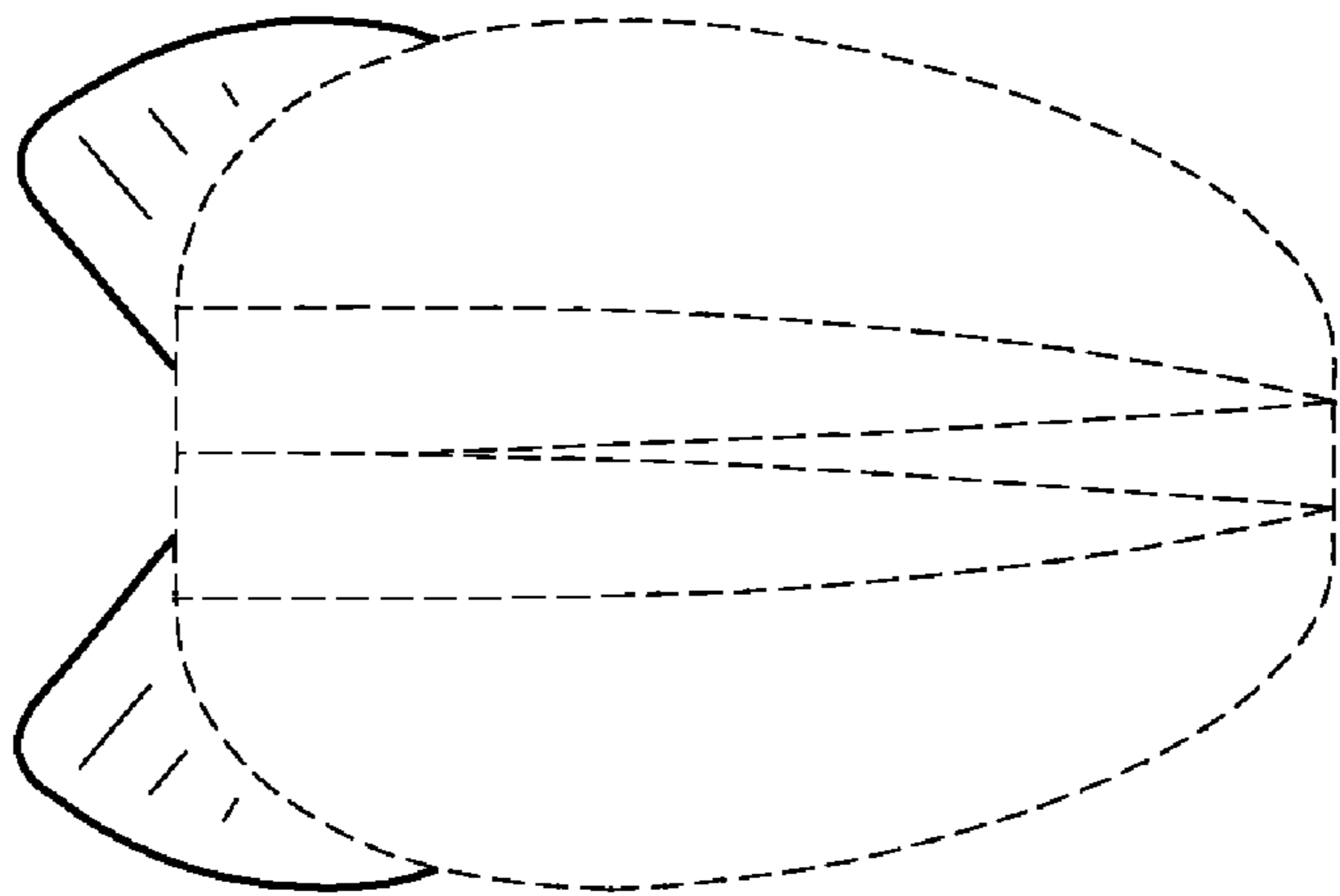
