FIG. 5 is a front view of the disposable body fluid containment bag;

FIG. 6 is a left side elevational view of the disposable body fluid containment bag; and,

FIG. 7 is a right side elevational view of the disposable body fluid containment bag.

The remaining broken lines show stitching that is part of the claimed design.

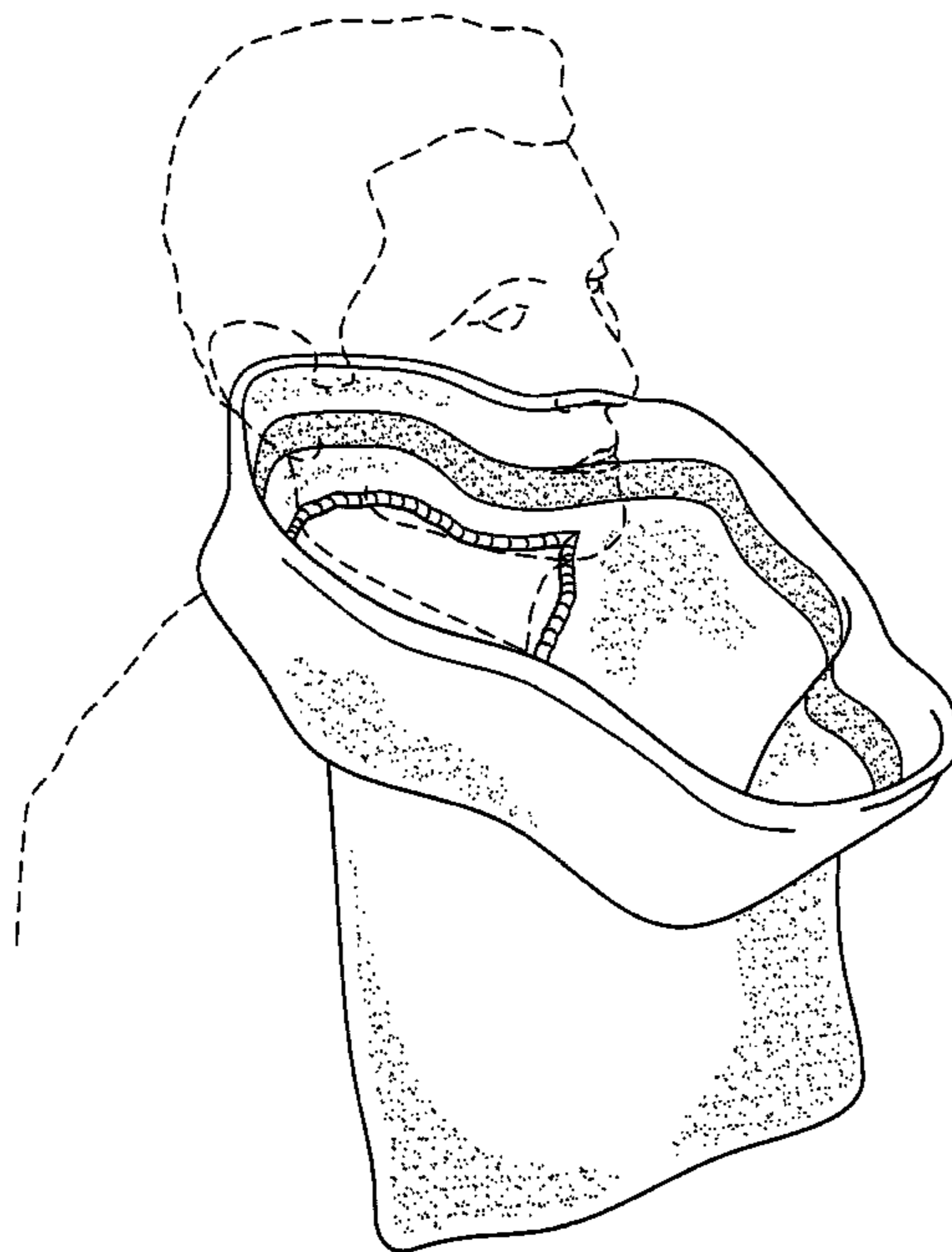

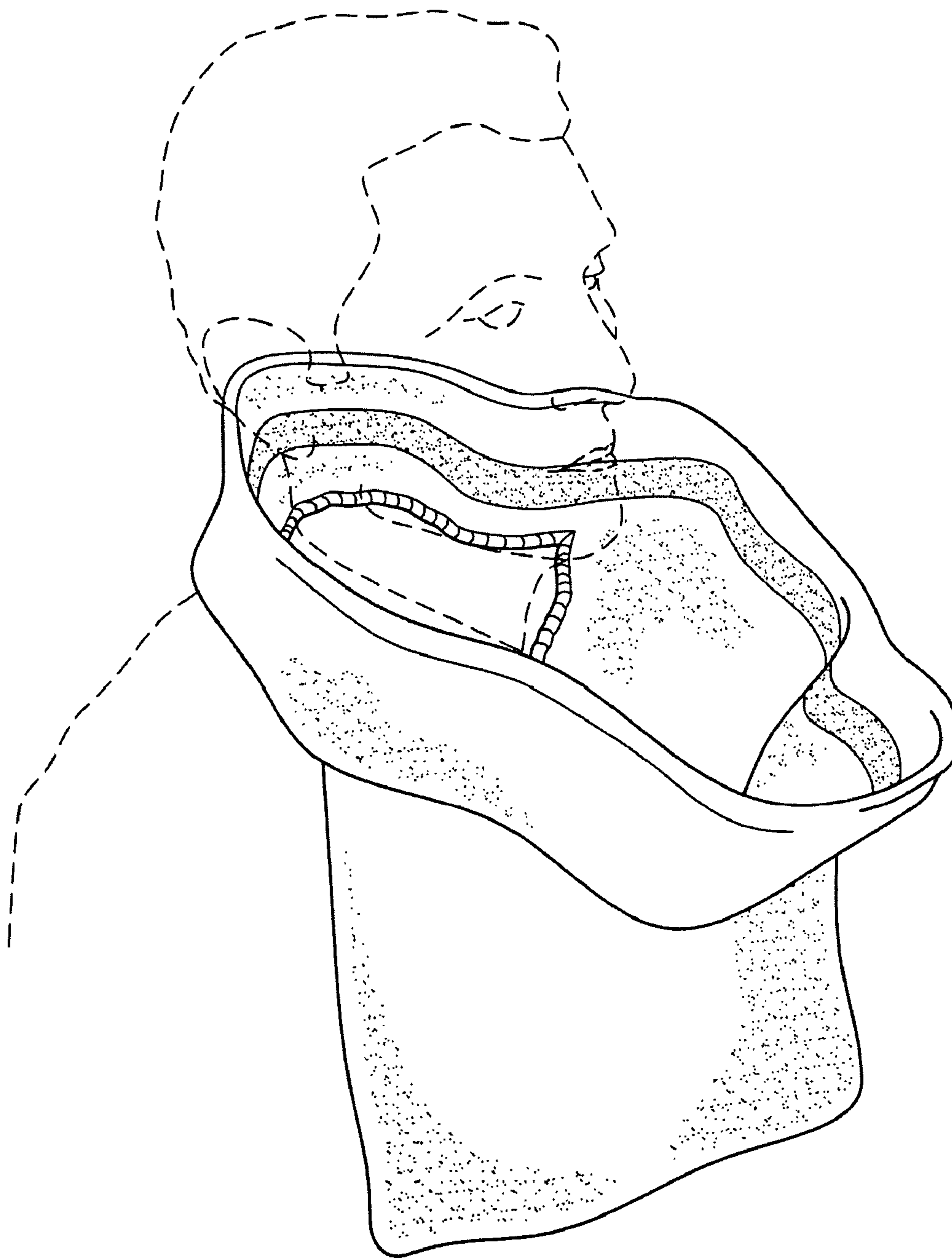

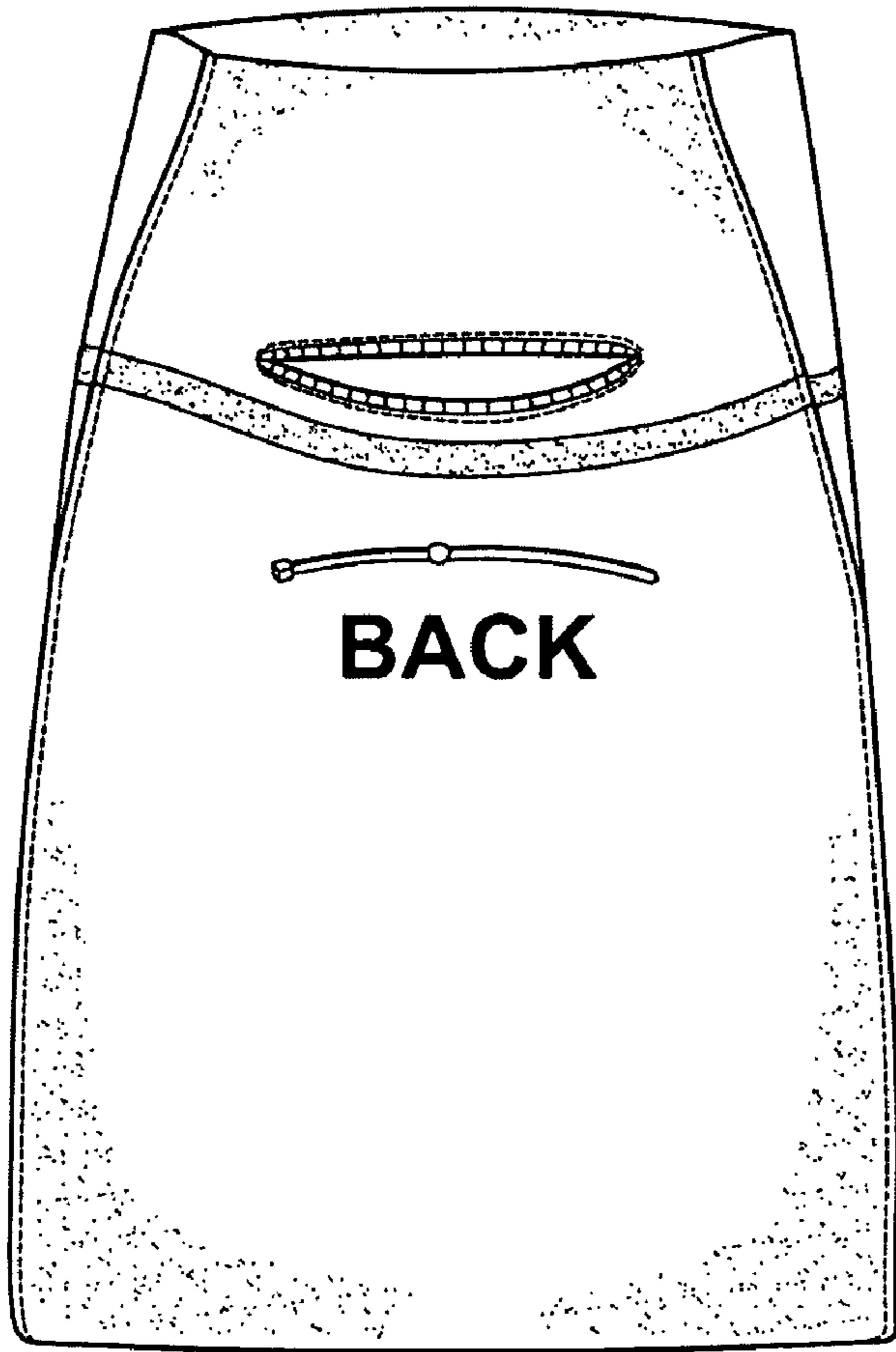

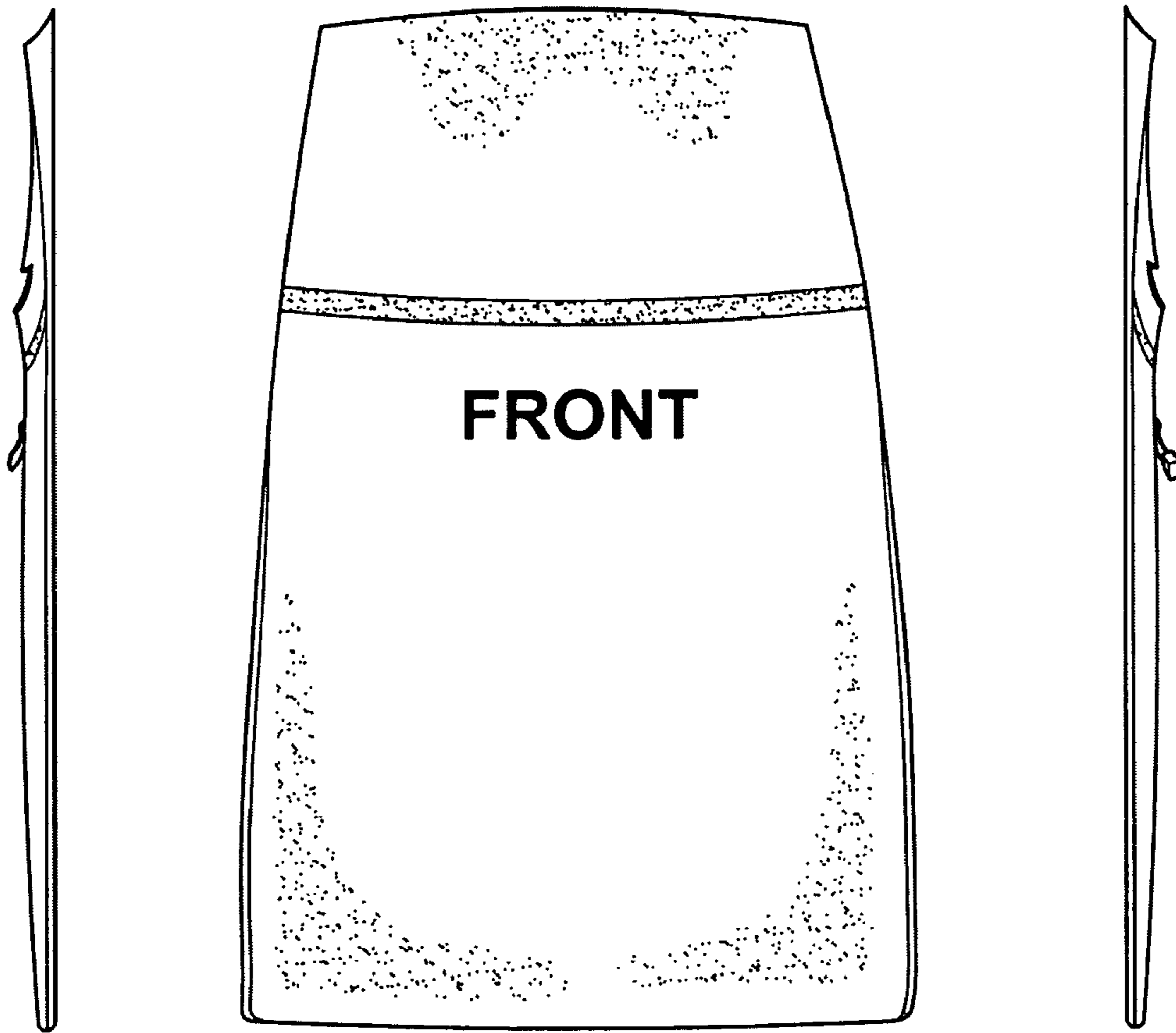
