FIG. 6 is a rear elevation view of FIG. 1;

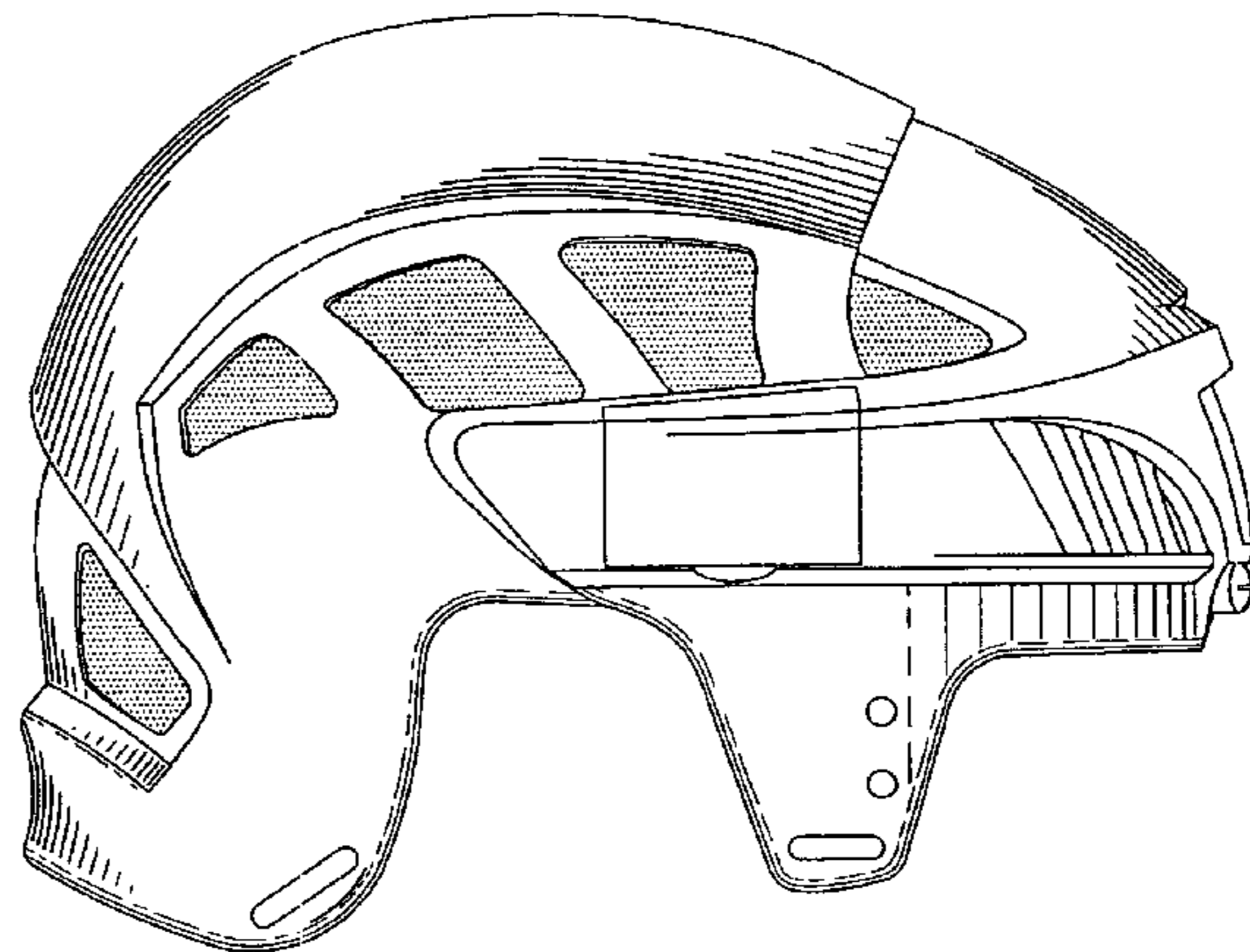
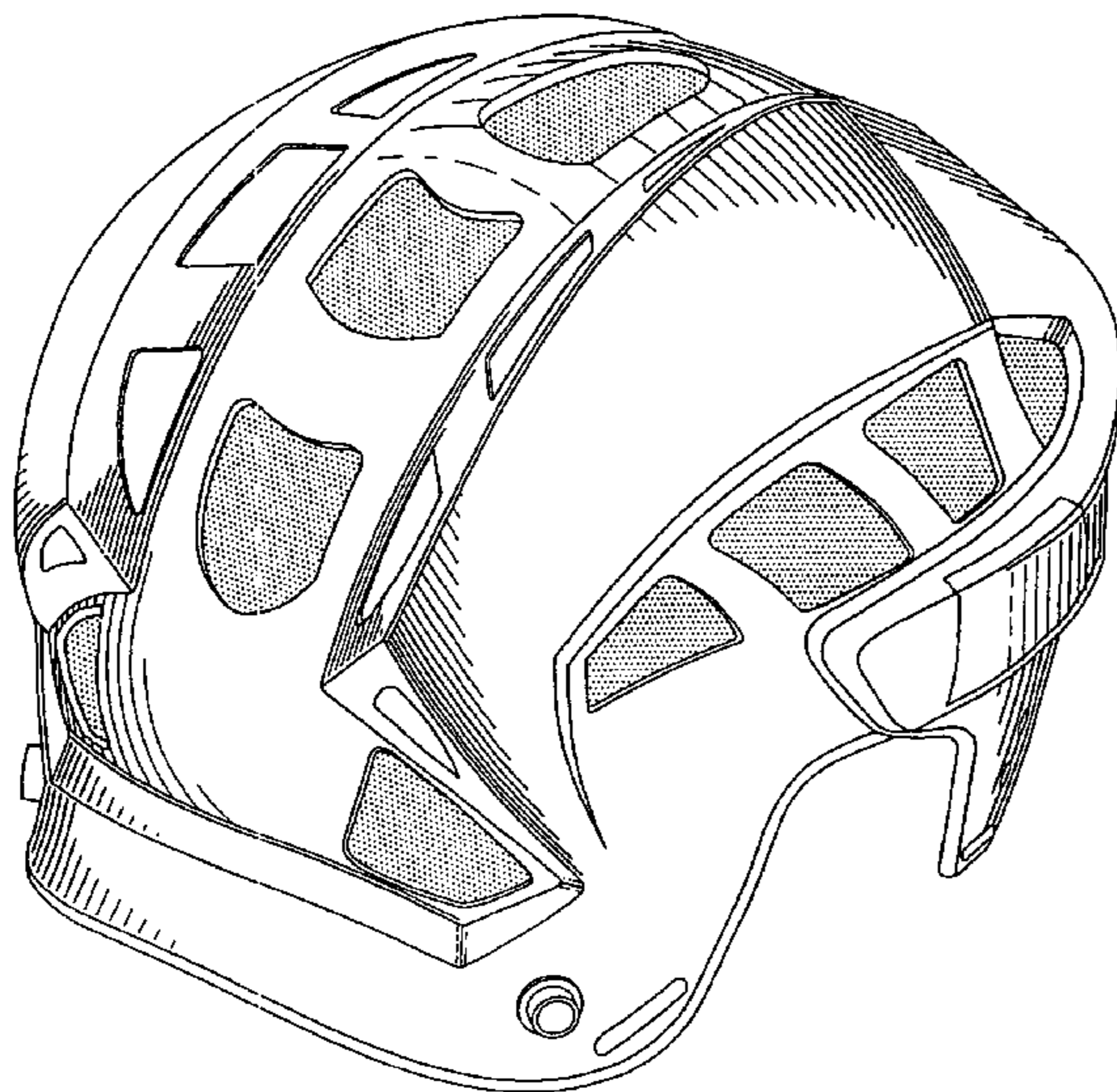
FIG. 7 is a rear perspective view of a second embodiment thereof;

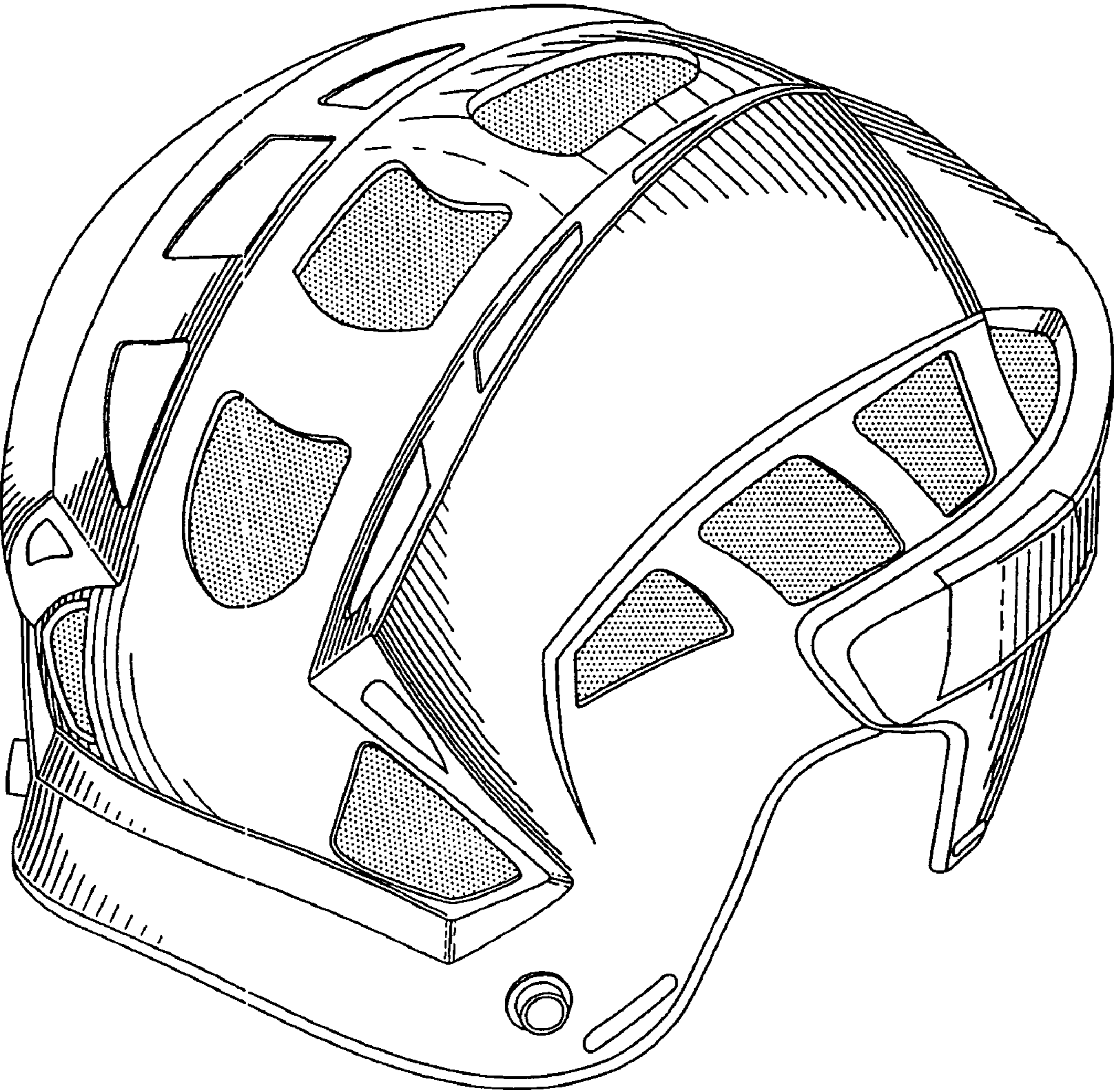

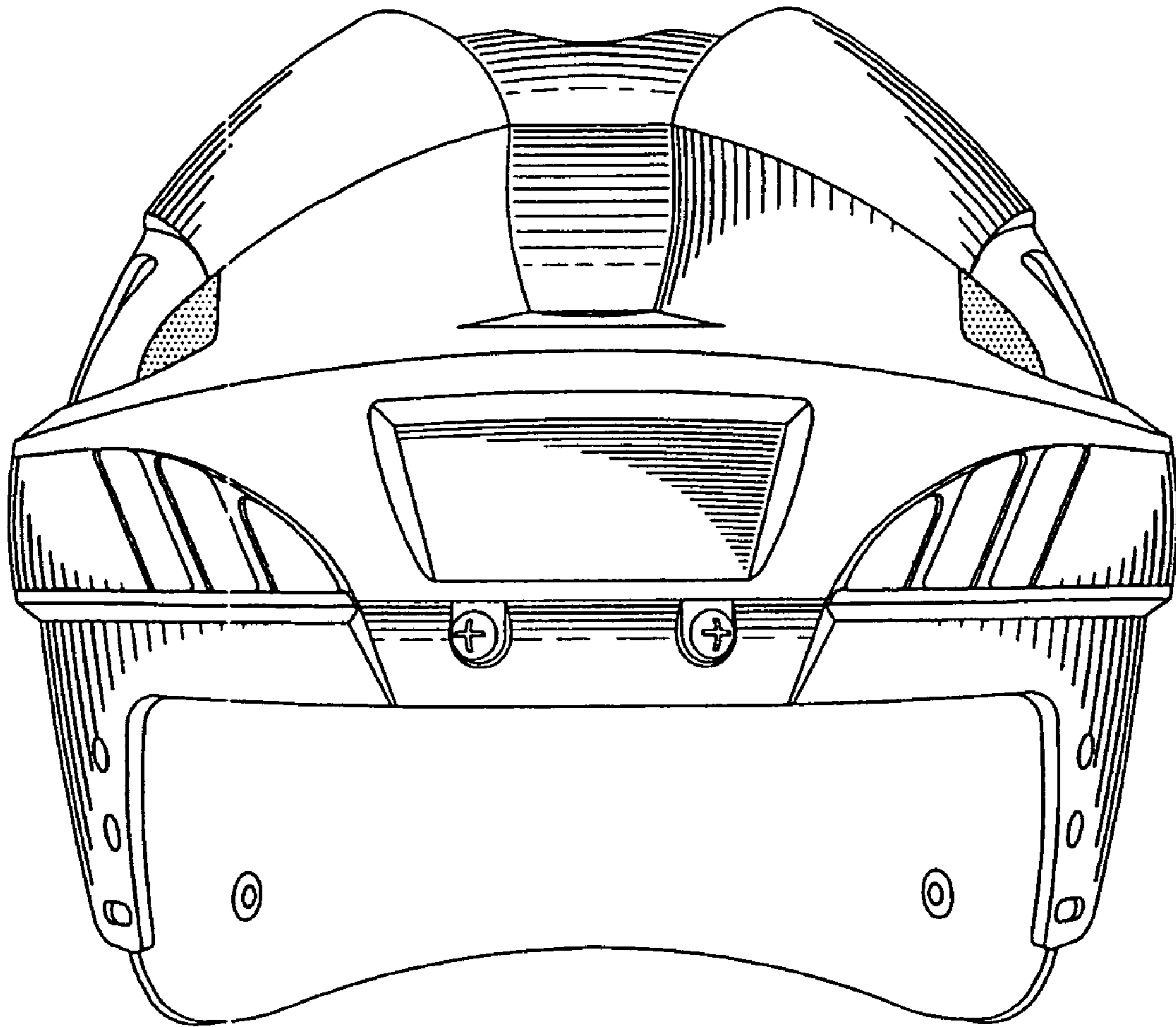

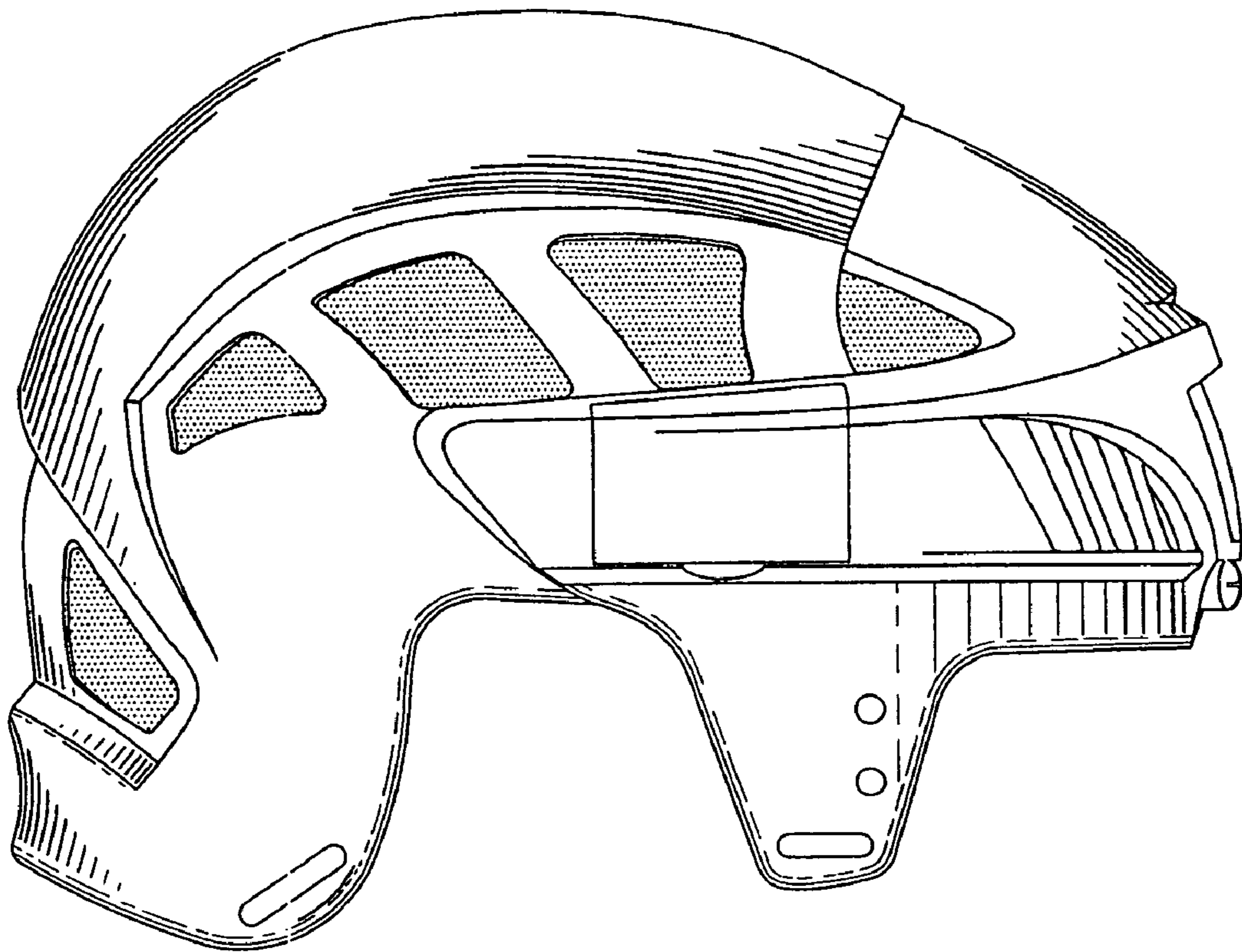

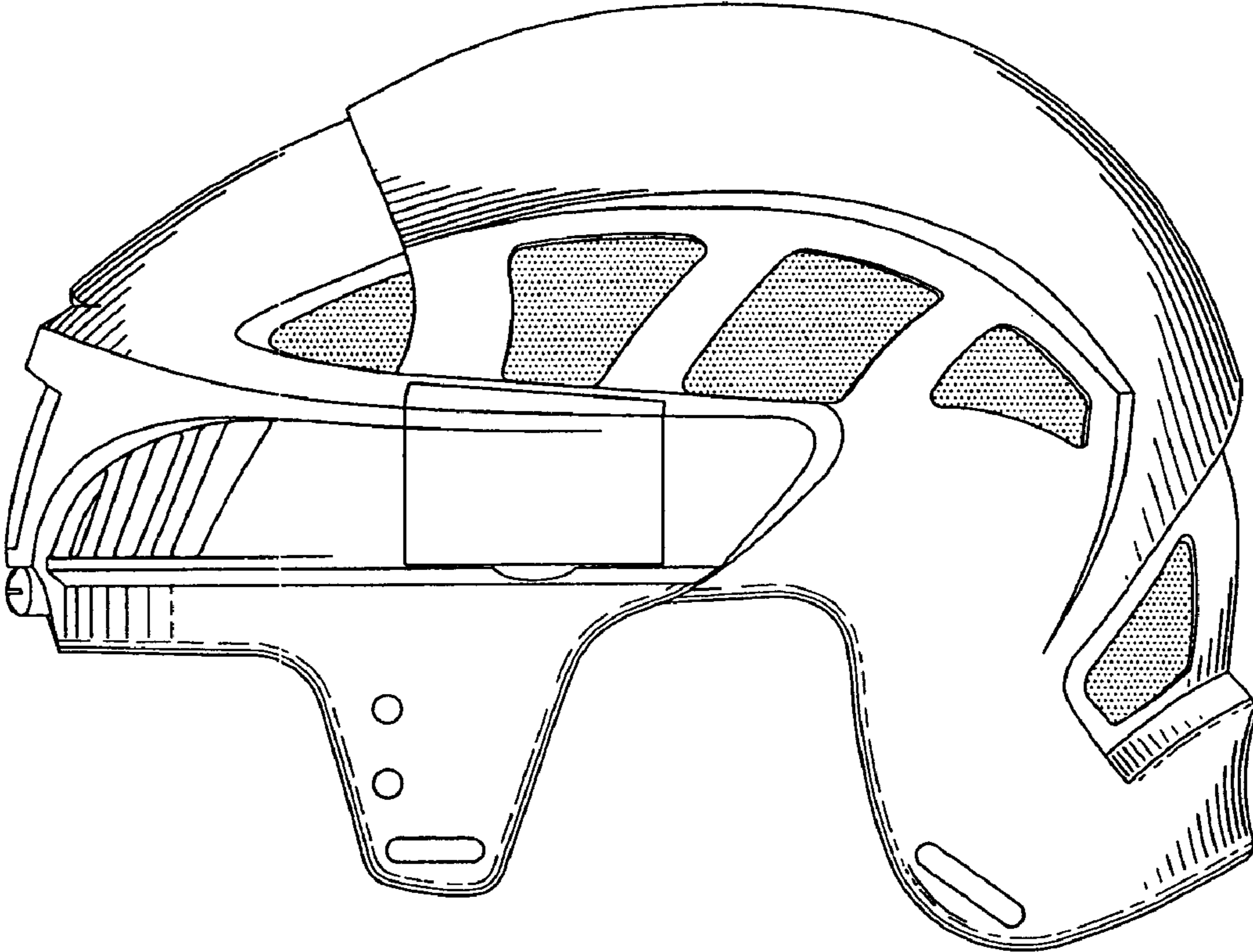

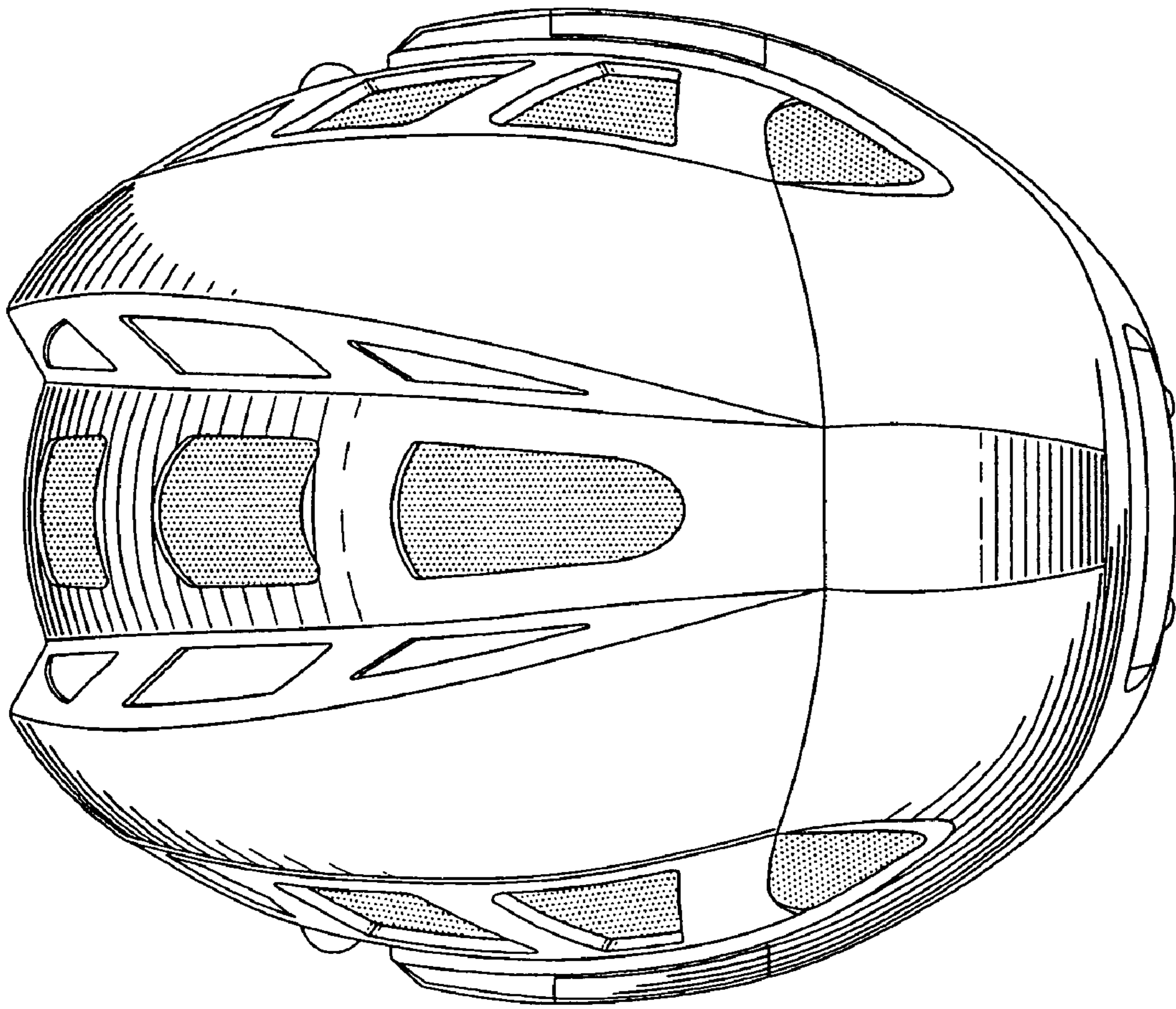

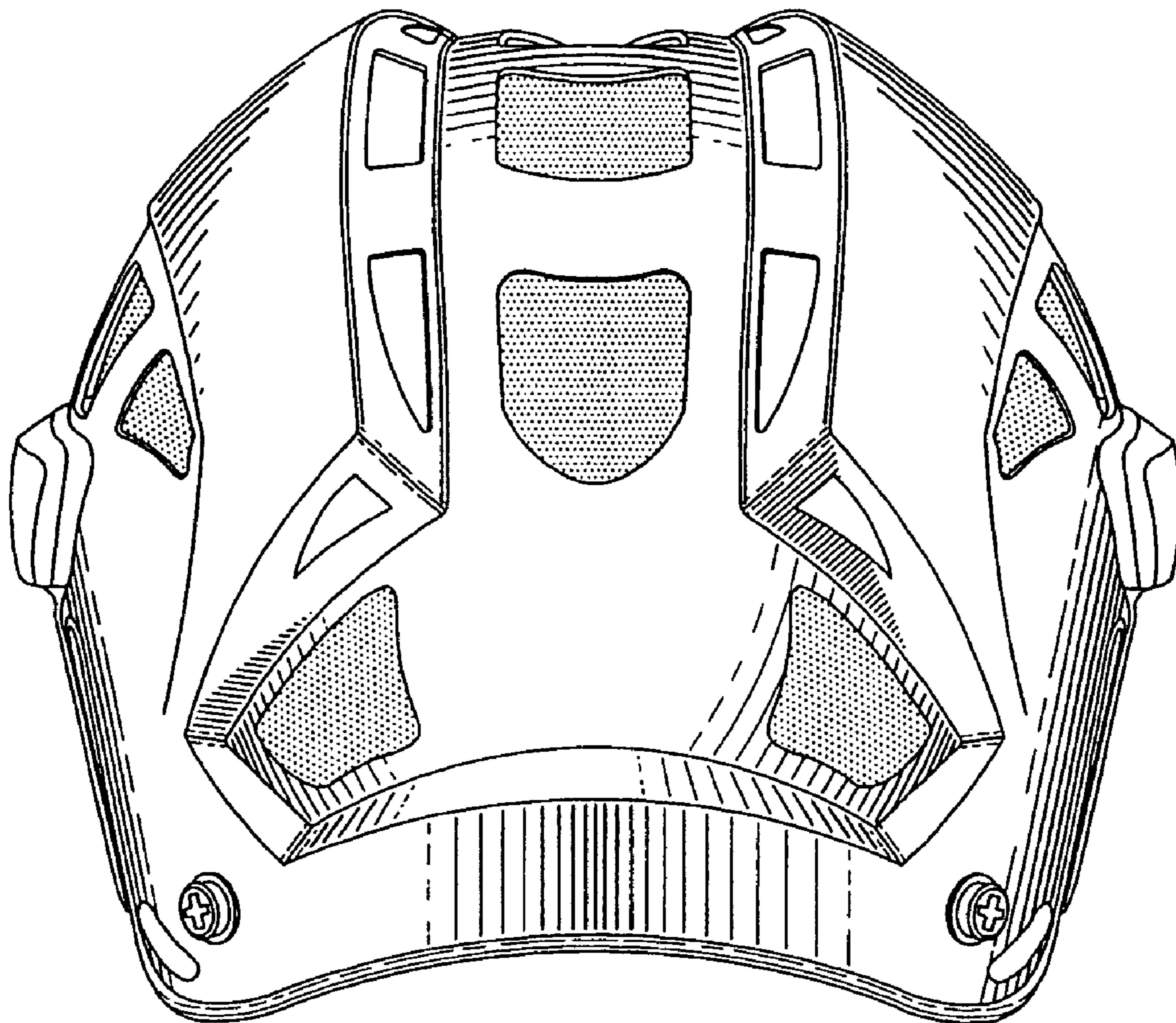

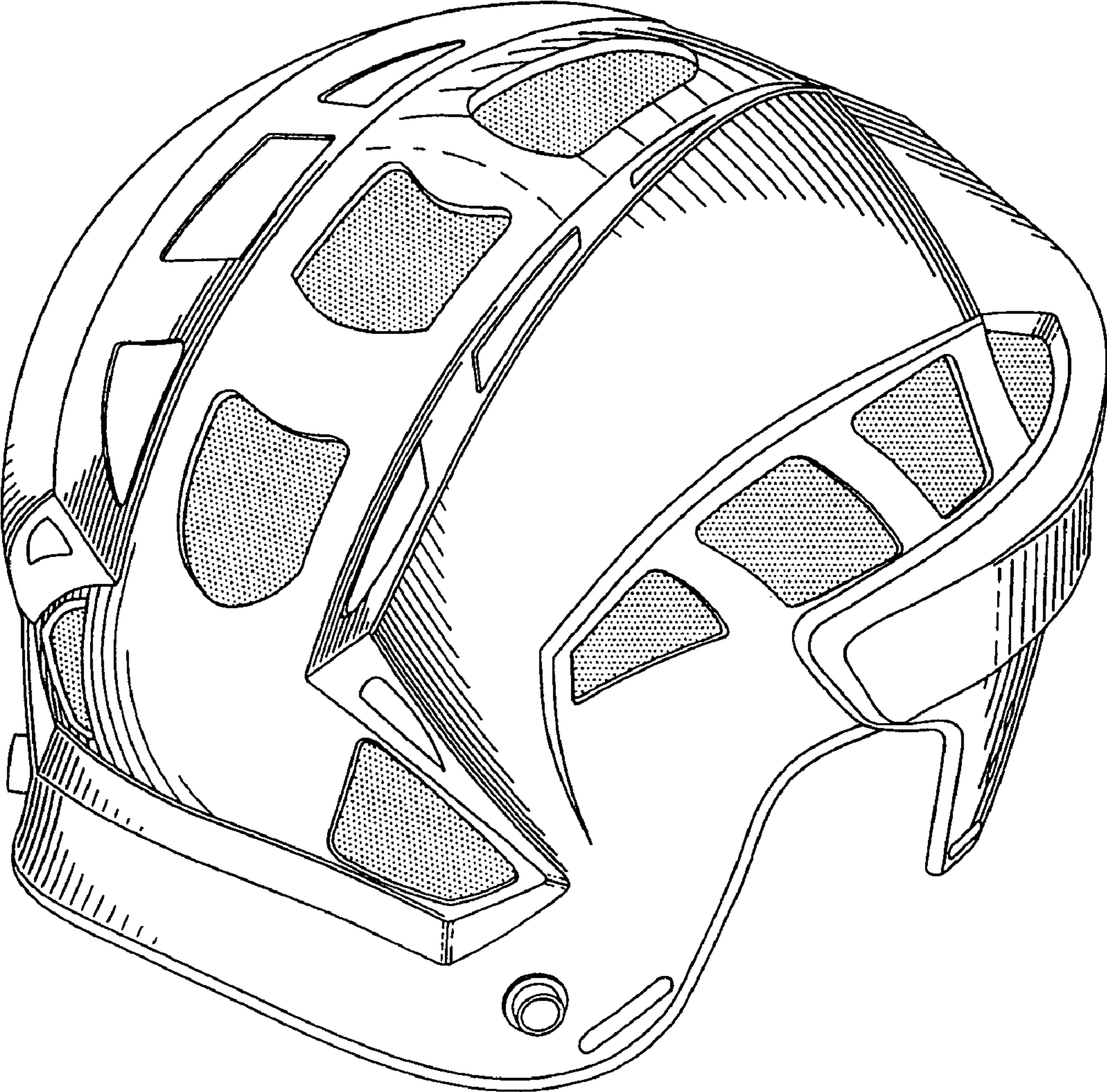

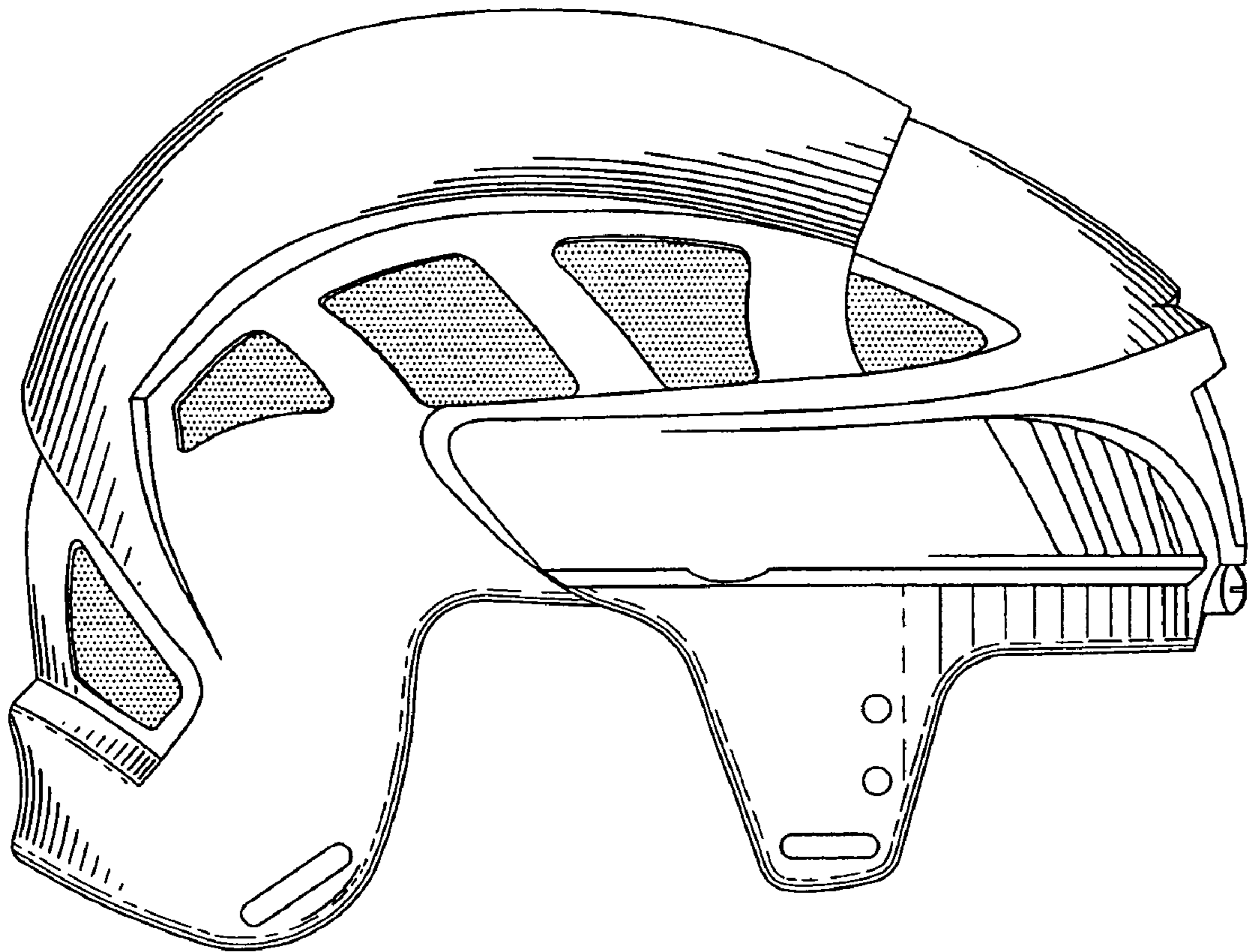

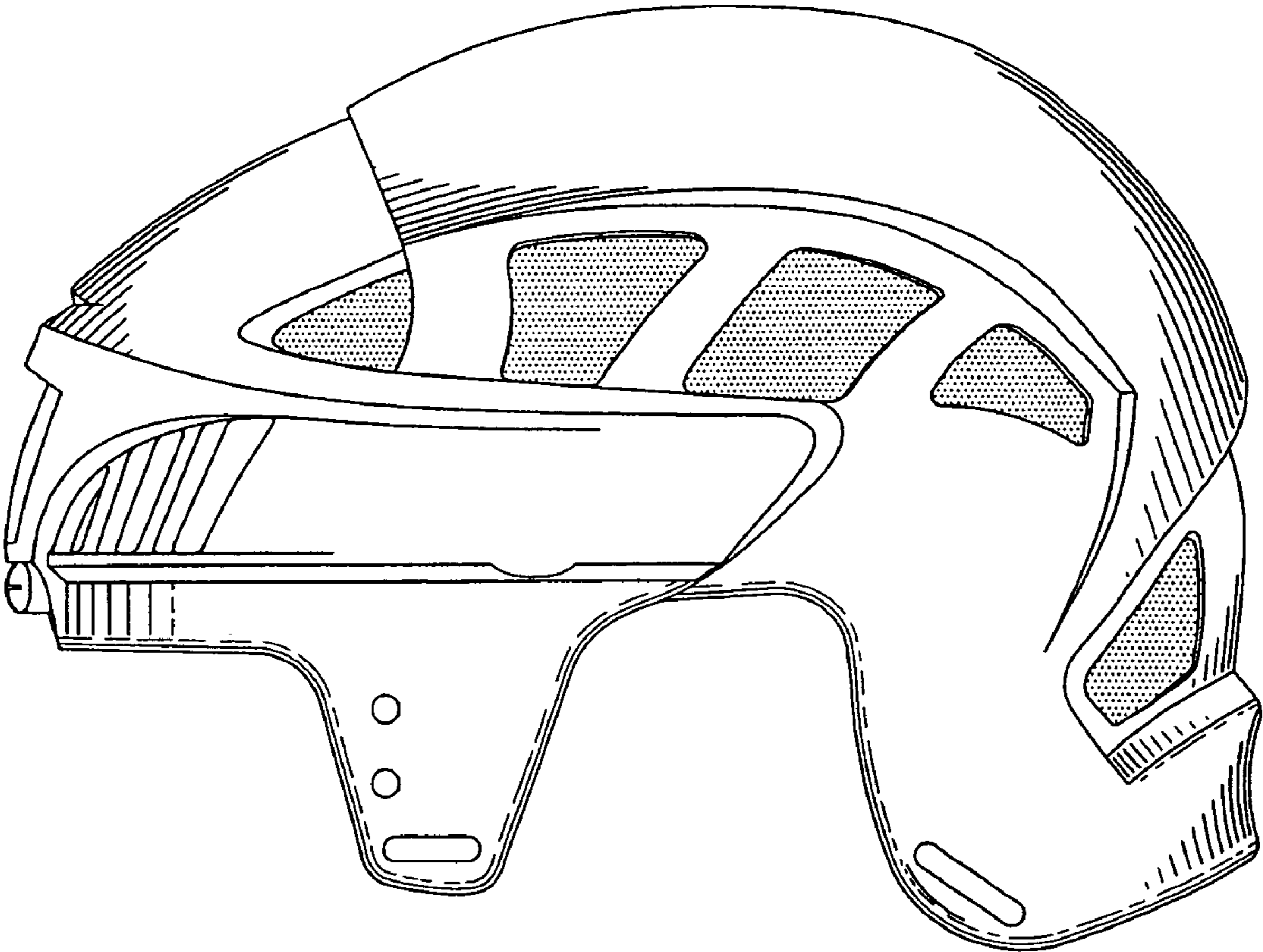

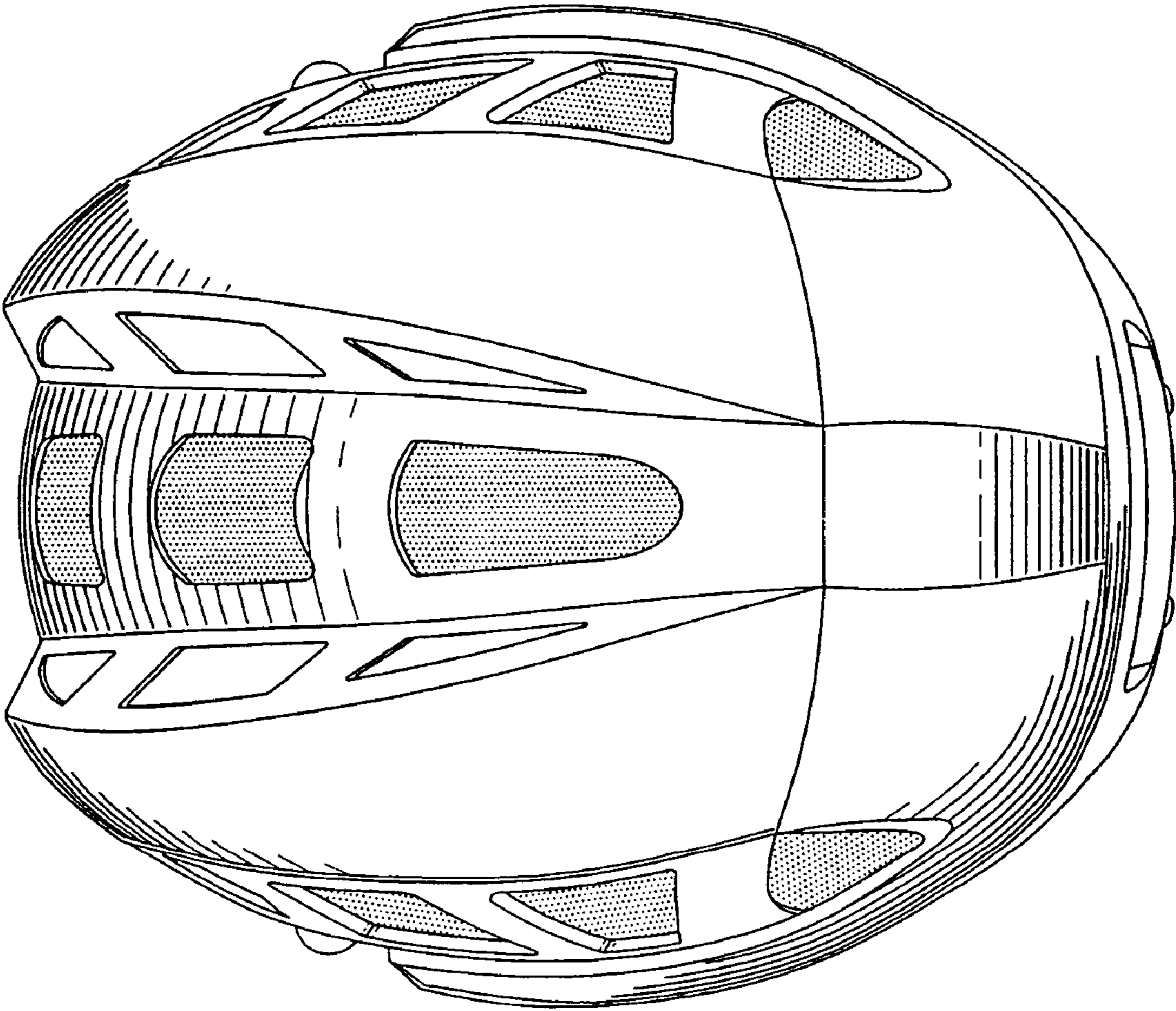
