FIG. 3 is a rear view of a pet bowl design;

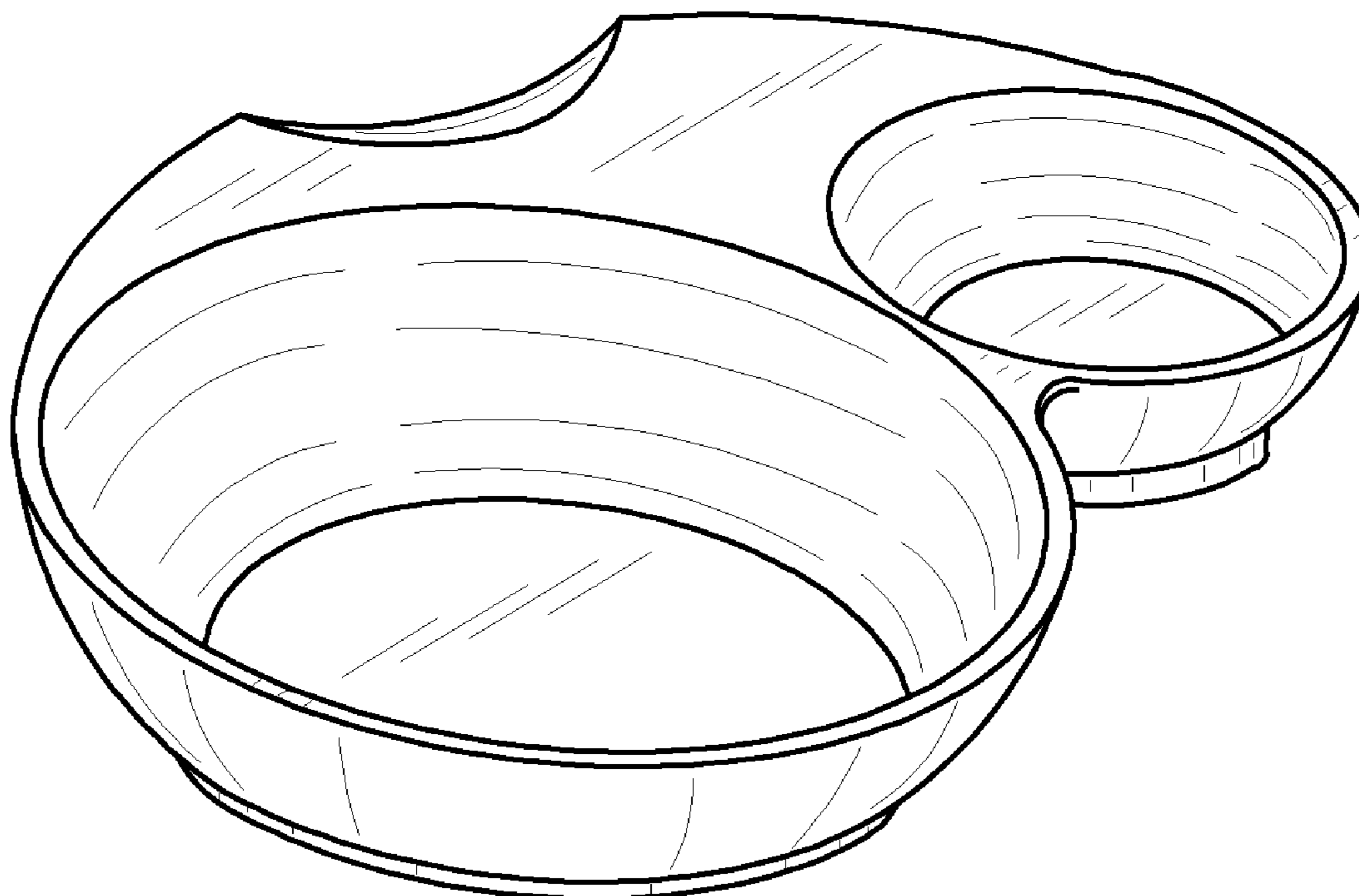
FIG. 4 is a top view of a pet bowl design;

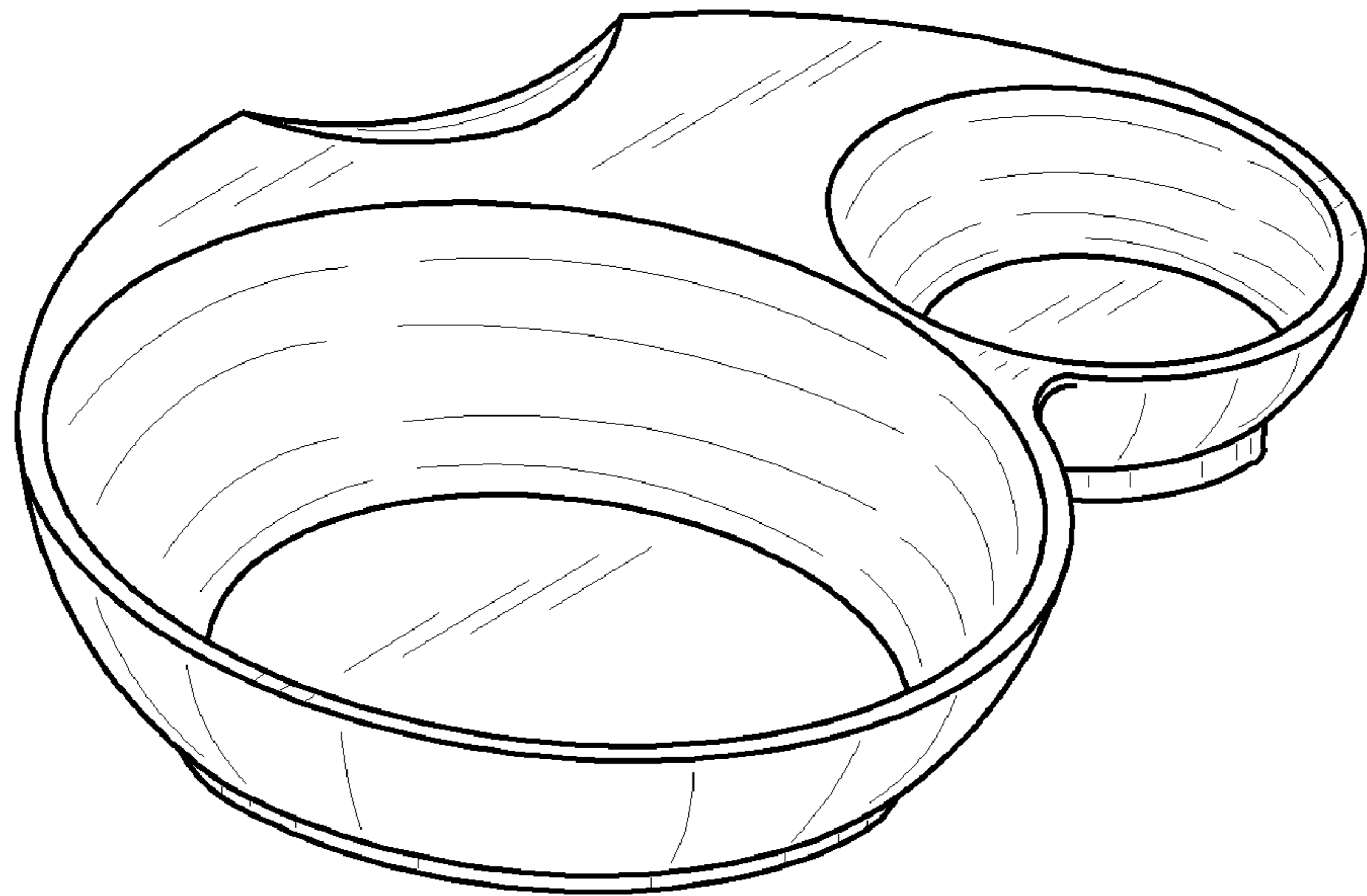

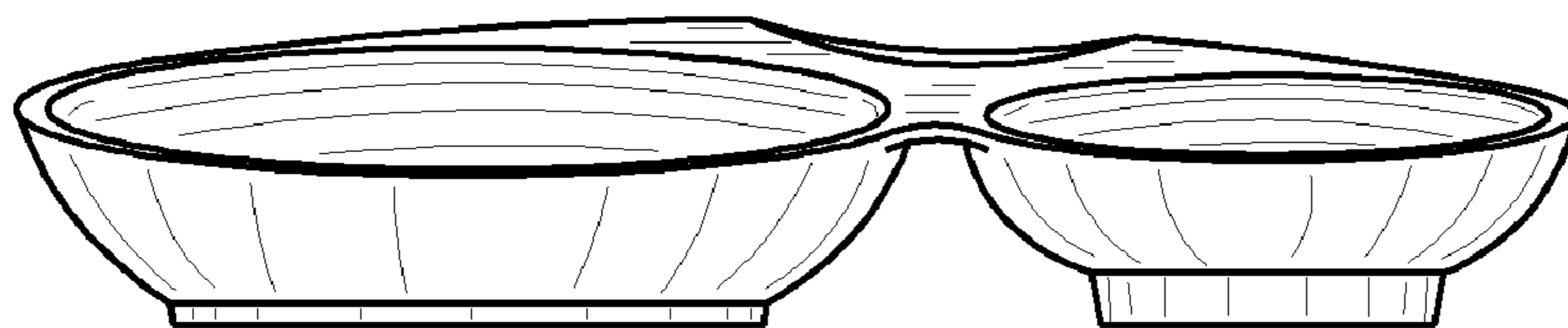

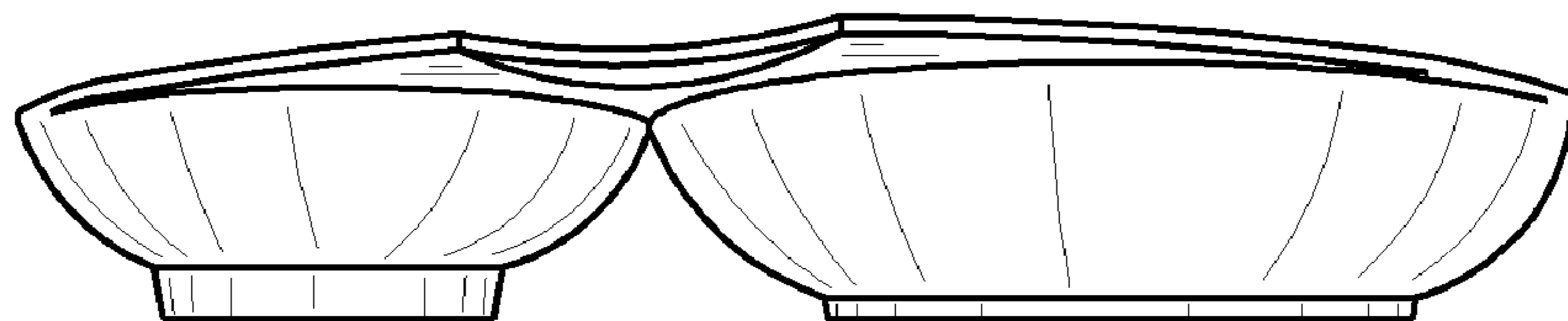

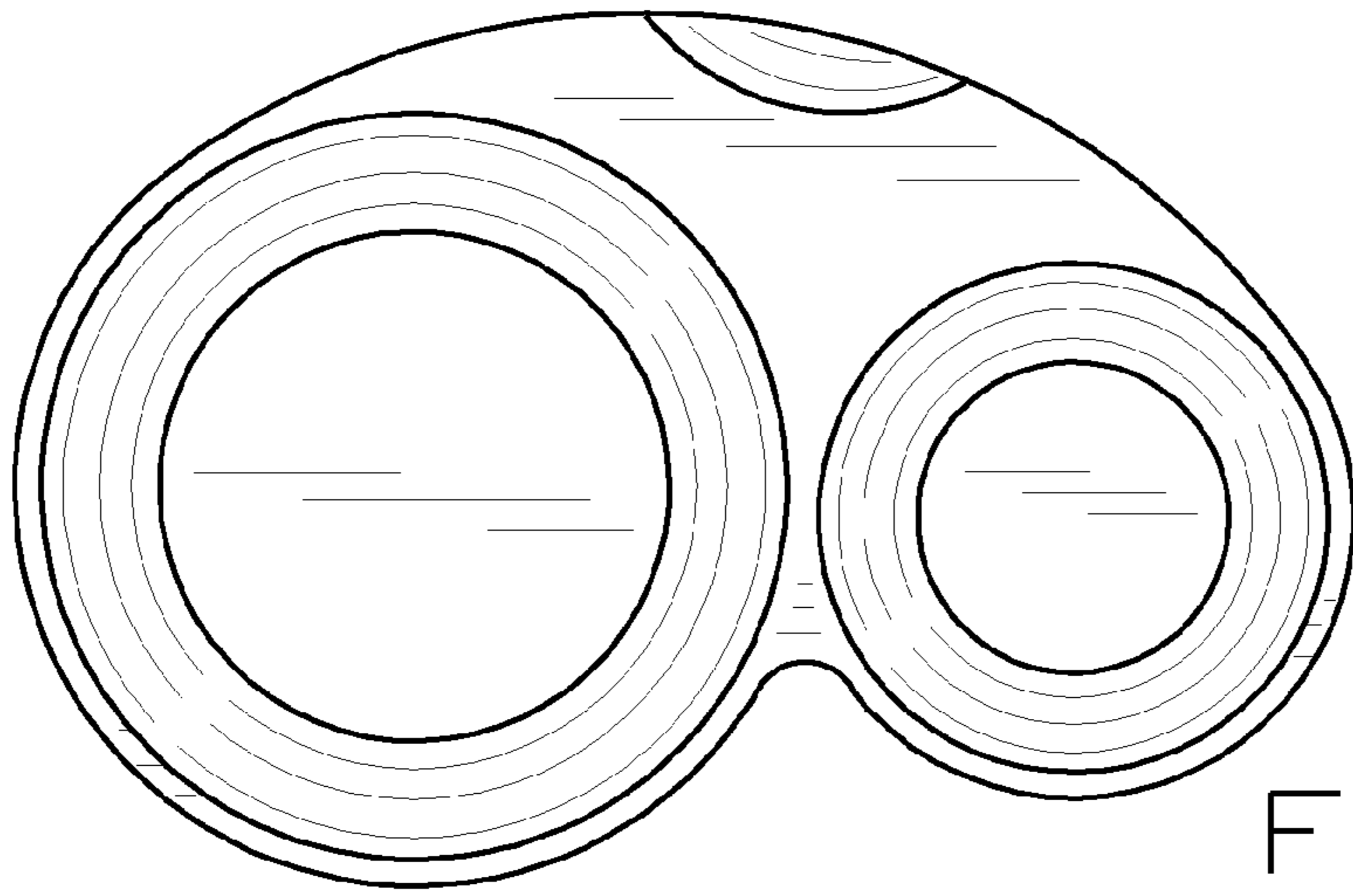

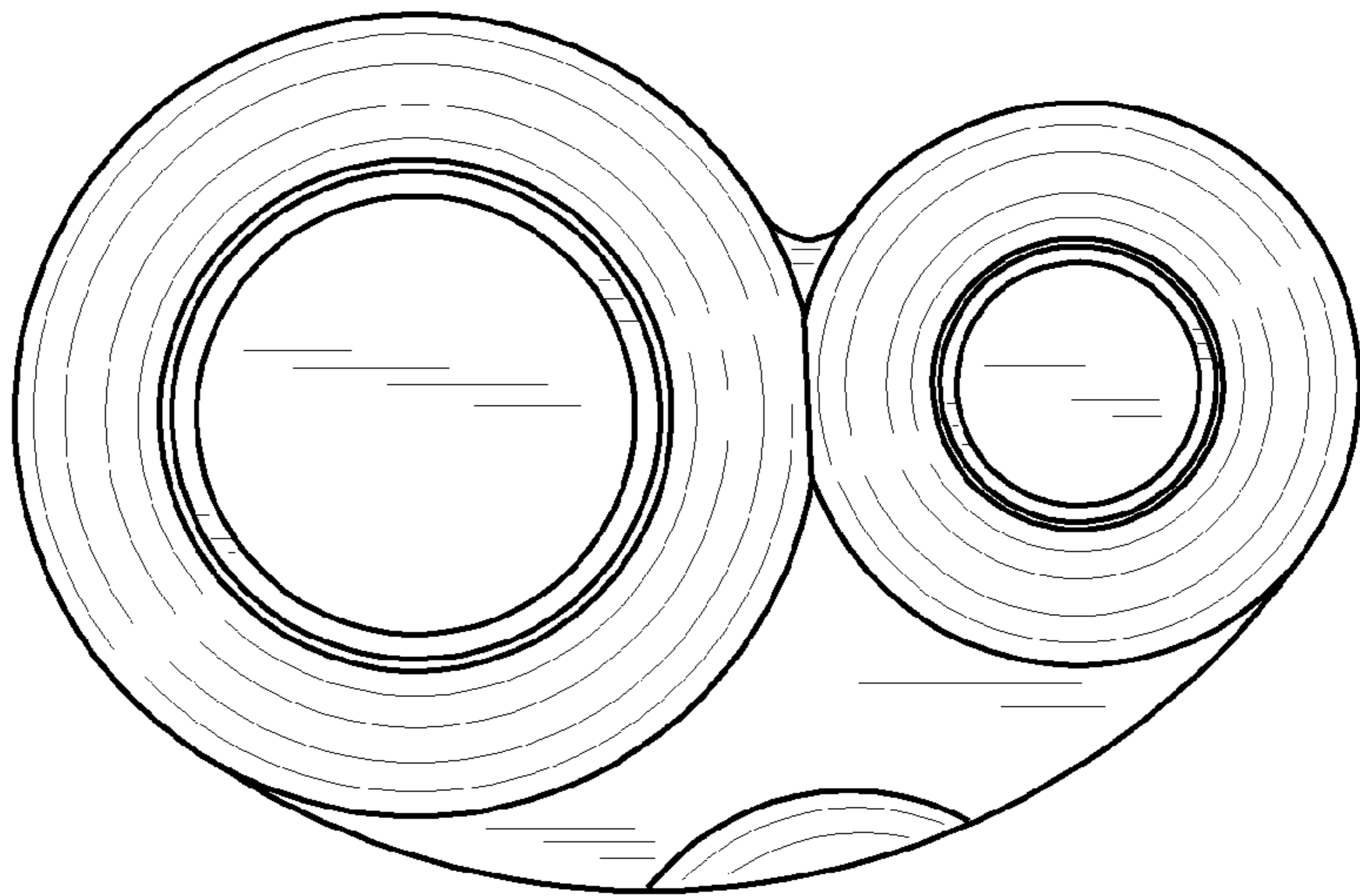

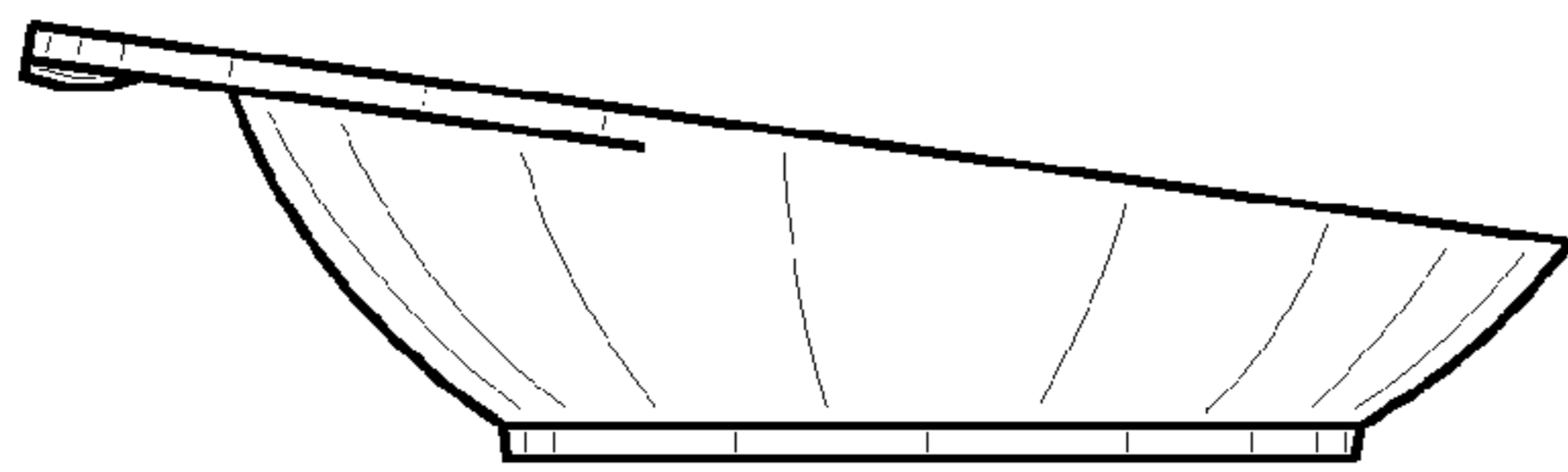

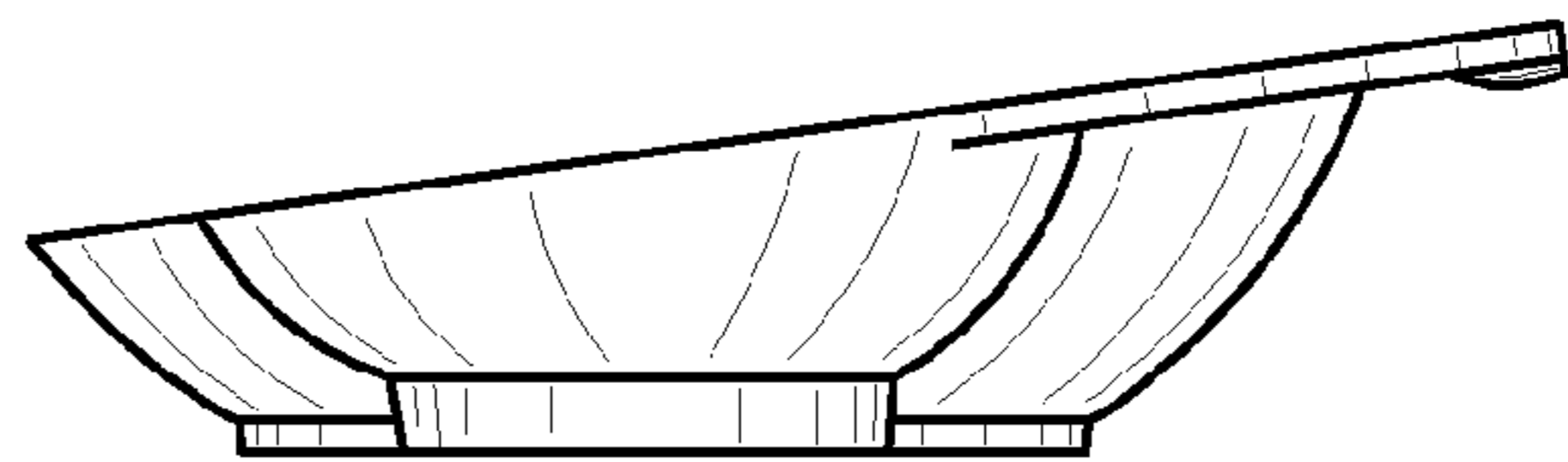
