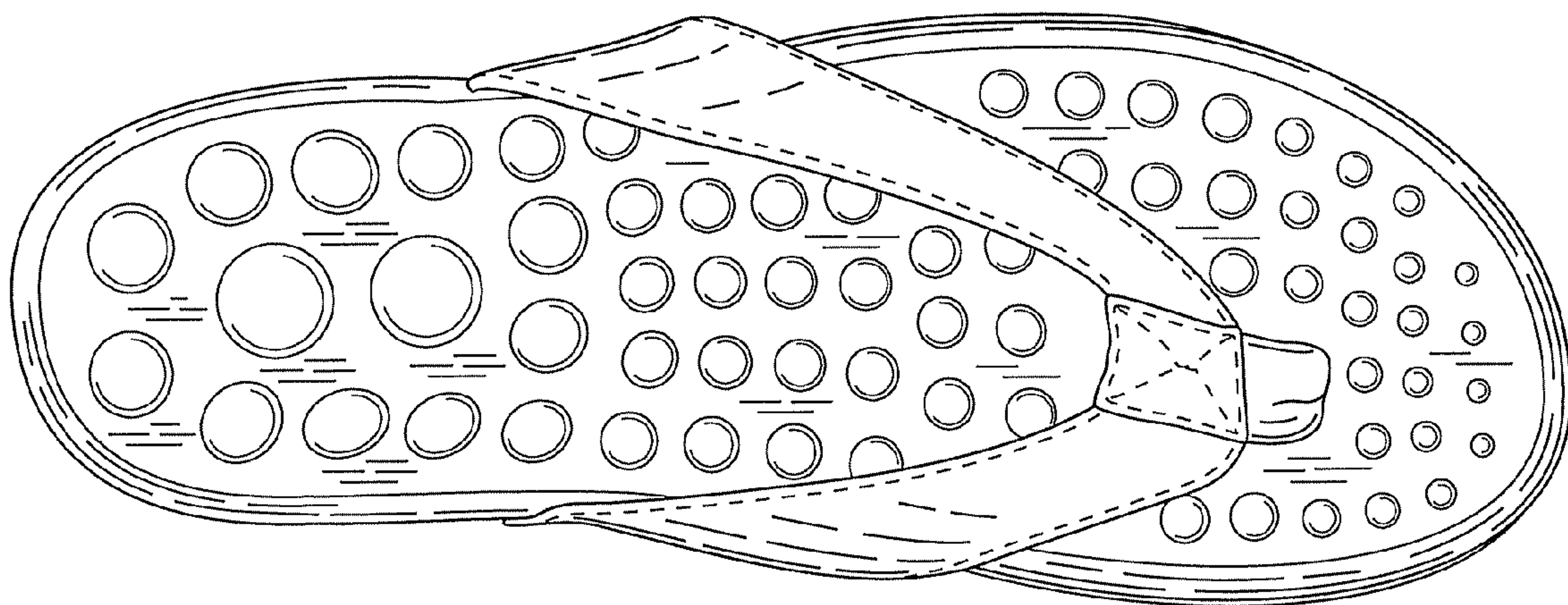
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of a sandal, showing my new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a front elevational view thereof.  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a lateral side elevational view thereof; and  
FIG. 6 is a medial side elevational view thereof;  
FIG. 7 is a front perspective view thereof;  
FIG. 8 is a rear perspective view thereof; and,  
FIG. 9 is a bottom perspective view thereof.

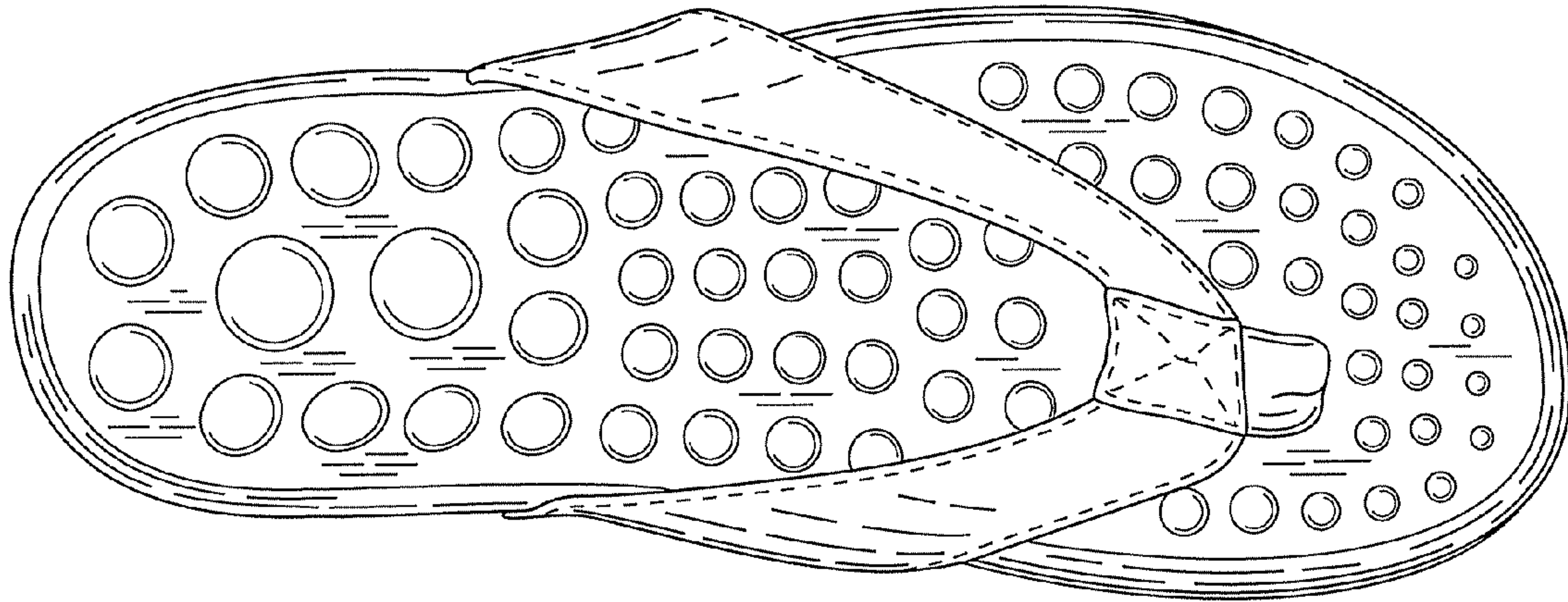

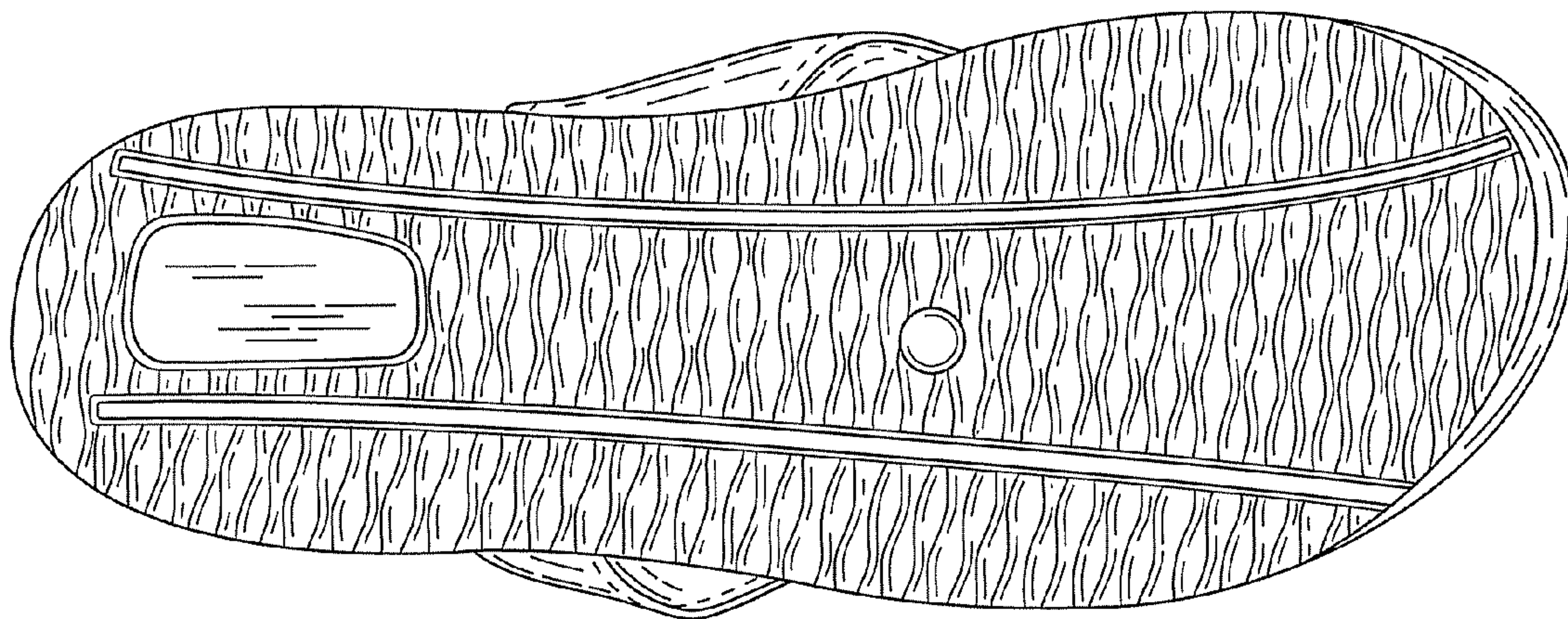

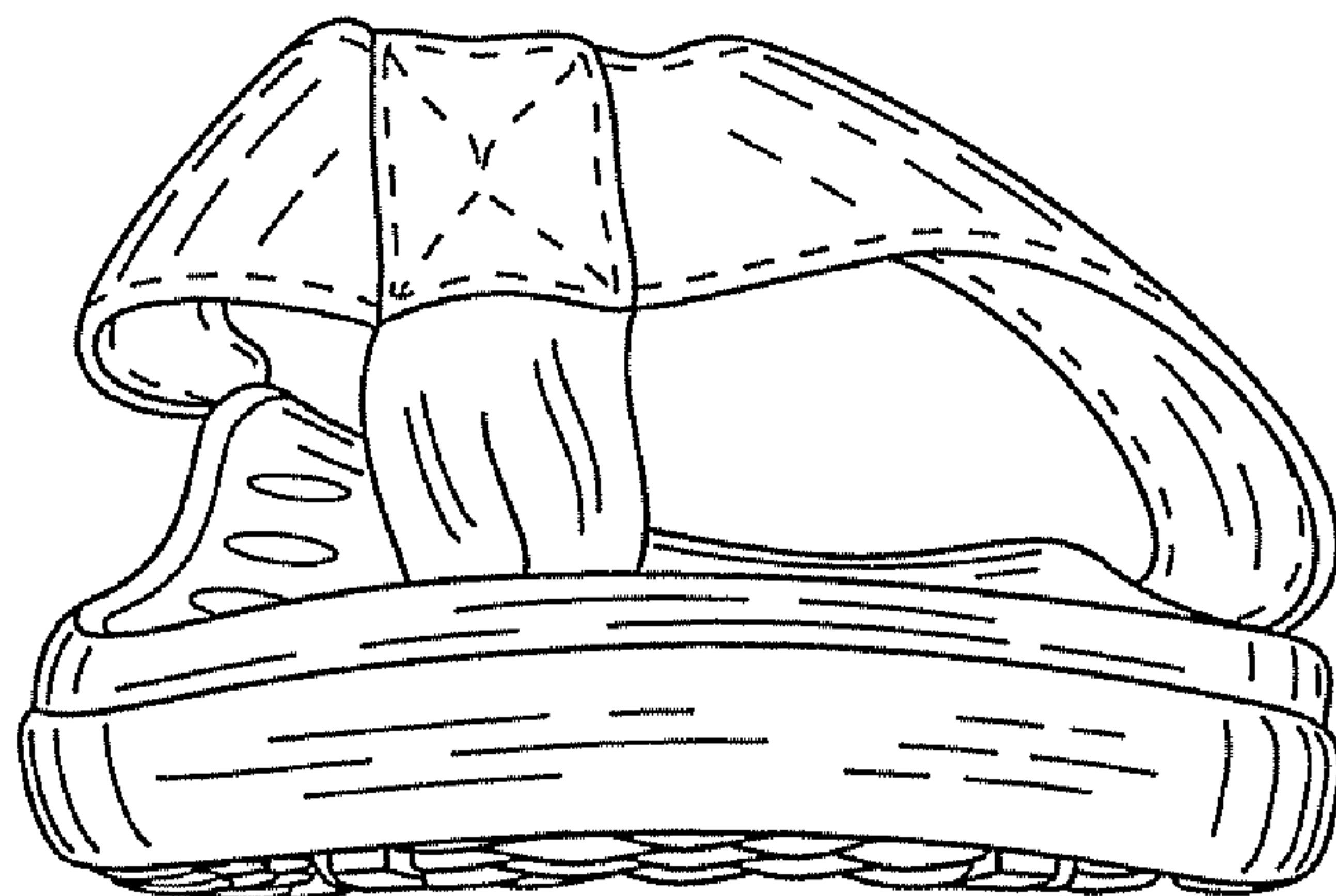

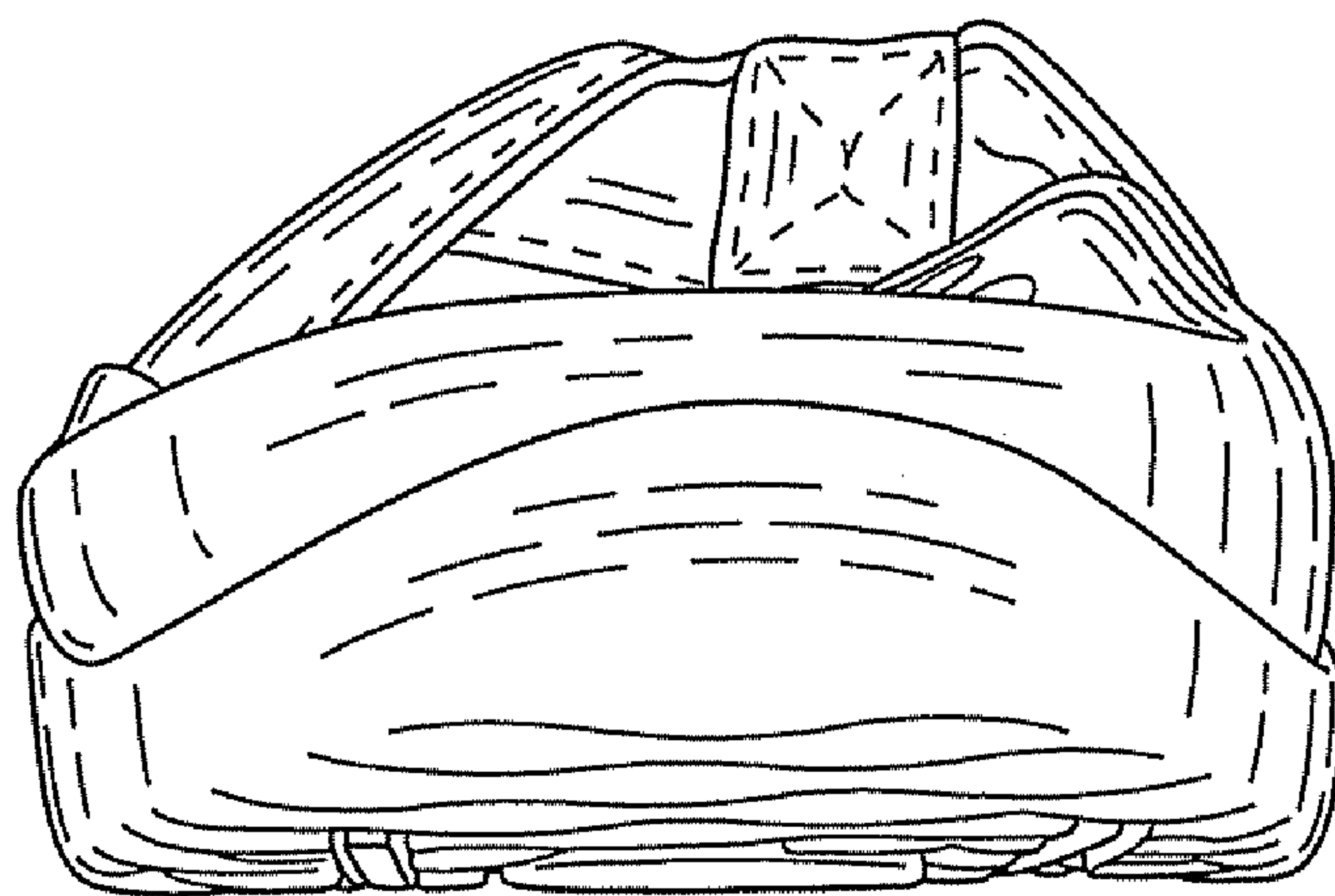

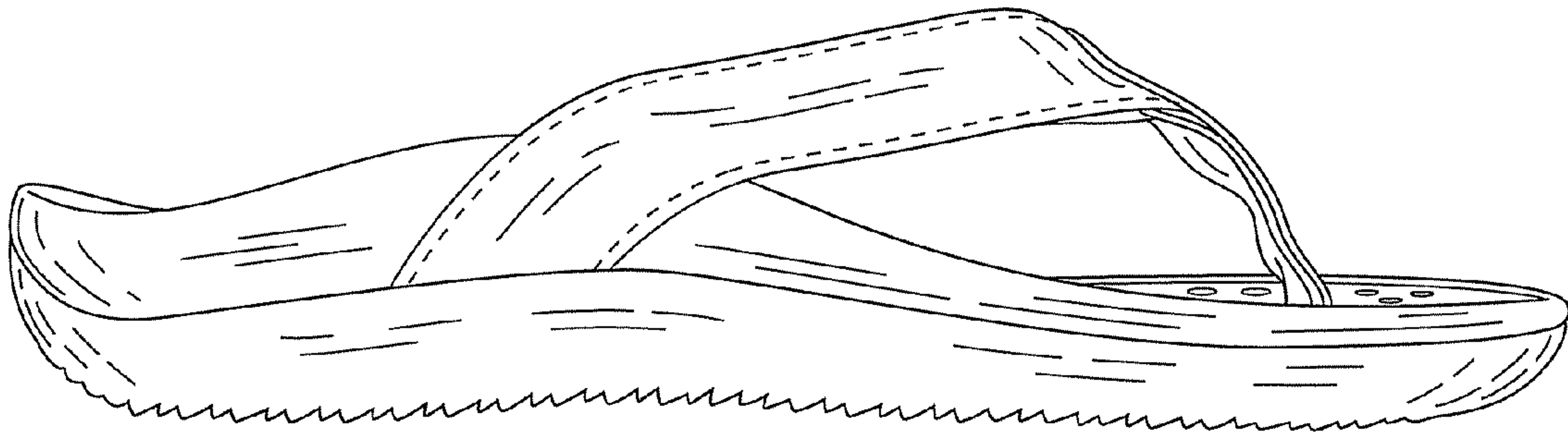

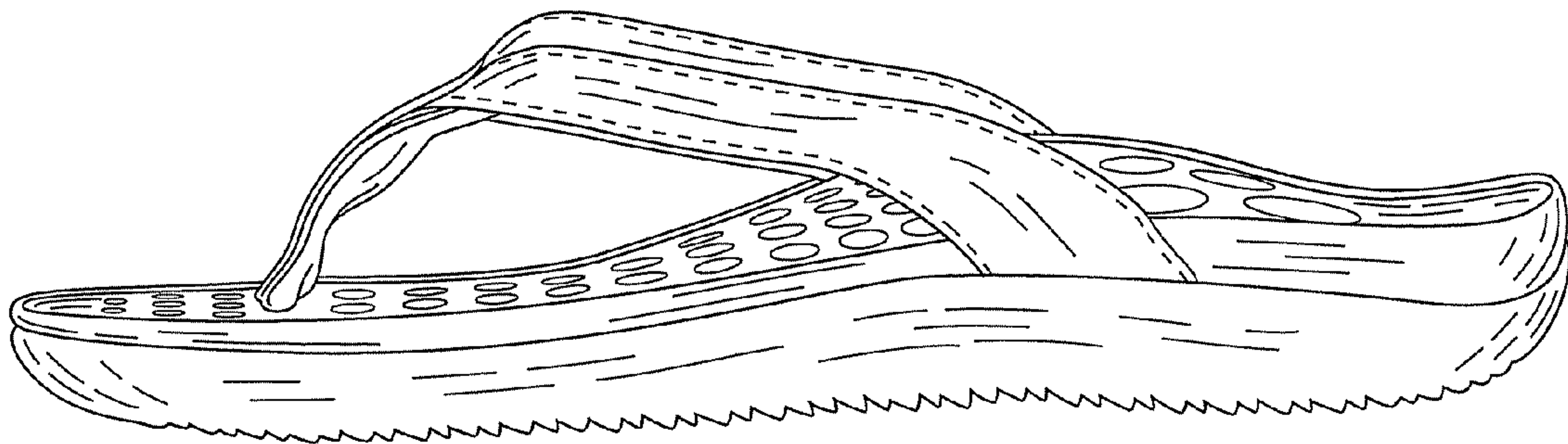

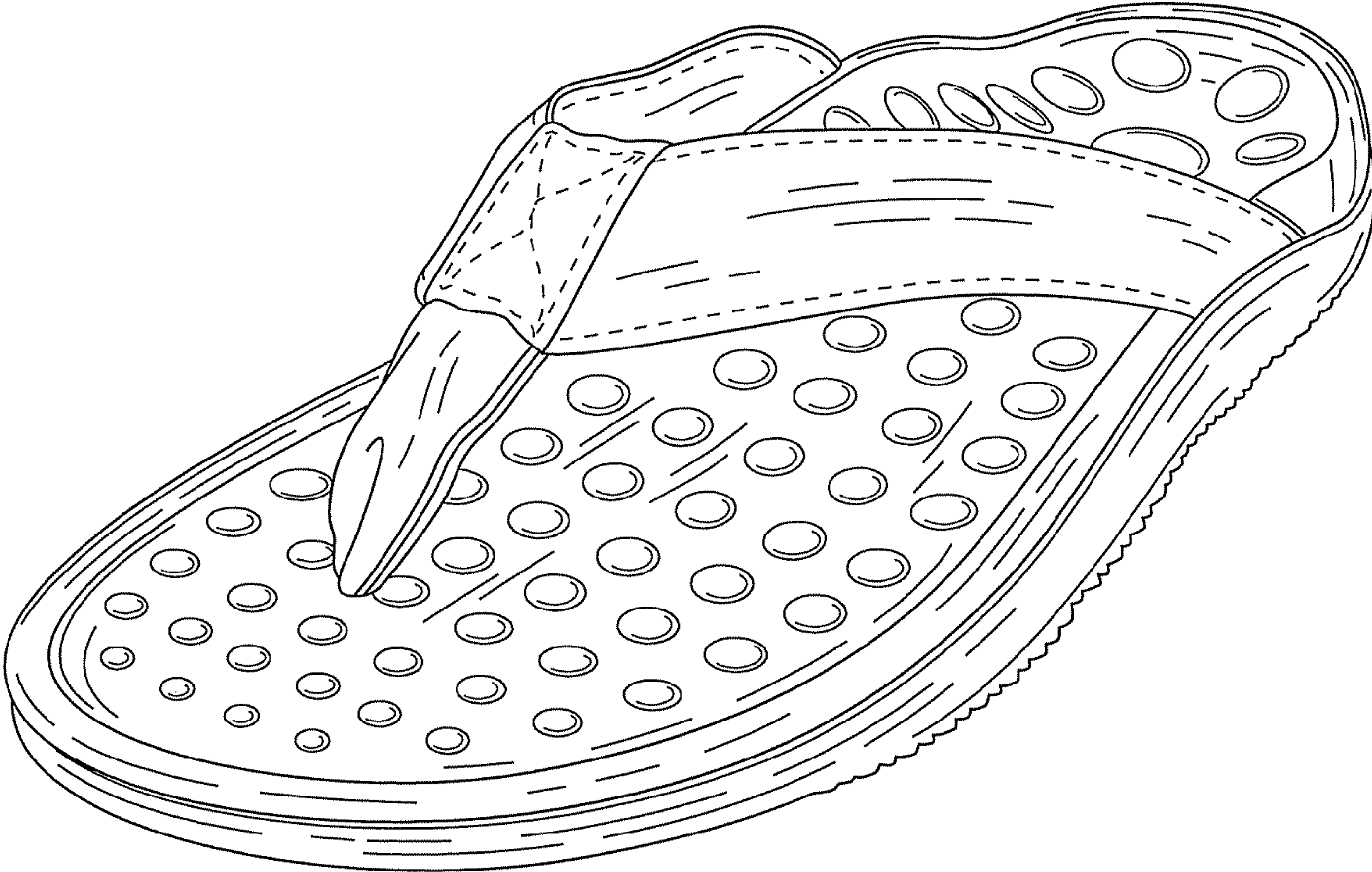

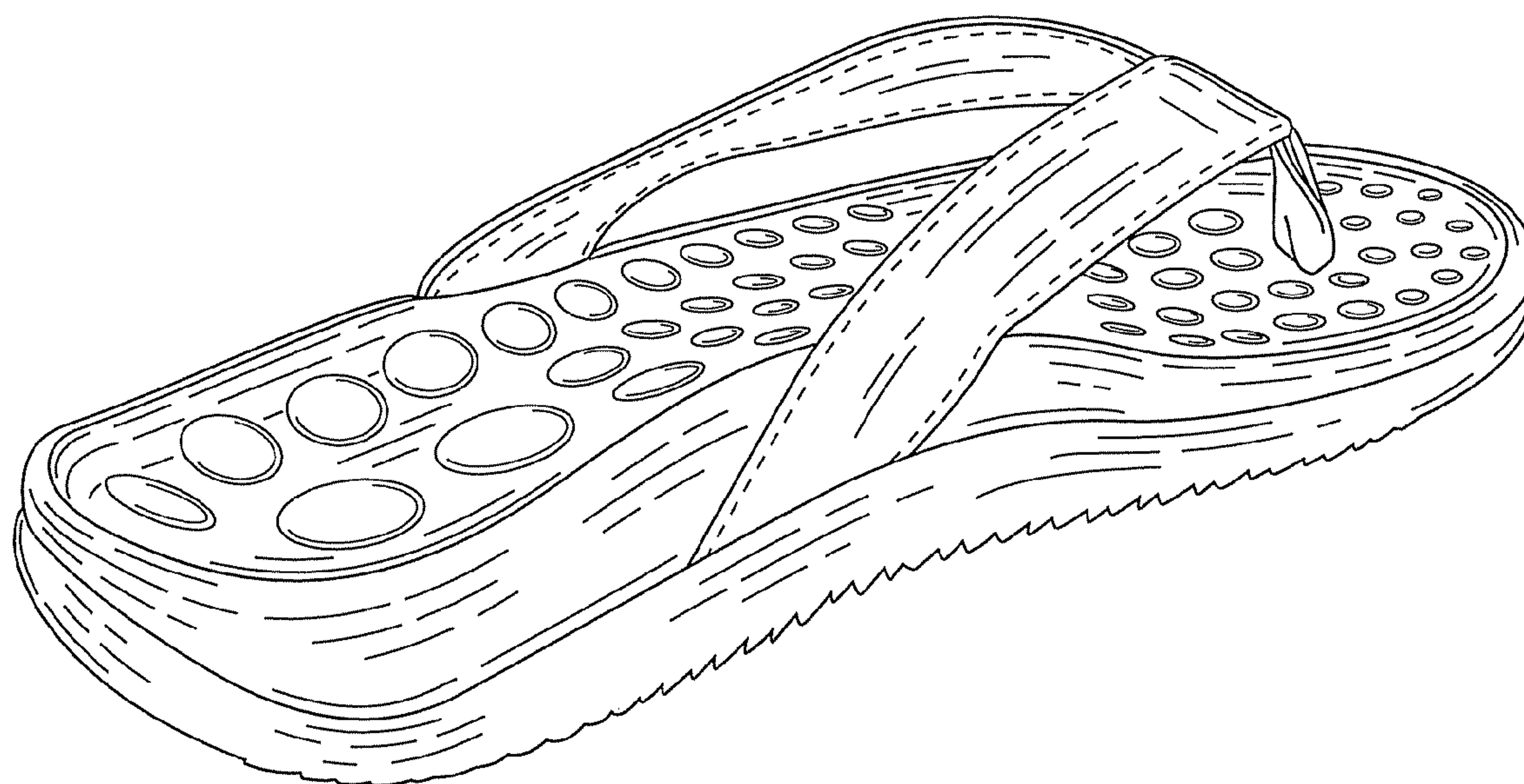

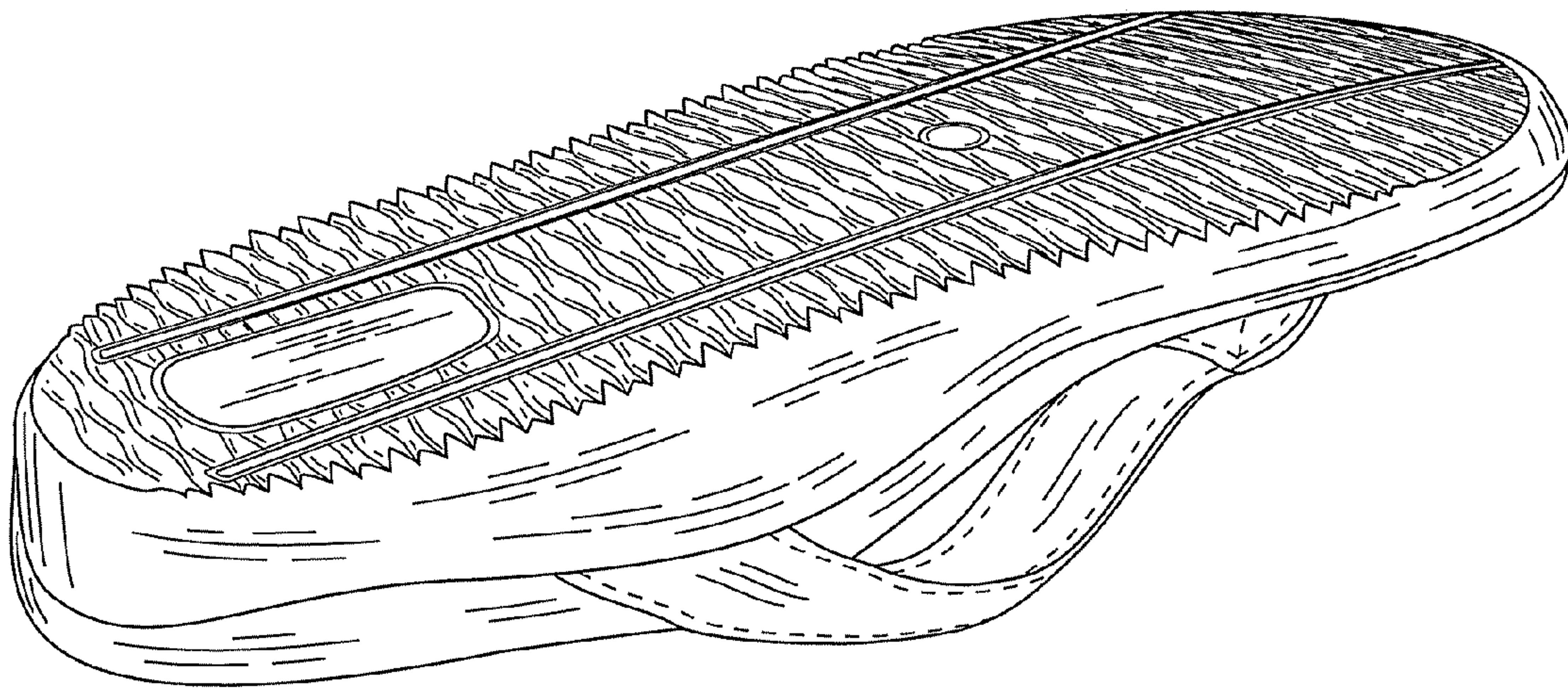
