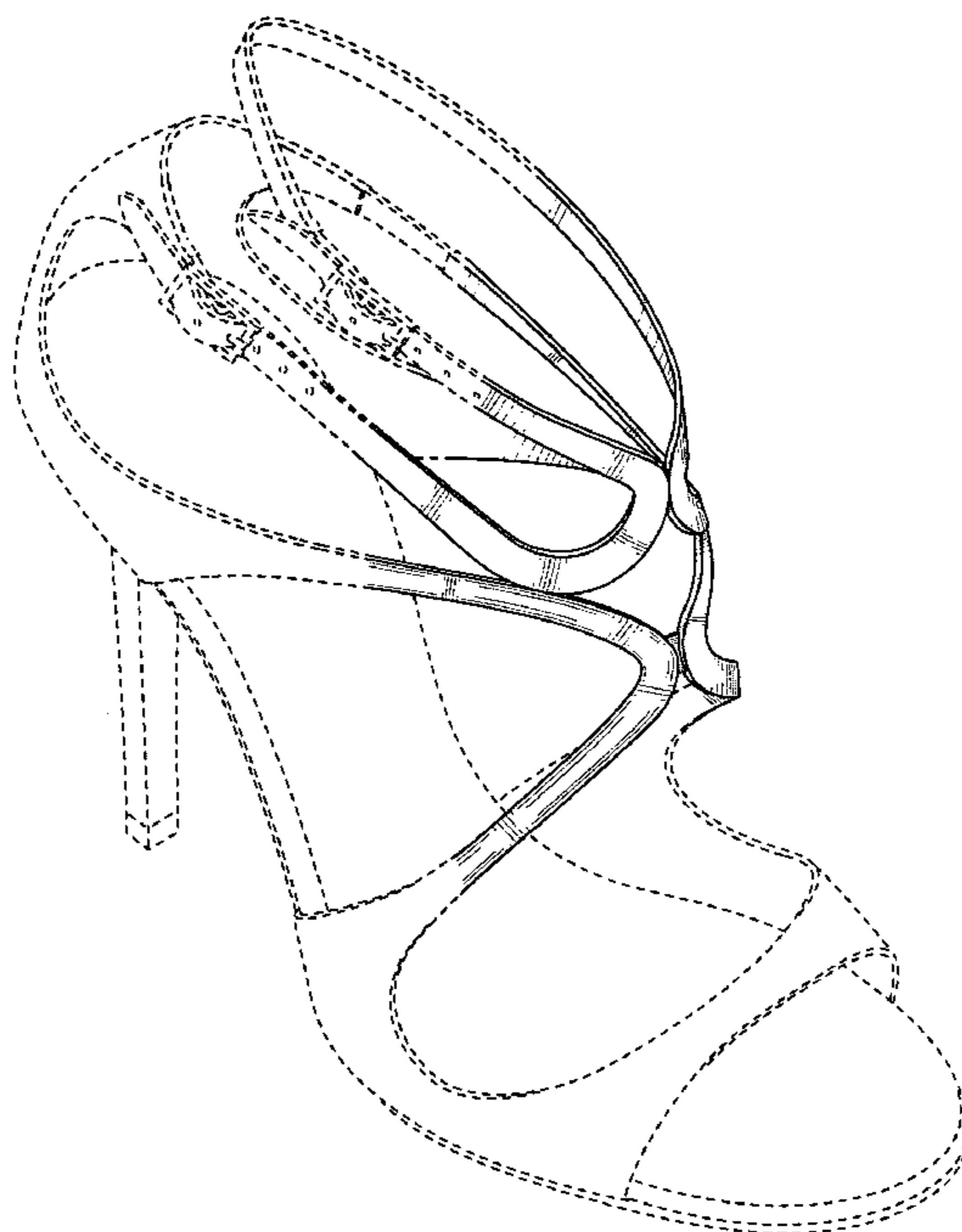
FIG. 4 is a front view thereof;

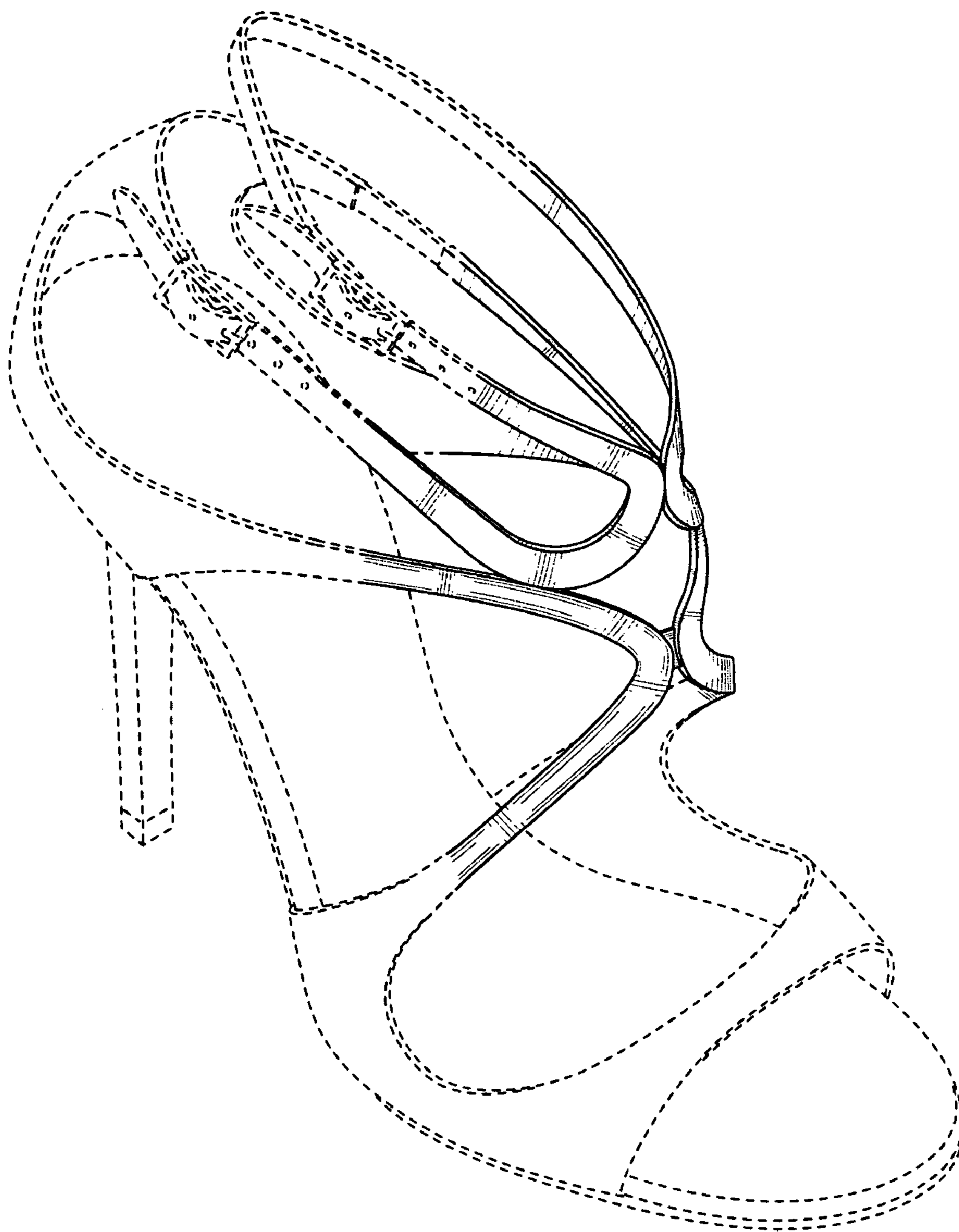

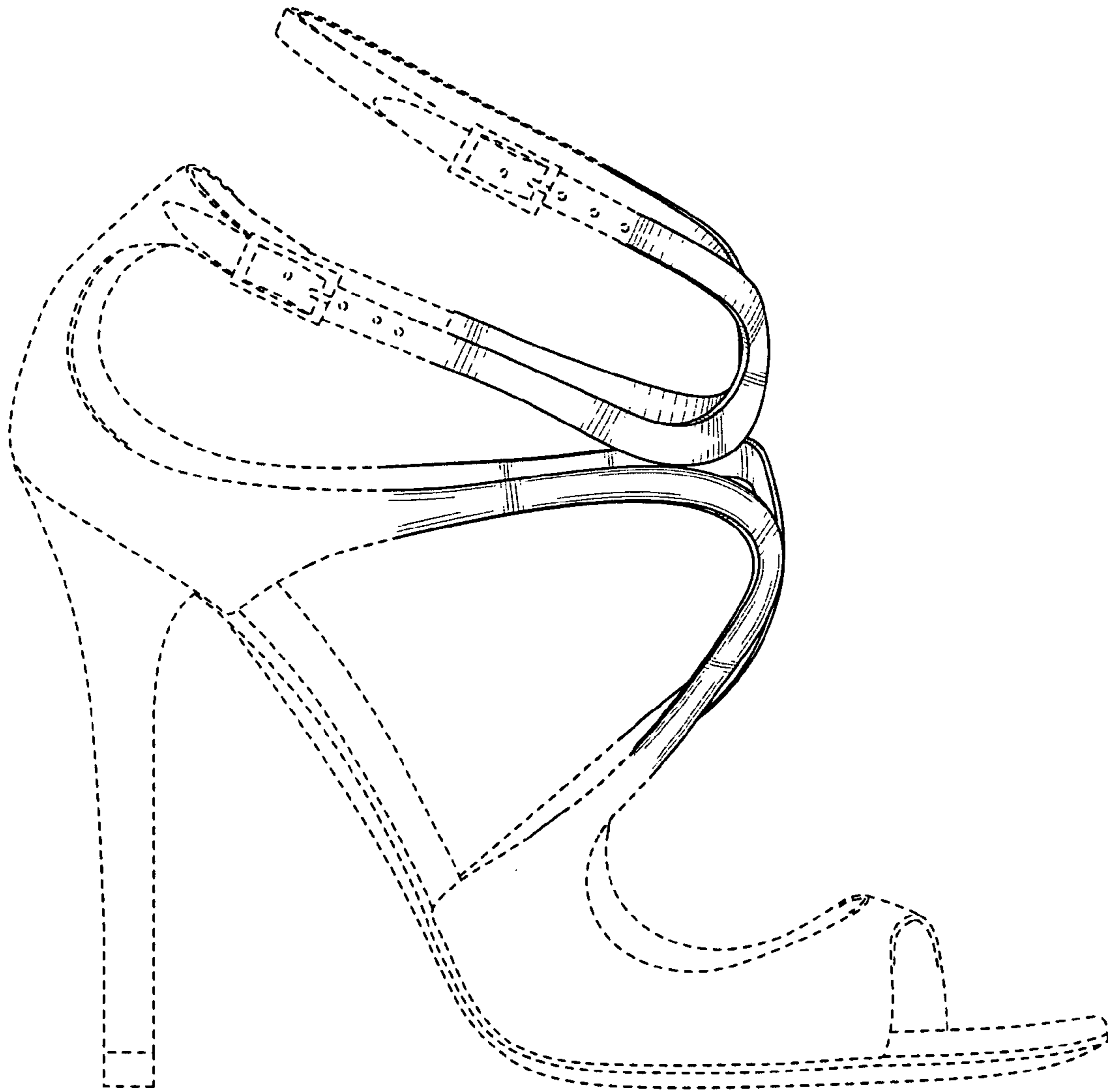

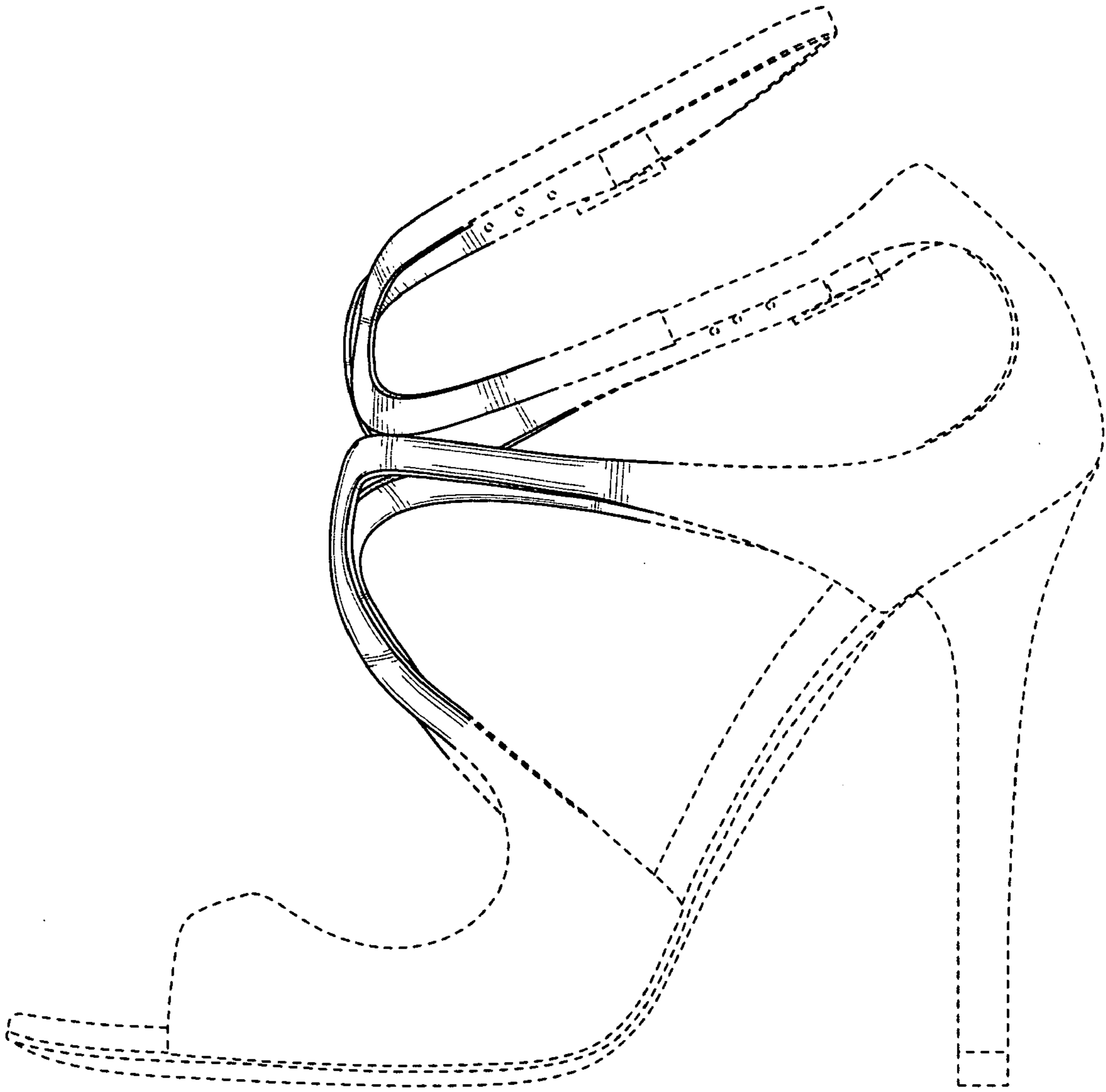

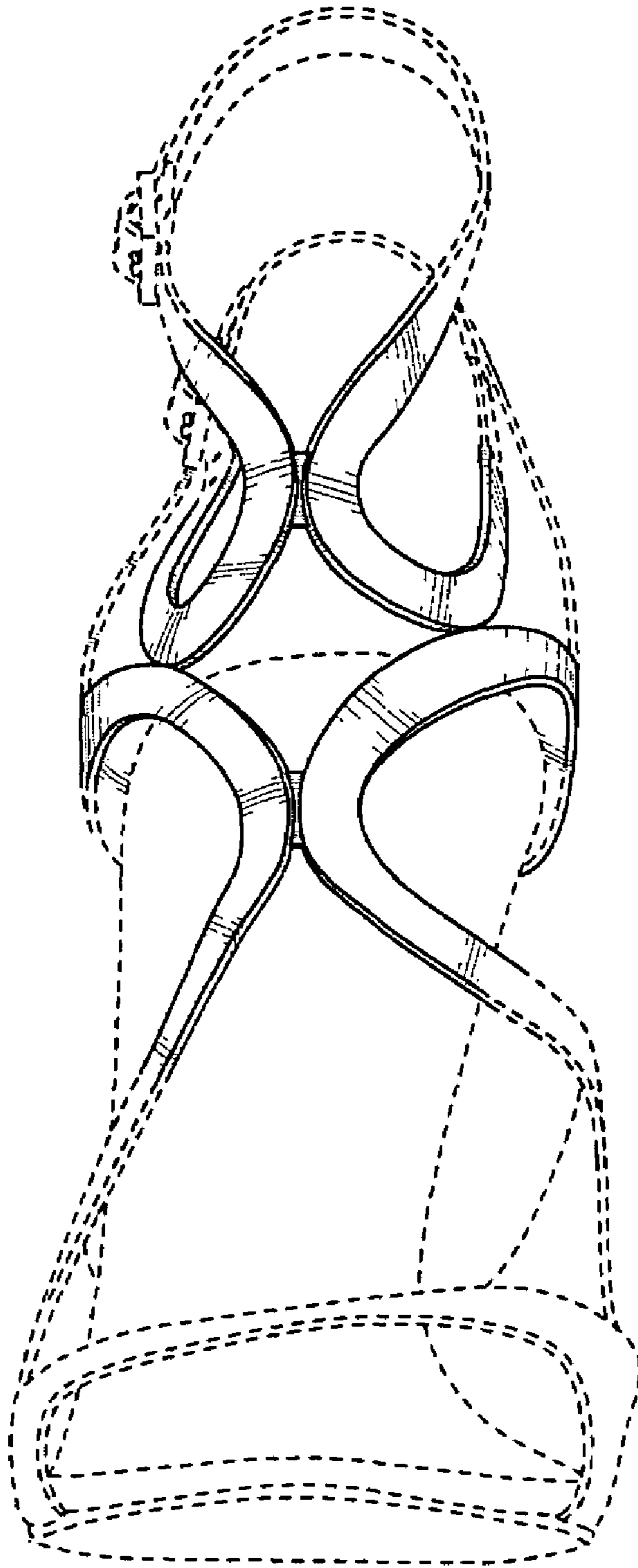

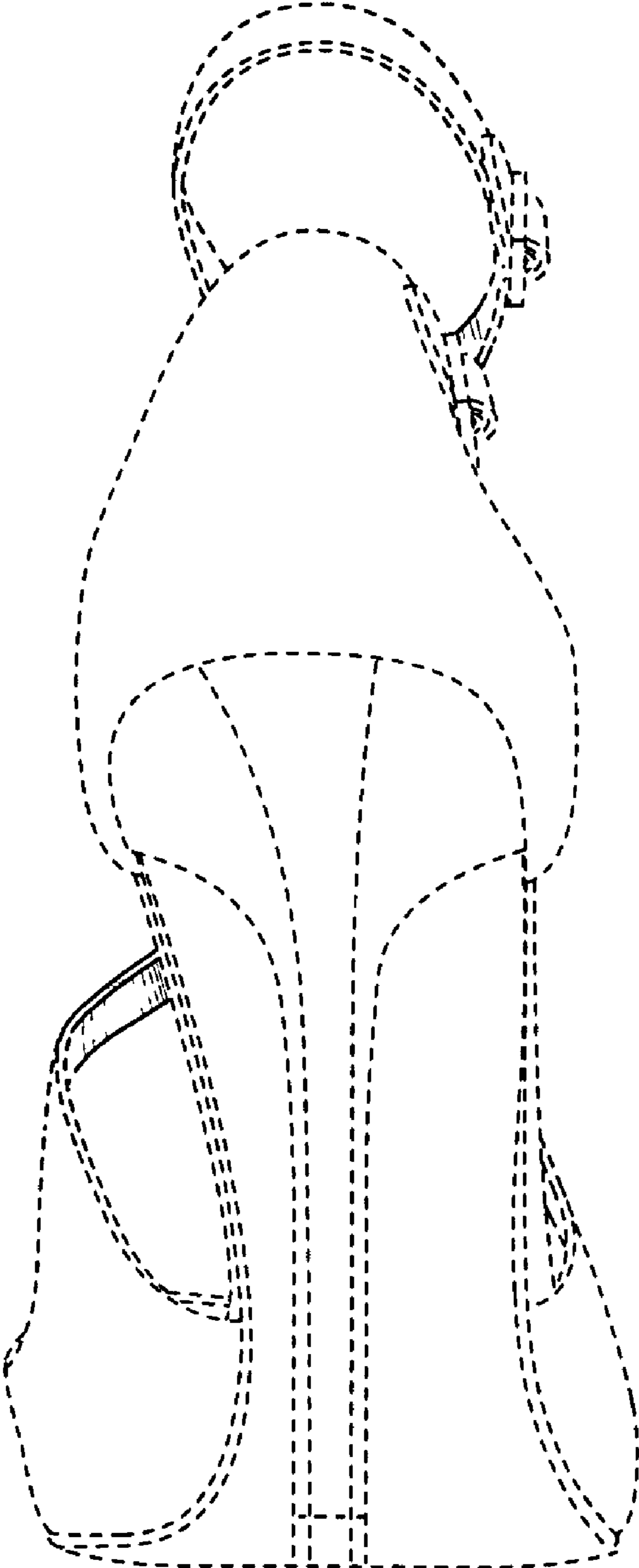

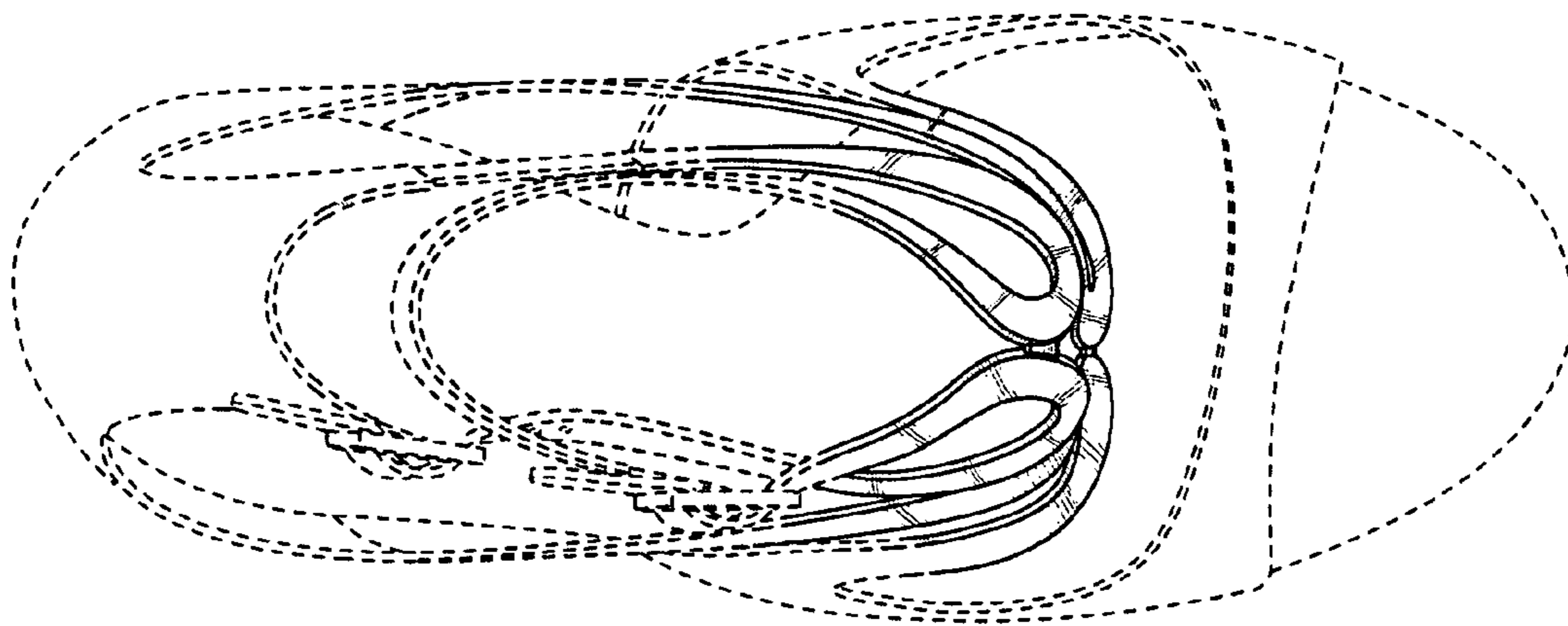
