(57) **CLAIM**

The ornamental design for a grommet and handle assembly for handbag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a grommet and handle assembly for handbag showing my new design;

FIG. 2 is a front view of the grommet and handle assembly shown in FIG. 1;

FIG. 3 is a rear view of the grommet and handle assembly shown in FIG. 1;

FIG. 4 is a left side view of the grommet and handle assembly shown in FIG. 1;

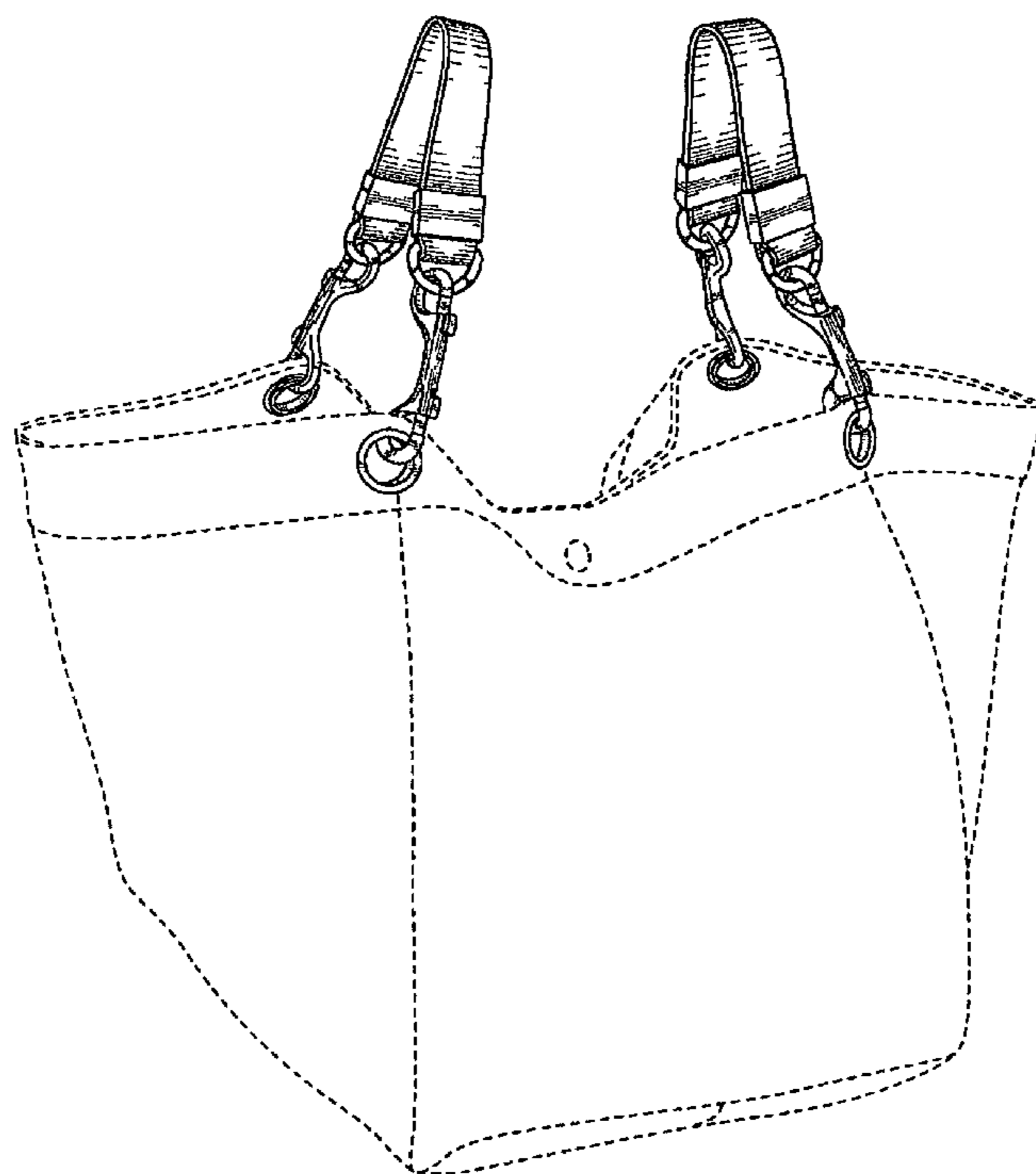
FIG. 5 is a right side view of the grommet and handle assembly shown in FIG. 1;

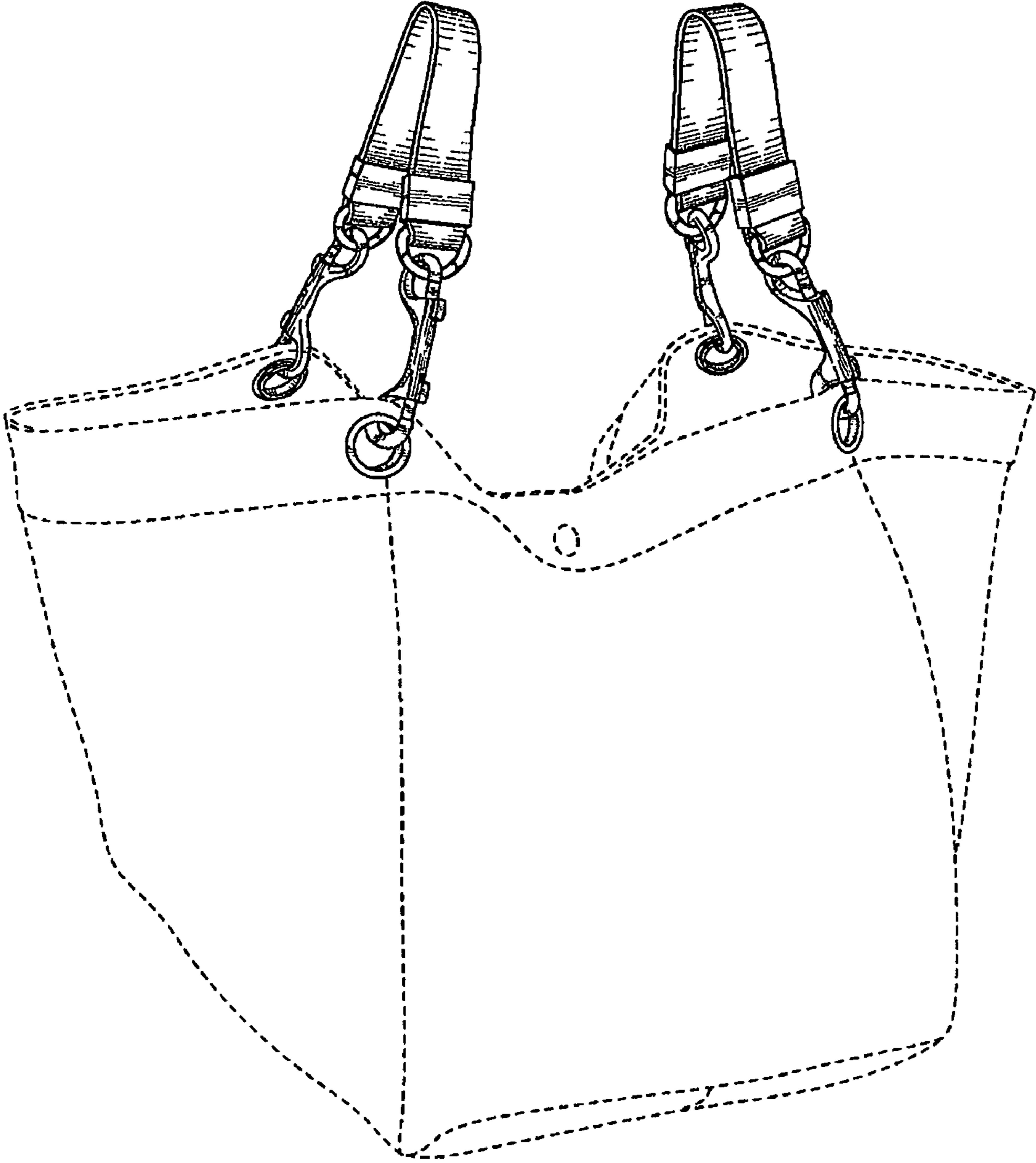

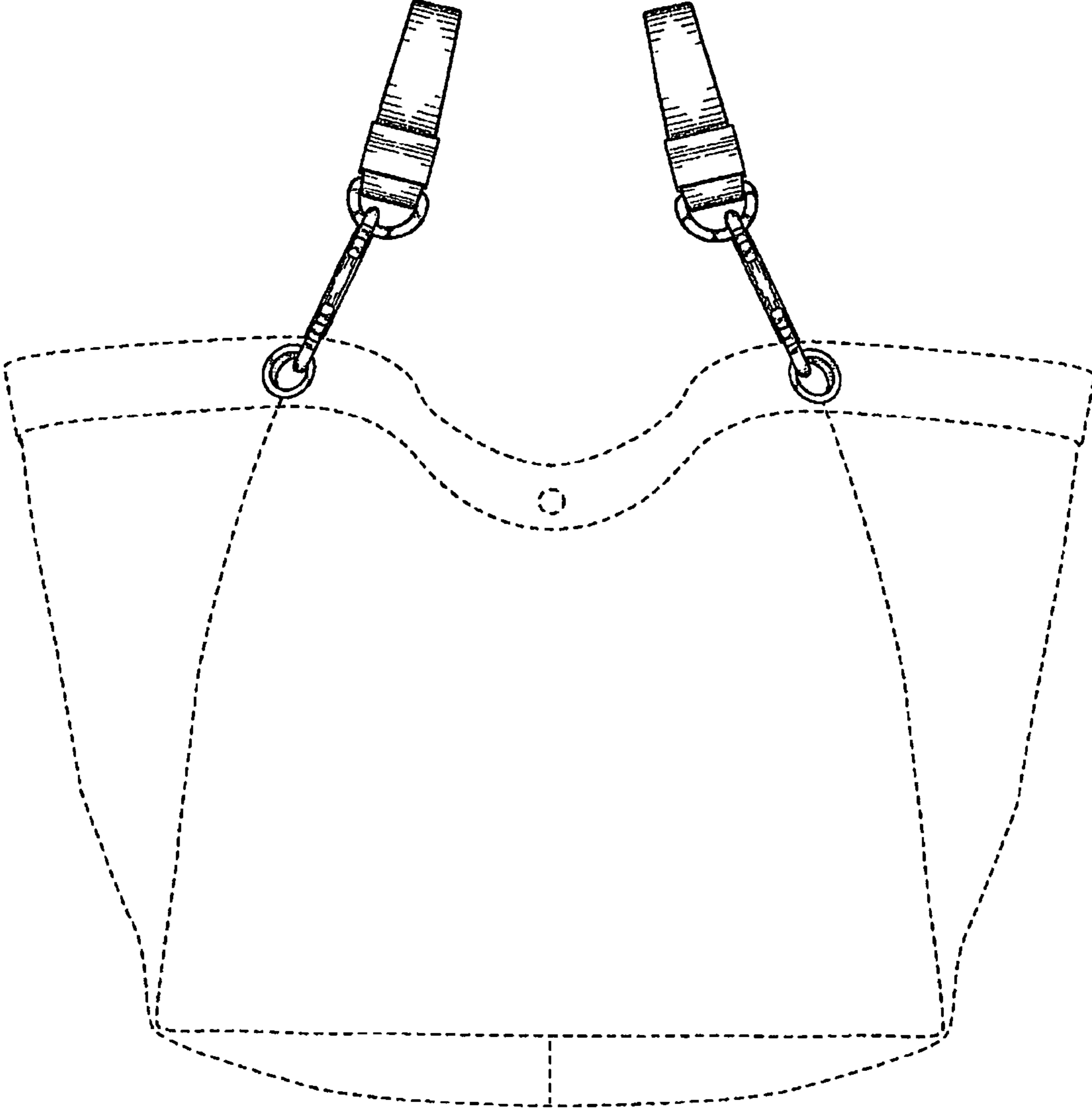

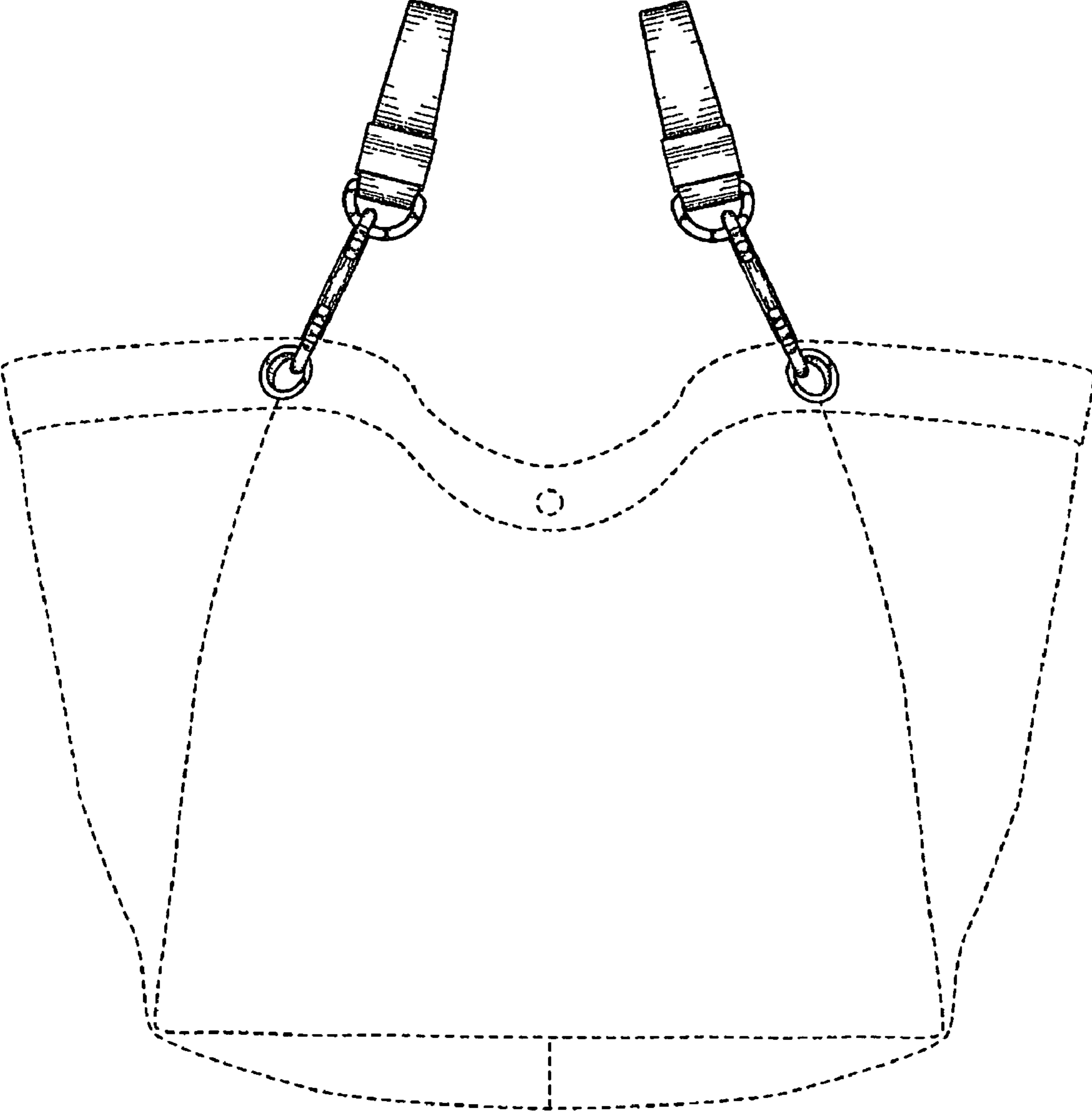

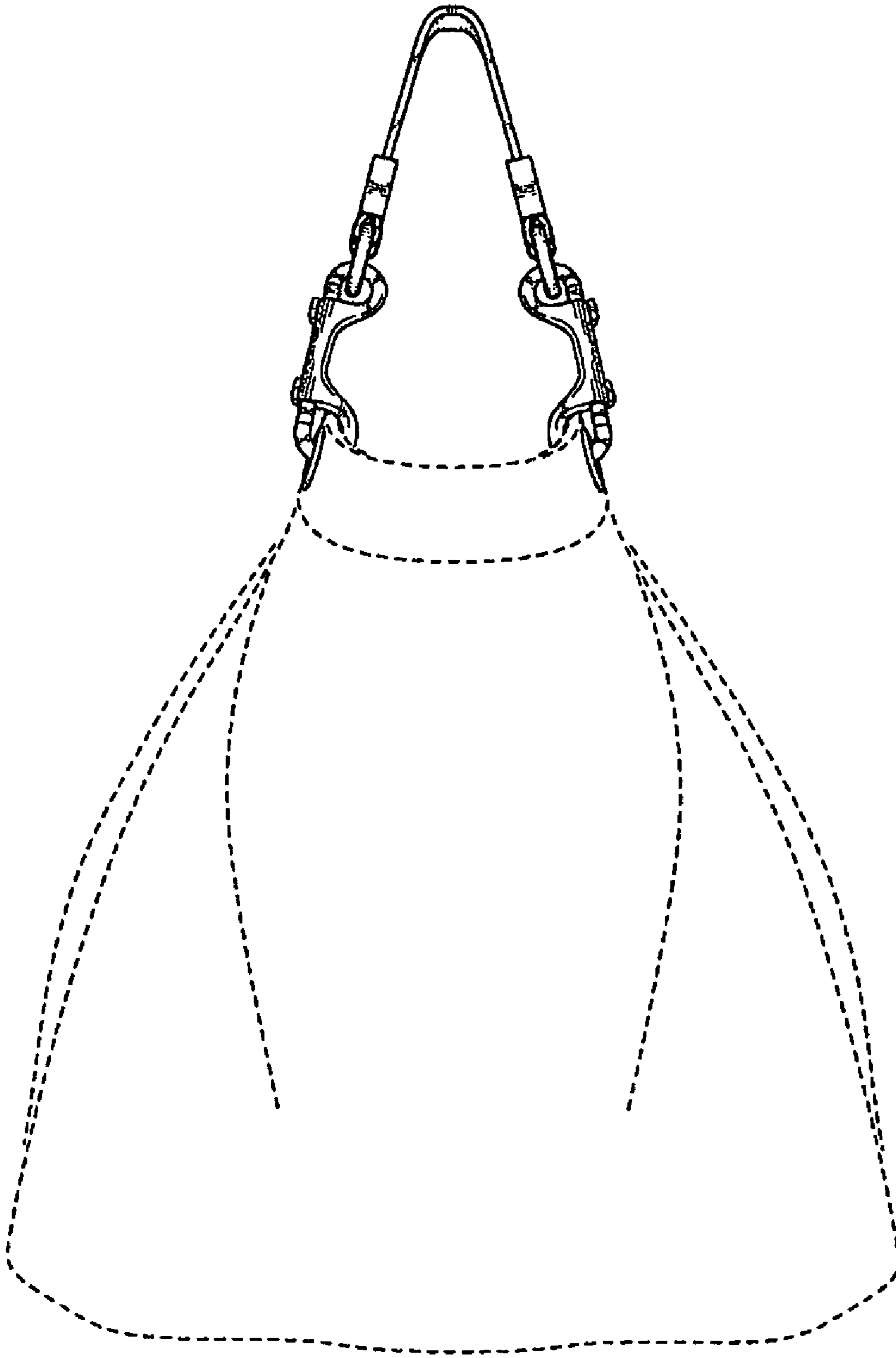

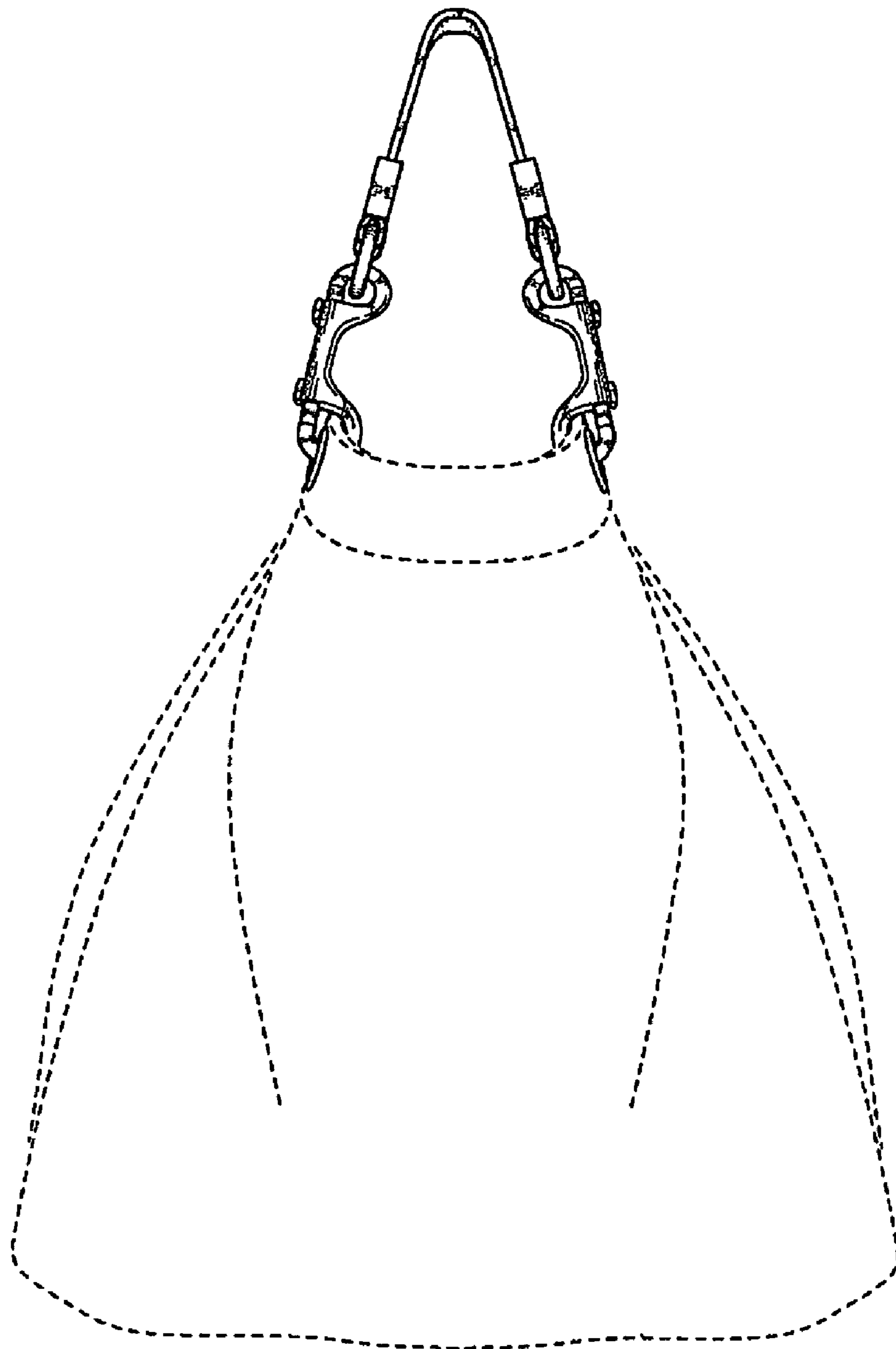

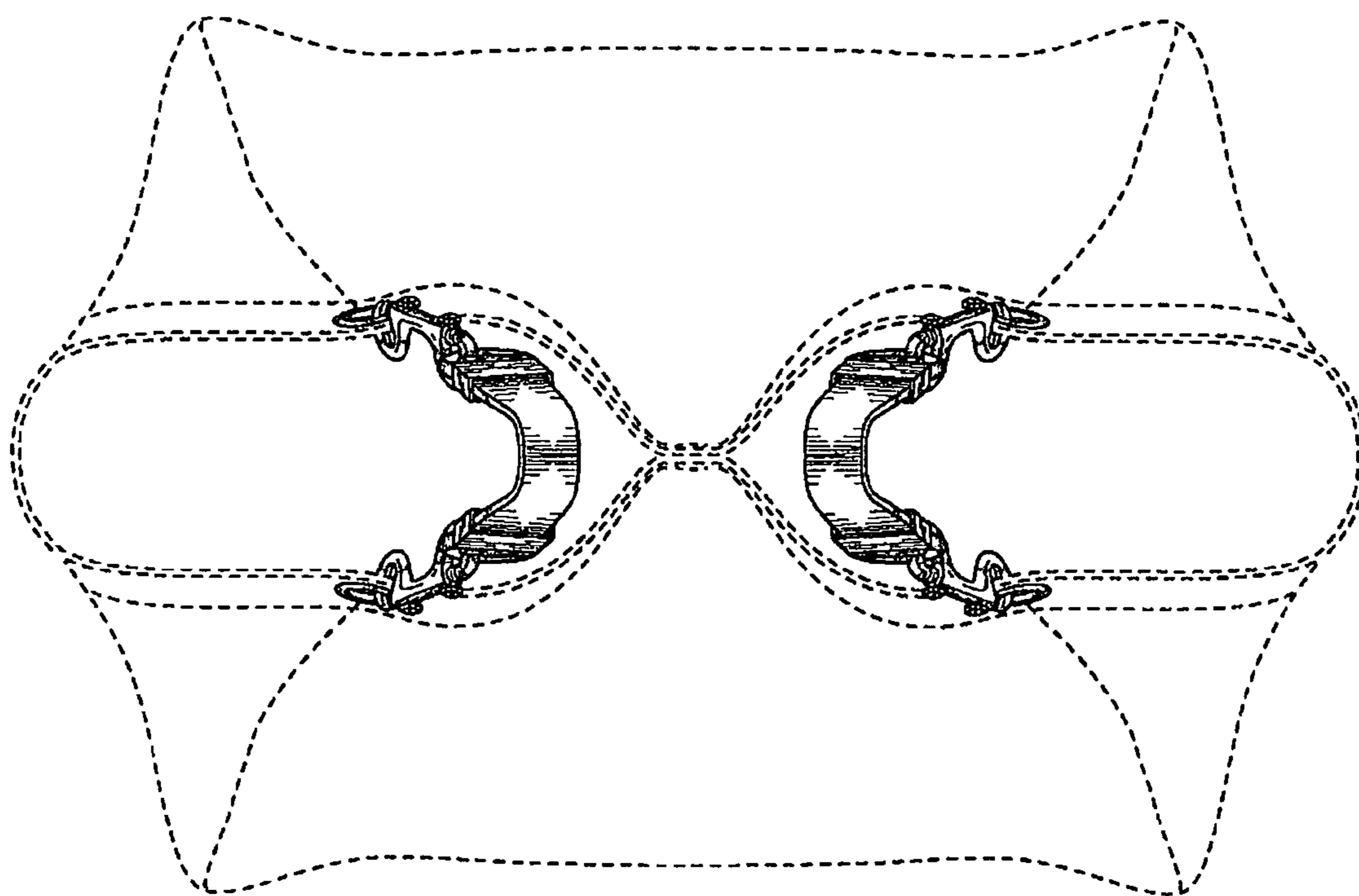

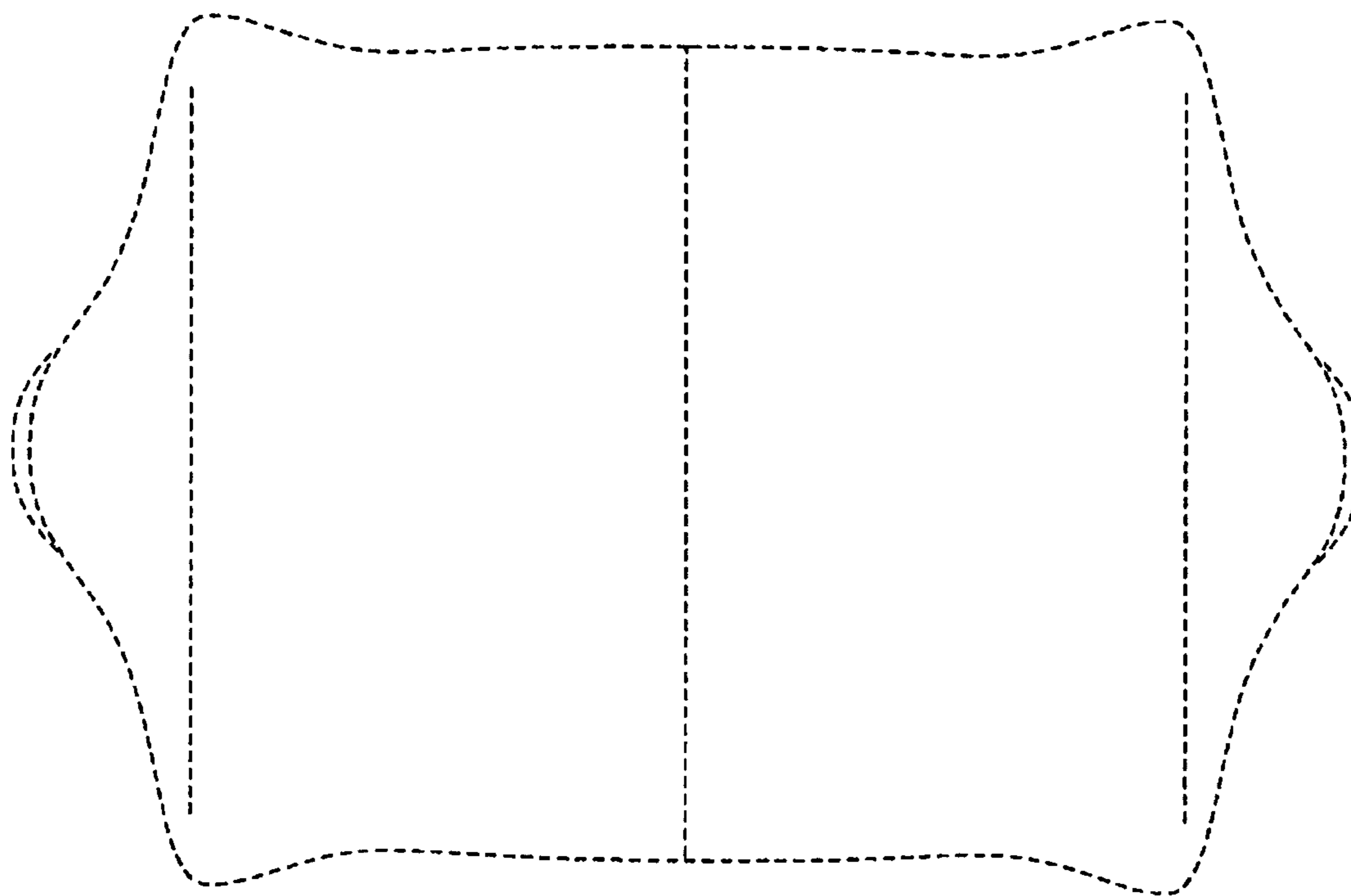
