(57) **CLAIM**

I claim the ornamental design for a gemstone, as shown and described.

DESCRIPTION

FIG. 17 is a front view of the third embodiment;

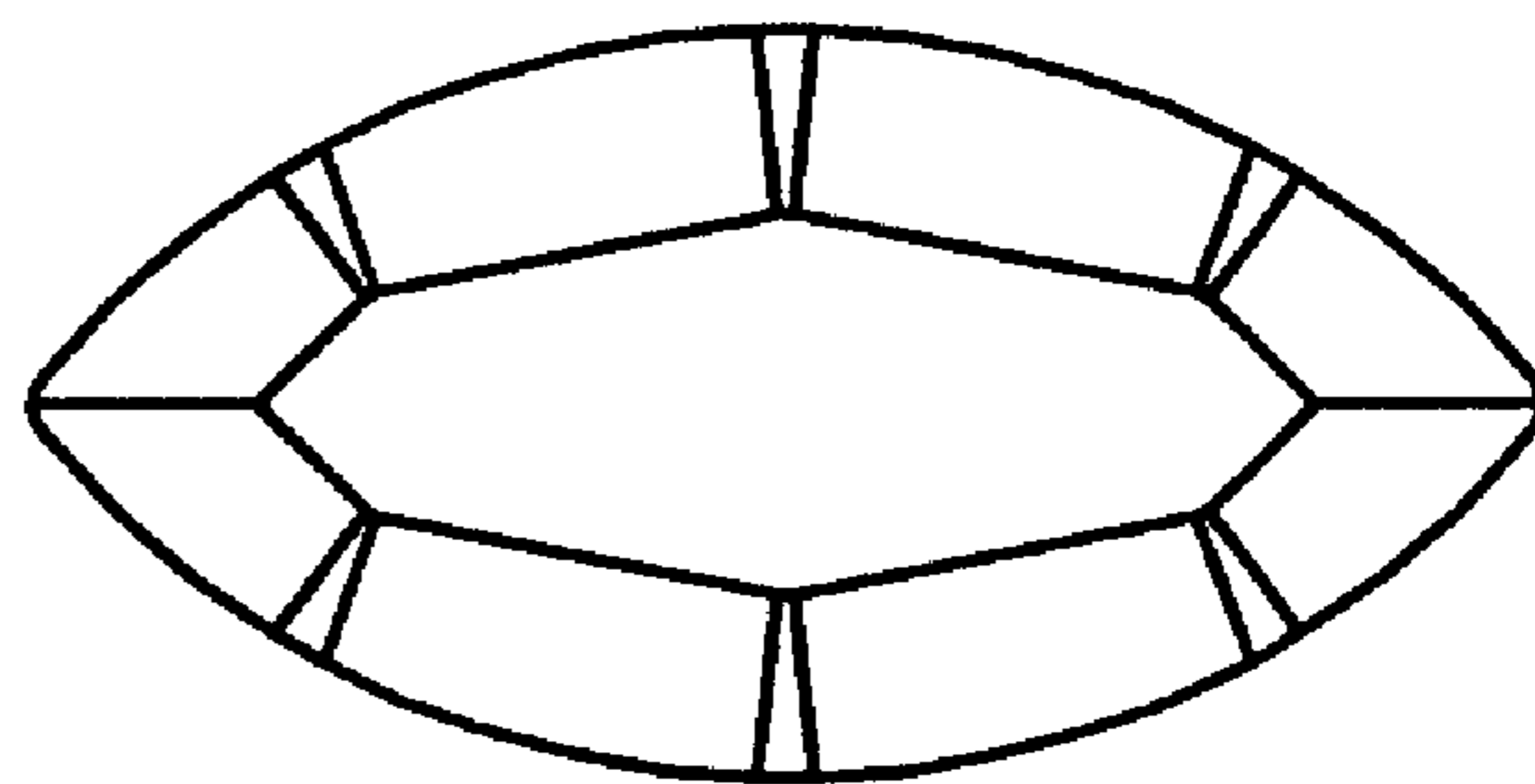
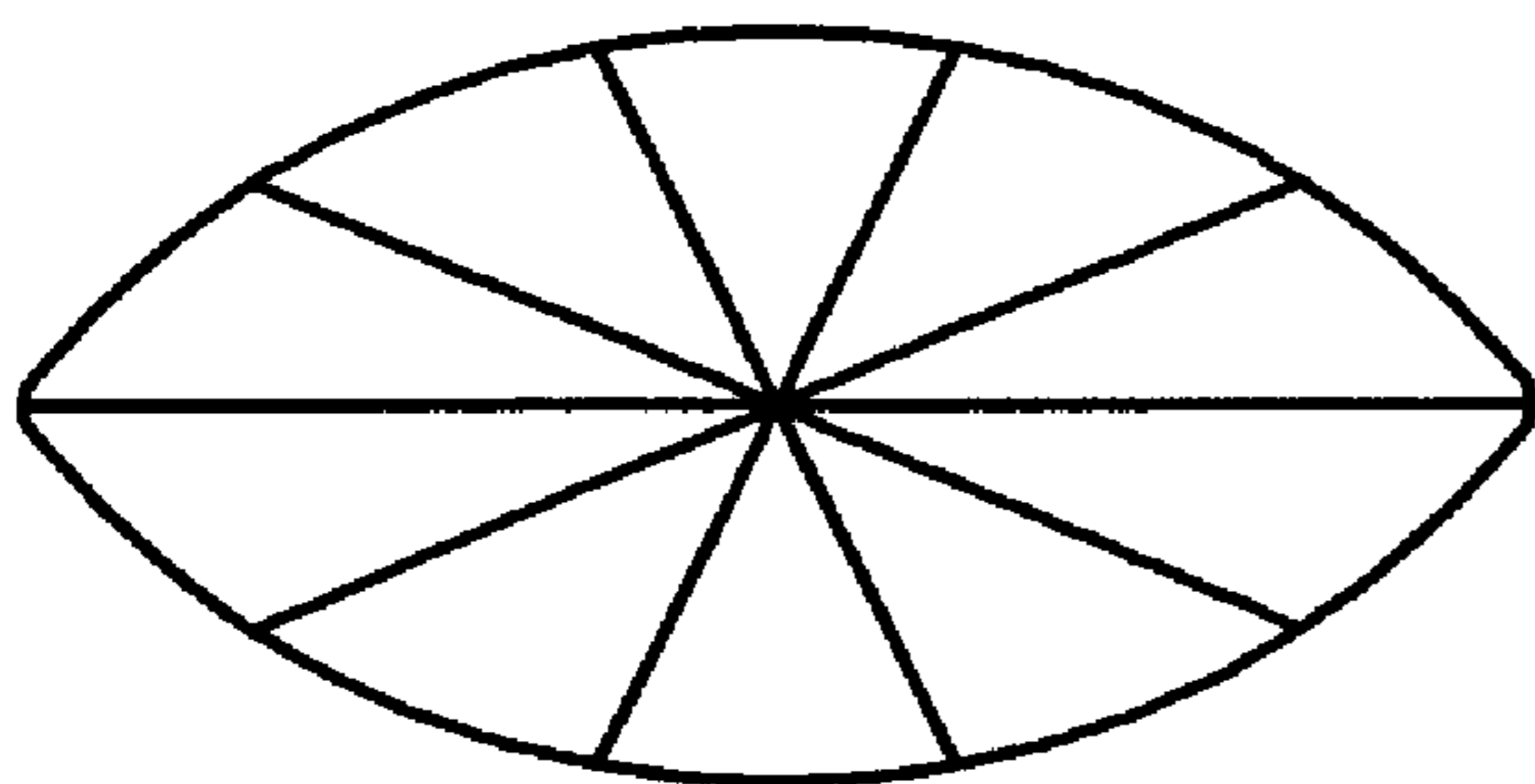
FIG. 18 is a left side view of the third embodiment;

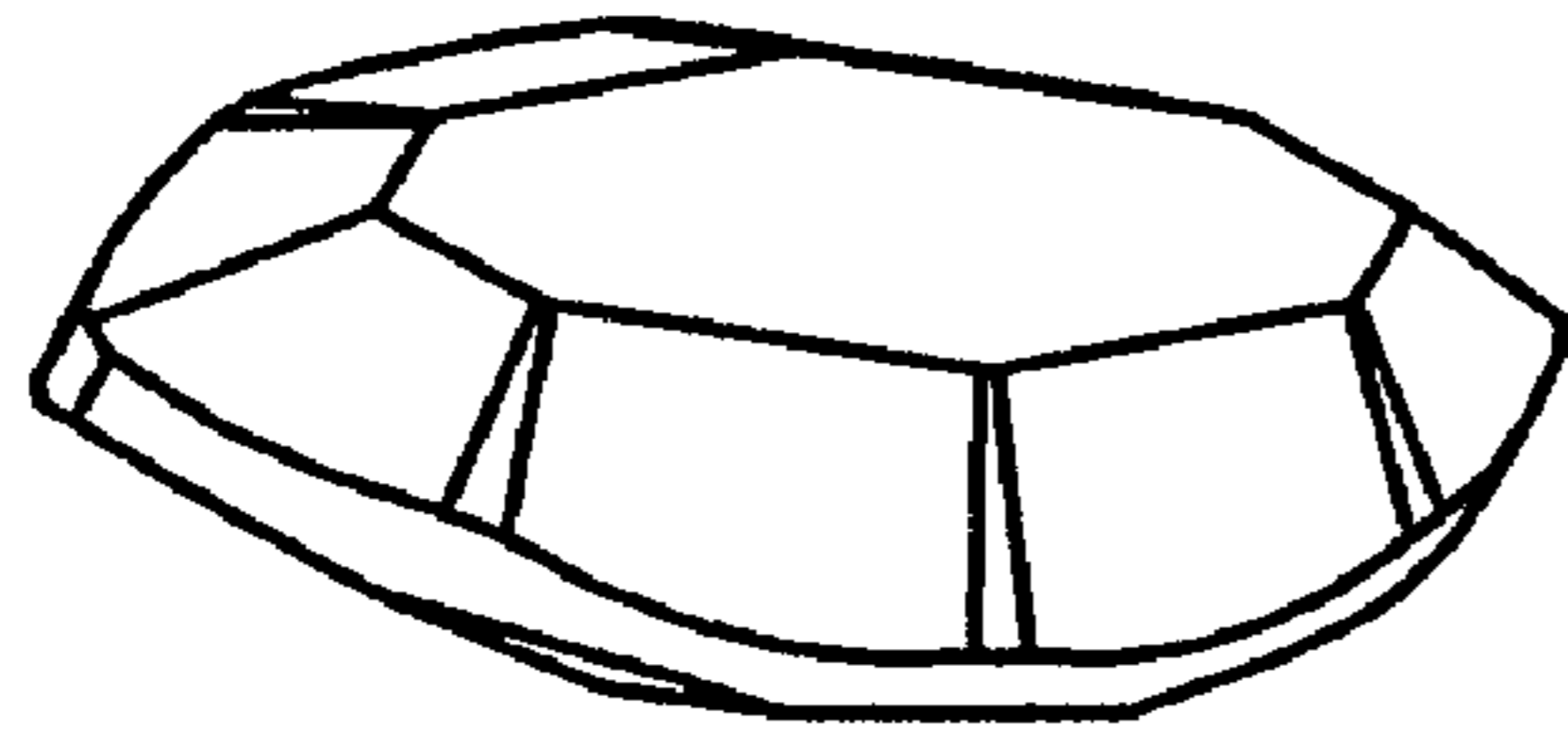

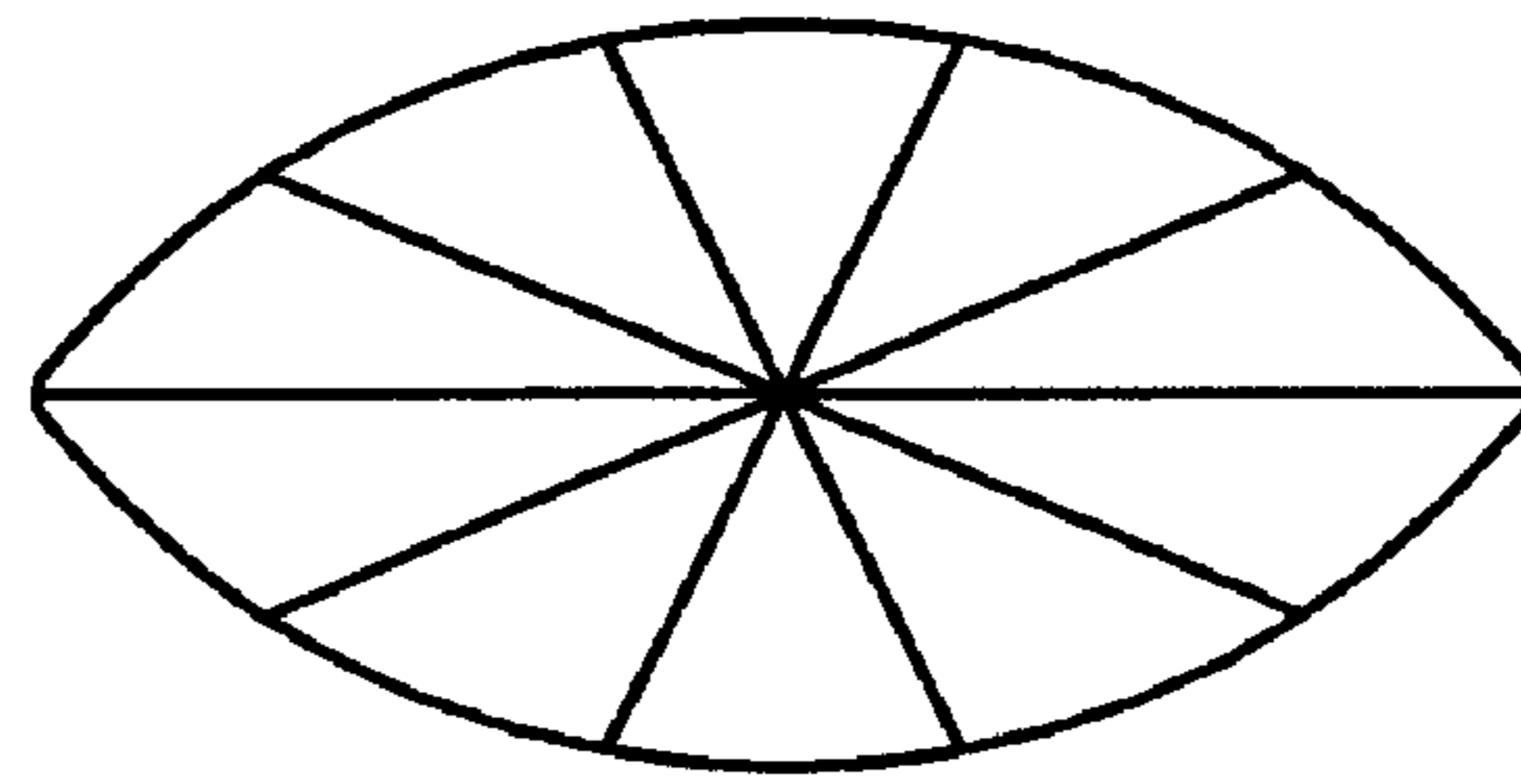

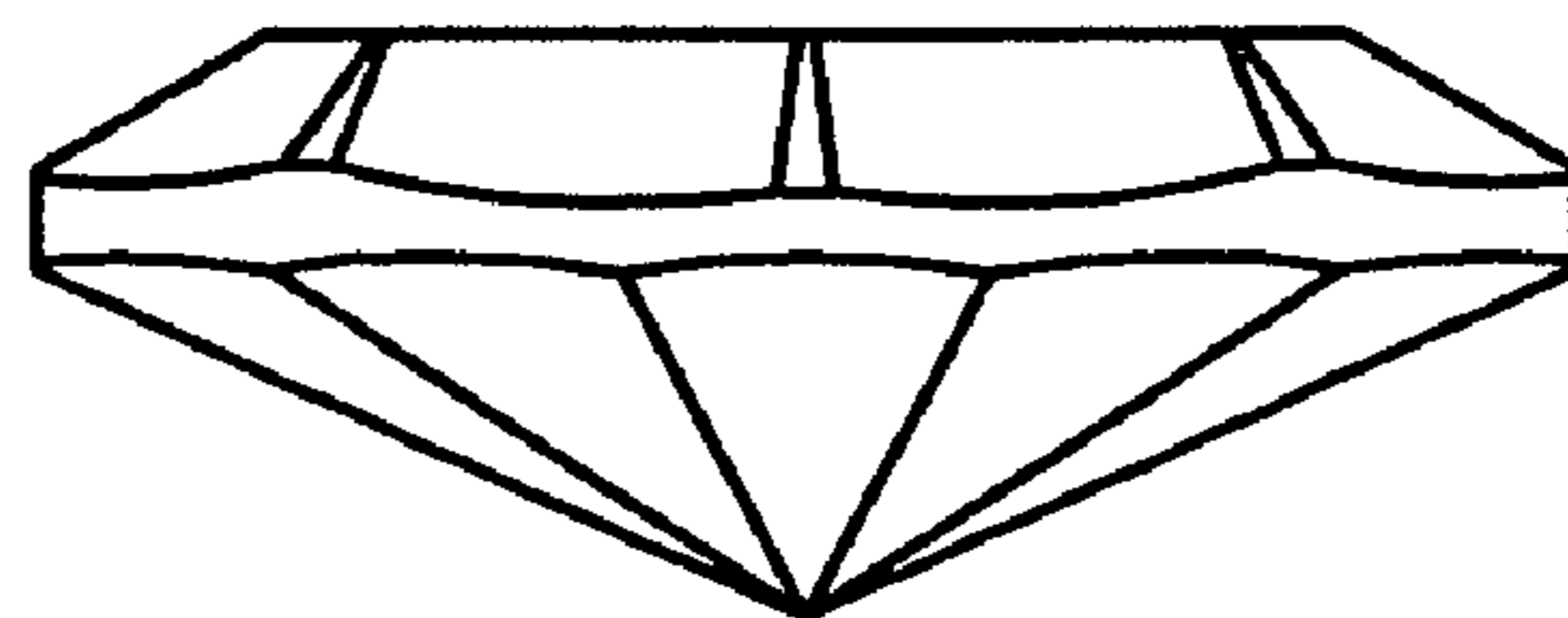

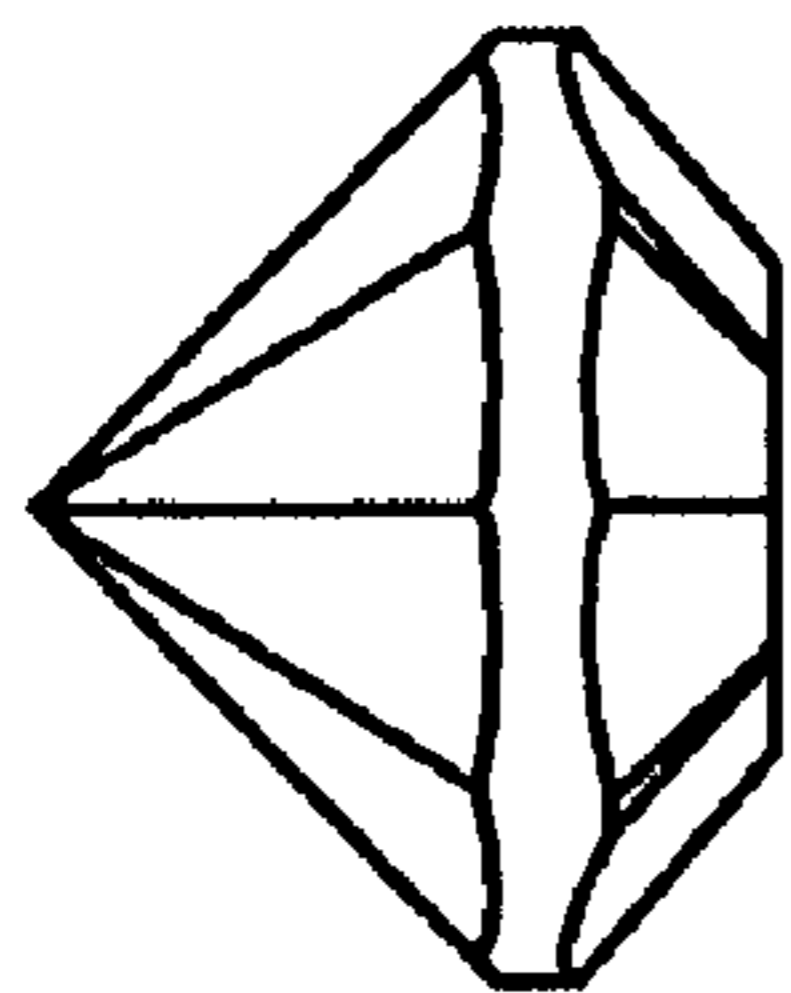

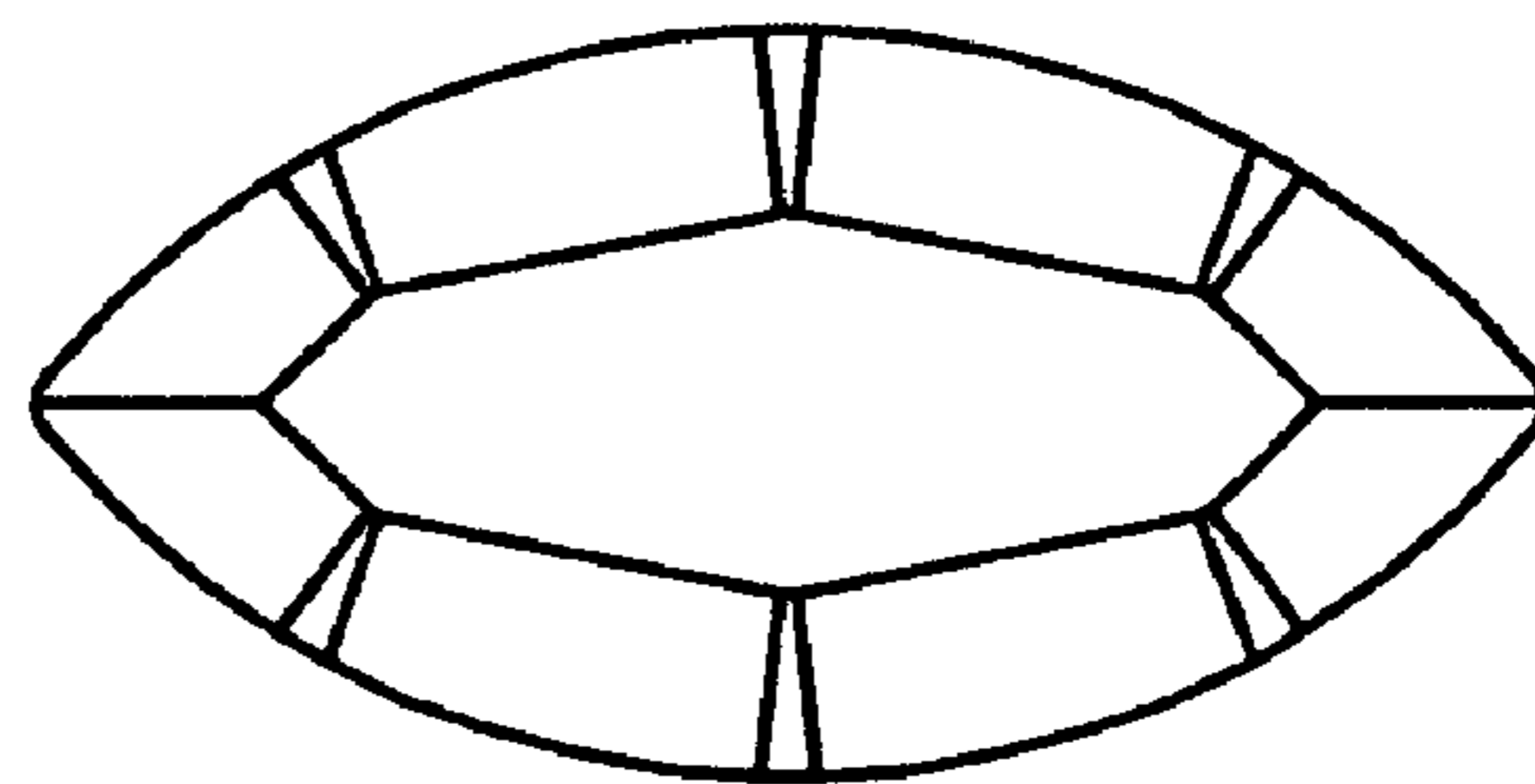

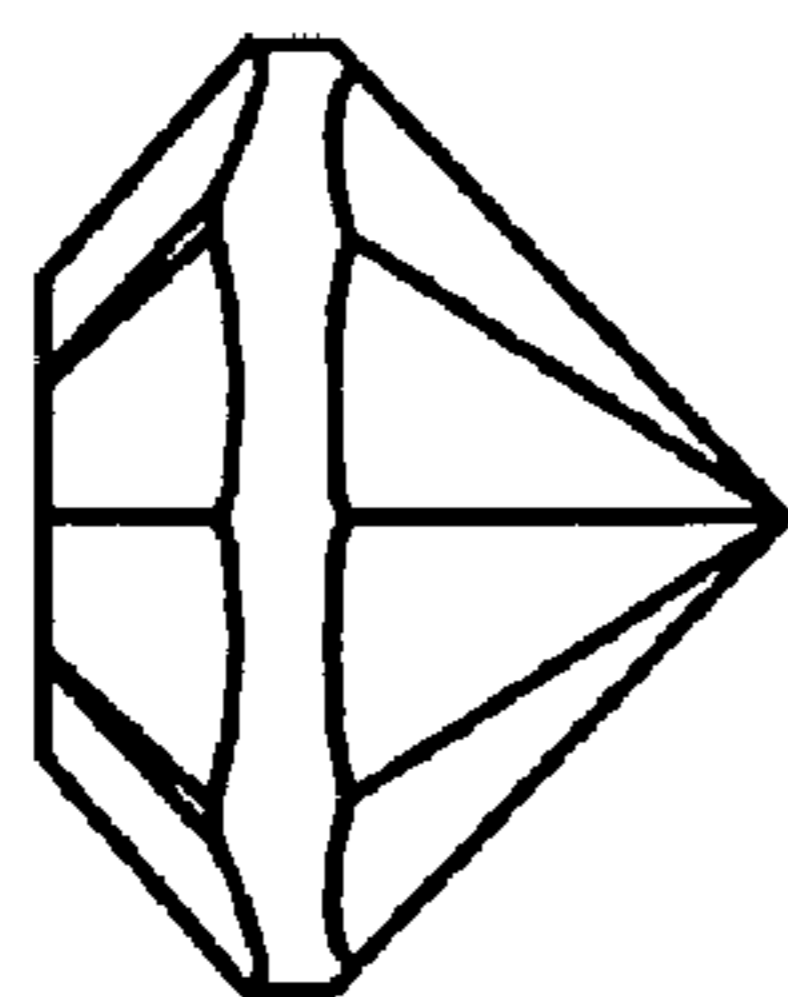

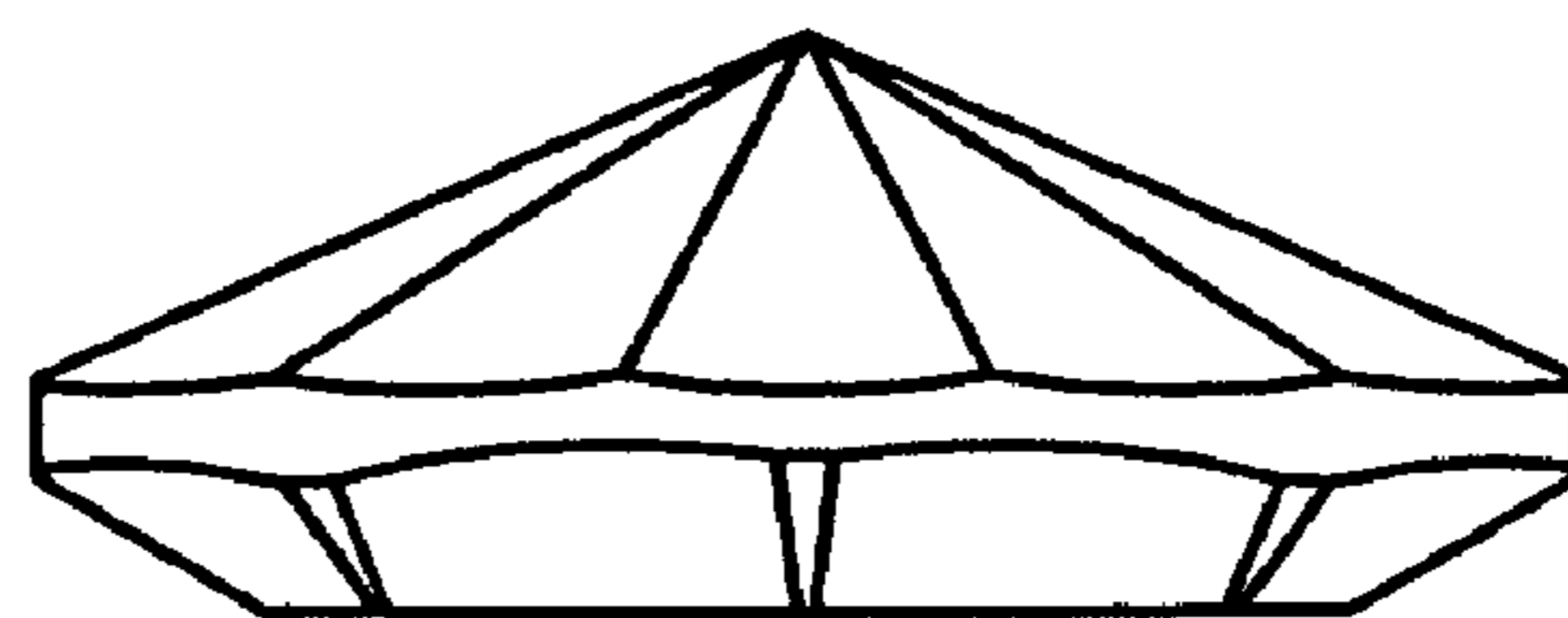

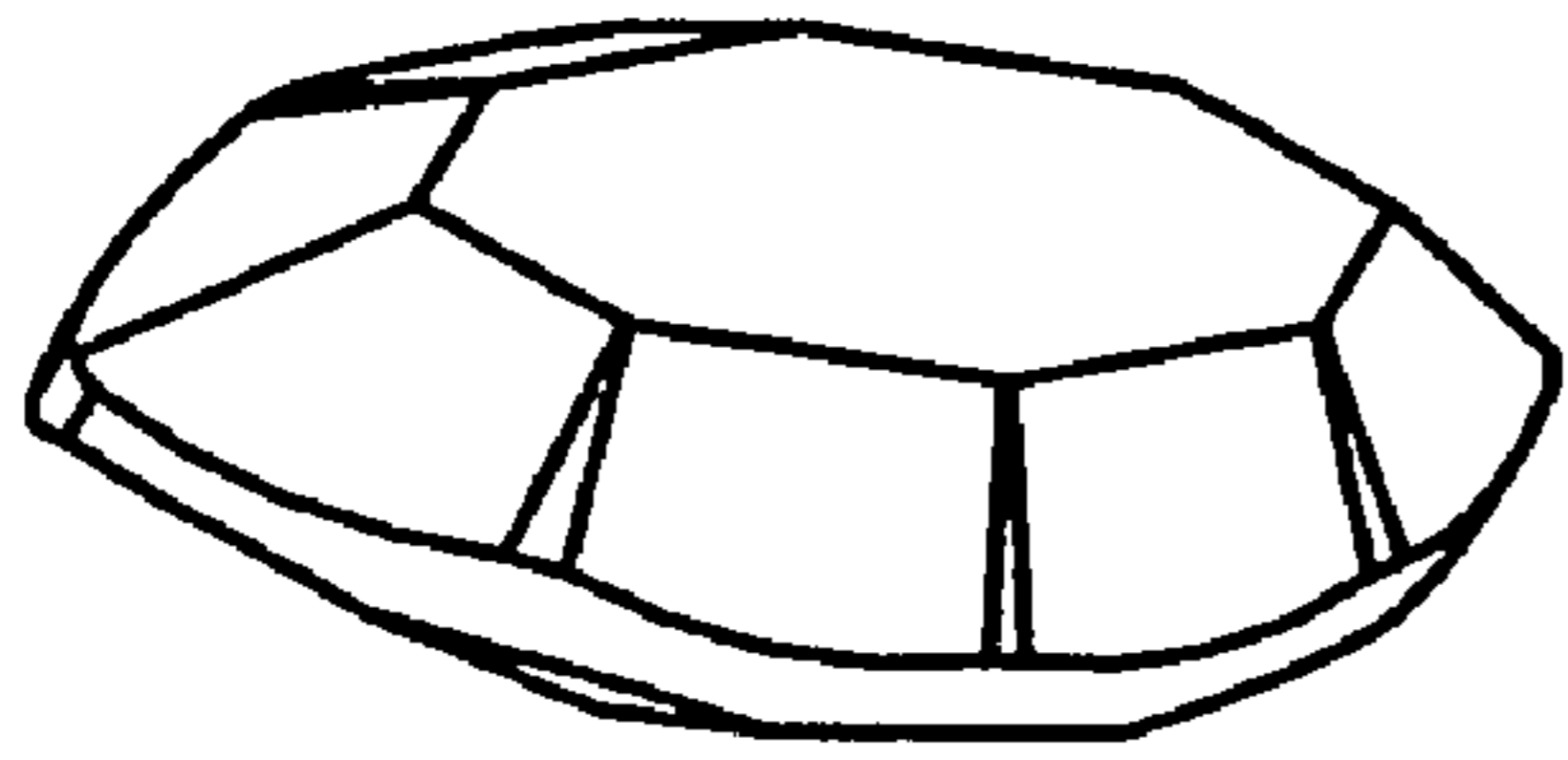

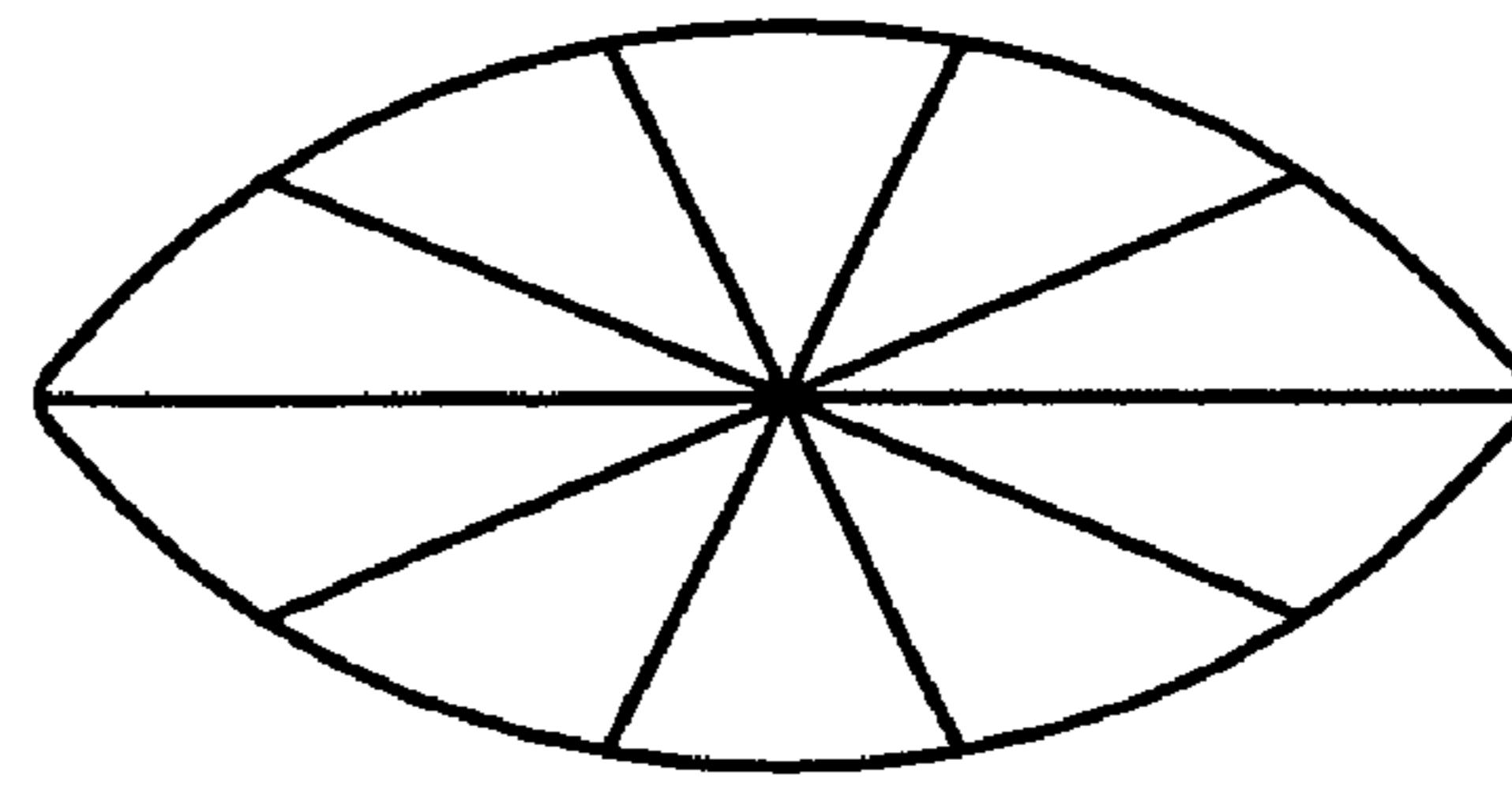

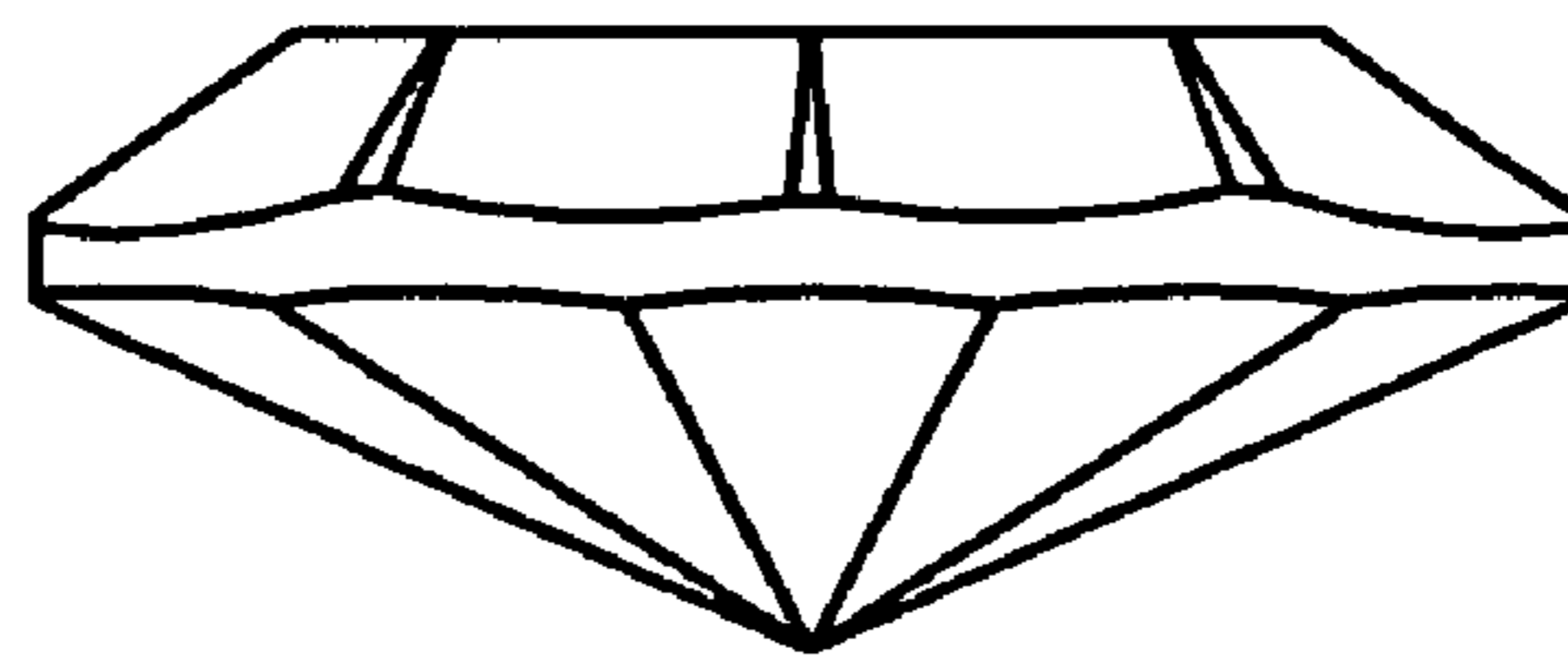

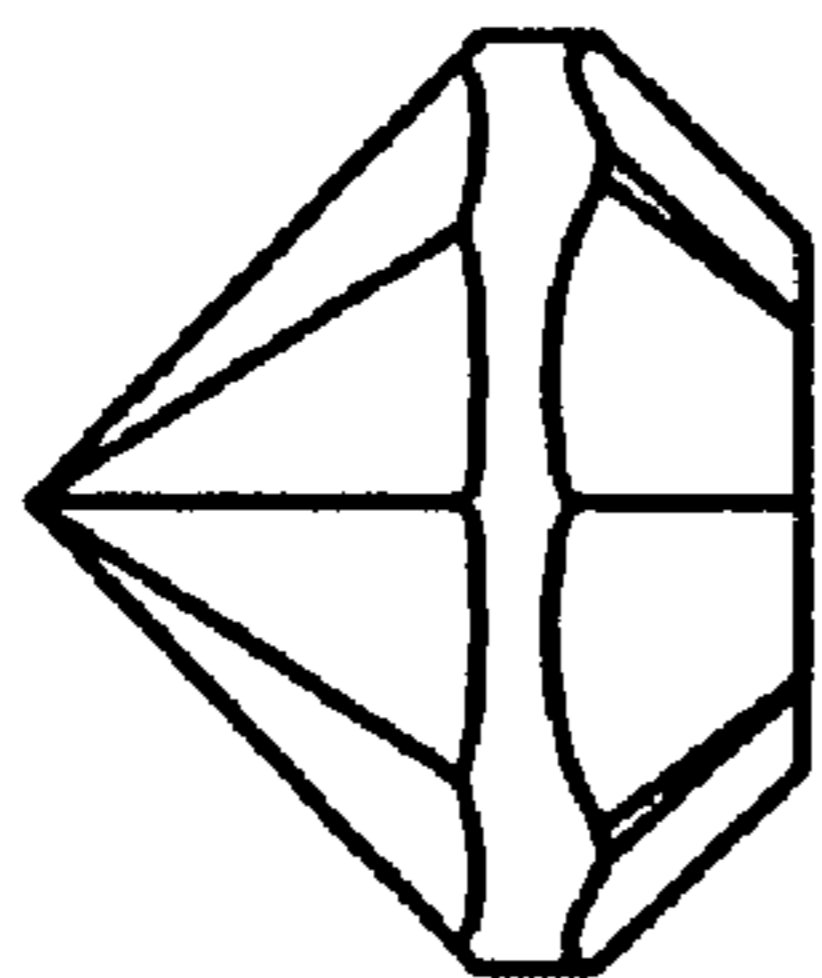

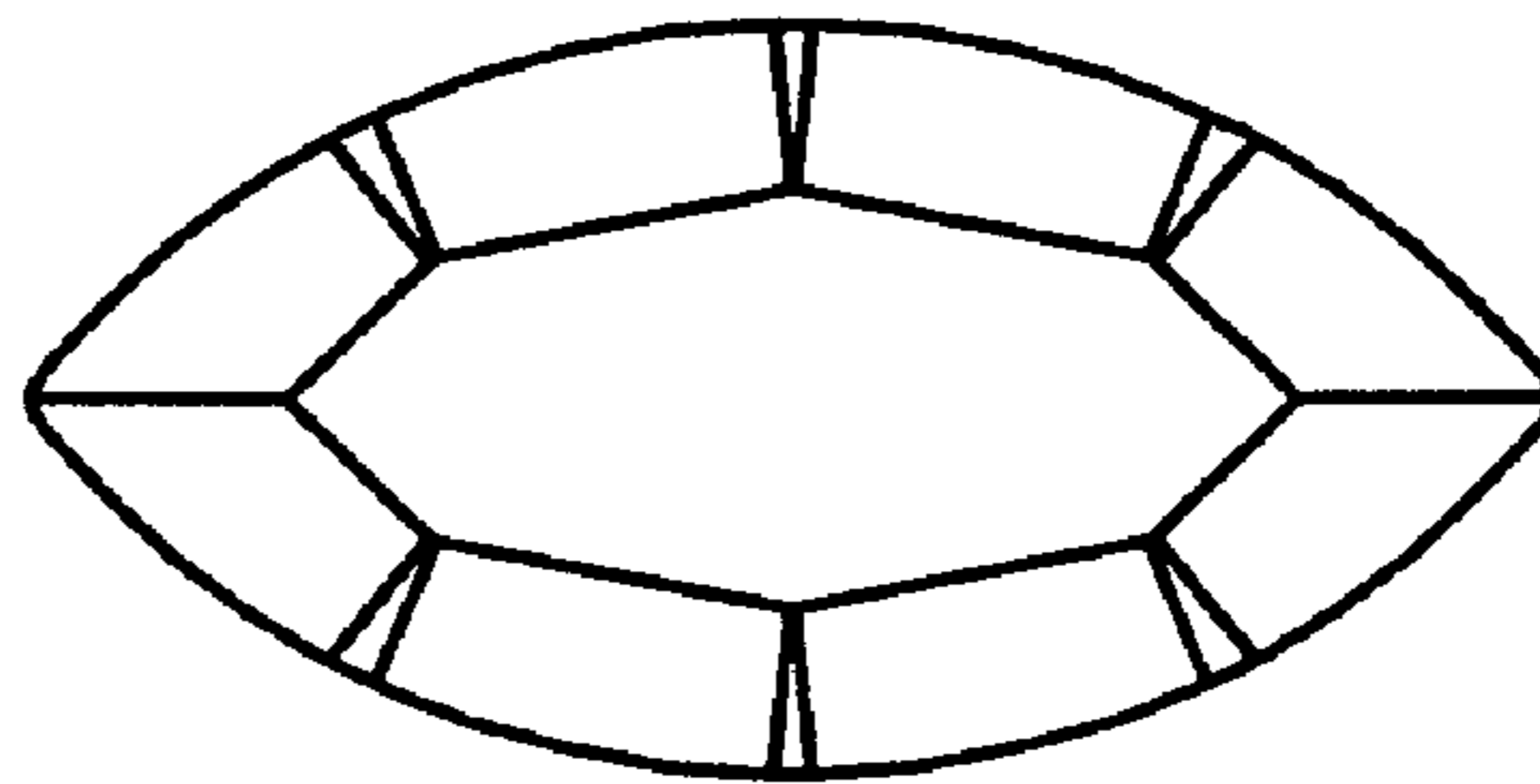

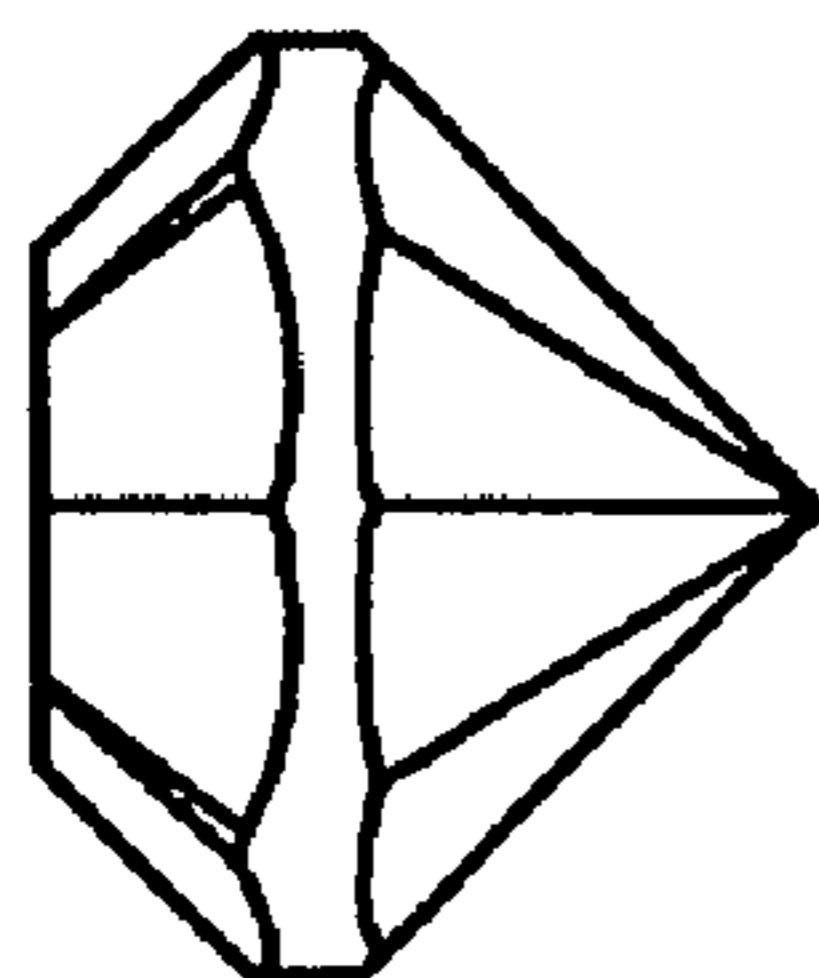

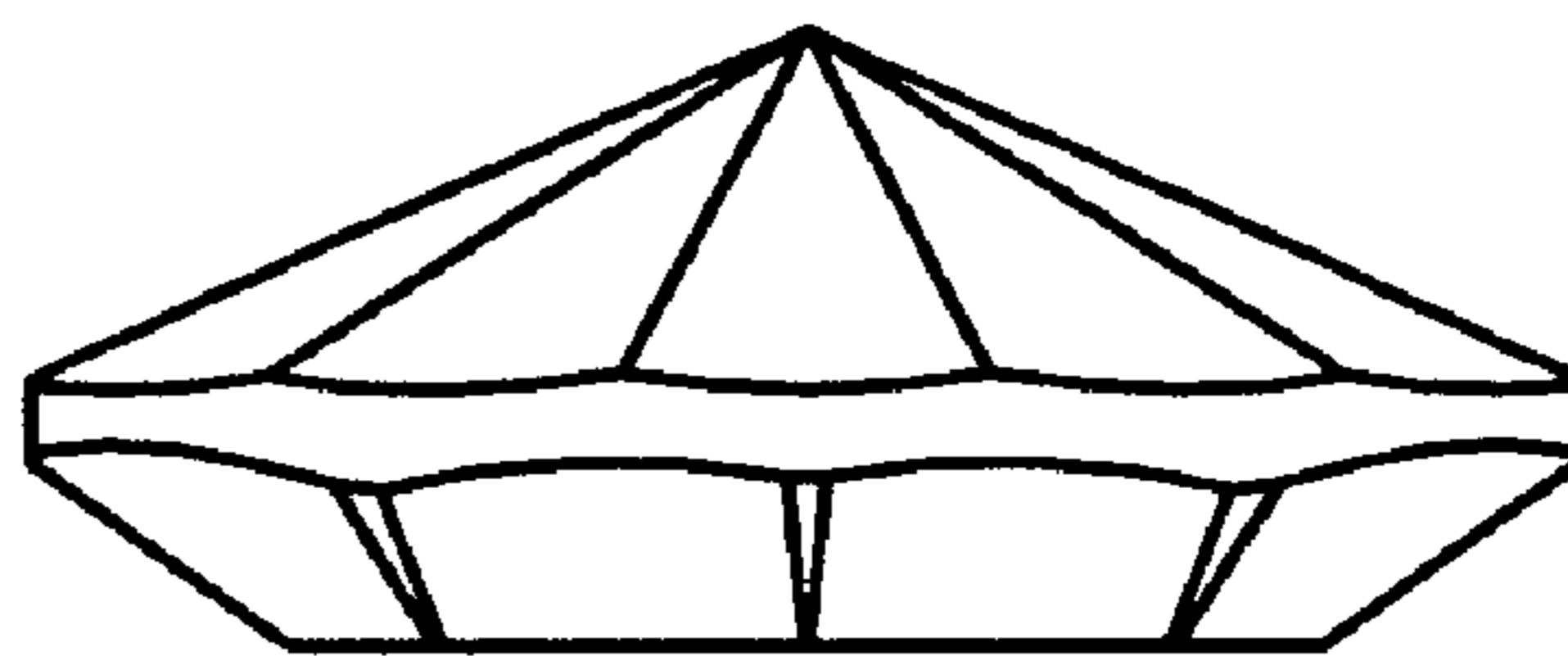

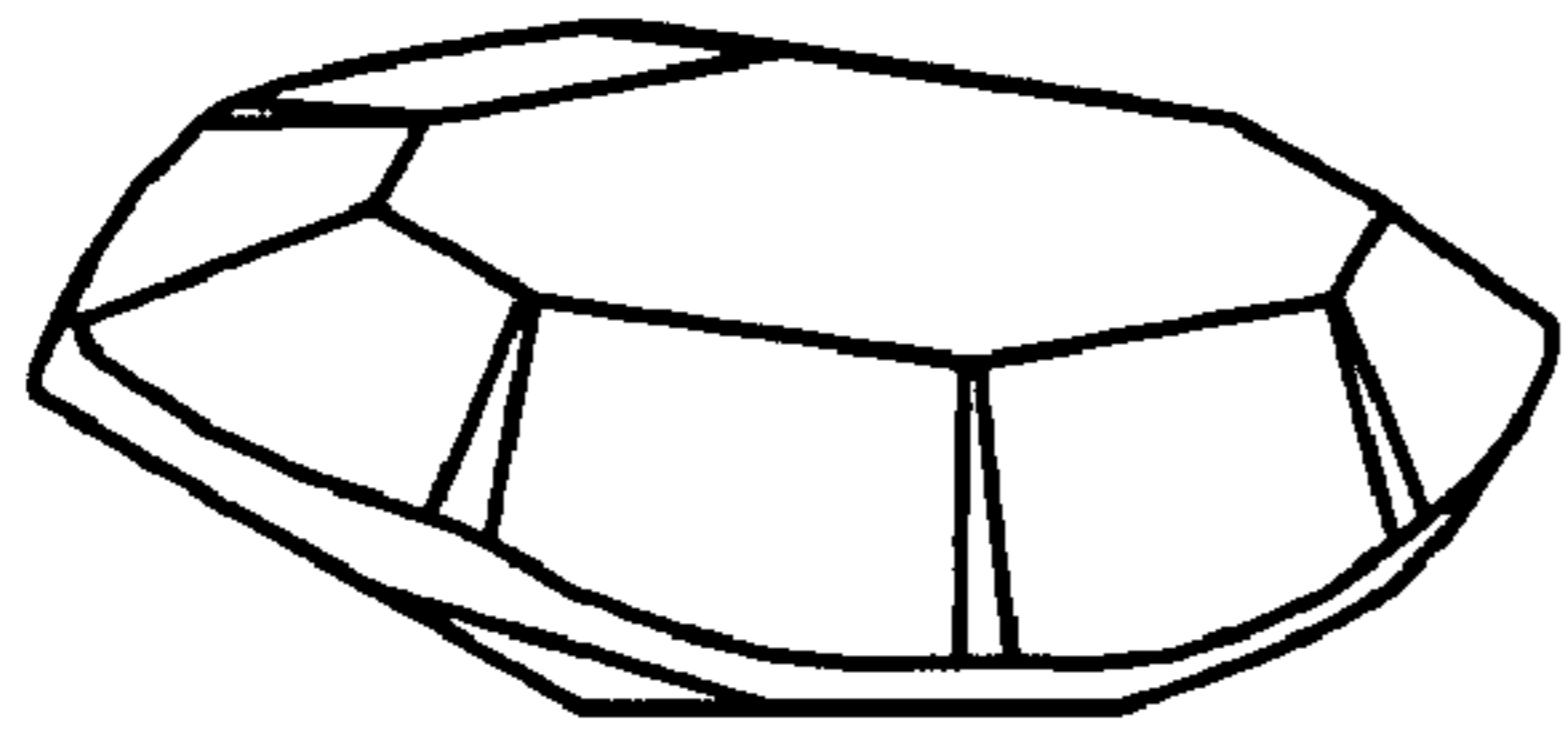

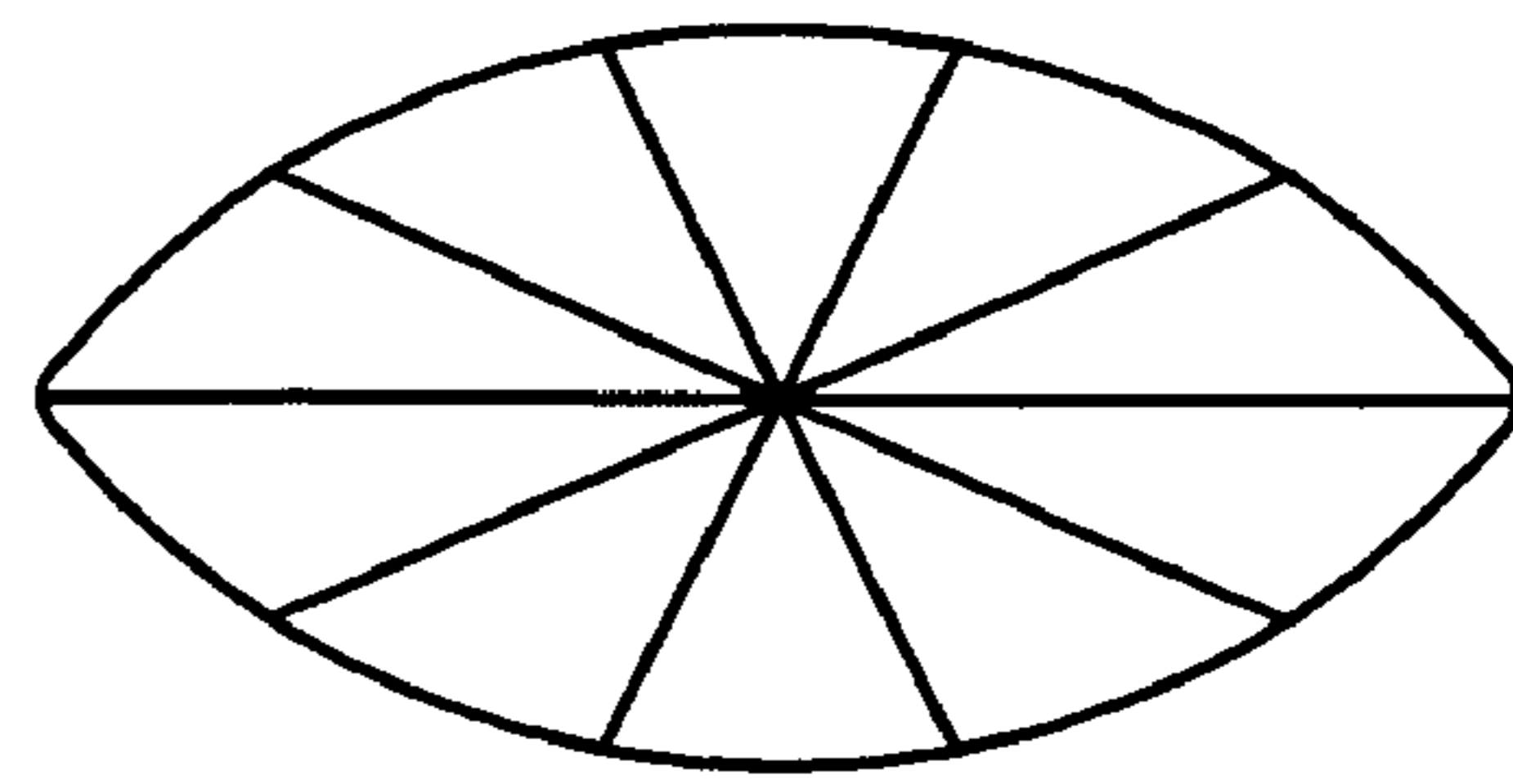

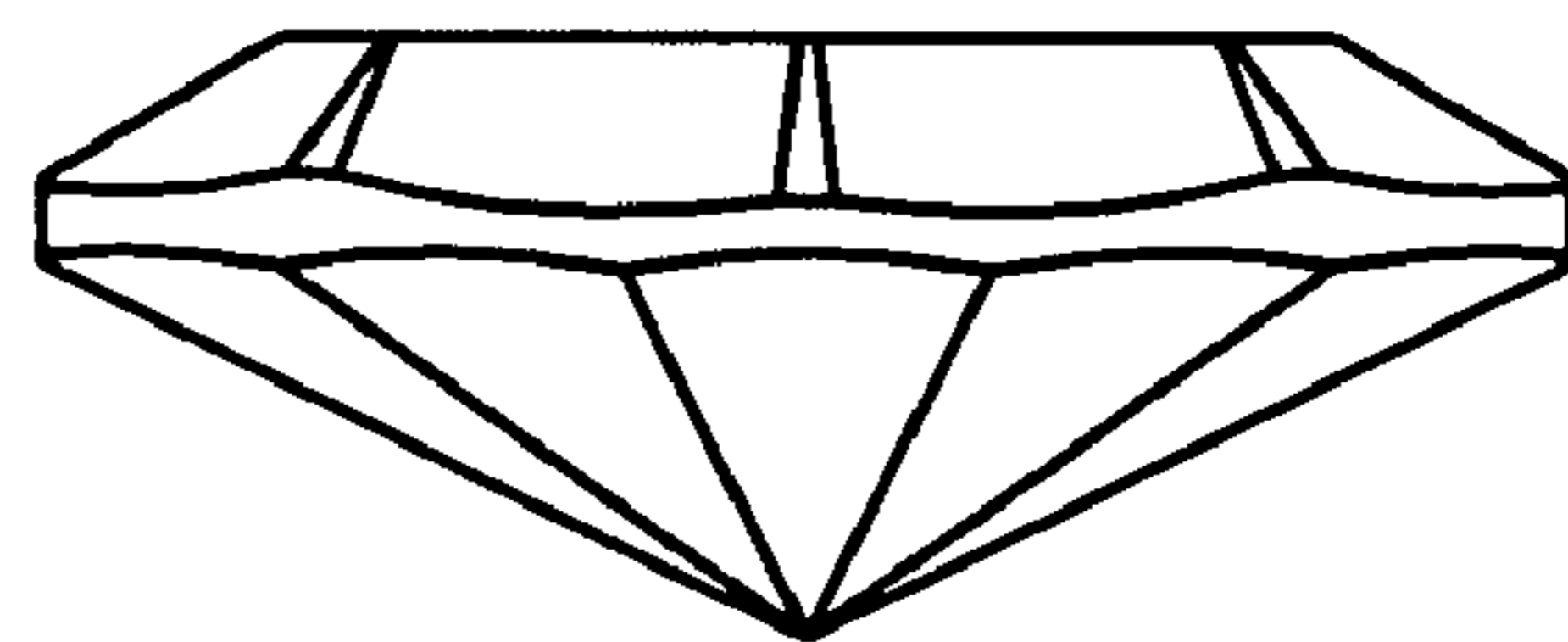

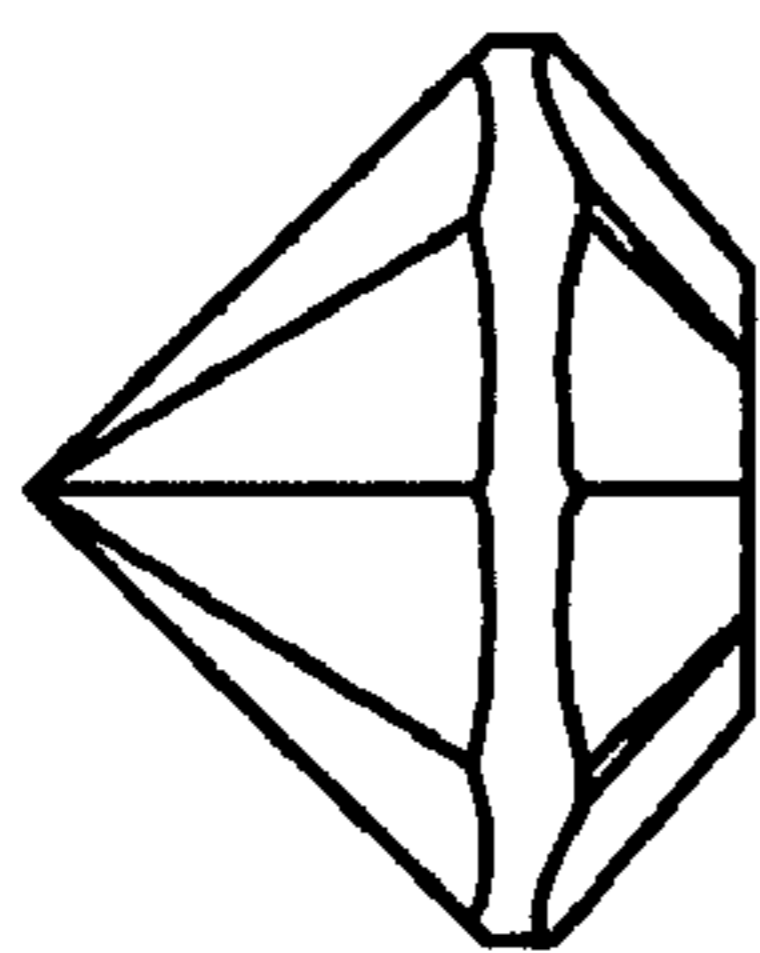

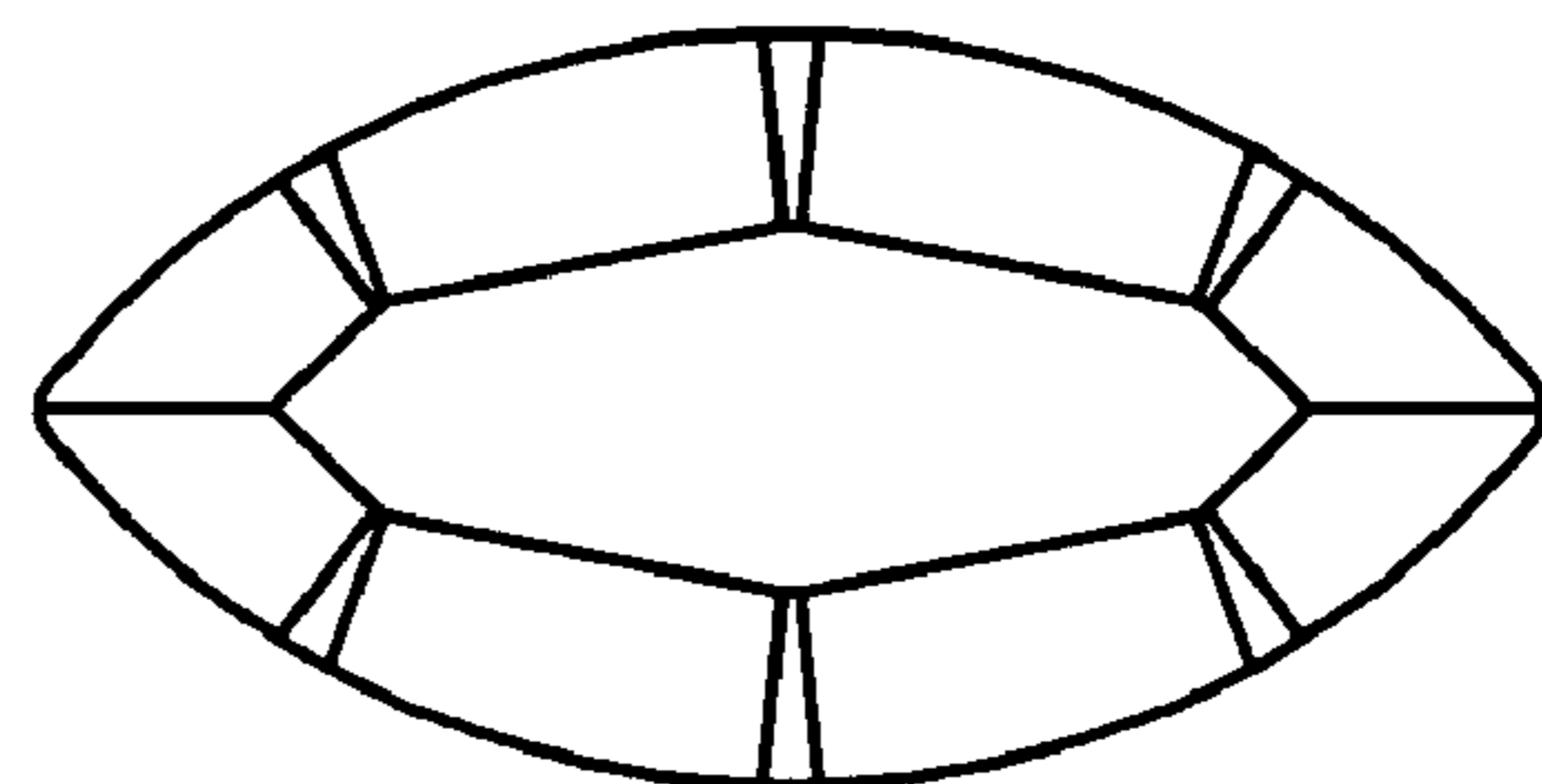

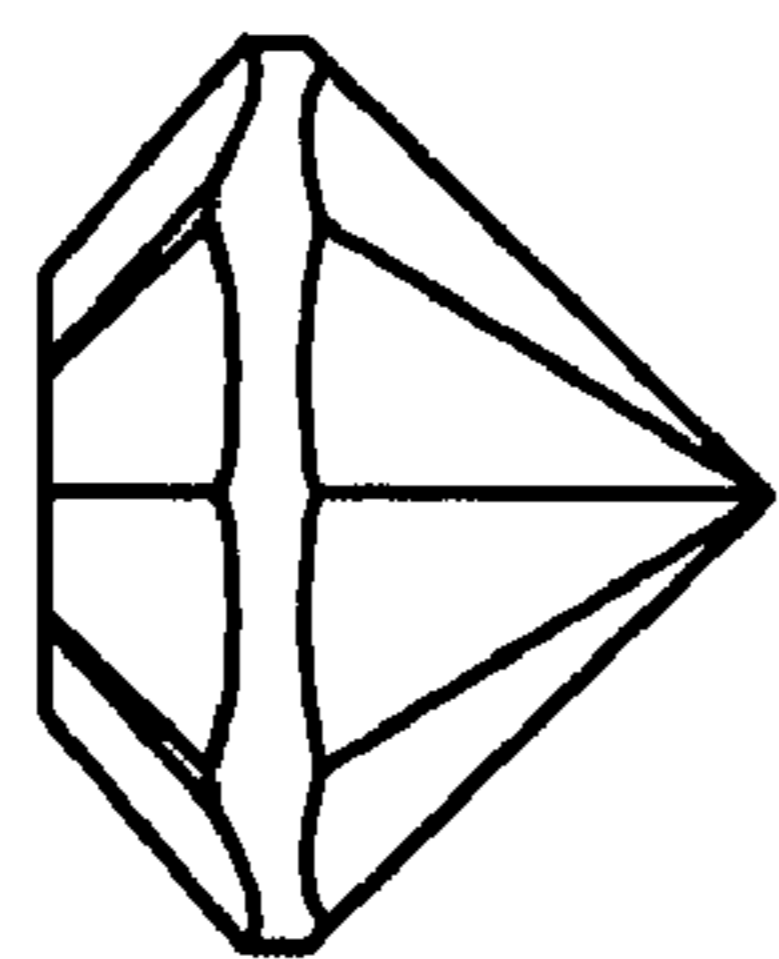

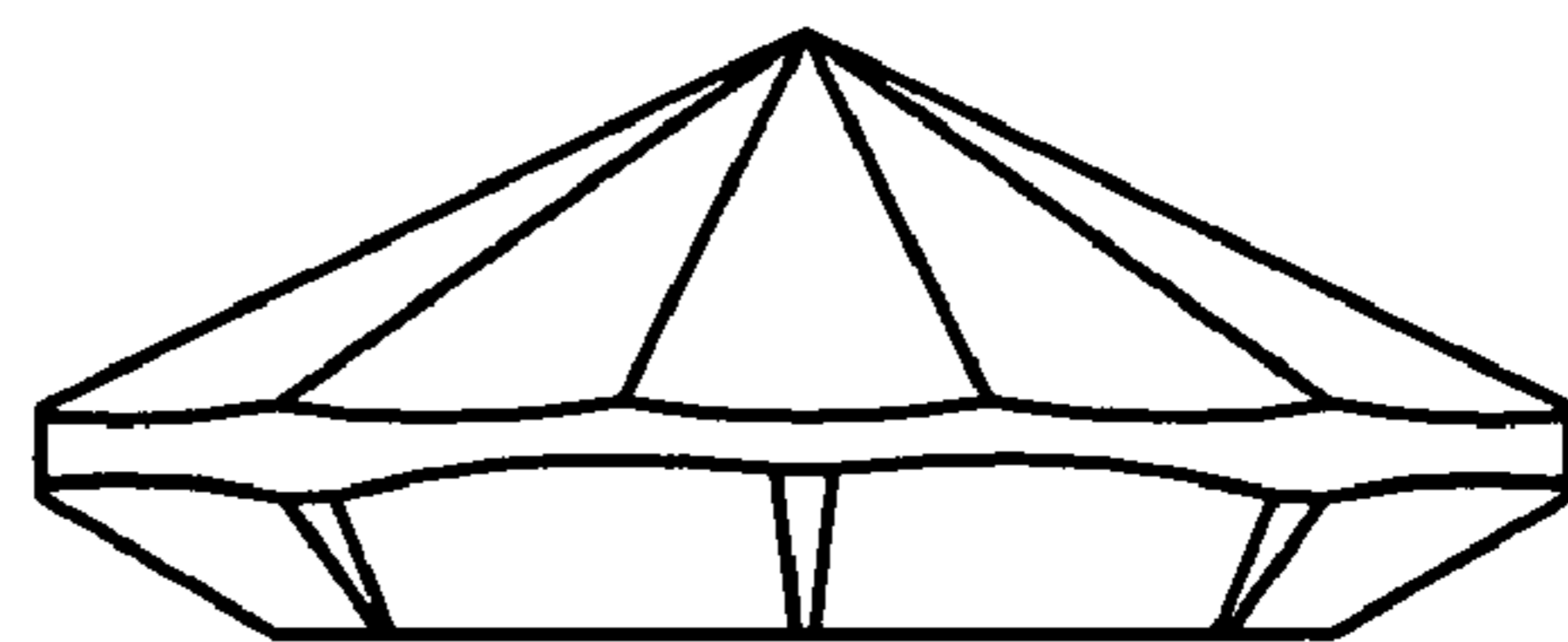
