The ornamental design for a steering wheel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment showing the design of a steering wheel;

FIG. 2 is a front and left side perspective view of the first embodiment;

FIG. 3 is a front elevational view of the first embodiment;

FIG. 4 is a right side elevational view of the first embodiment;

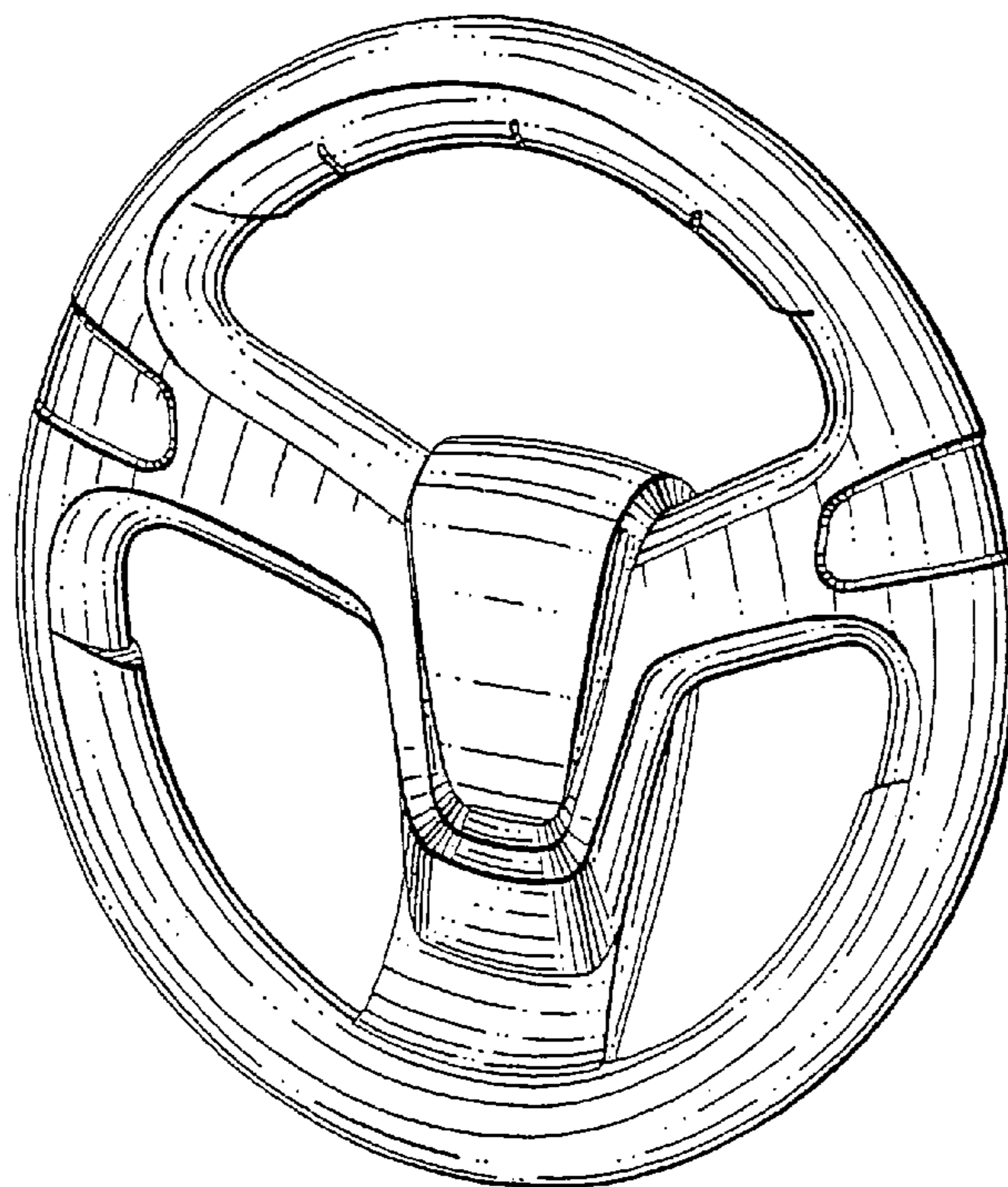

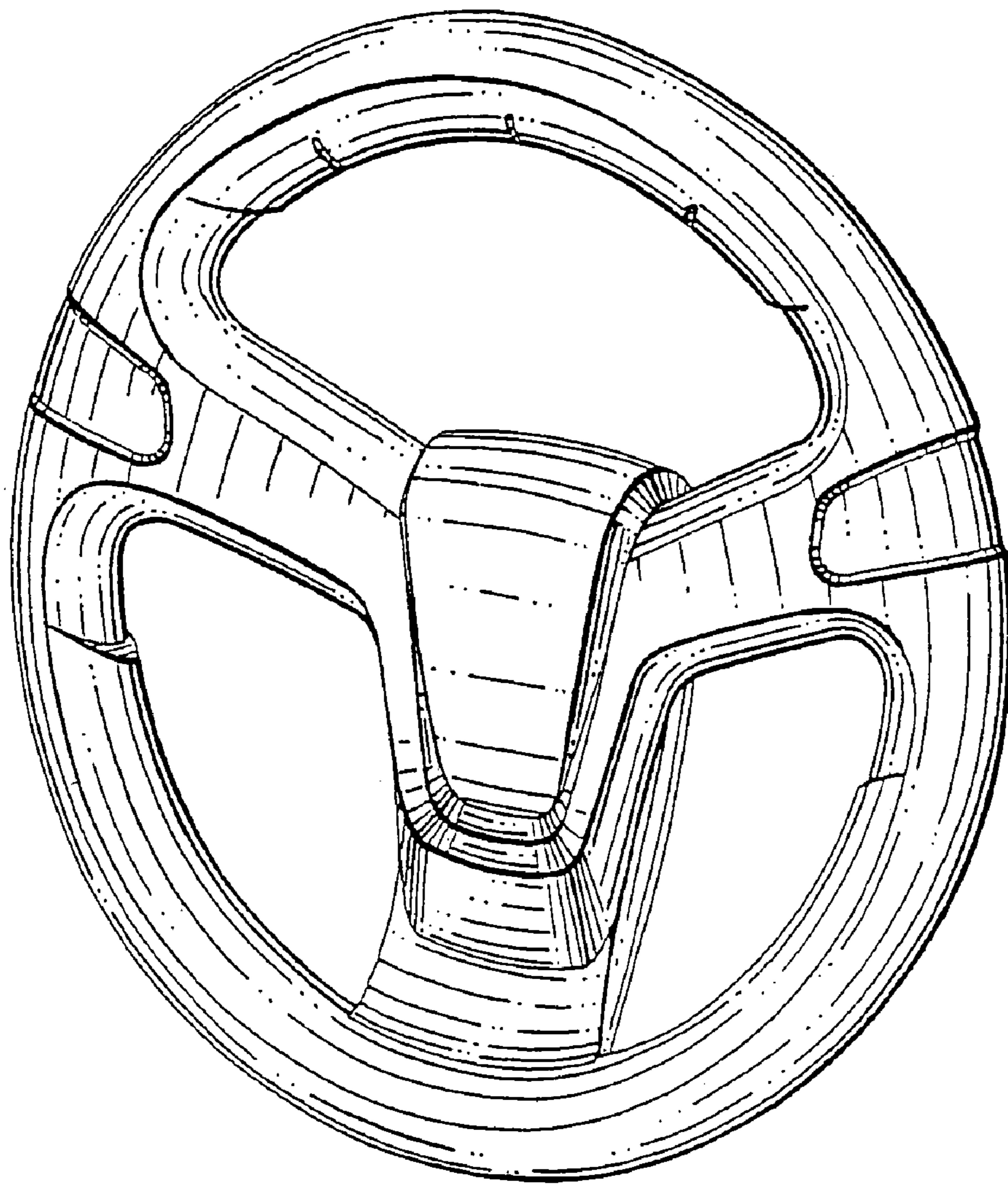
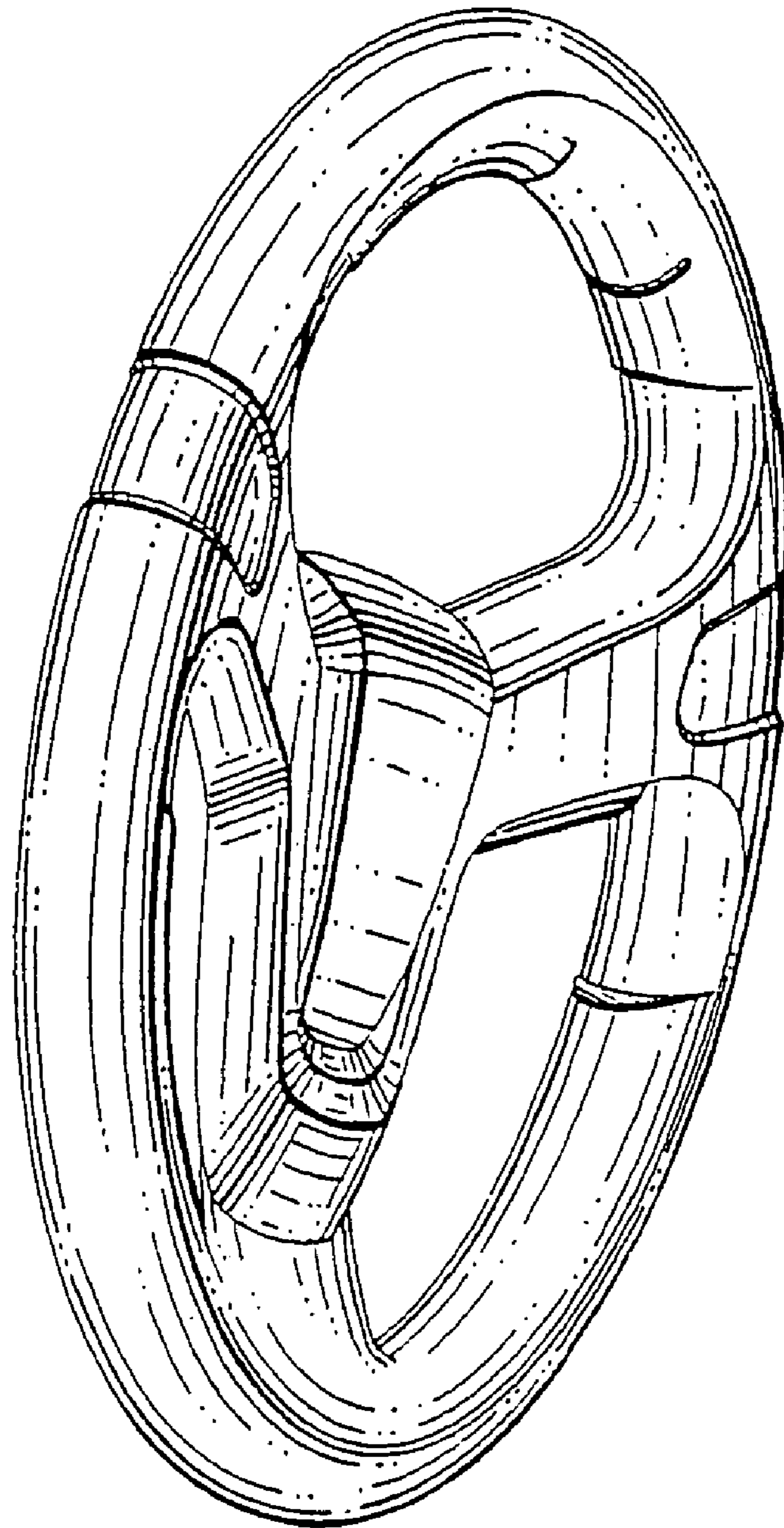

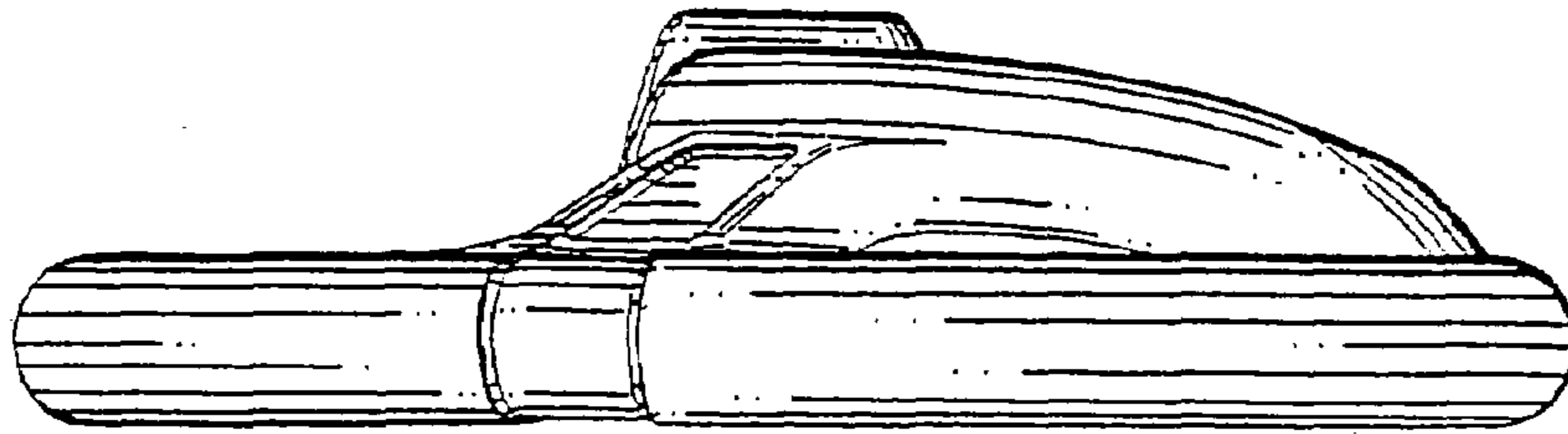

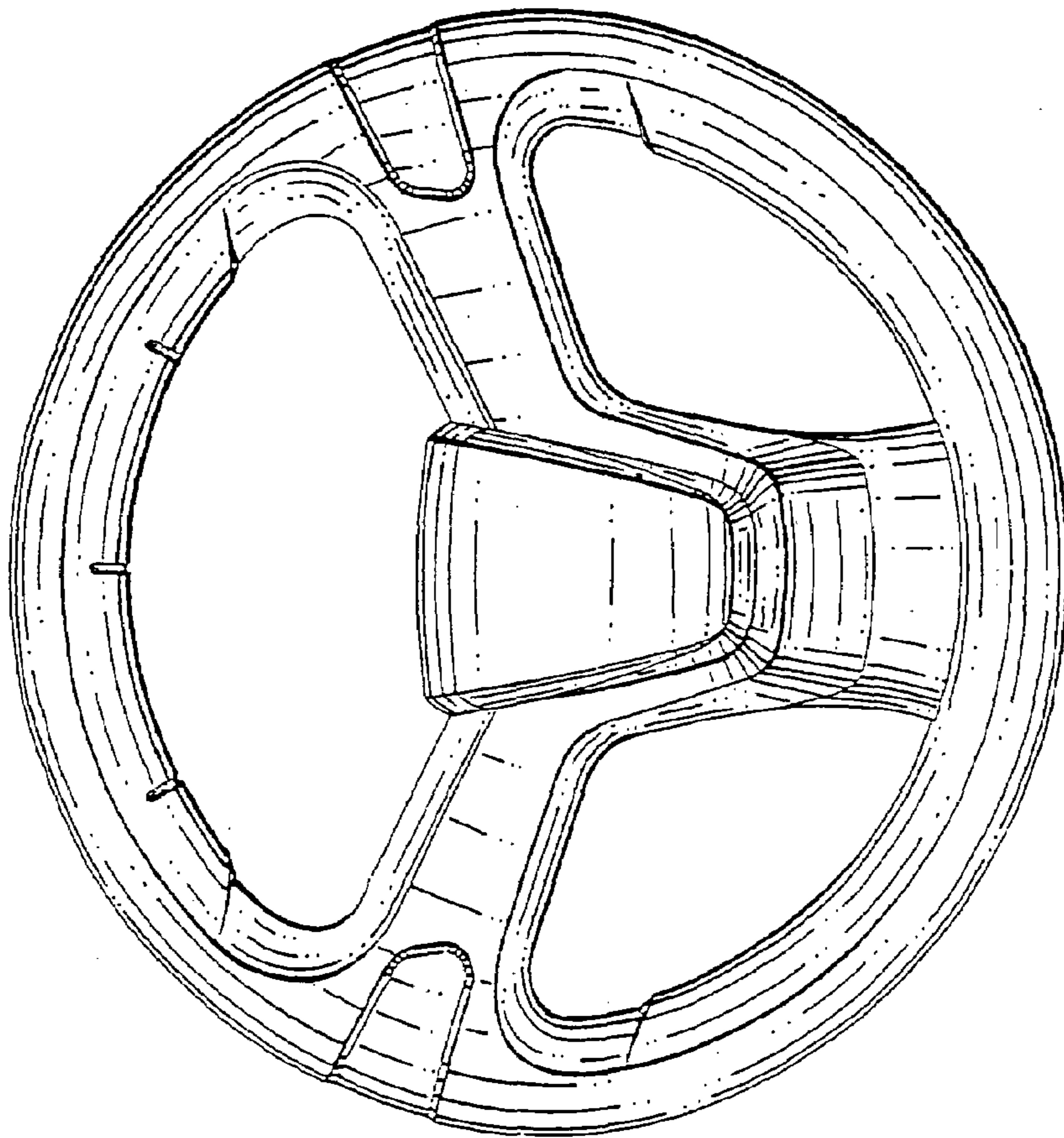

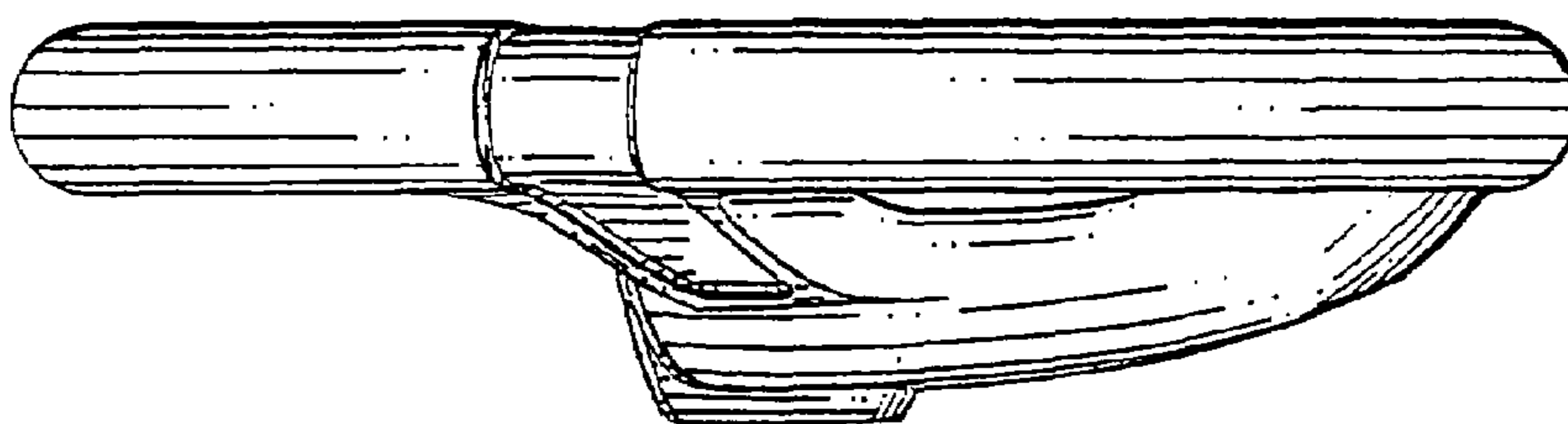

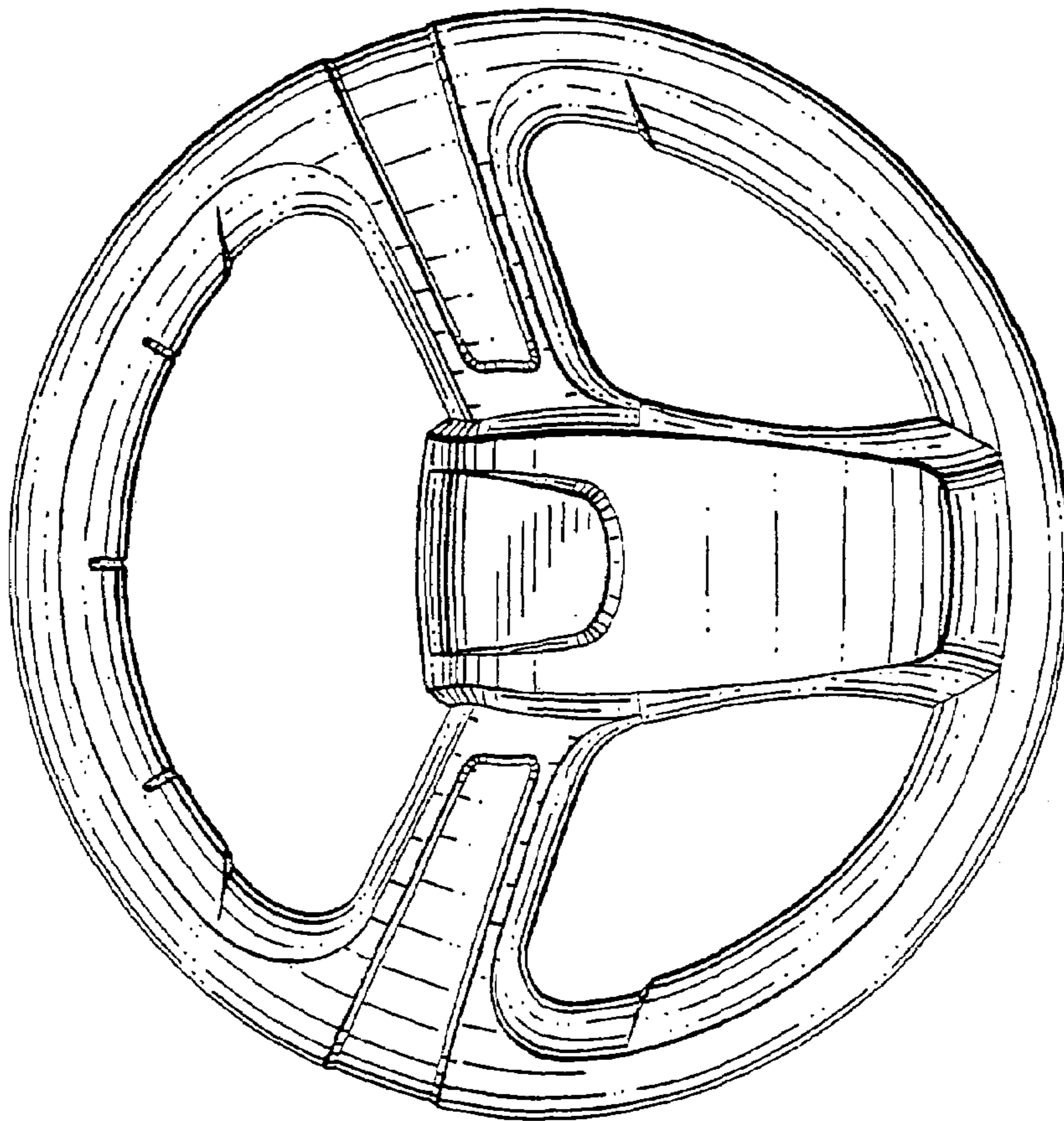

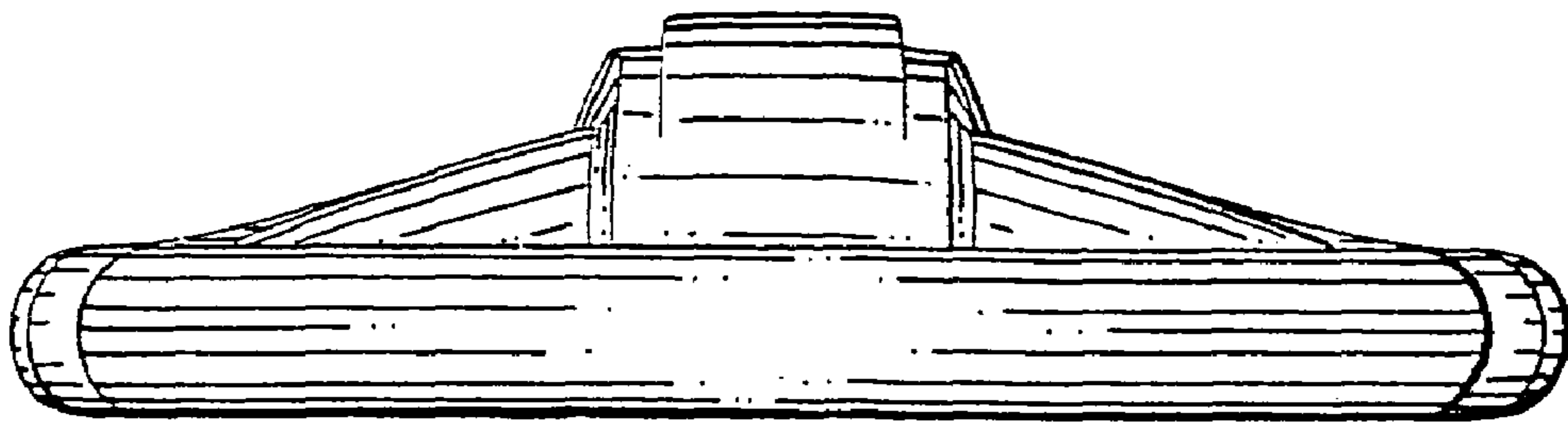
