**DESCRIPTION**

FIG. 1 is a perspective view of a wireless headset according to our new design;

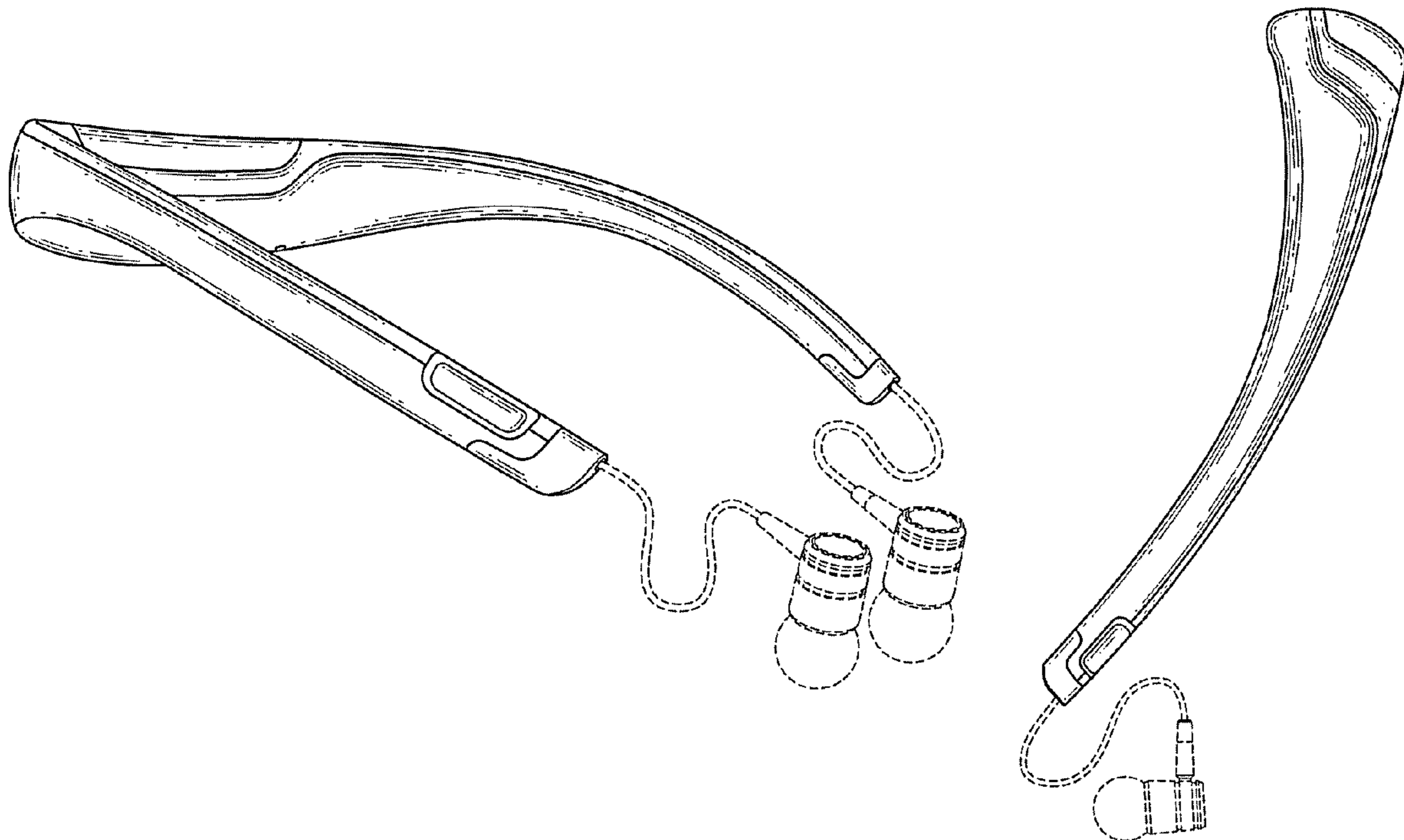

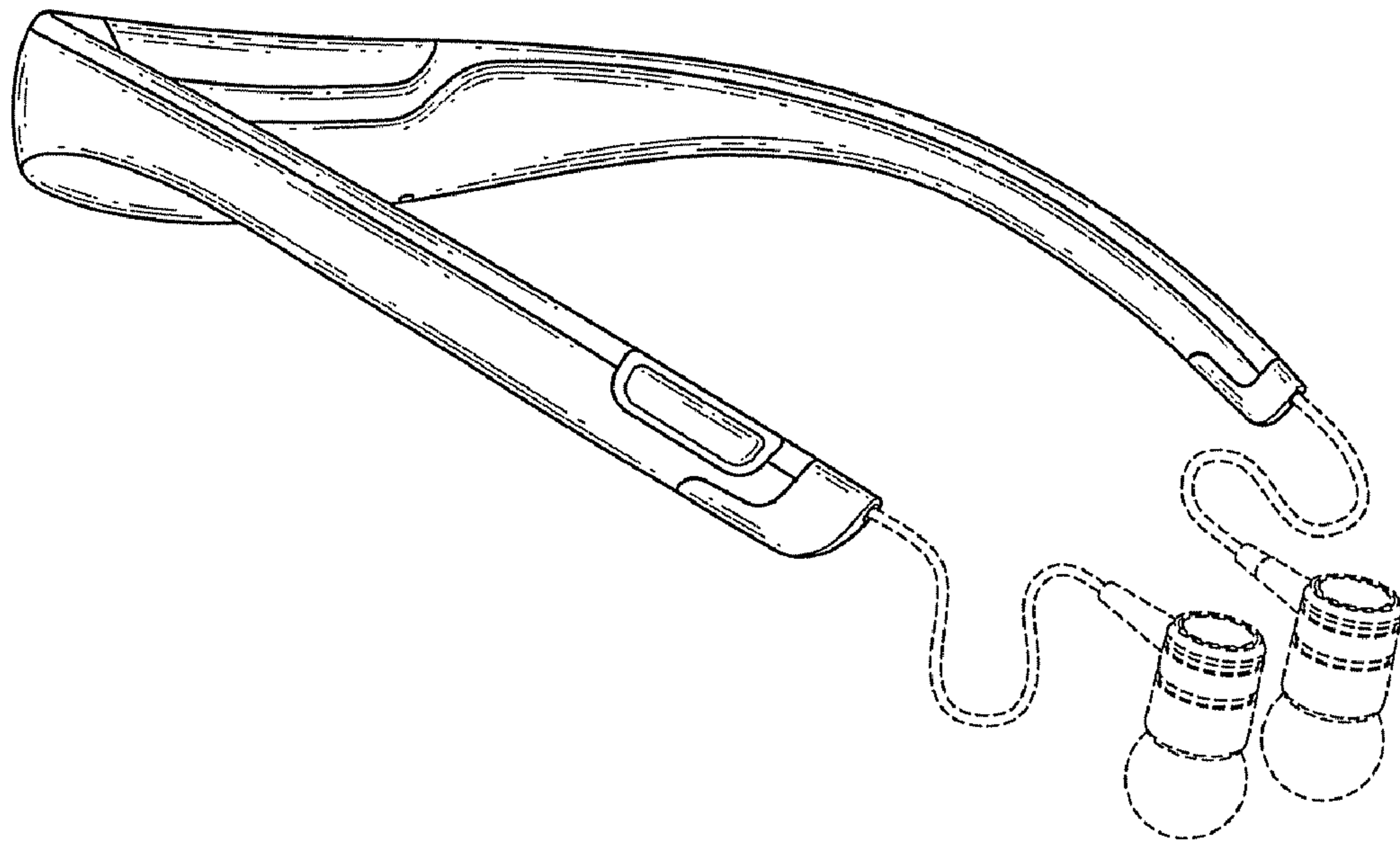

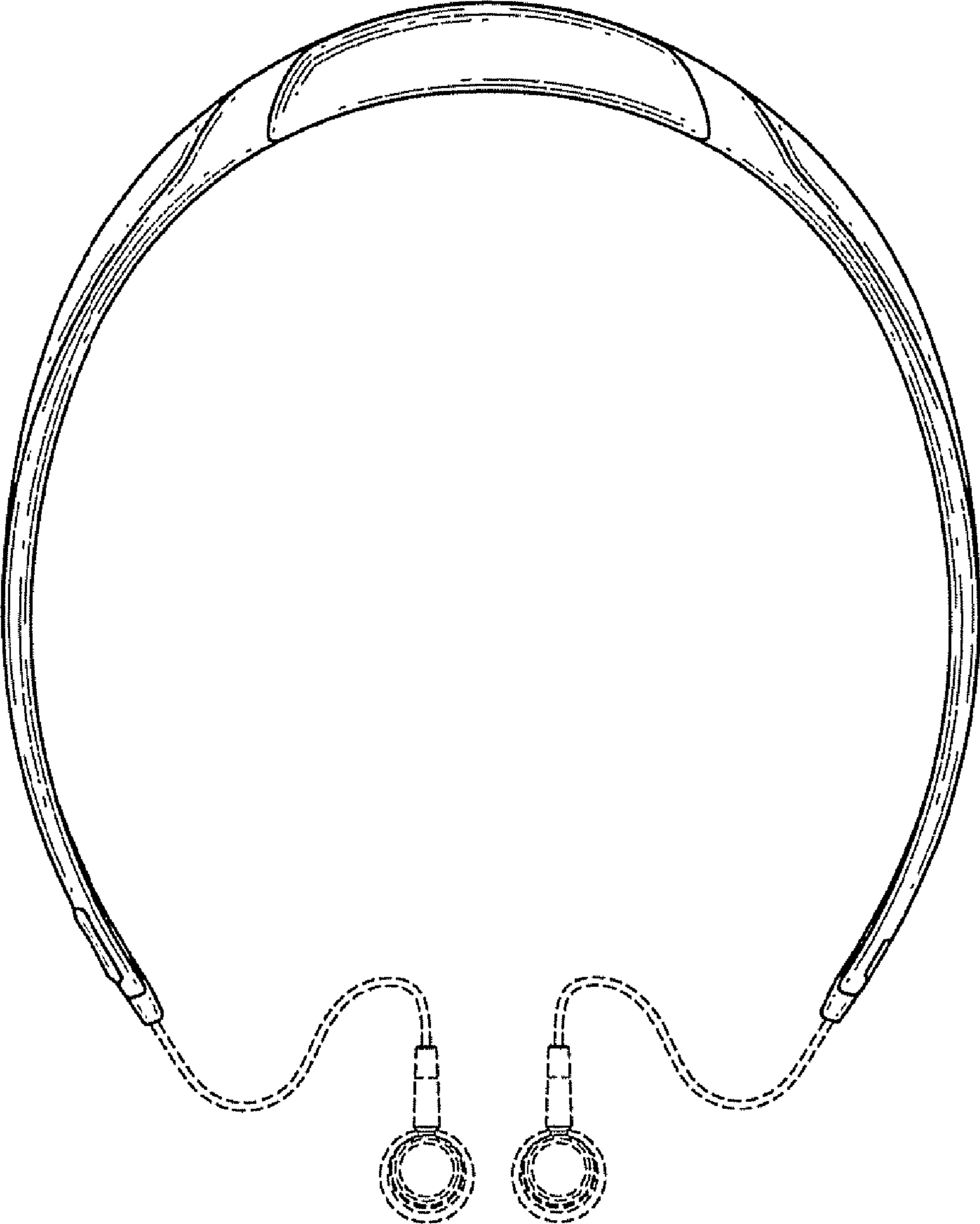

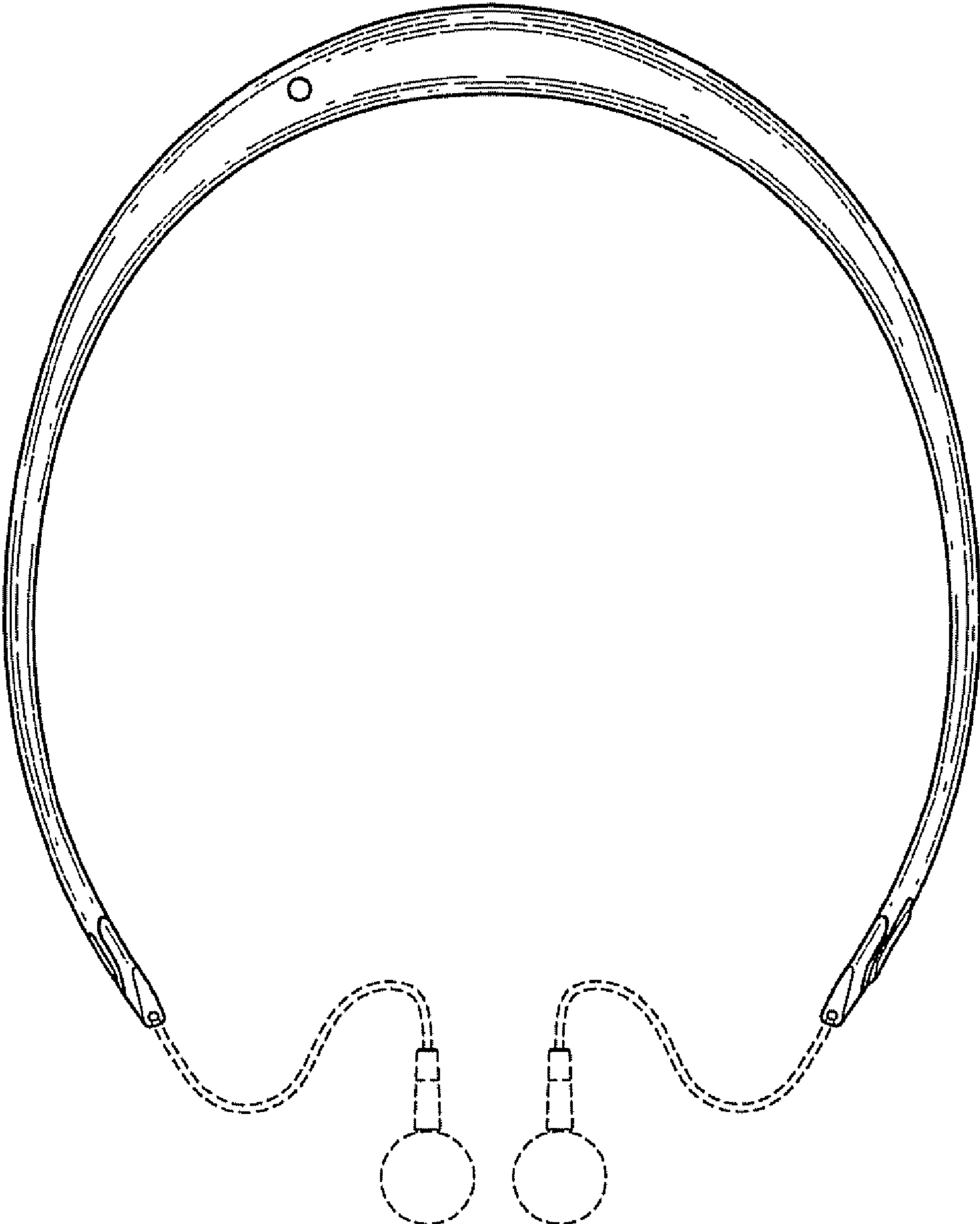

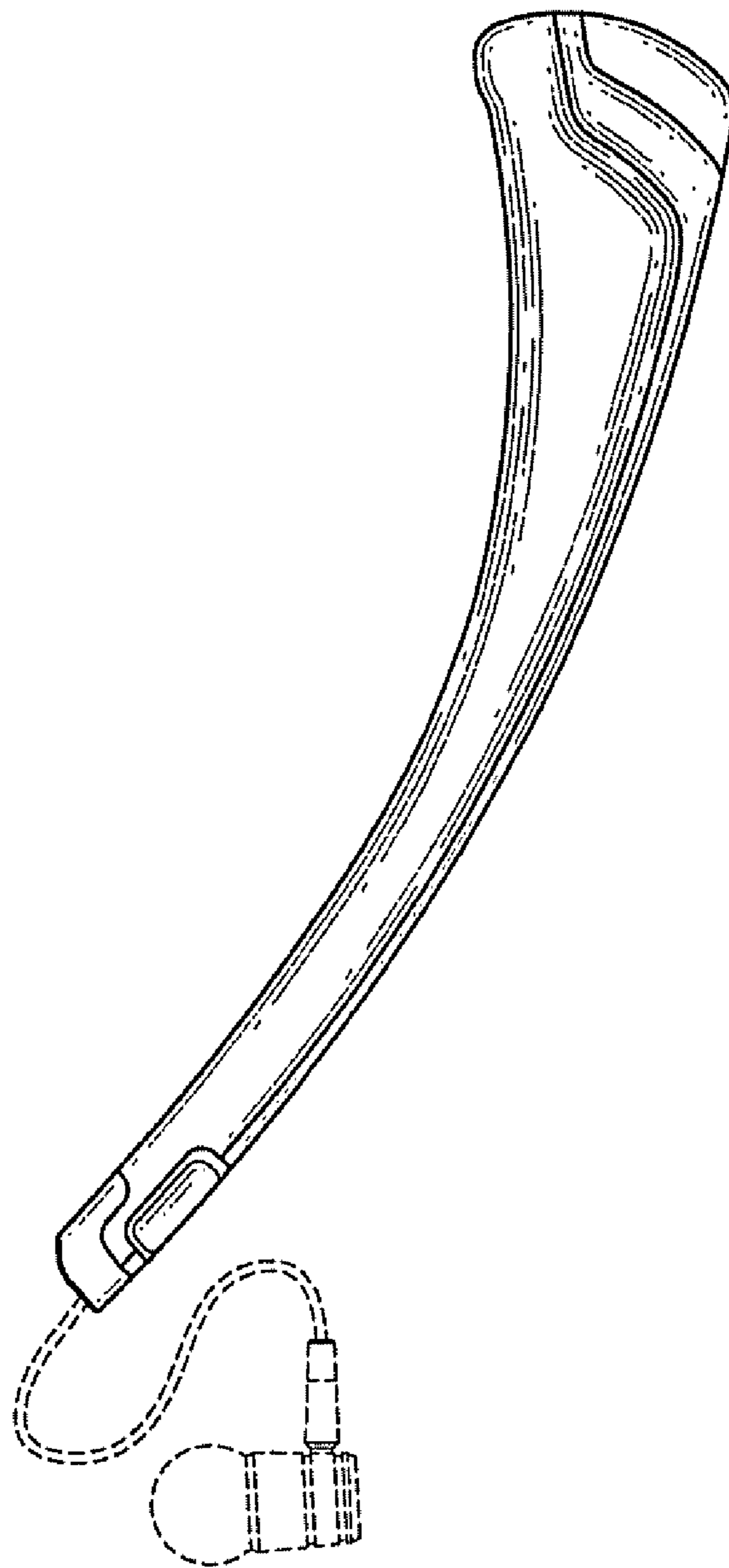

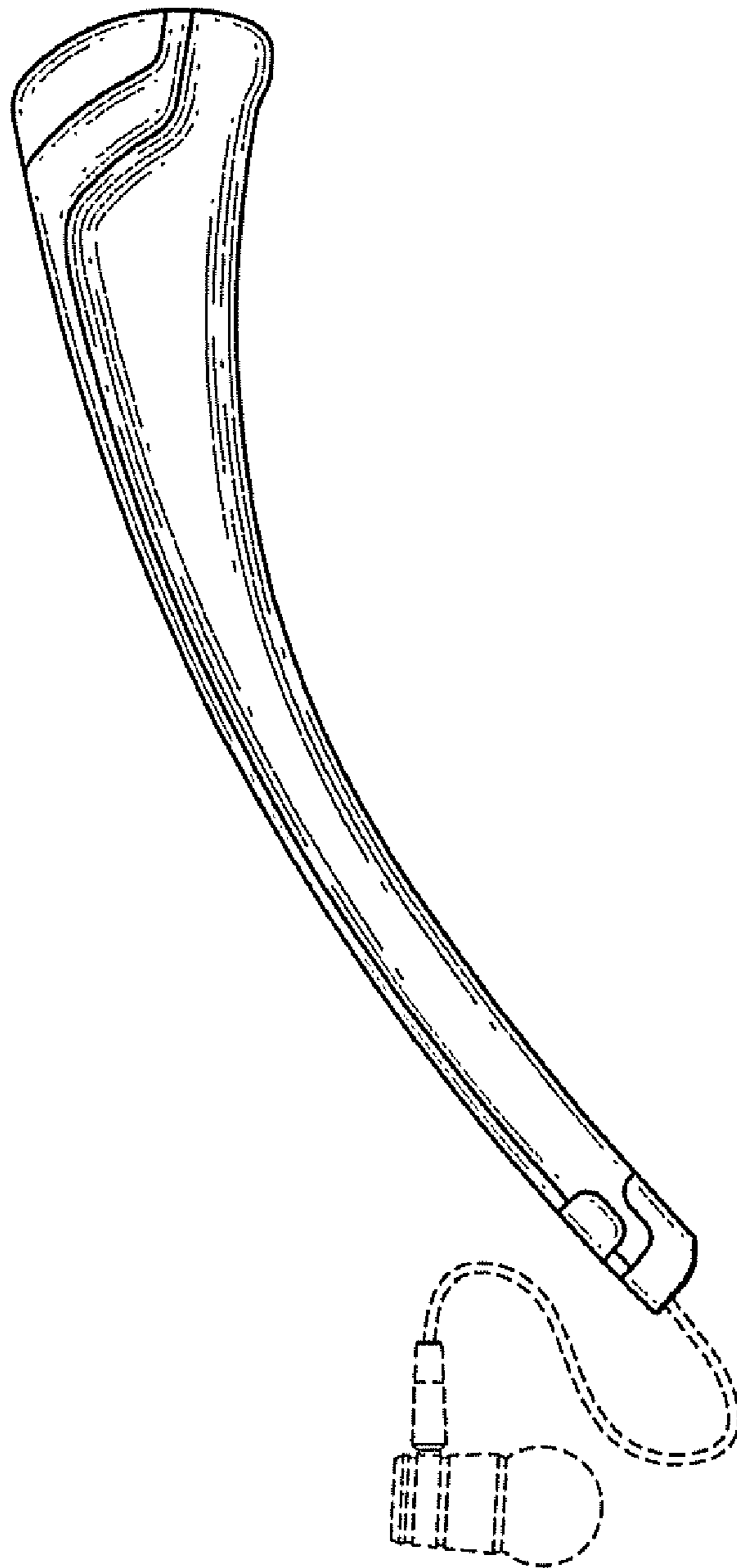

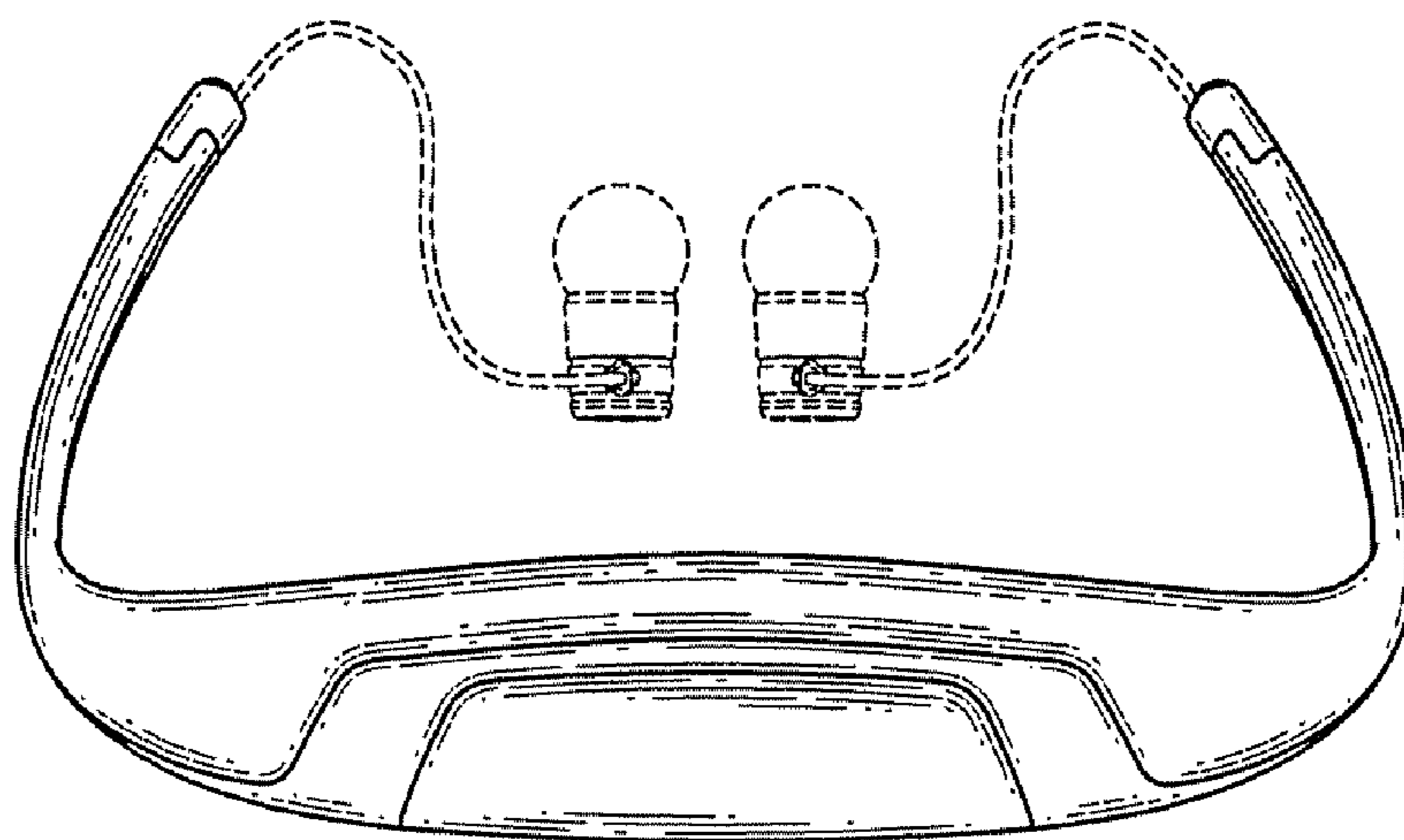
