FIG. 6 is a top orthographic view thereof; and,

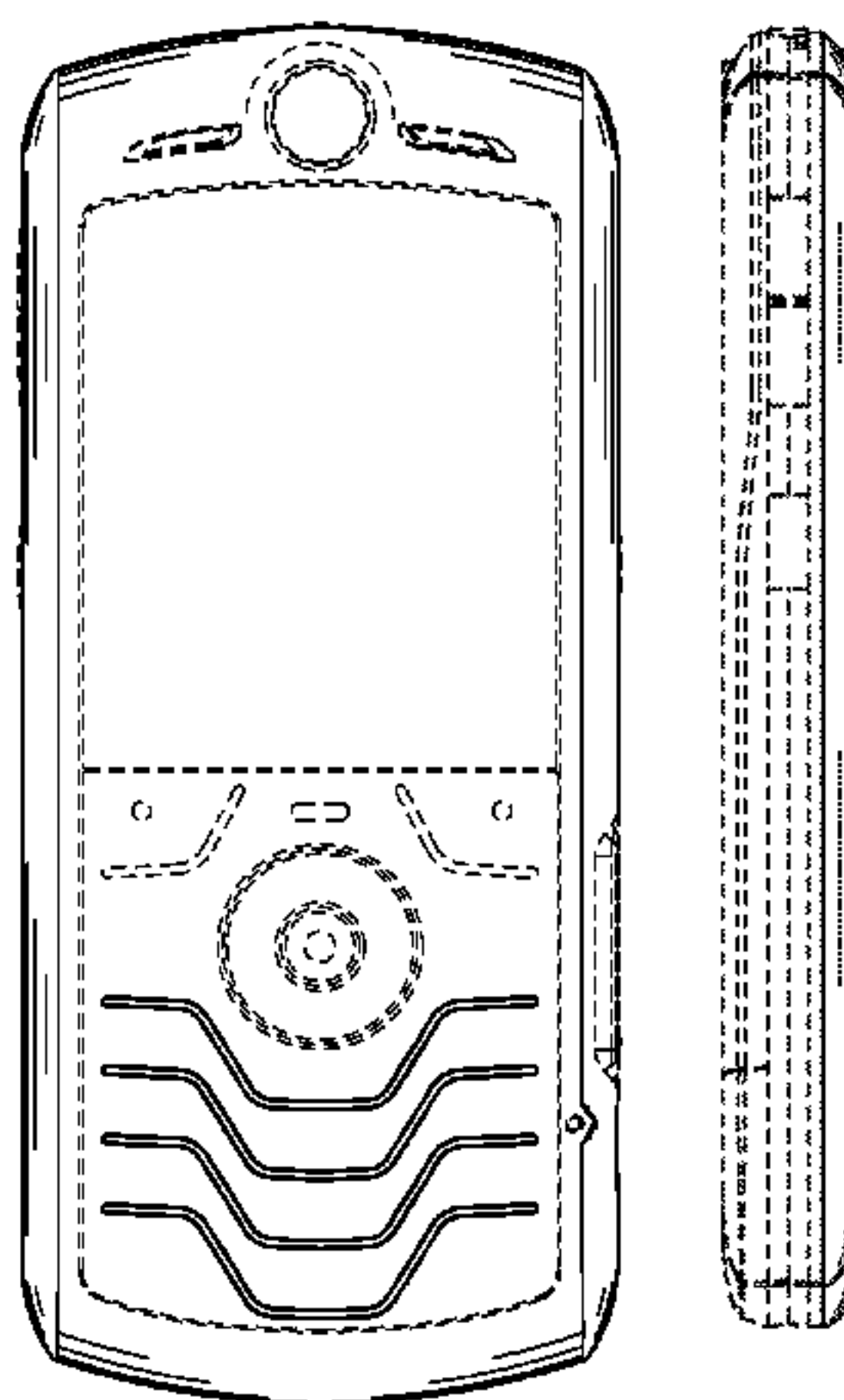
FIG. 7 is a bottom orthographic view thereof.

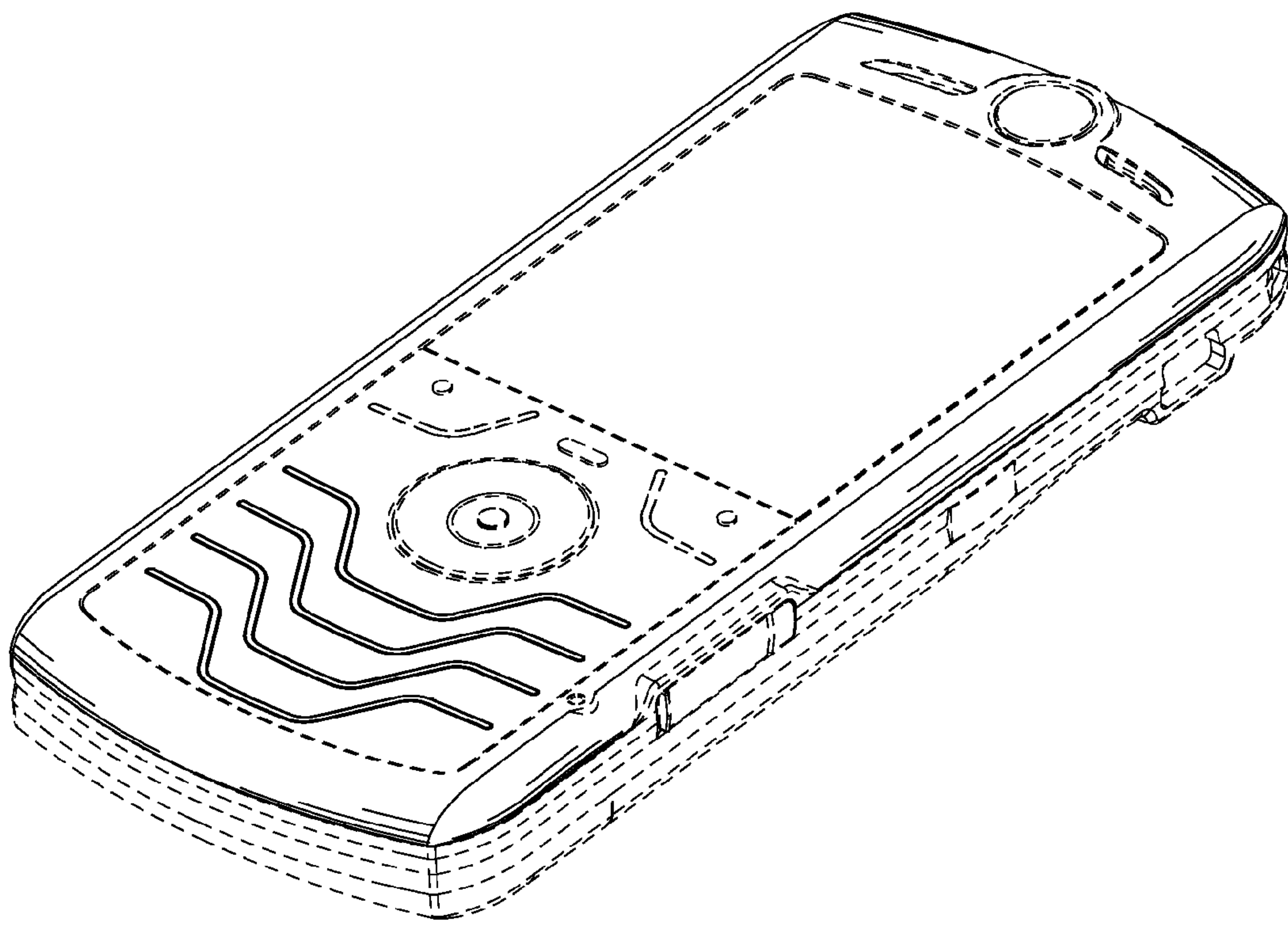

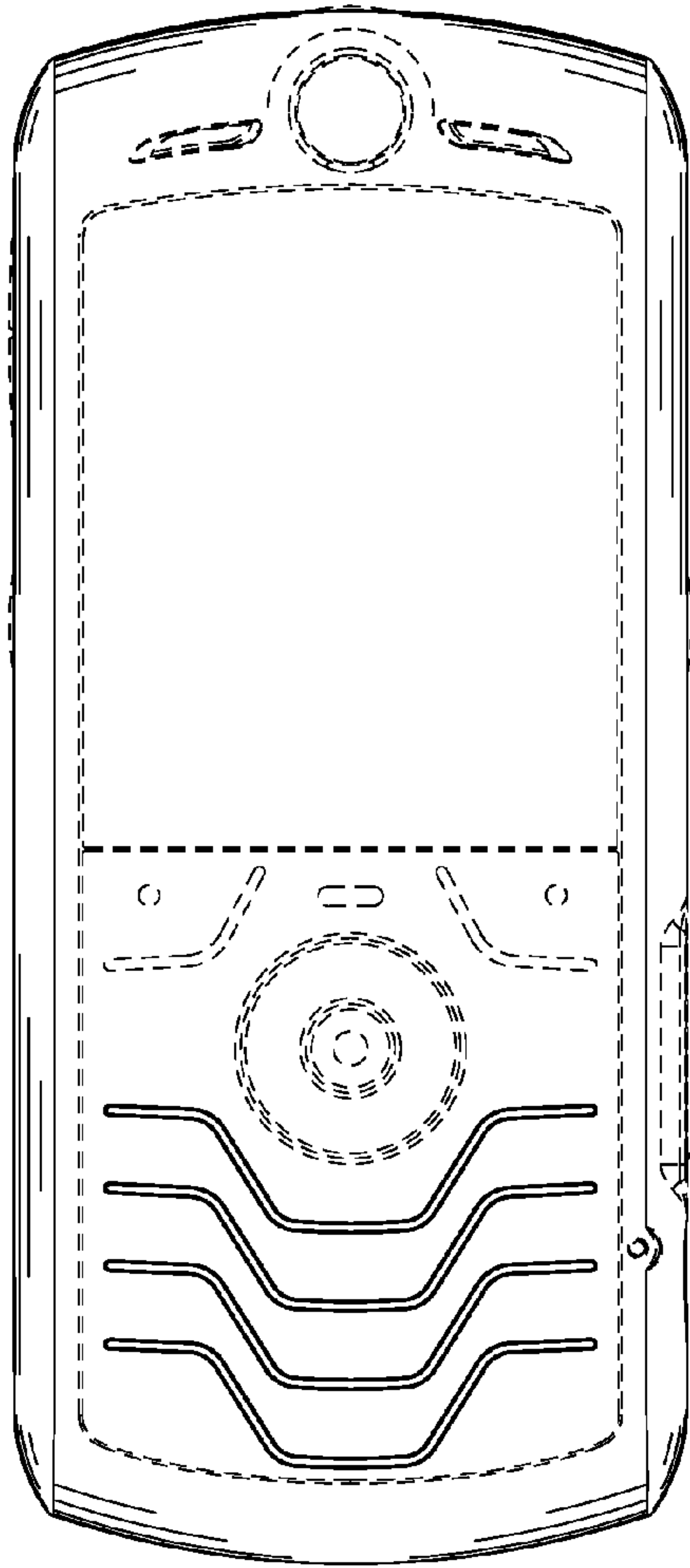

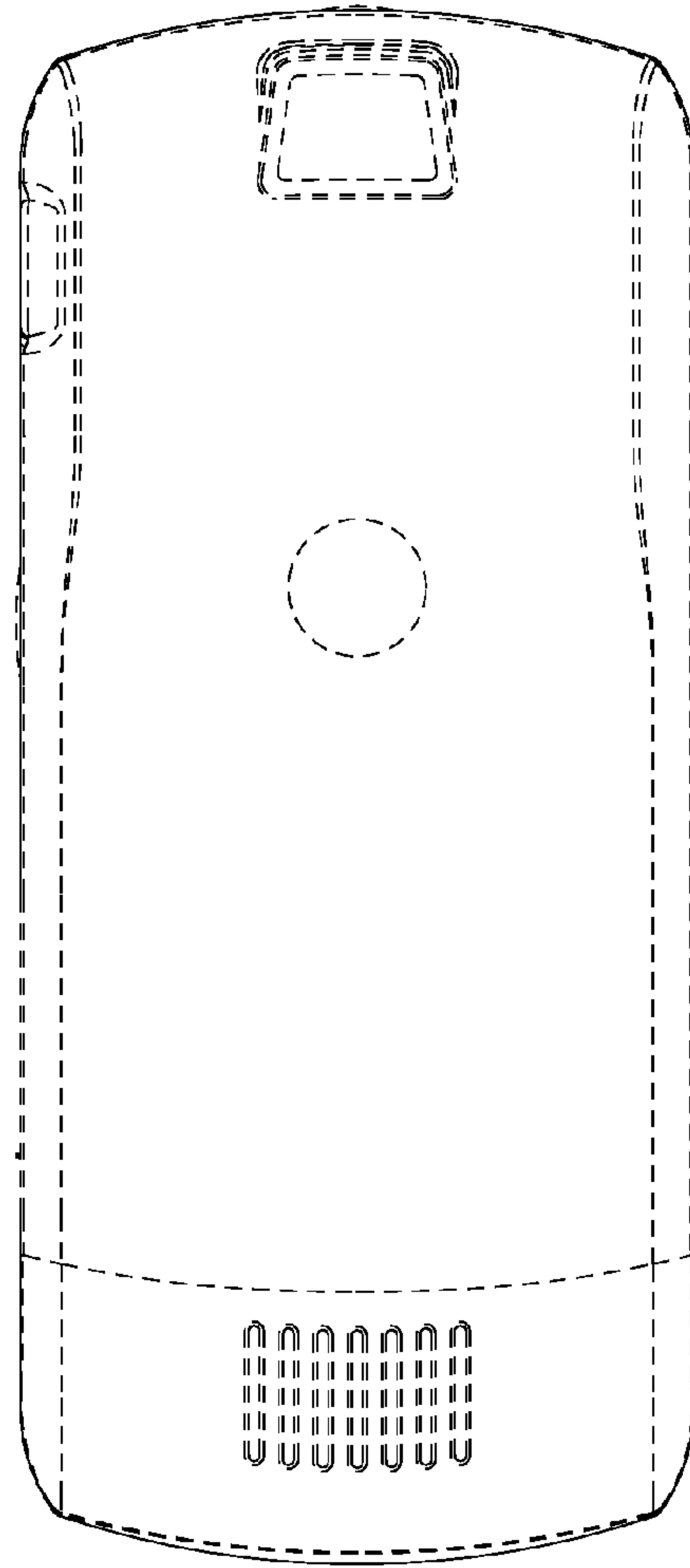

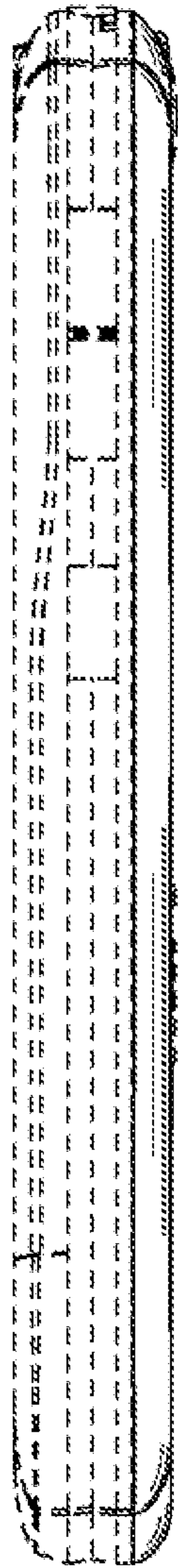




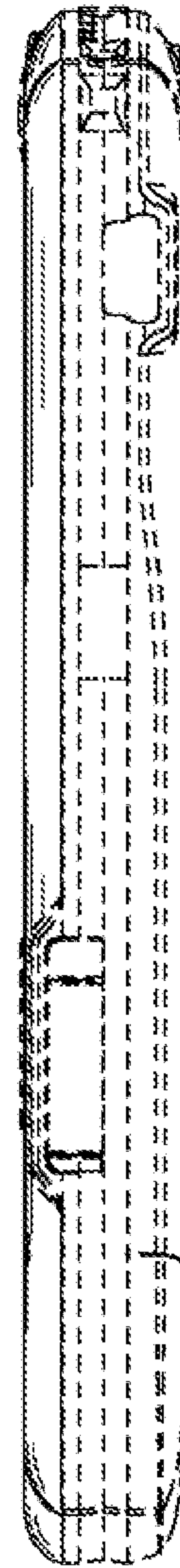

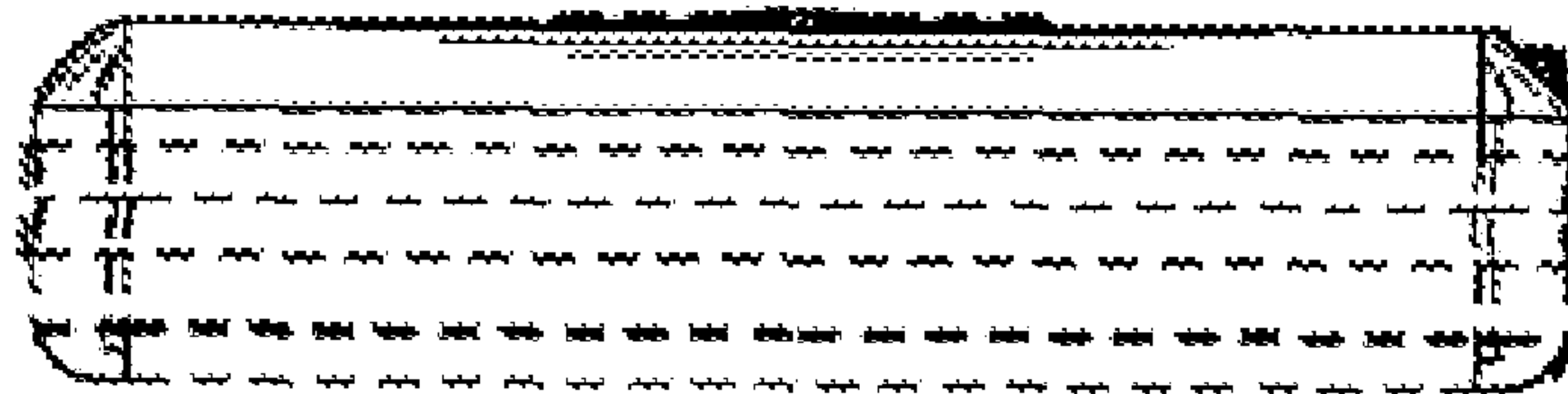
