(57) **CLAIM**

The ornamental design for a memory device with surface pattern, as shown and described.

DESCRIPTION

FIG. 1 is a front view showing a memory device with surface pattern;

FIG. 2 is a side view thereof; and,

FIG. 3 is a rear view thereof.

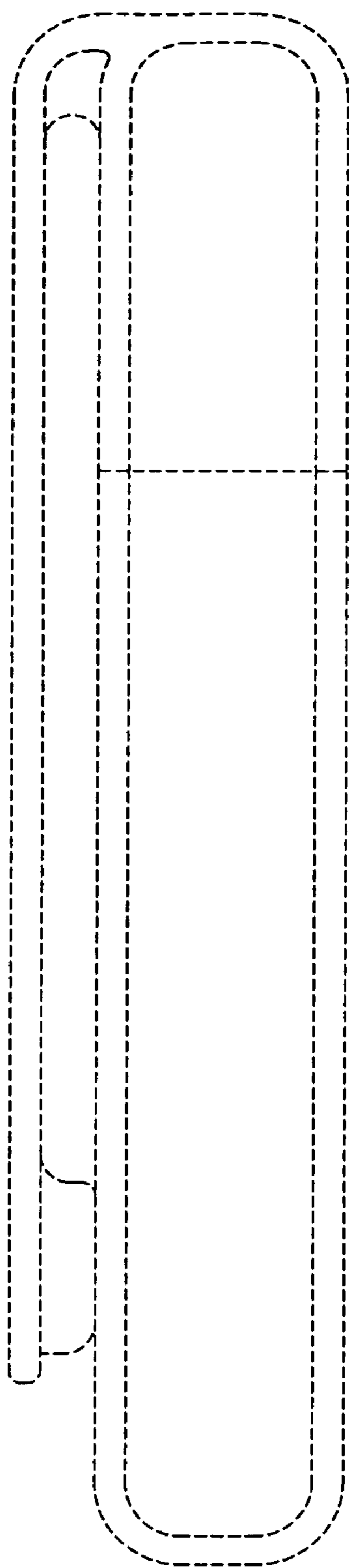

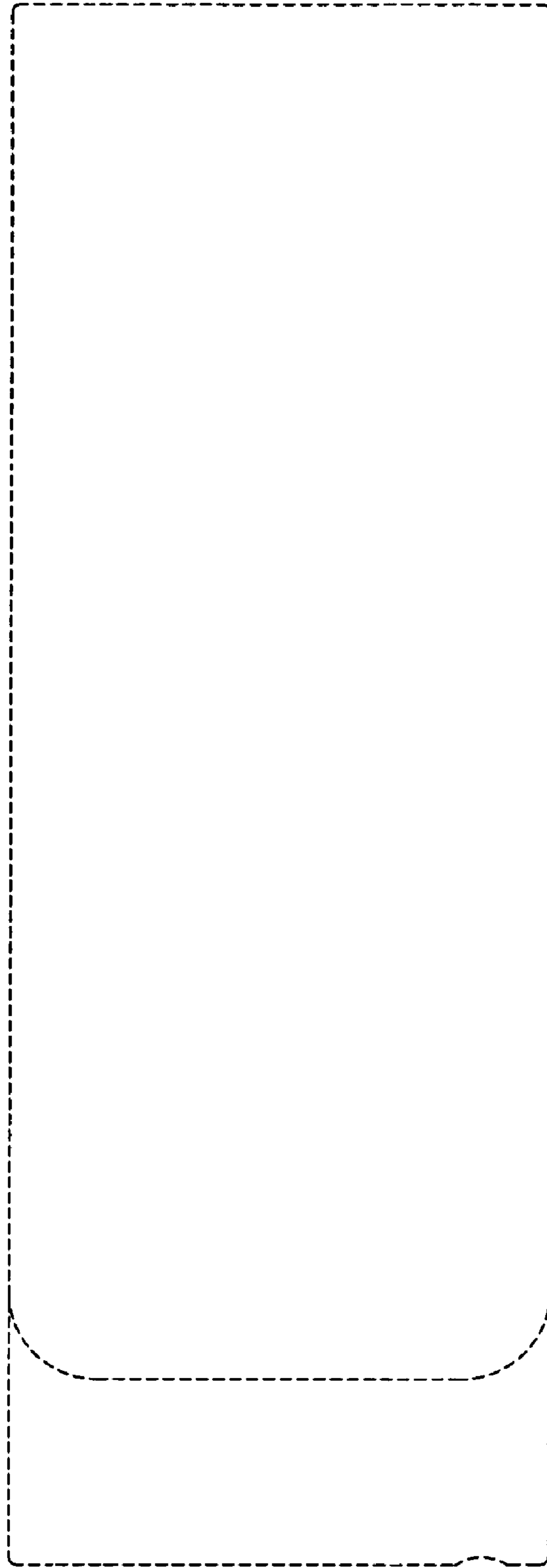
