The ornamental design for a cellular phone with a dynamic display on the screen thereof, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right perspective view of the cellular phone with dynamic display on the screen thereof showing our new design;

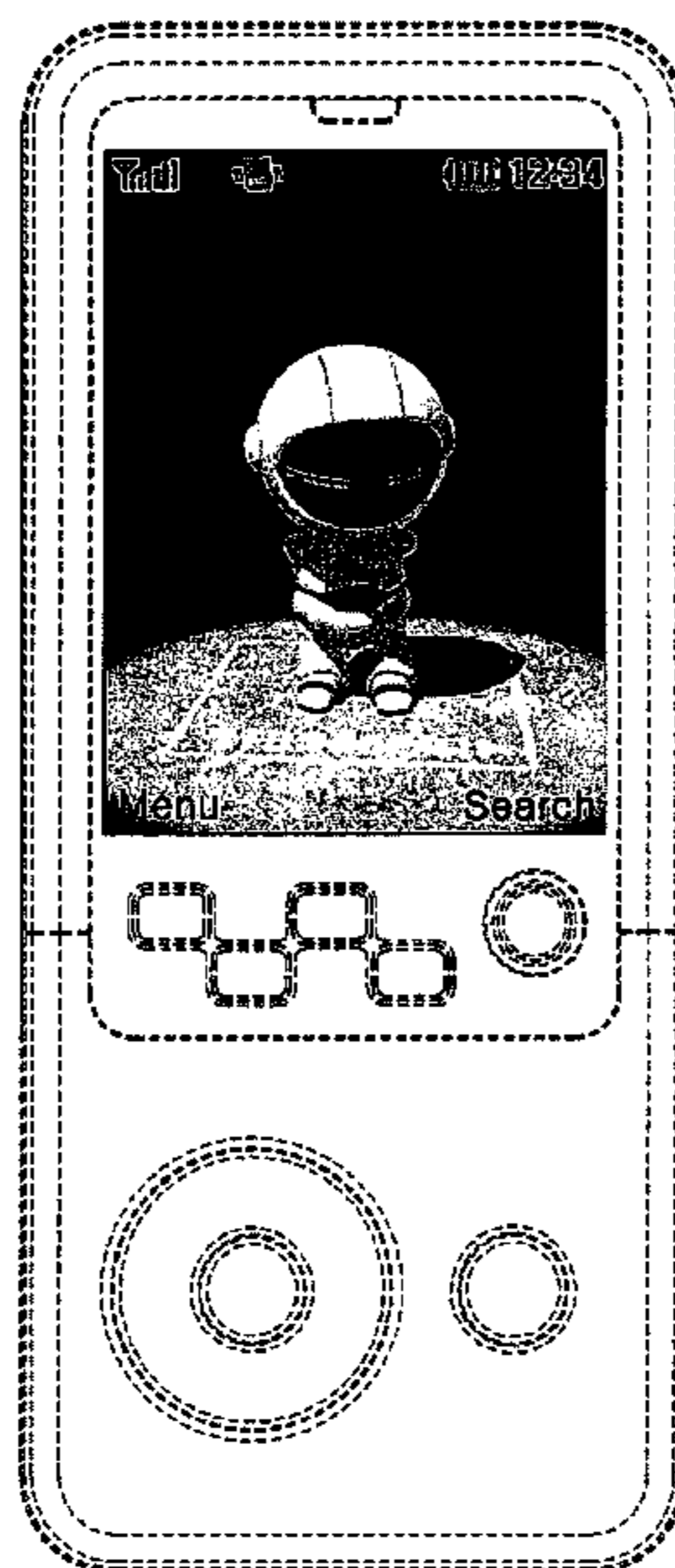

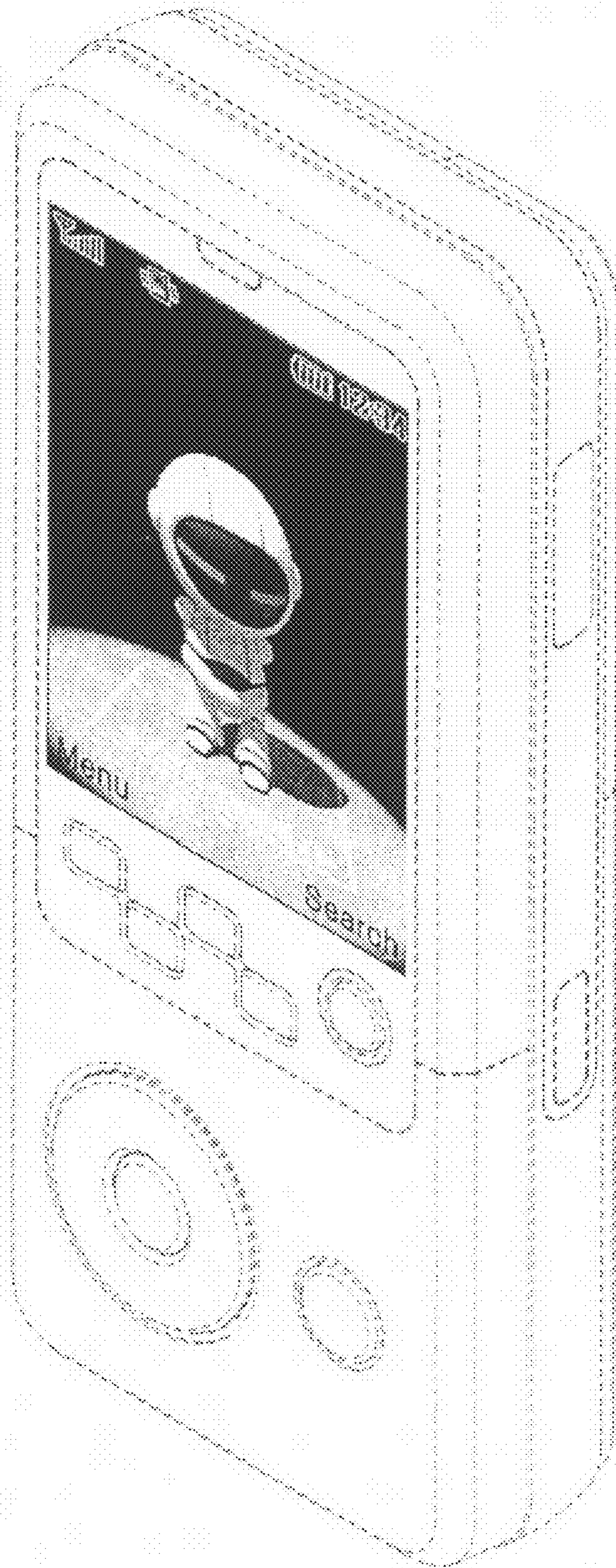

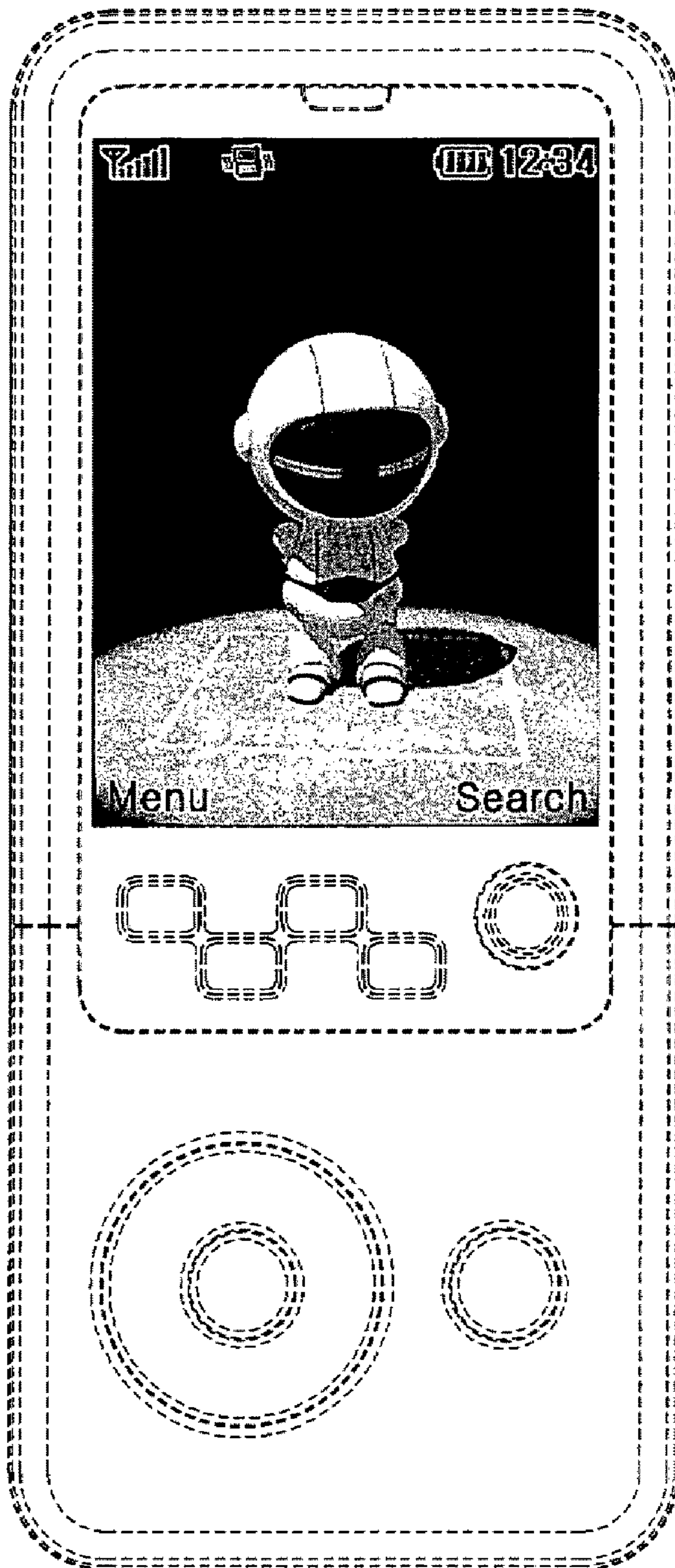

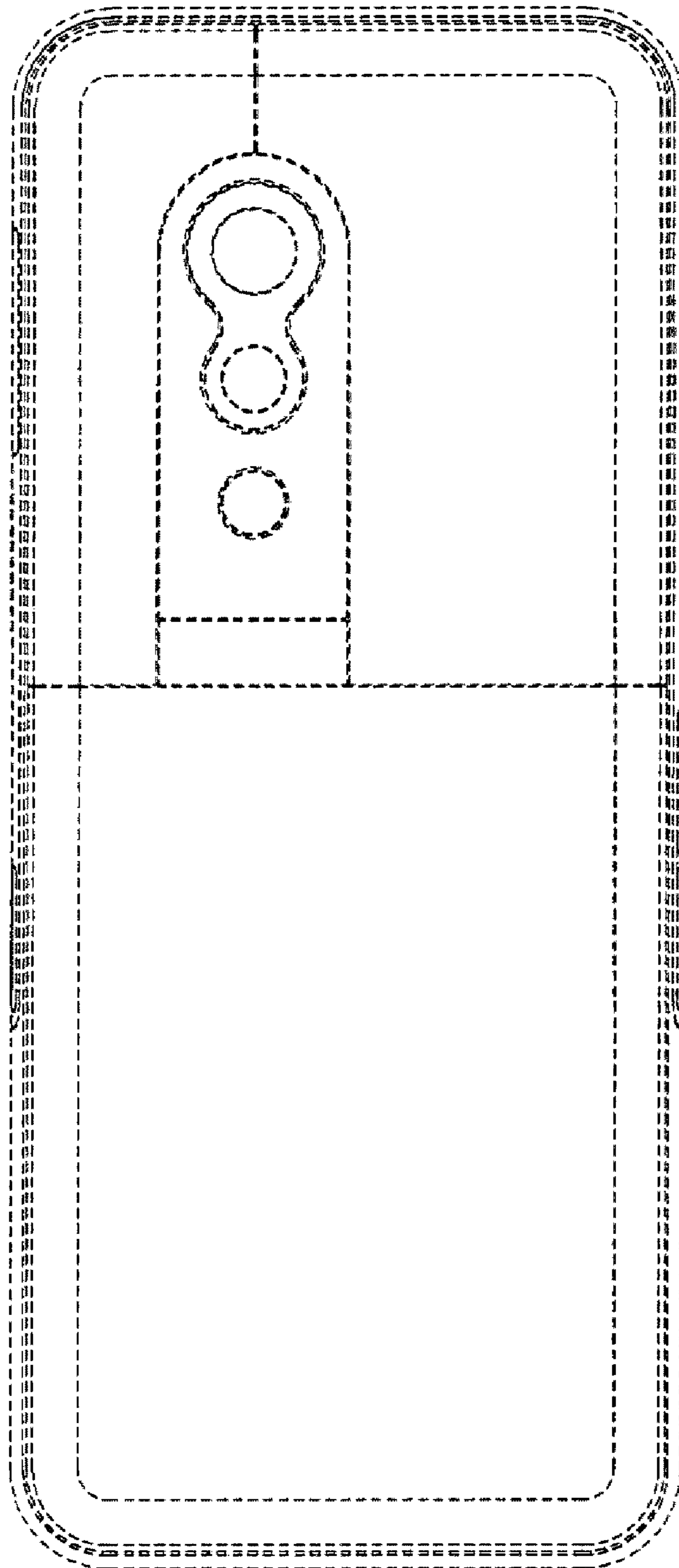

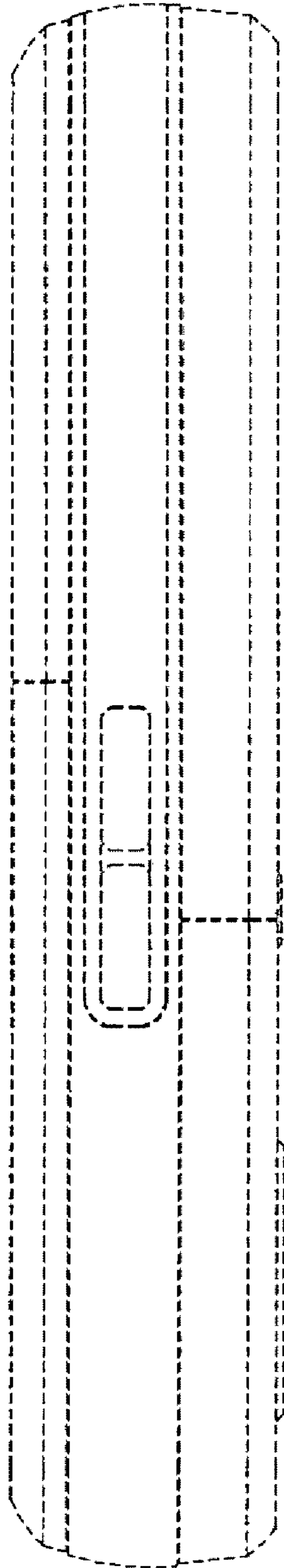

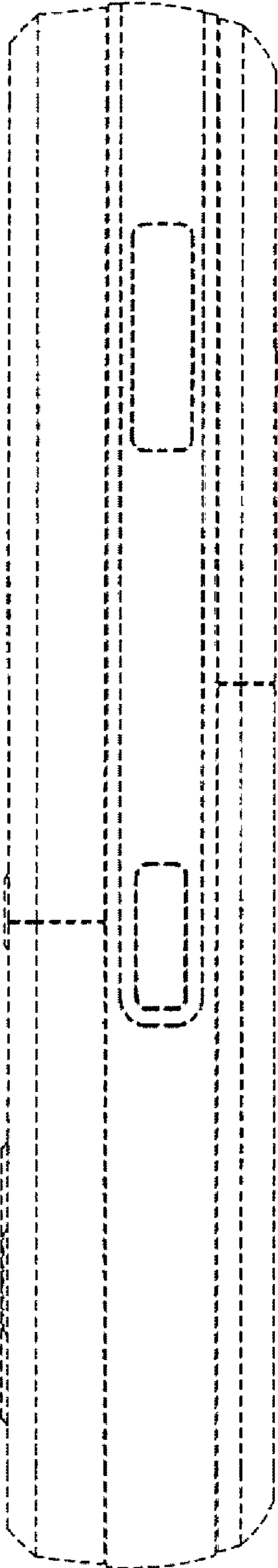

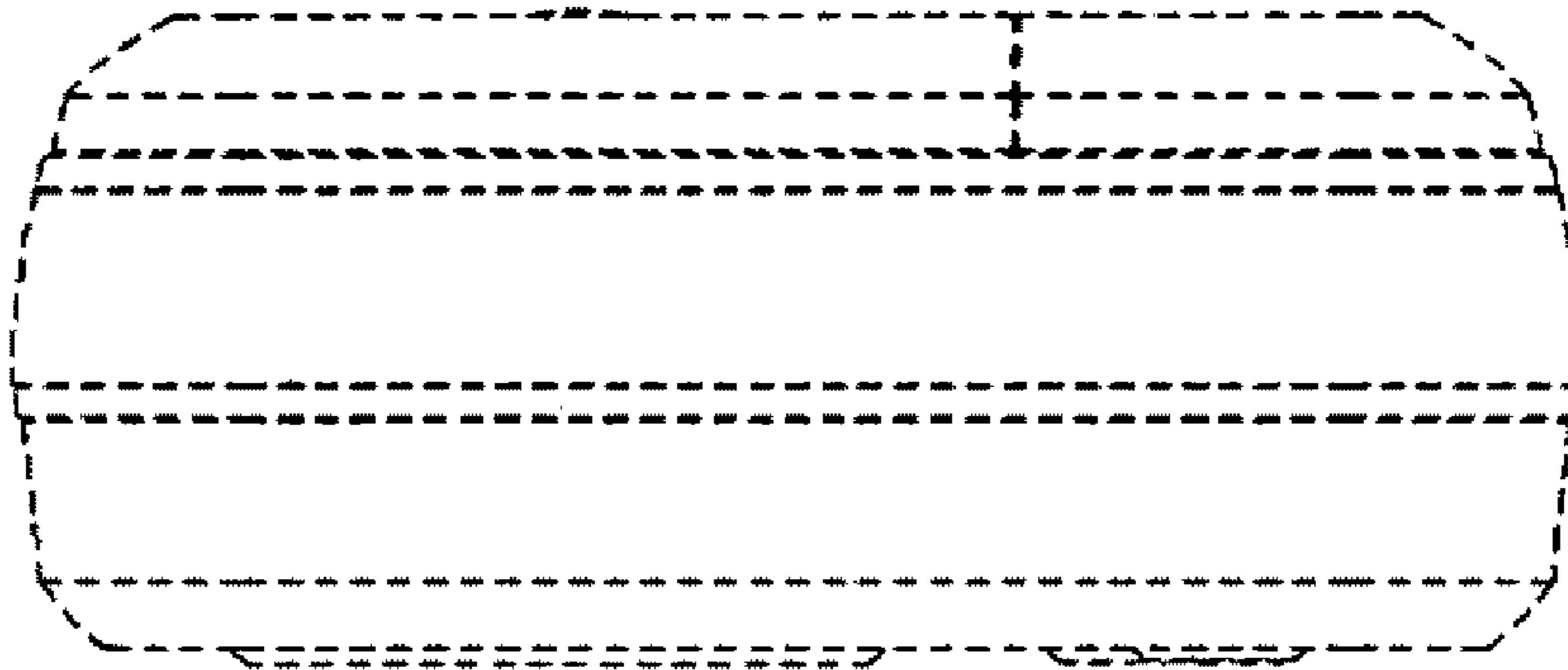
