**DESCRIPTION**

FIG. 9 is a rear elevation view thereof;

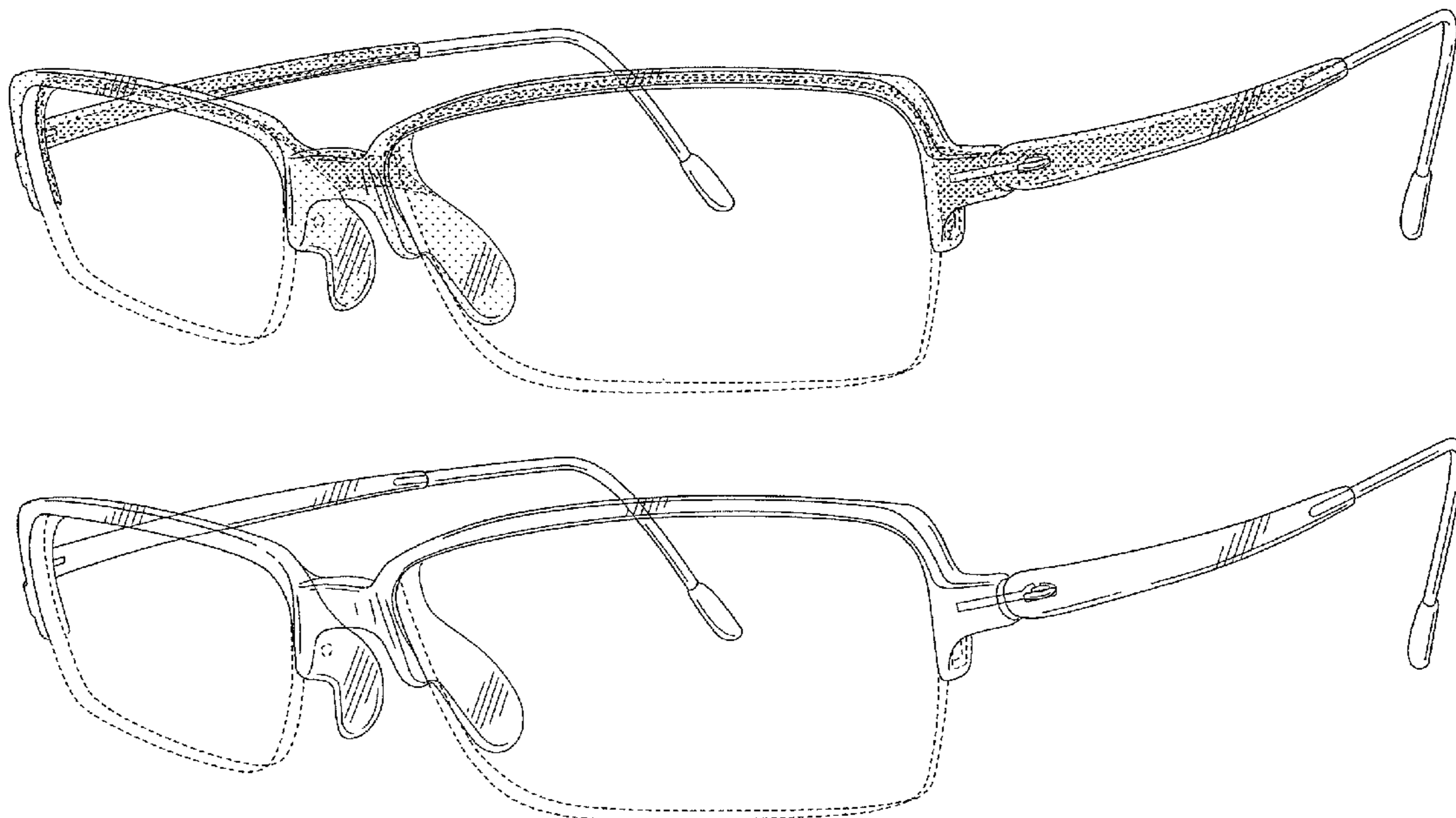
FIG. 10 is a top plan view thereof;

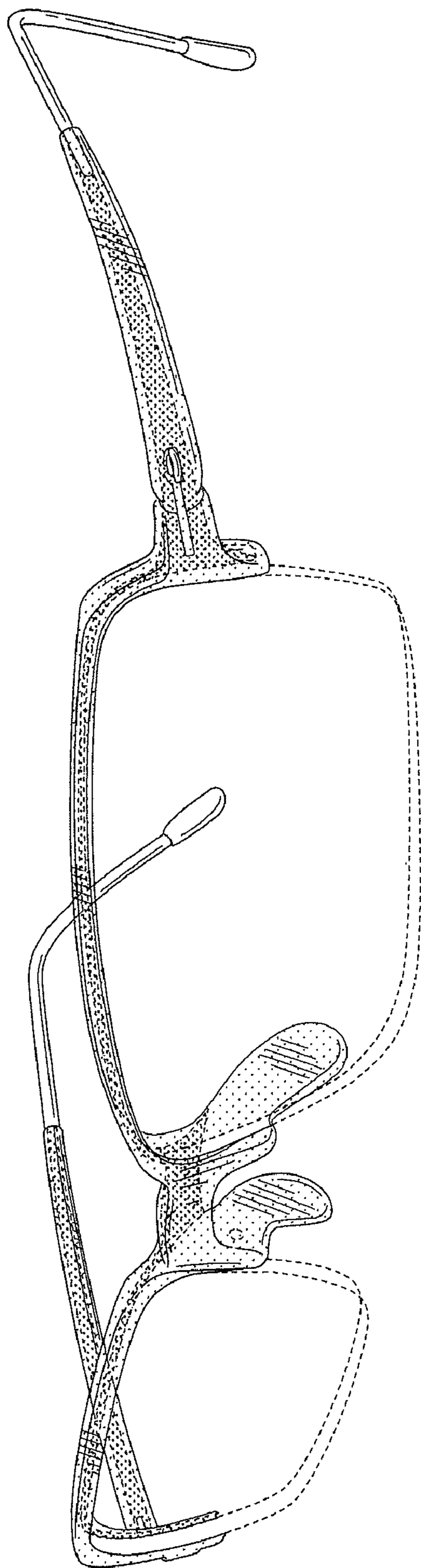
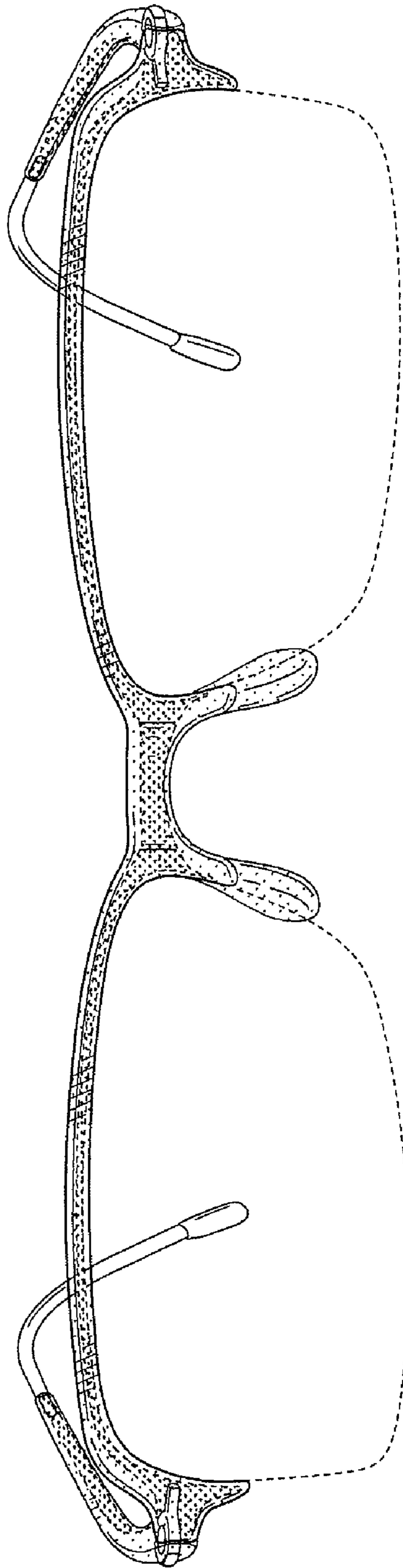

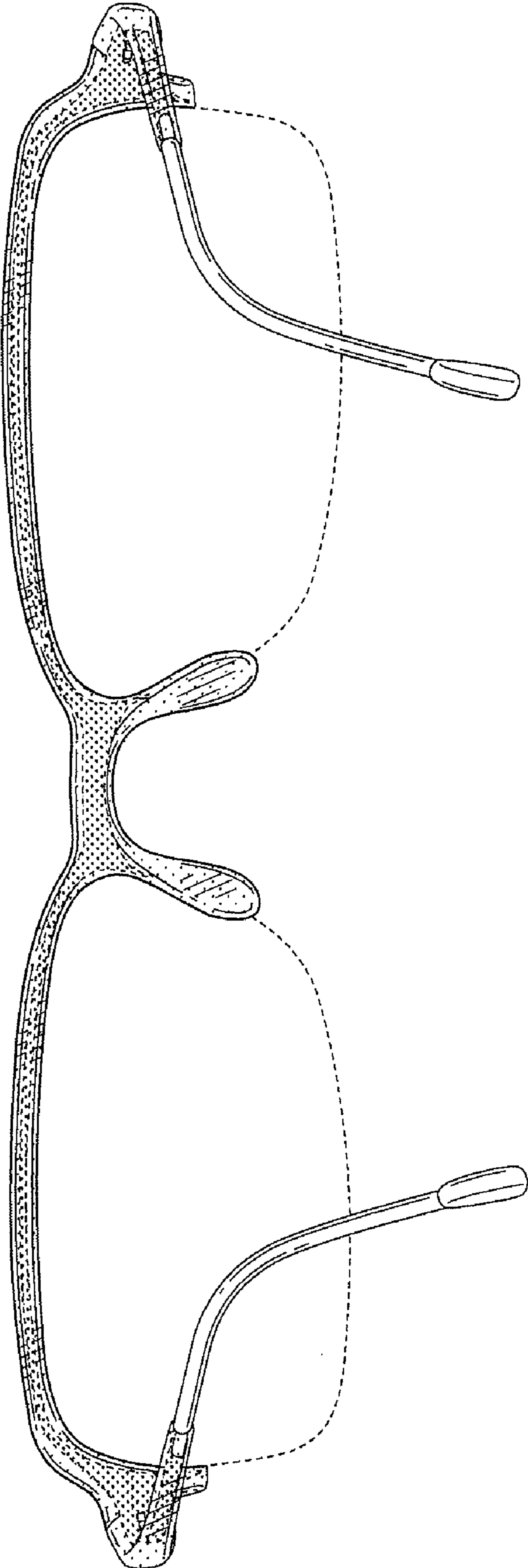

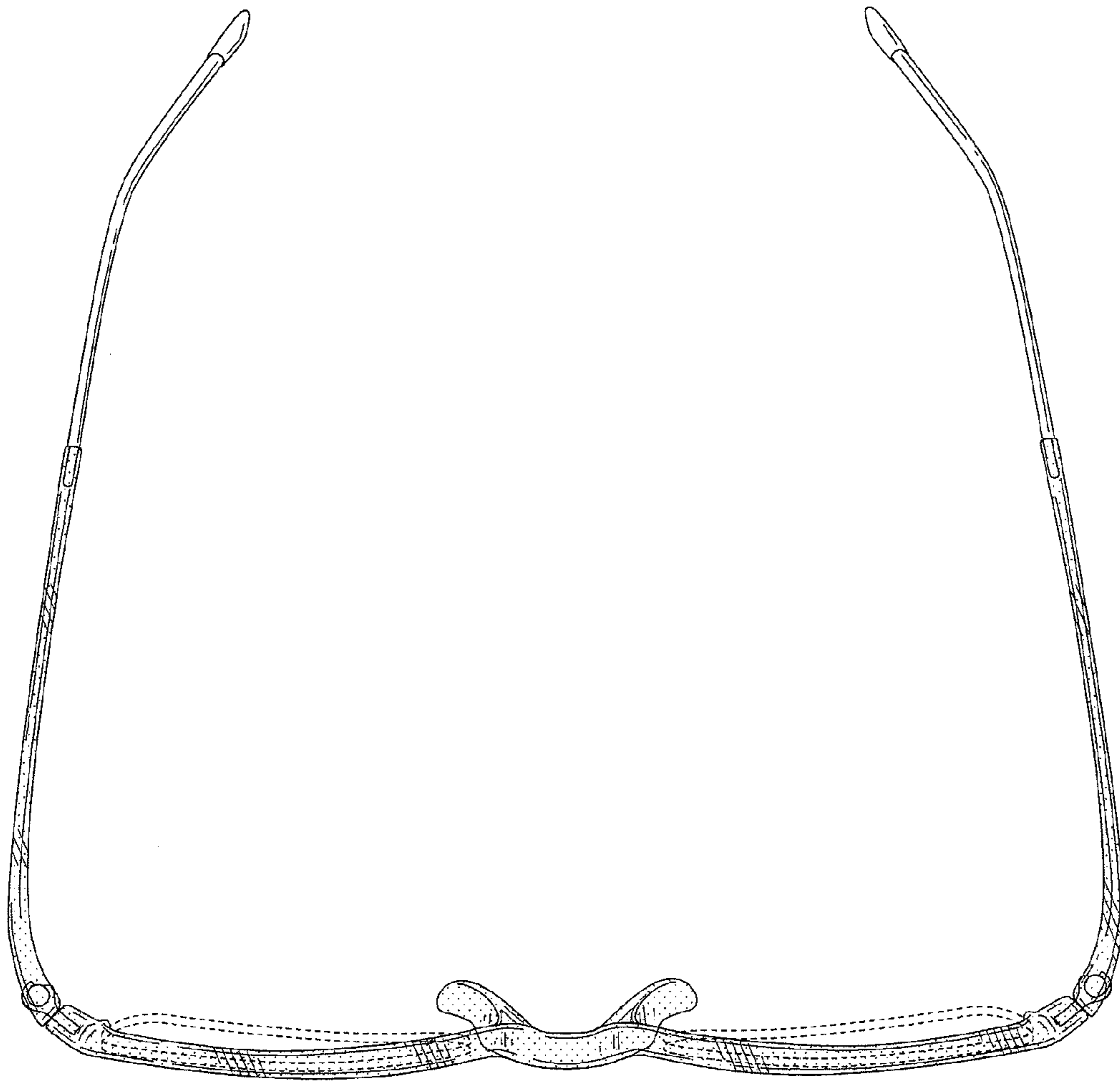

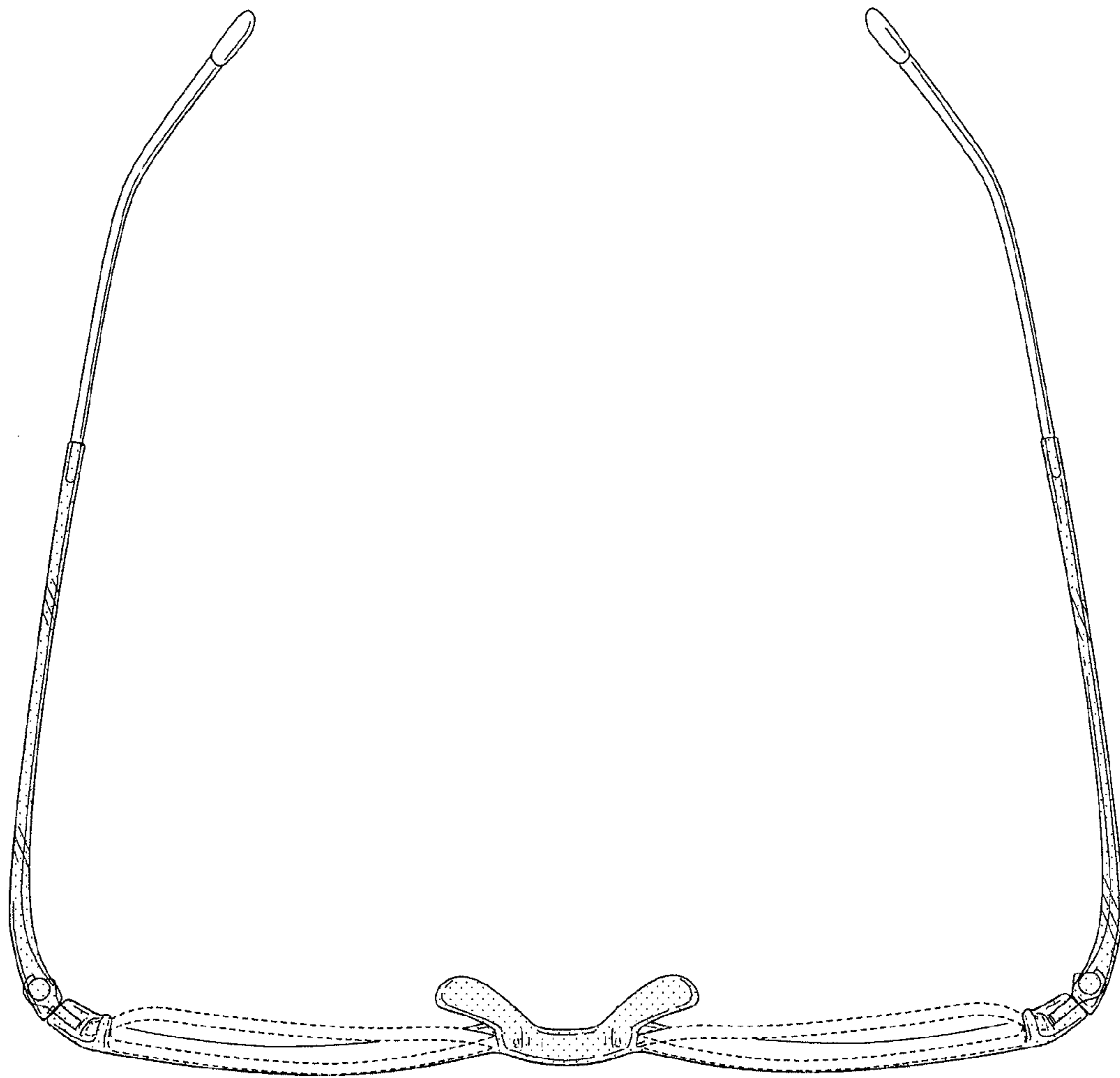

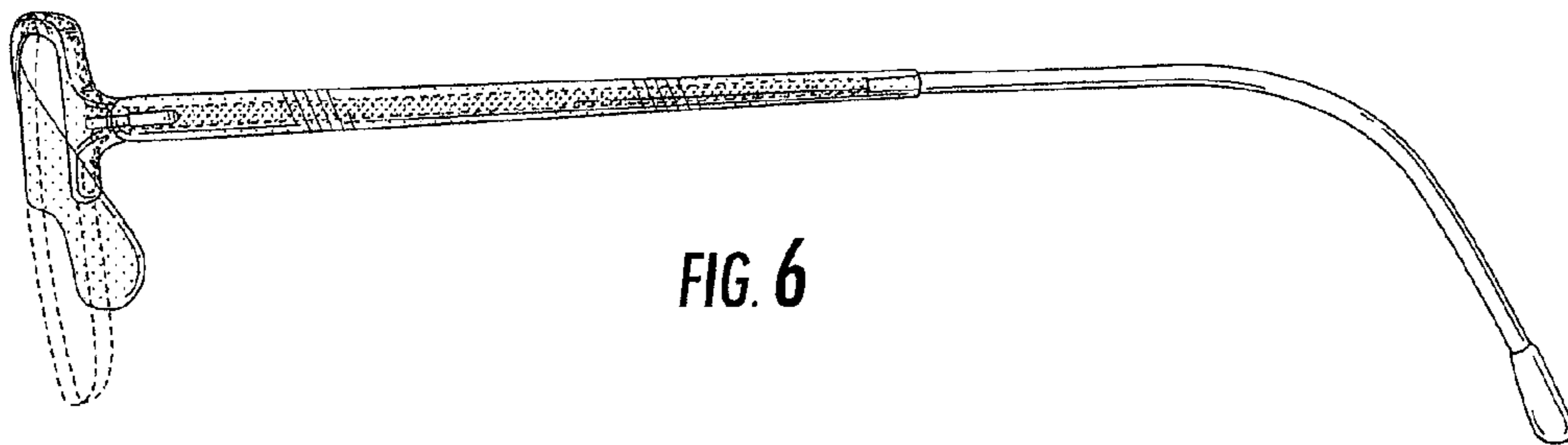

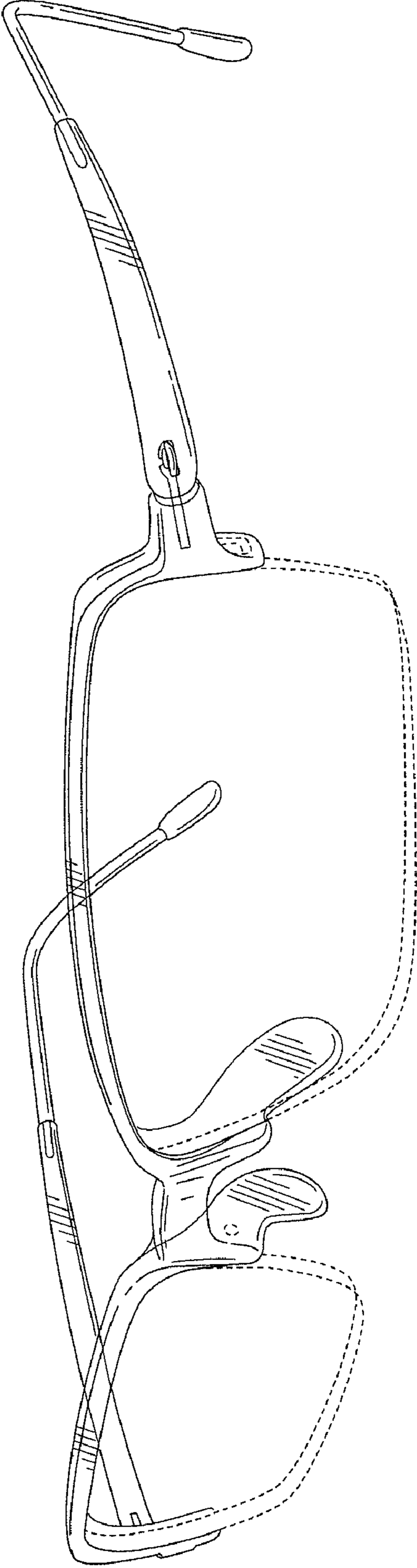

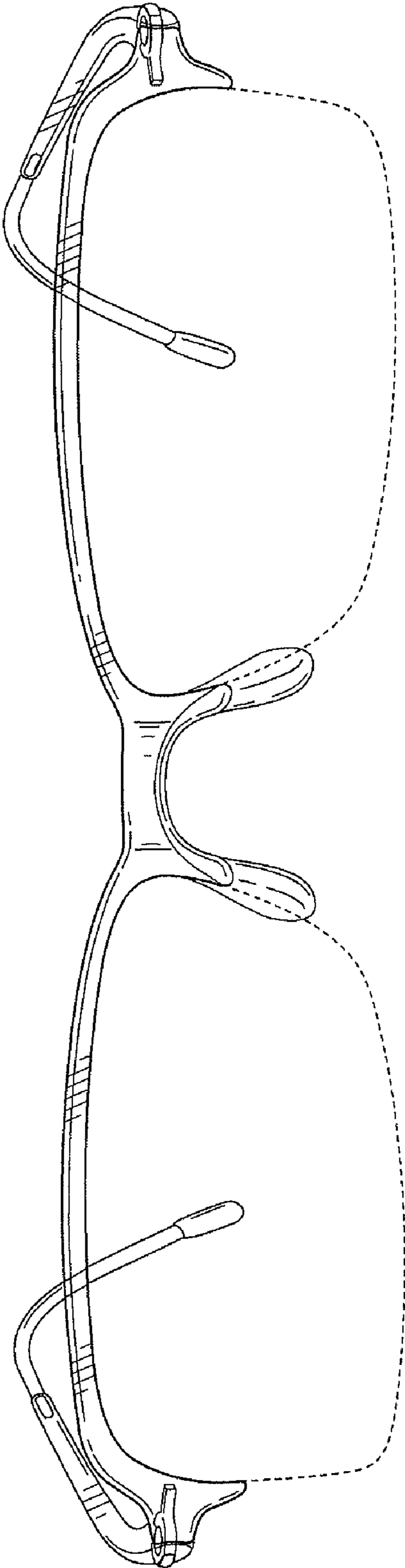

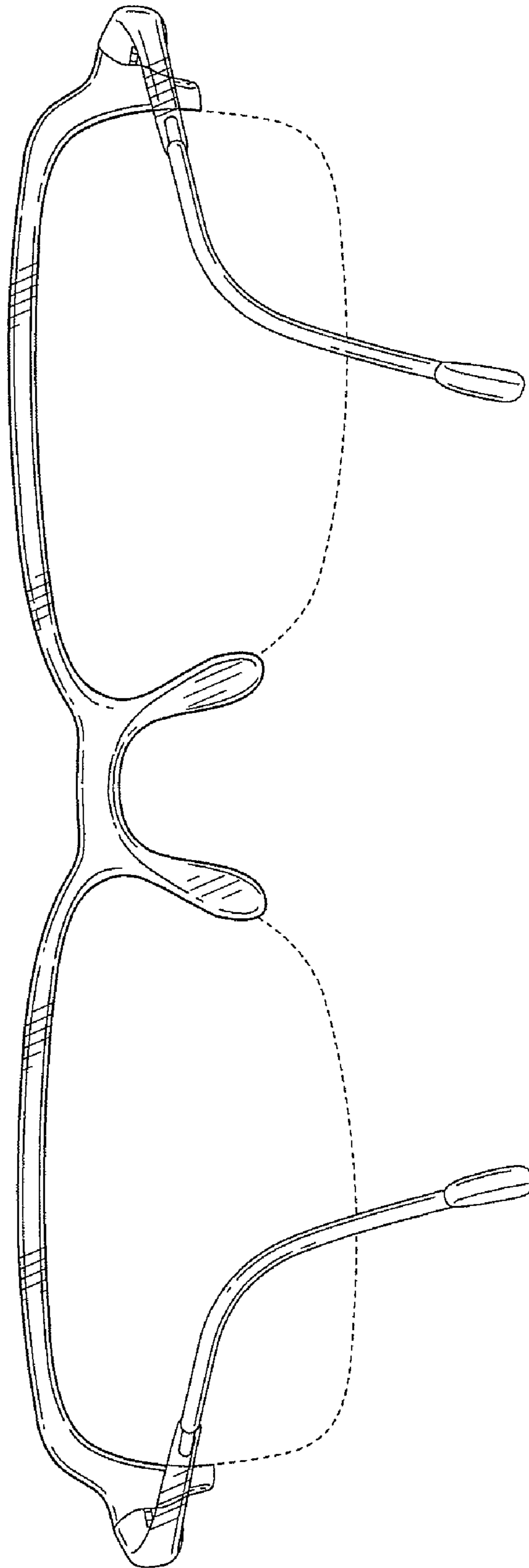

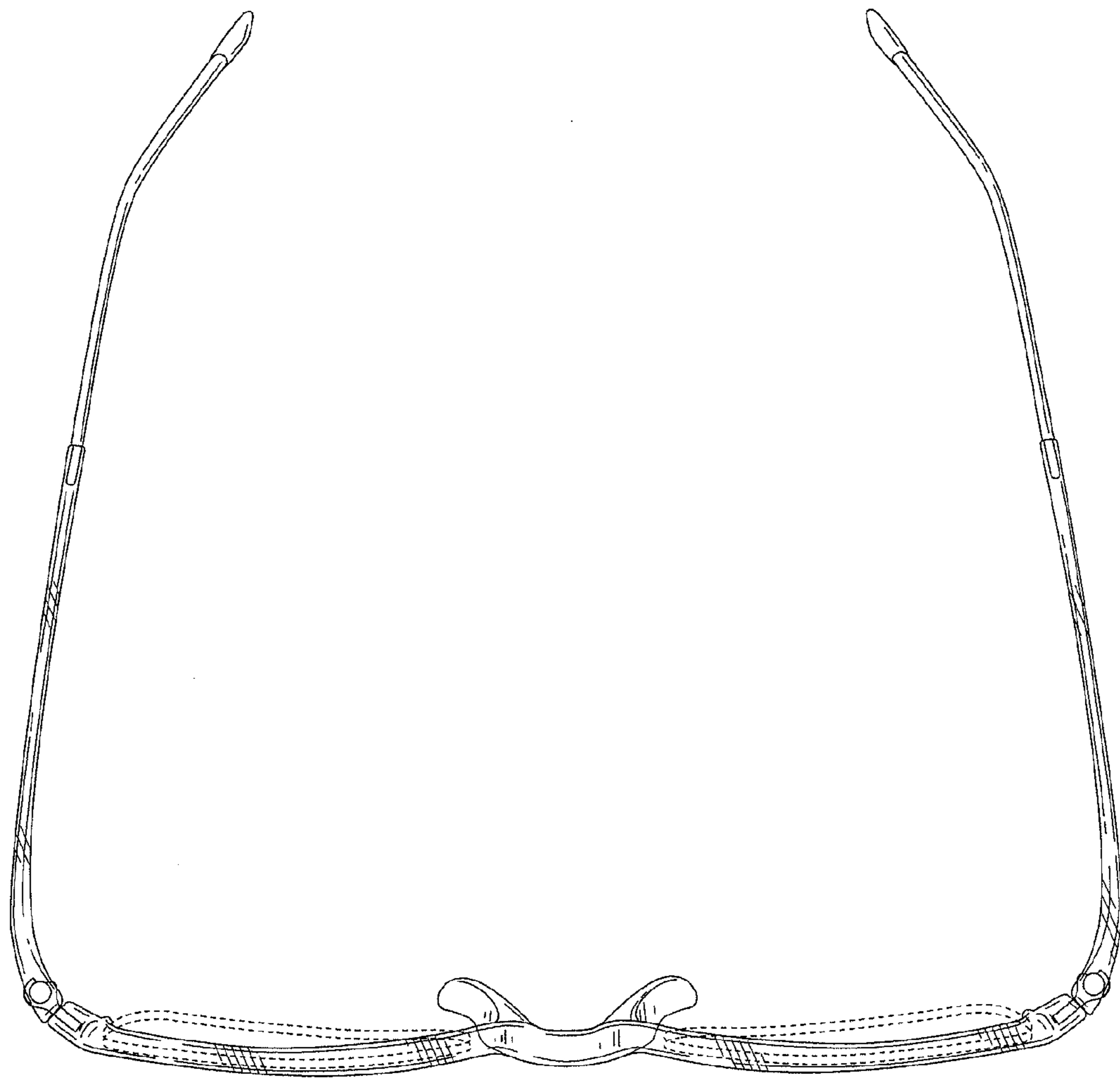

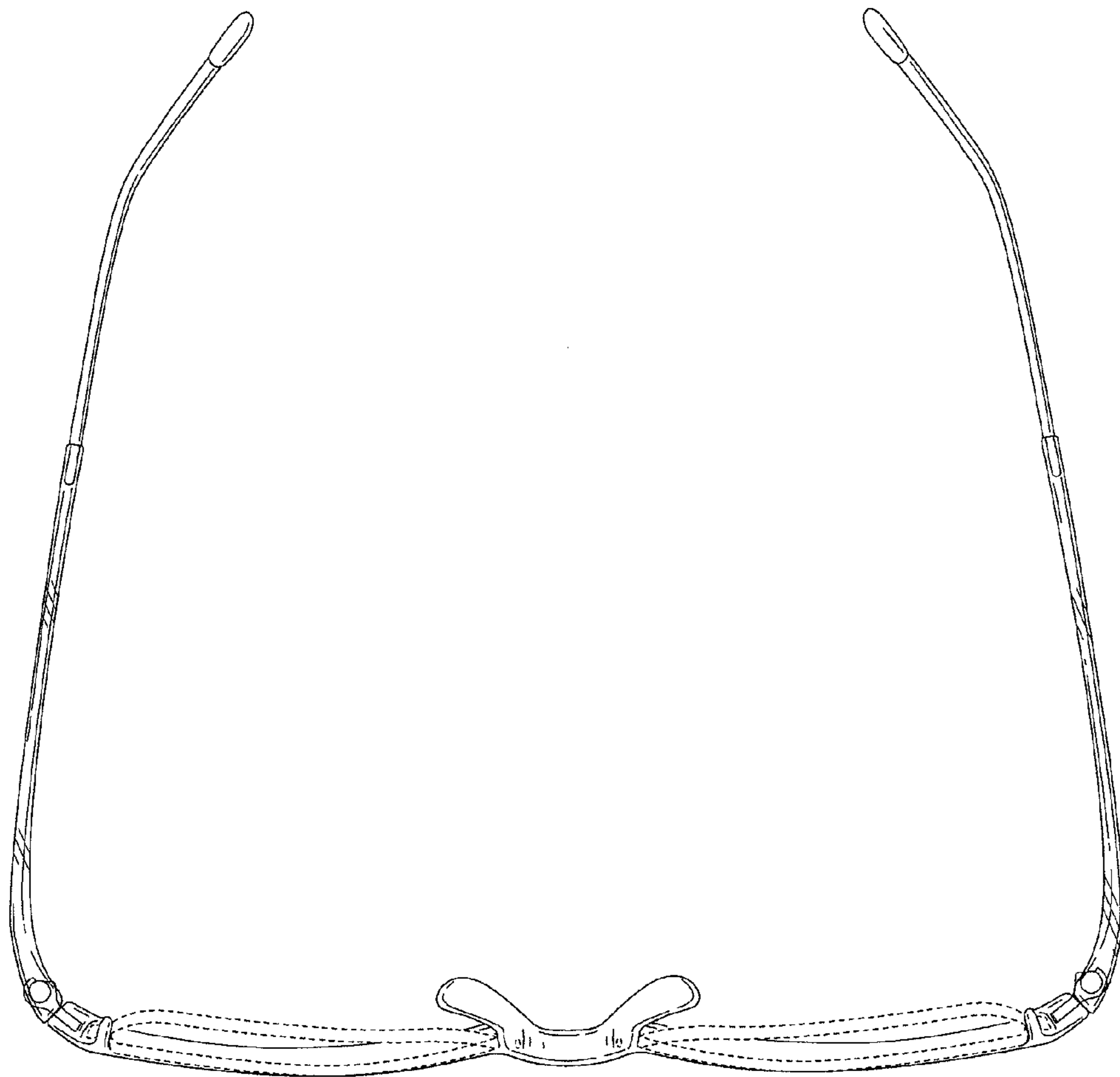

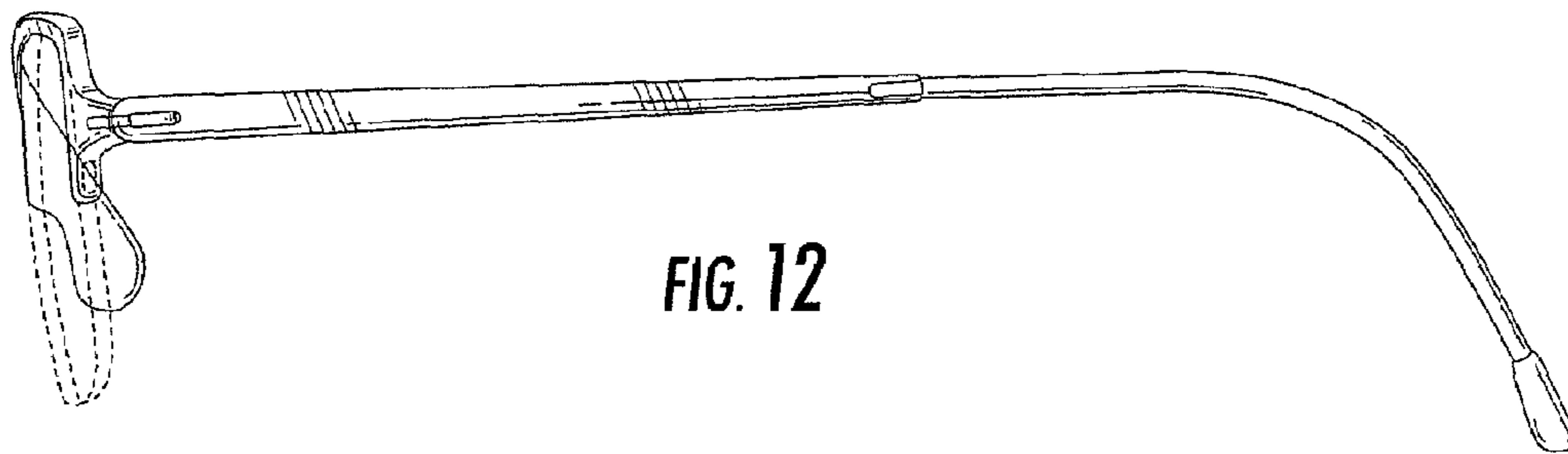
