FIG. 6 is an enlarged bottom plan view thereof;

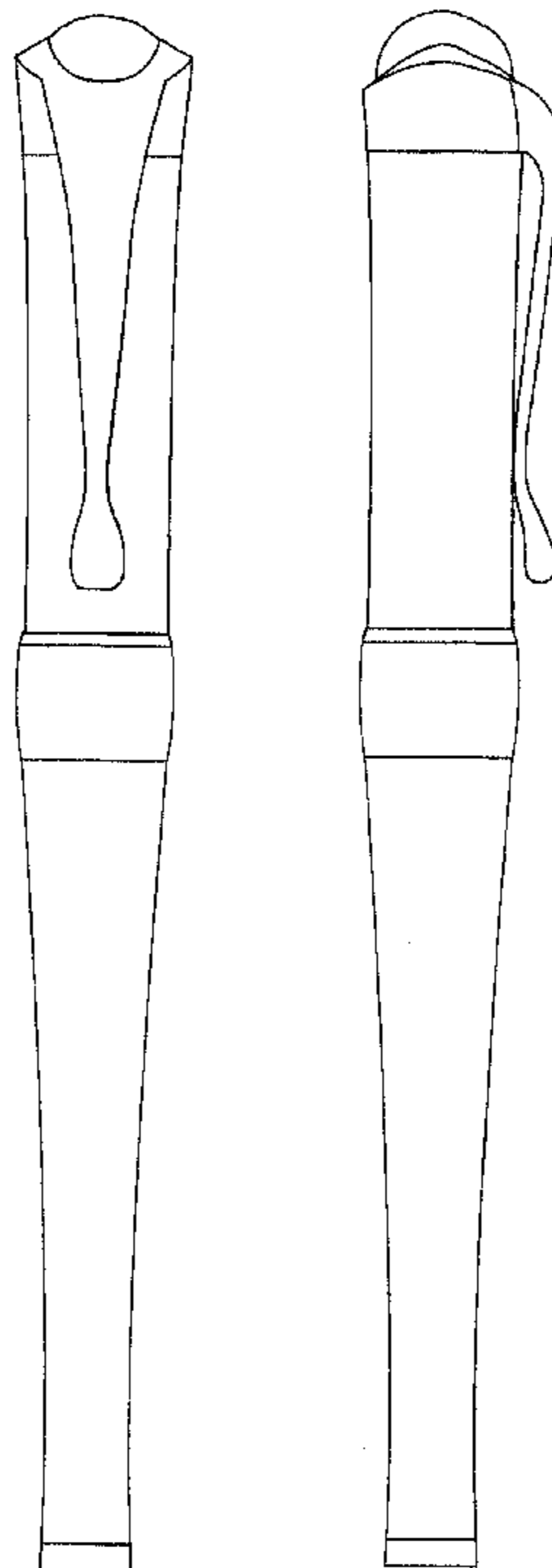
The broken lines showing the bottom of the fountain pen in FIG. 6 are included for the purpose of illustrating environment and form no part of the claimed design.

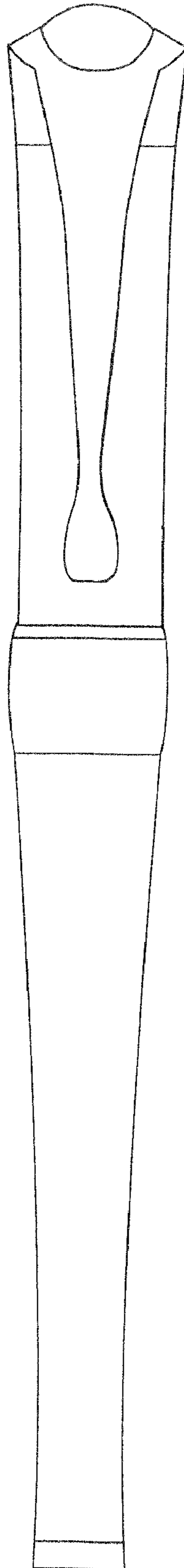

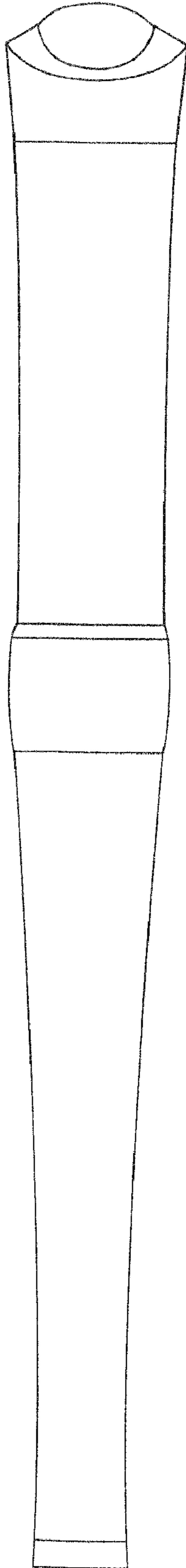

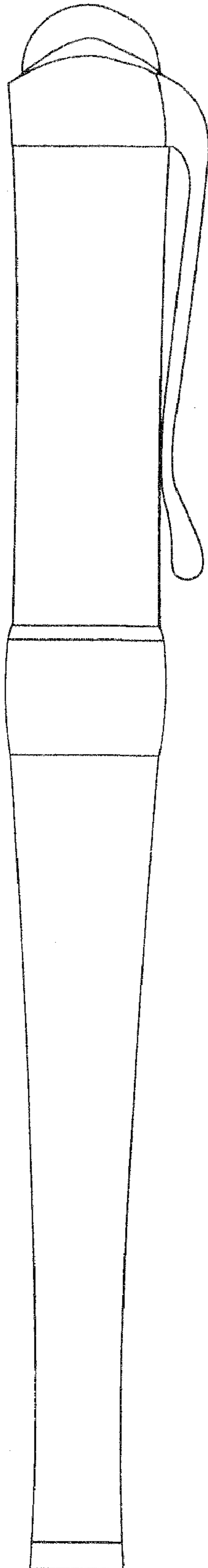

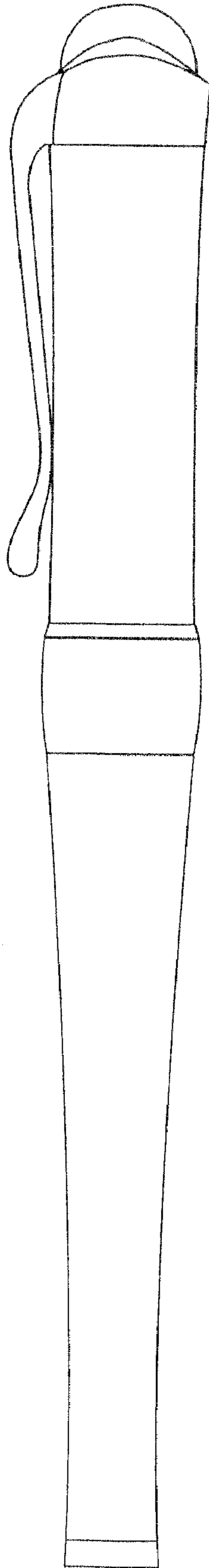

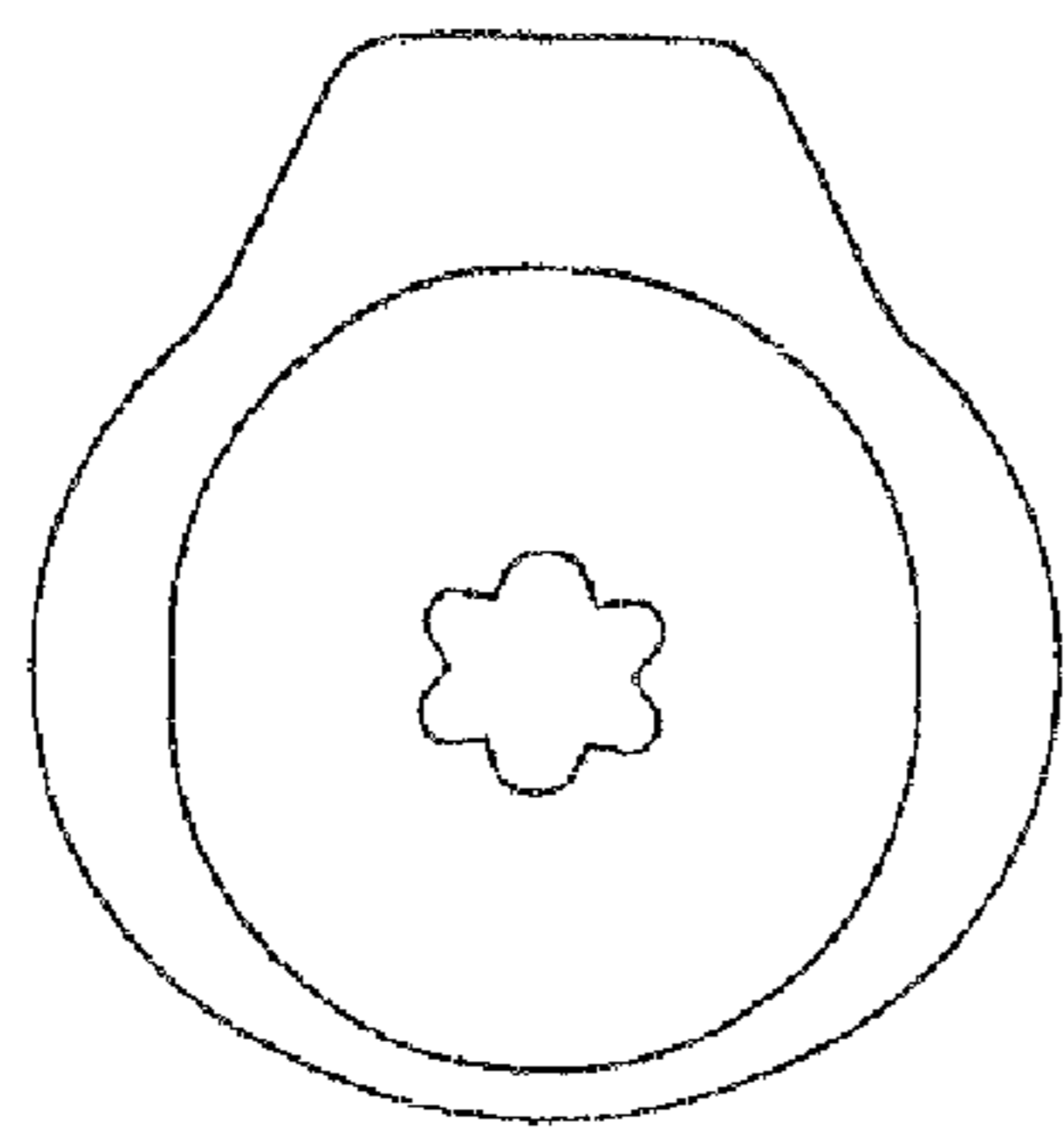

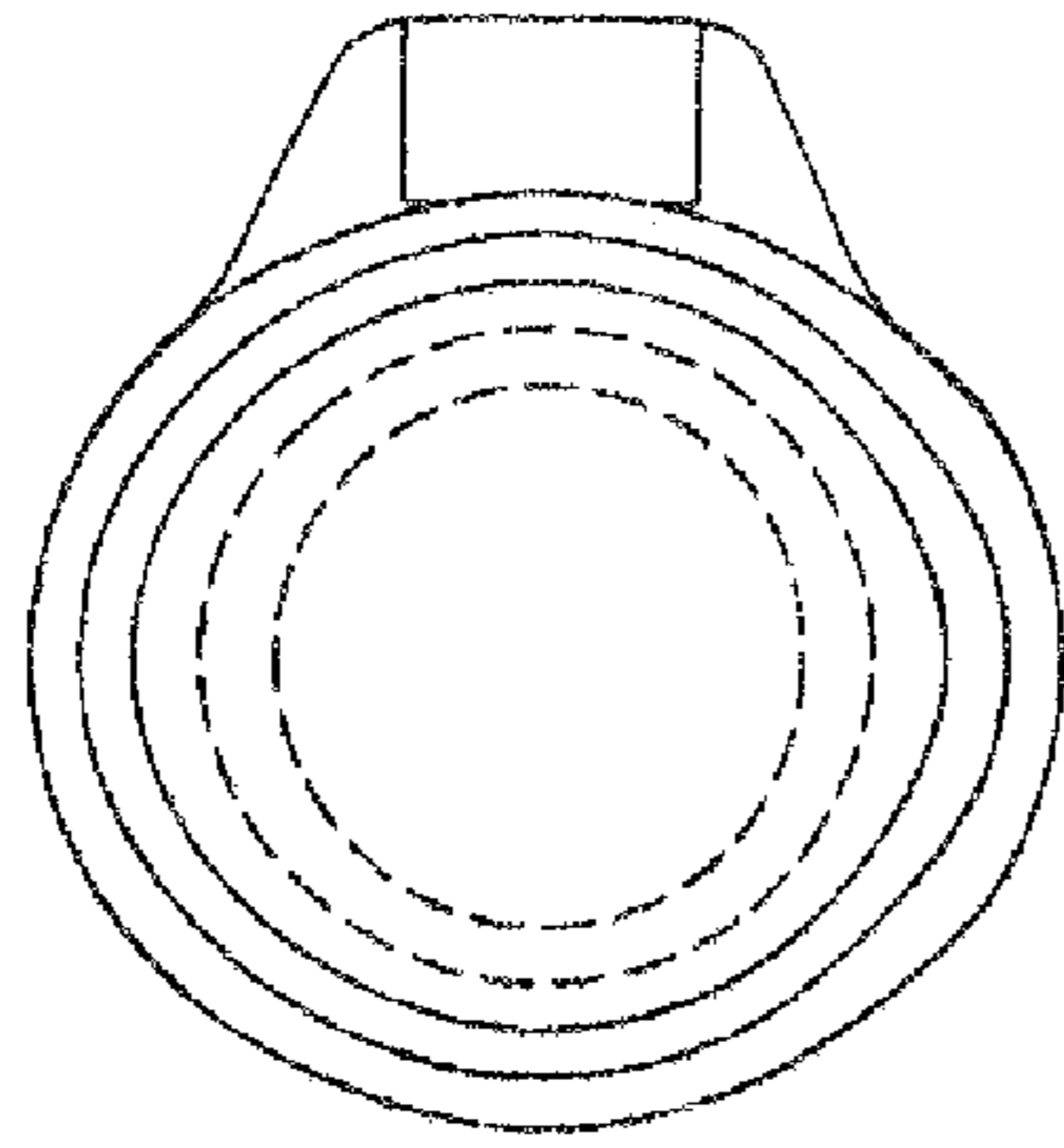
