The ornamental design for a hose section, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a hose section.

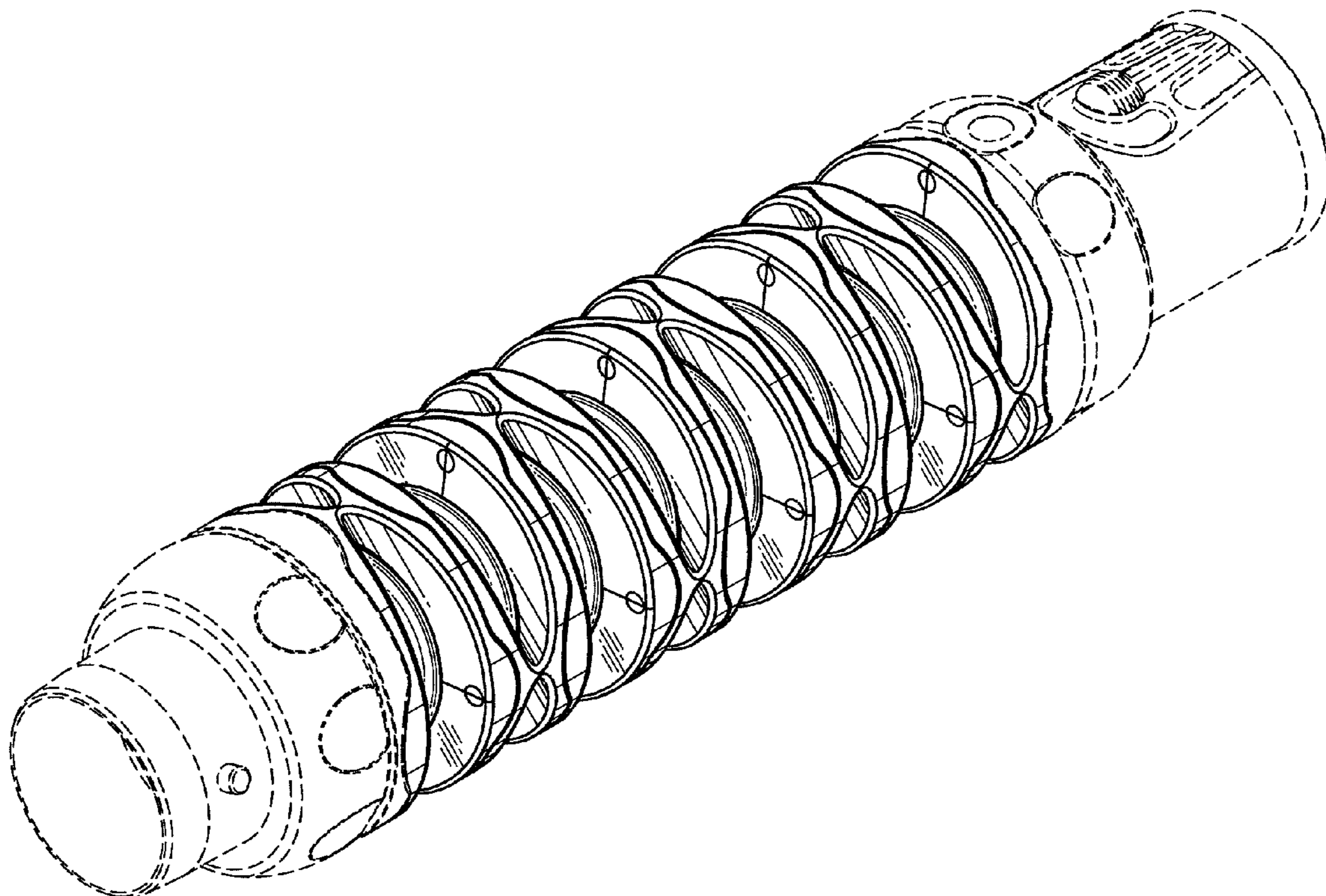
FIG. 2 shows another perspective view of the hose section shown in FIG. 1.

FIG. 3 shows a top view of the hose section shown in FIG. 1, the bottom view being a mirror image of the top view; and,

FIG. 4 shows a right side elevation view of the hose section shown in FIG. 1, the left side elevation view being a mirror image of the right side elevation view.

Portions or features of the hose section not shown in the drawings form no part of the claimed design. Portions of features of the hose section shown in broken lines in the drawings form no part of the claimed design.

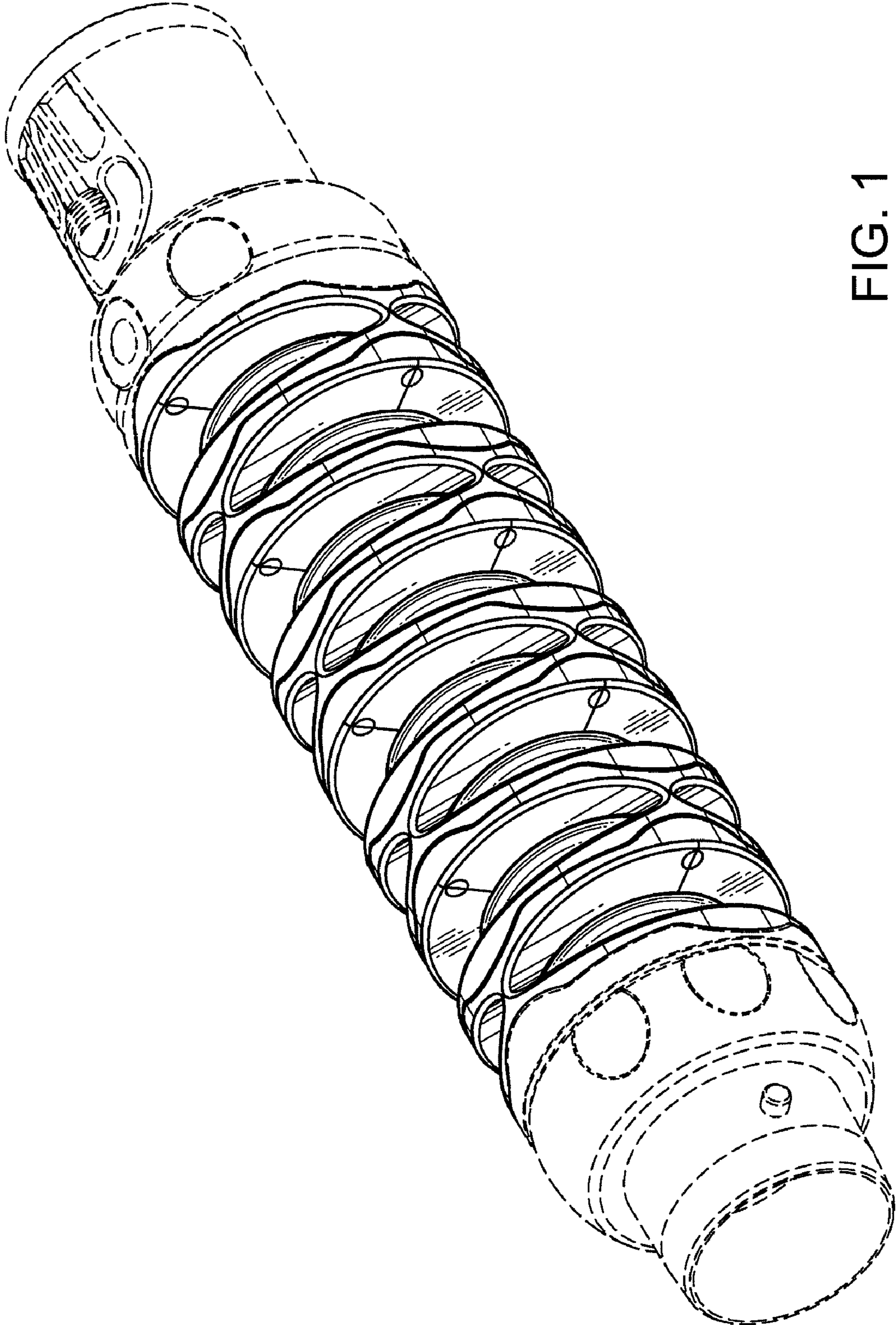

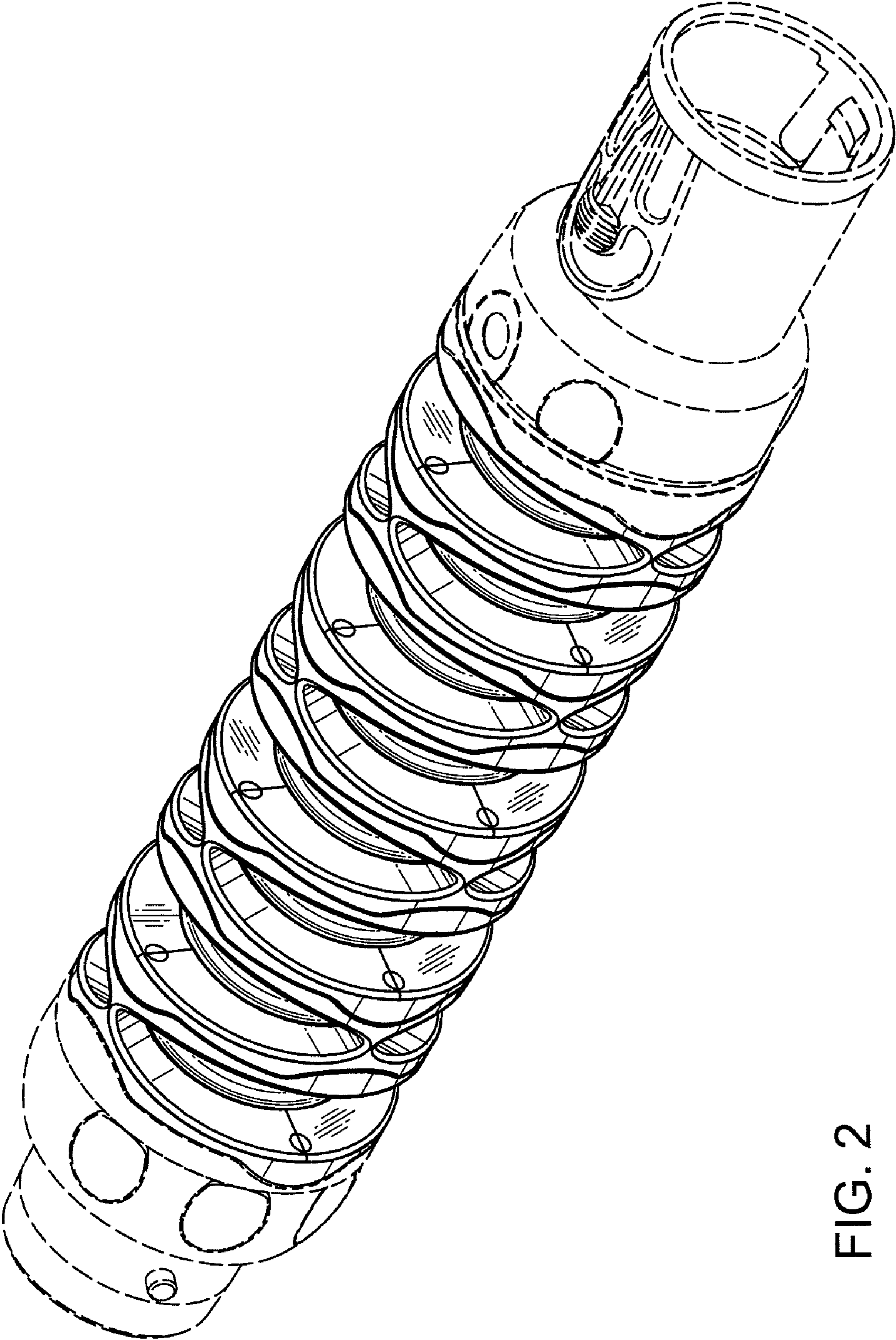

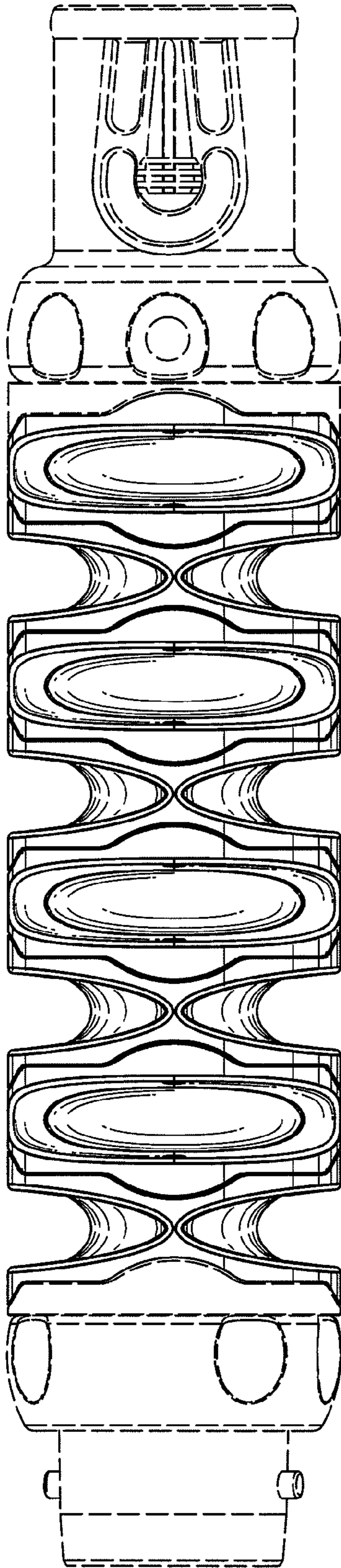

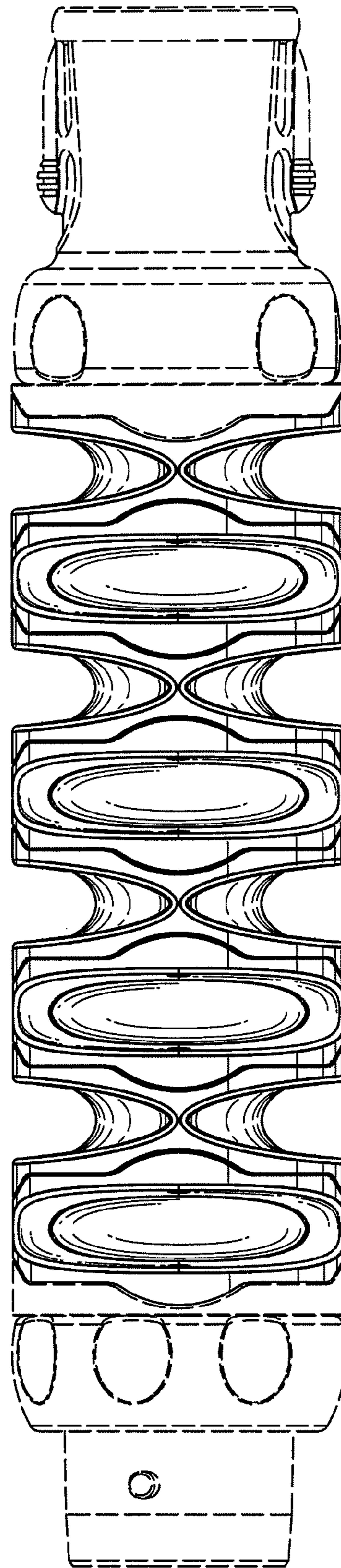
