FIG. 4 is an outer side elevation view thereof.

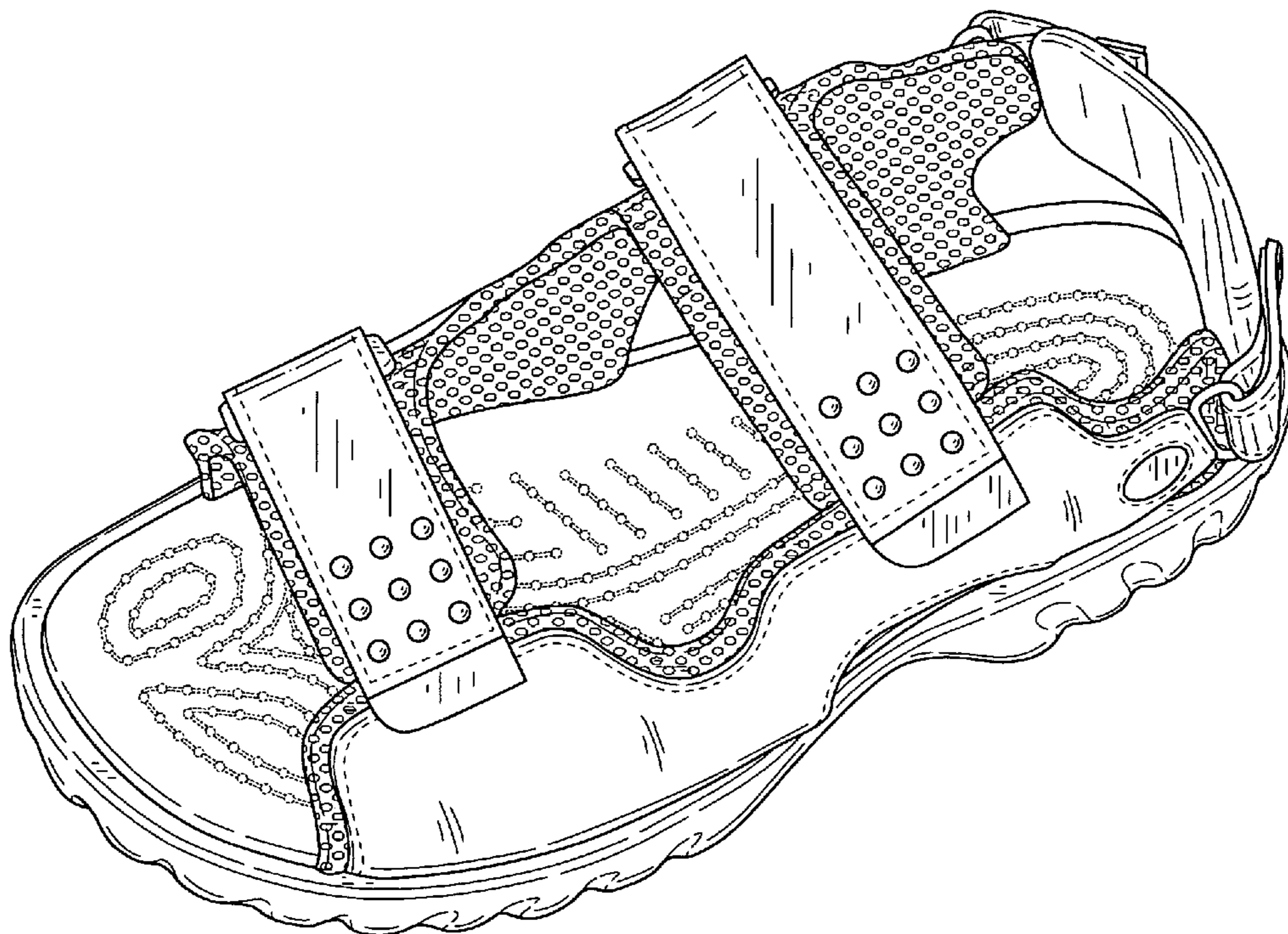
FIG. 5 is an inner side elevation view thereof.

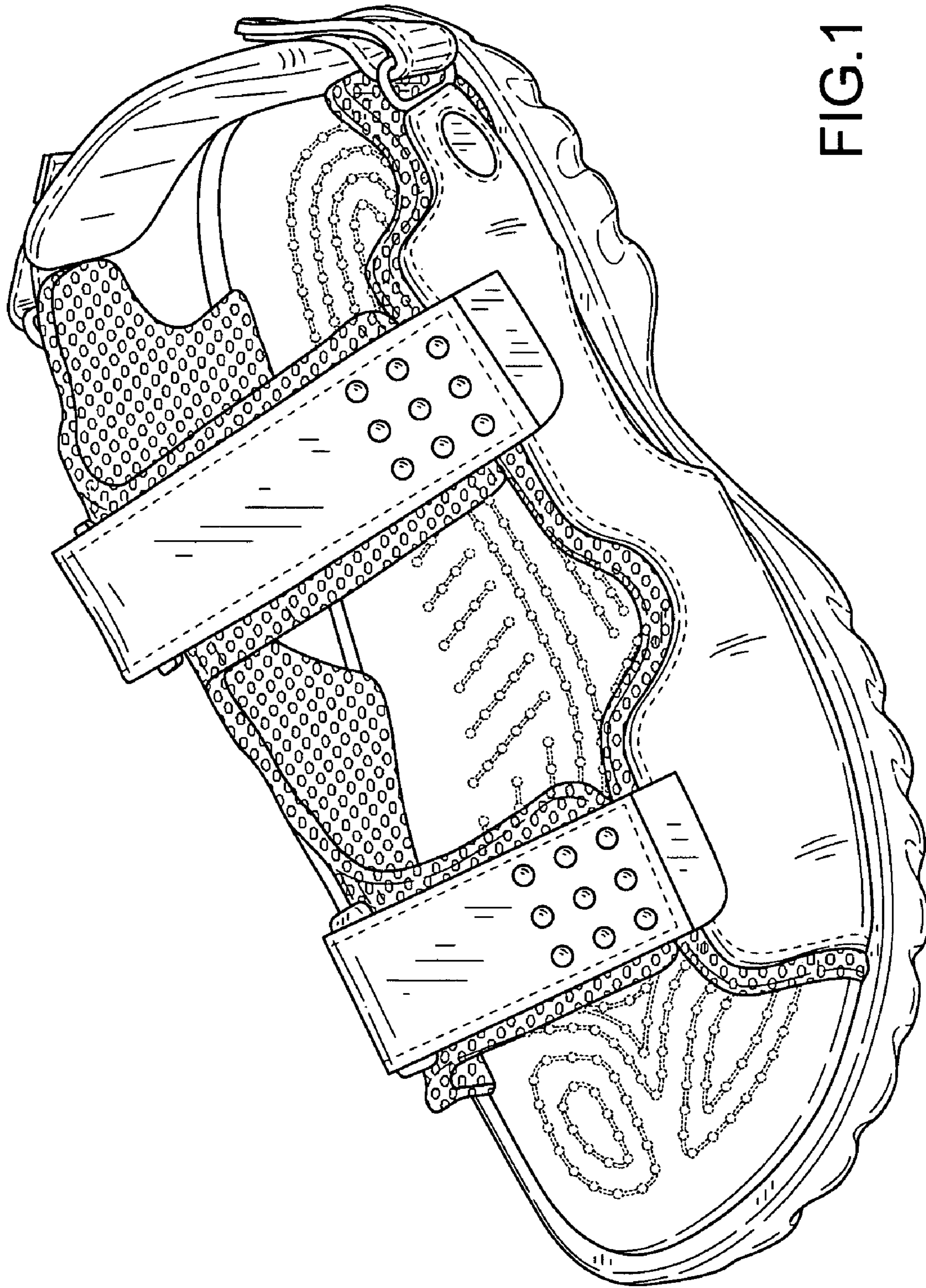

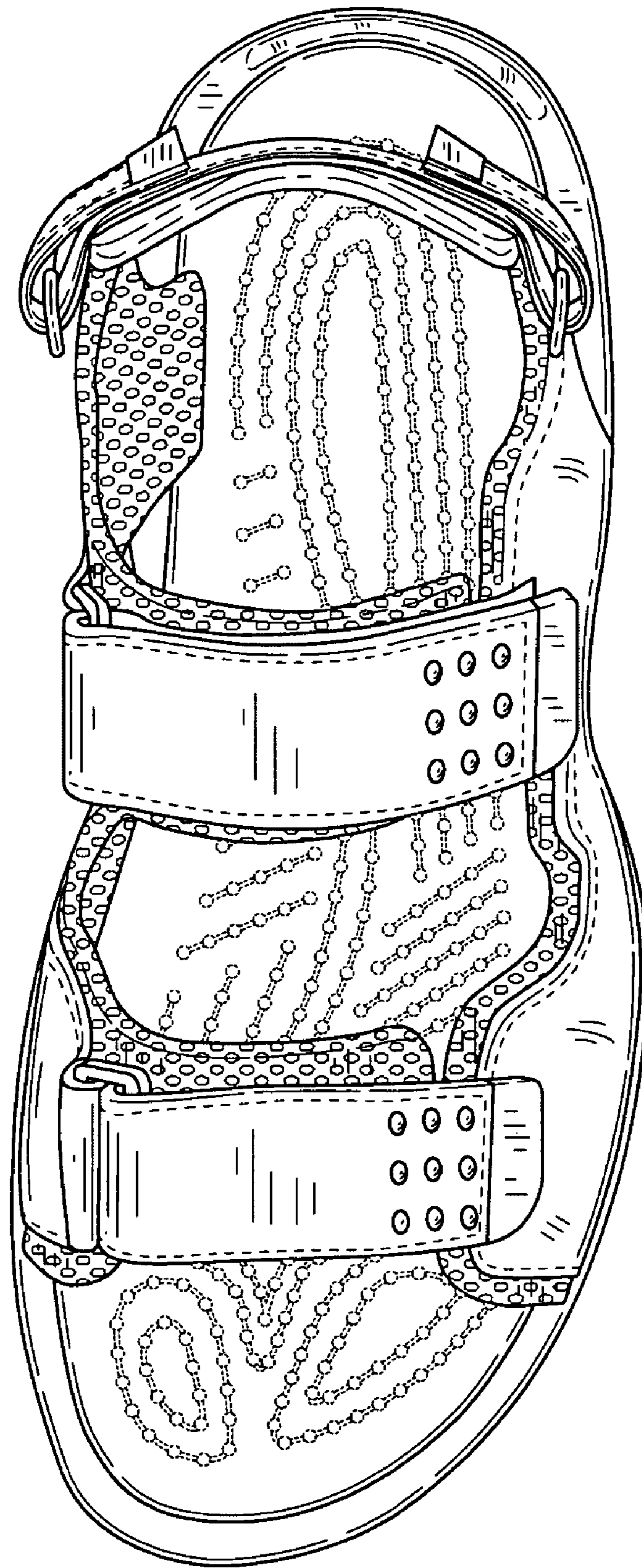

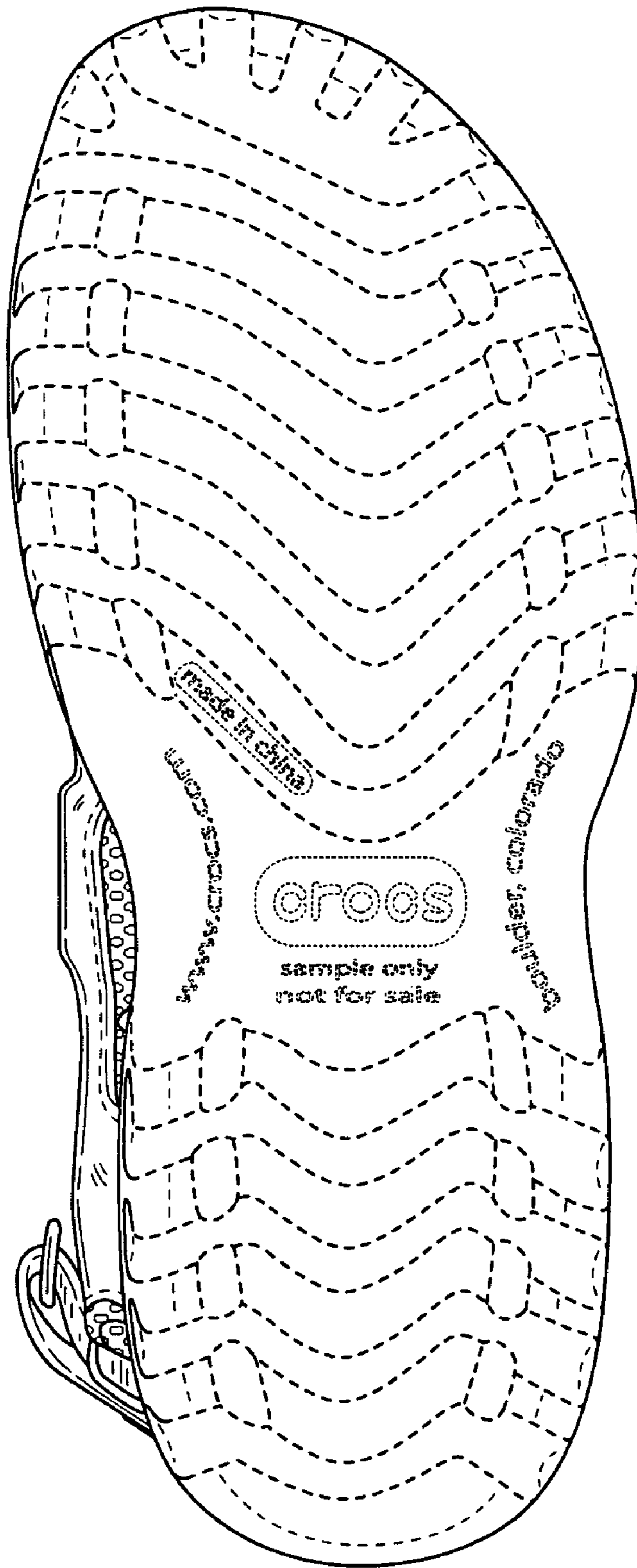

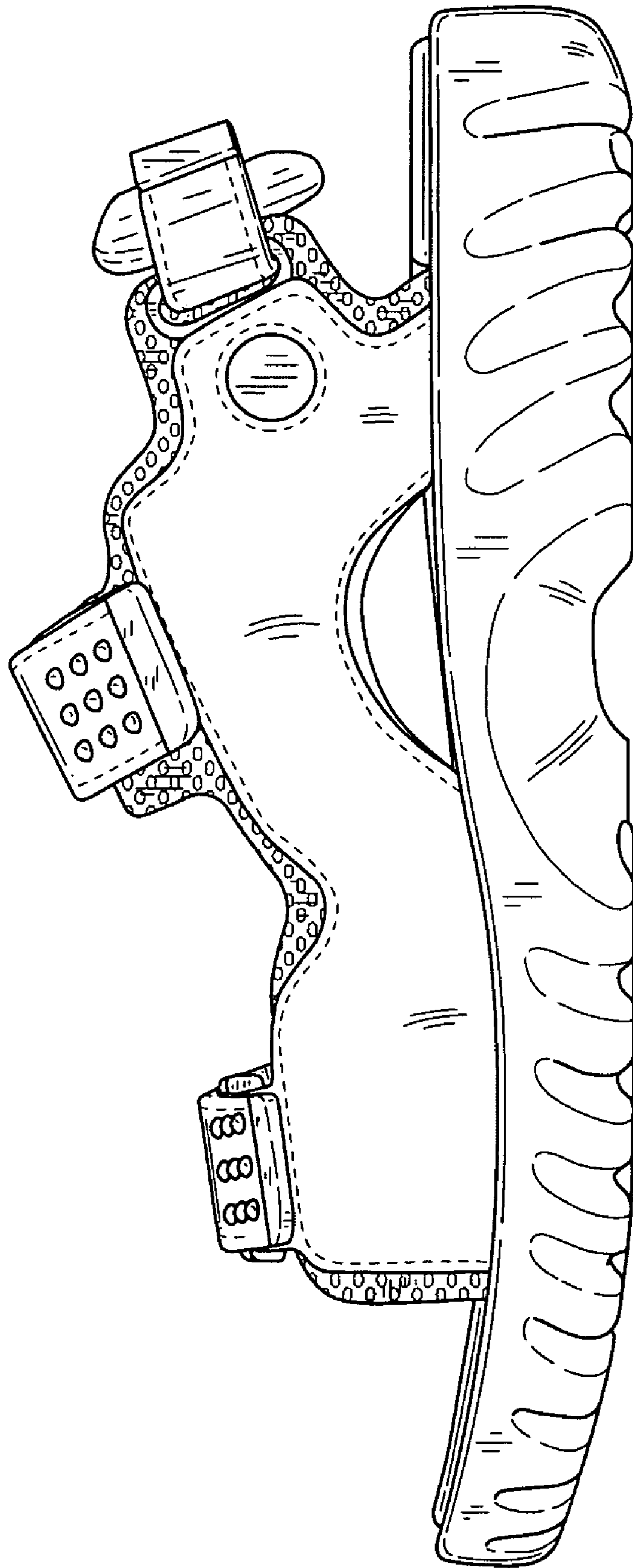

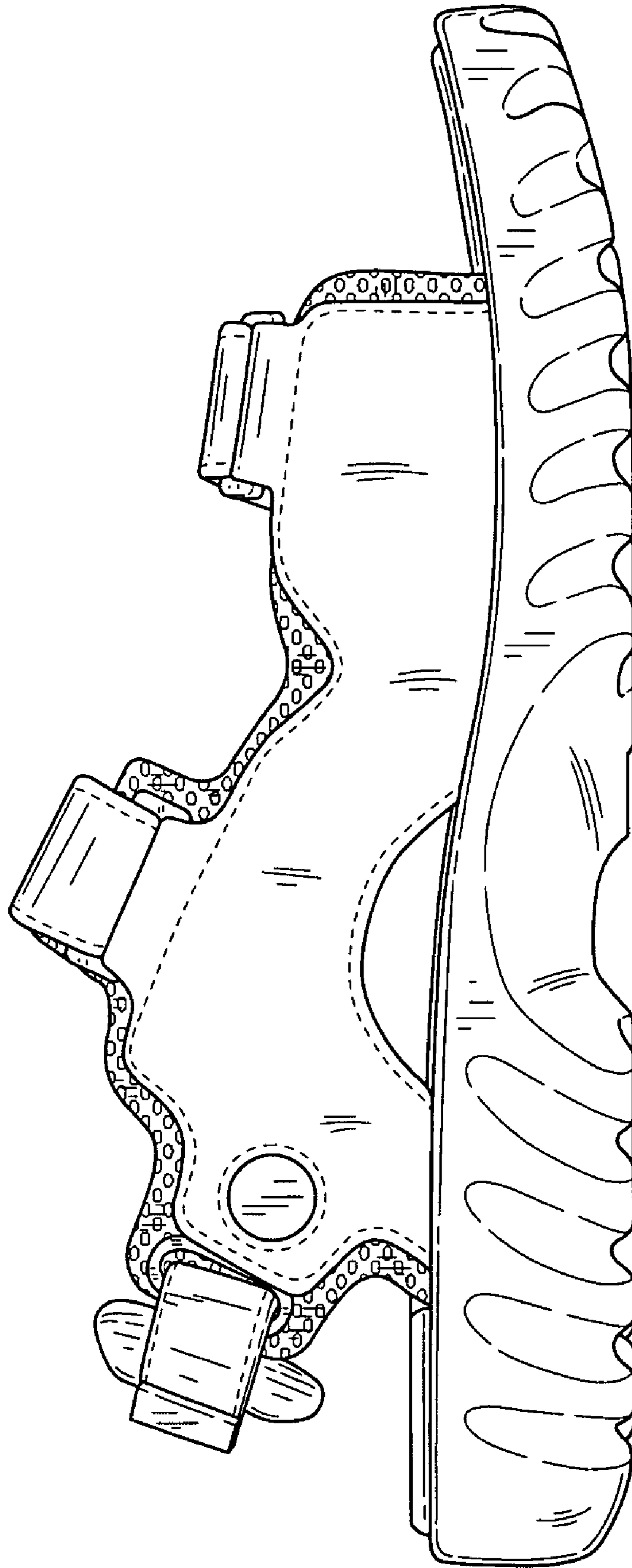

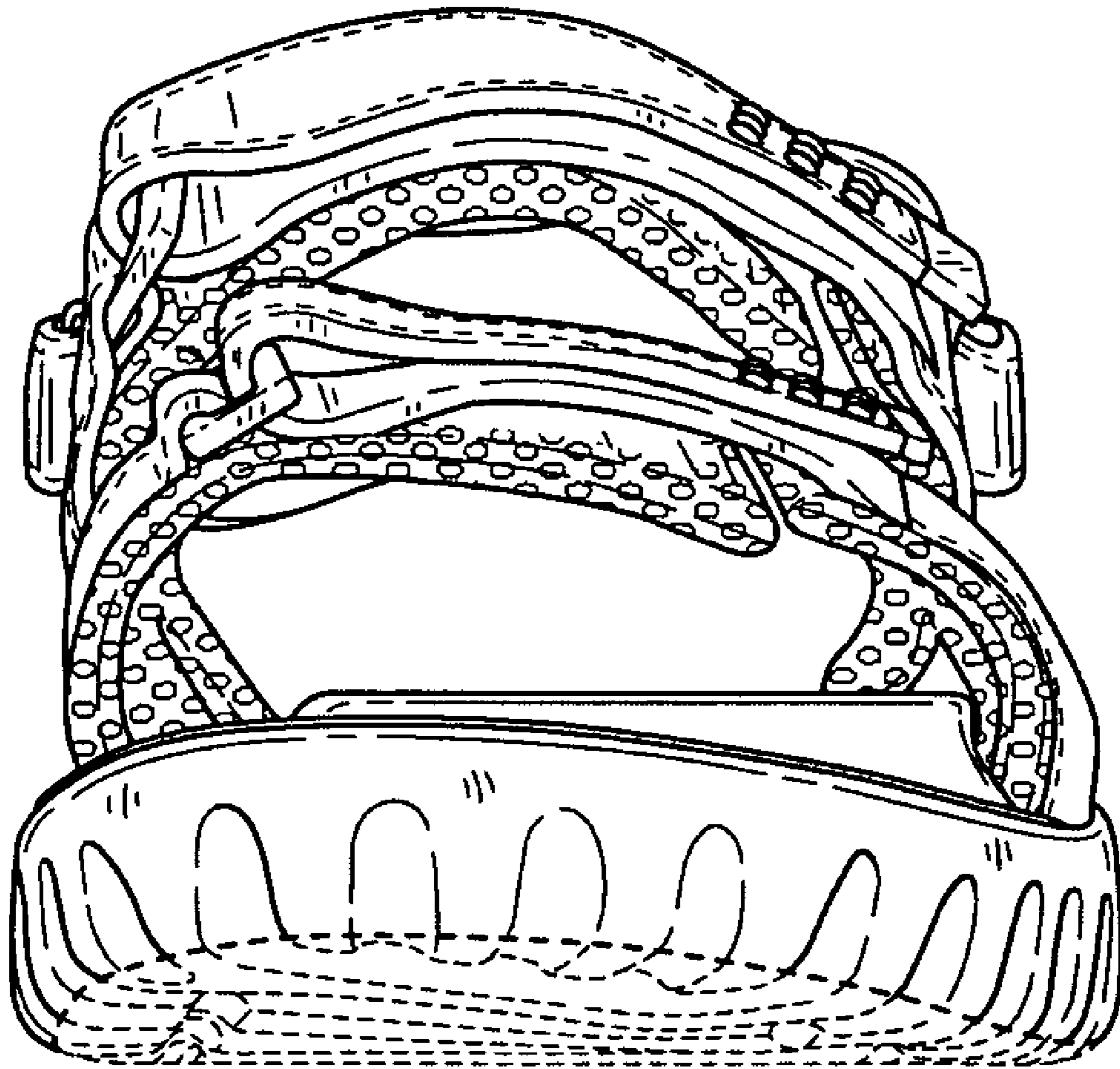

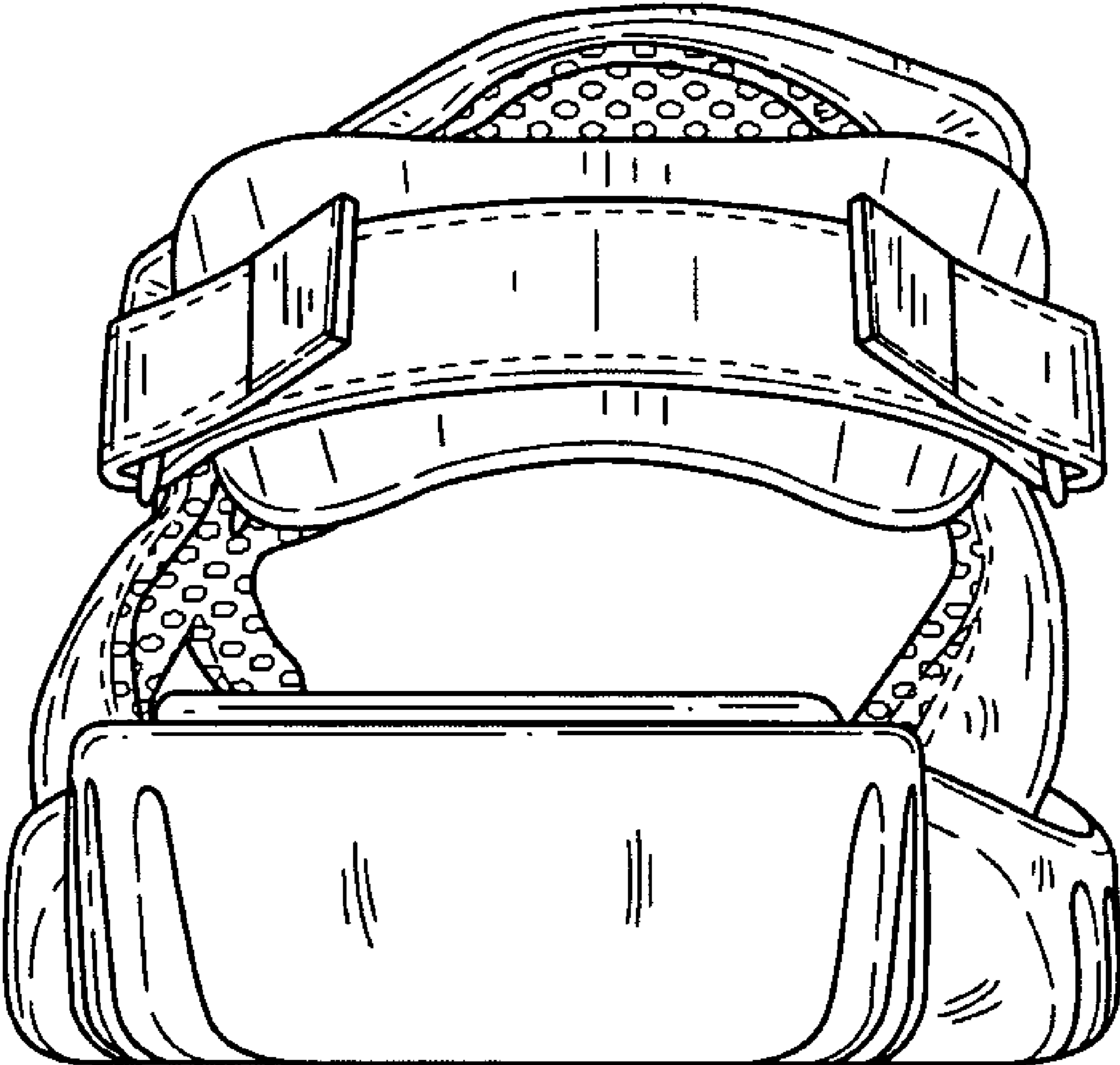
