DESCRIPTION

FIG. 1 is a perspective view of the container with lid and internal dividers looking from above and from right to left.

FIG. 2 is a side view along the left side of the container with lid and internal dividers as shown in FIG. 1, the container and lid have the same appearance from either side.

FIG. 3 is an end view from along the right side of the container with lid and internal dividers as shown in FIG. 1, the container and lid have the same appearance from either end.

FIG. 4 is an exterior top view of the lid as shown in FIG. 1.

FIG. 5 is an interior view of the lid as shown in FIG. 1.

FIG. 6 is an interior top view of the container as shown in FIG. 1.

FIG. 7 is a bottom view of the container as shown in FIG. 1.

FIG. 8 is a section view of the lid along the lines 8—8 of FIG. 4

FIG. 9 is a section view of the container along the lines 9—9 of FIG. 6.

FIG. 10 is a section view of the lid along the lines 10—10 of FIG. 4; and,

FIG. 11 is a section view of the container along the lines 11—11 of FIG. 6.

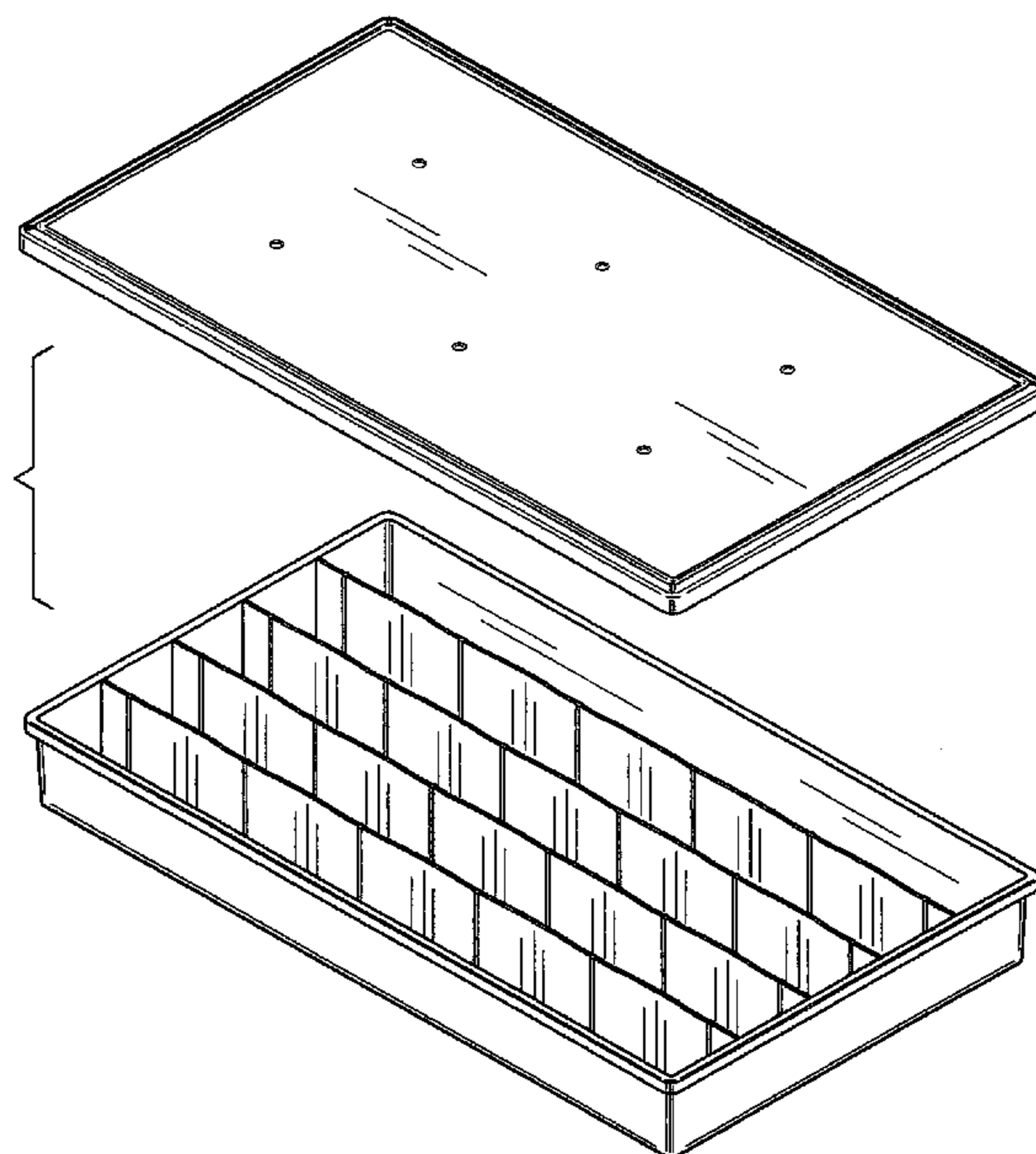

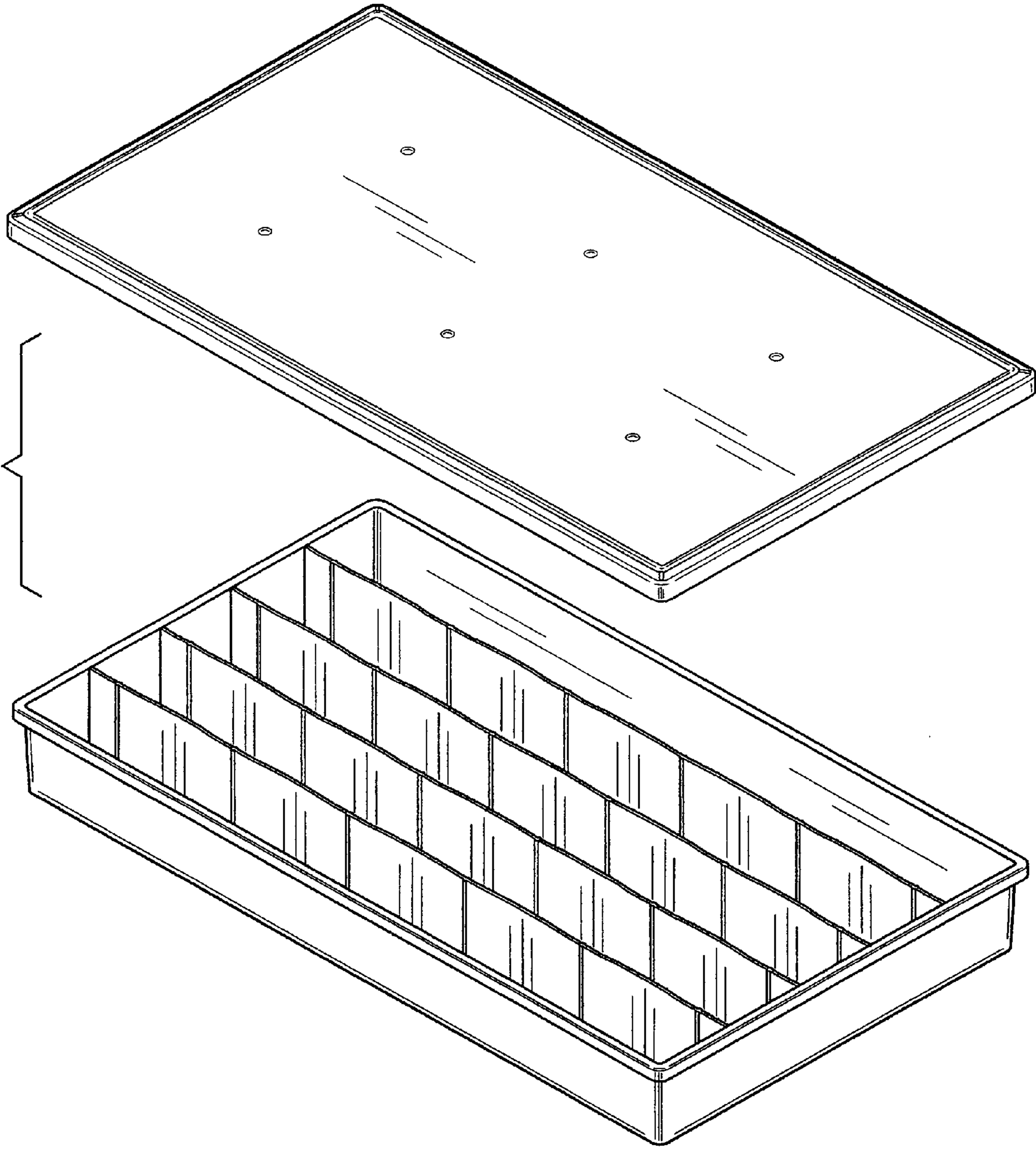

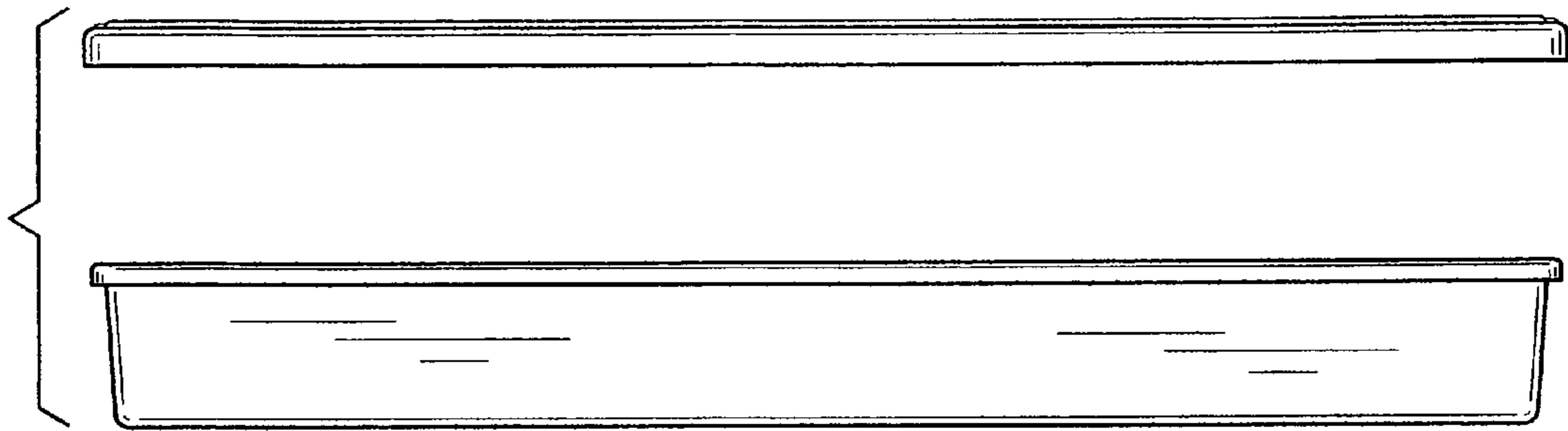

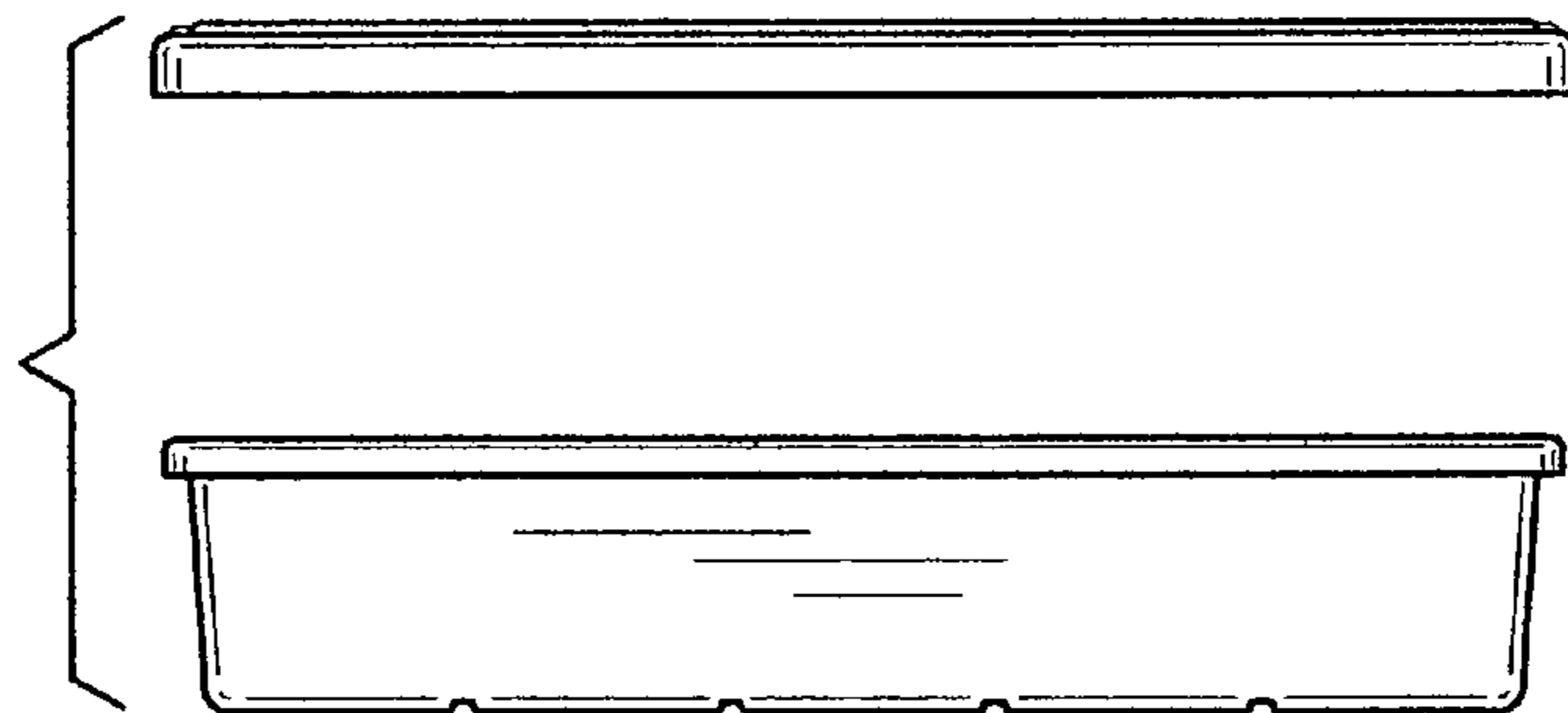

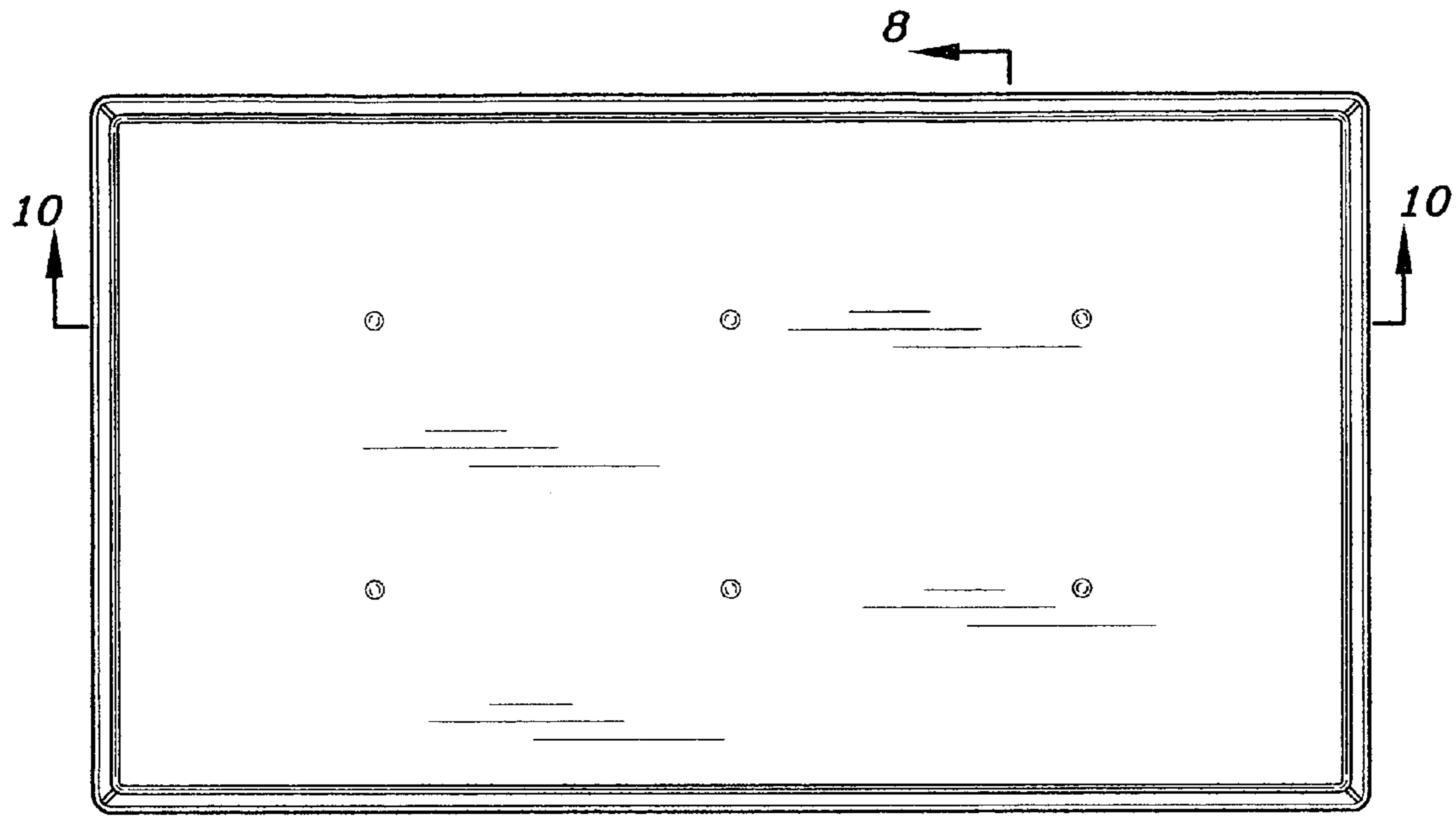

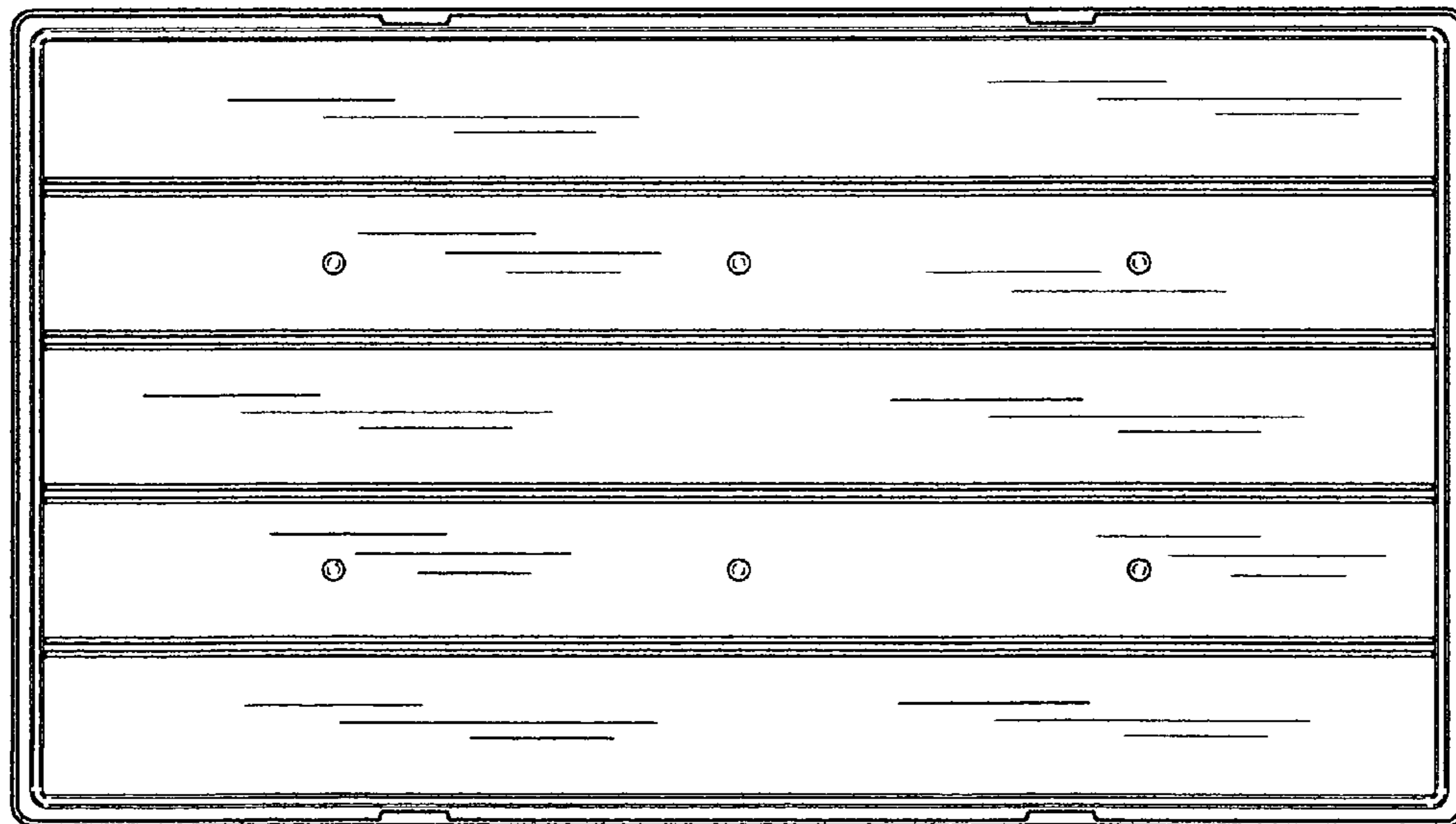
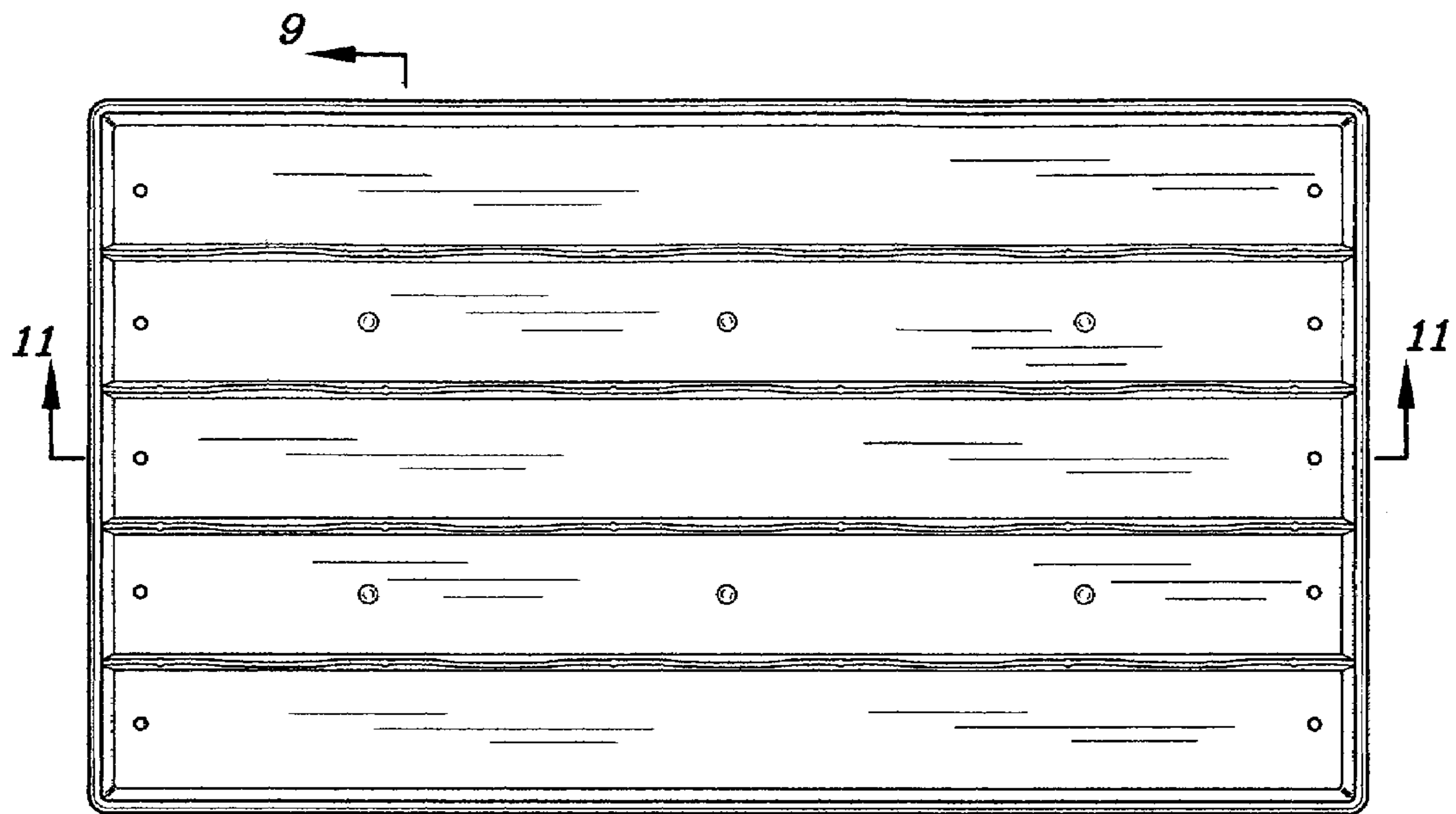

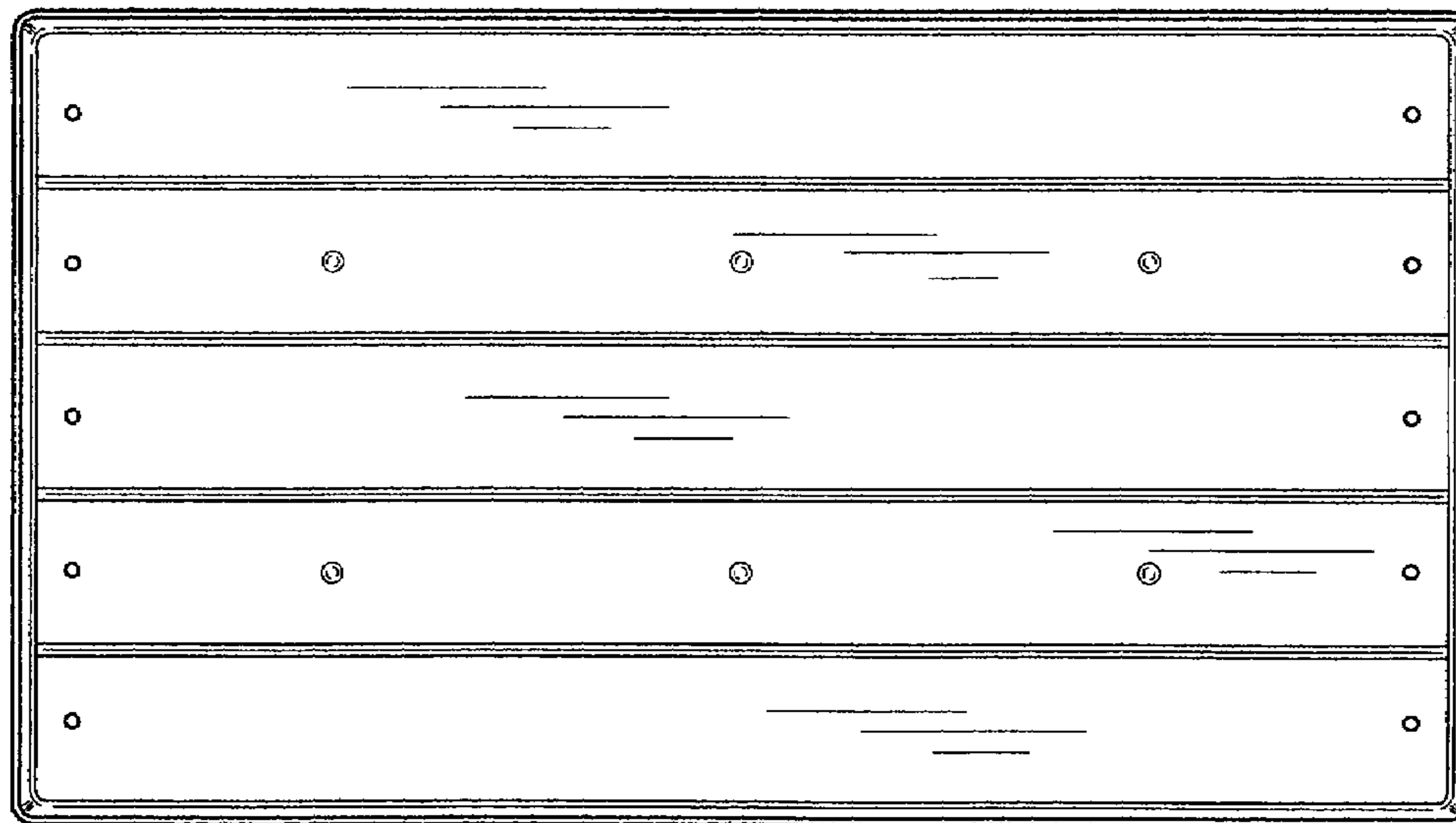

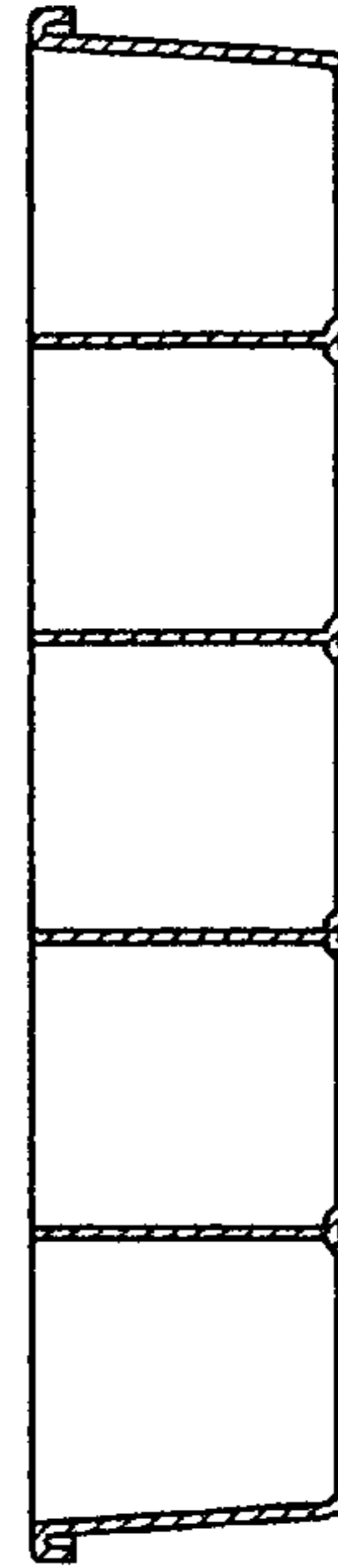

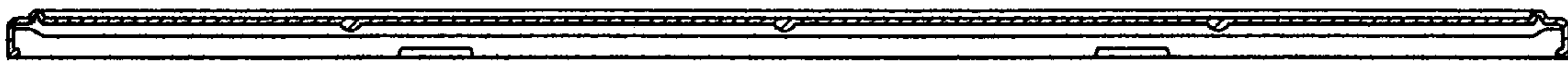
