DESCRIPTION

FIG. 1 is a front right perspective view of the toaster showing the new design;

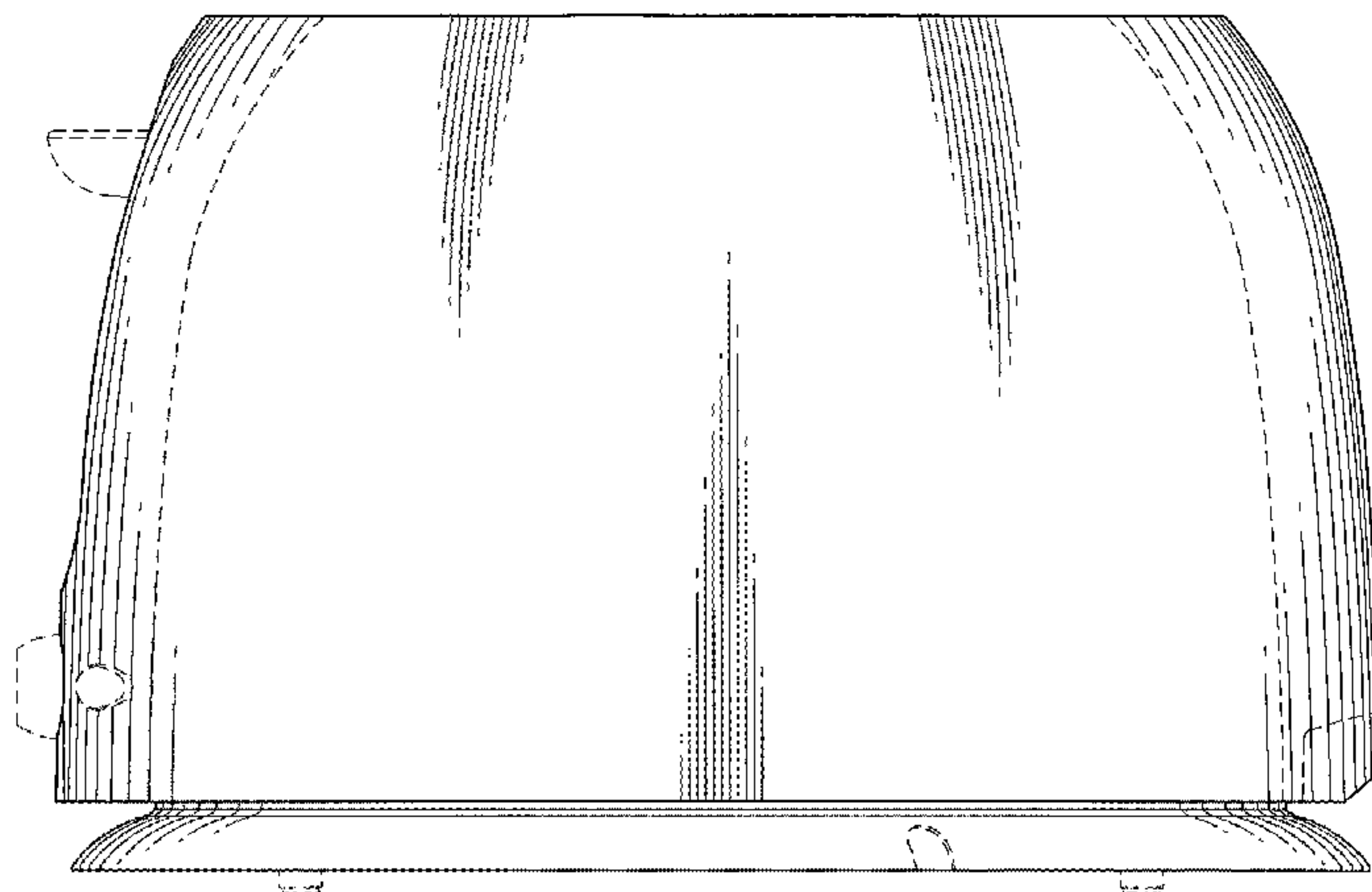
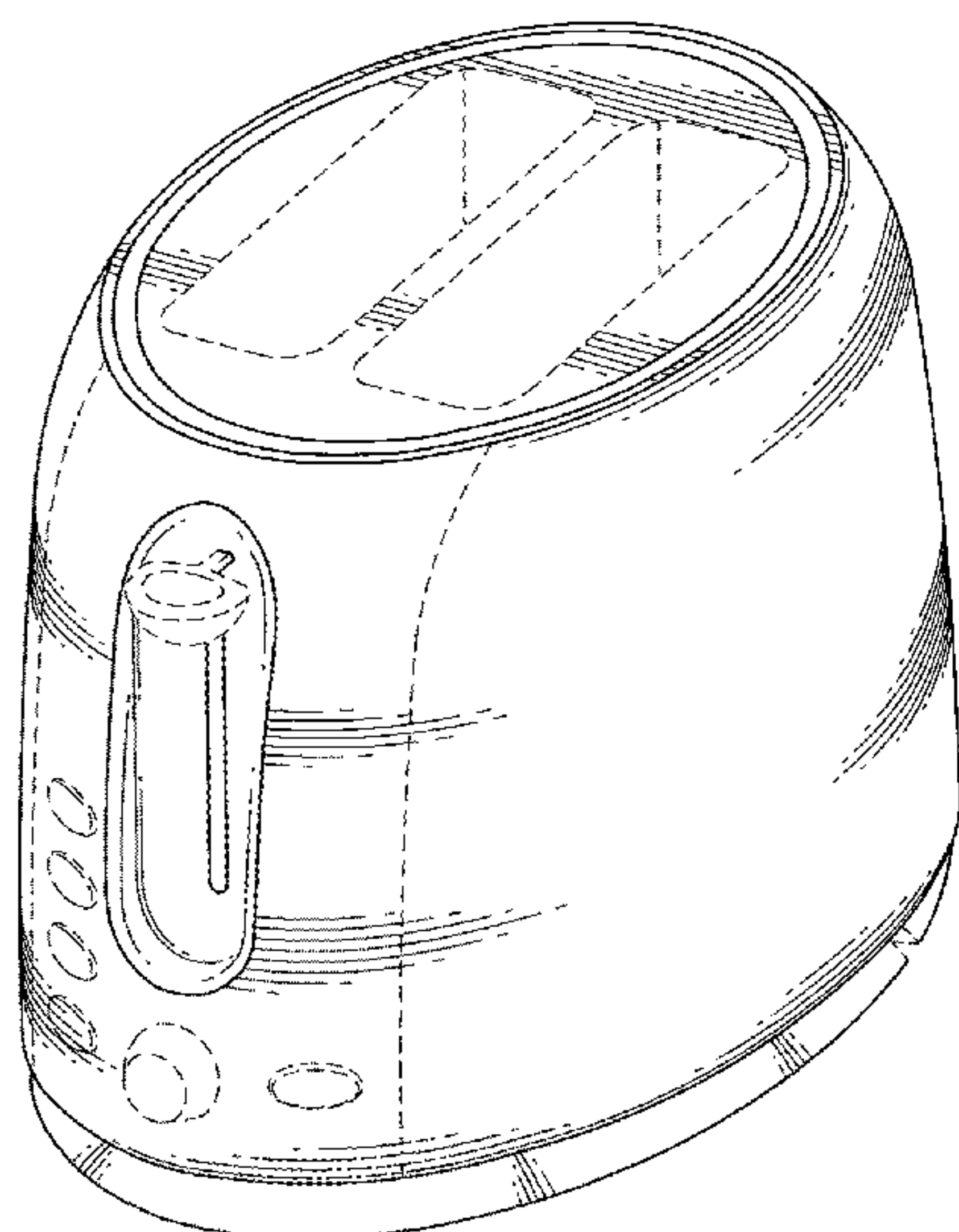

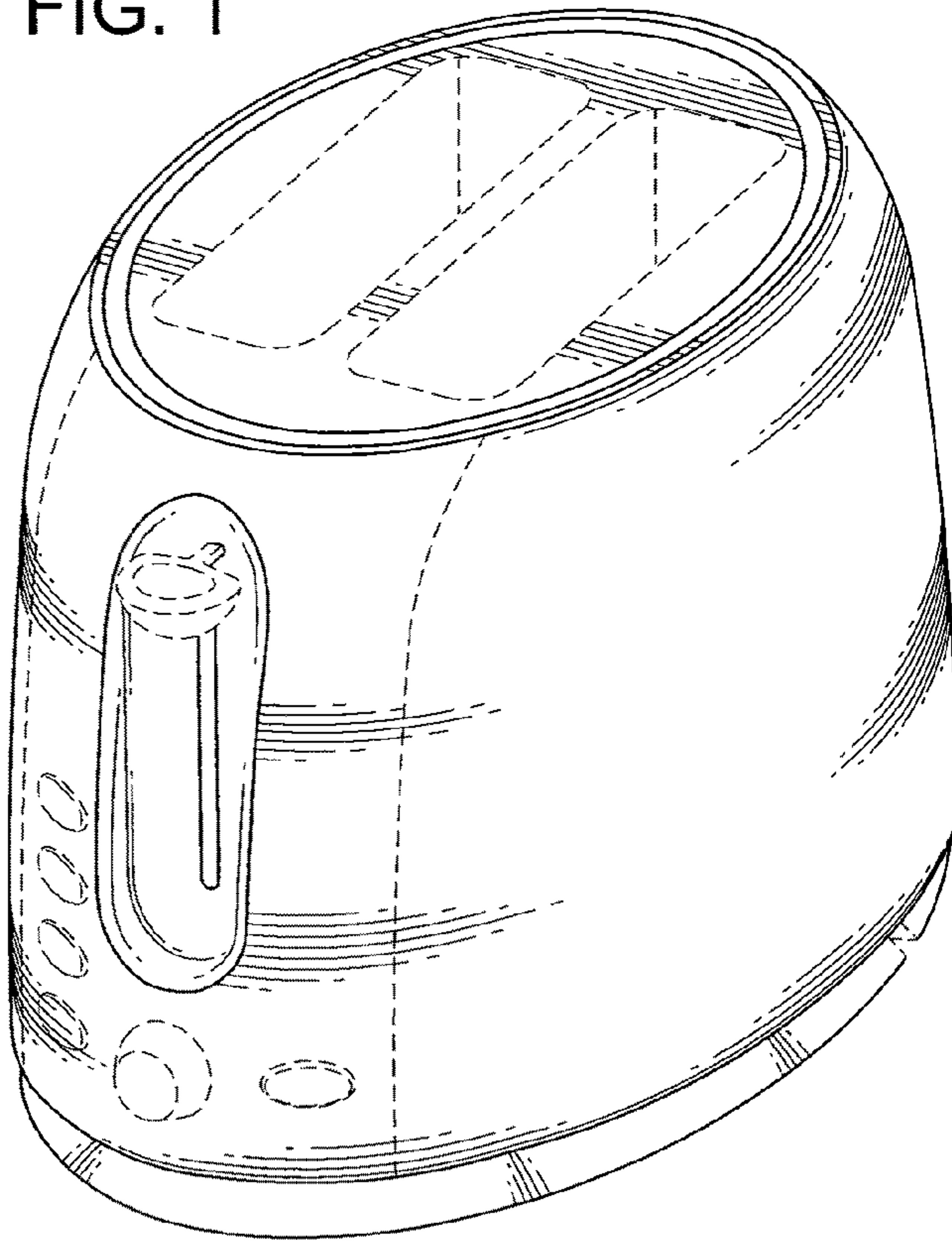

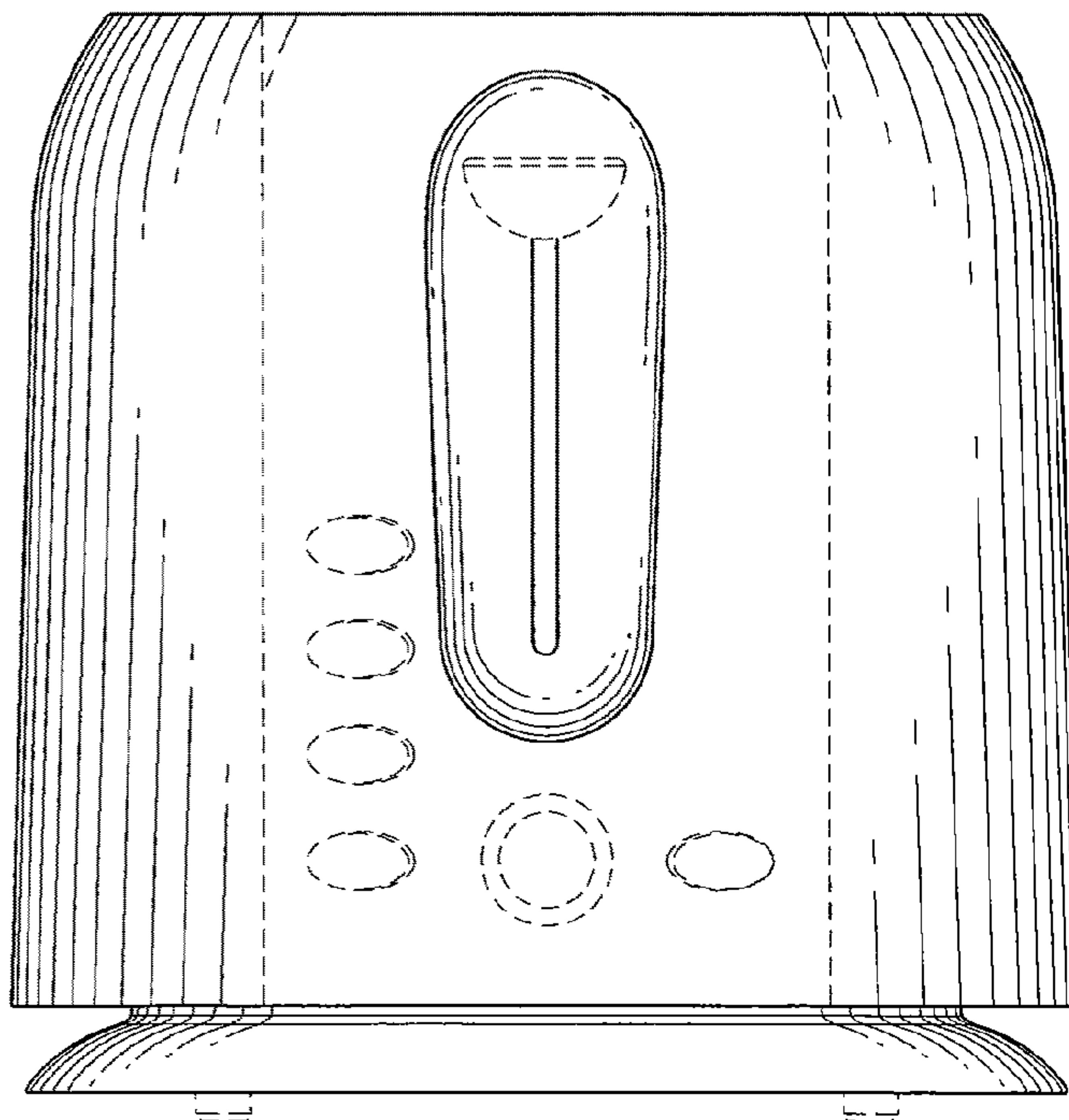

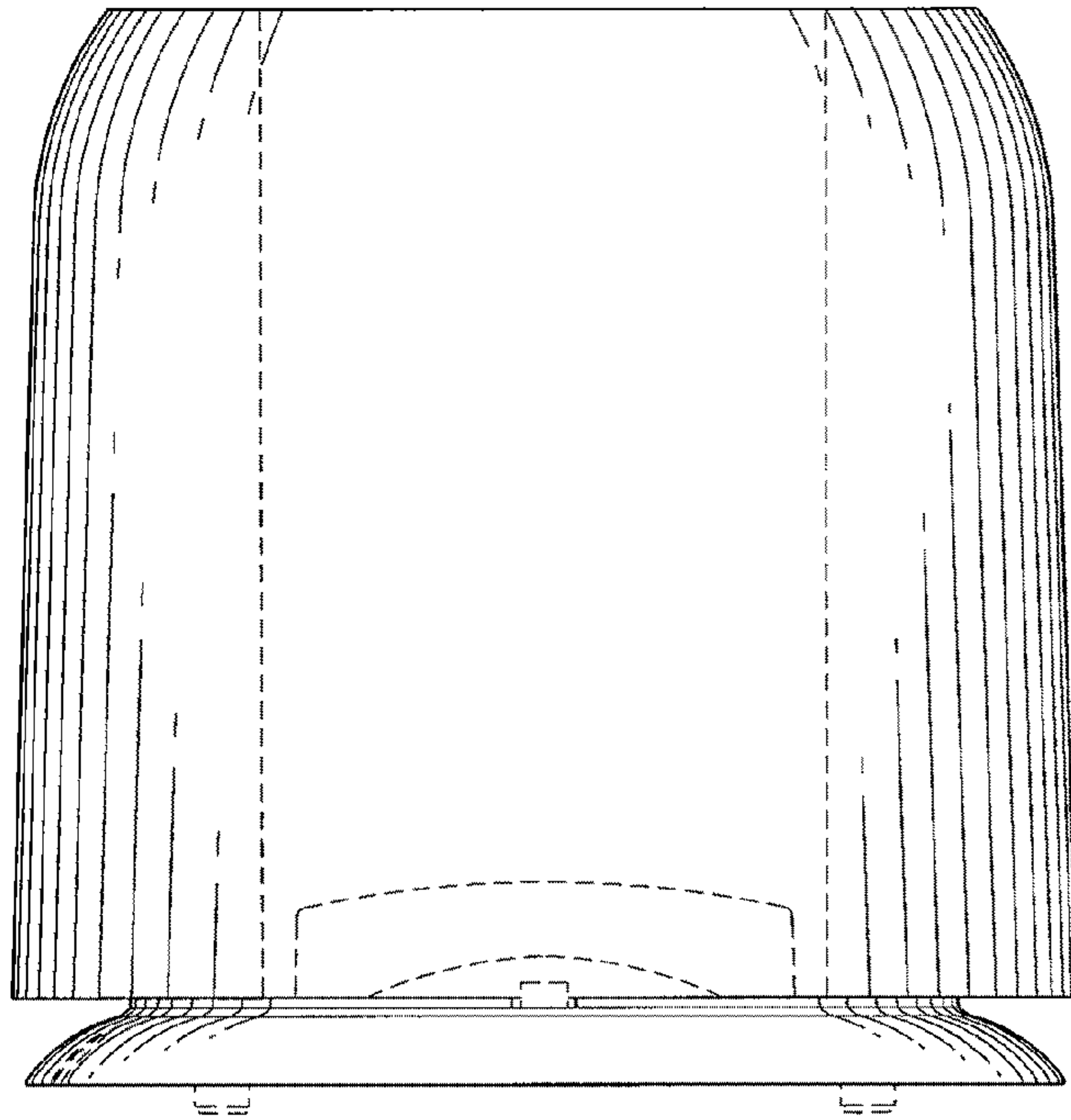

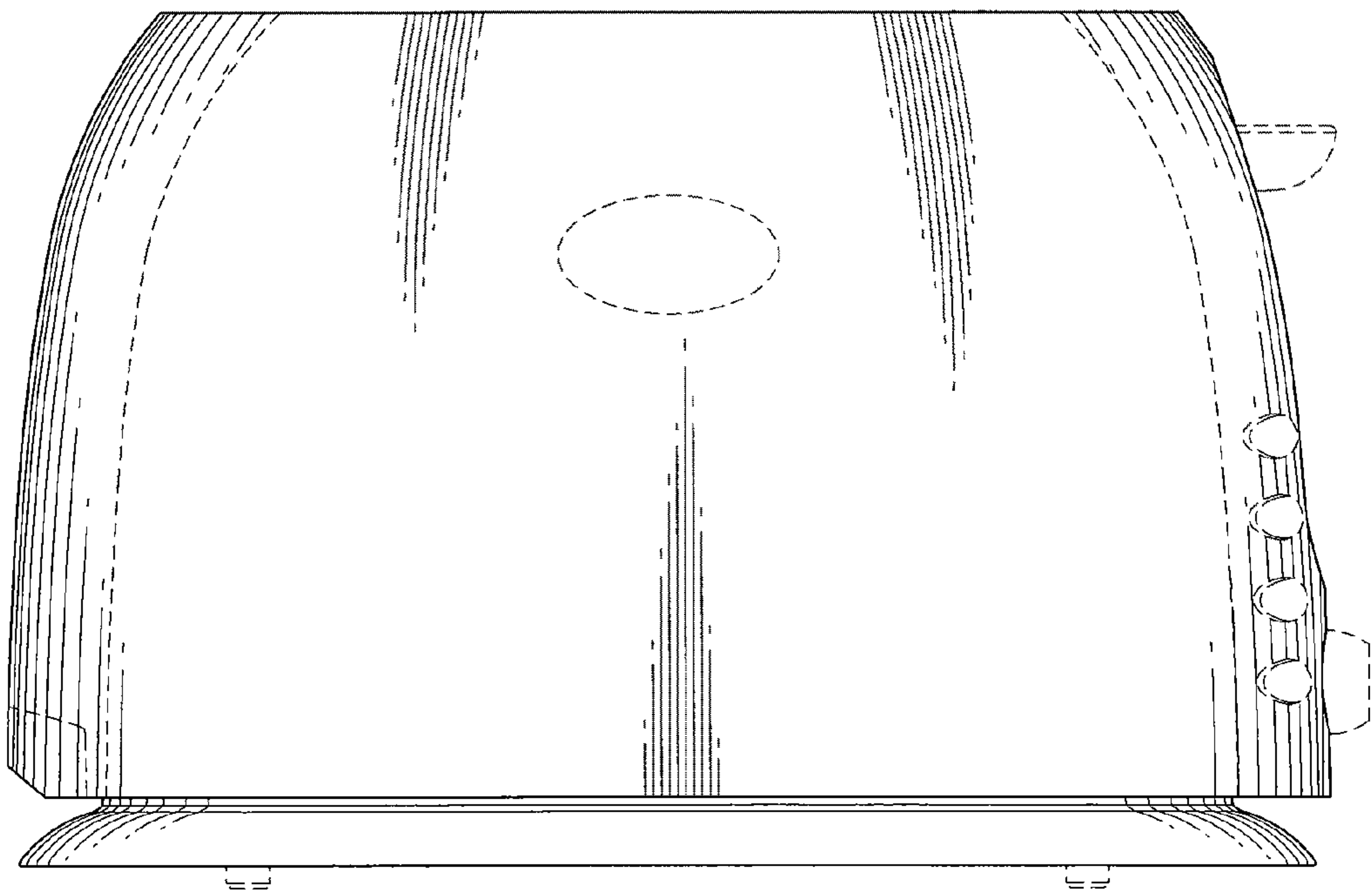

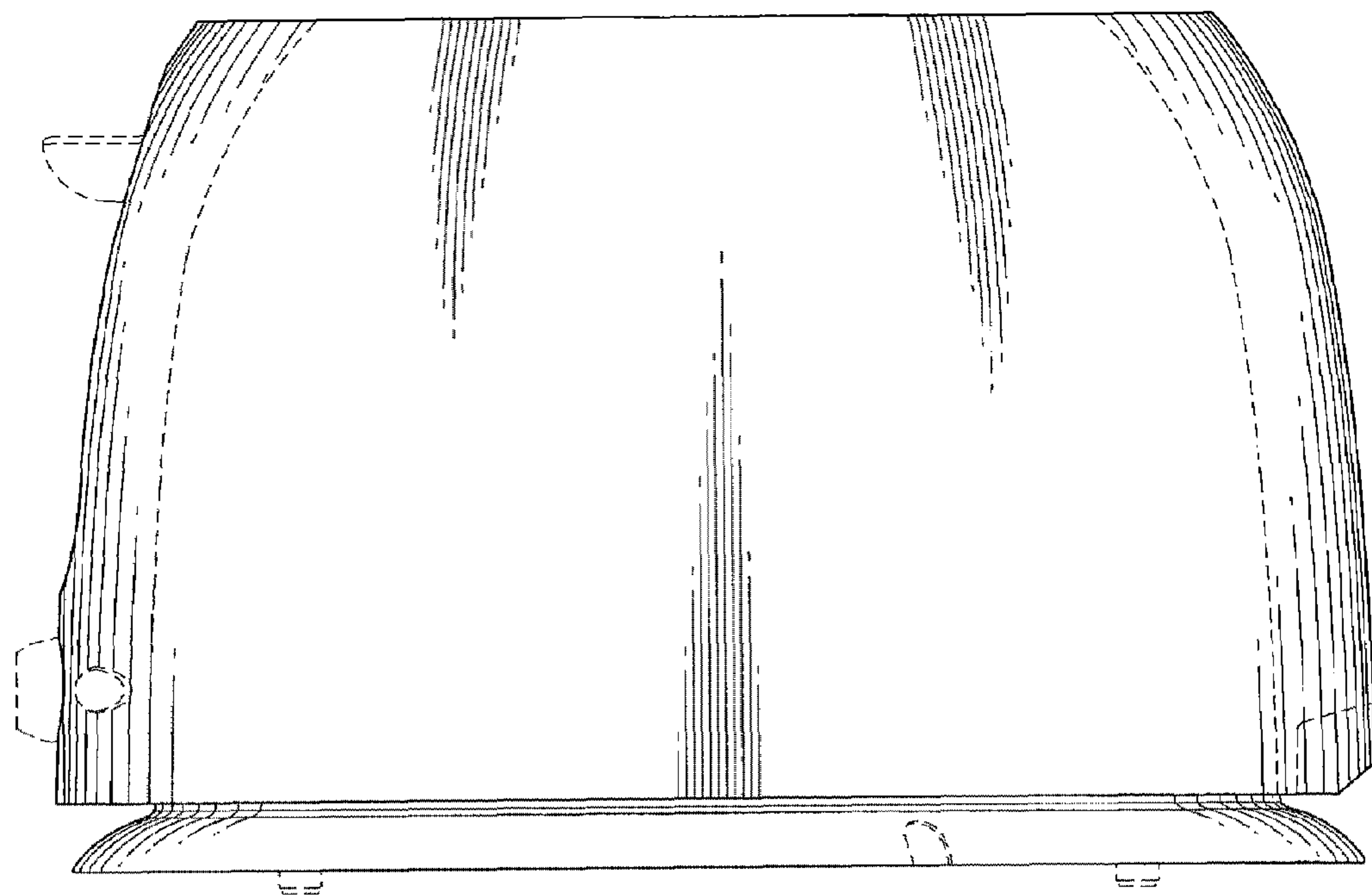

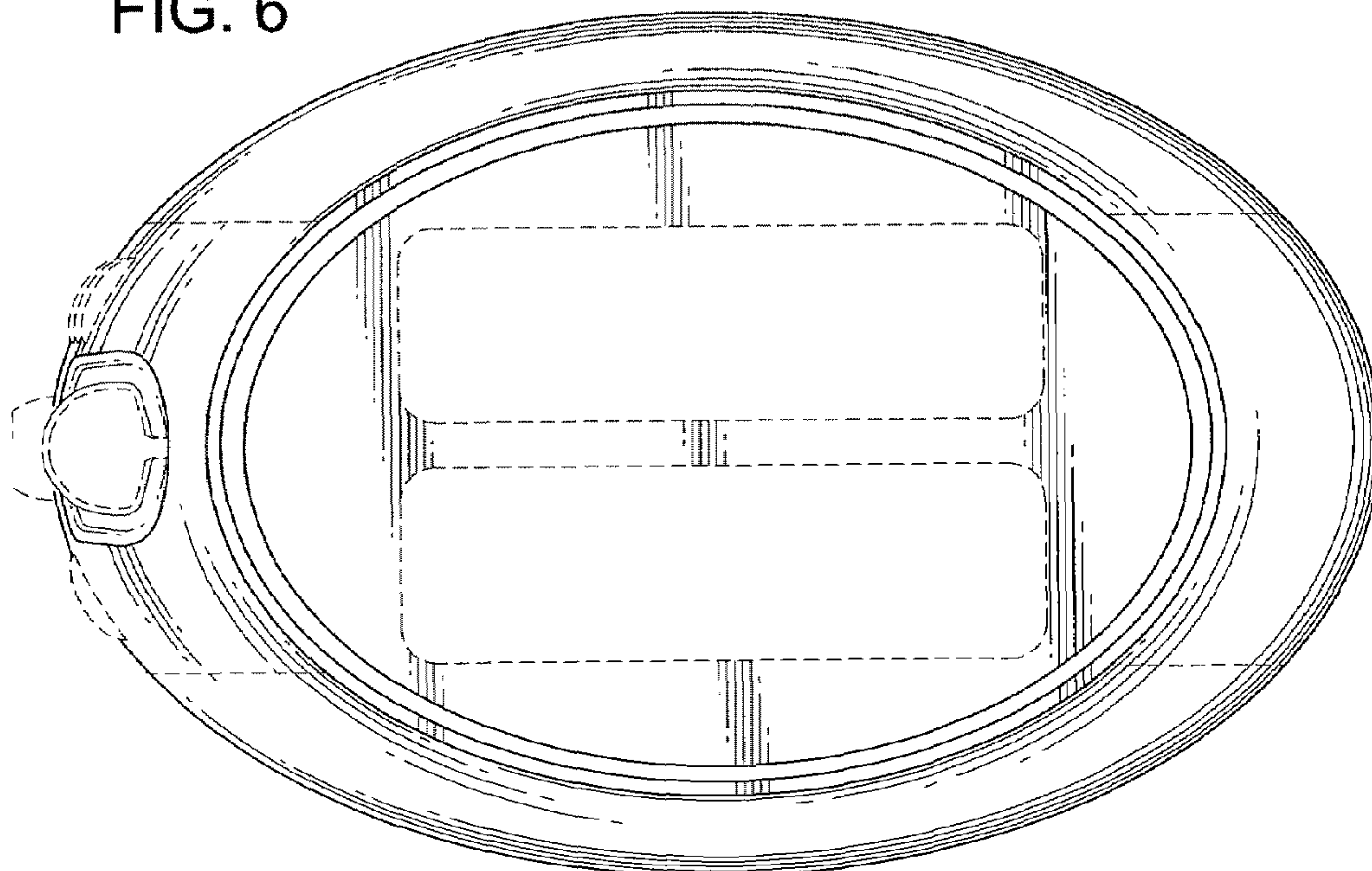
