FIG. 1 is a perspective view from above the front and side of the “sauce pan lid handle”, showing my new design;

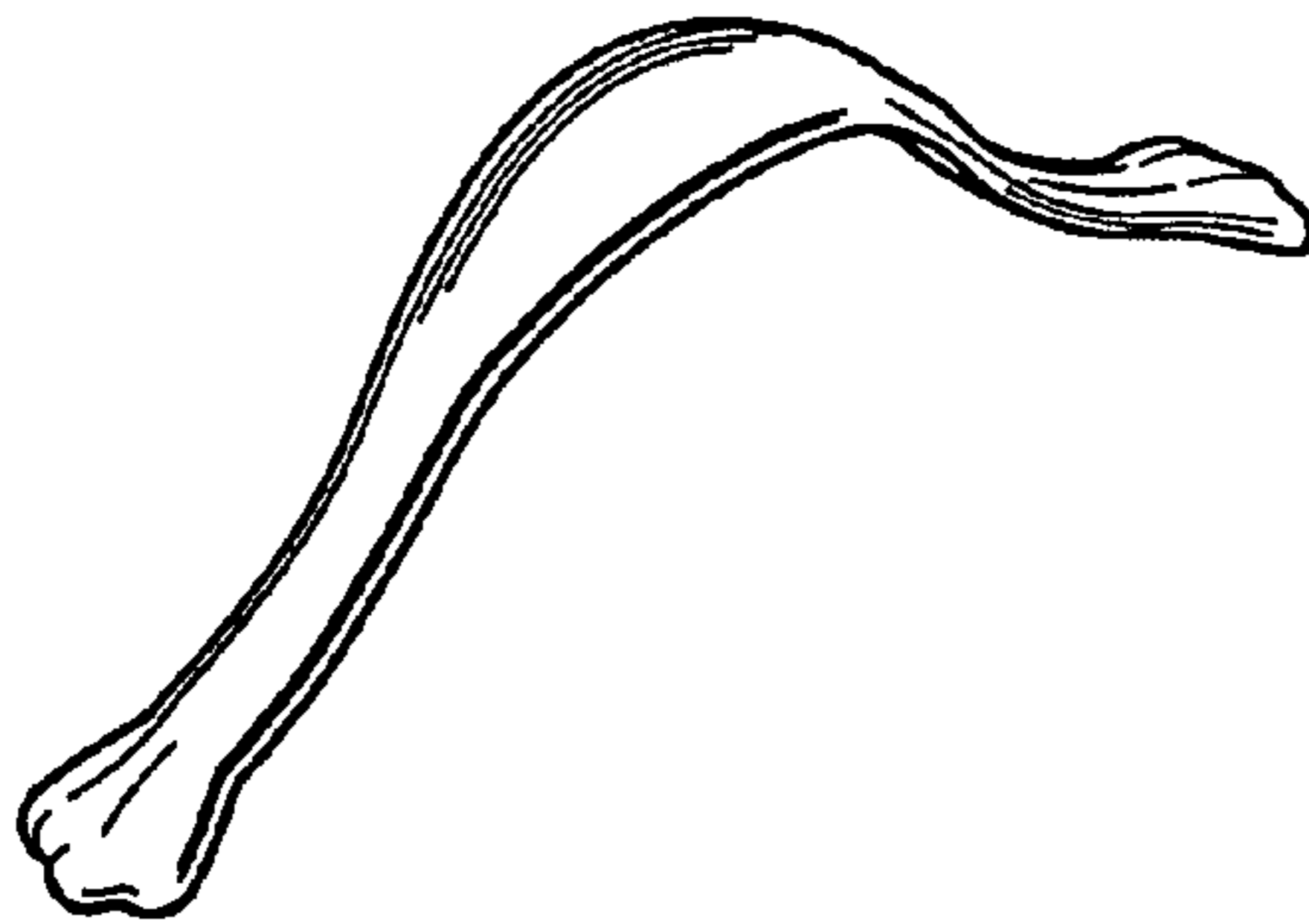
FIG. 2 is a top plan view thereof;

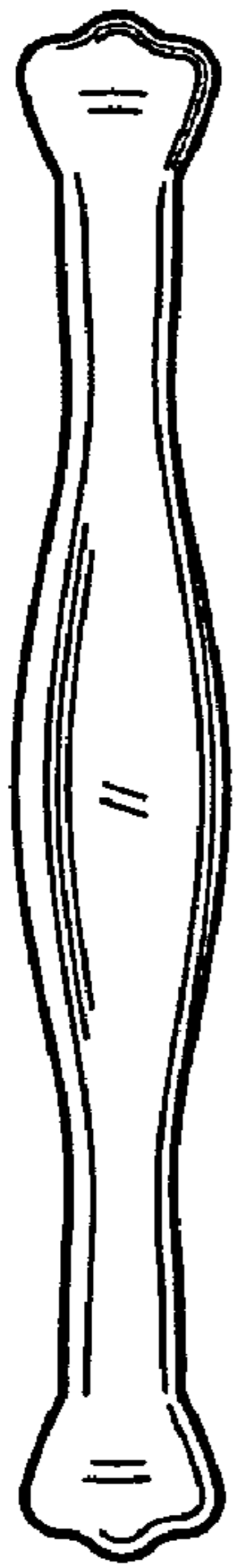

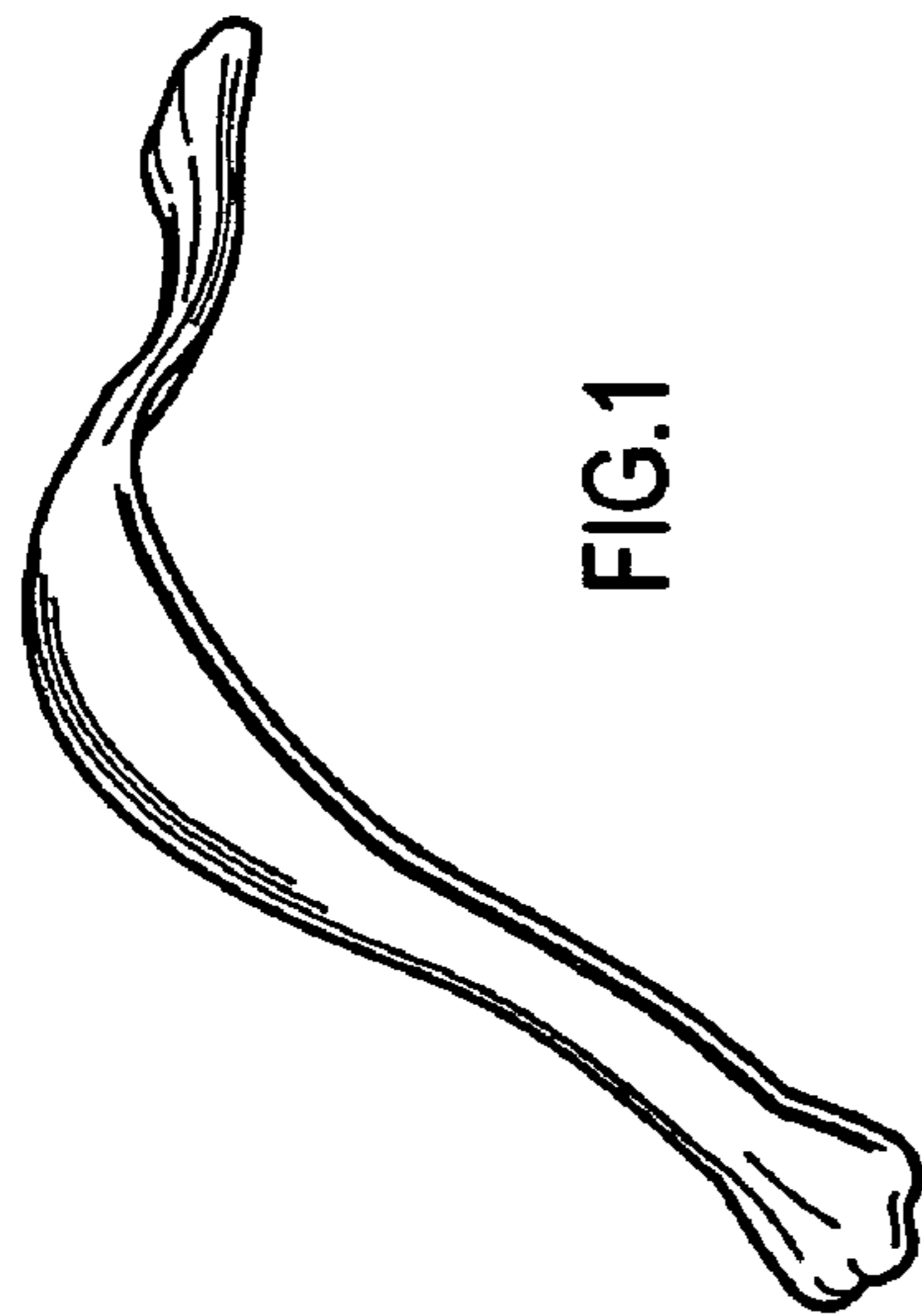

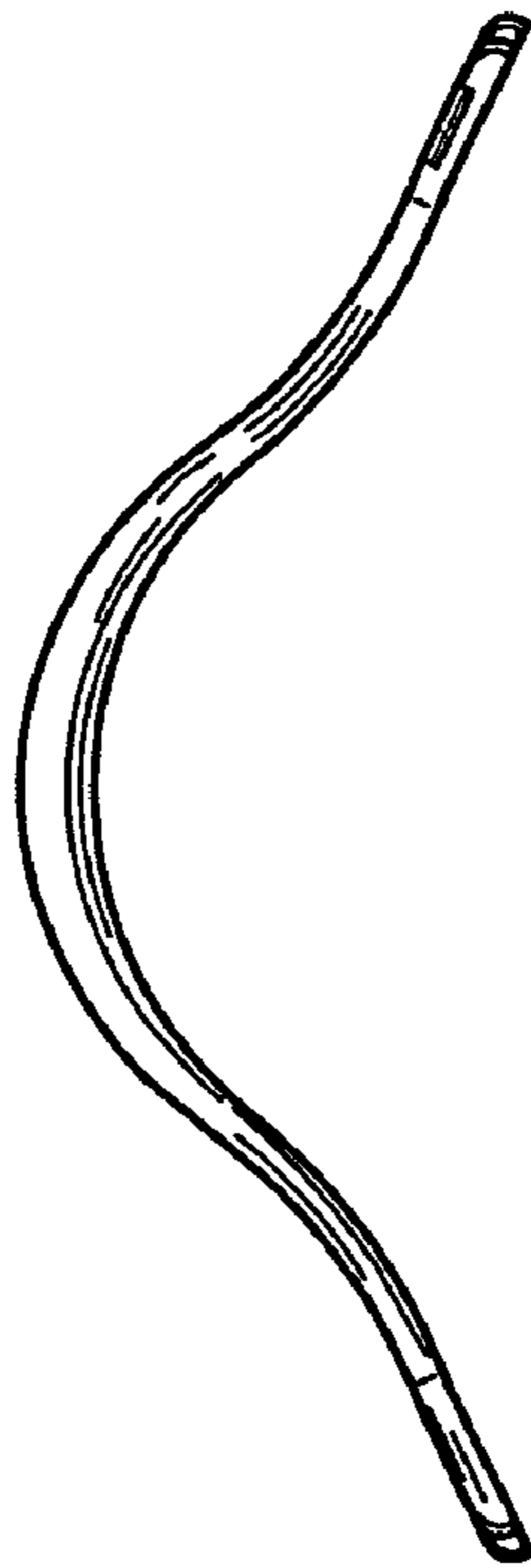
