FIG. 13 is a top view thereof;

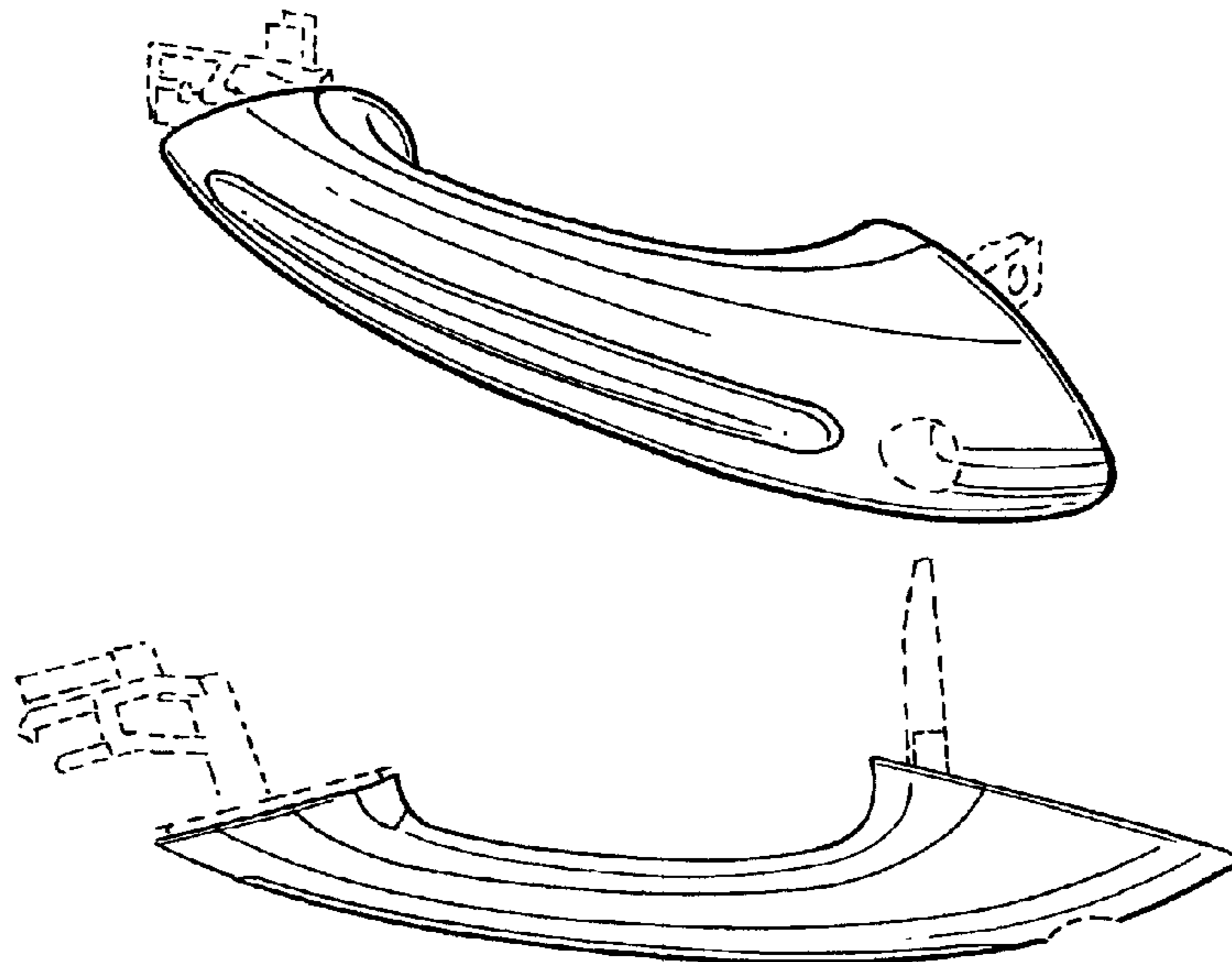
FIG. 14 is a bottom view thereof;

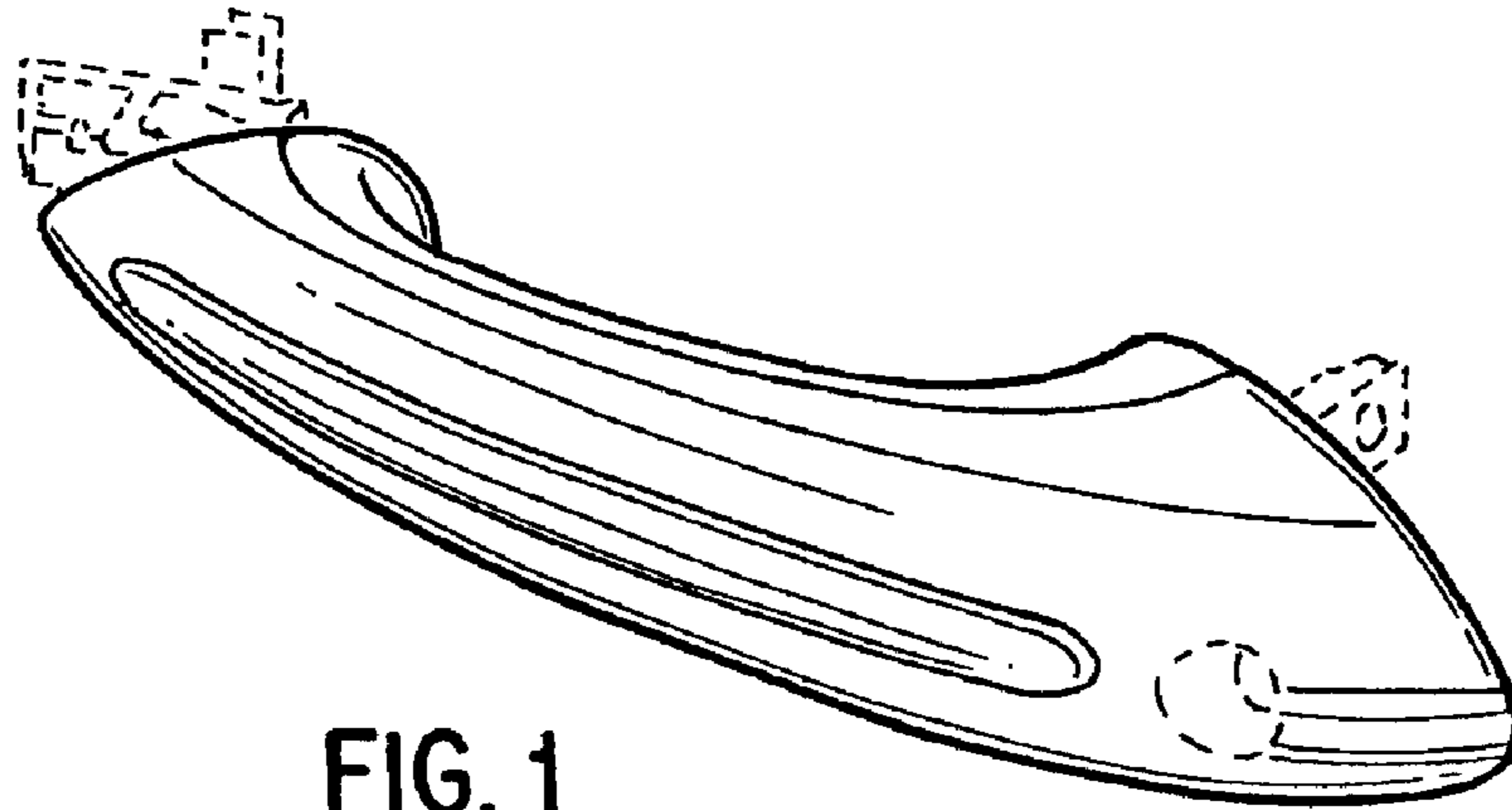

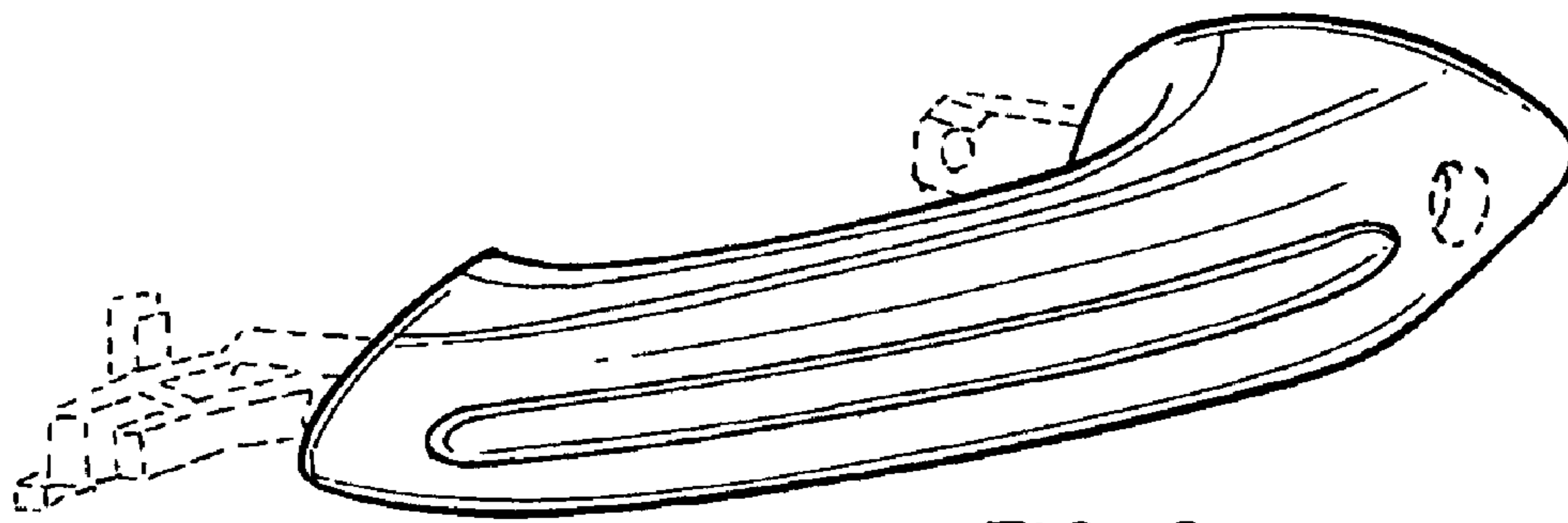

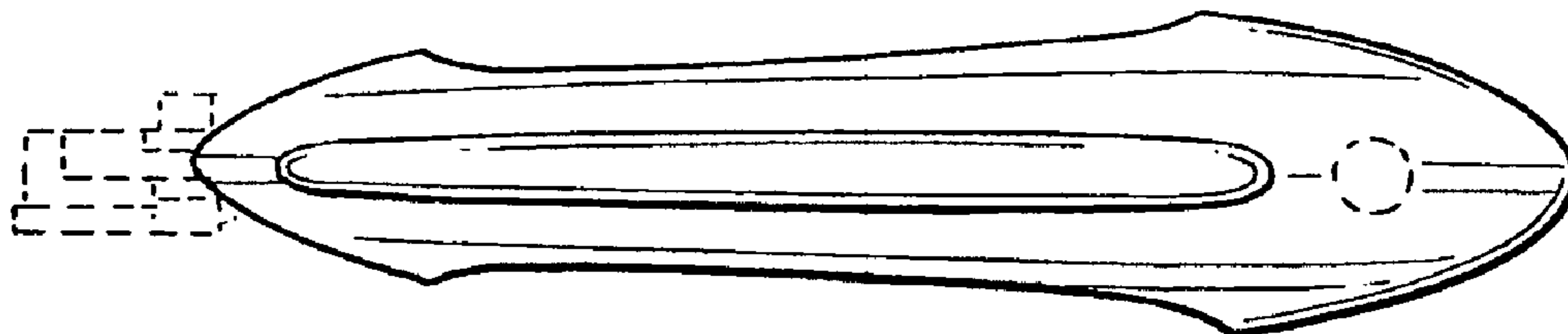

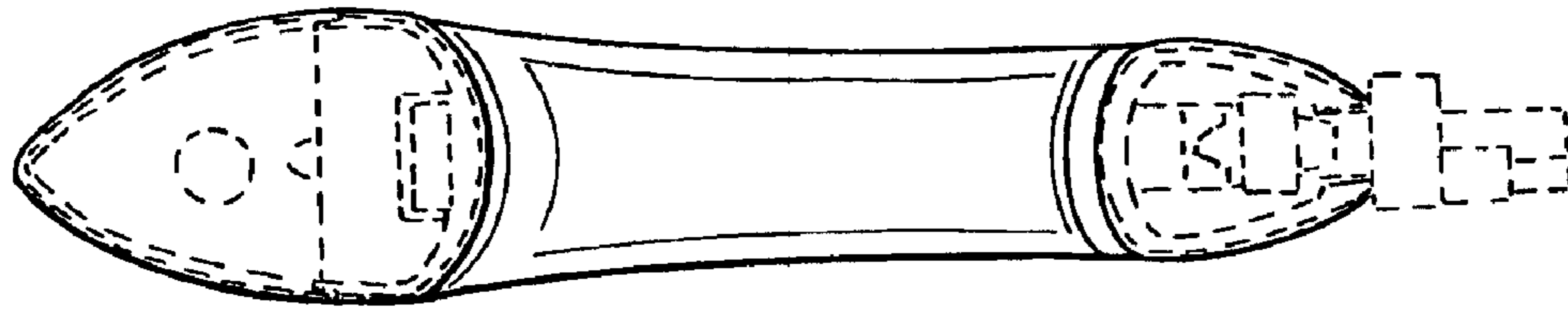

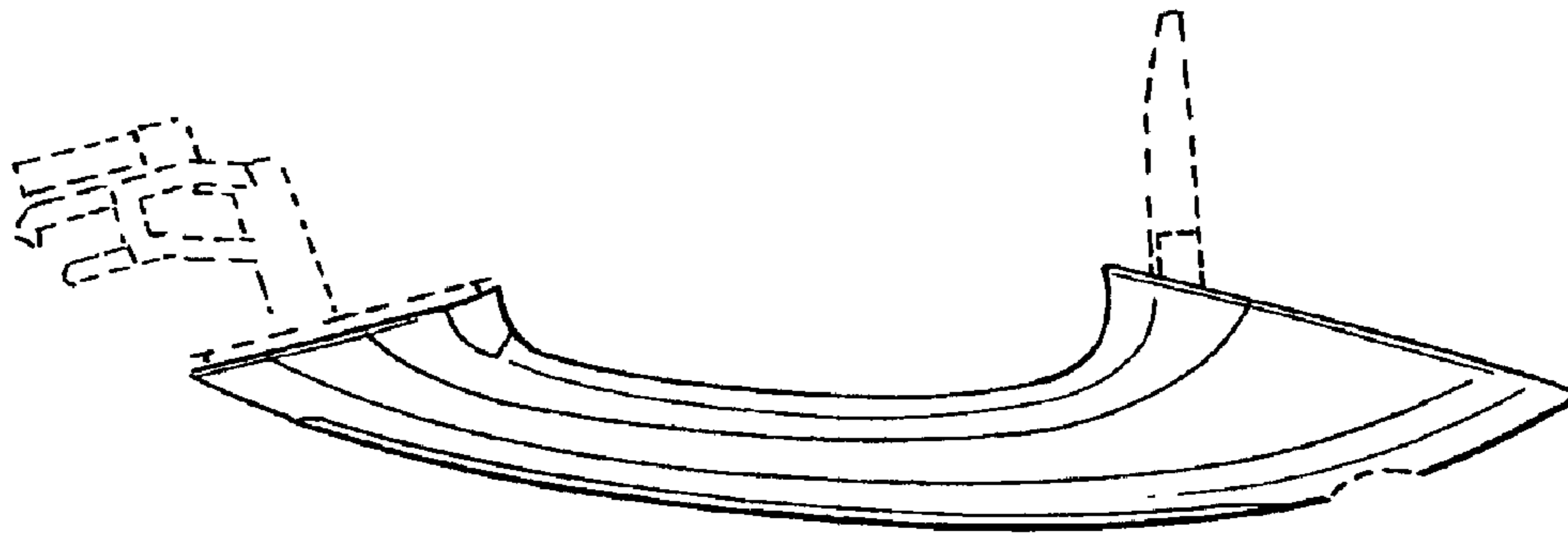

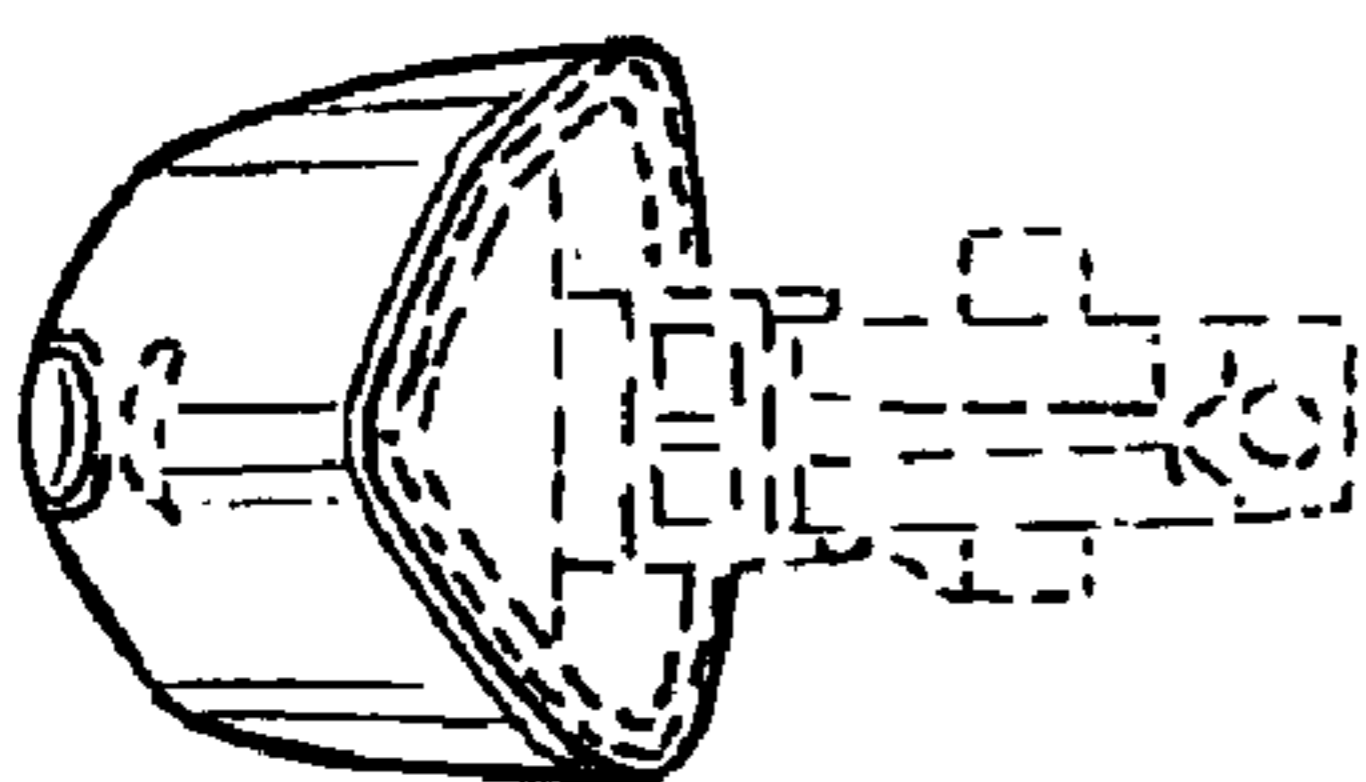

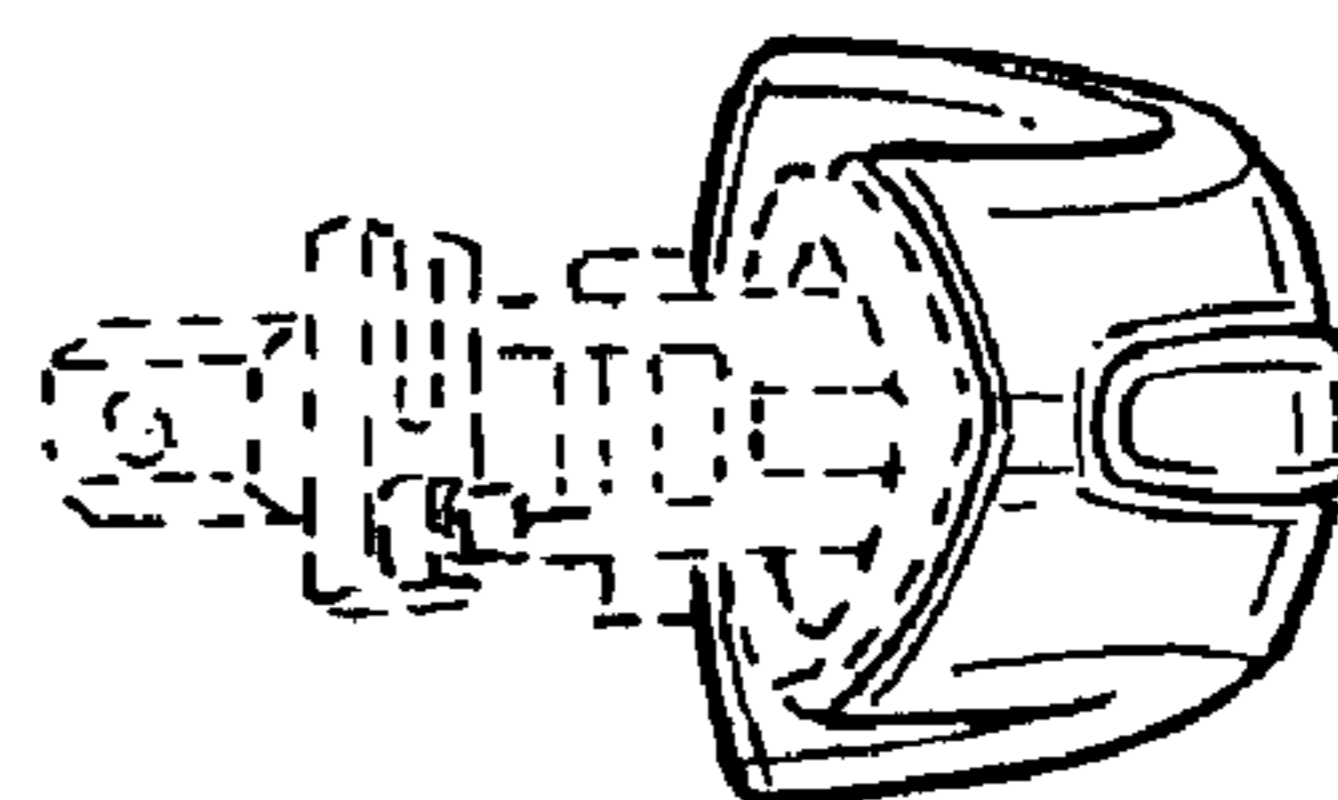

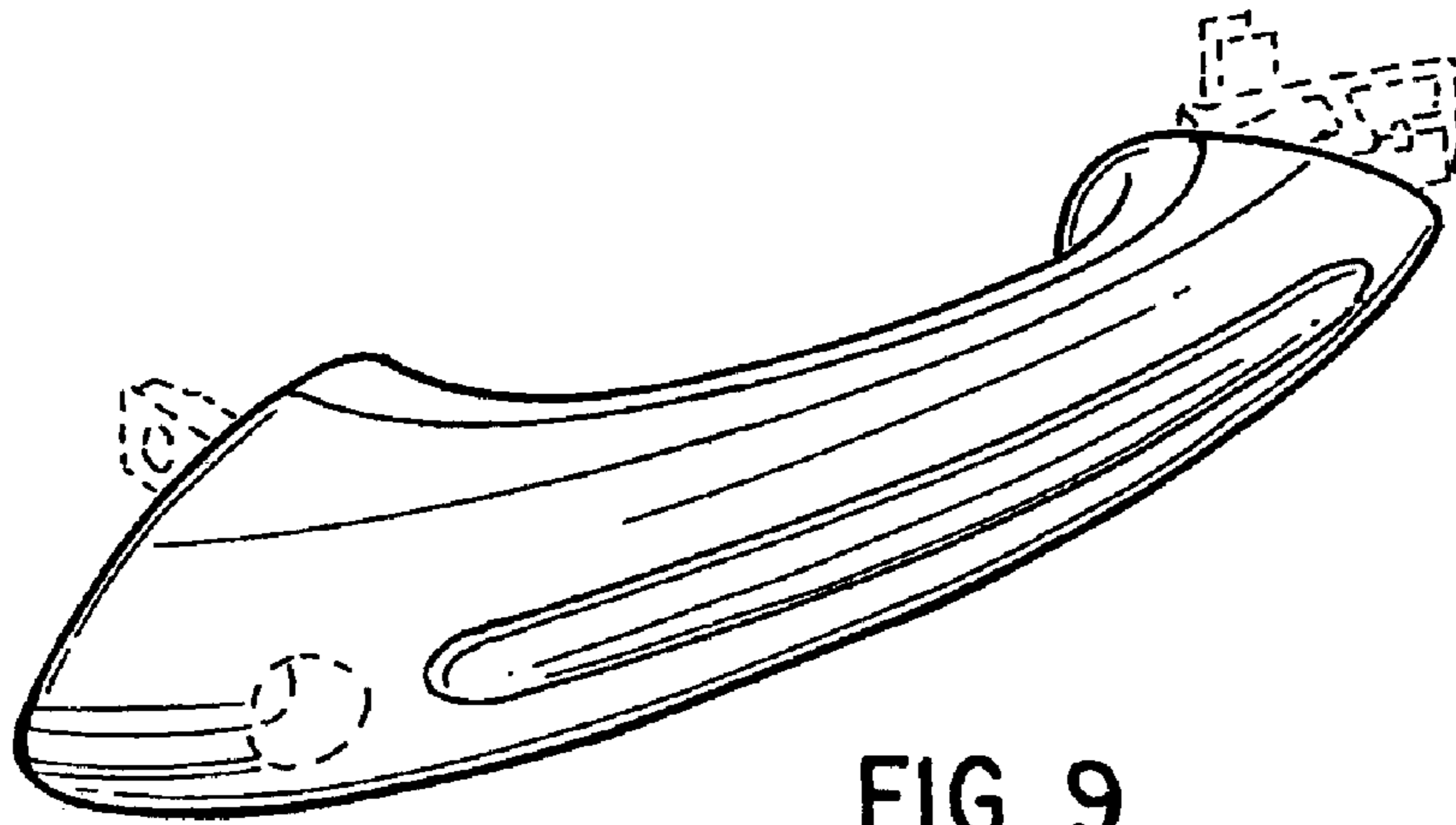

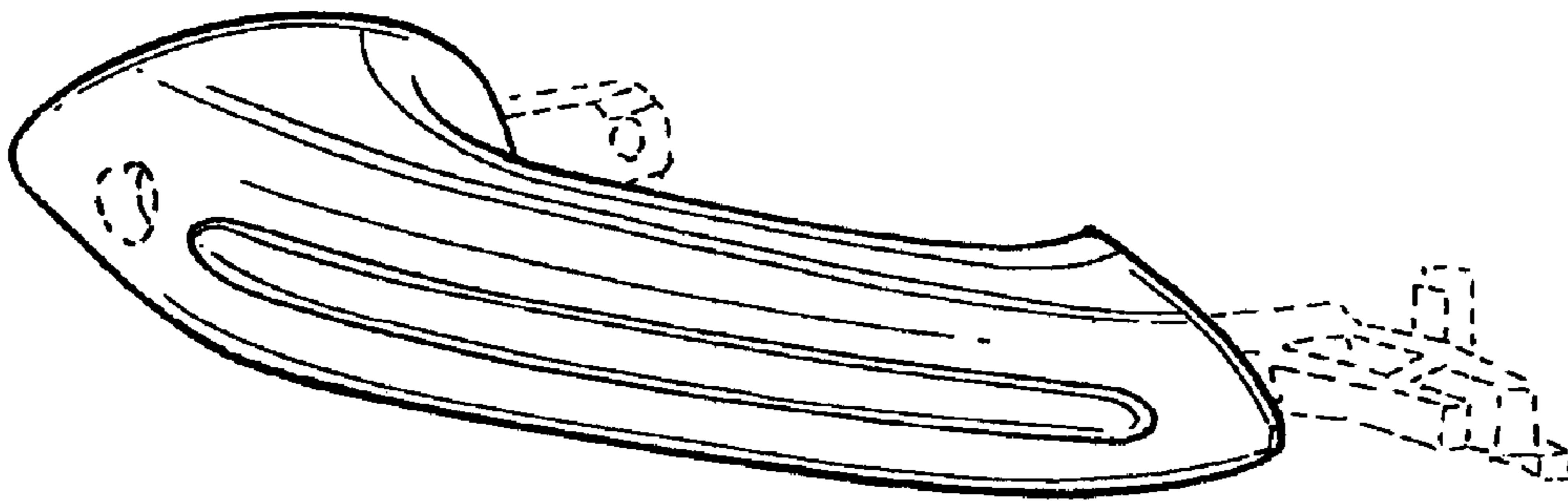

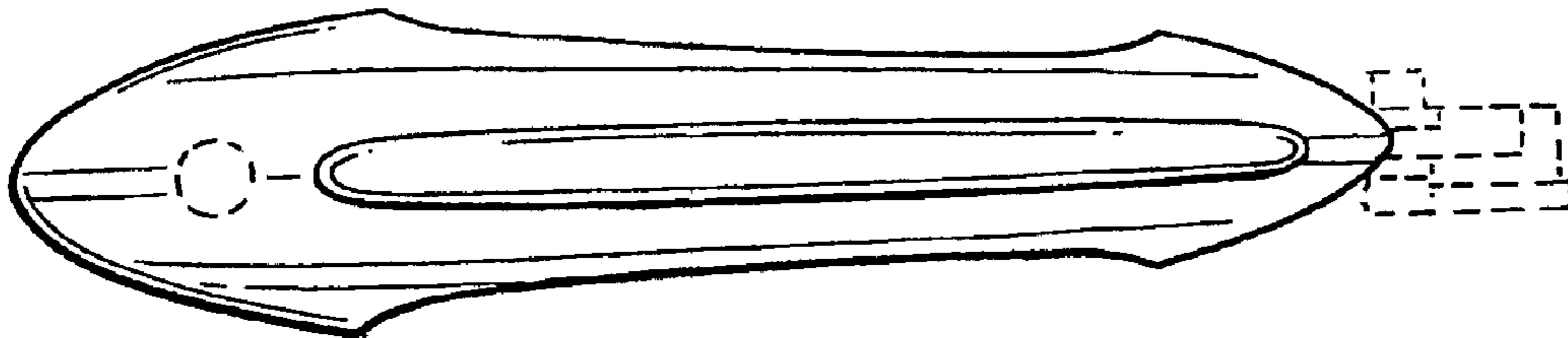

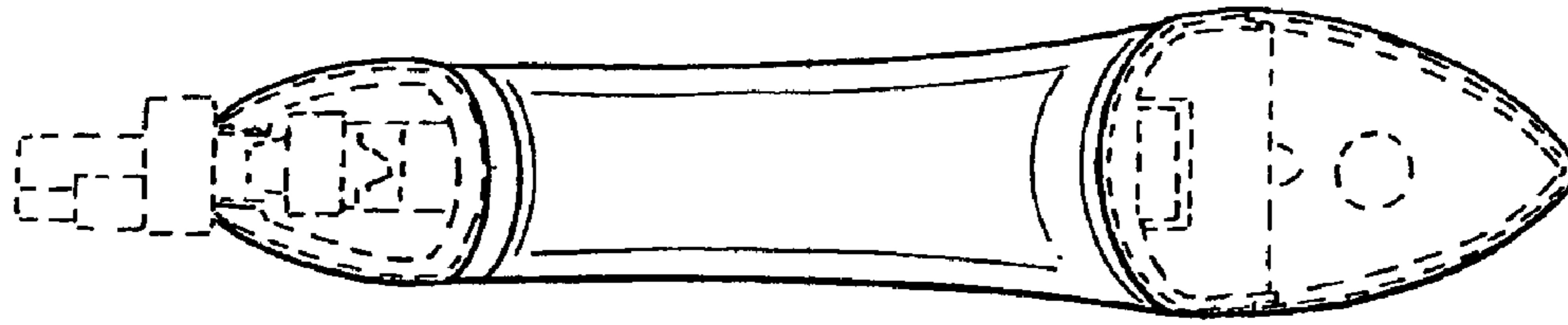

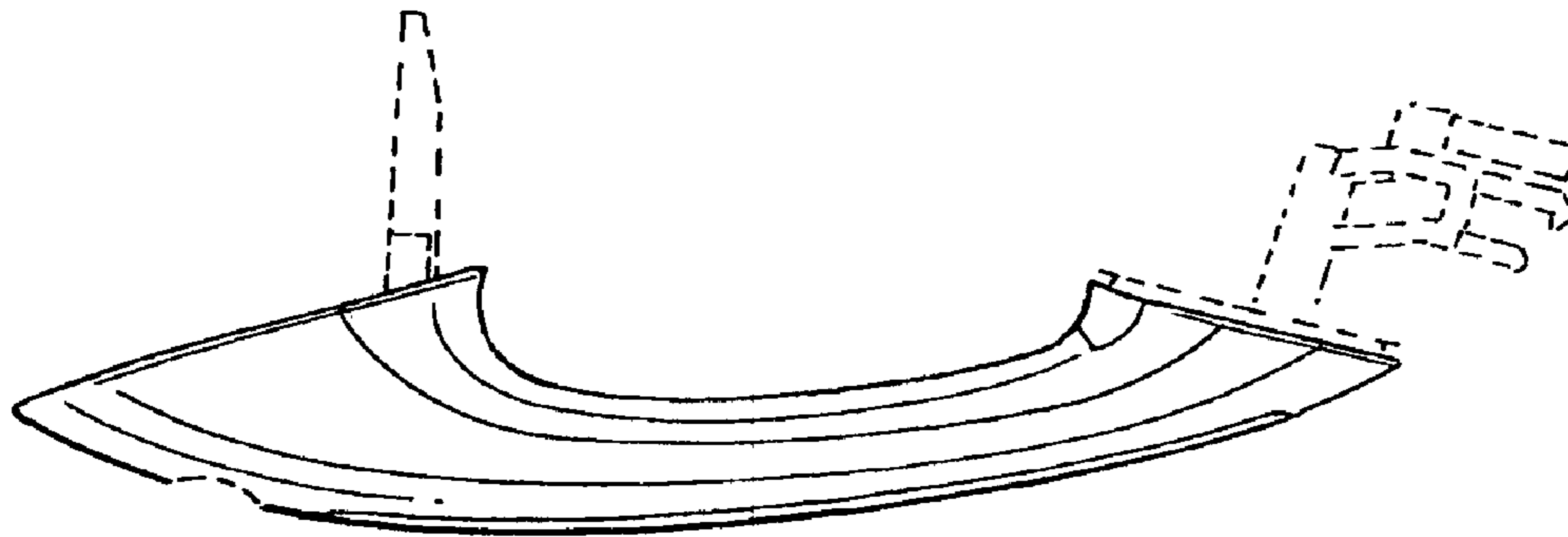

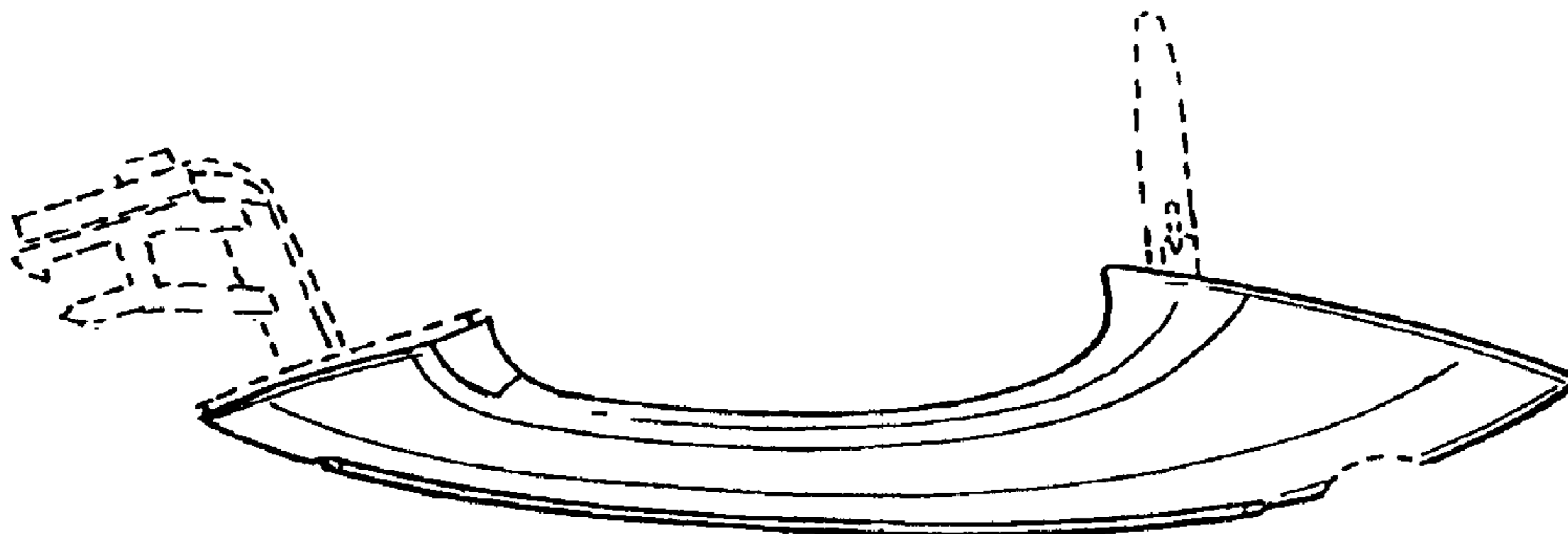

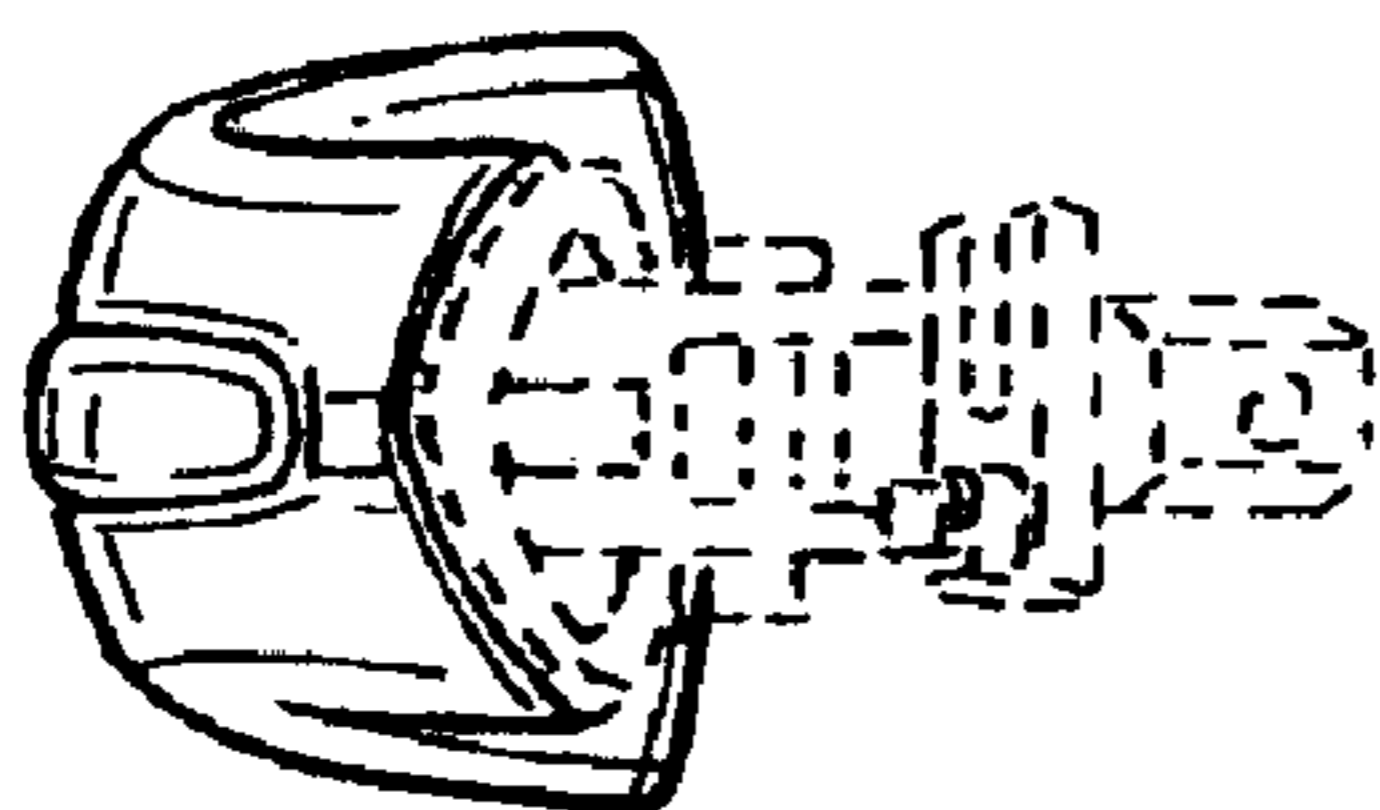

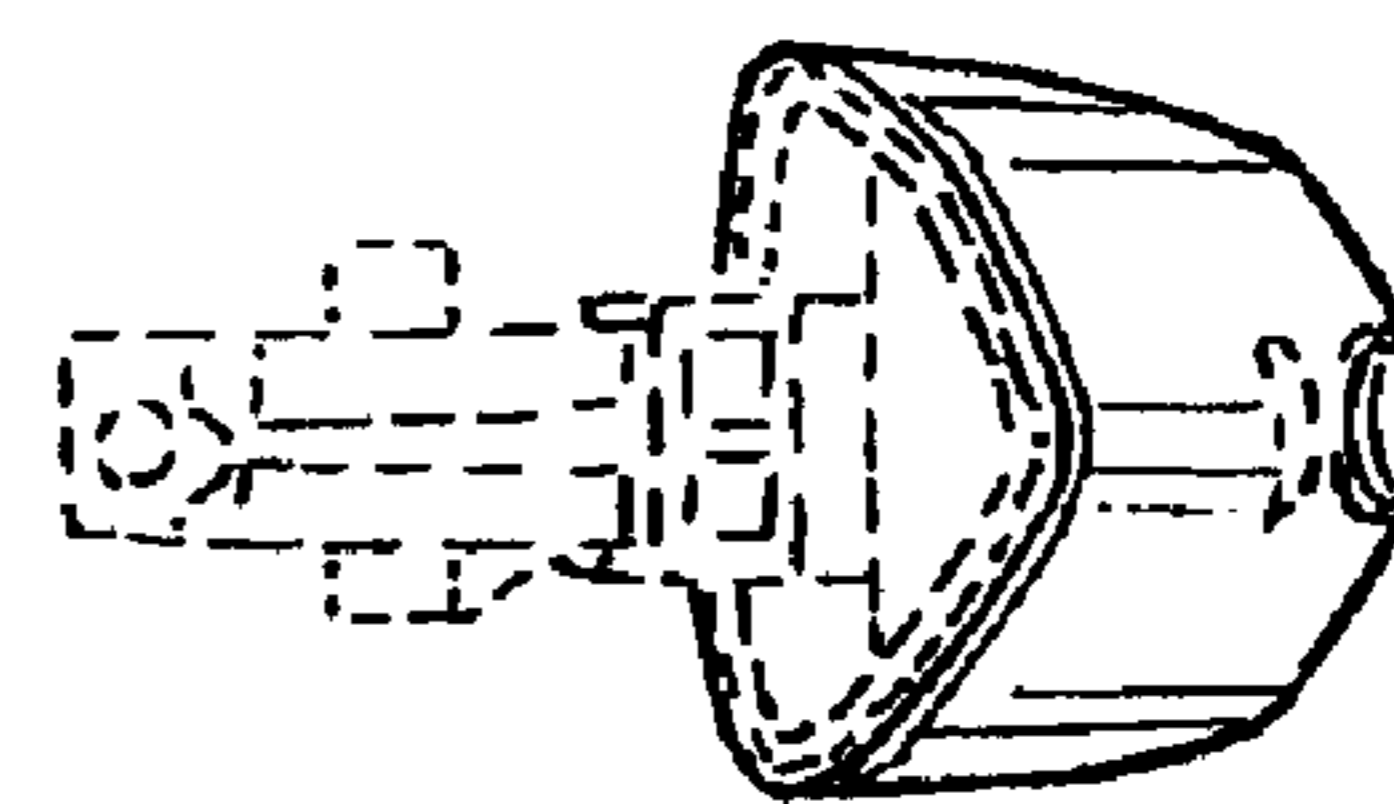
