DESCRIPTION

FIG. 1 is a front perspective view of a remote control showing
our new design;

FIG. 2 is a left side elevational view thereof, the right side
elevational view being a mirror image thereof;

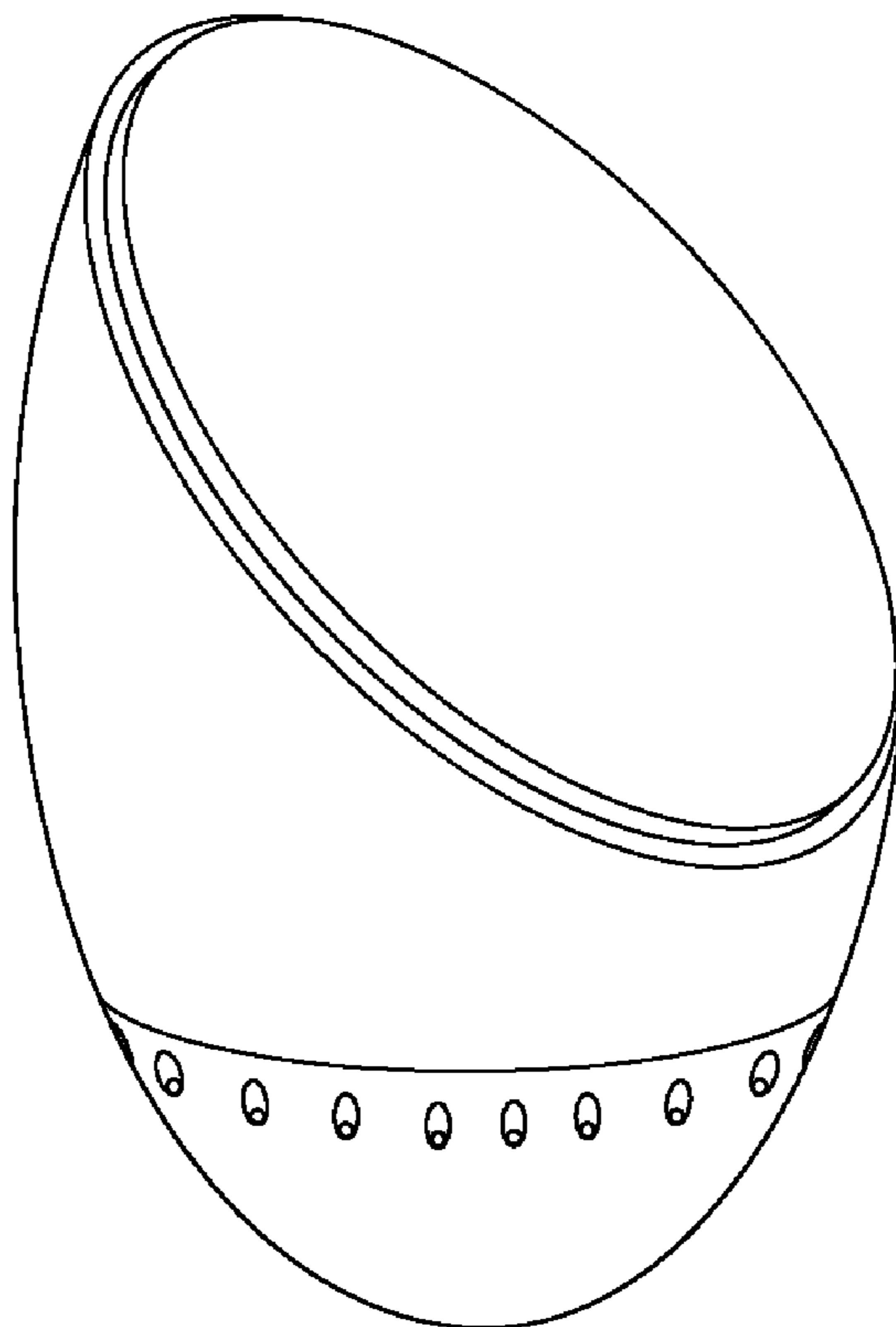
FIG. 3 is a front elevational view thereof;

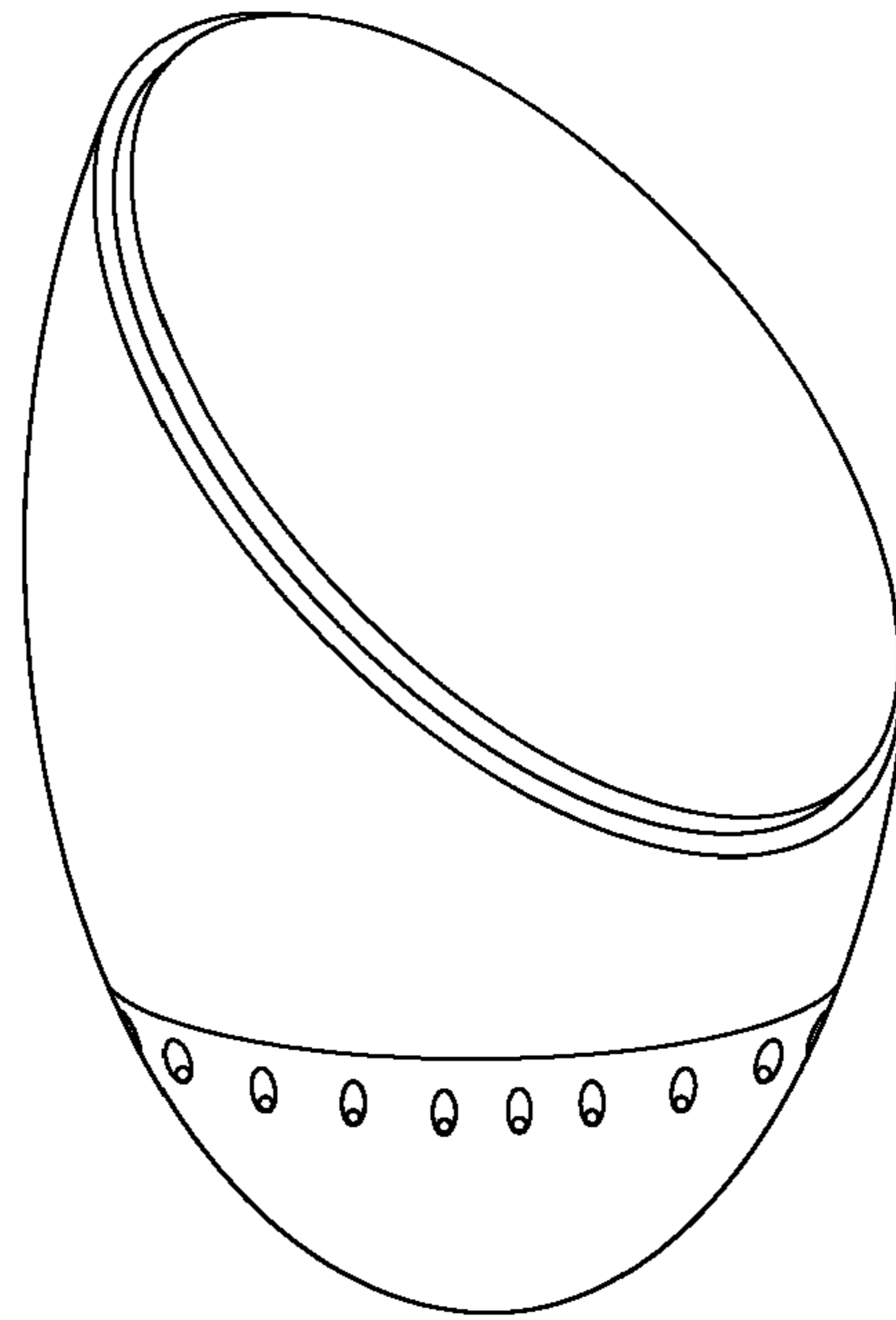

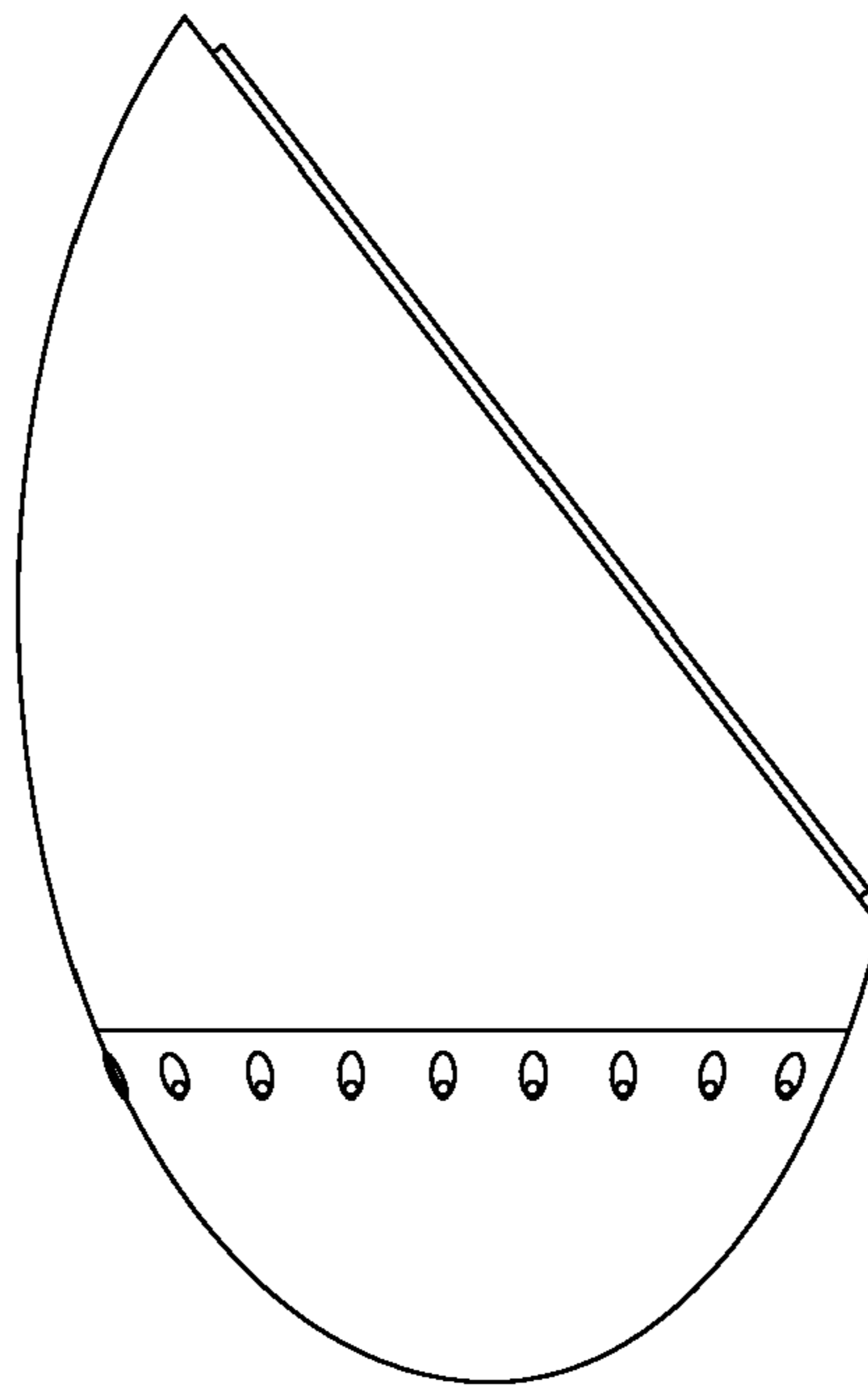

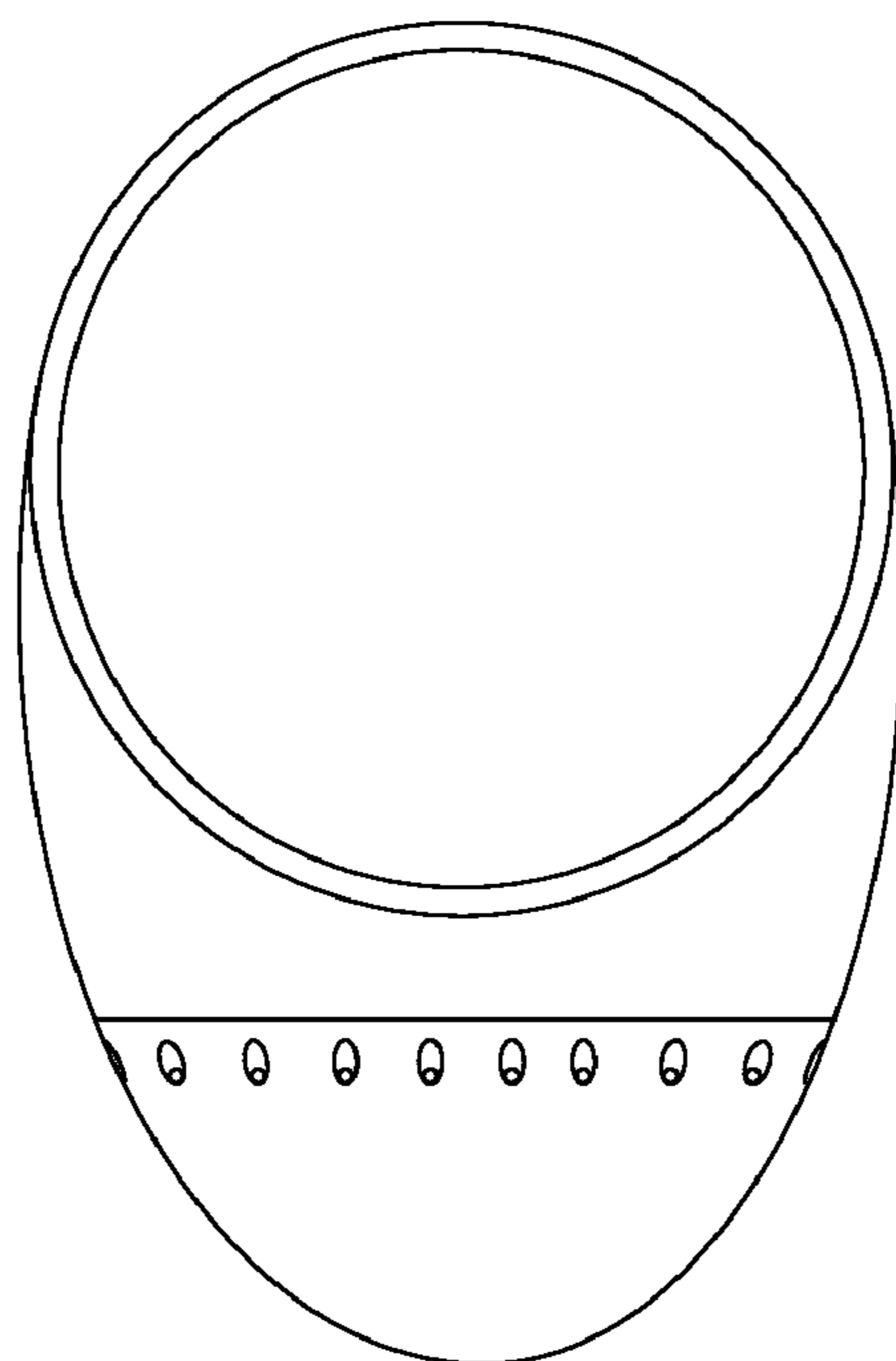

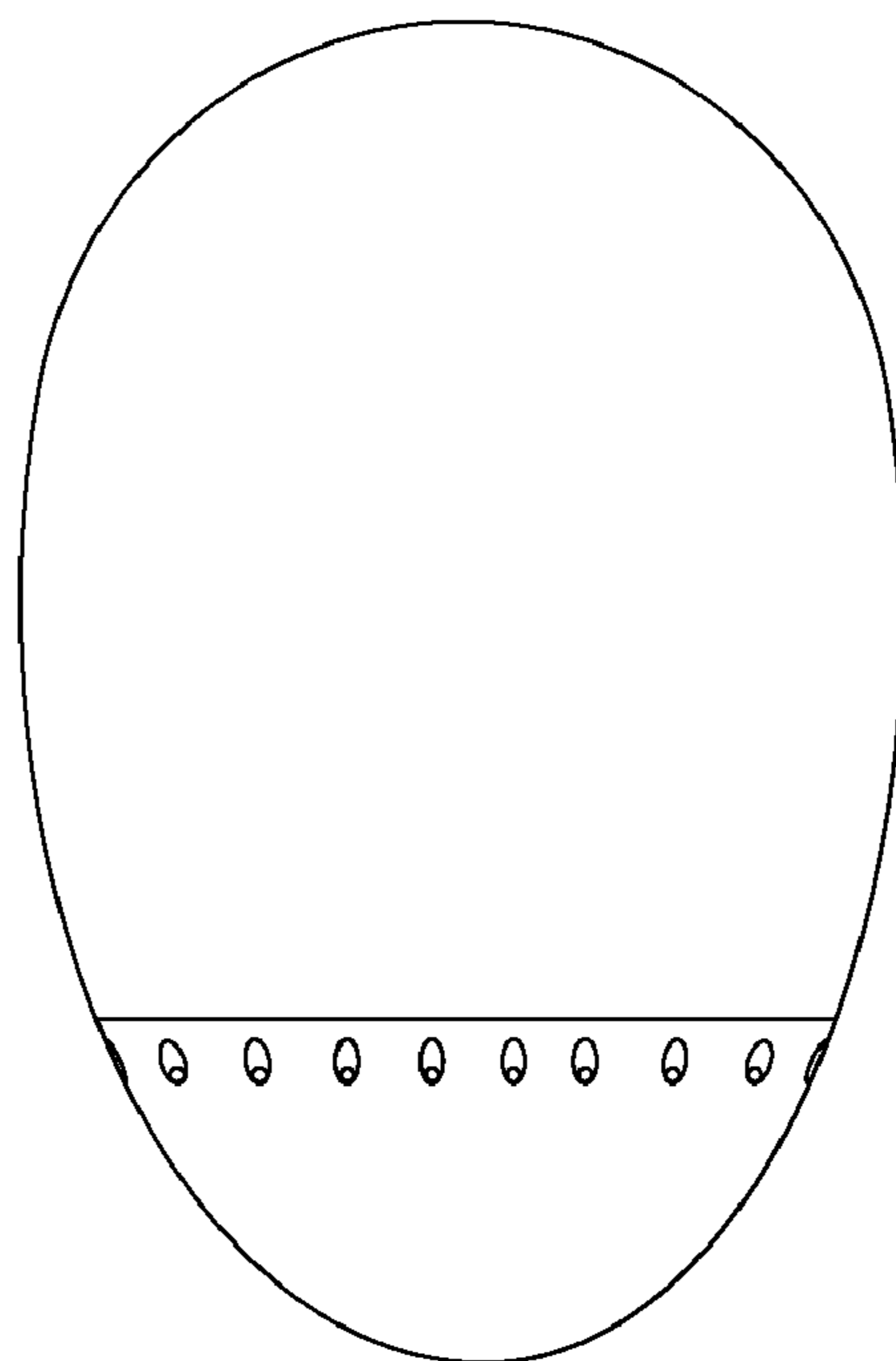

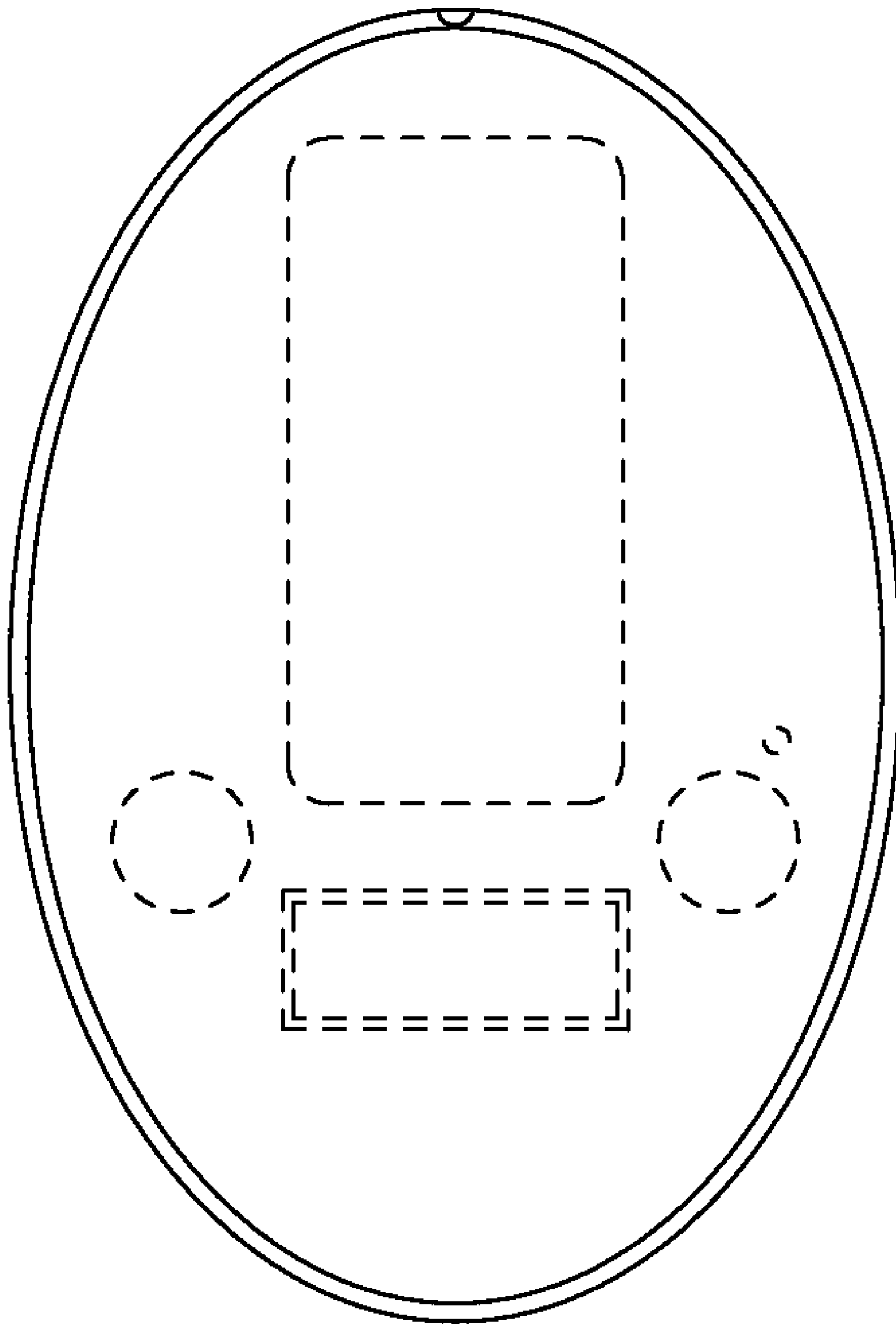
