The ornamental design for a mobile-phone, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view, in a folded position with the top portion slightly rotated to the right, of a mobile-phone showing my new design;

FIG. 15 is a rear elevational view thereof;

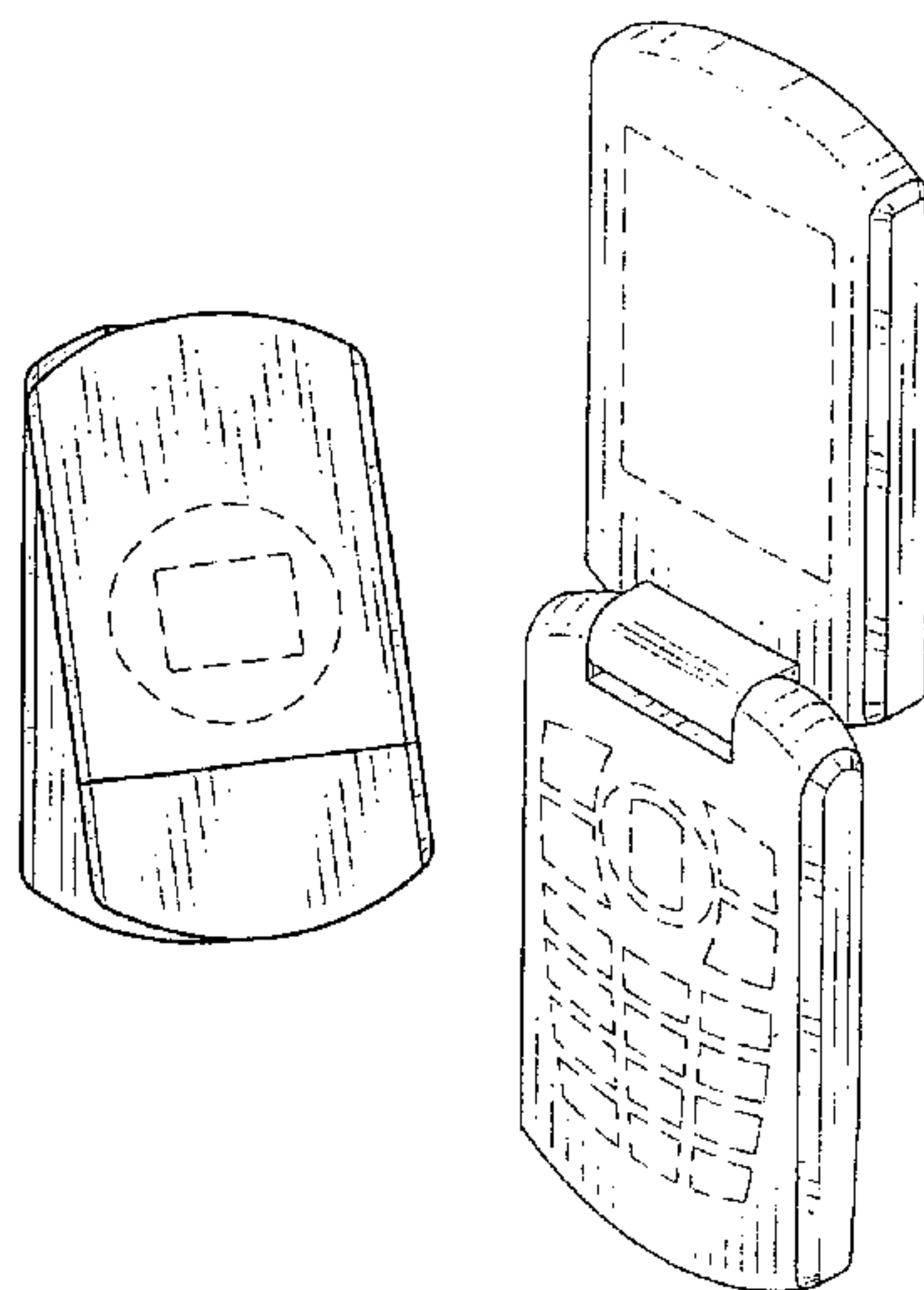
FIG. 16 is a top plan view thereof;

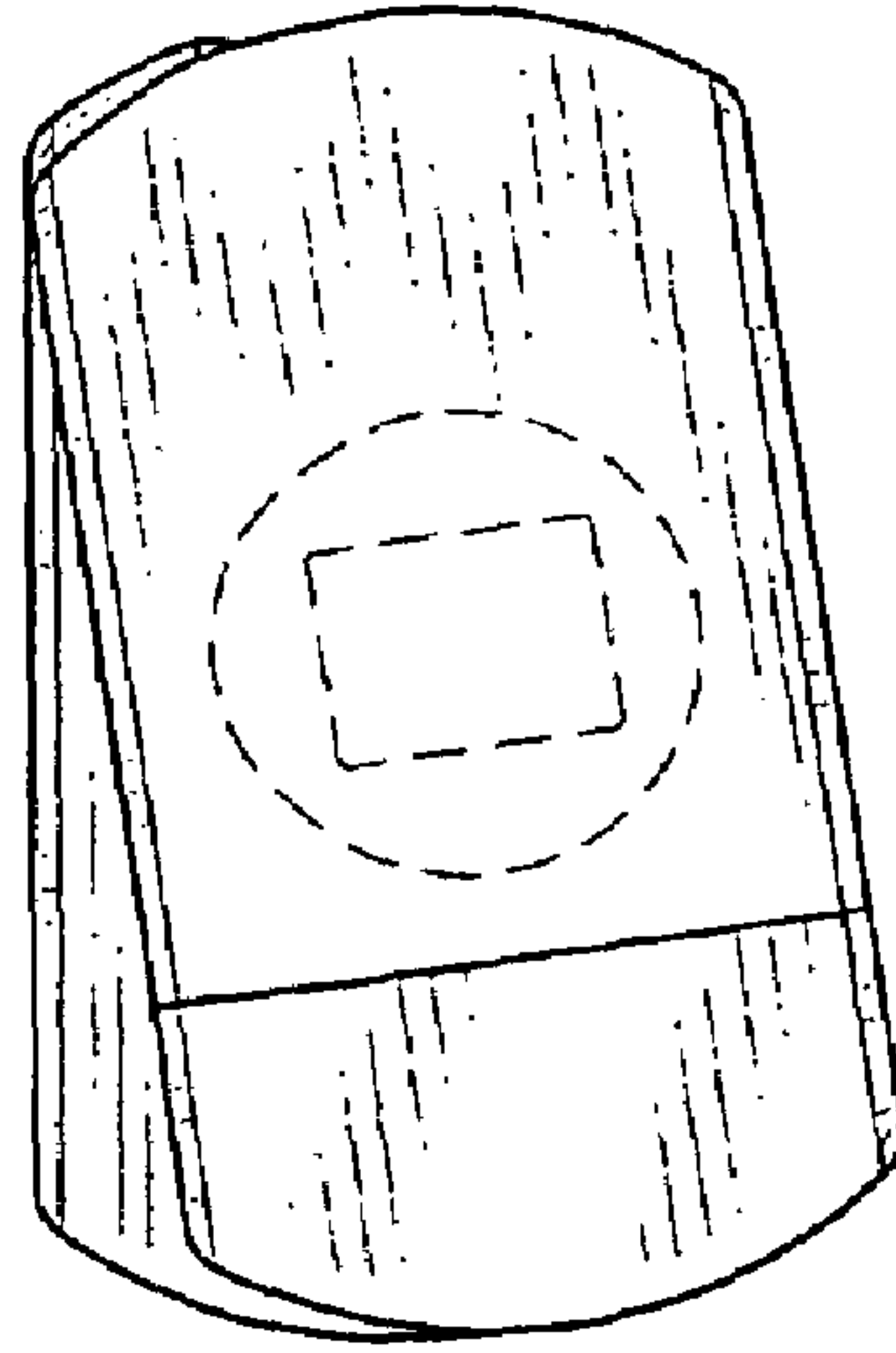

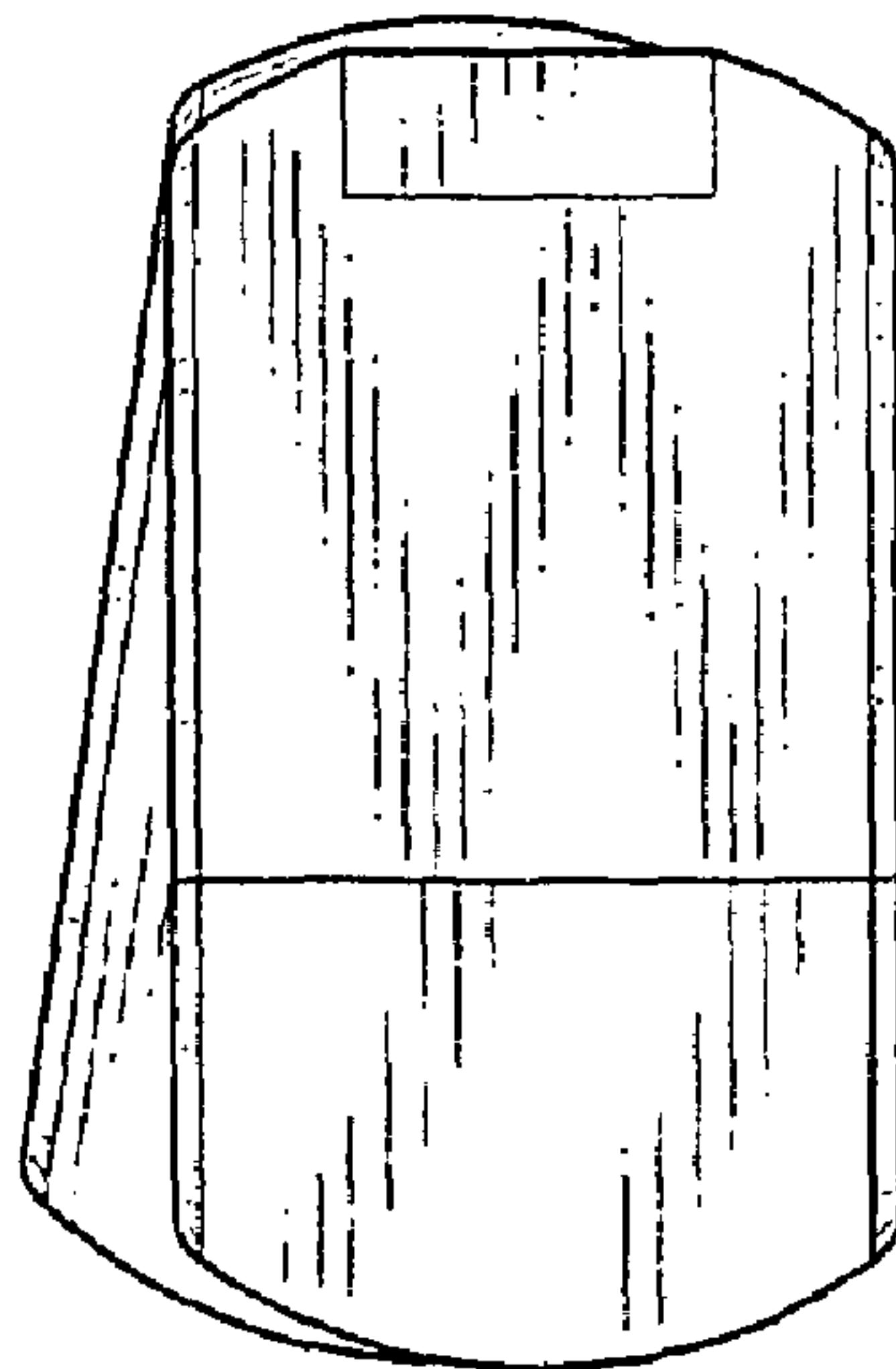

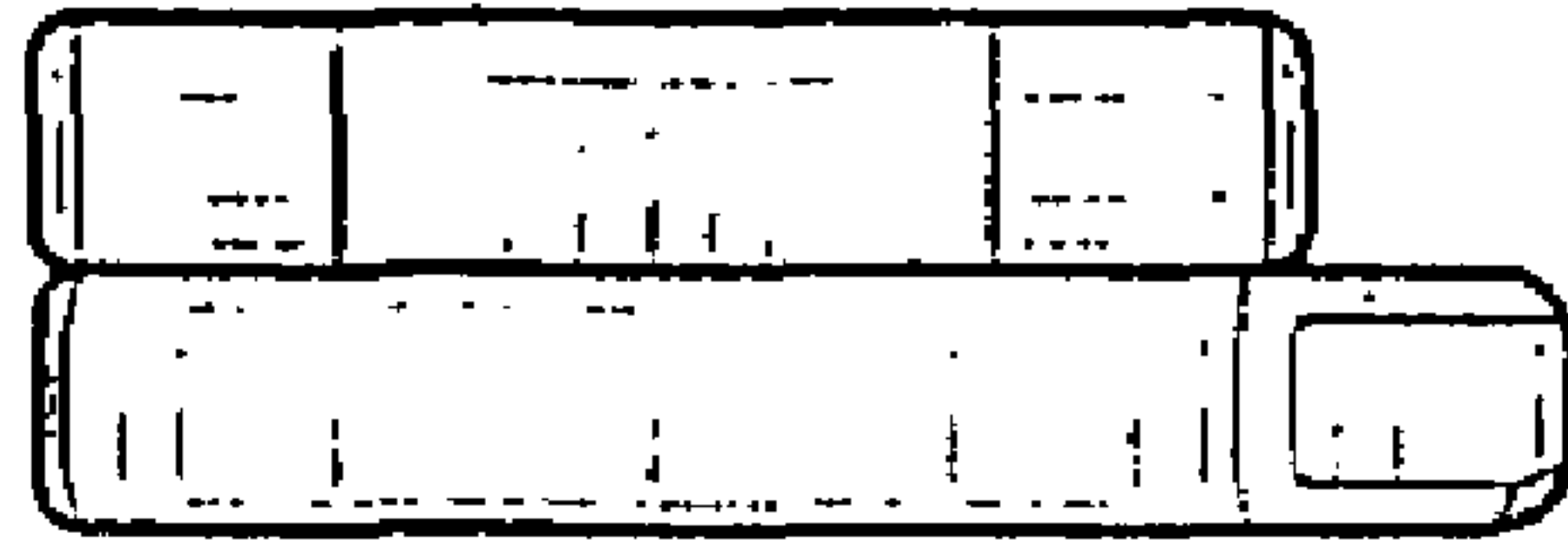

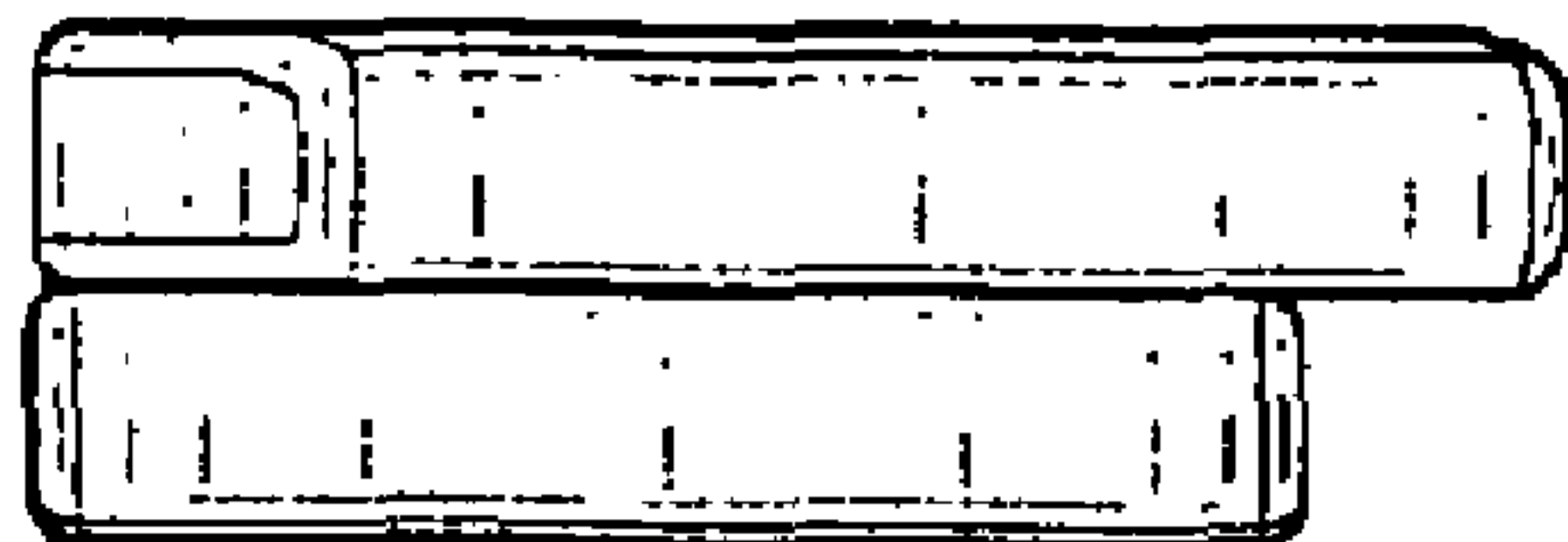

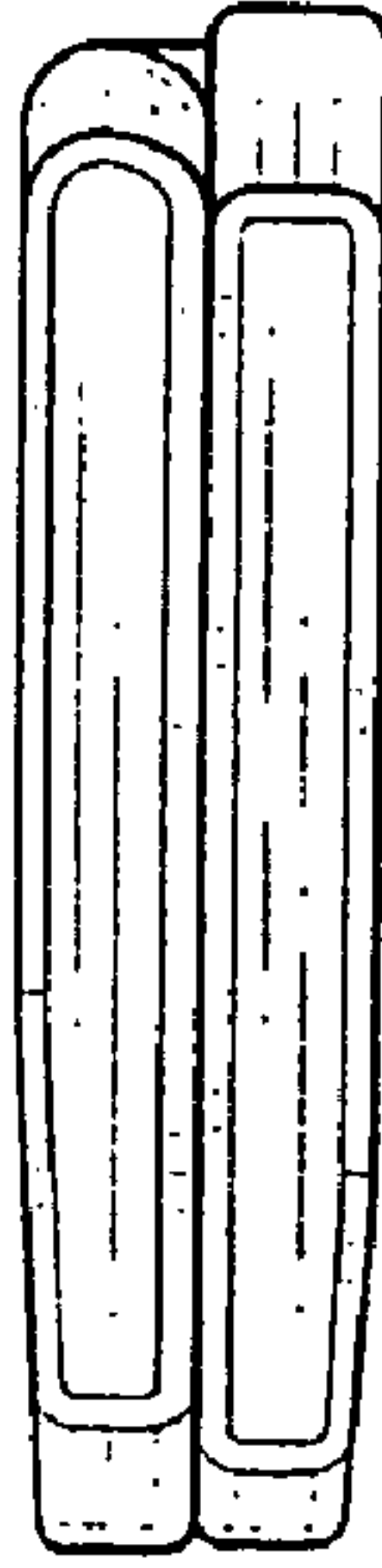

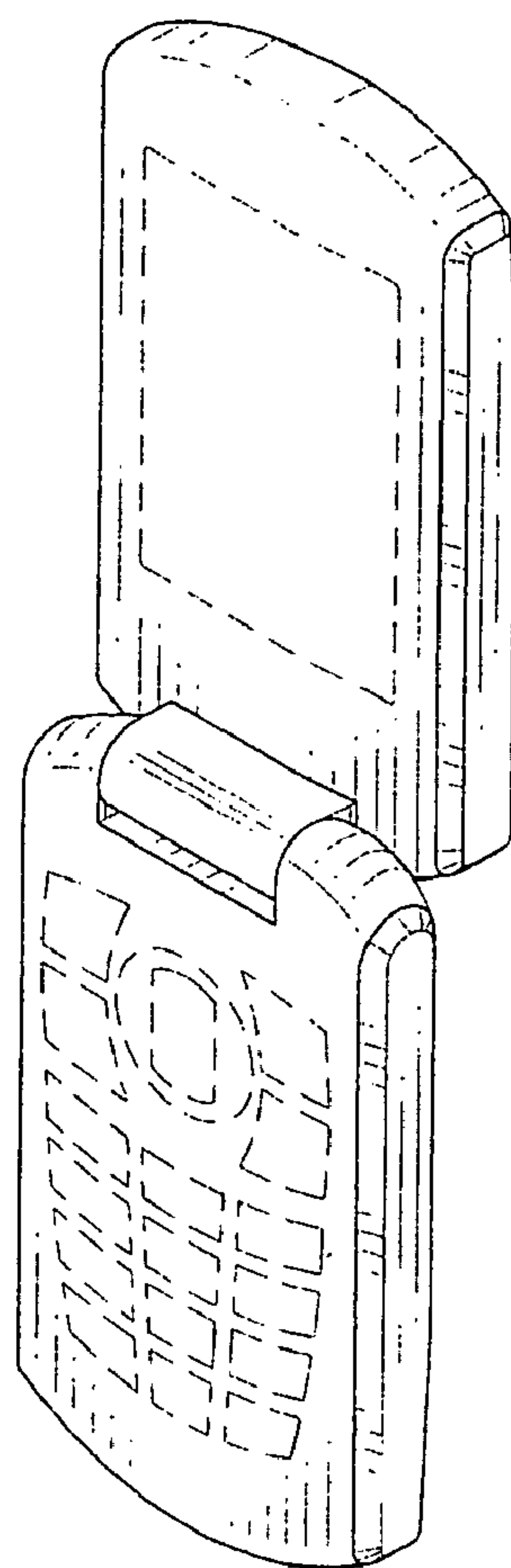

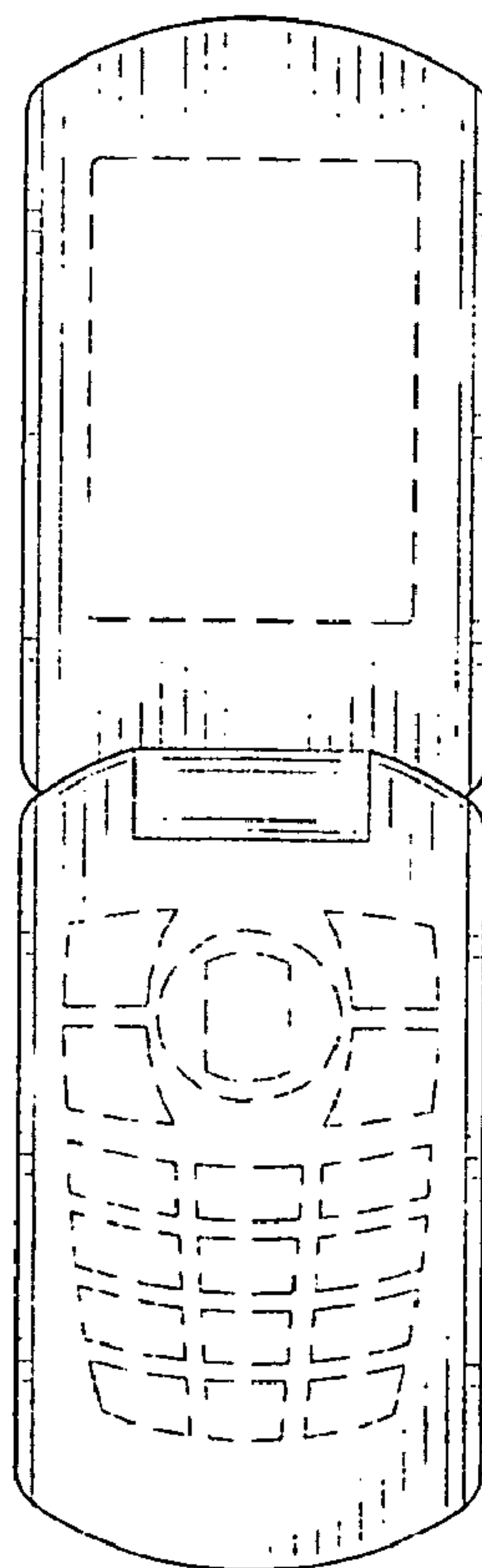

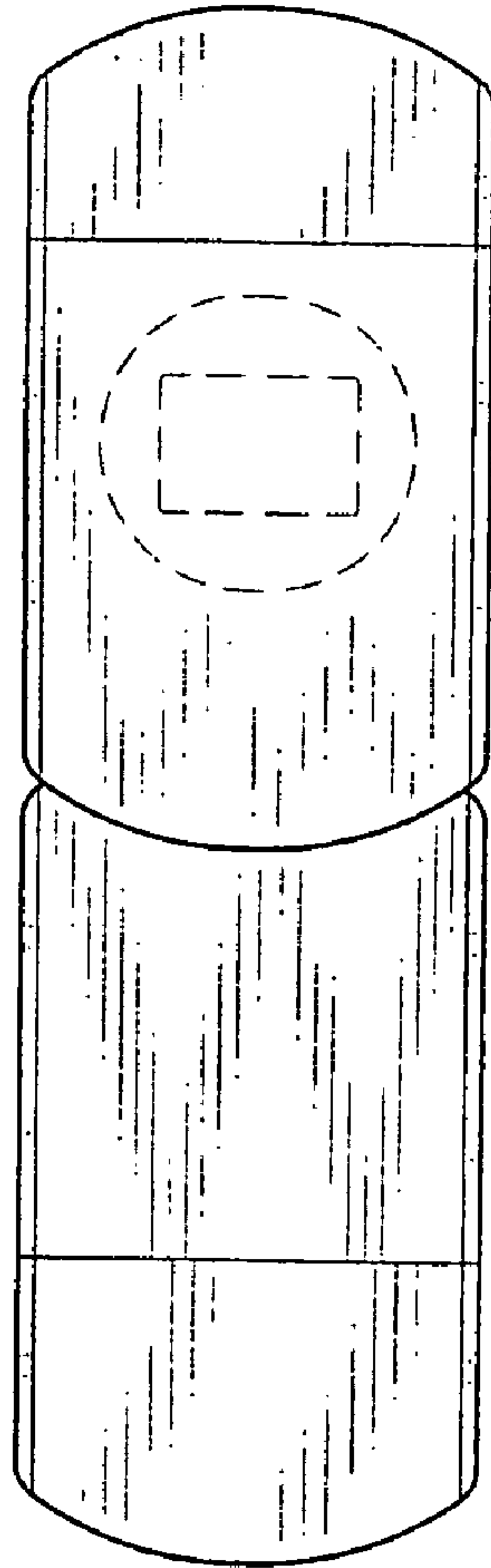

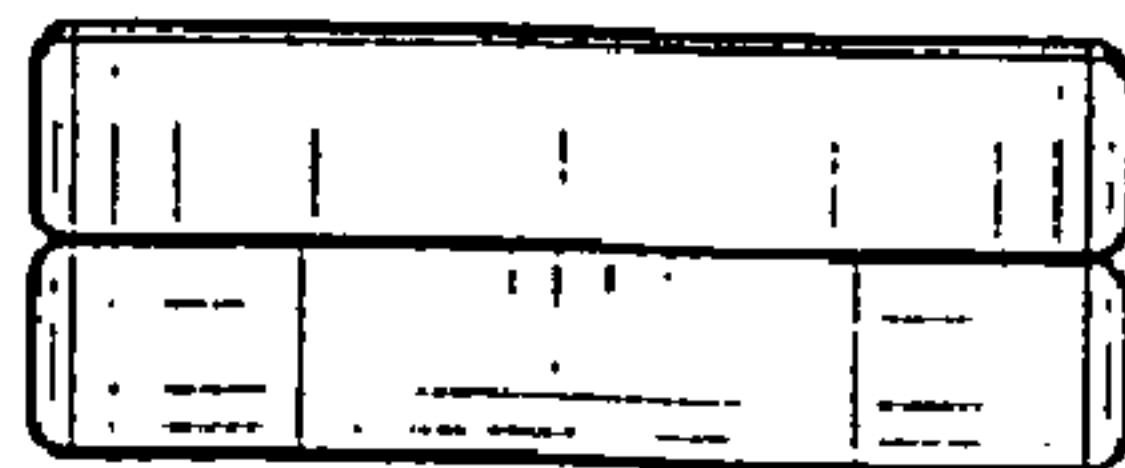

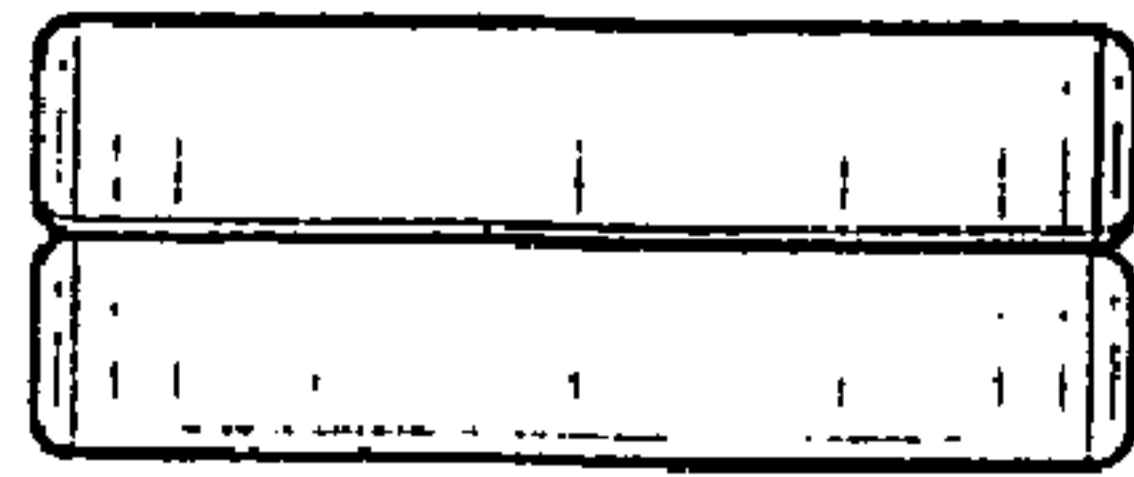

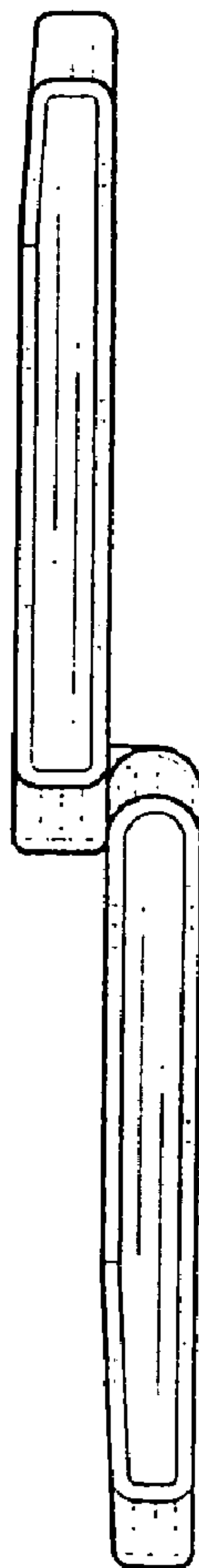

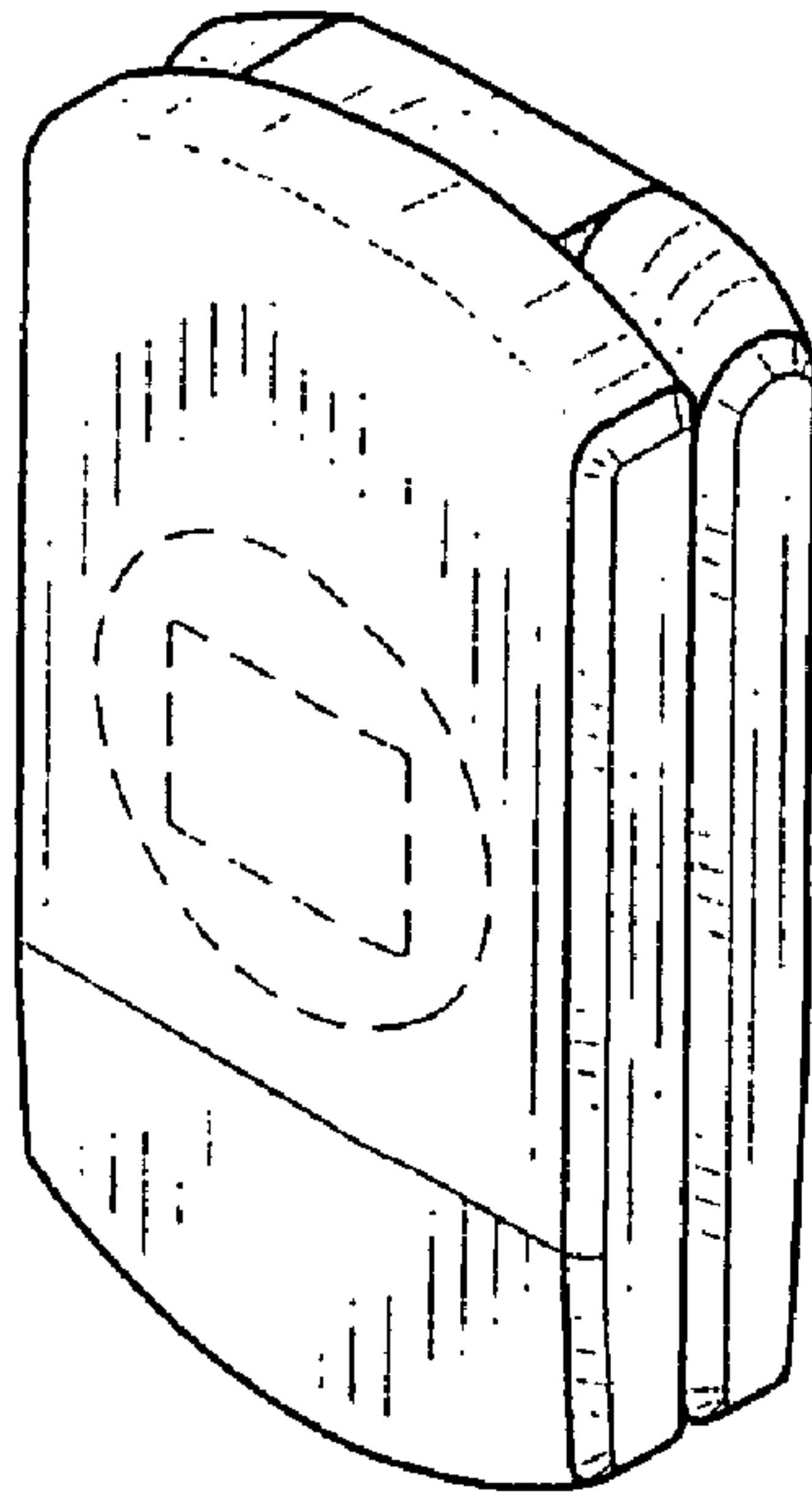

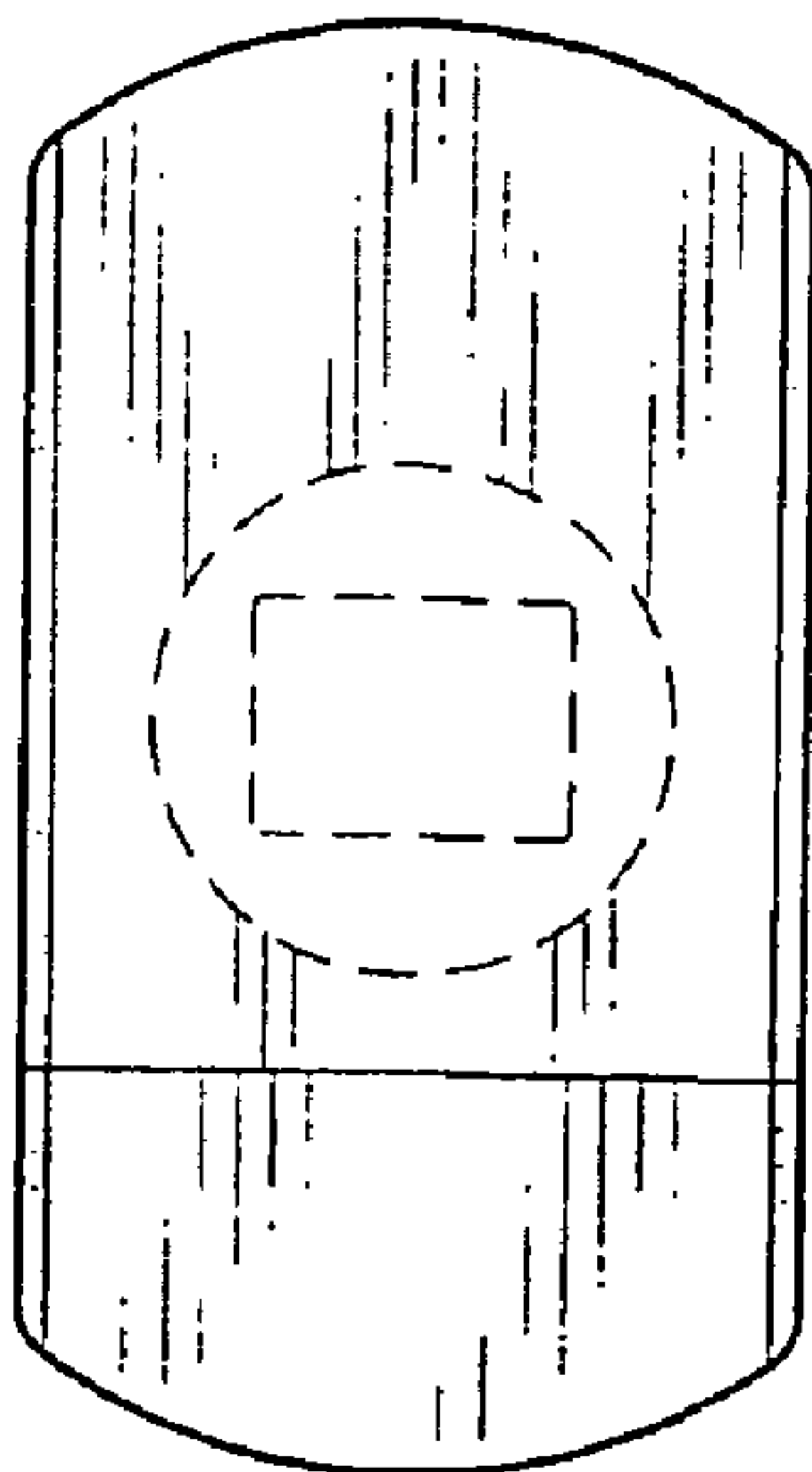

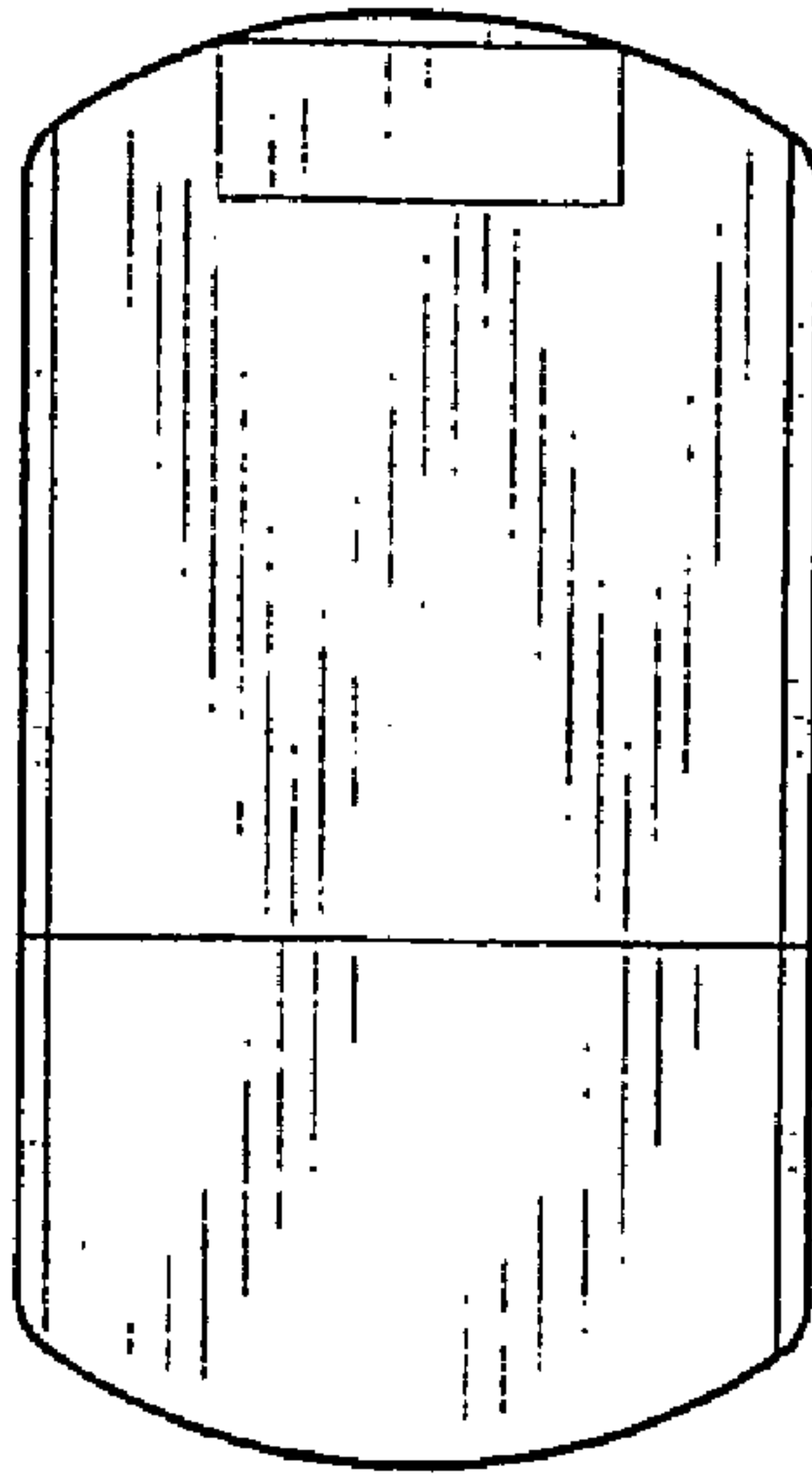

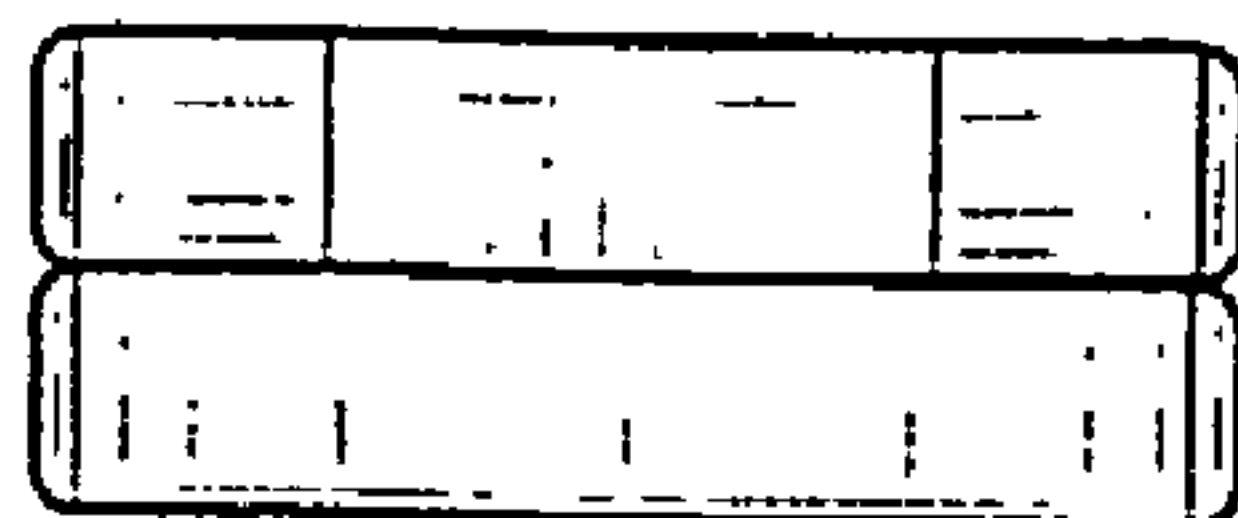

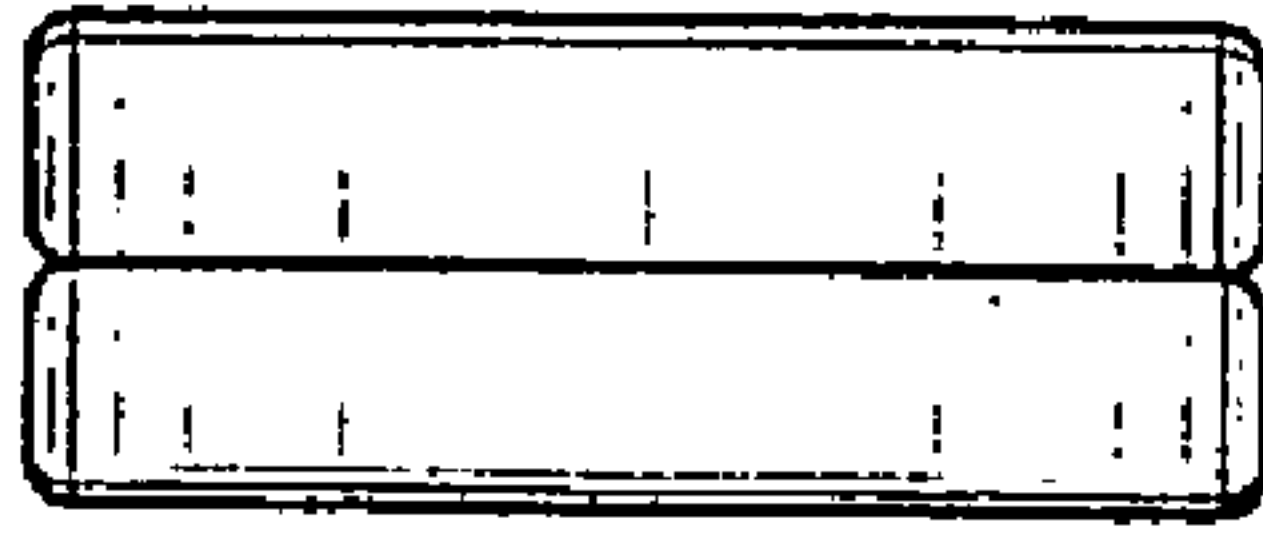
