DESCRIPTION

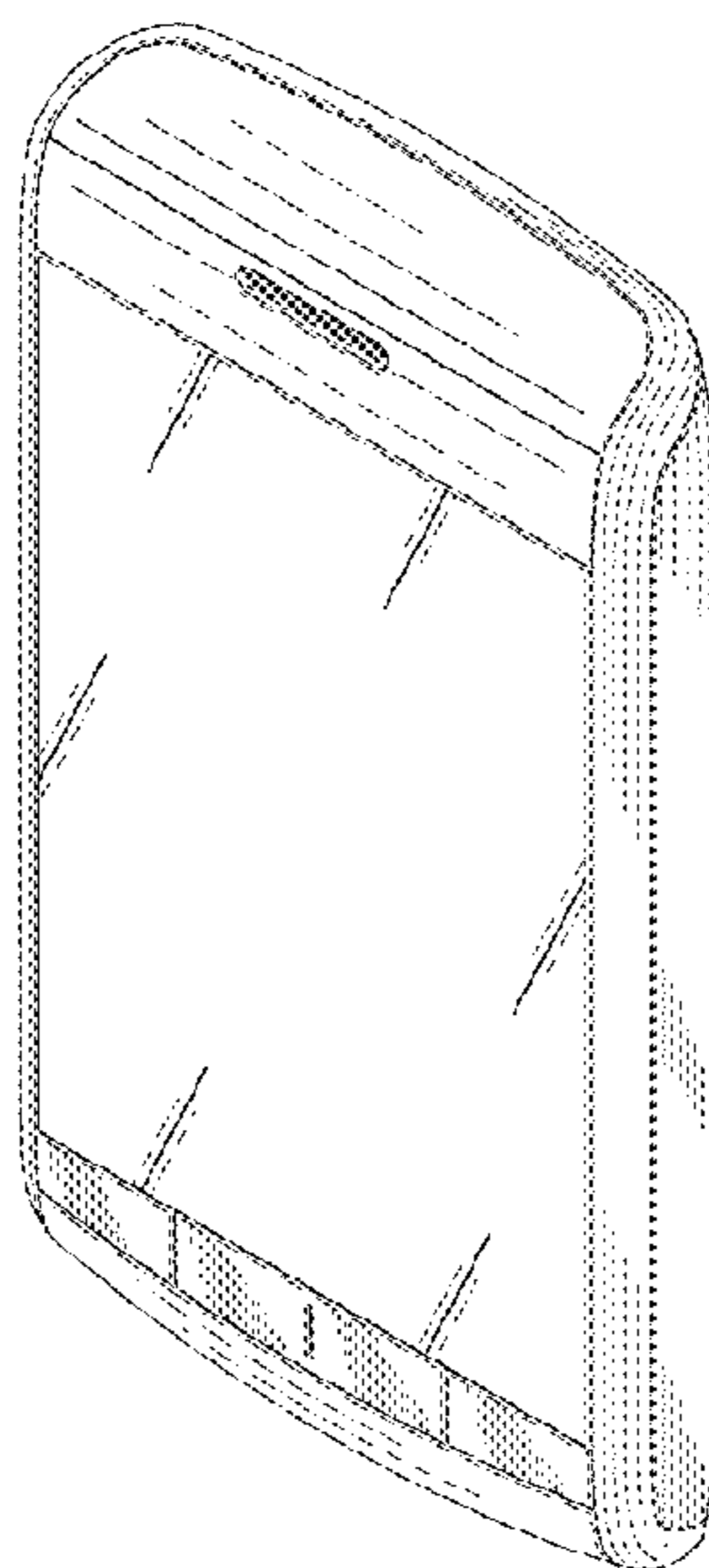
FIG. 1 is a front perspective view of the hand-held electronic device;

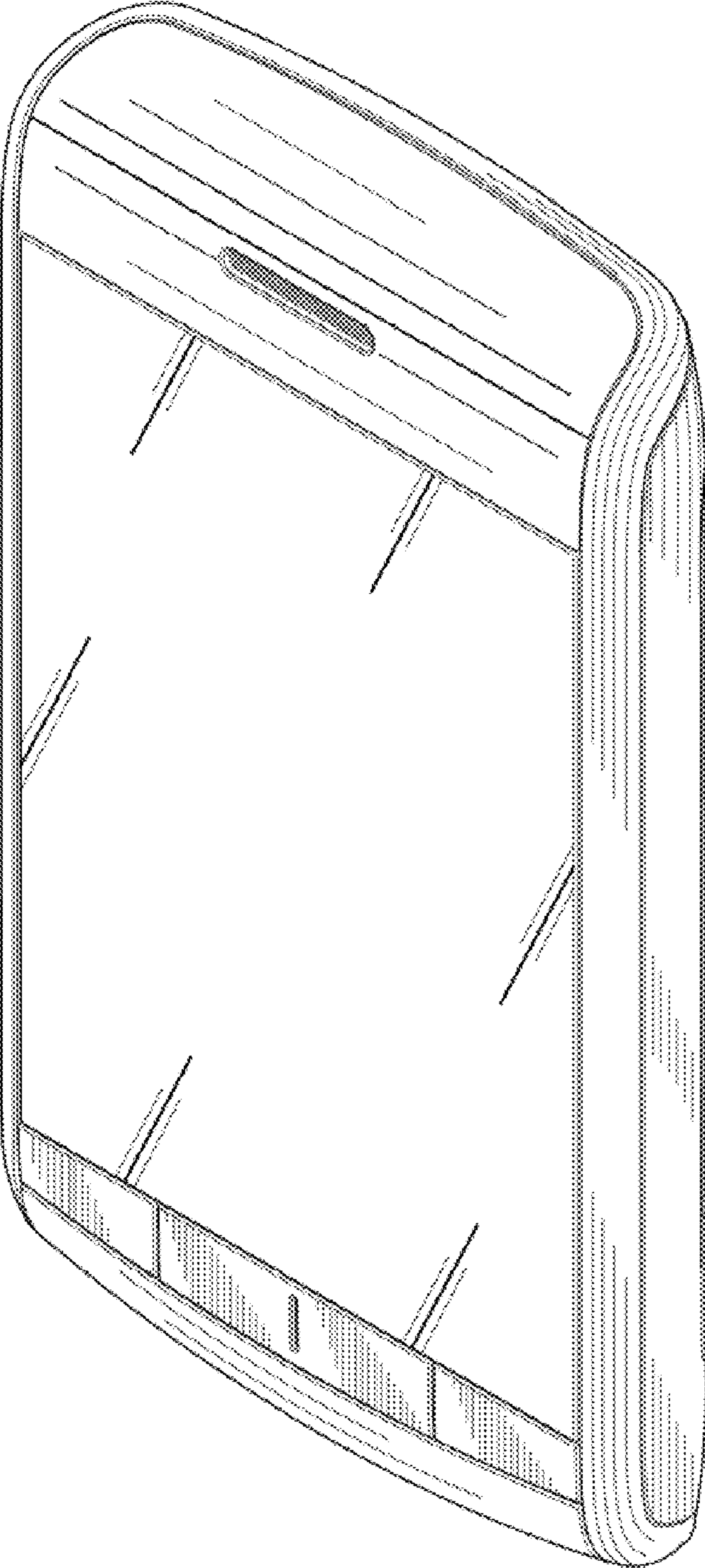

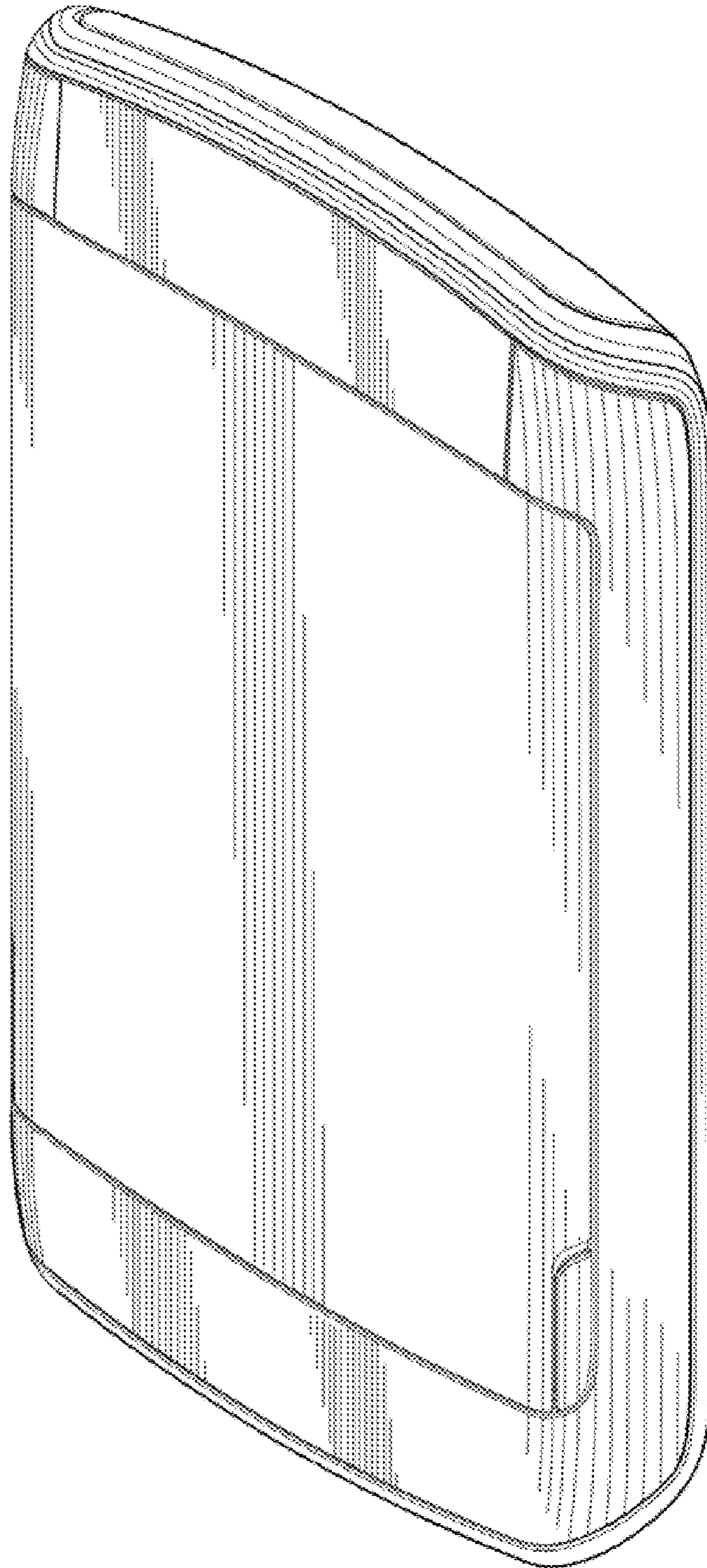

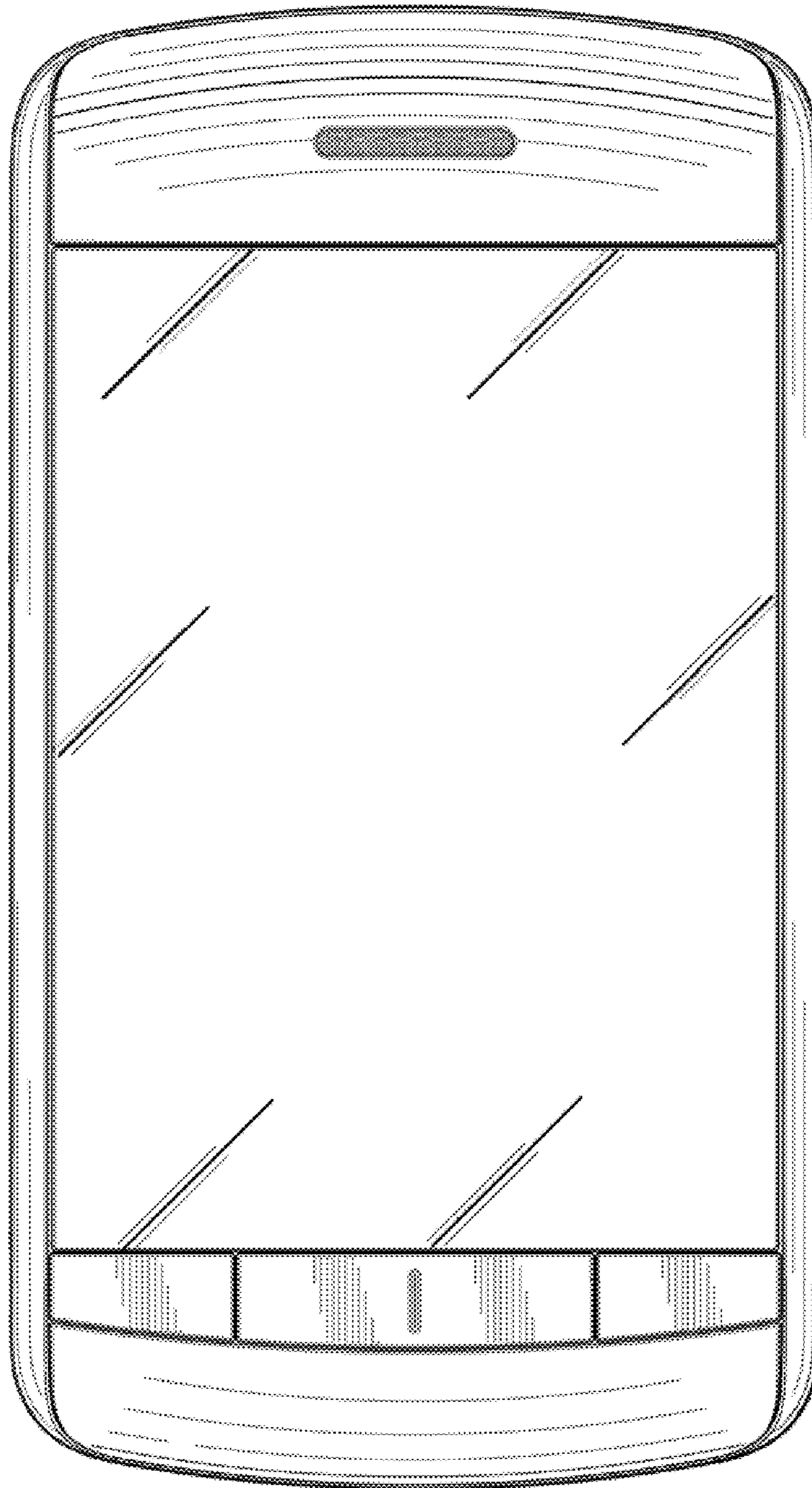

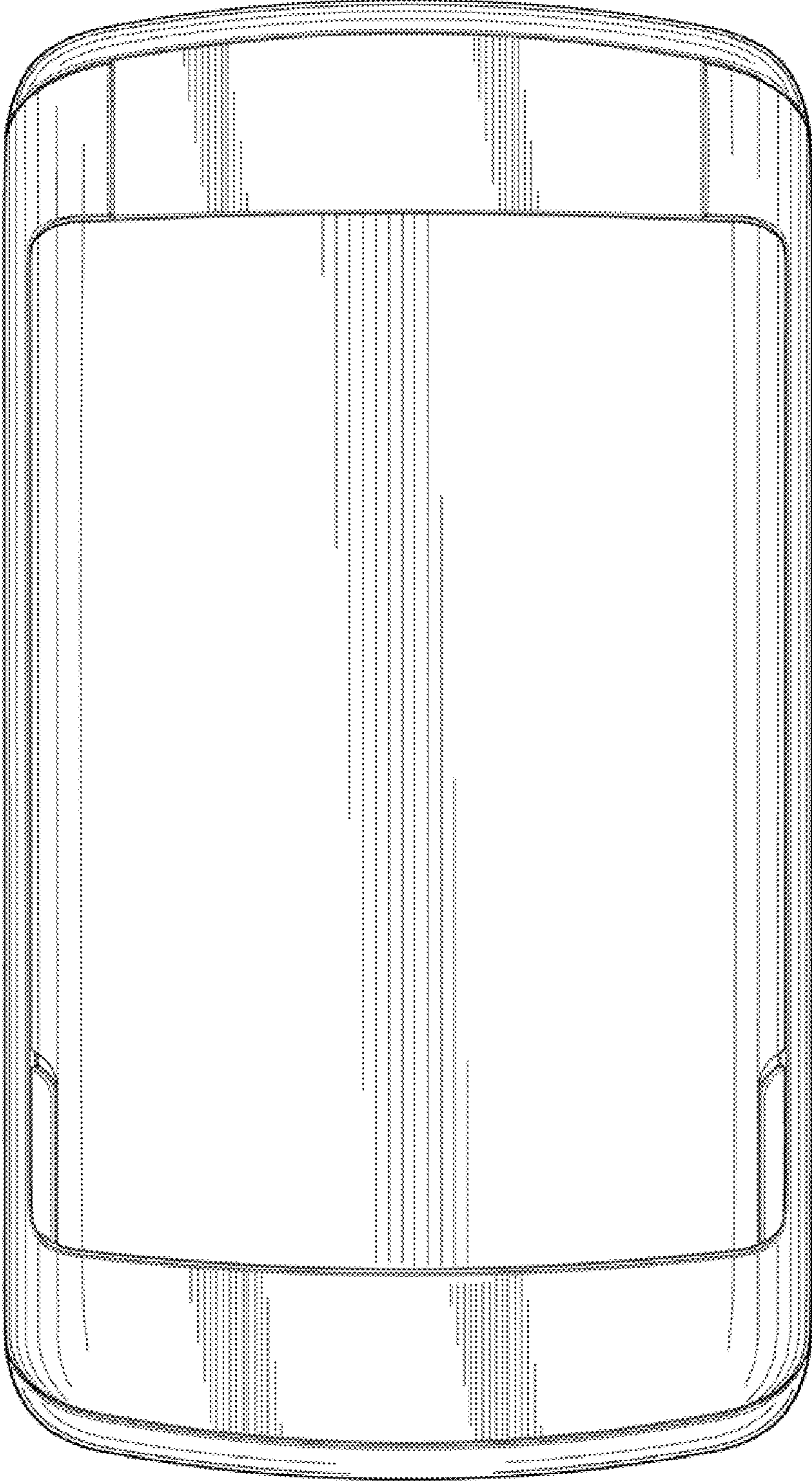

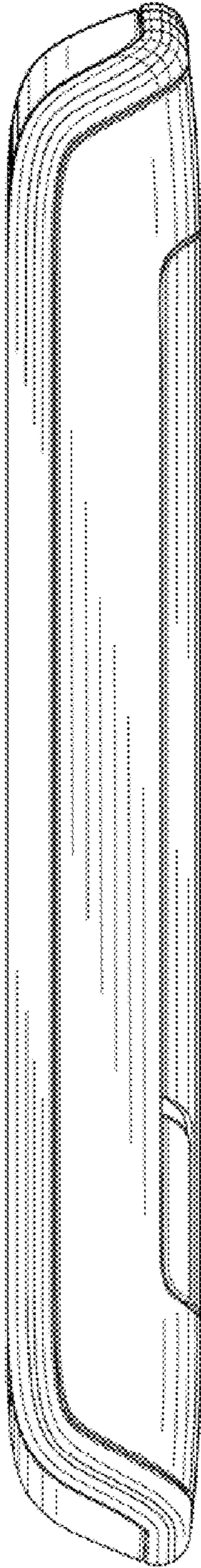

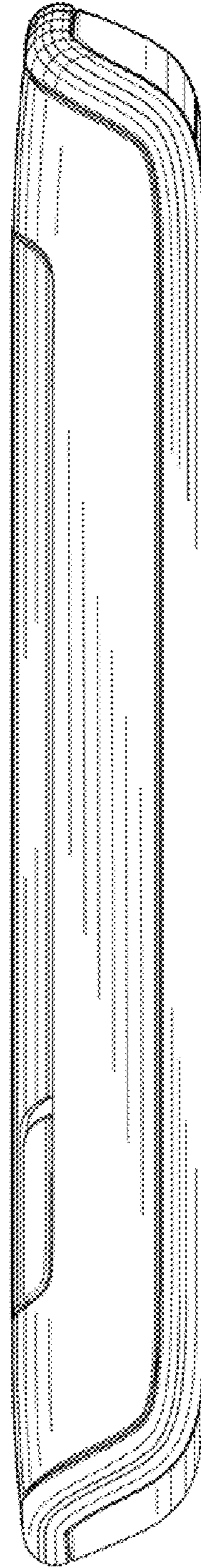

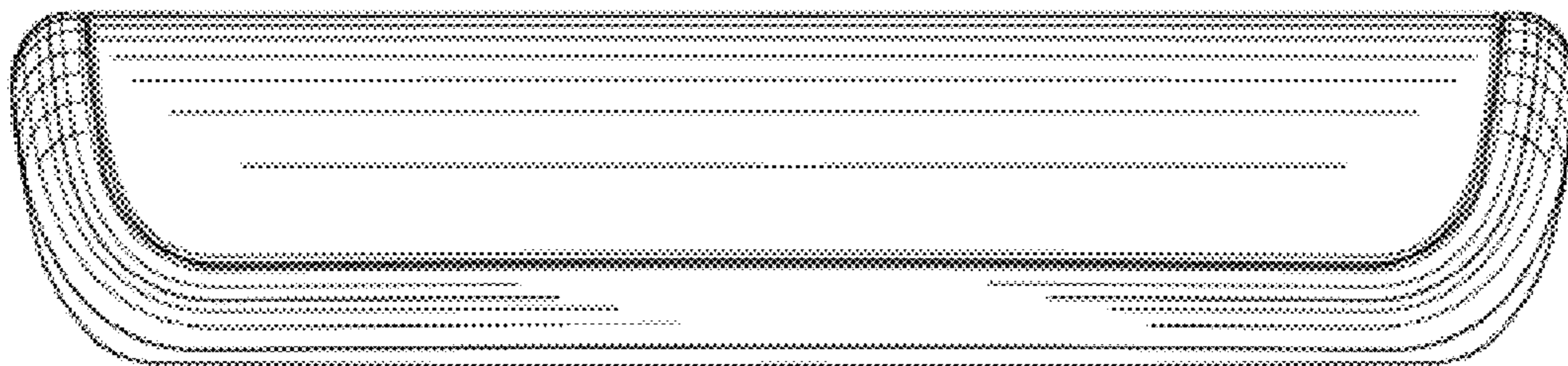

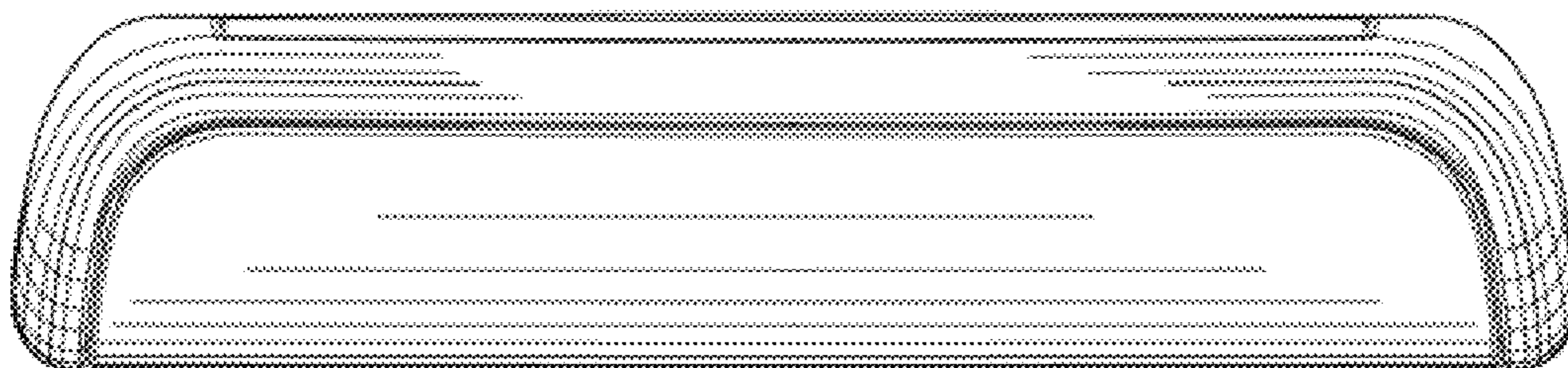
