FIG. 3 is a top view of the ballpoint pen;

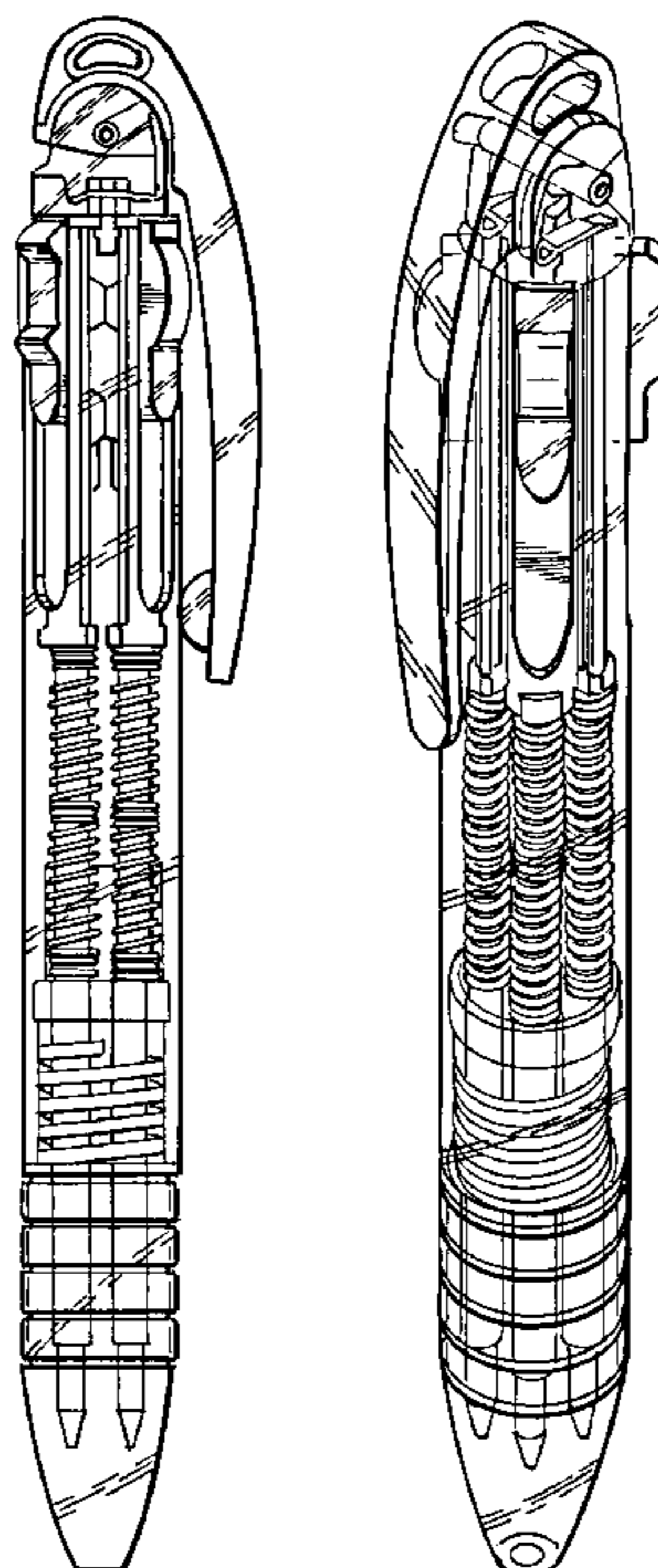
FIG. 4 is a bottom view of the ballpoint pen;

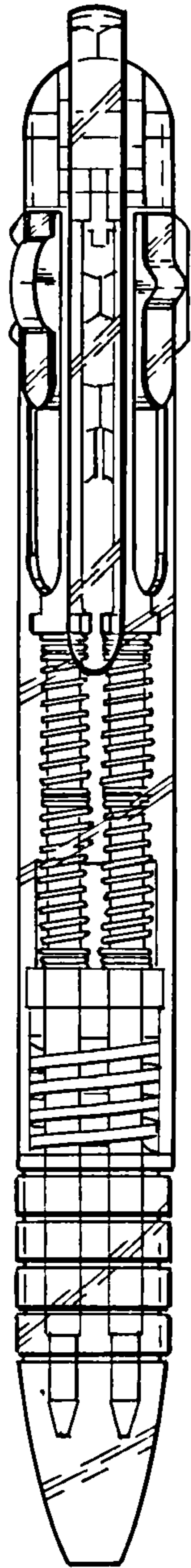
FIG. 5 is a right side view of the ballpoint pen;

FIG. 6 is a left side view of the ballpoint pen; and,

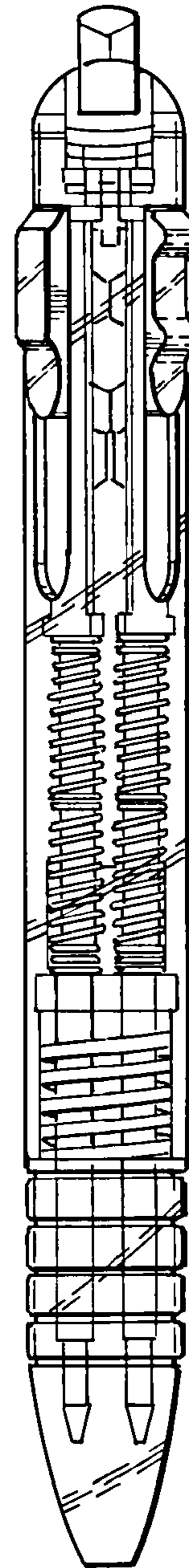
FIG. 7 is a perspective view of the ballpoint pen;

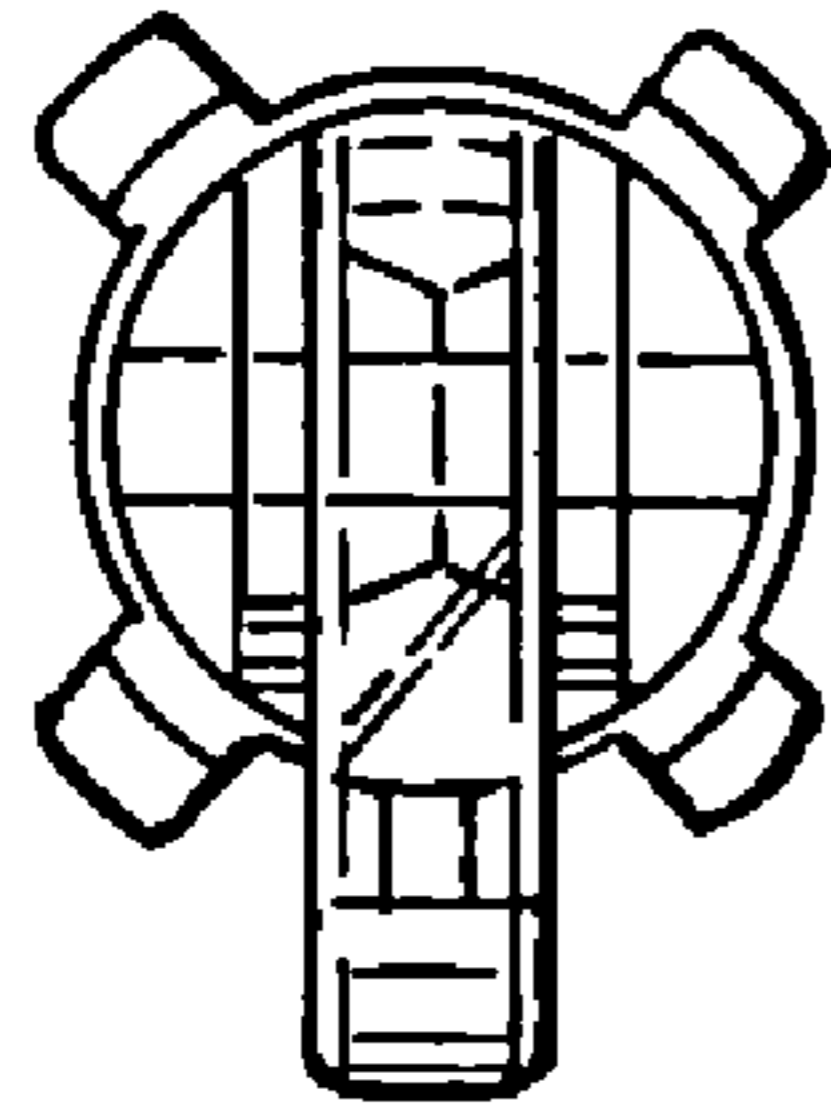




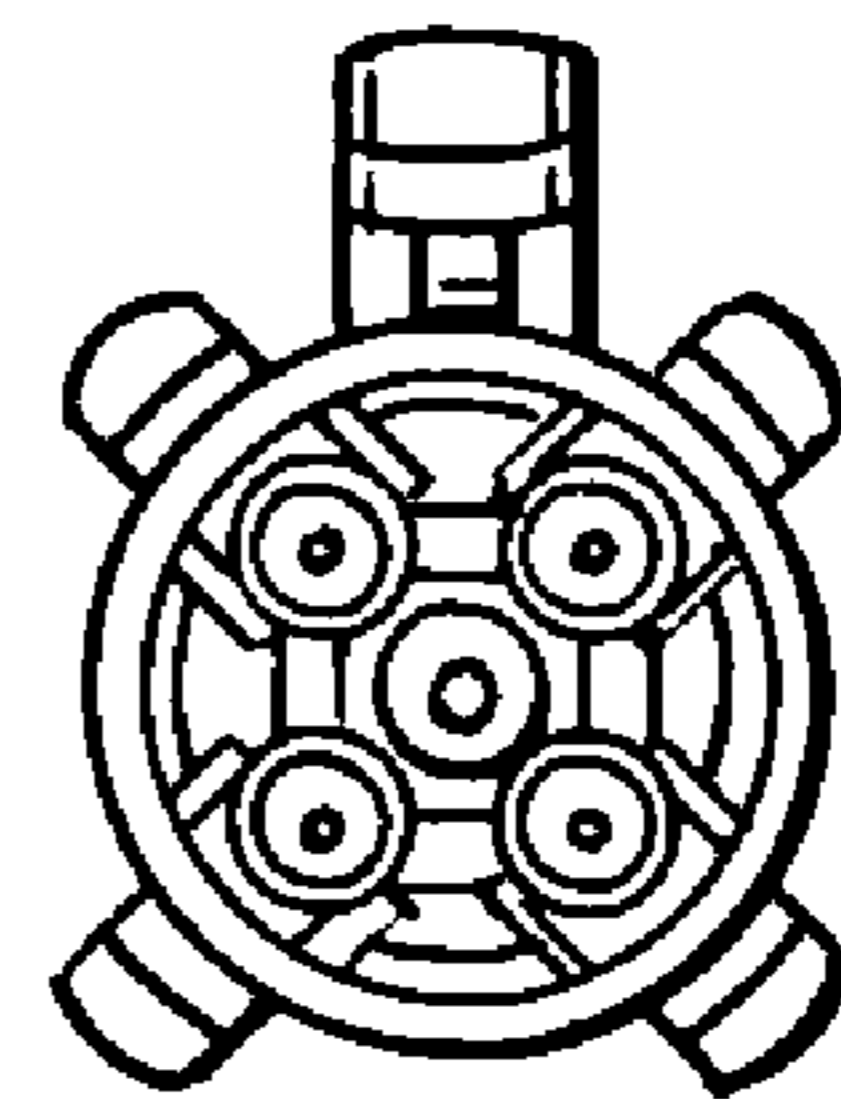

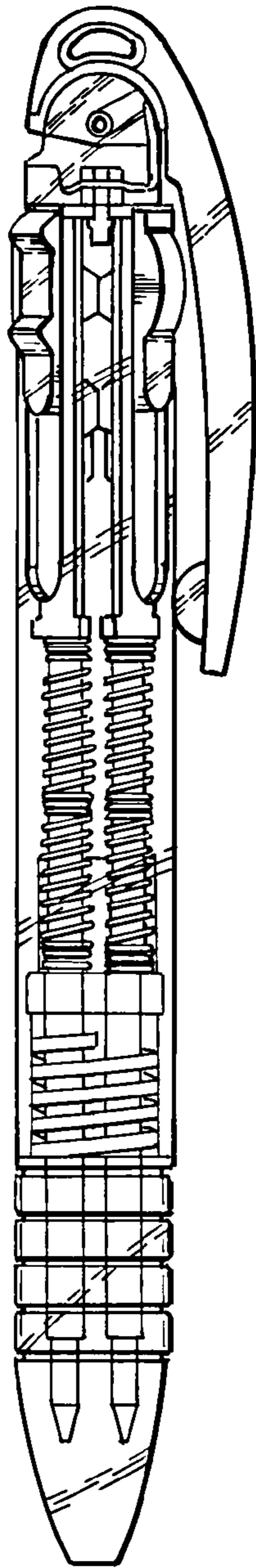

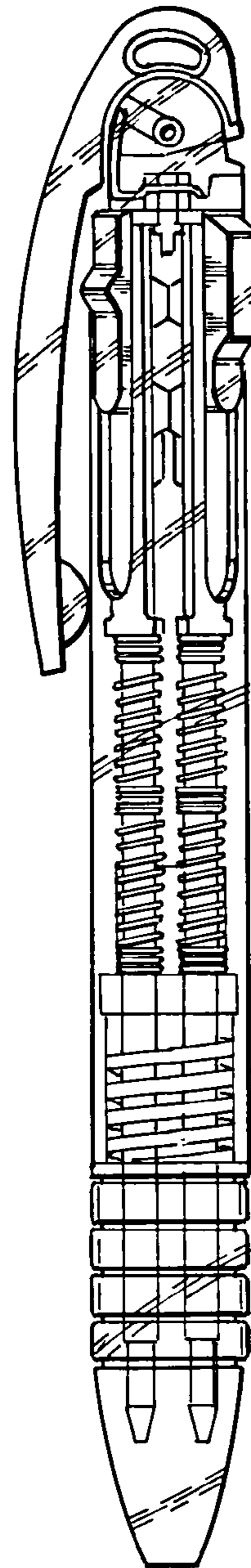

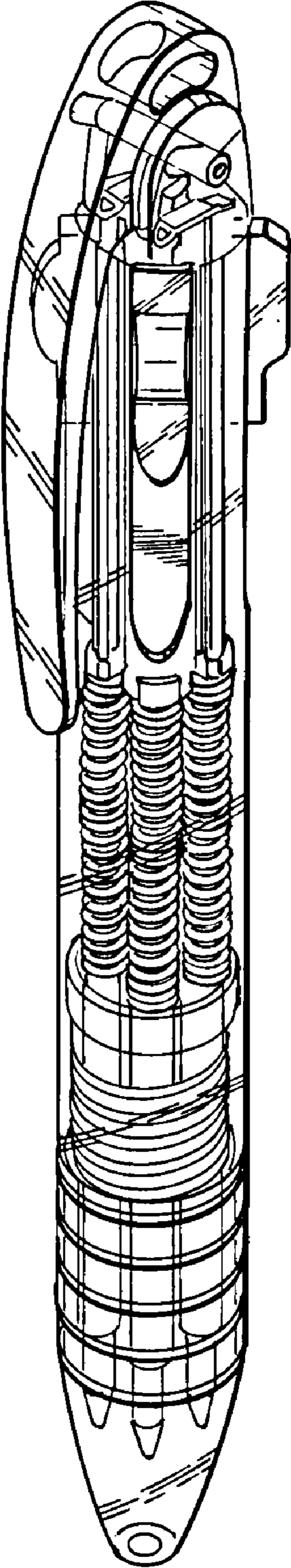
