(57) **CLAIM**

What is claimed is the ornamental design for a carpenter's pencil, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a carpenter's pencil showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

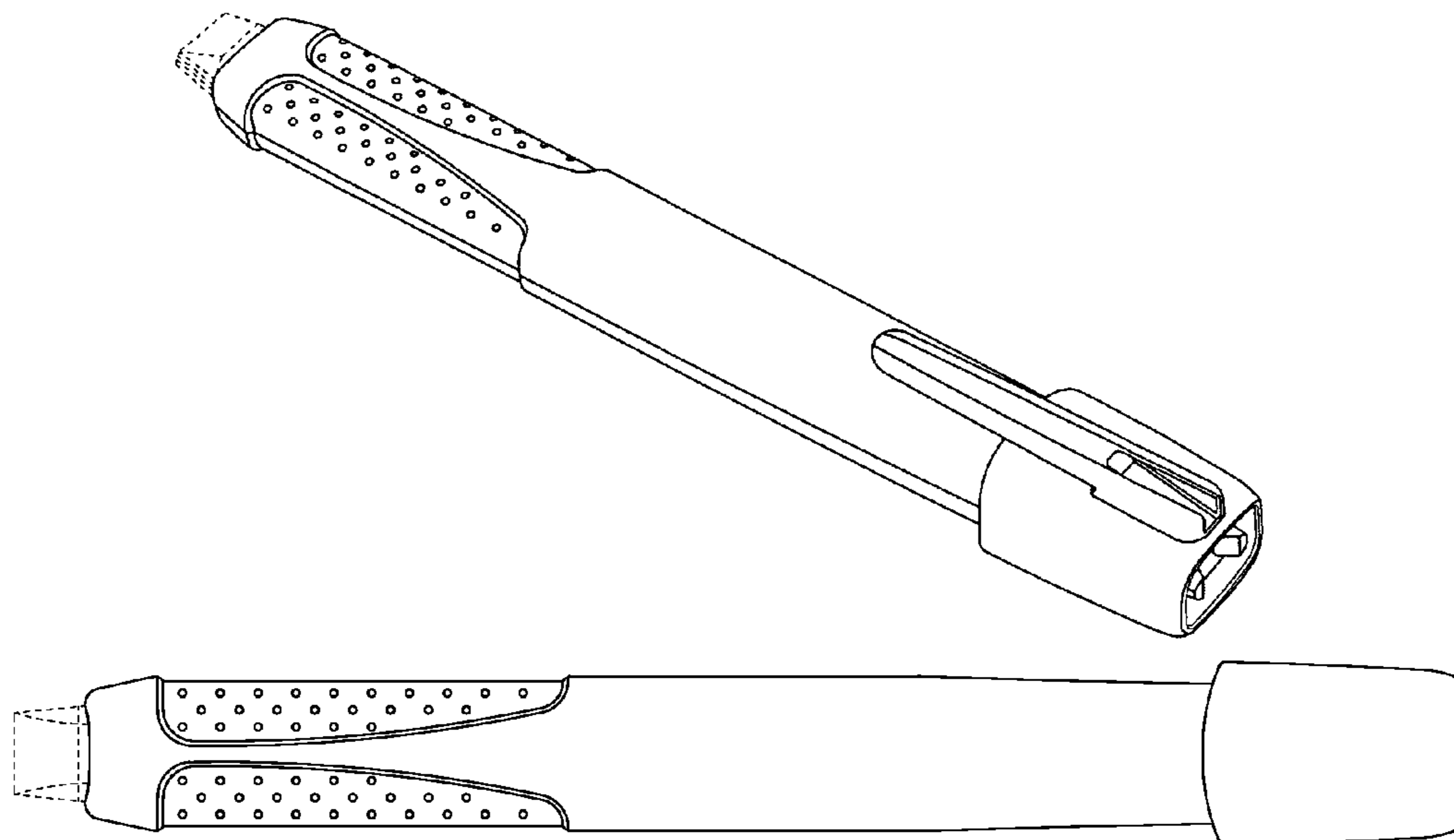
FIG. 5 is a rear elevational view thereof;

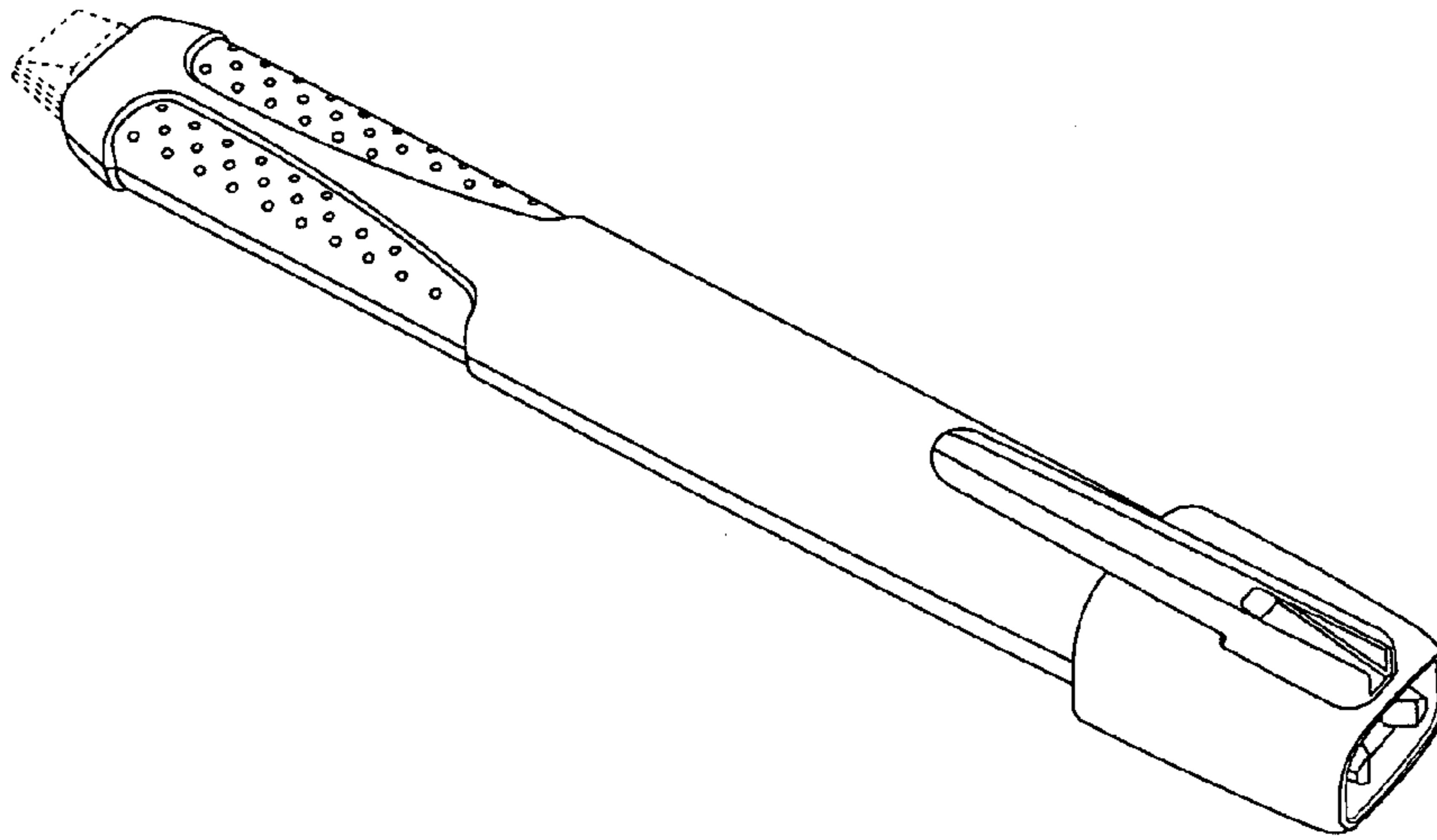

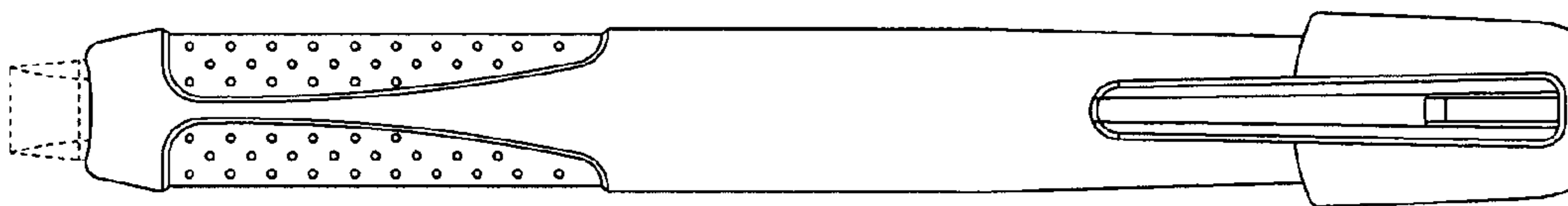

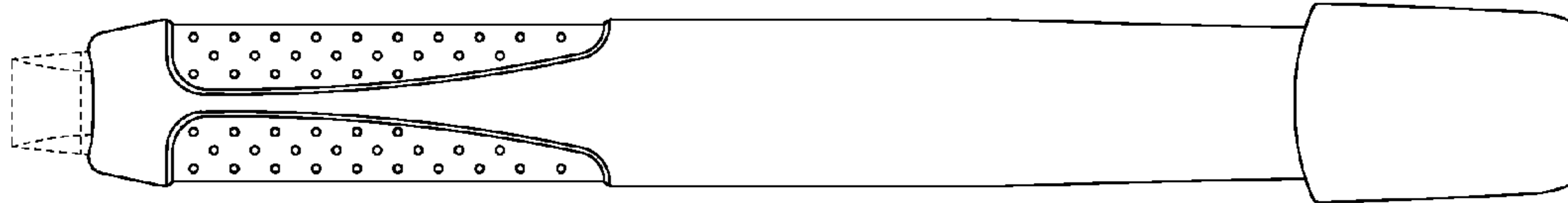

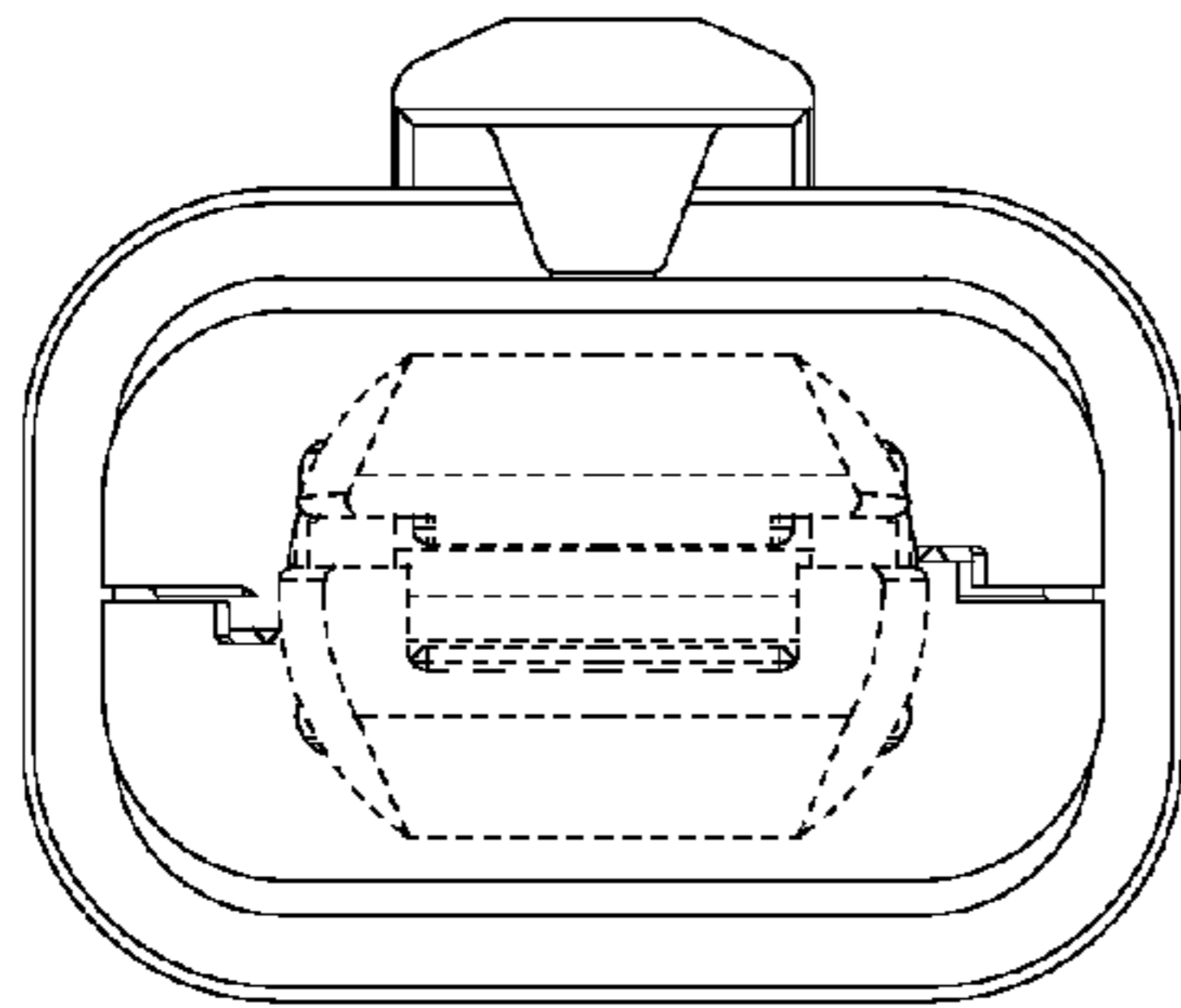

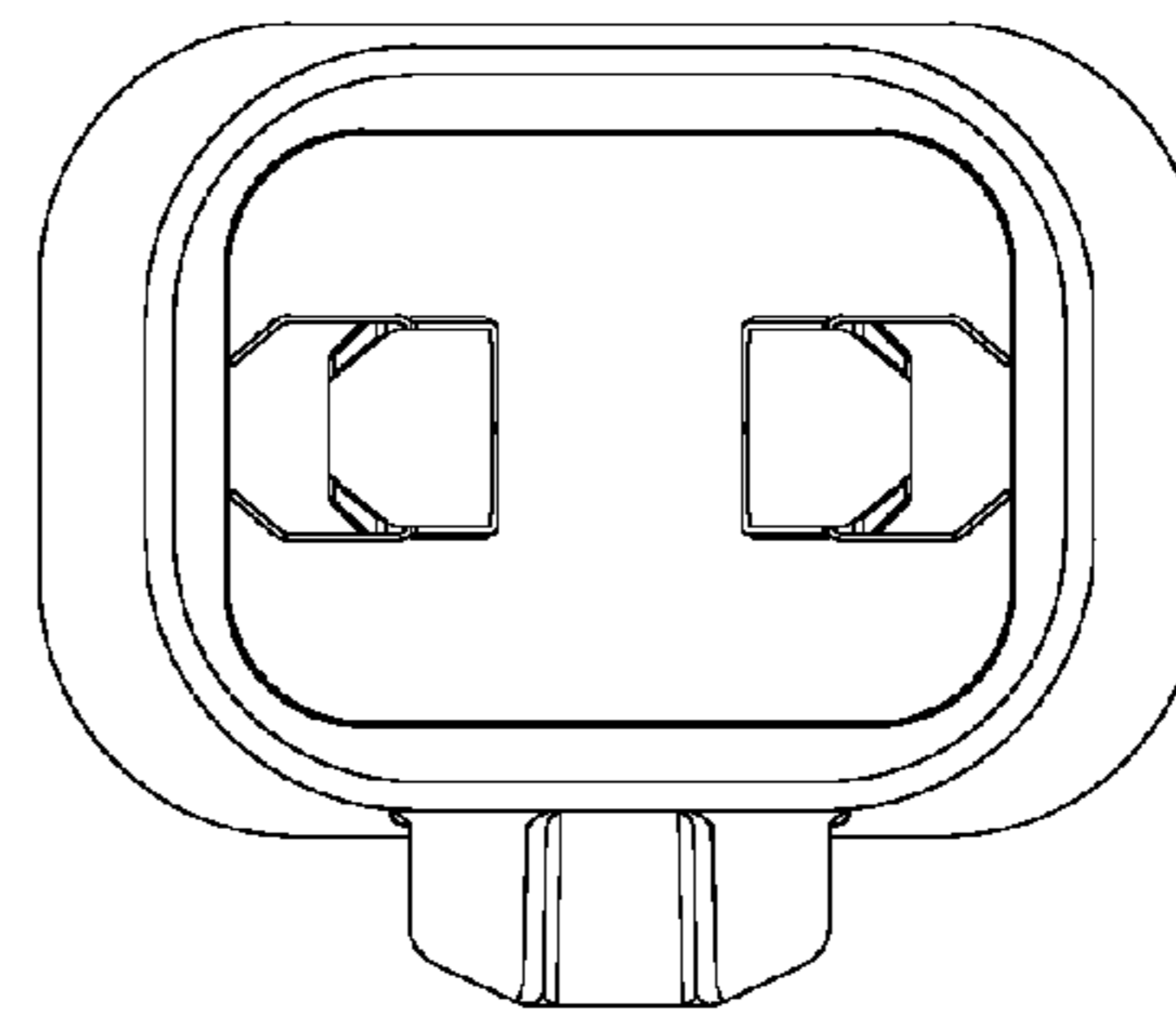

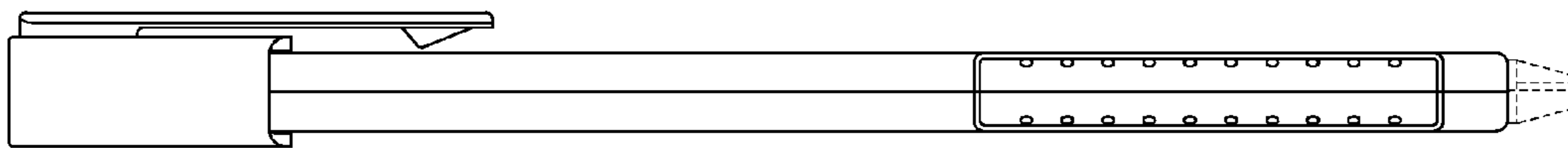

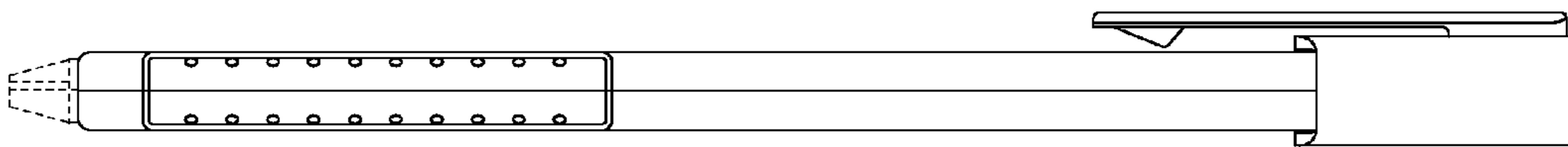
