DESCRIPTION

FIG. 1 is a perspective illustration of a pipe gland according to an embodiment of the present invention;

FIG. 2 is a detail perspective illustration of the pipe gland shown in FIG. 1;

FIG. 3 is a detail front illustration of the pipe gland shown in FIG. 1;

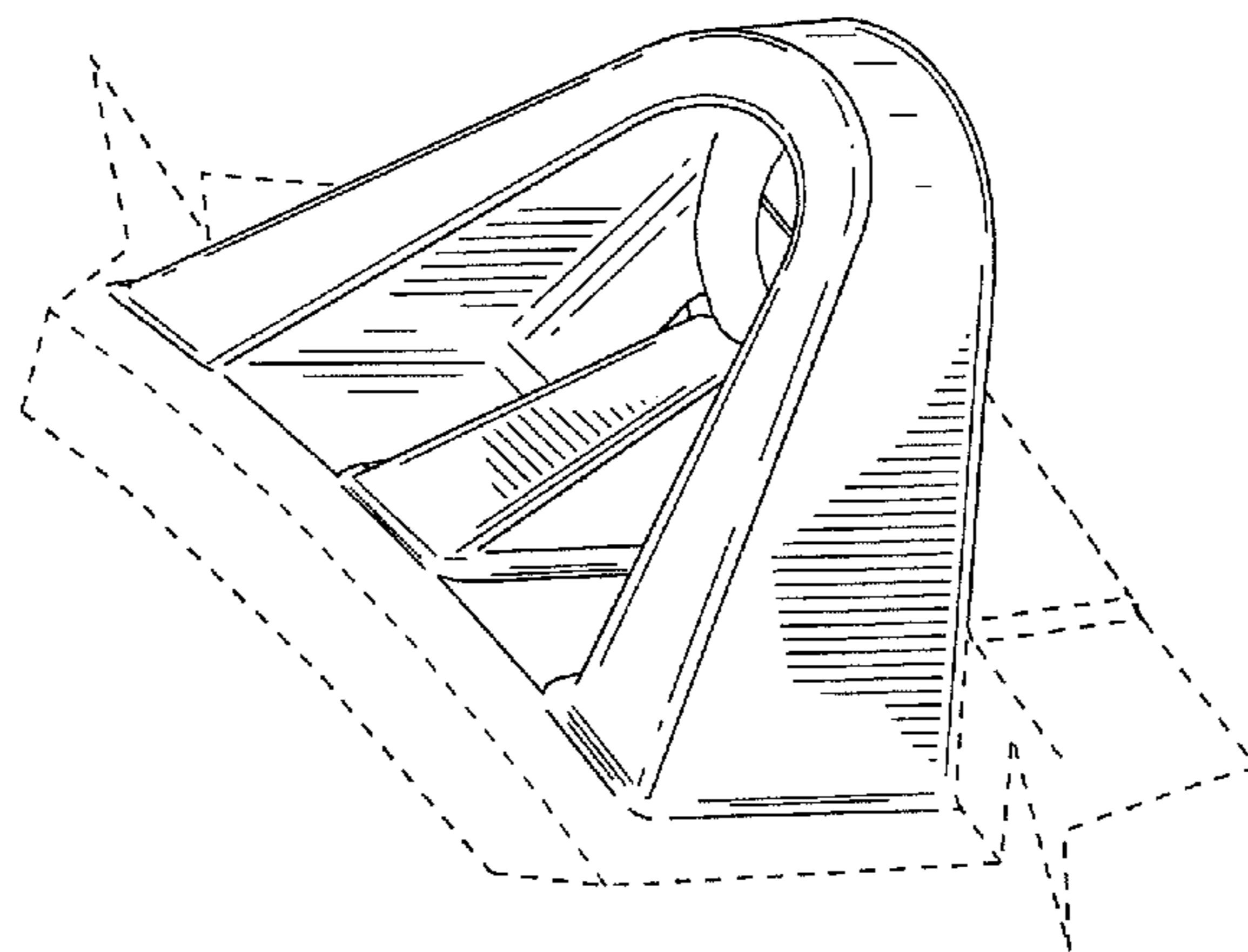
FIG. 4 is a detail right side elevation illustration of the pipe gland shown in FIG. 1;

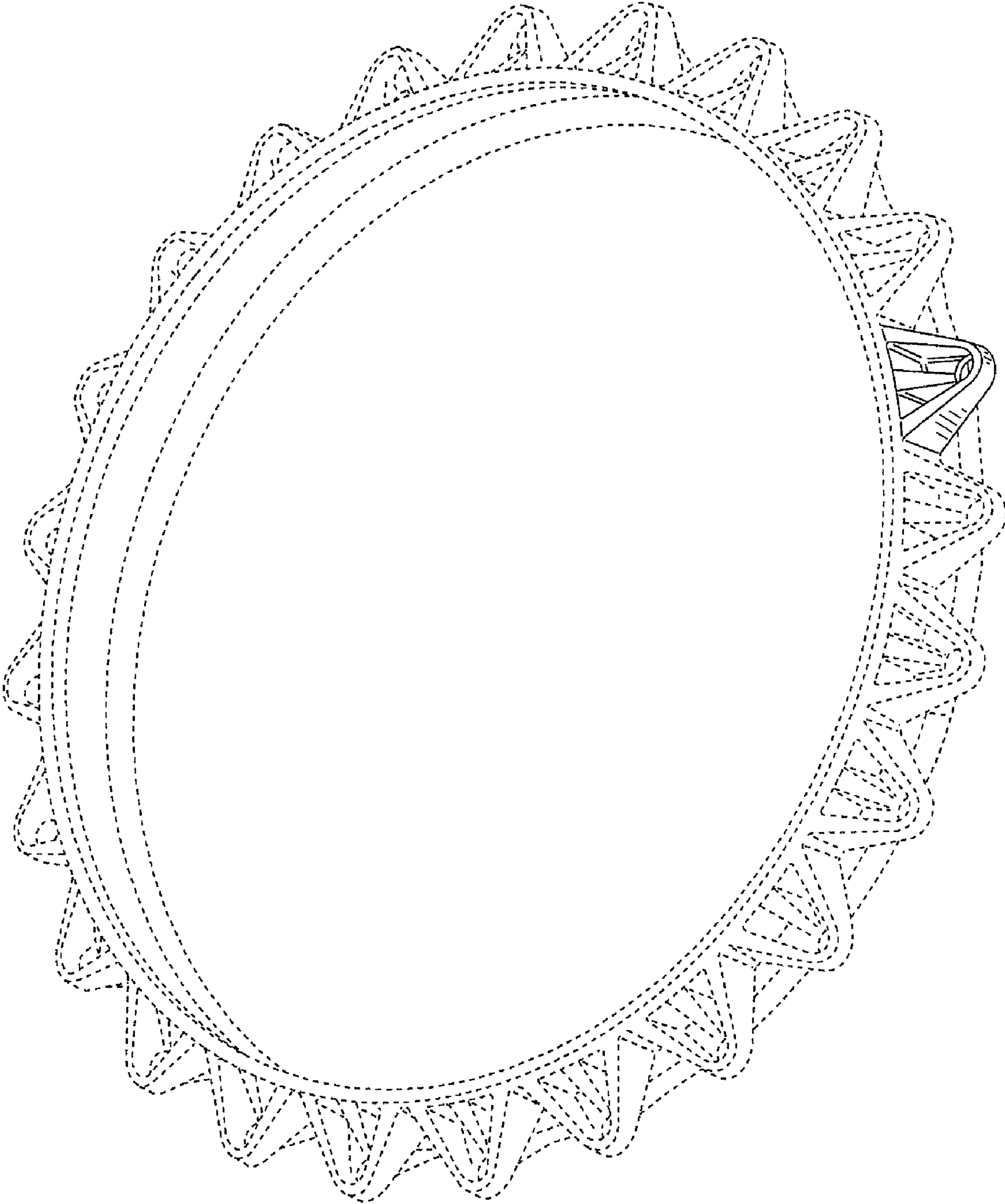

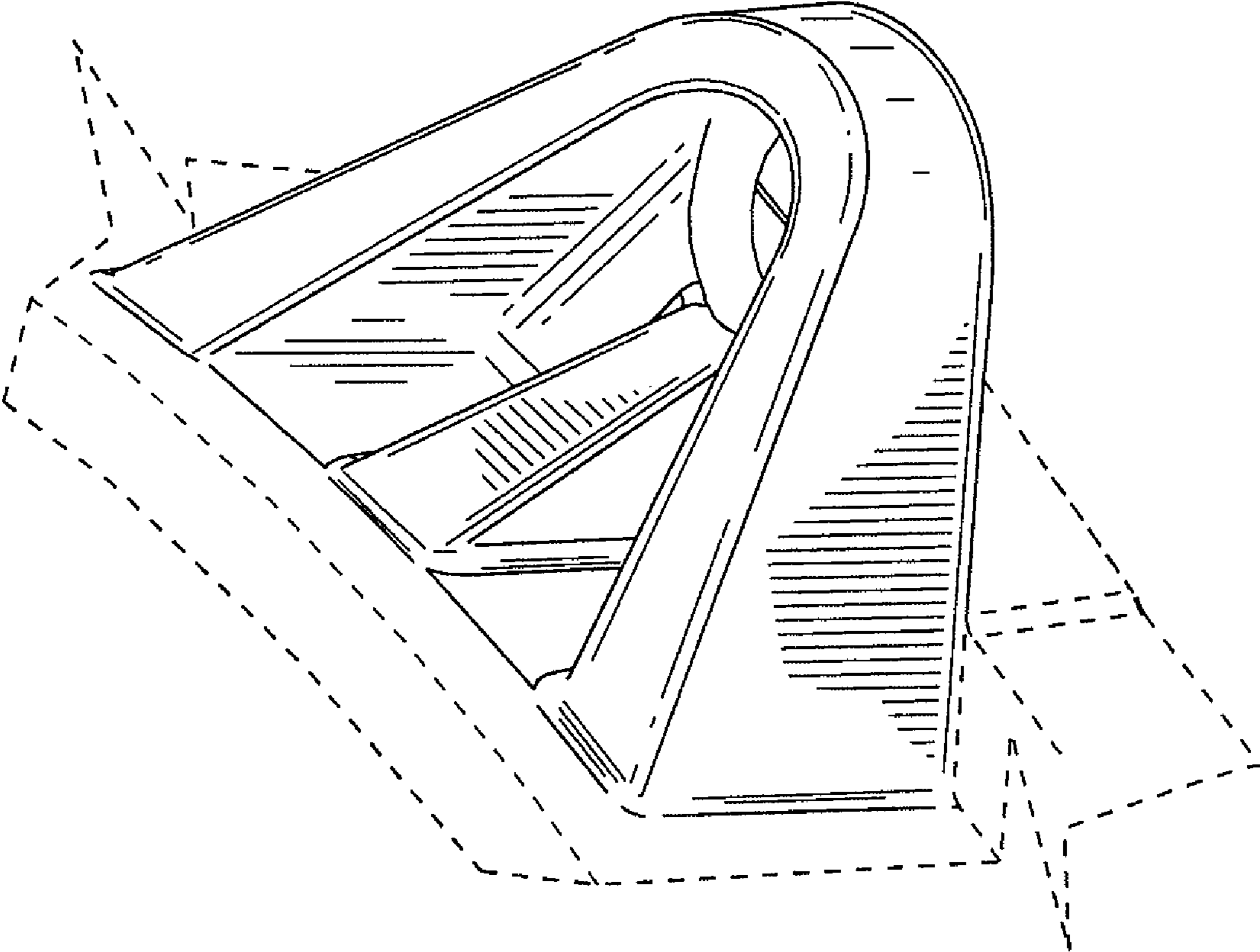

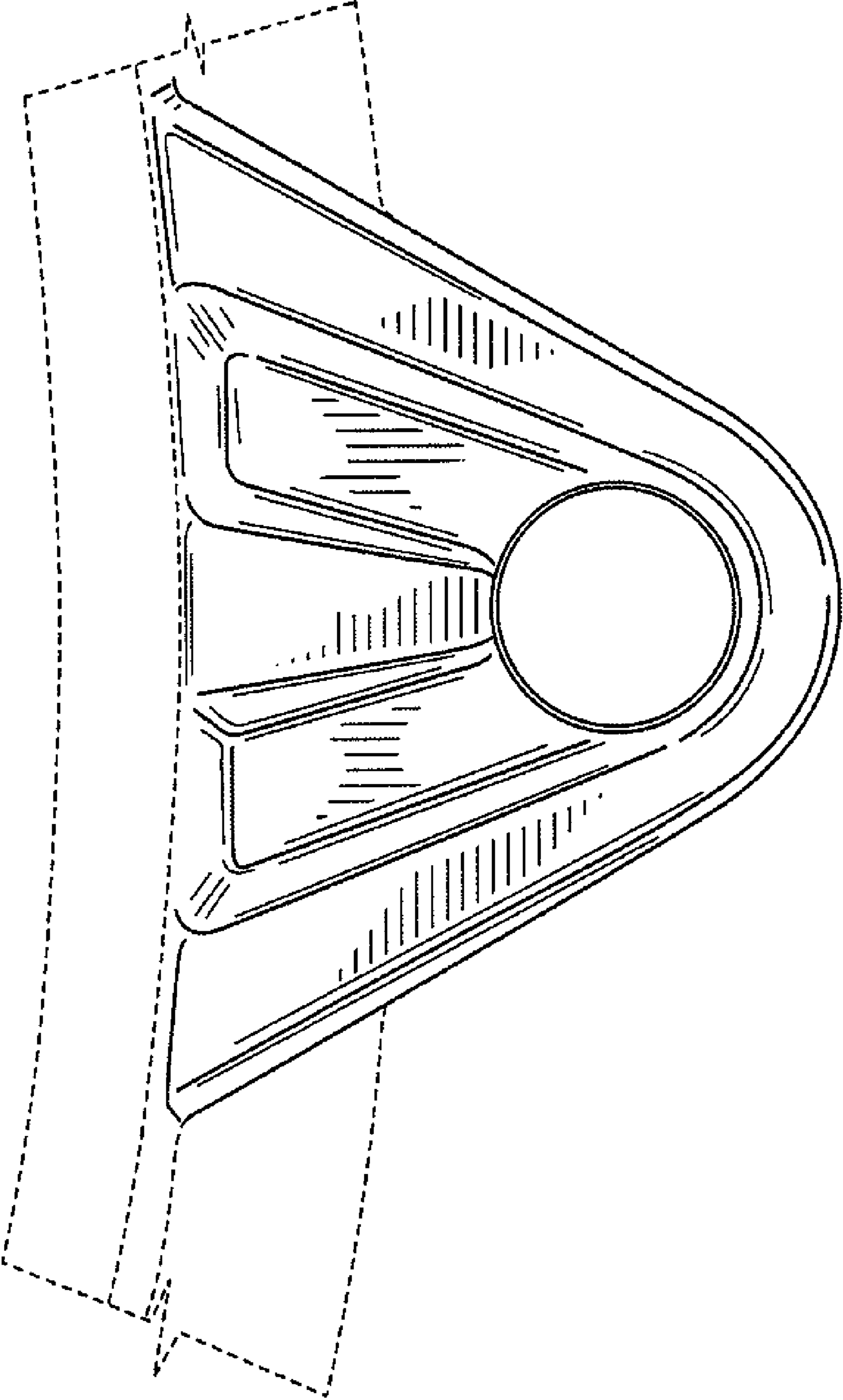

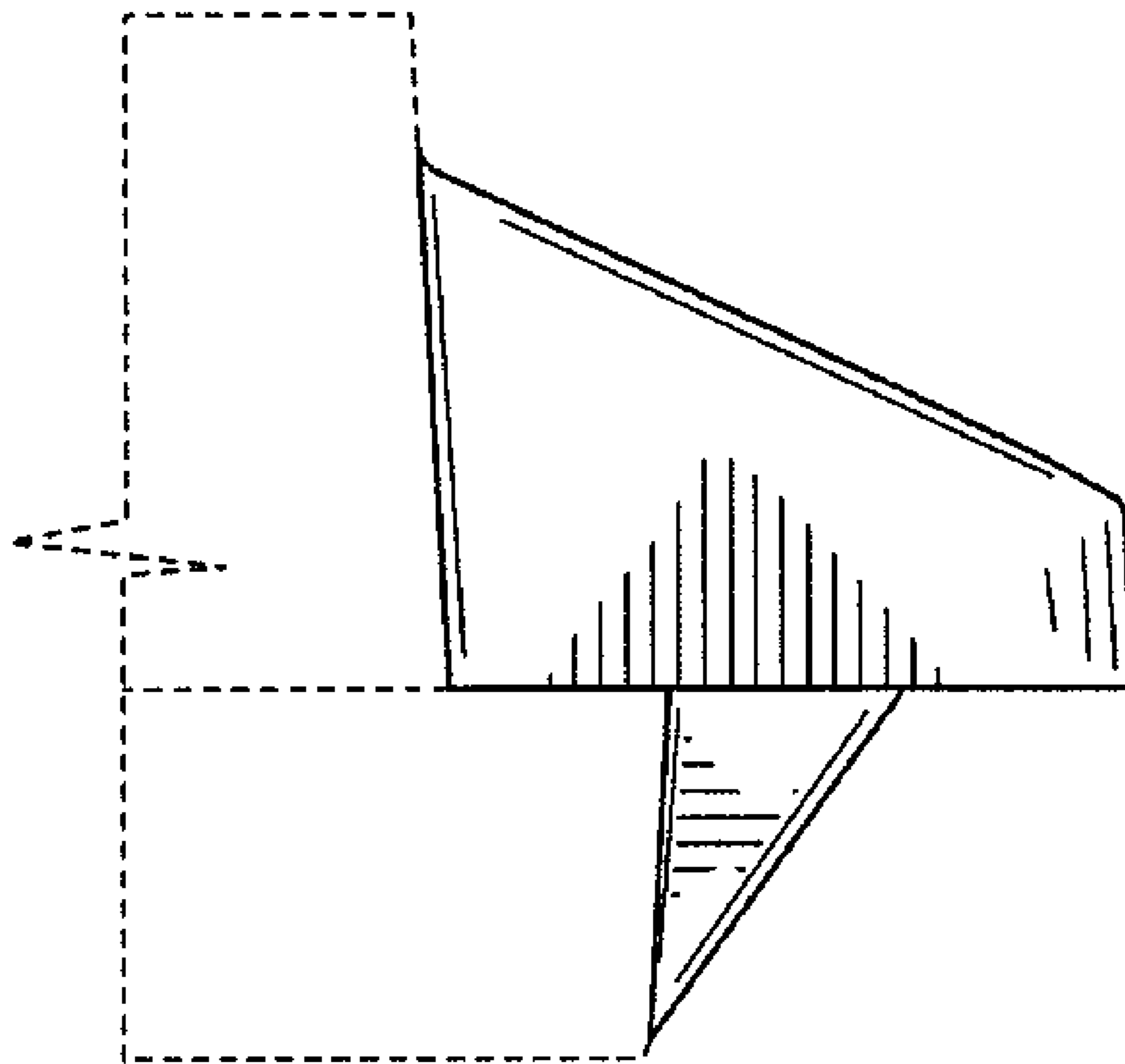

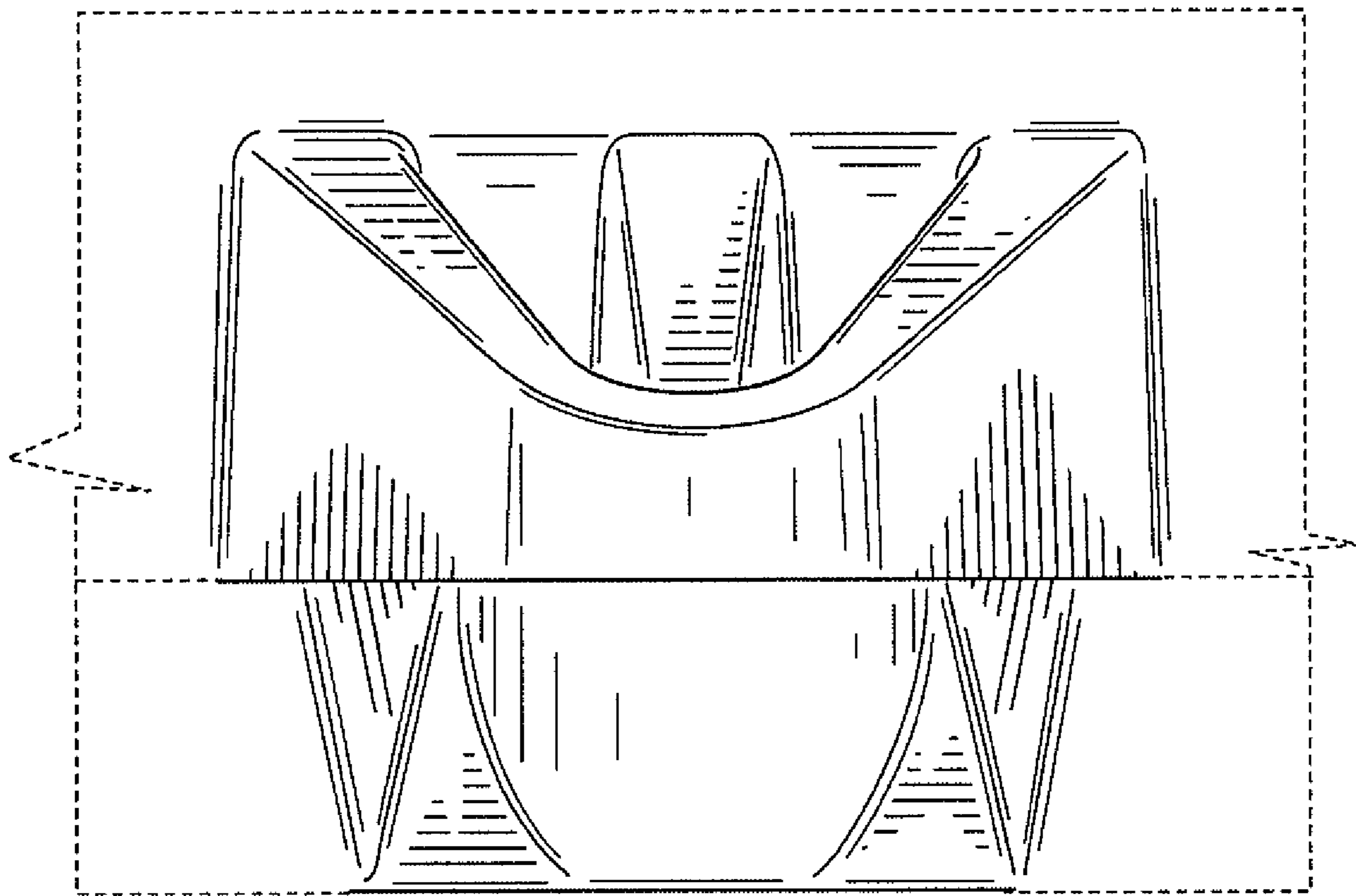

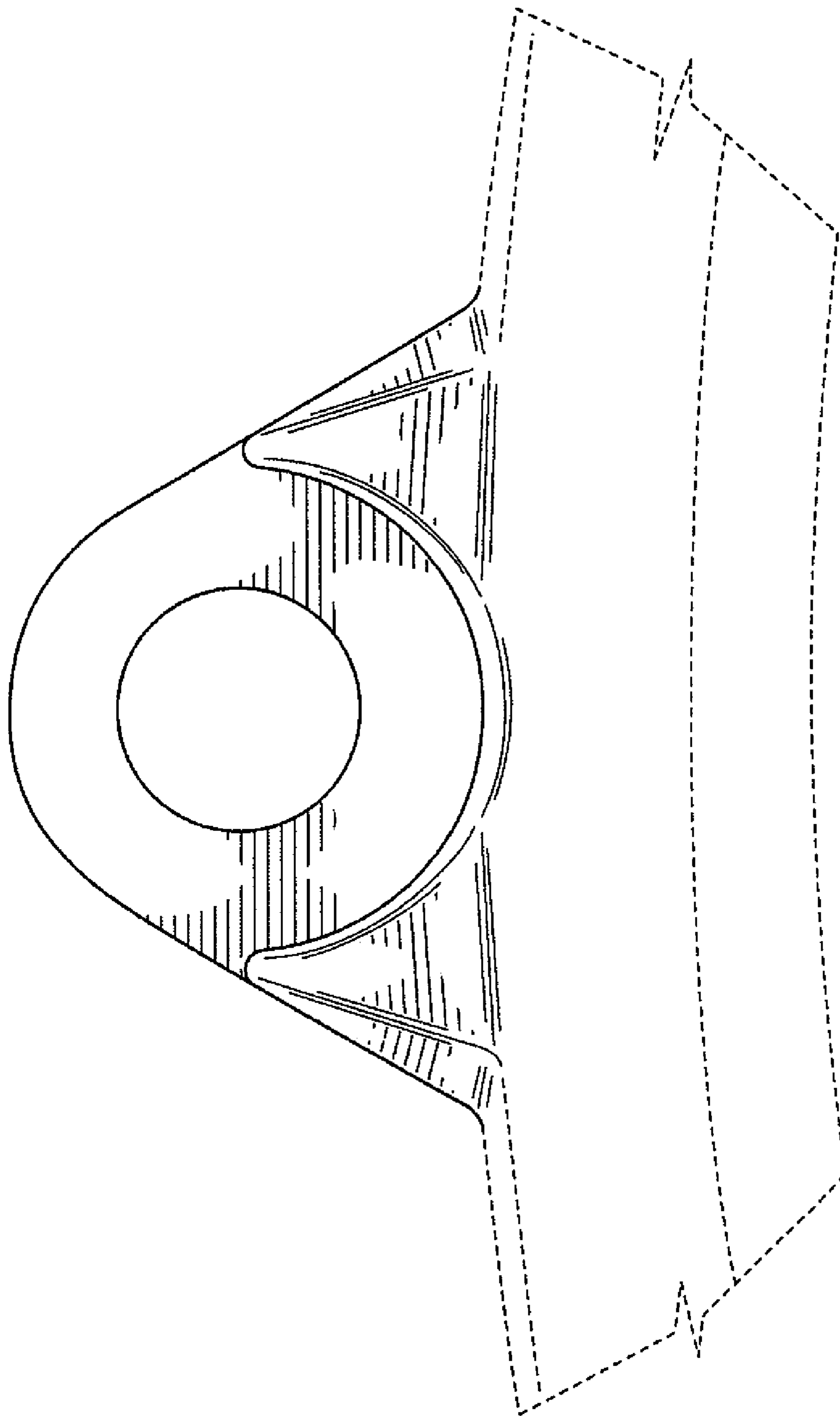
