(57) **CLAIM**

The ornamental design for a hearth, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hearth showing a first embodiment of the new design;

FIG. 2 is a back elevational view thereof;

FIG. 3 is a side elevational view thereof, the opposite side being a mirror image of this view;

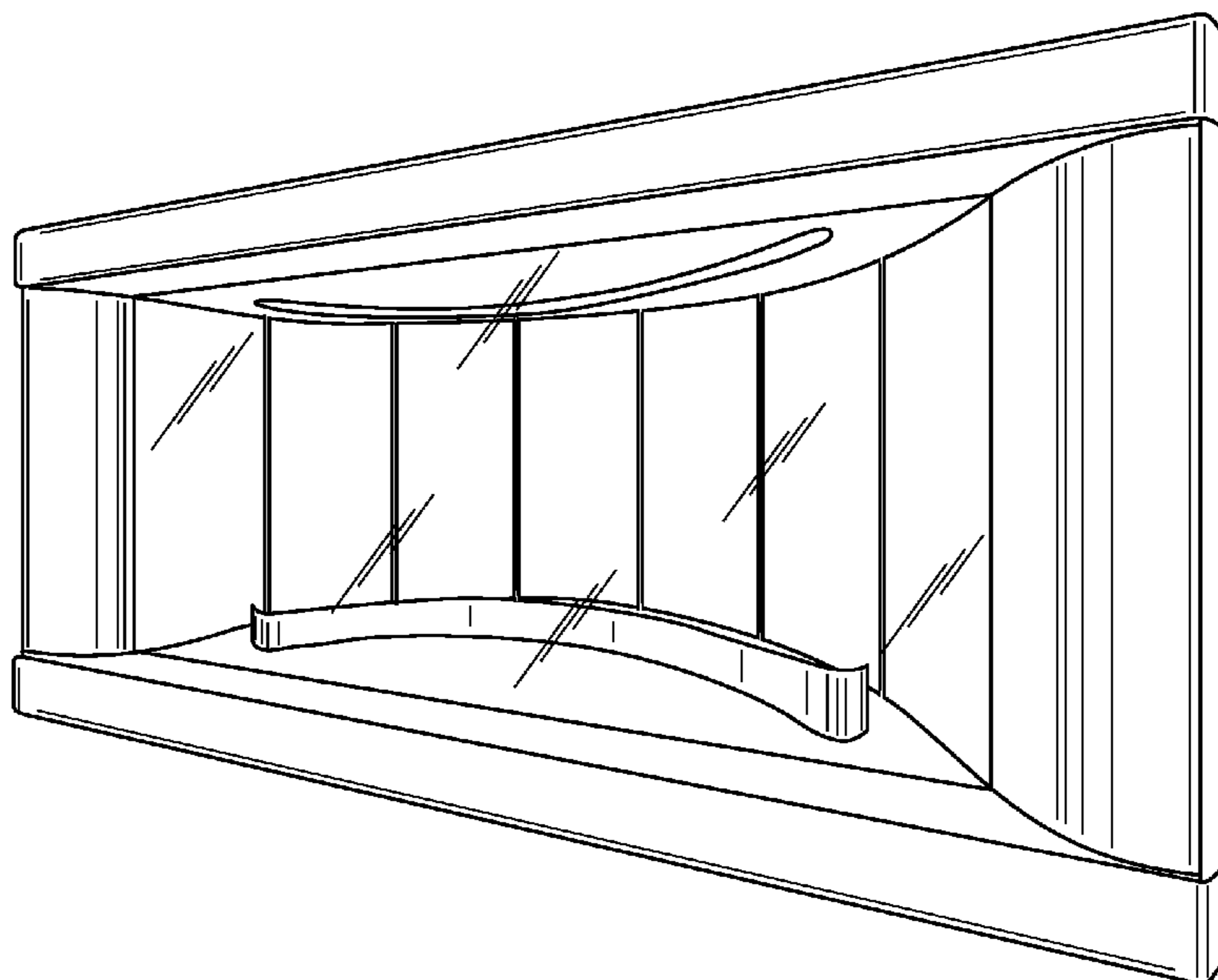
FIG. 4 is a front elevational view thereof;

FIG. 5 is a top view thereof; and,

FIG. 6 is a bottom view thereof.

The broken line showing of portions of the hearth in FIGS. 2, 3, 5 and 6 are included for the purpose of illustrating environment and forms no part of the claimed design.

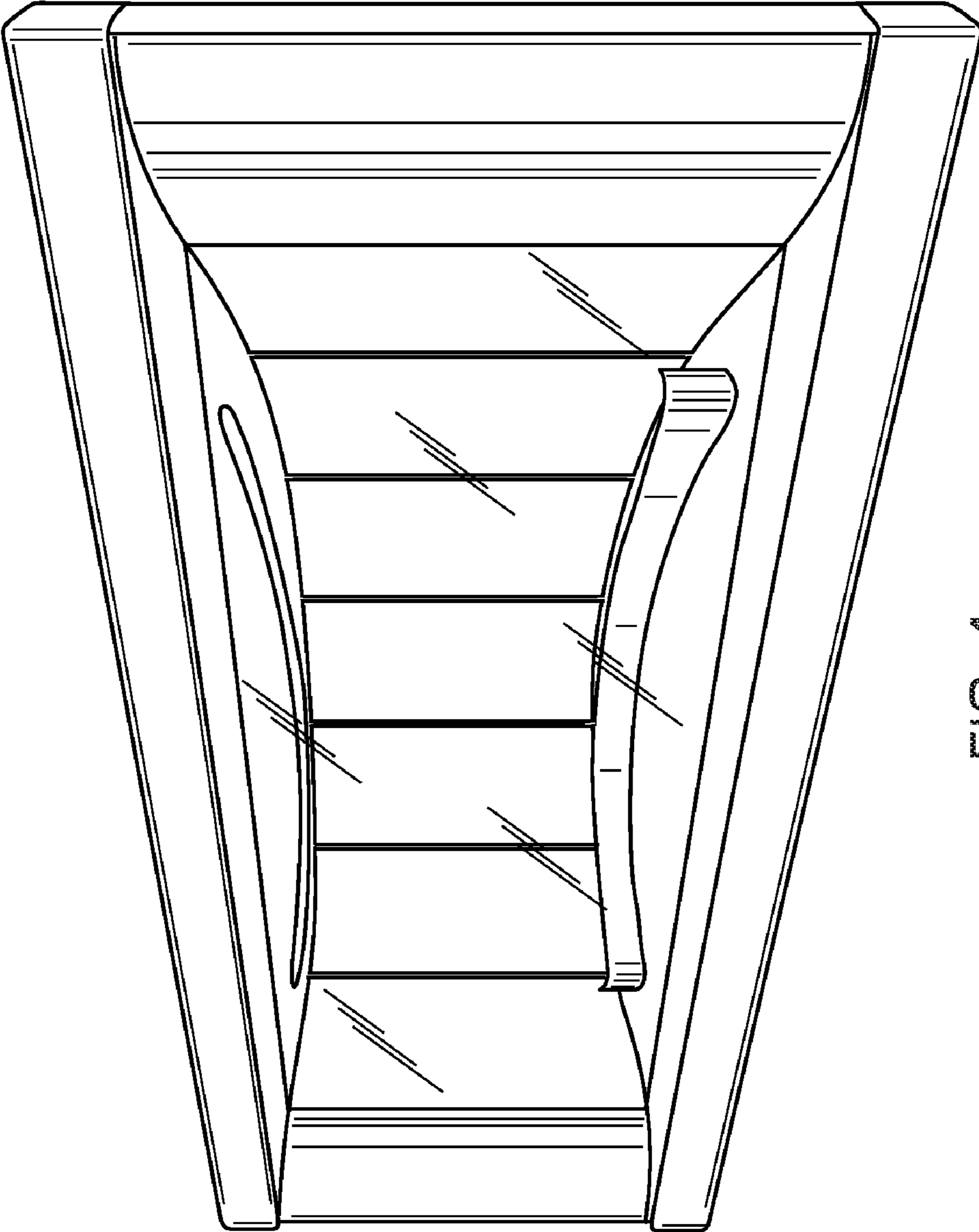

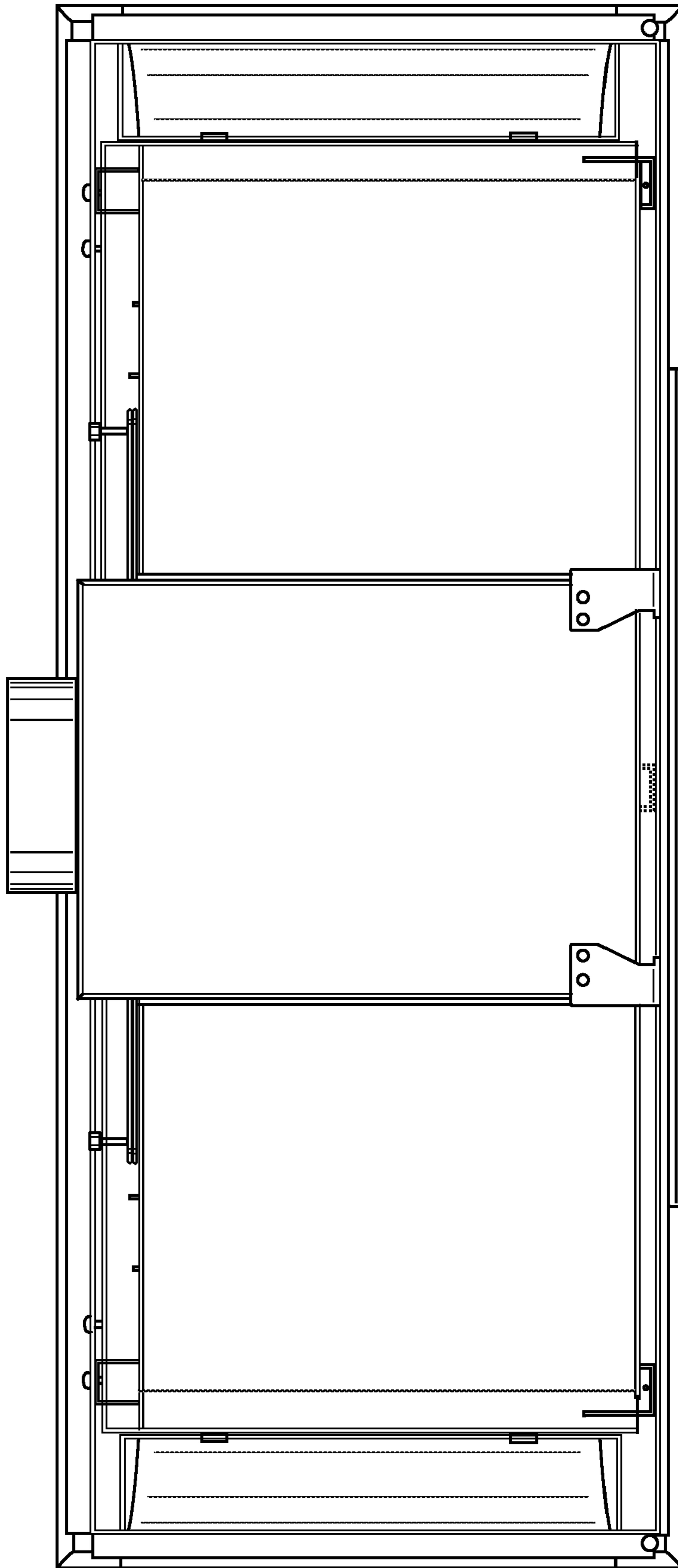

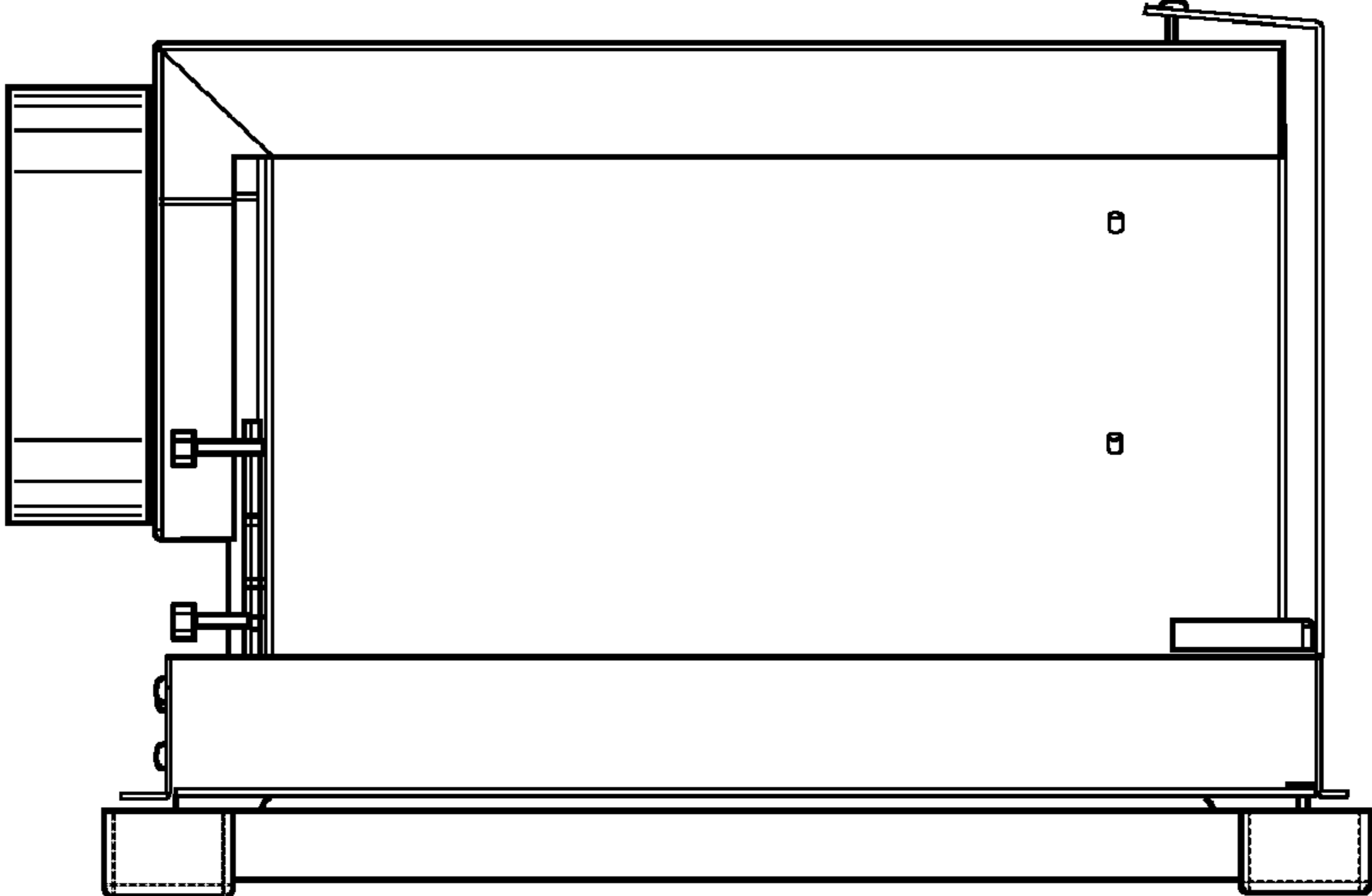

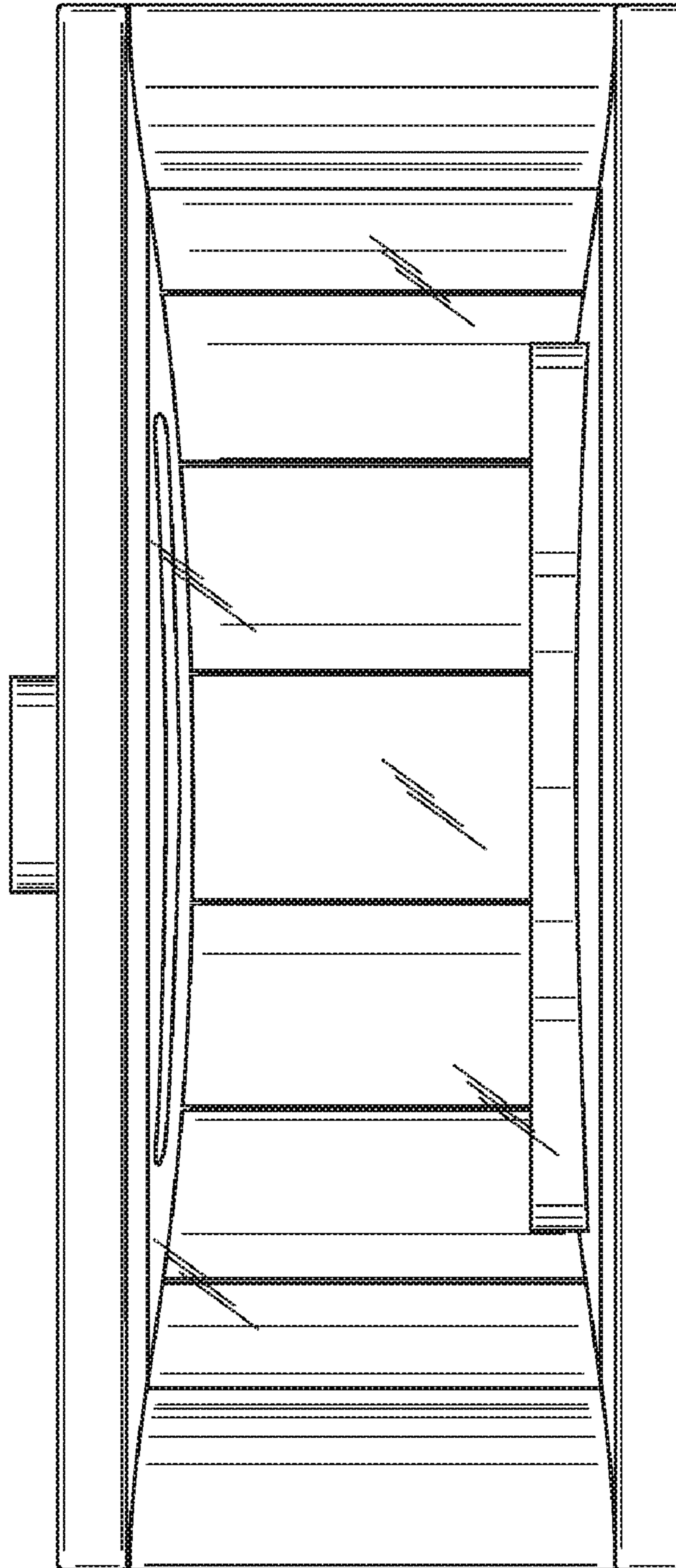
