(57) **CLAIM**

The ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a light fixture in accordance with my design;

FIG. 2 is a top plan view of the light fixture in accordance with my design;

FIG. 3 is a bottom plan view of the light fixture in accordance with my design;

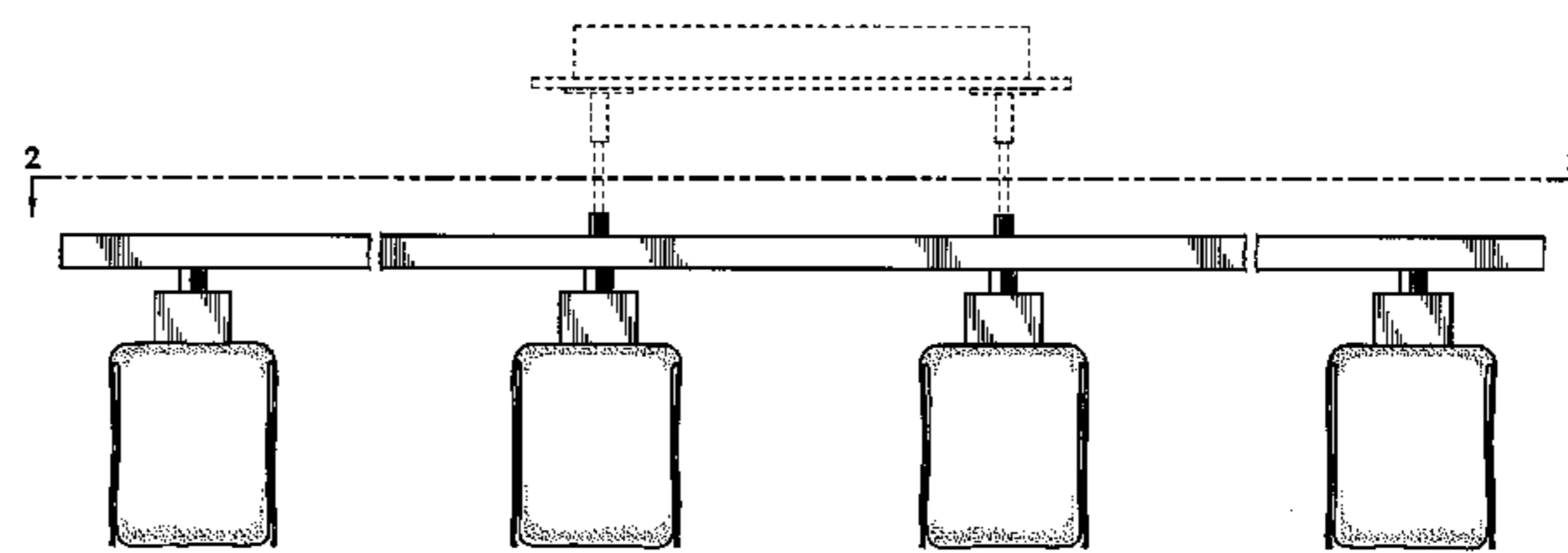
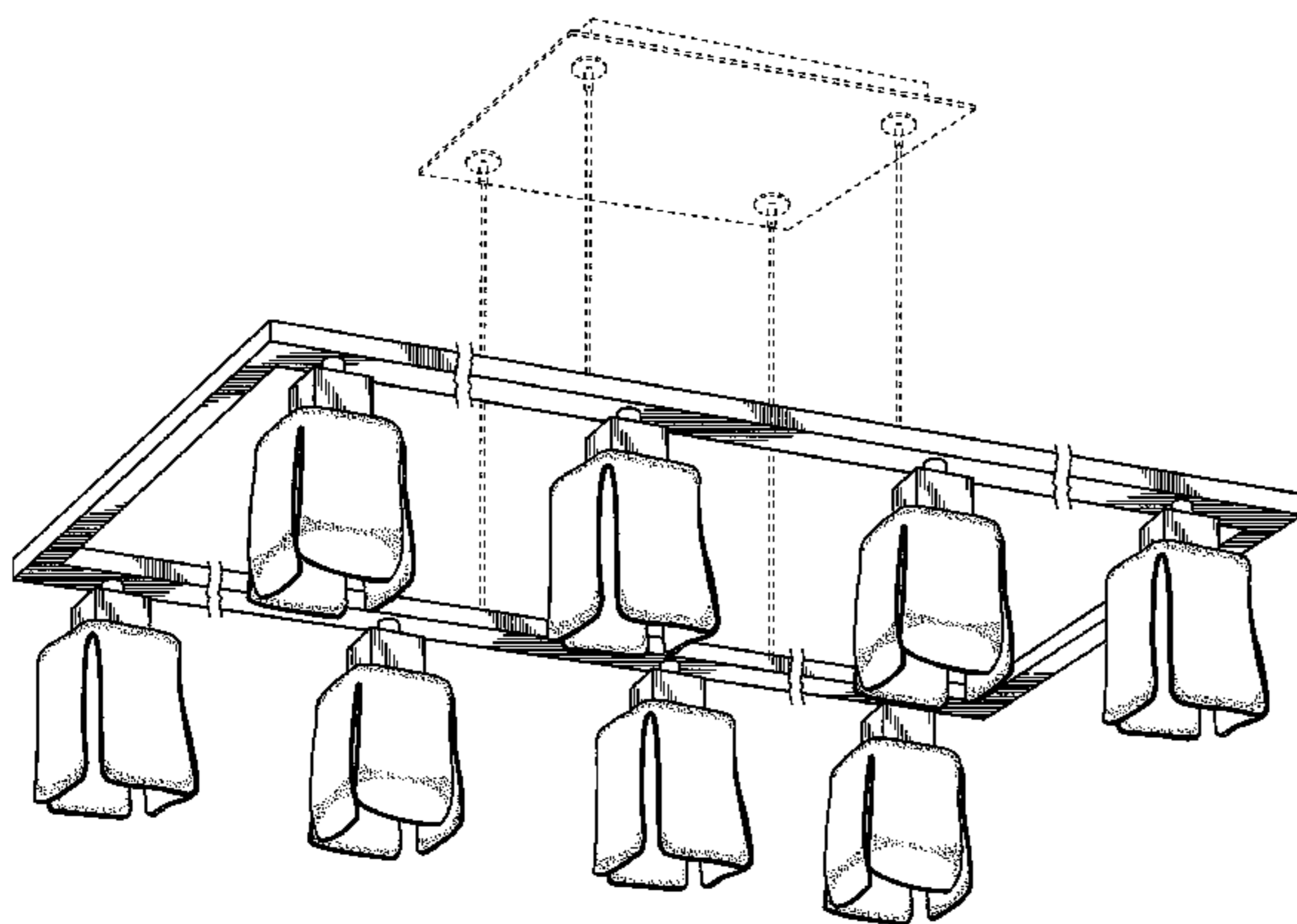
FIG. 4 is a side elevation view of the light fixture in accordance with my design, the opposite side being a mirror image of that shown; and,

FIG. 5 is a front elevation view of the light fixture in accordance with my design, the opposite side being a mirror image of that shown.

The light fixture of FIGS. 1, 2, 3, and 5 is shown with a portion broken away to indicate indeterminate length.

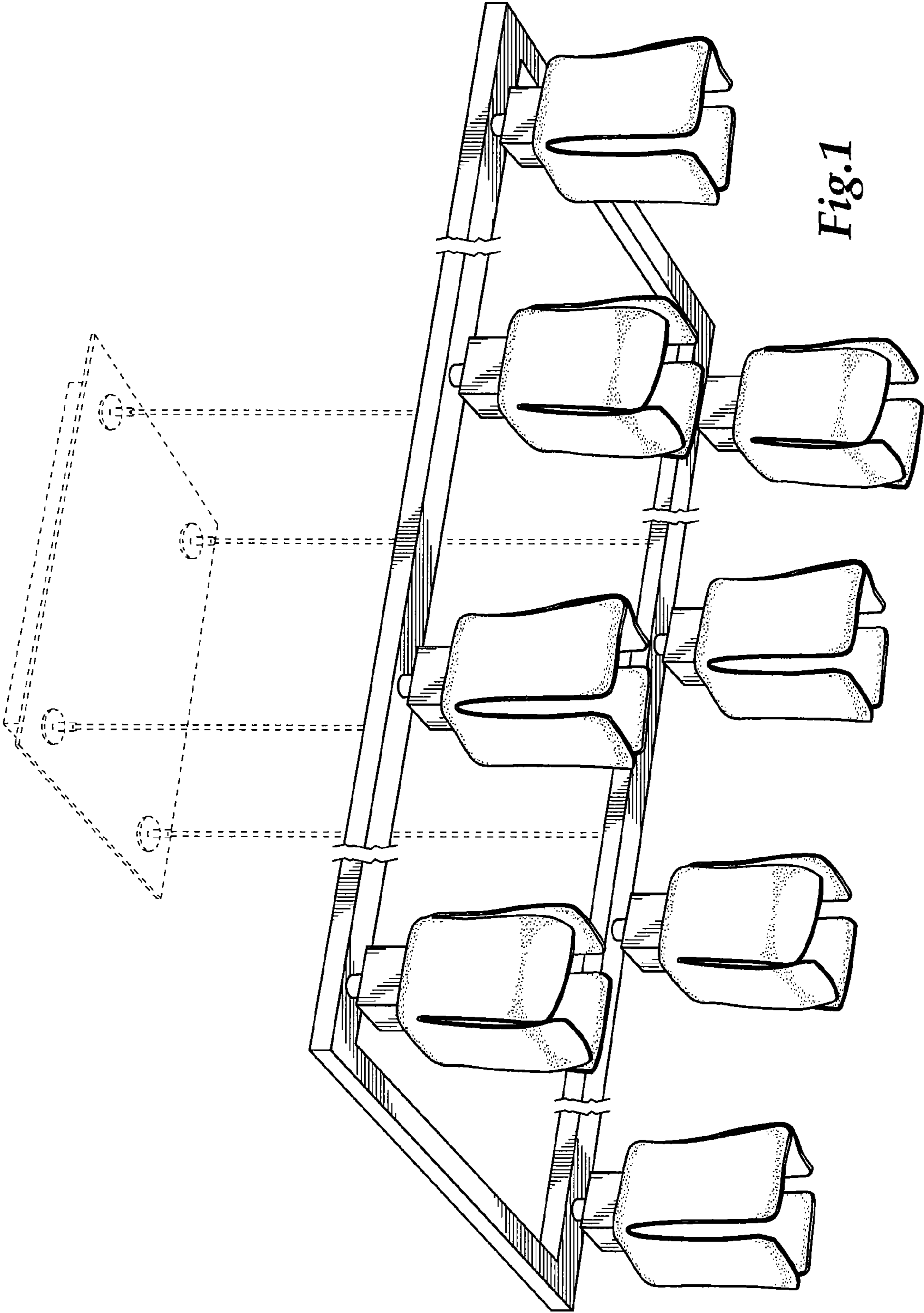
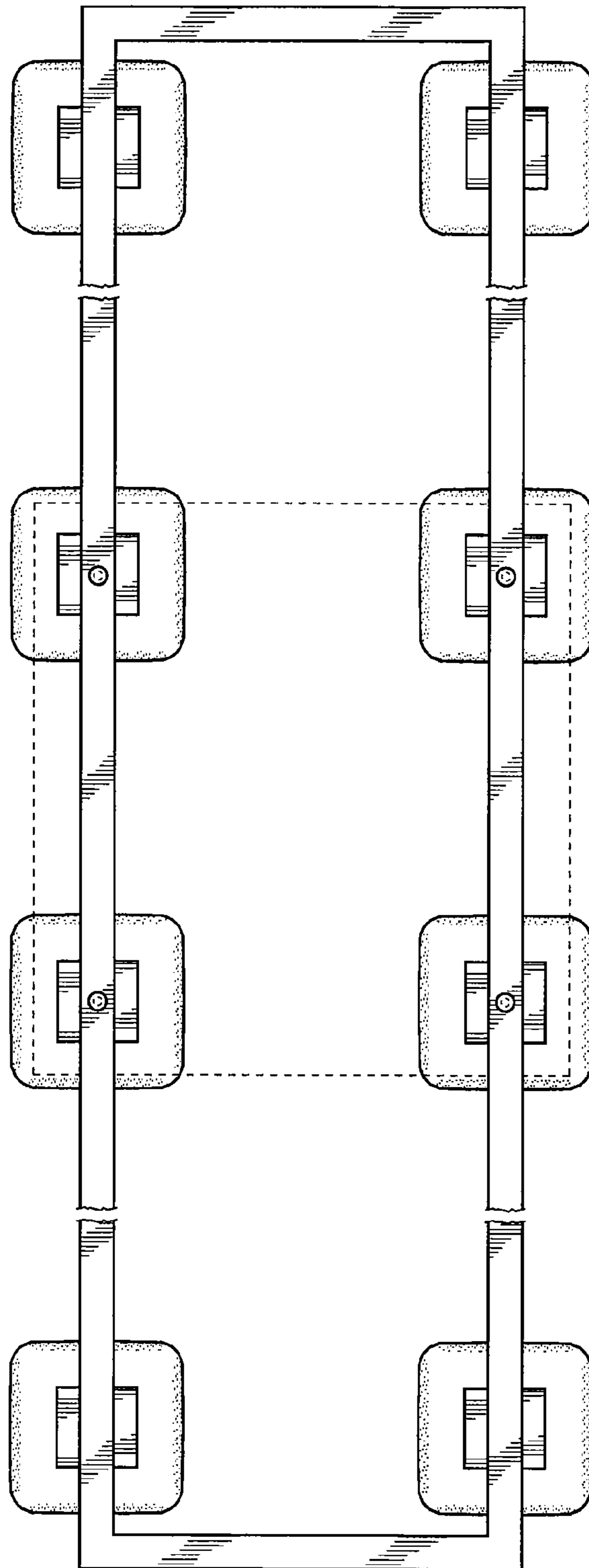
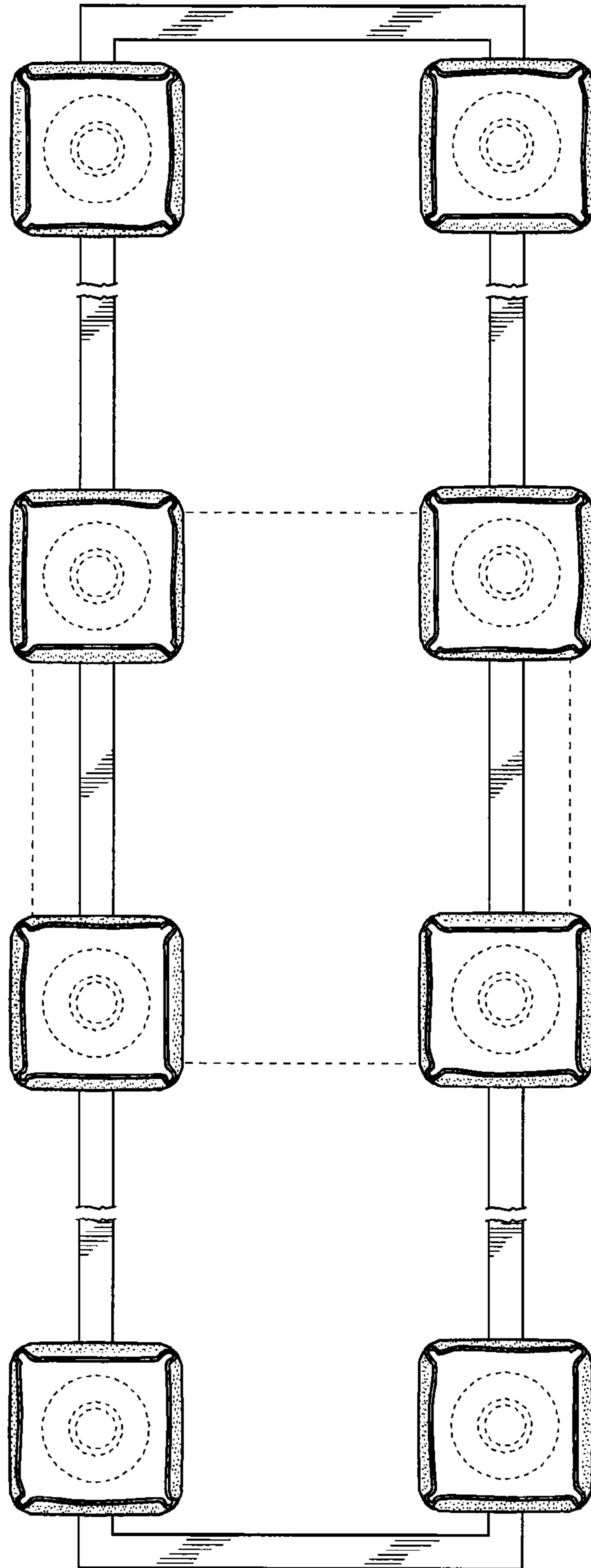
