FIG. 1 is a top perspective view of a light fixture showing my new design;

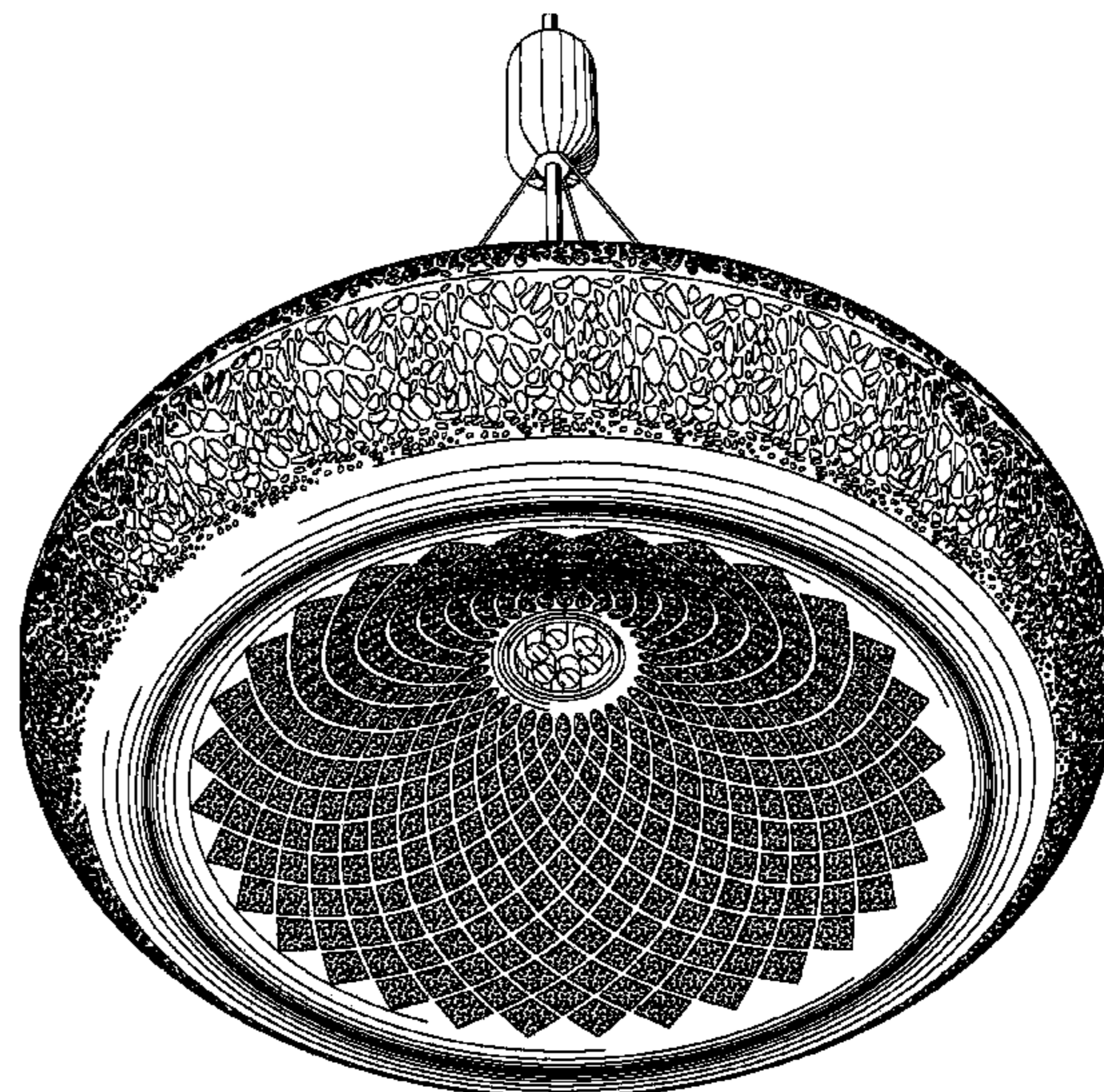
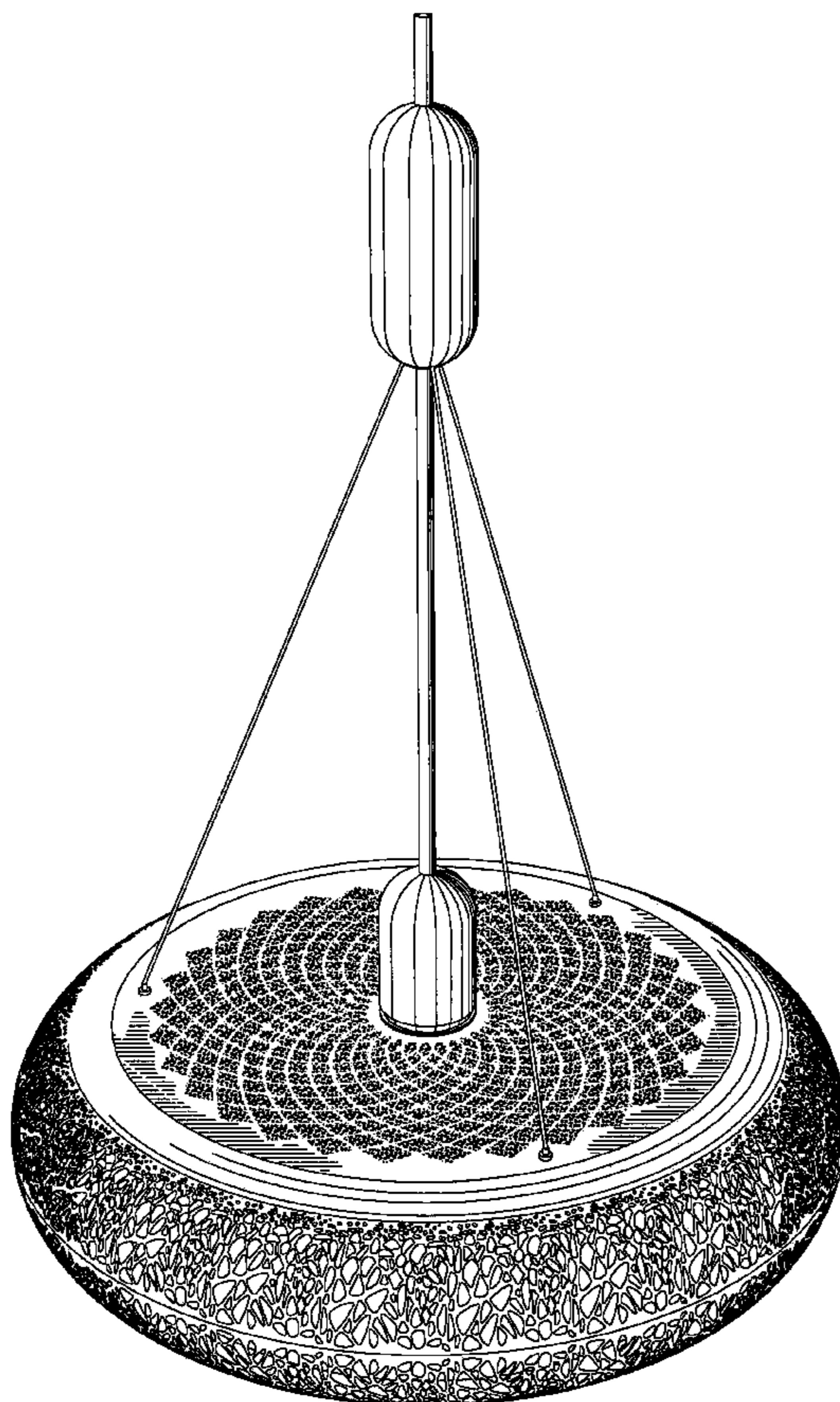
FIG. 2 is a side elevational view of the light fixture of FIG. 1;

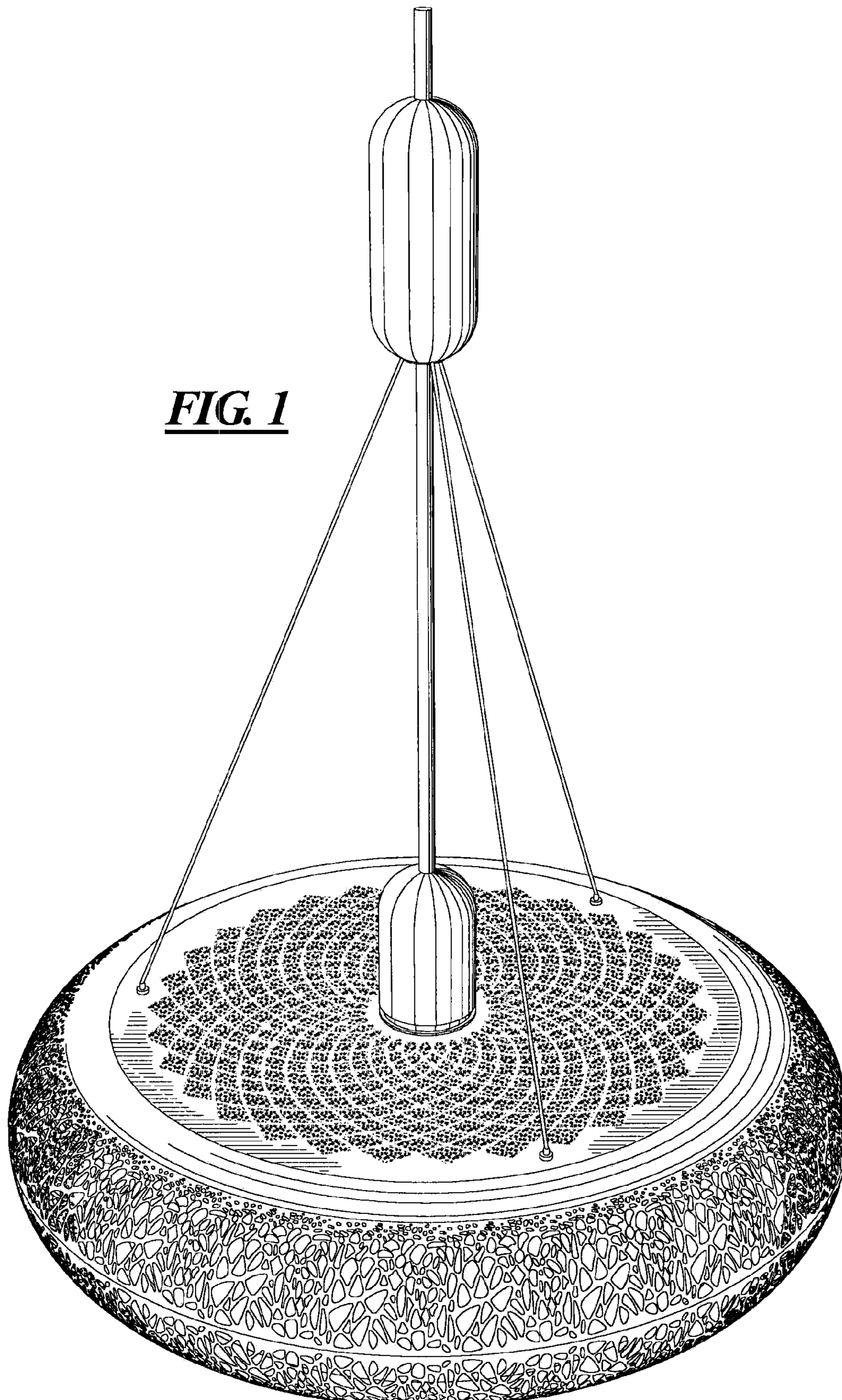

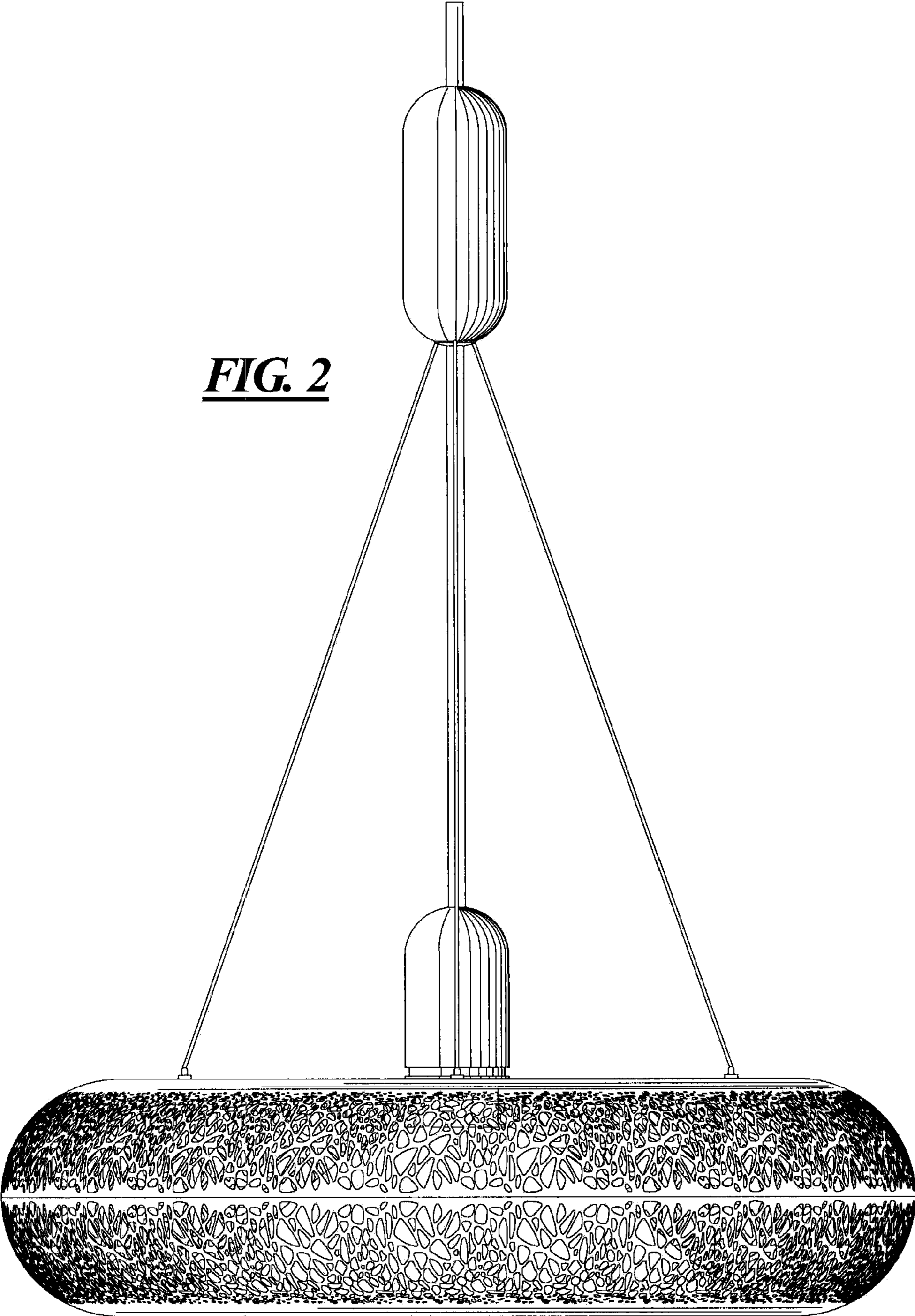

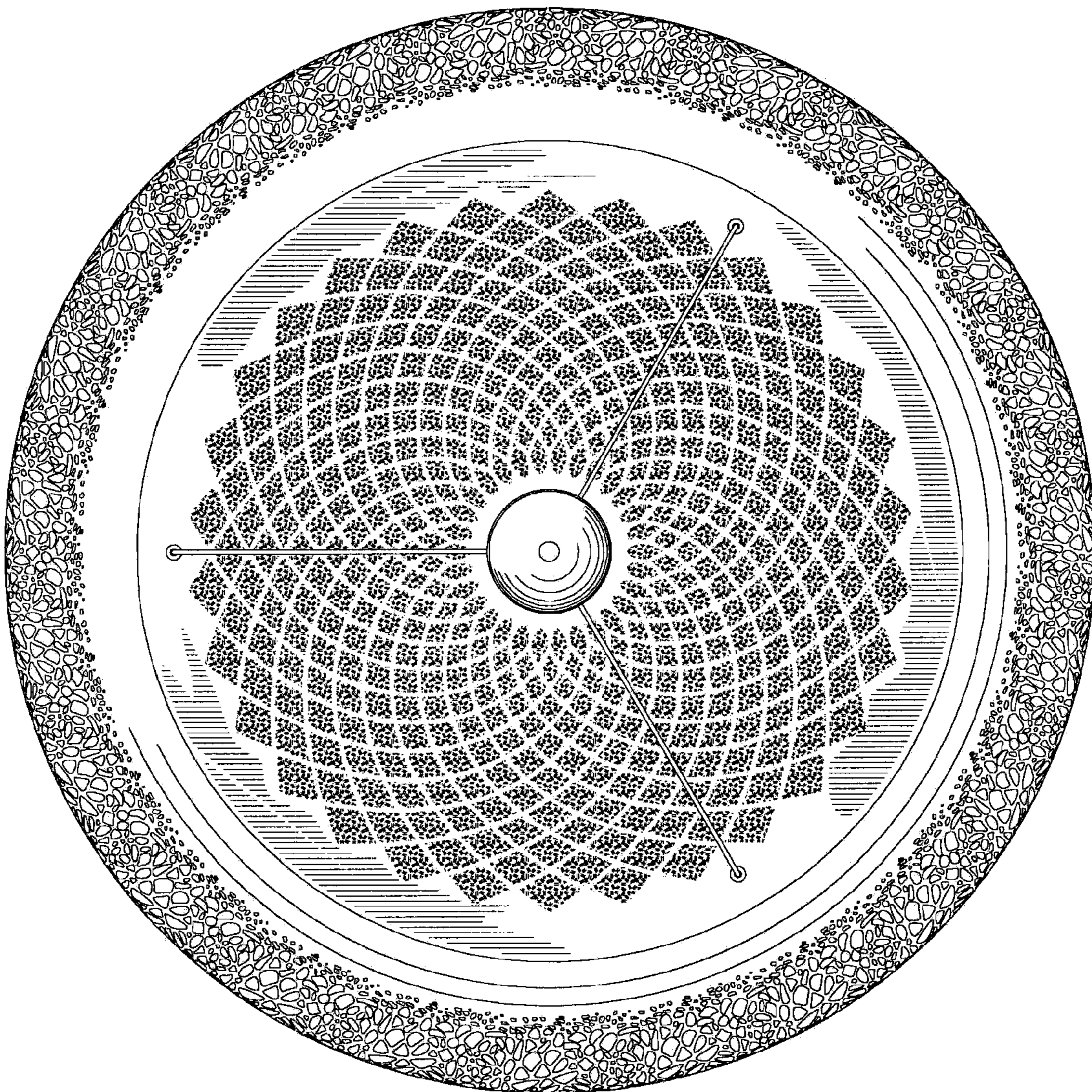

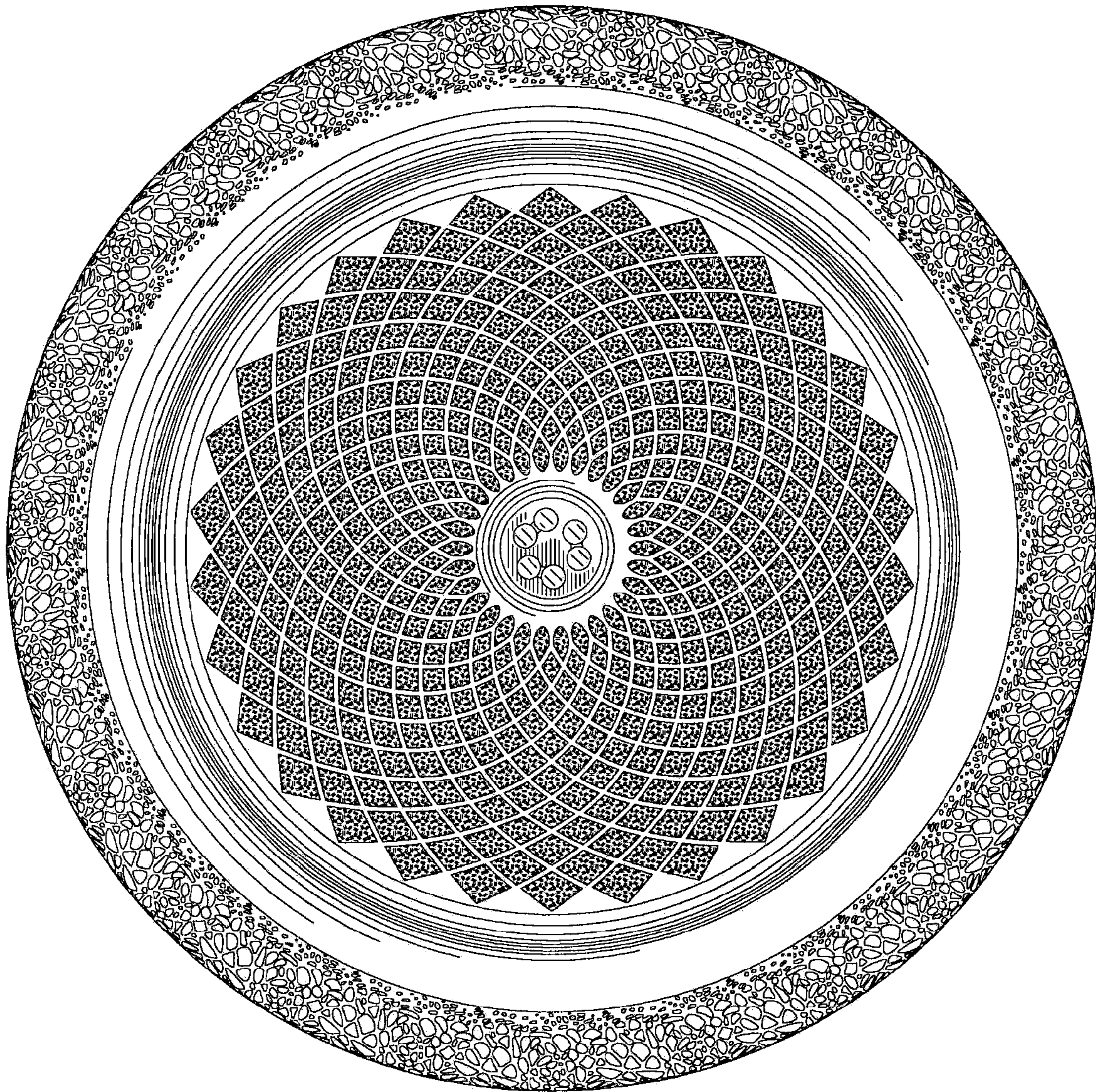
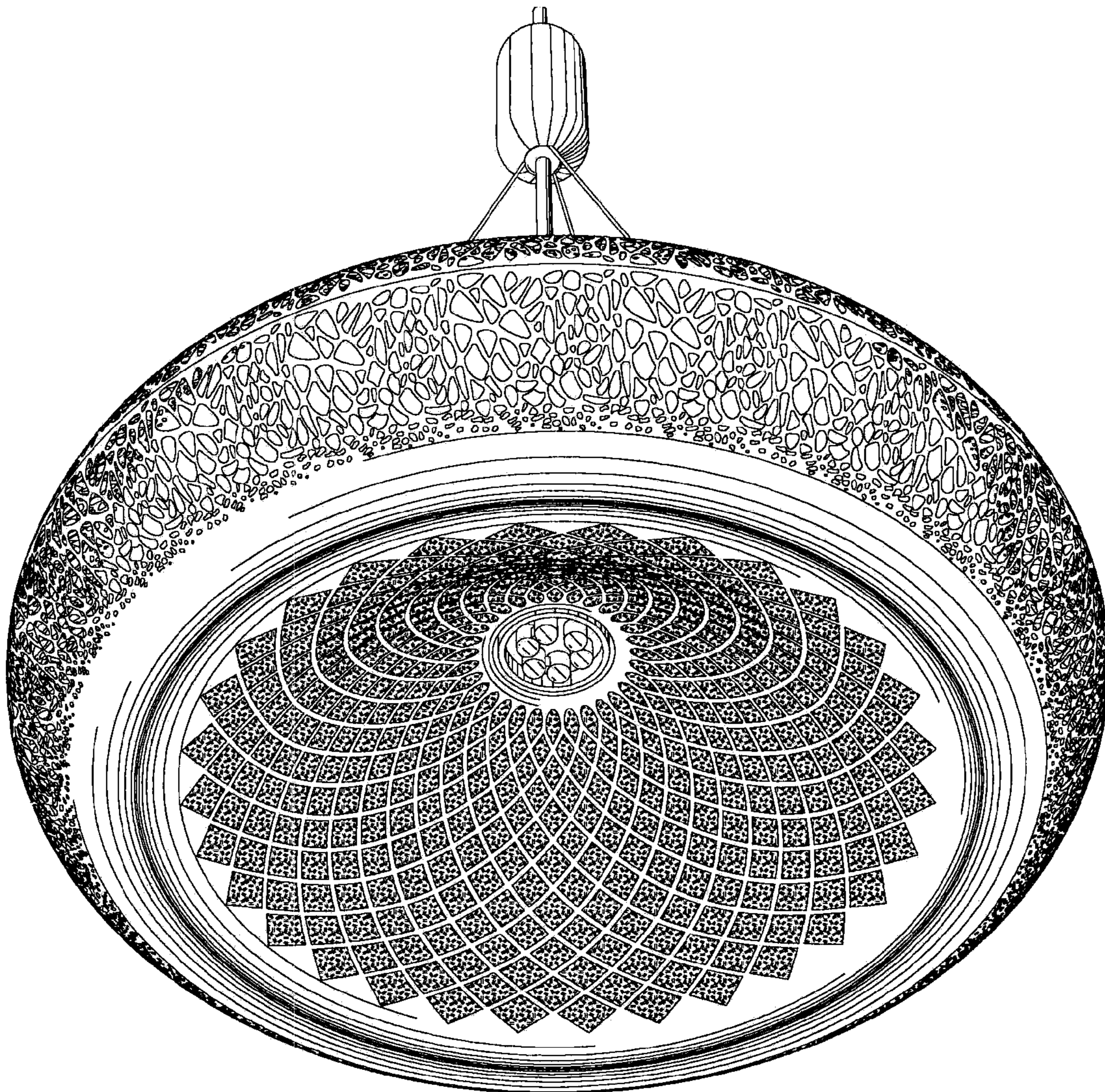
