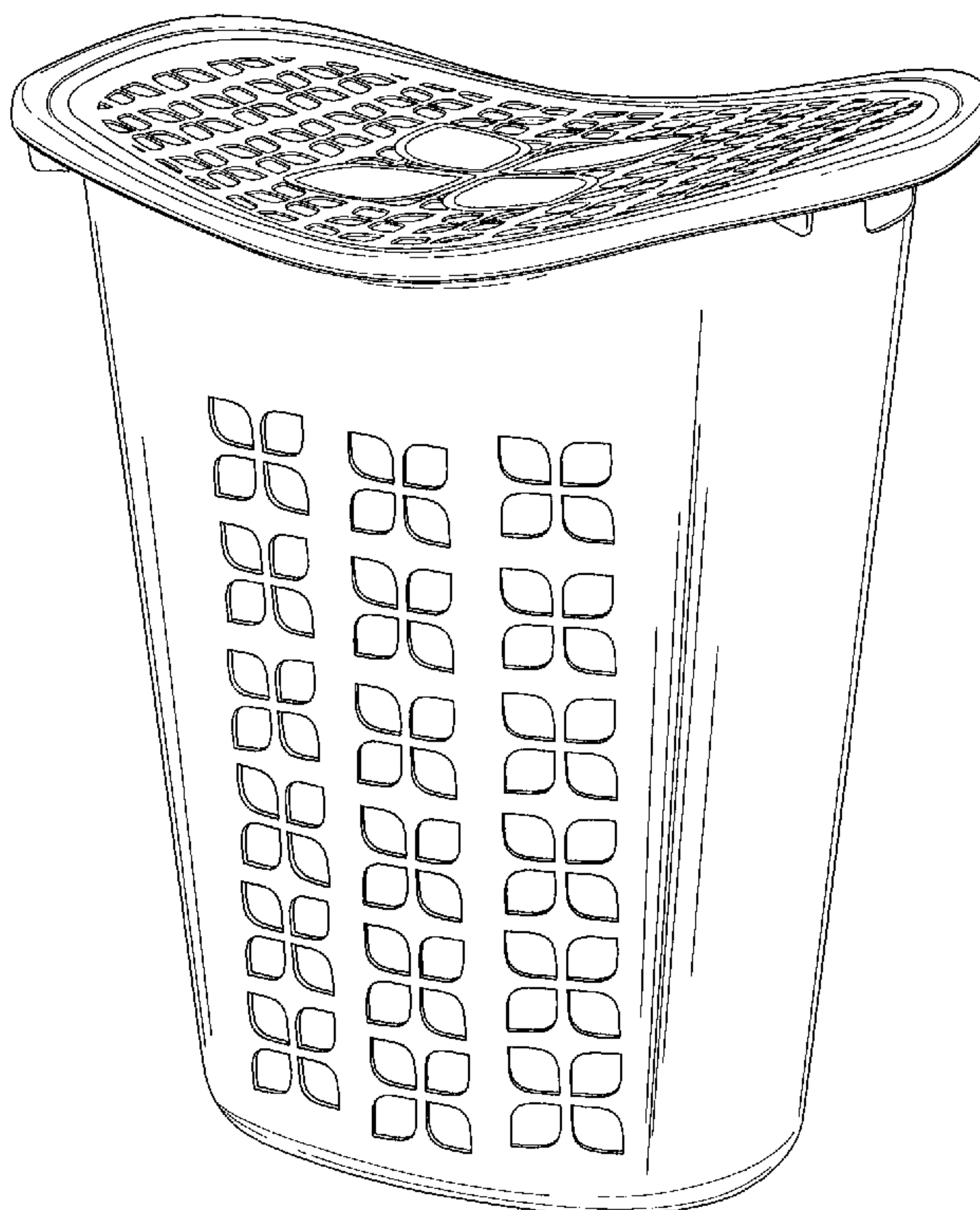
FIG. 5 is a top view showing our new design shown in FIG. 1;

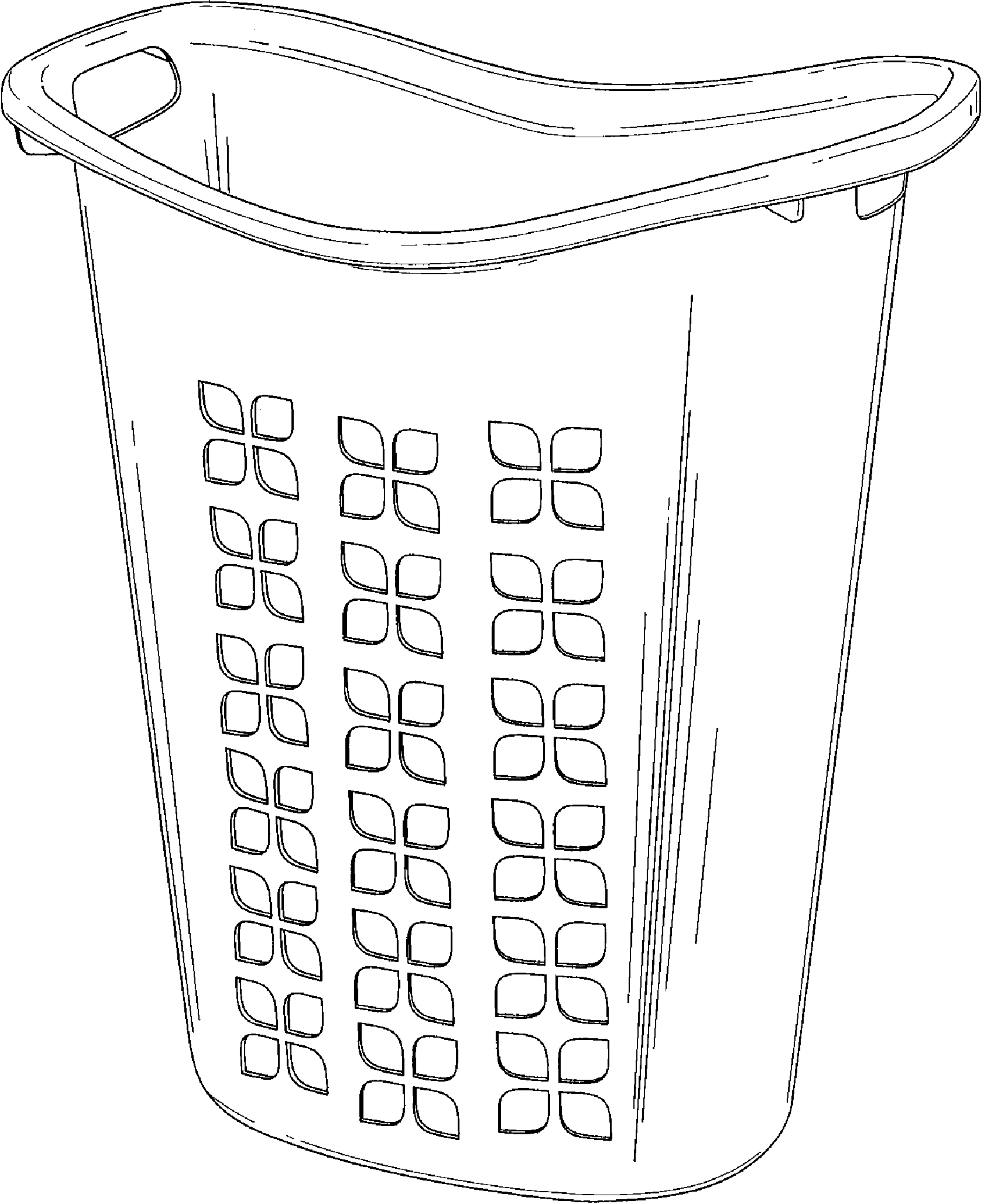

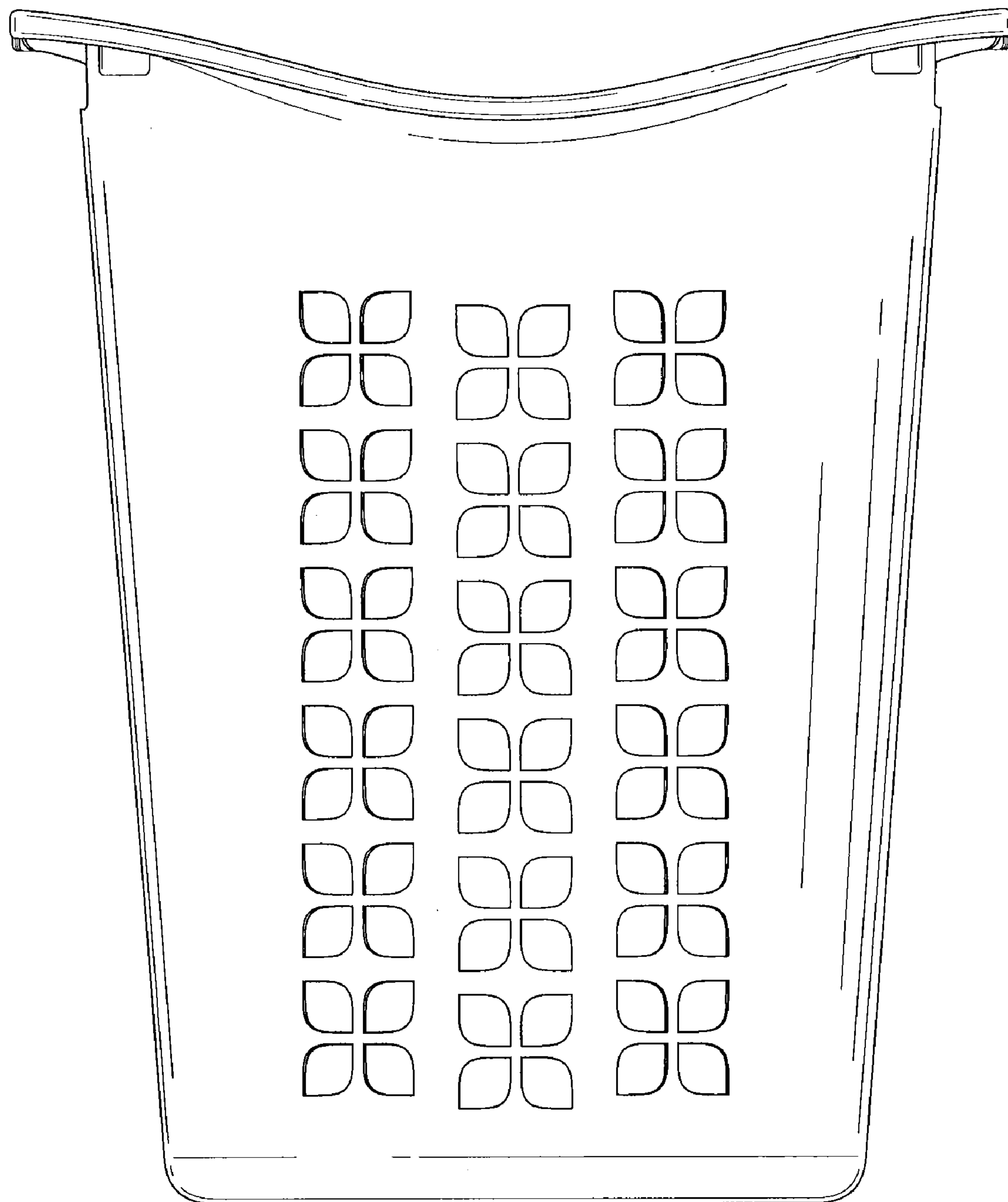

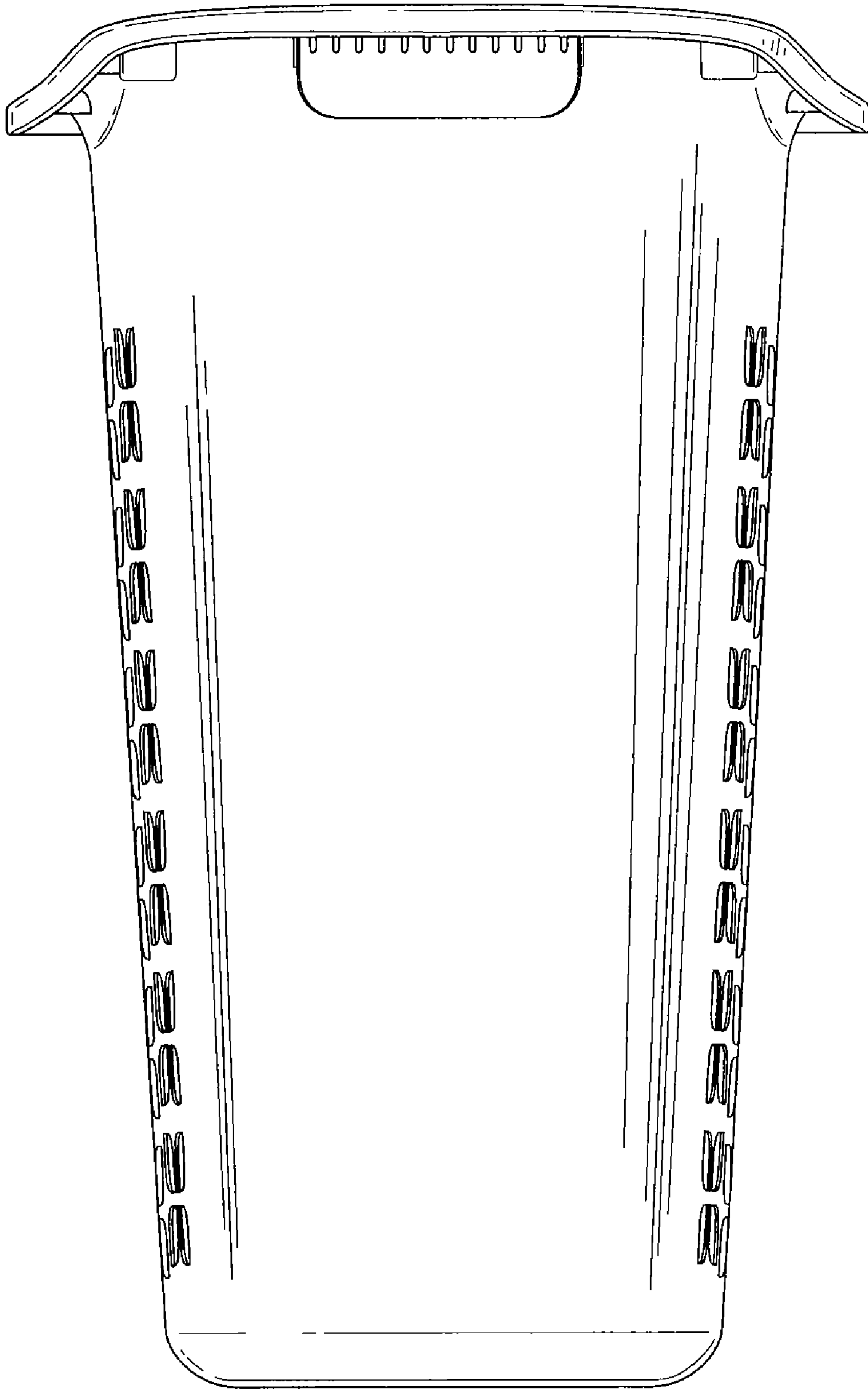

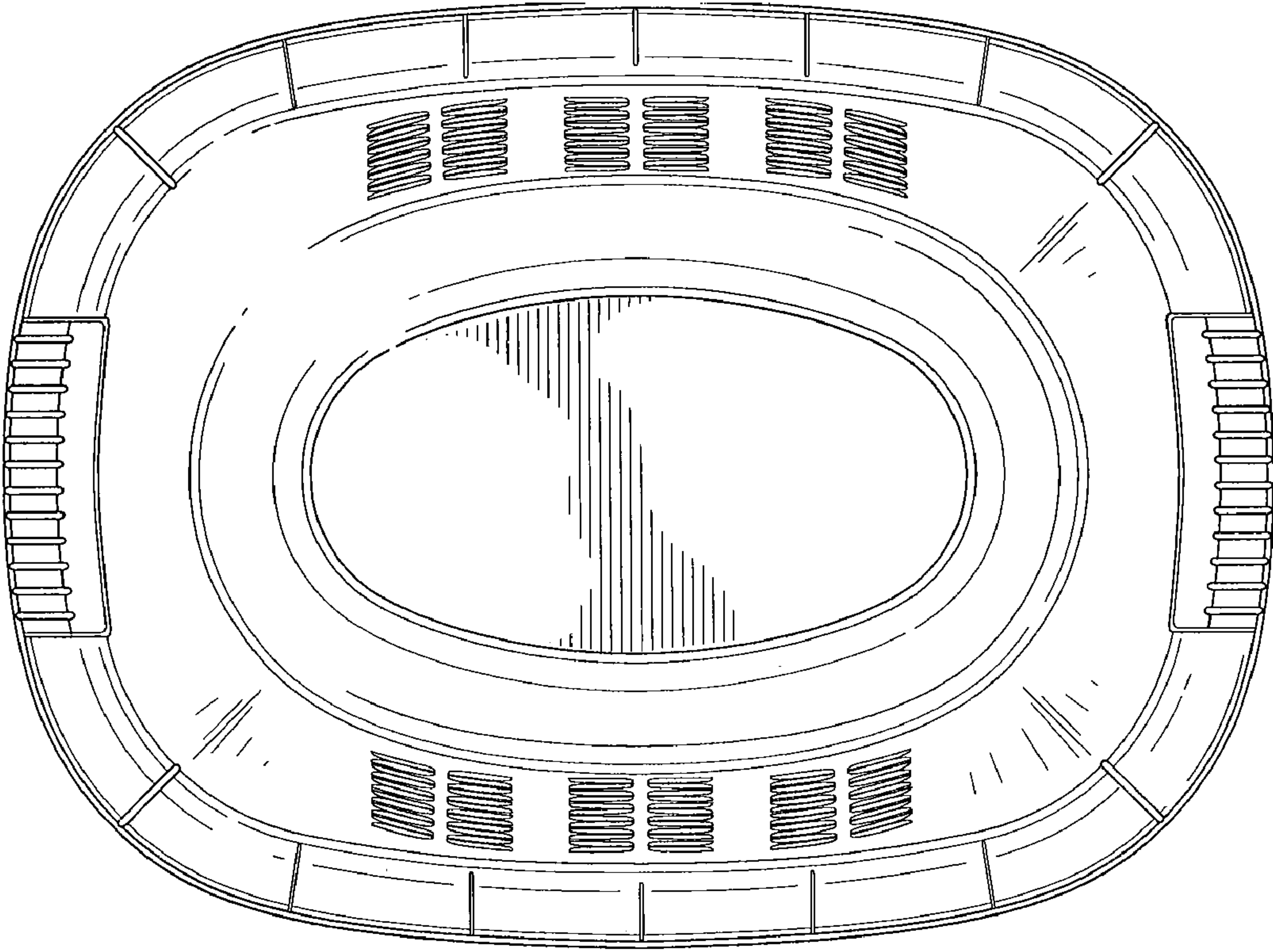

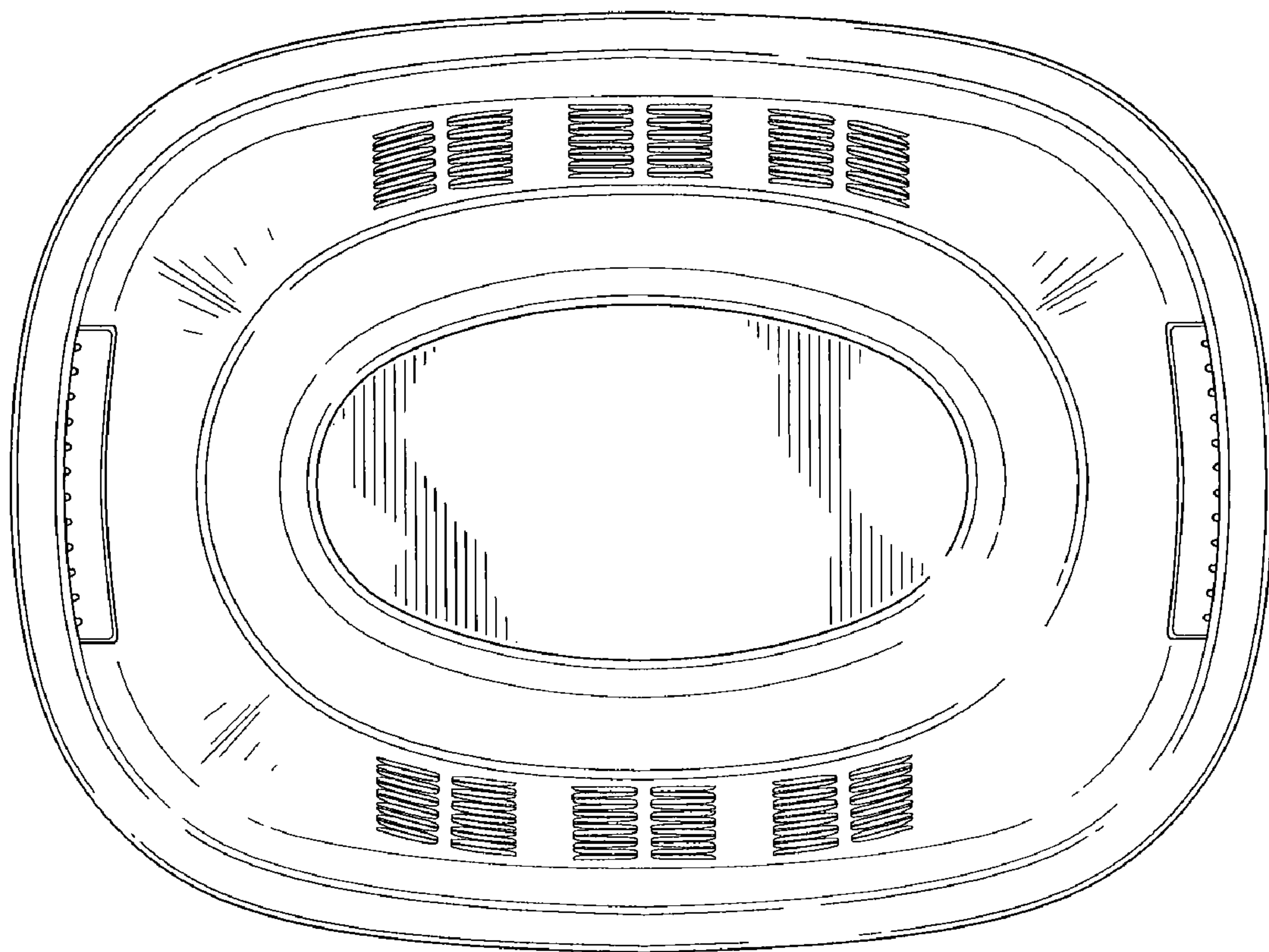

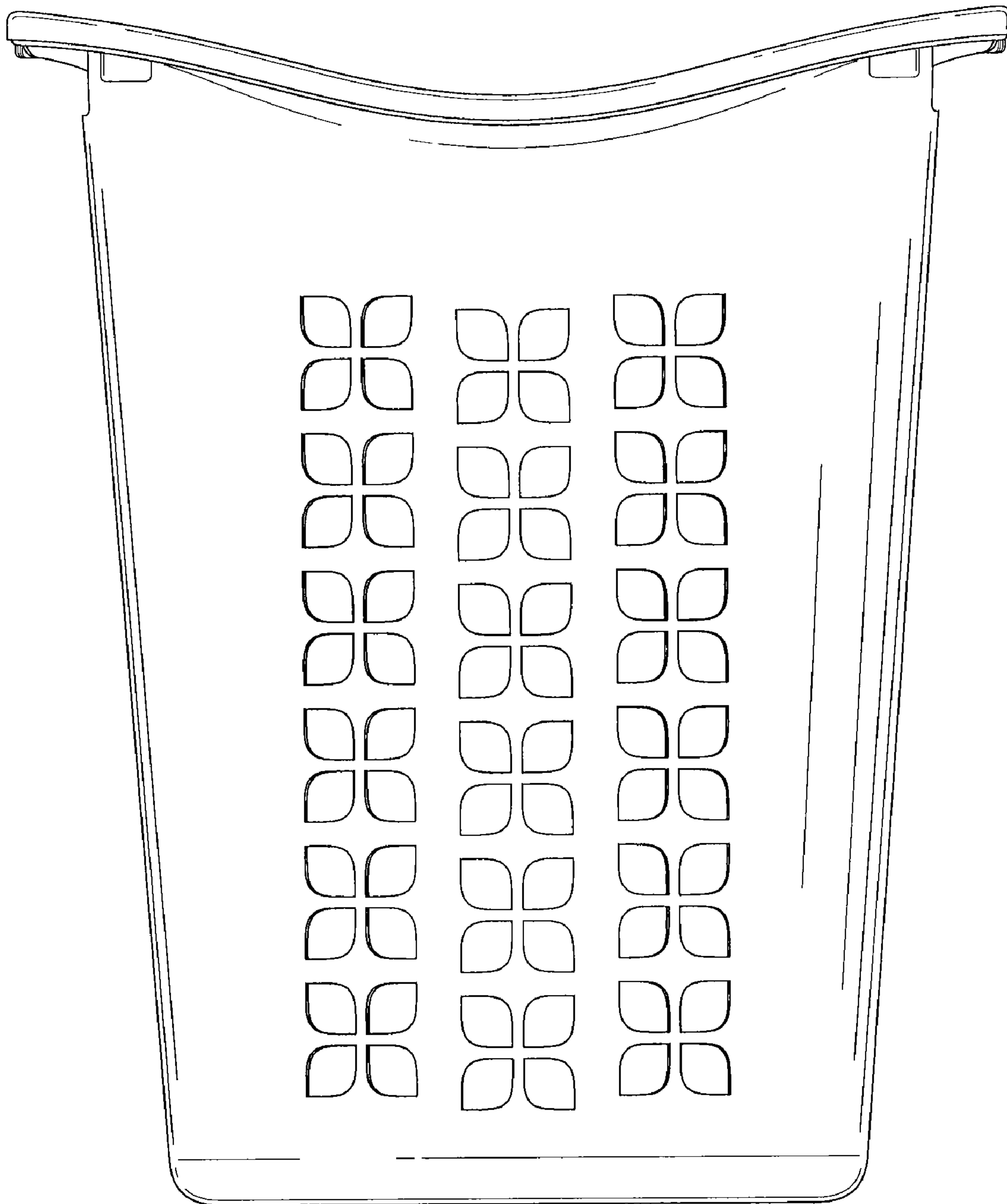

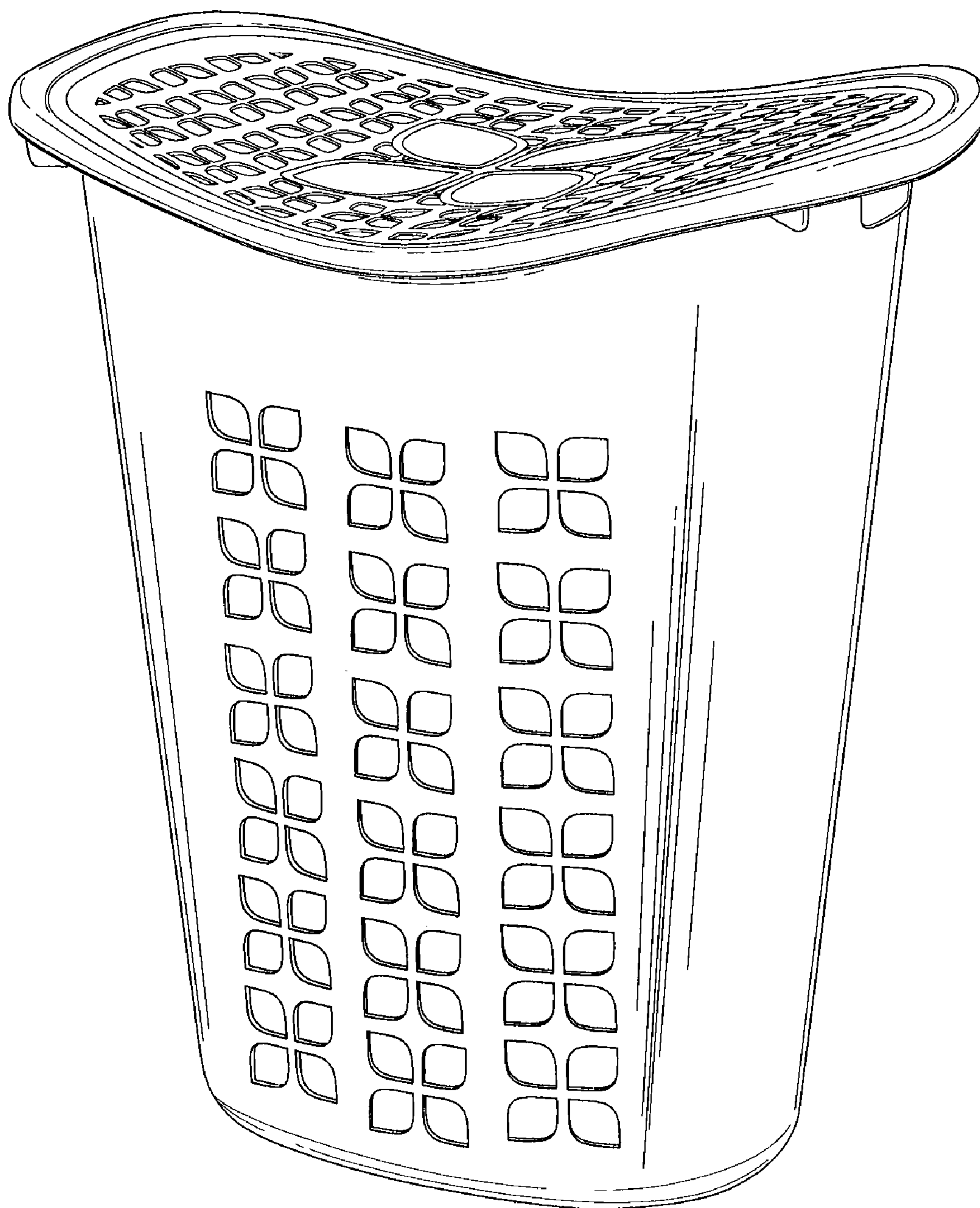

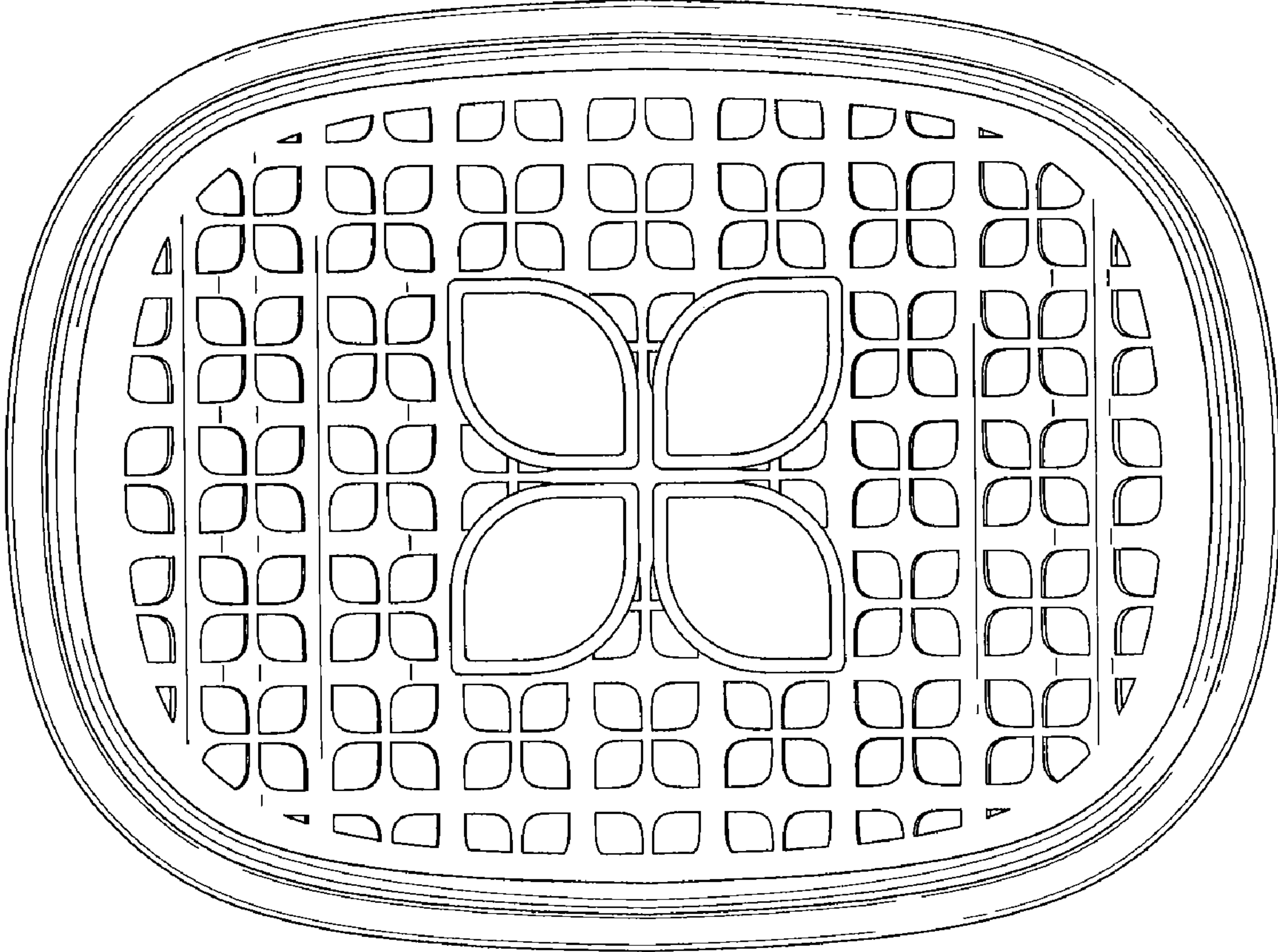
