(57) **CLAIM**

The ornamental design for a structural member for a hand truck or cart, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hand truck frame member showing my new design, the broken line illustration of the other components of the hand truck are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is an end view of a frame member on an enlarged scale;

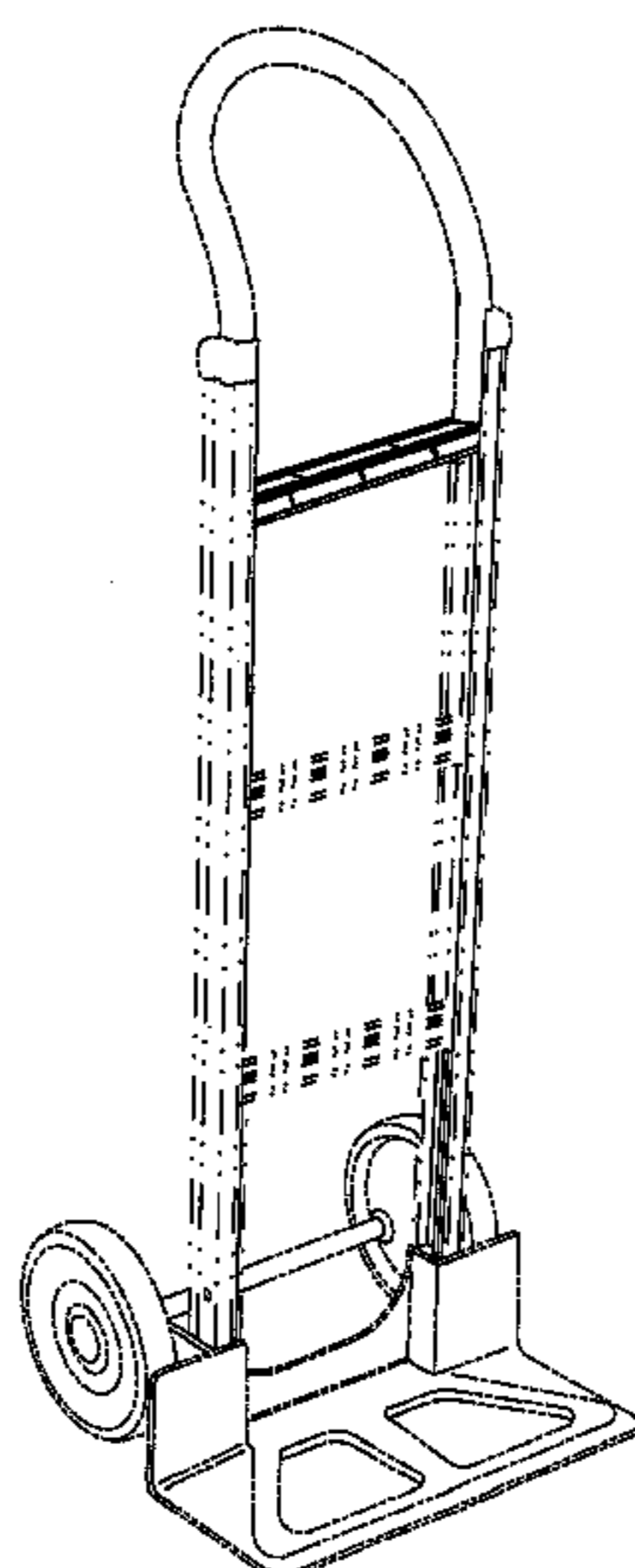
FIG. 3 is an enlarged fragmentary side view thereof, the opposite side view being a mirror image of that shown;

FIG. 4 is an enlarged fragmentary rear view thereof;

FIG. 5 is an enlarged fragmentary front view thereof; and,

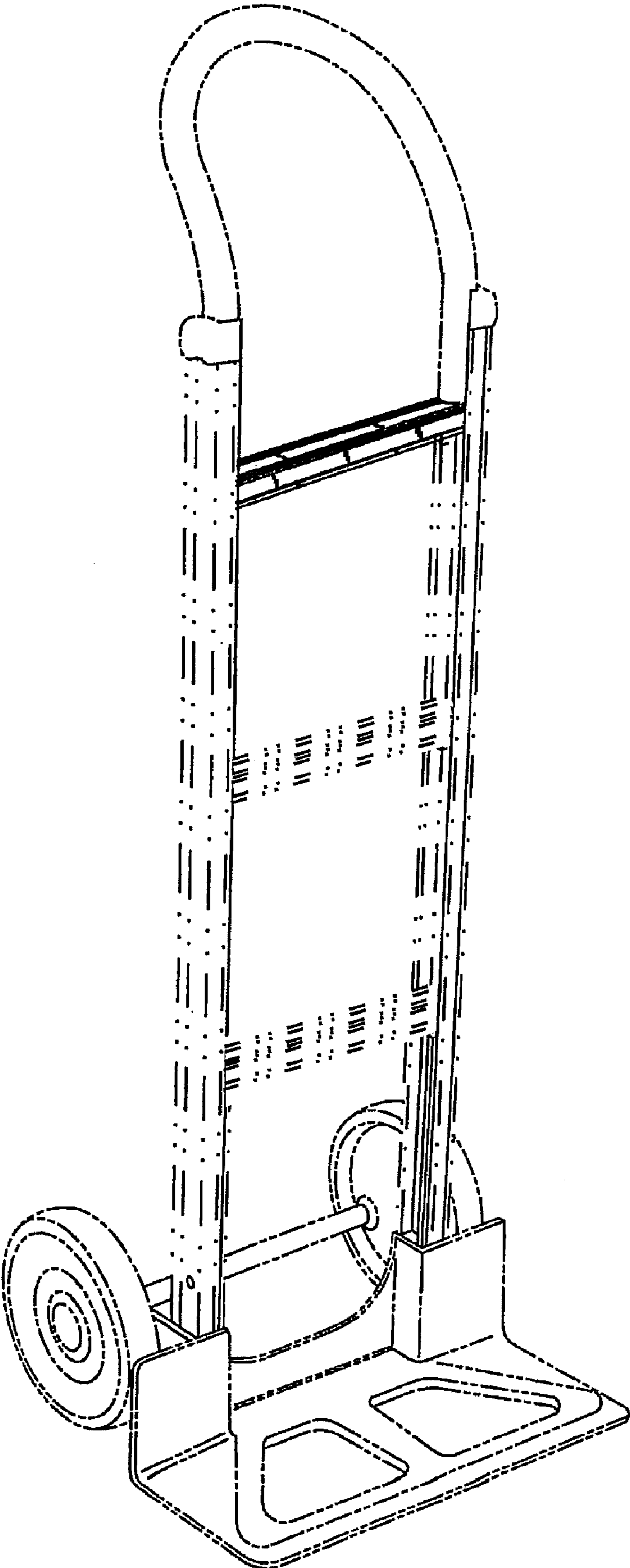

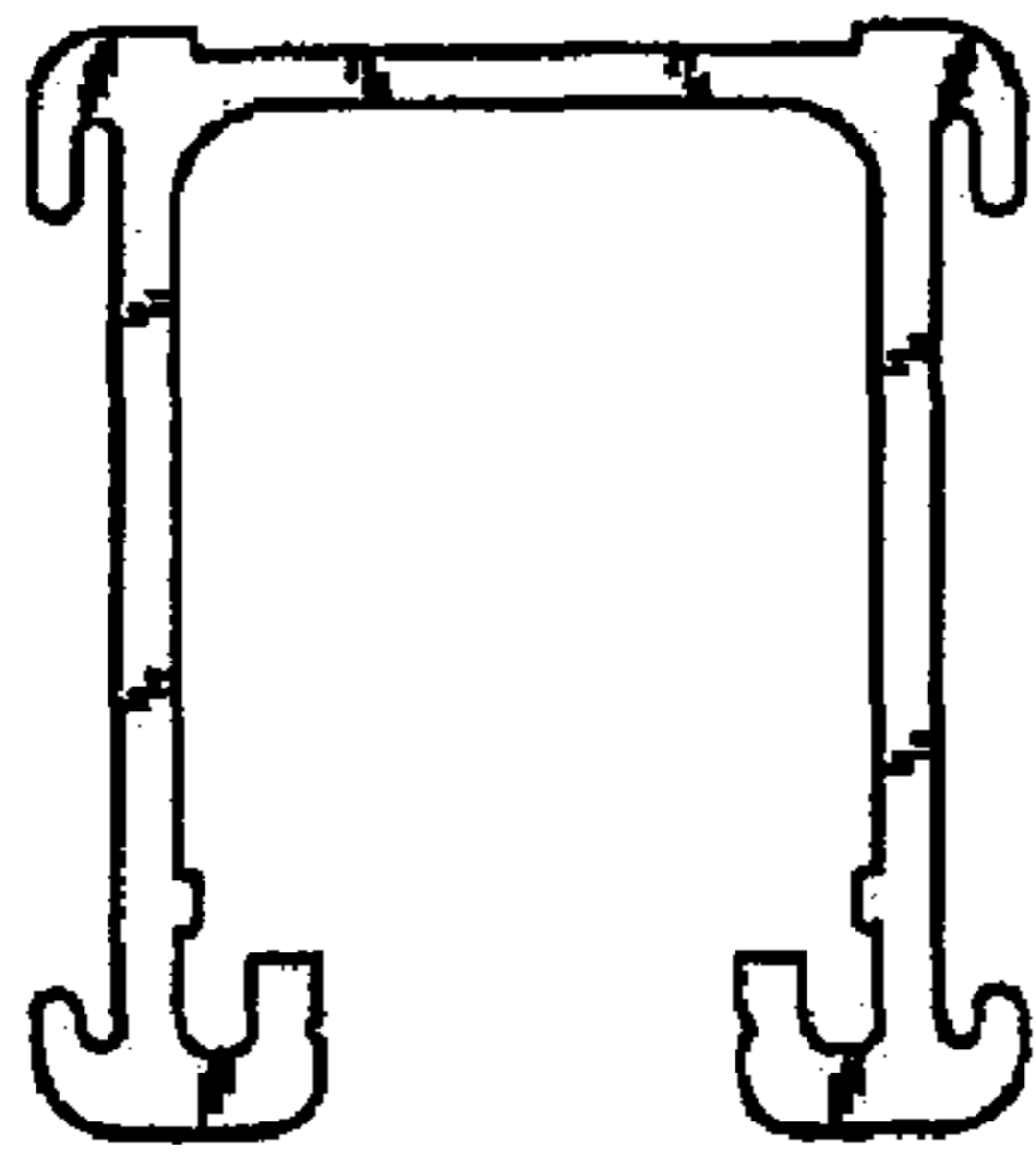

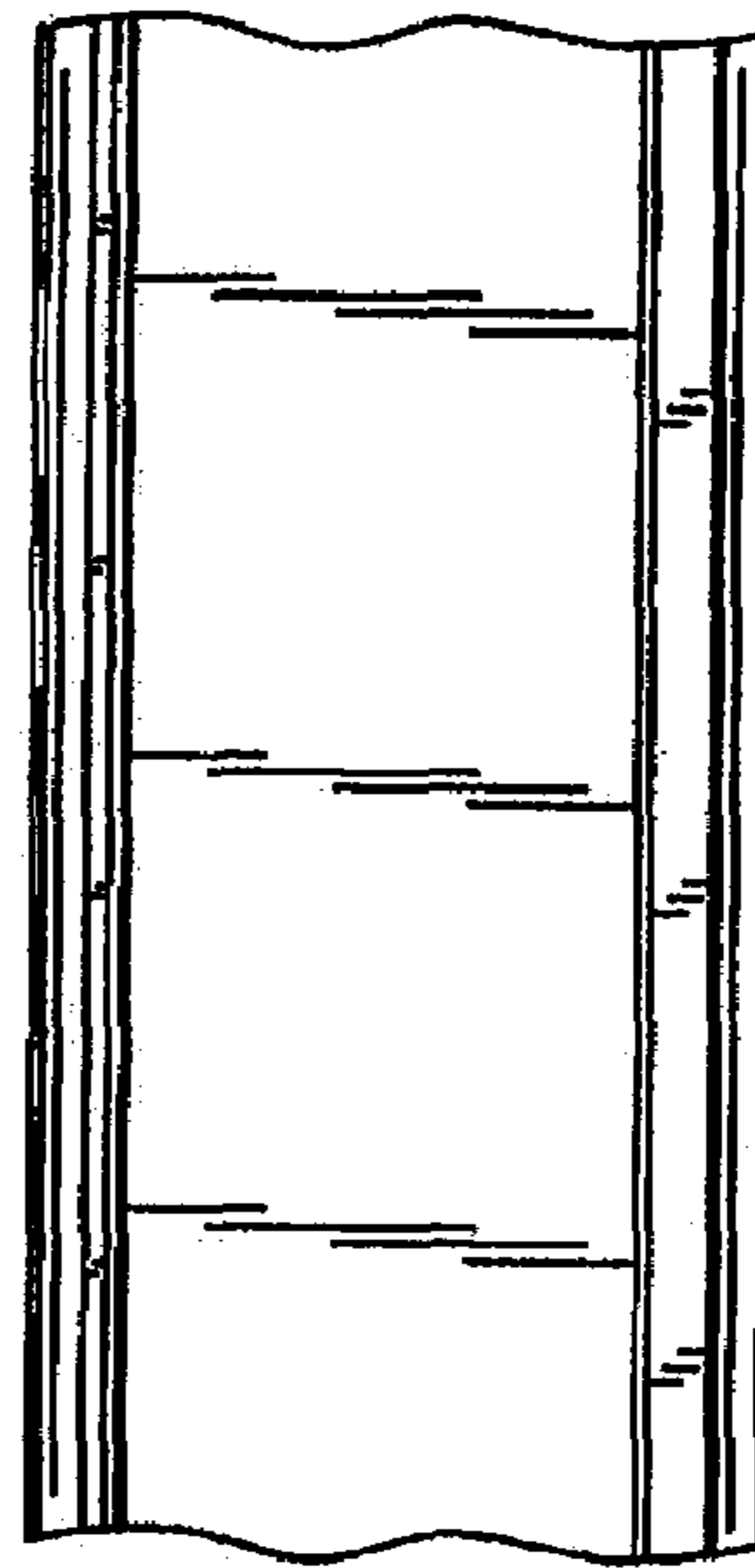

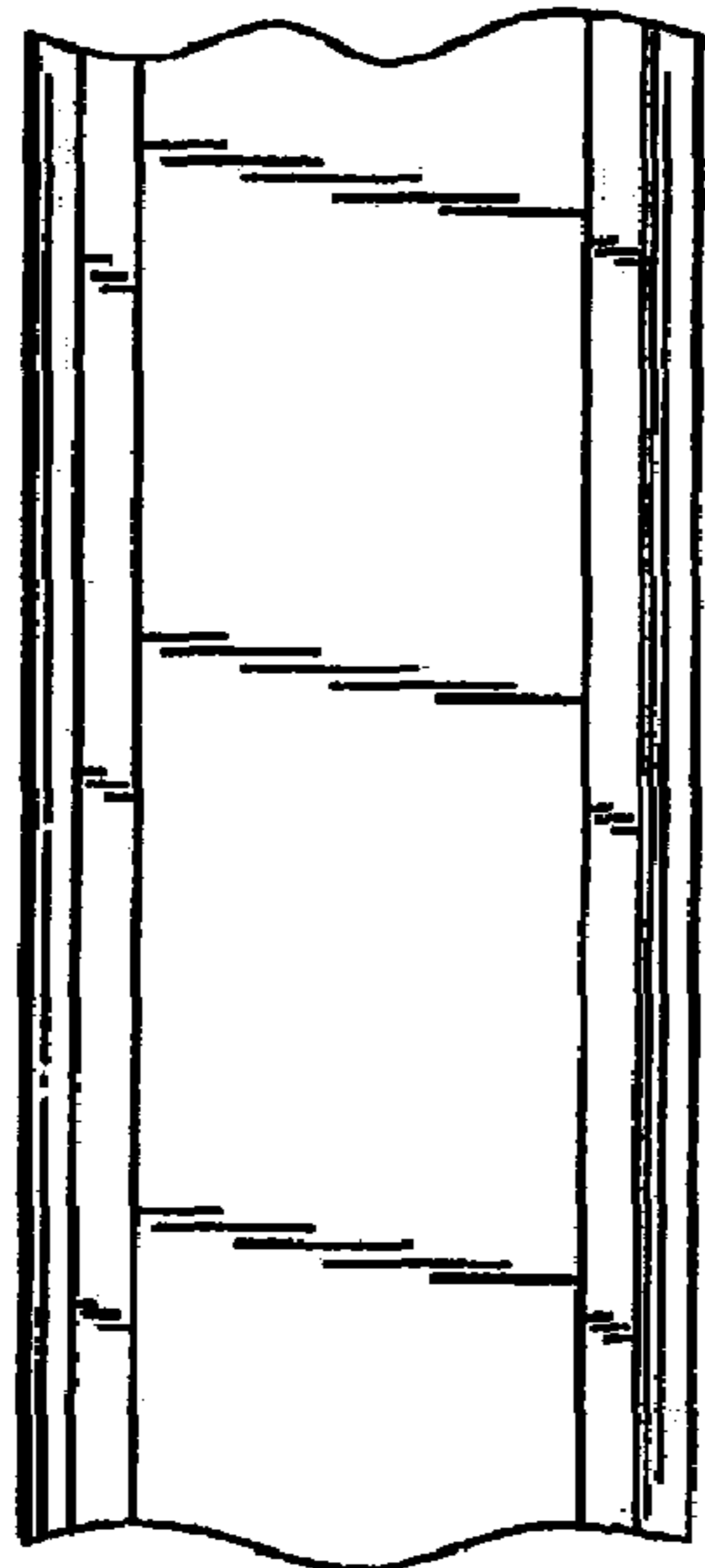

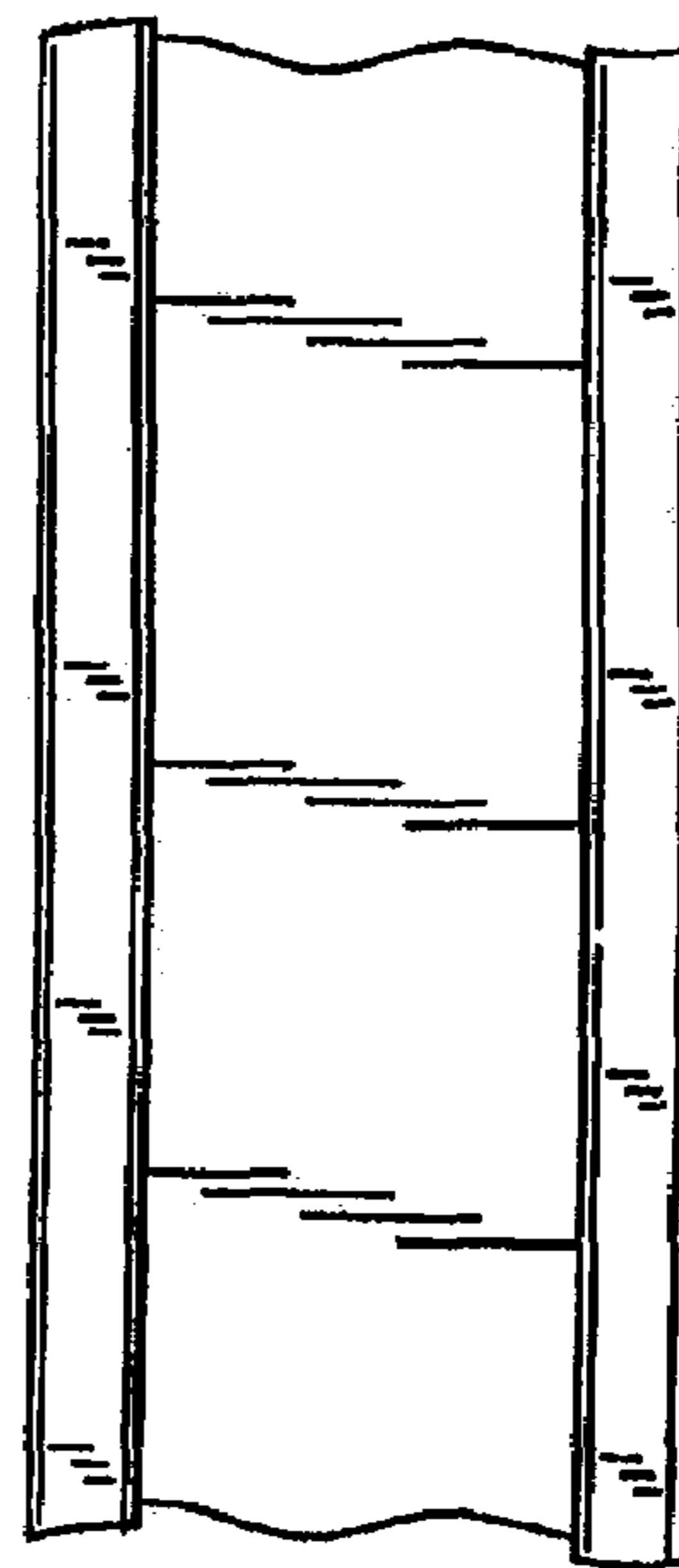

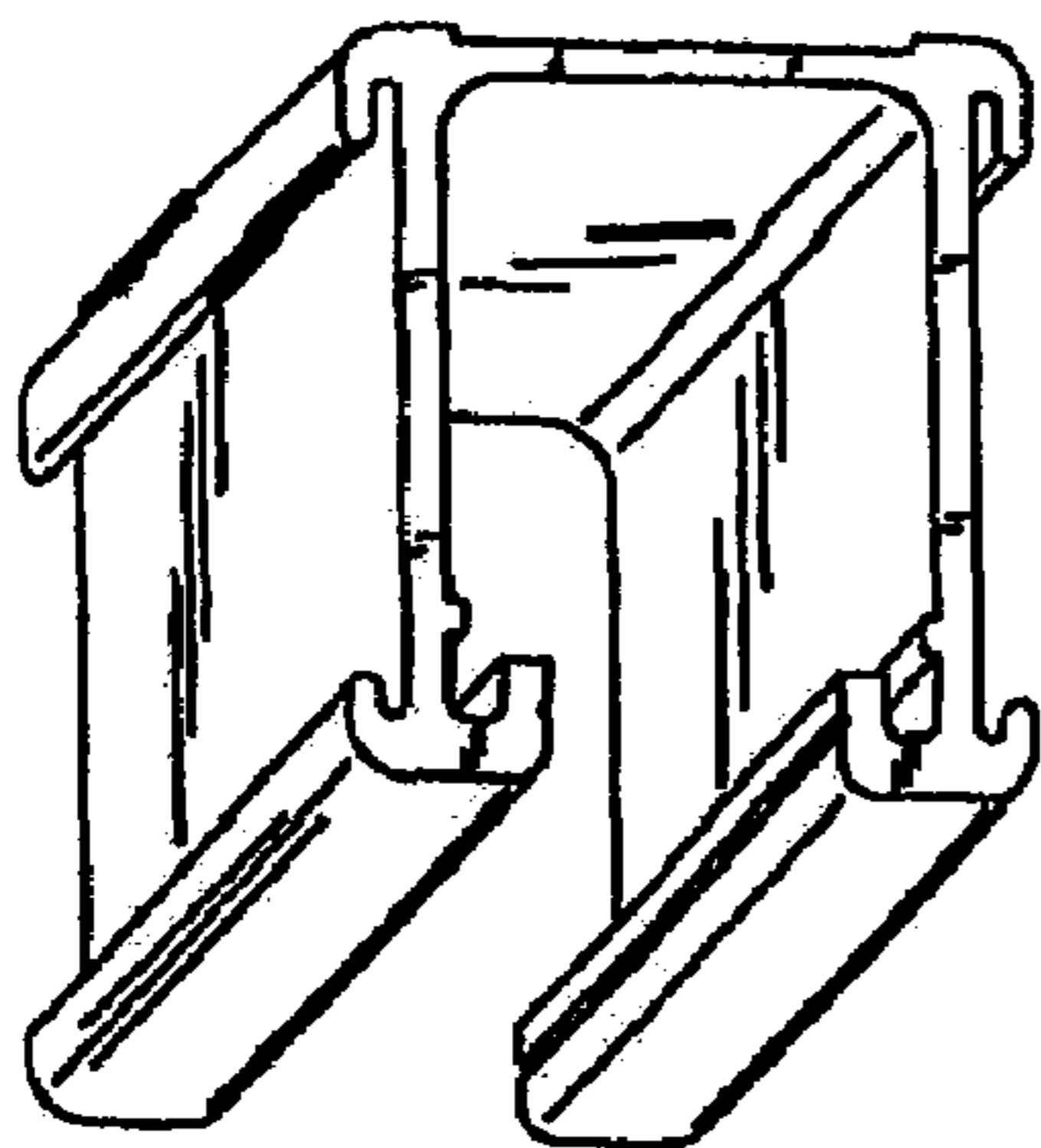
