(57) **CLAIM**

The ornamental design for a swimming costume, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a swimming costume showing my new design;

FIG. 2 is a left side view of the swimming costume in FIG. 1;

FIG. 3 is a rear view of the swimming costume in FIG. 1.

FIG. 4 is a right side view of the swimming costume in FIG. 1;

FIG. 5 is a front view of another embodiment of the swimming costume;

FIG. 6 is a left side view of the swimming costume in FIG. 5;

FIG. 7 is a rear view of the swimming costume in FIG. 5;

FIG. 8 is a right side view of the swimming costume in FIG. 5;

FIG. 15 is a rear view of the swimming costume in FIG. 13; and,

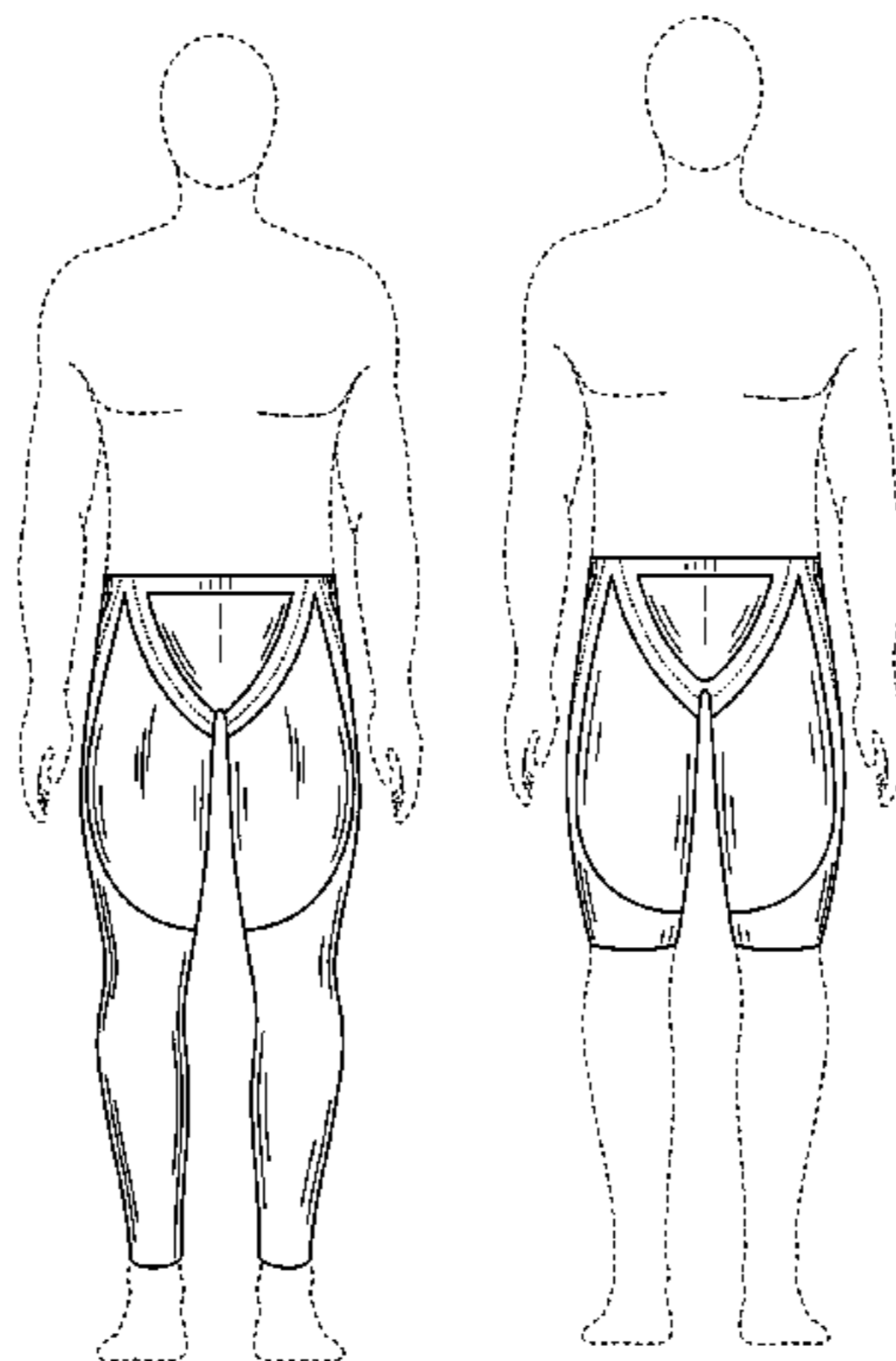
FIG. 16 is a right side view of the swimming costume in FIG. 13.

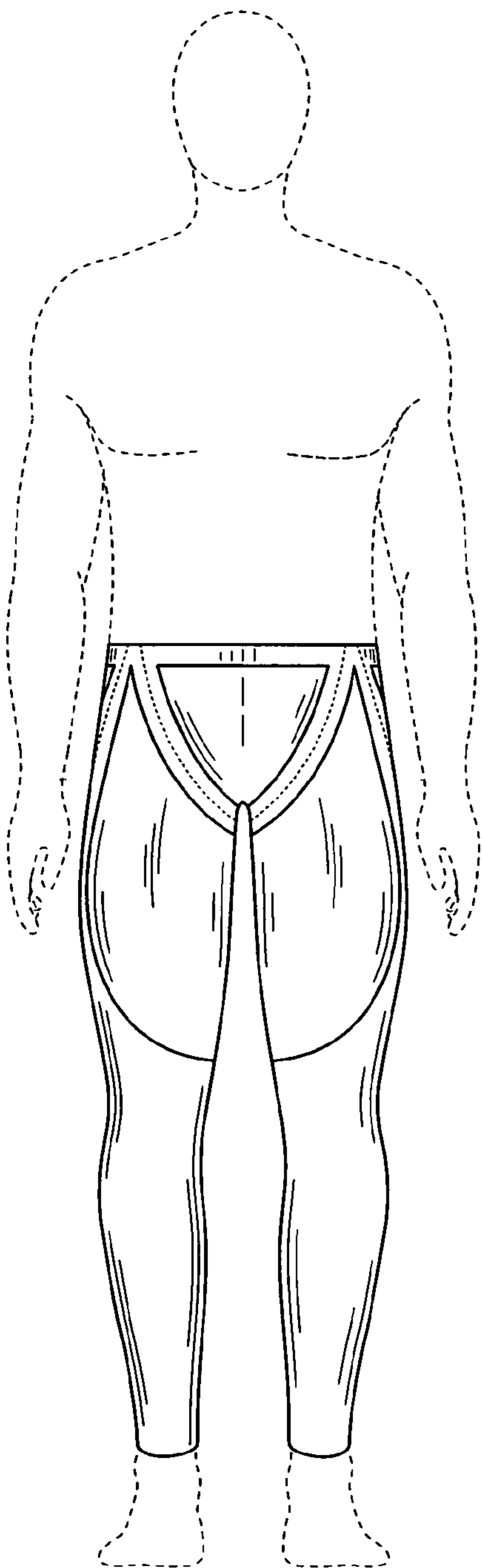

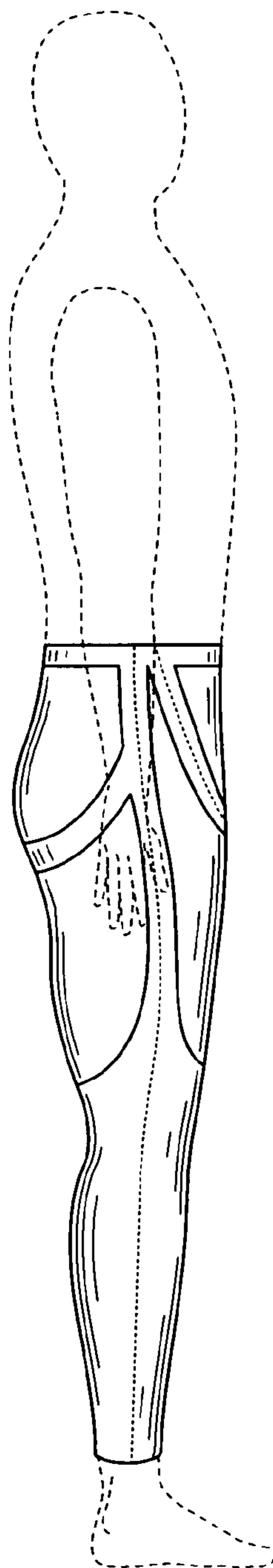

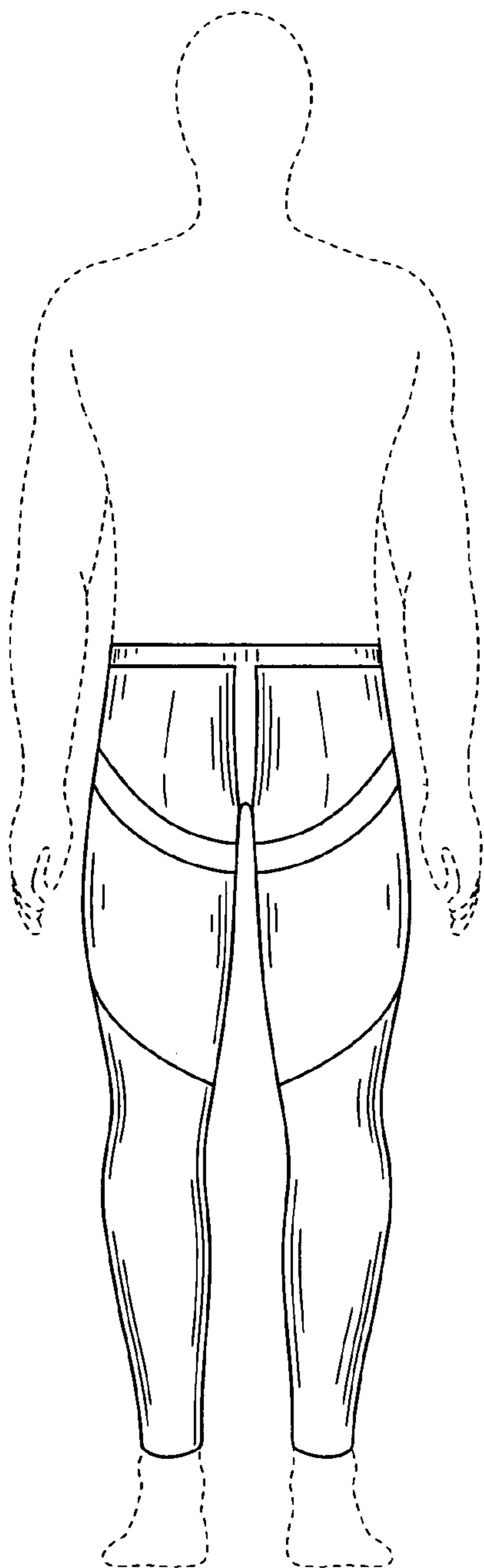

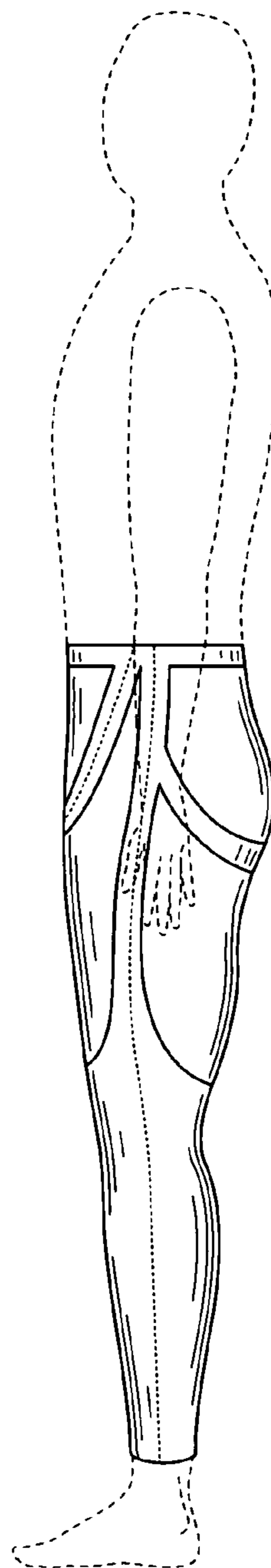

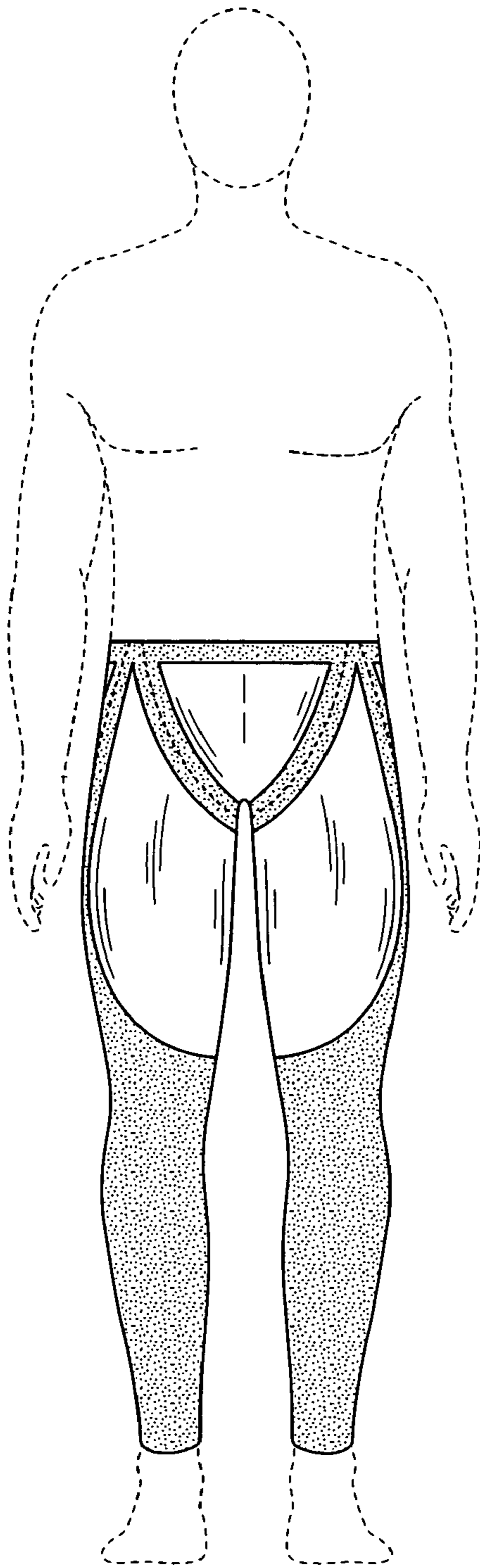

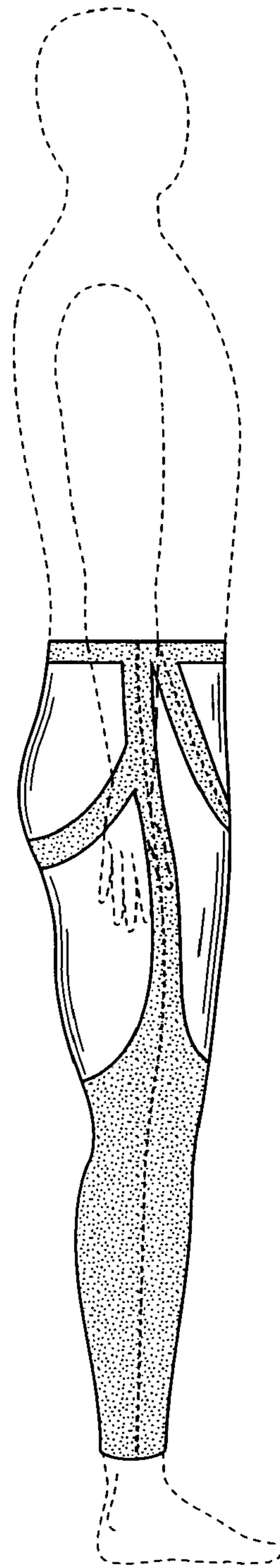

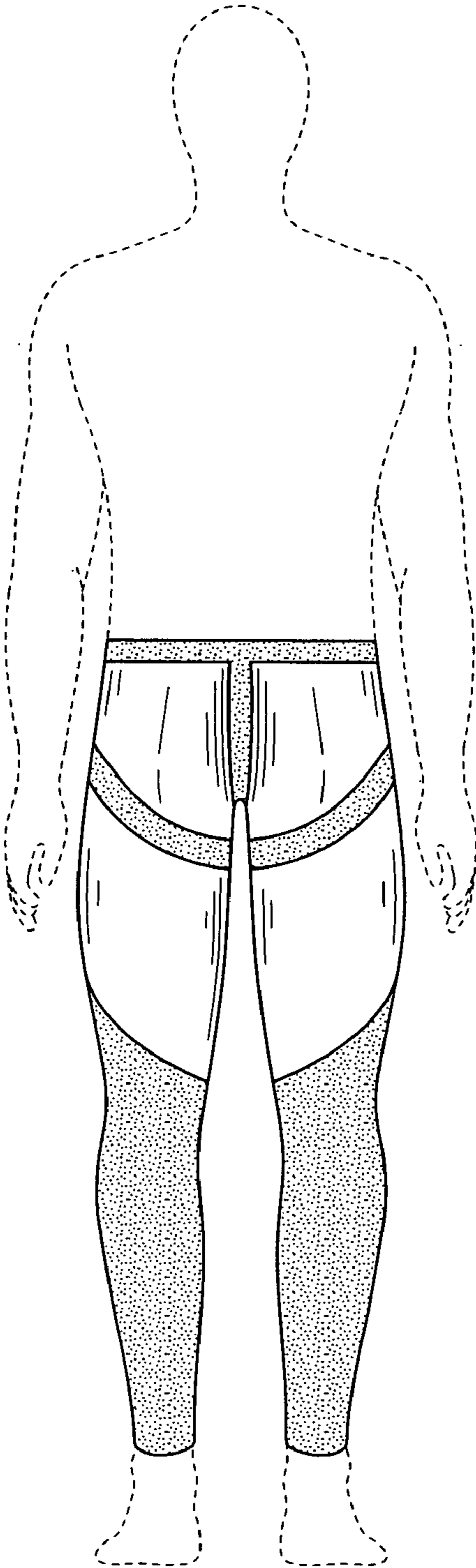

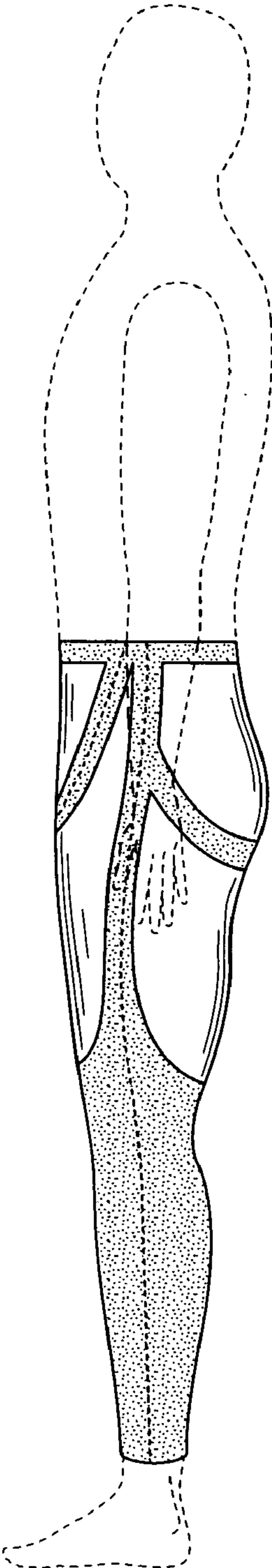

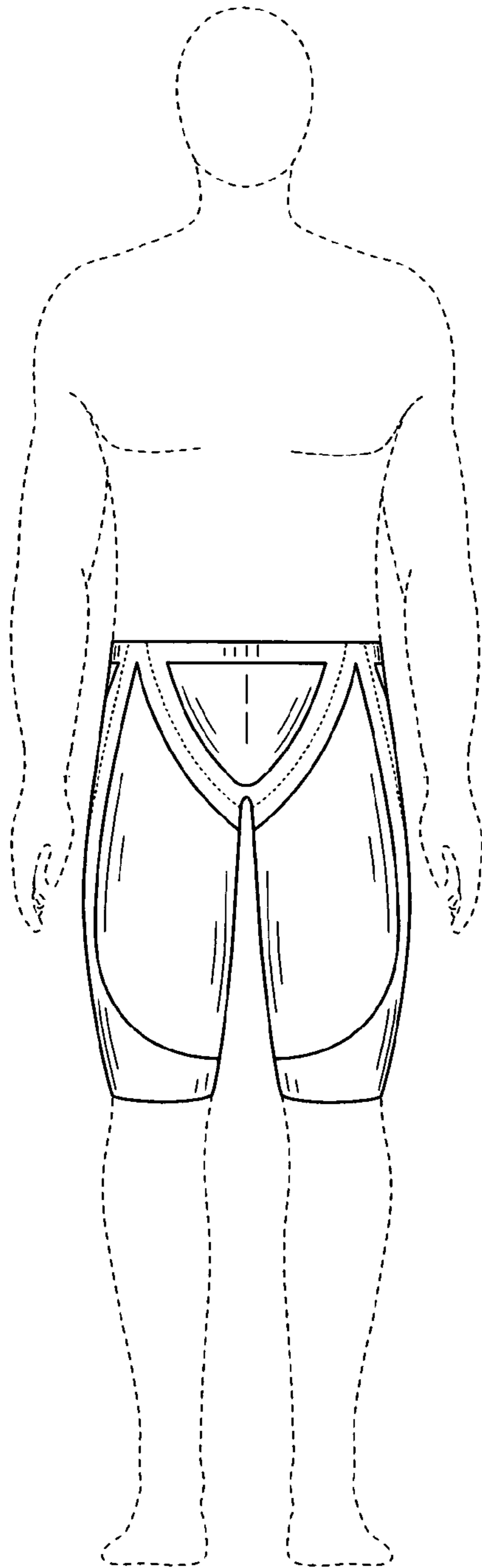

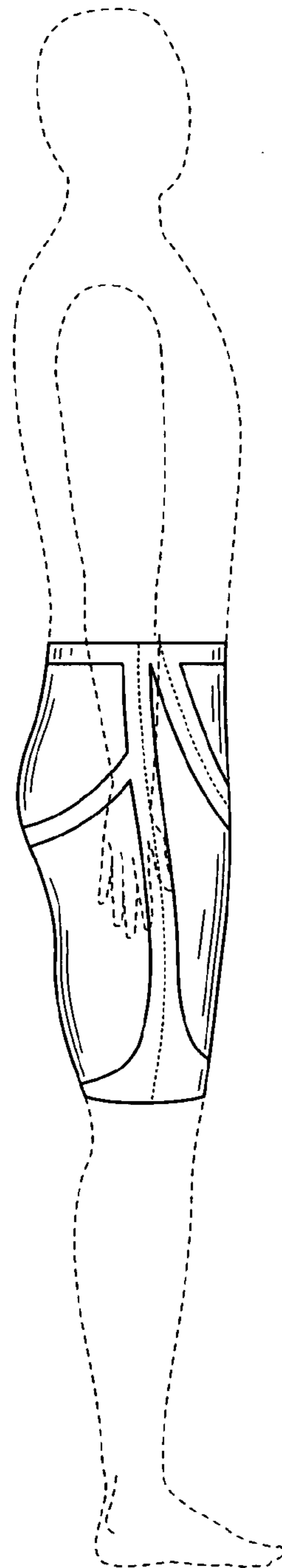

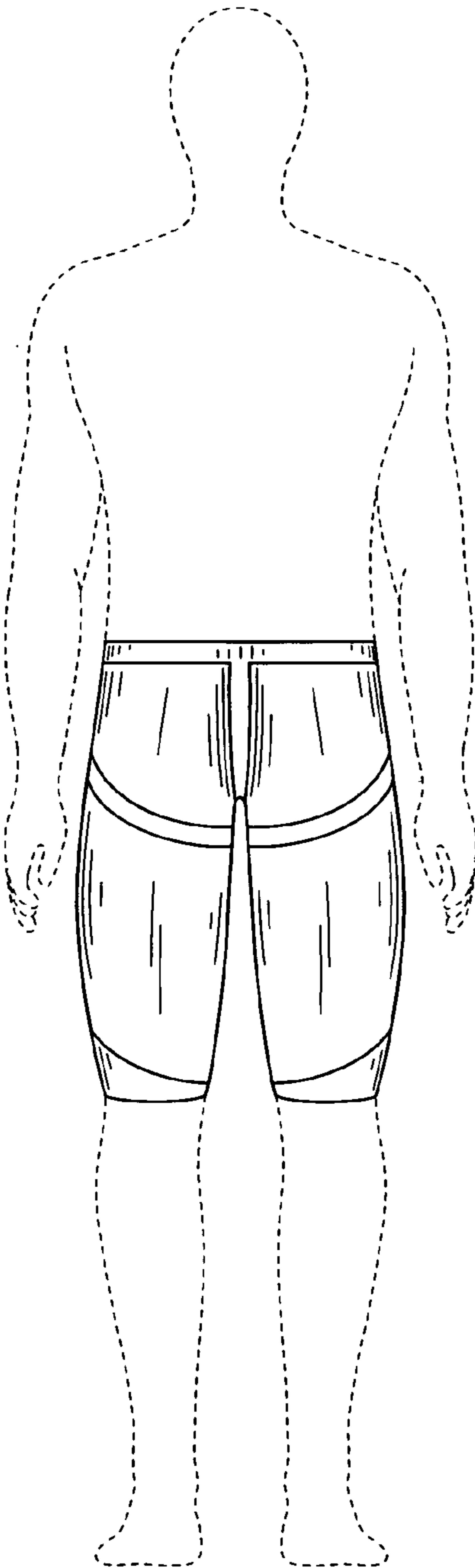

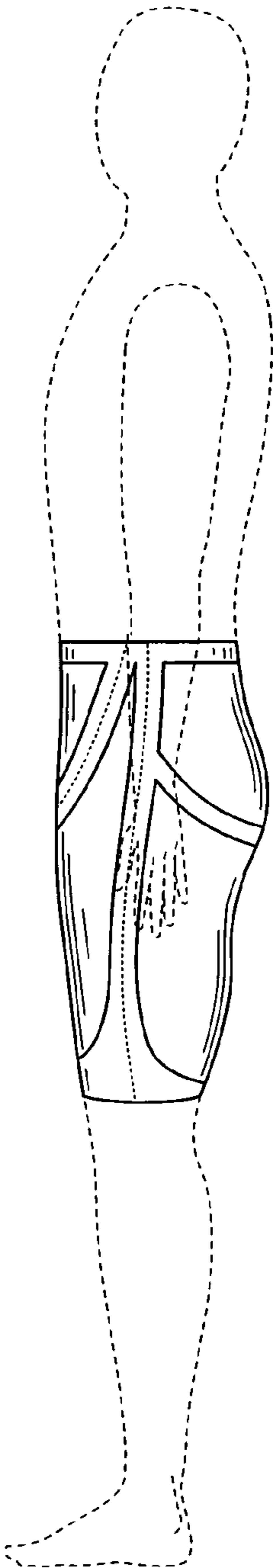

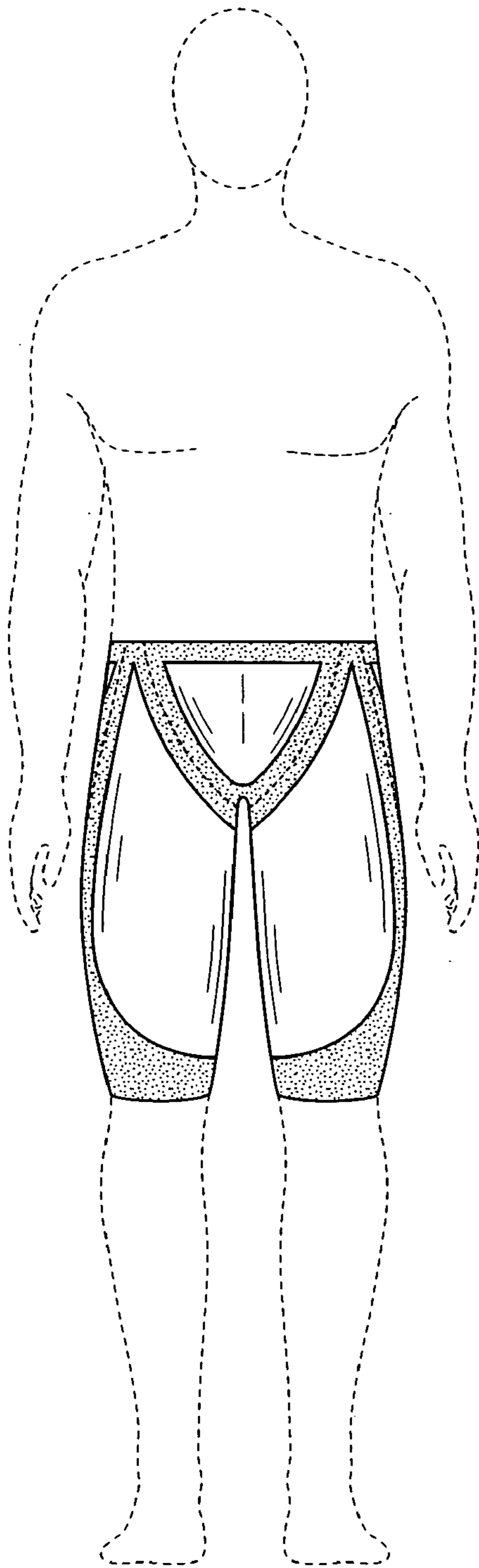

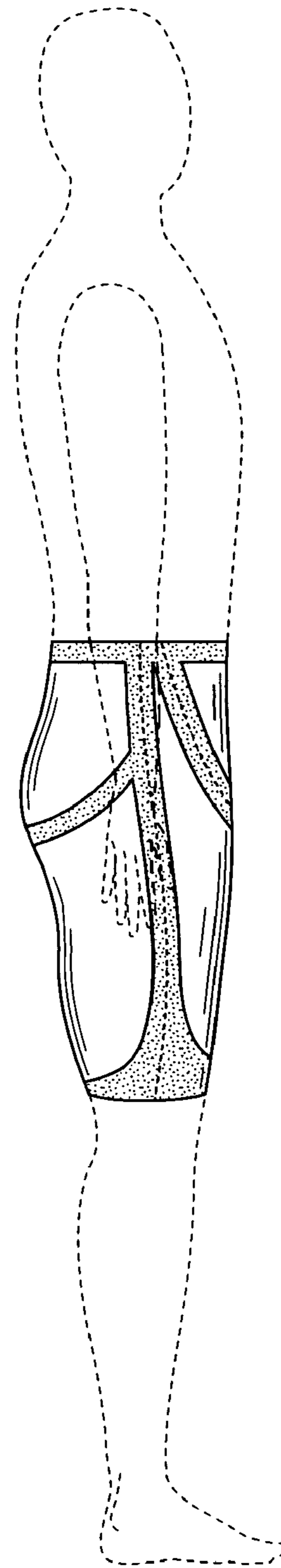

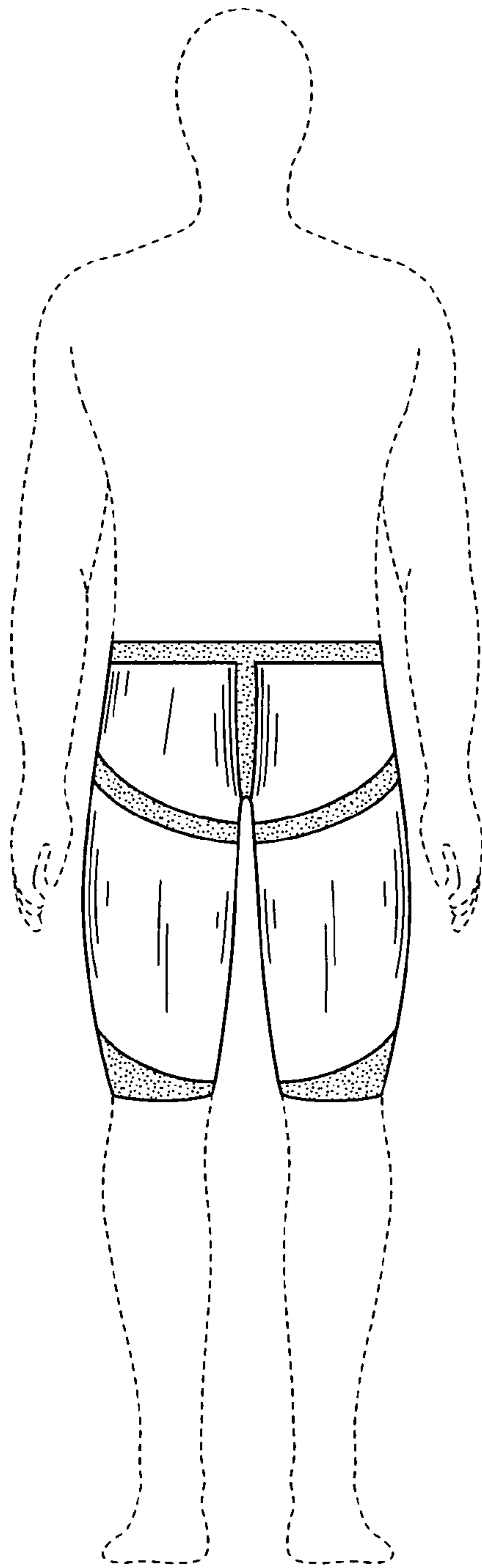

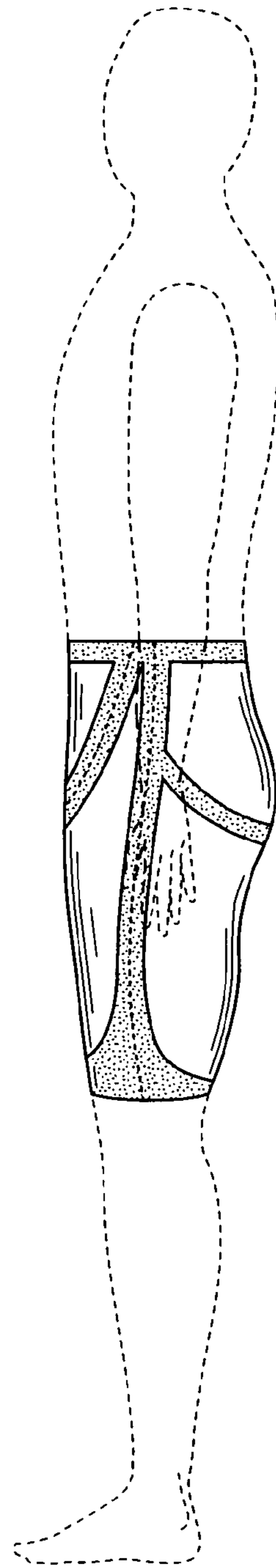
