(57) **CLAIM**

The ornamental design for a rain hat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from above showing the rain hat with a closure in a closed position;

FIG. 2 is a plan view of the rain hat, from below;

FIG. 3 is a plan view of the rain hat, from above;

FIG. 4 is a right side view of the rain hat;

FIG. 5 is a left side view of the rain hat;

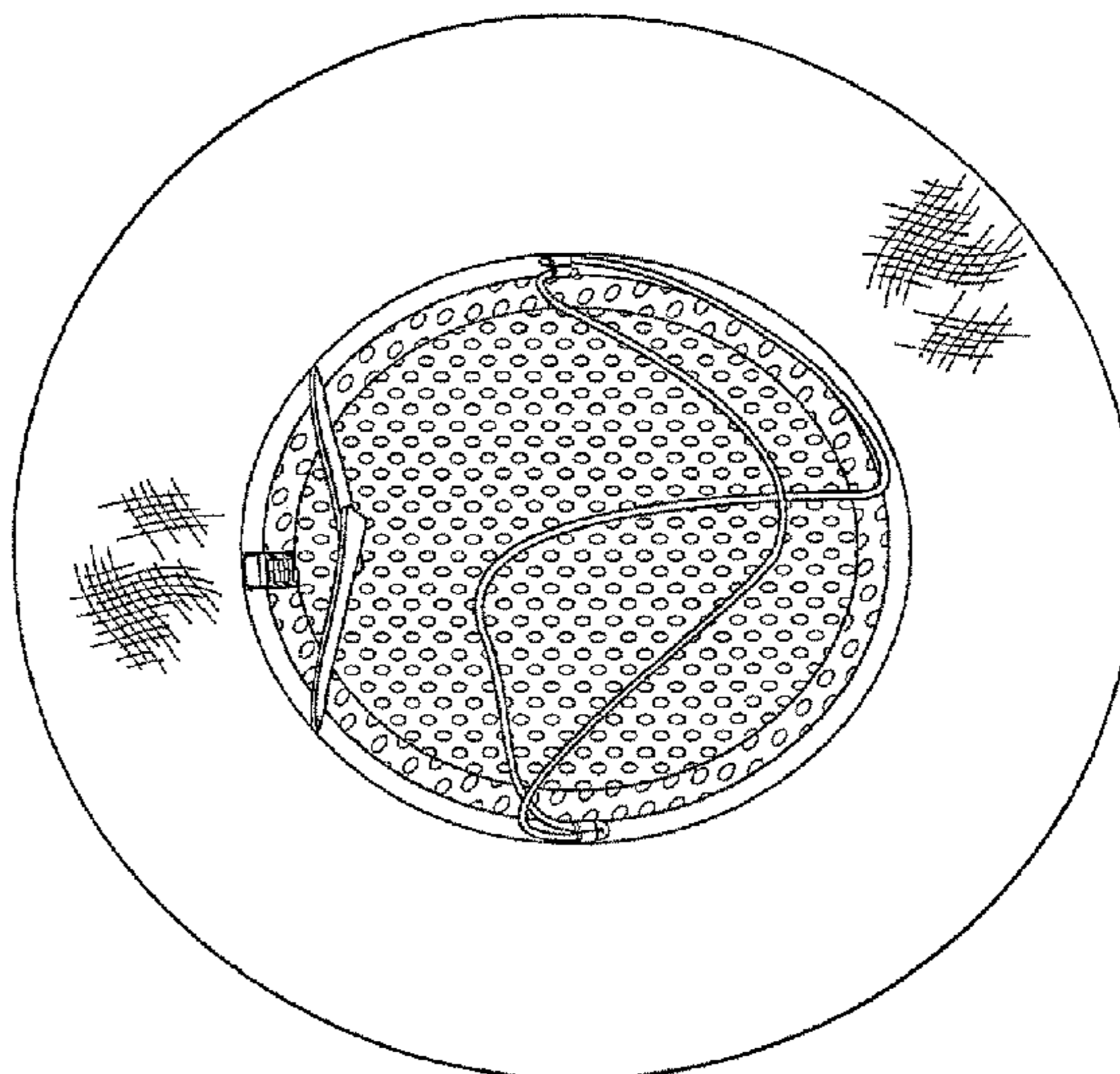
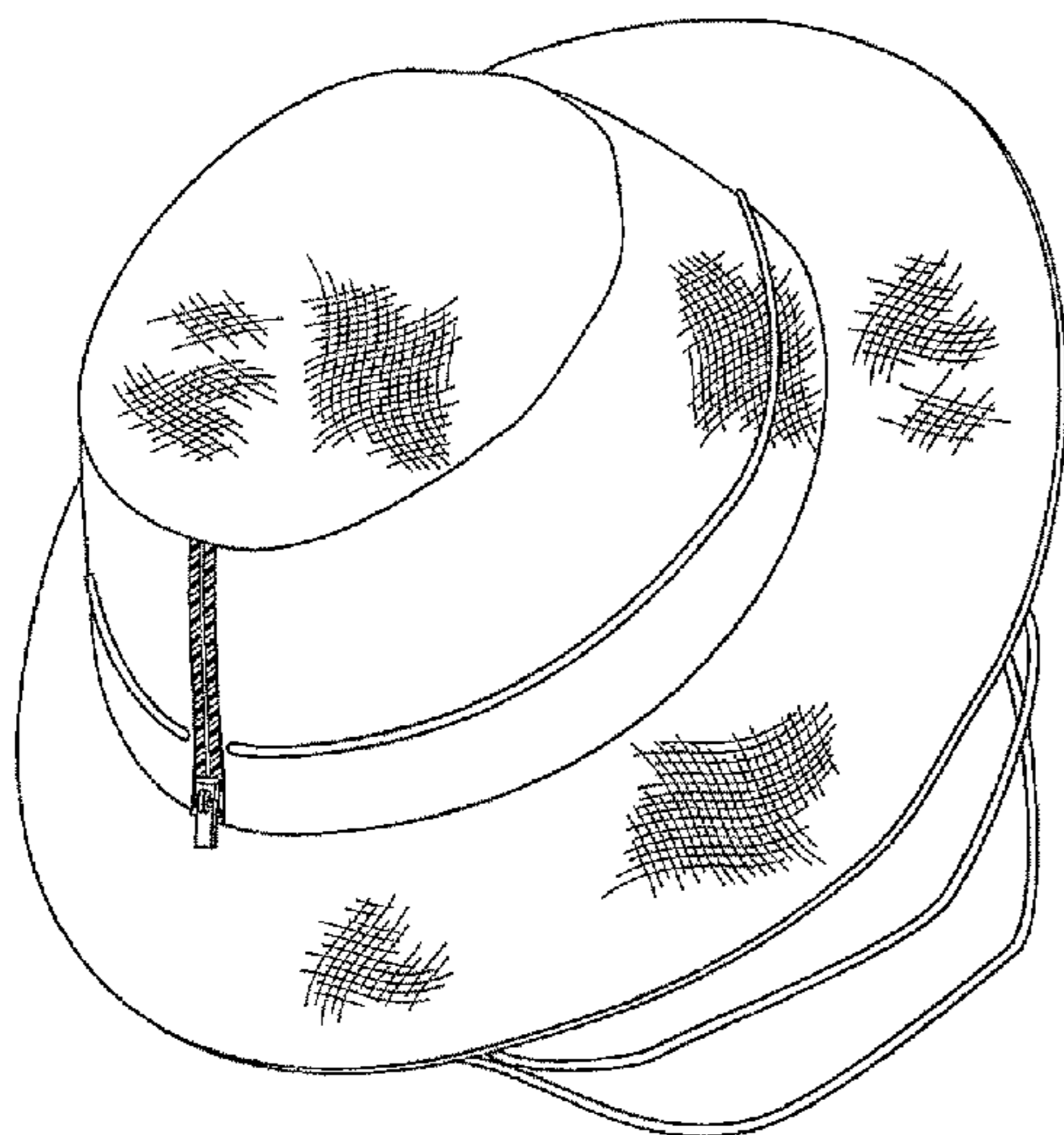
FIG. 6 is a front view of the rain hat;

FIG. 7 is a rear view of the rain hat, showing the closure in the closed position; and,

FIG. 8 is a perspective view from above of the rain hat showing the closure in the open position.

The crosshatched pattern, although shown intermittently, is meant to represent fabric, and is understood to be distributed uniformly over the surfaces of the claimed design.

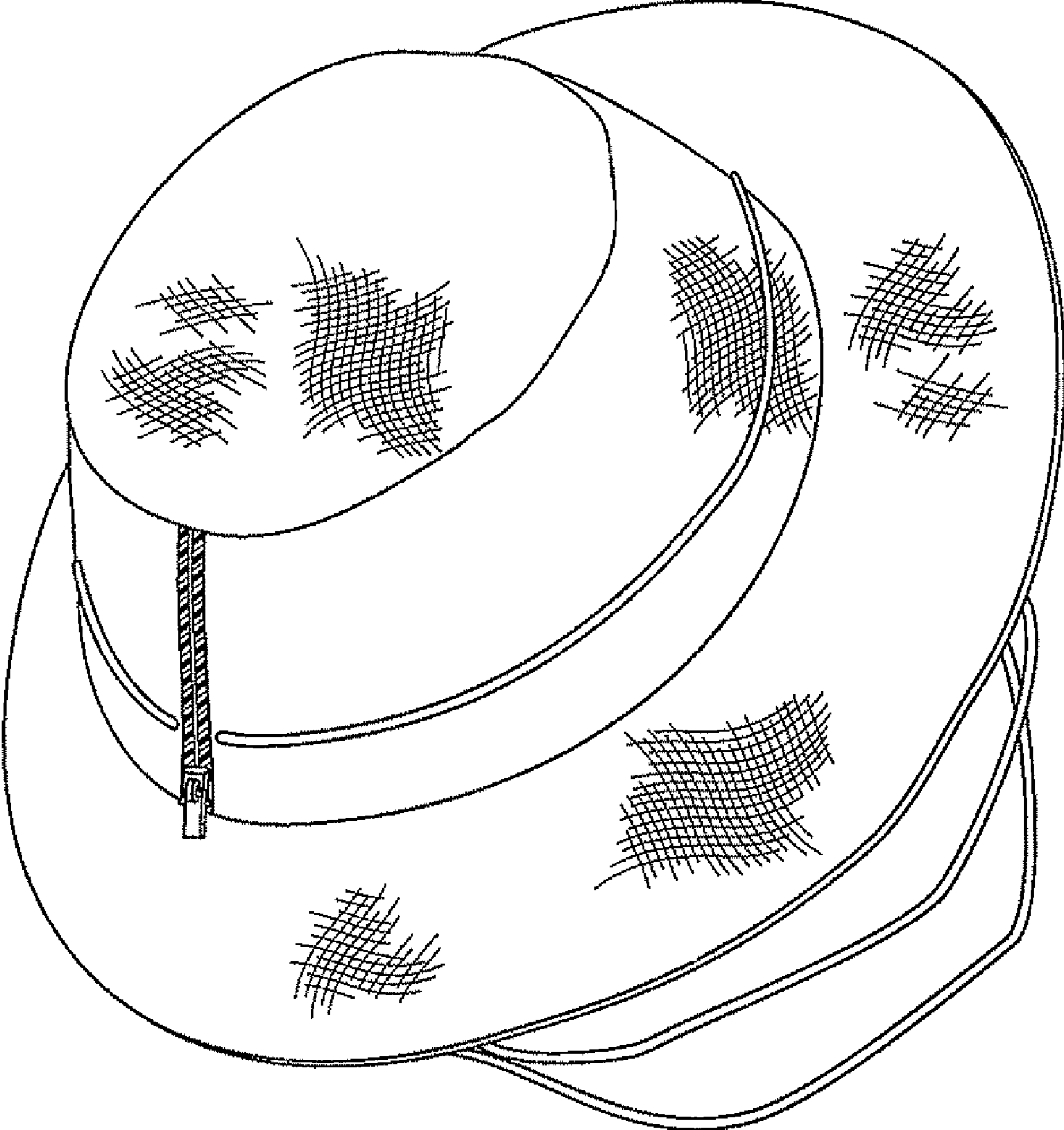

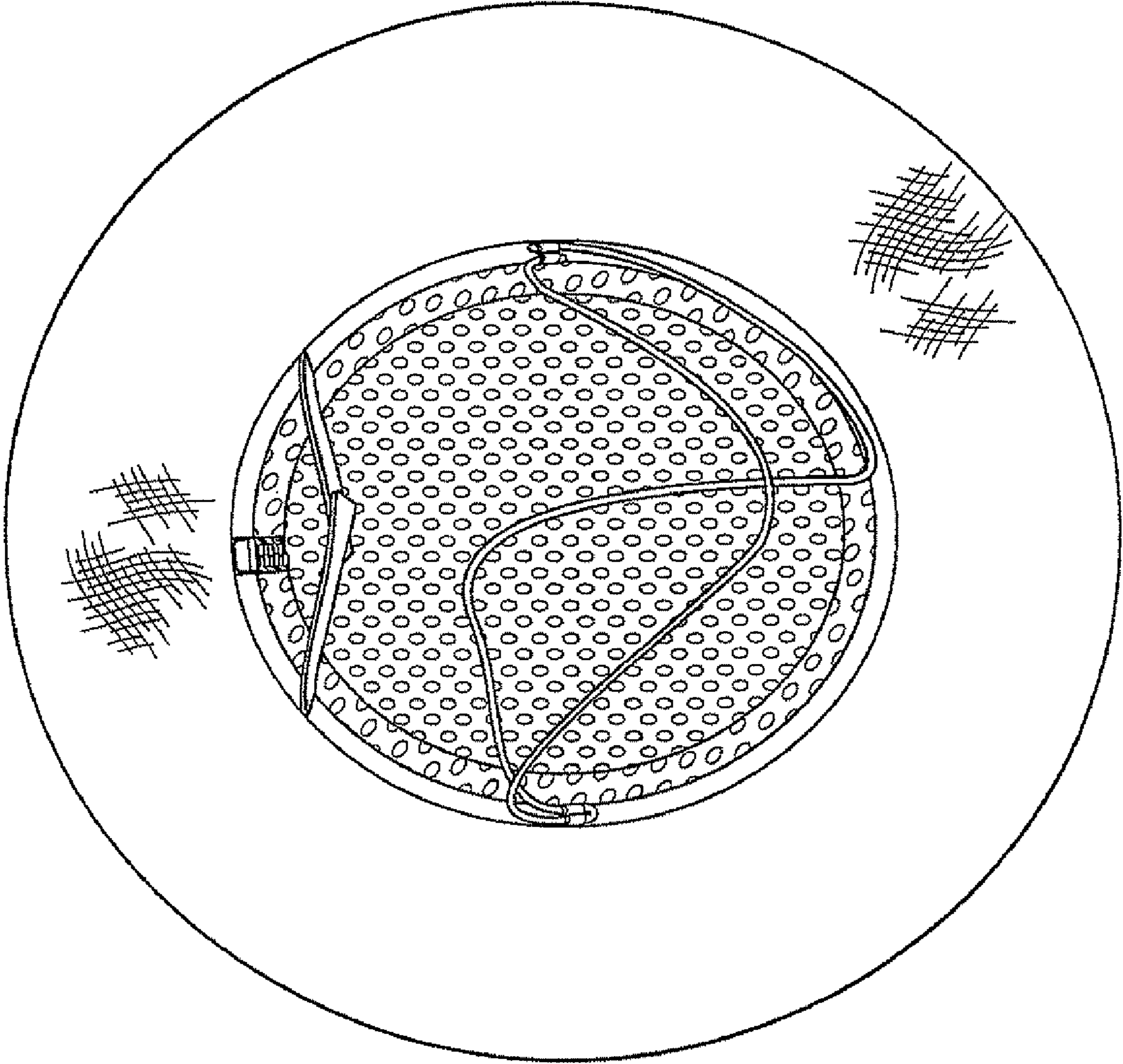

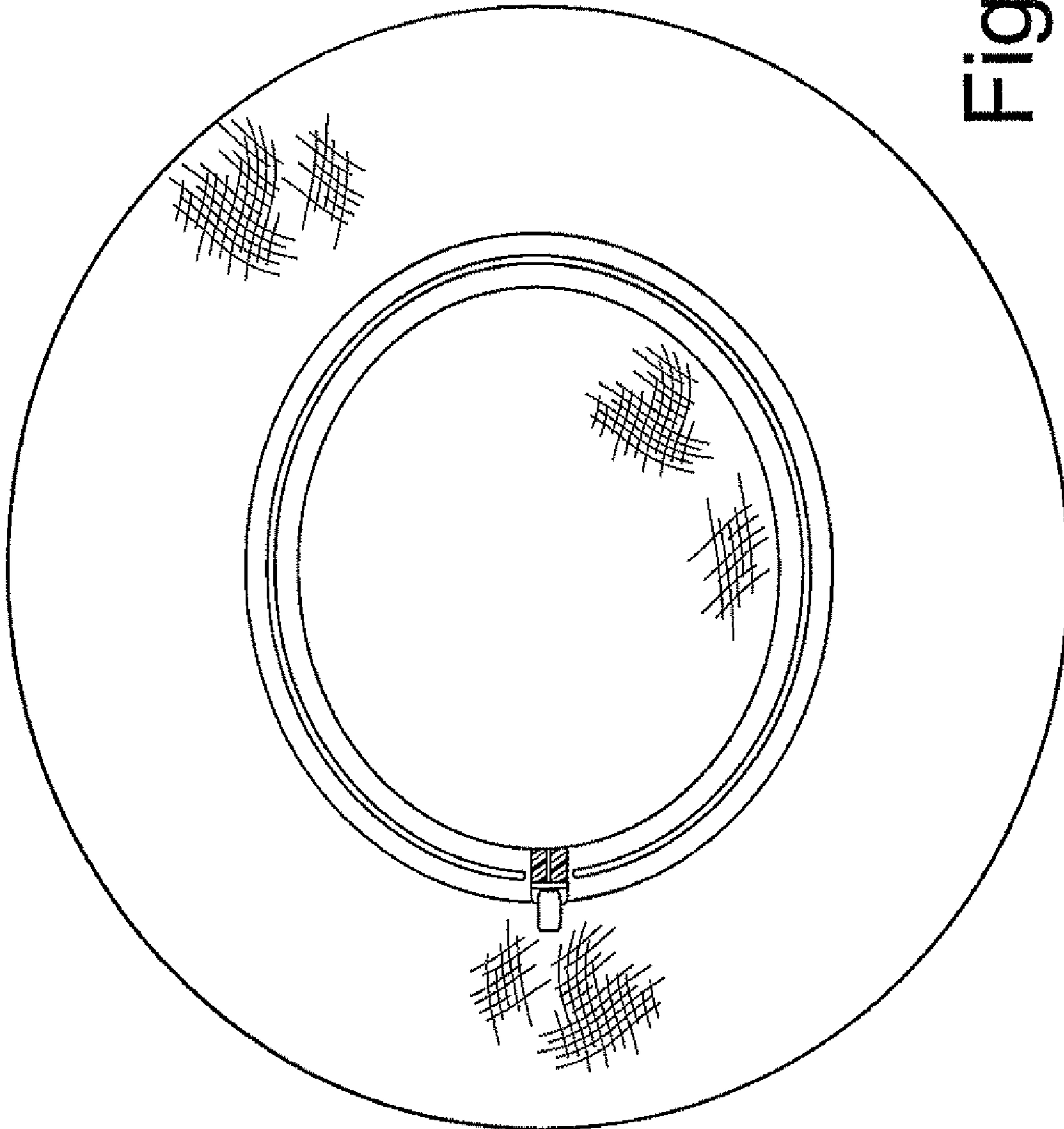

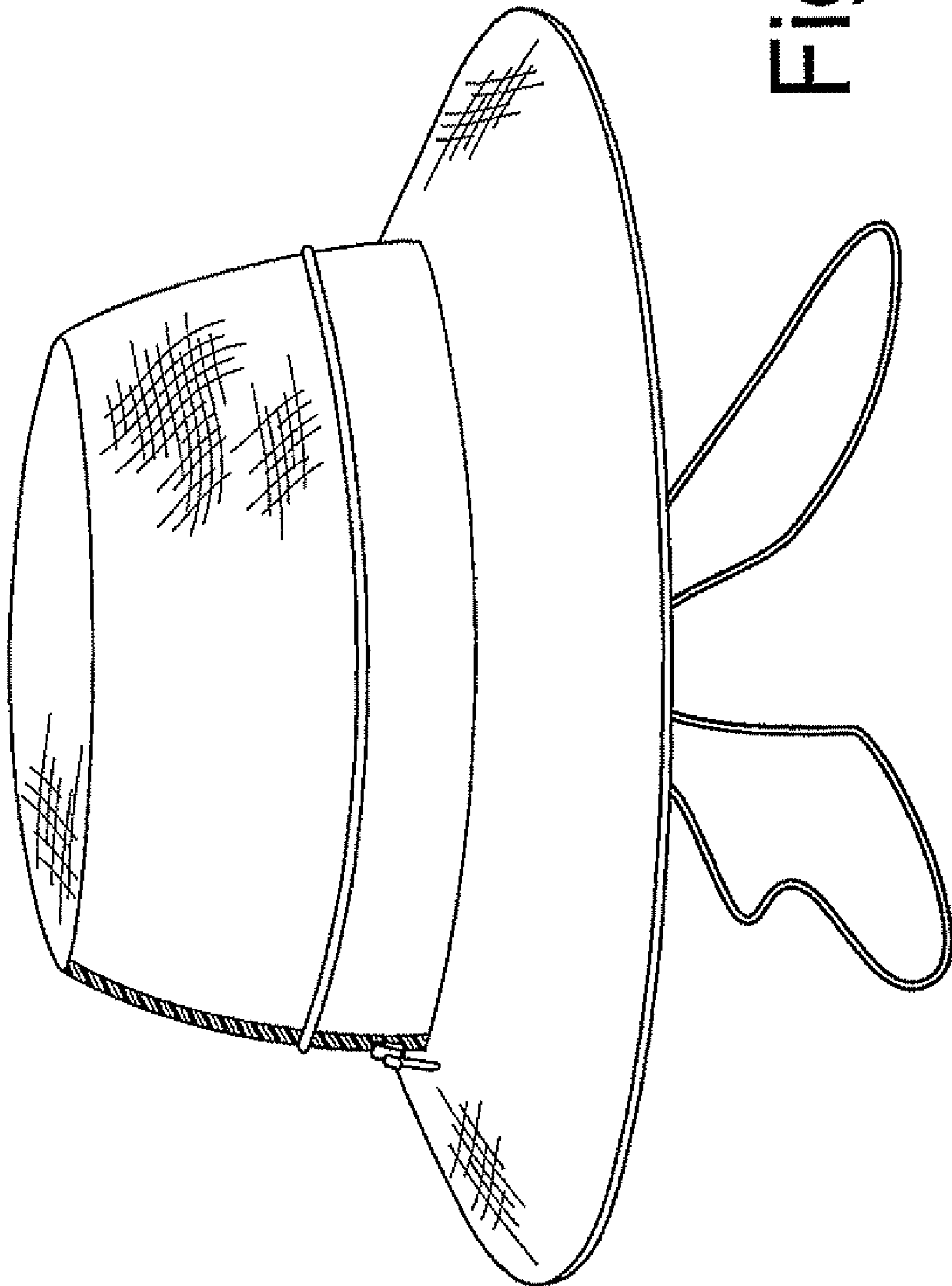

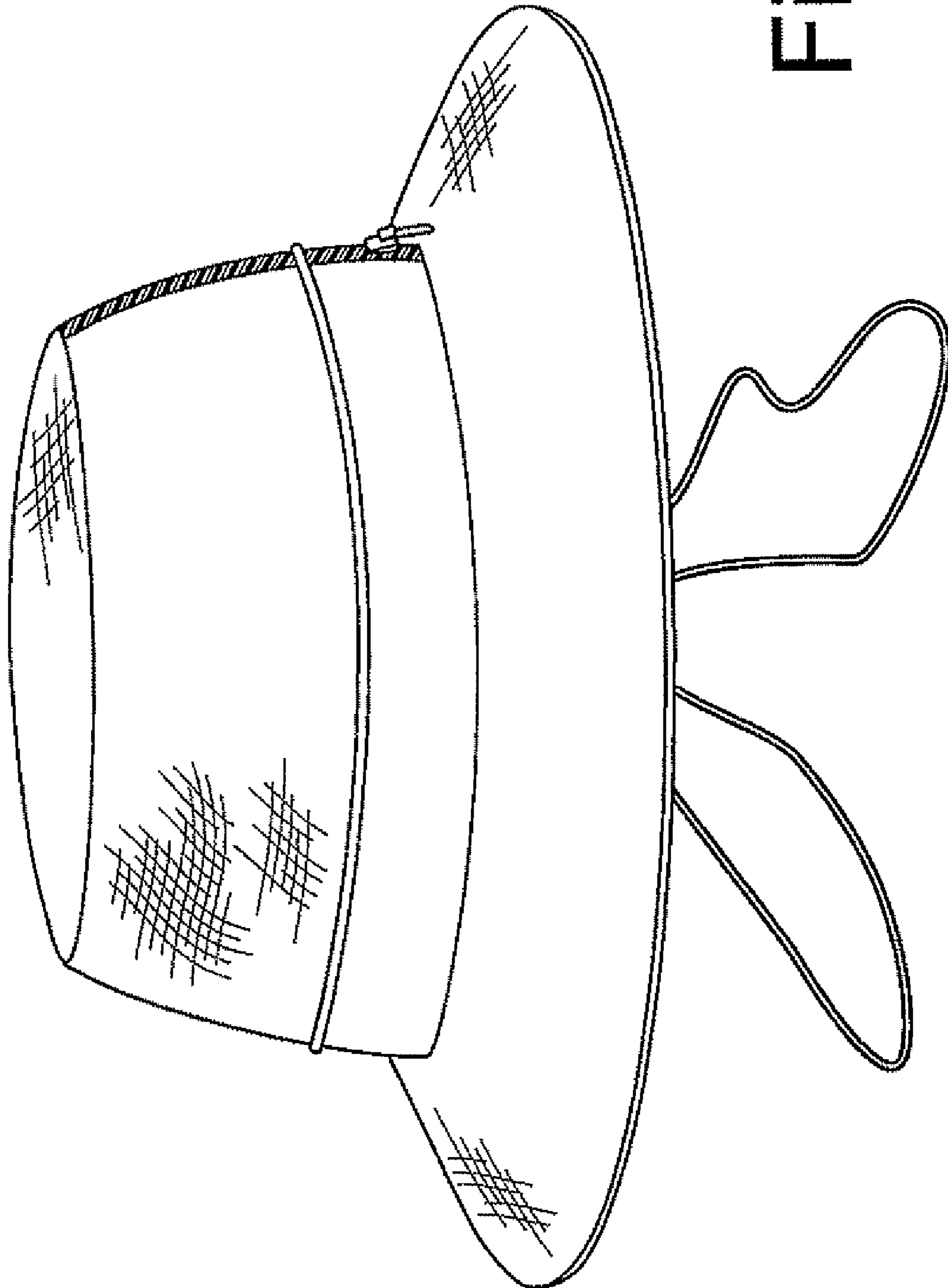

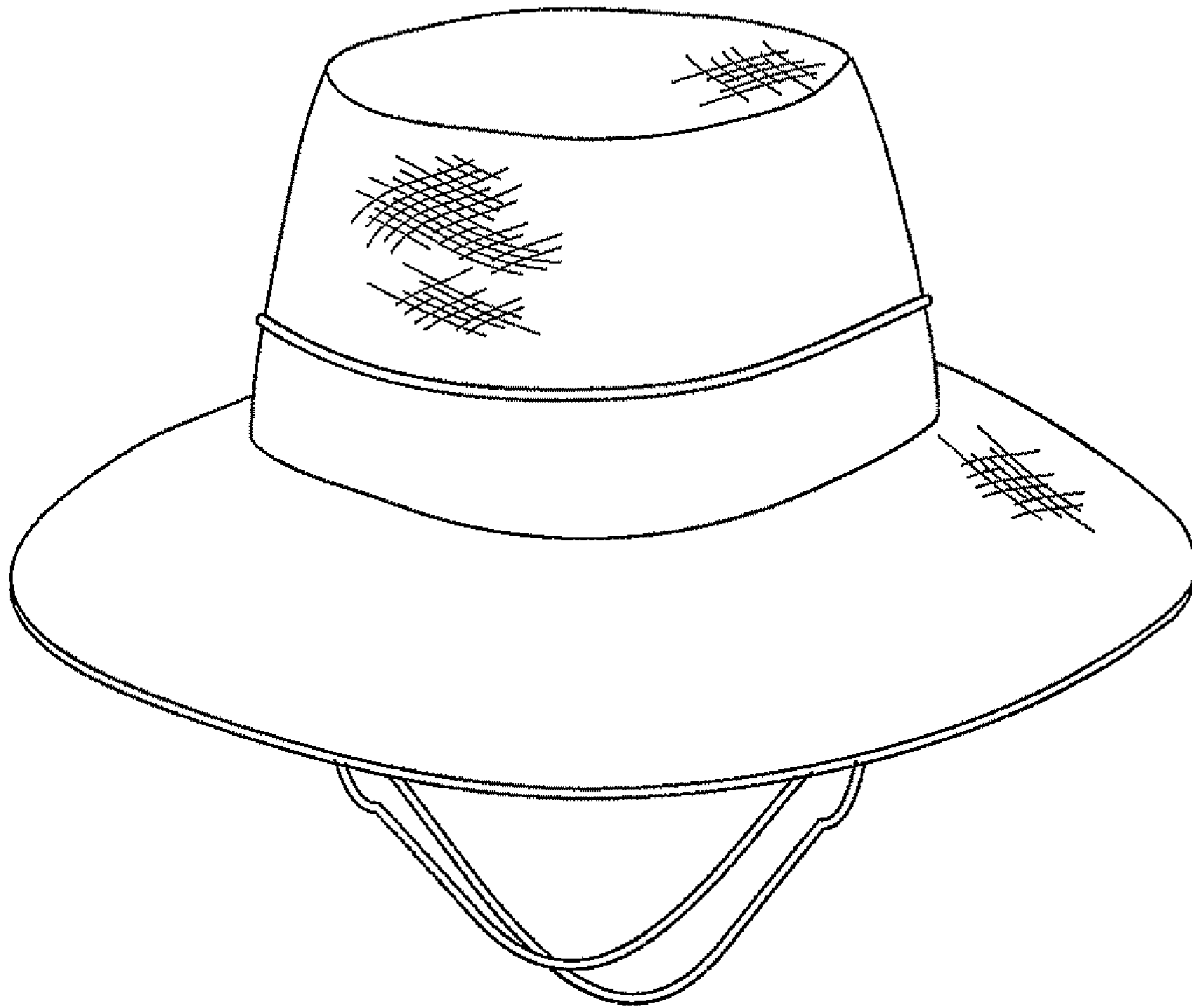

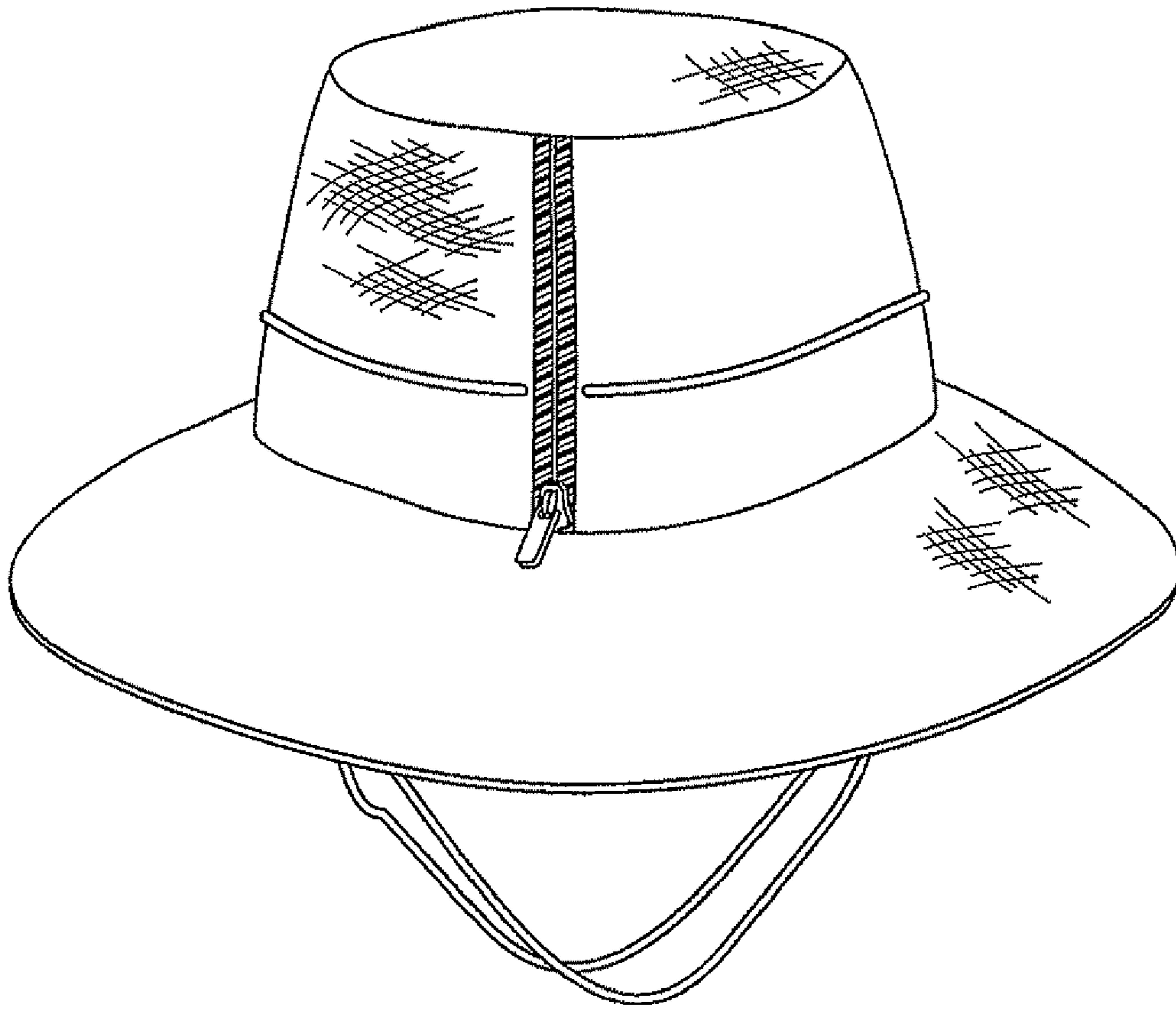

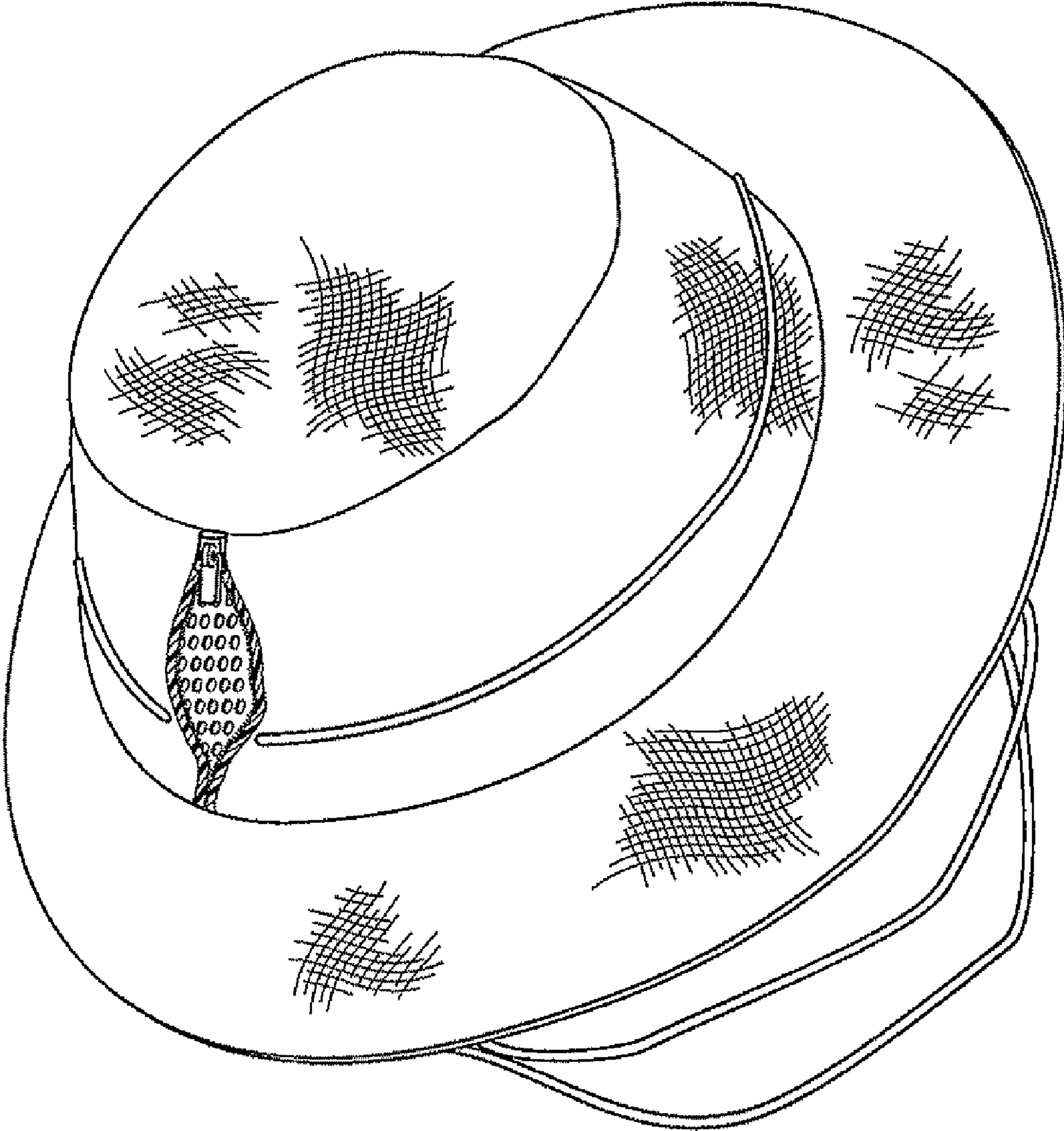
