(57) **CLAIM**

The ornamental design for a pair of footwear soles, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a bottom plan view of the right component of a pair of footwear soles embodying our new design; the left component being a mirror image of FIGS. 1-5;

FIG. 2 is a left side view thereof;

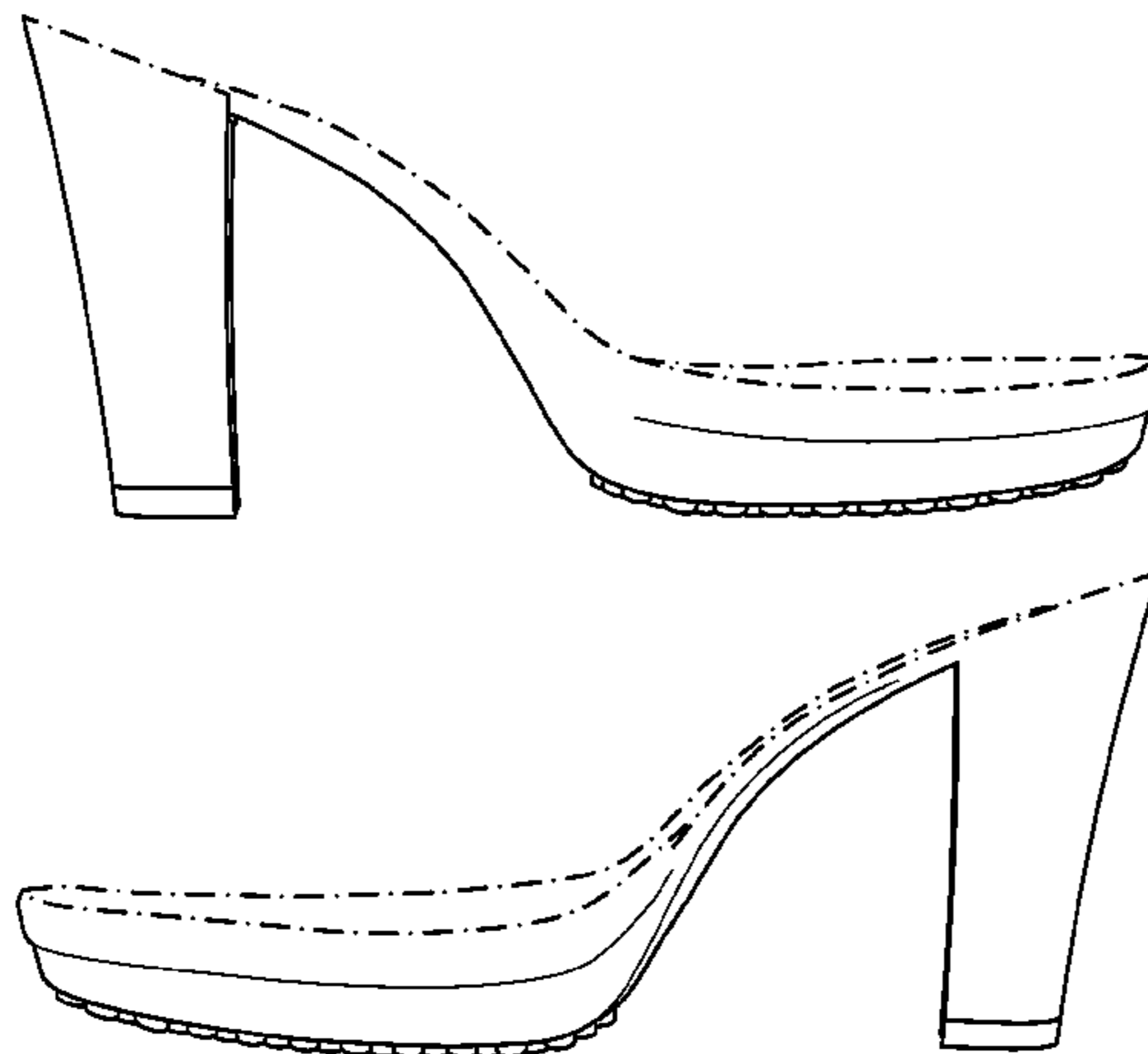
FIG. 3 is a right side view thereof;

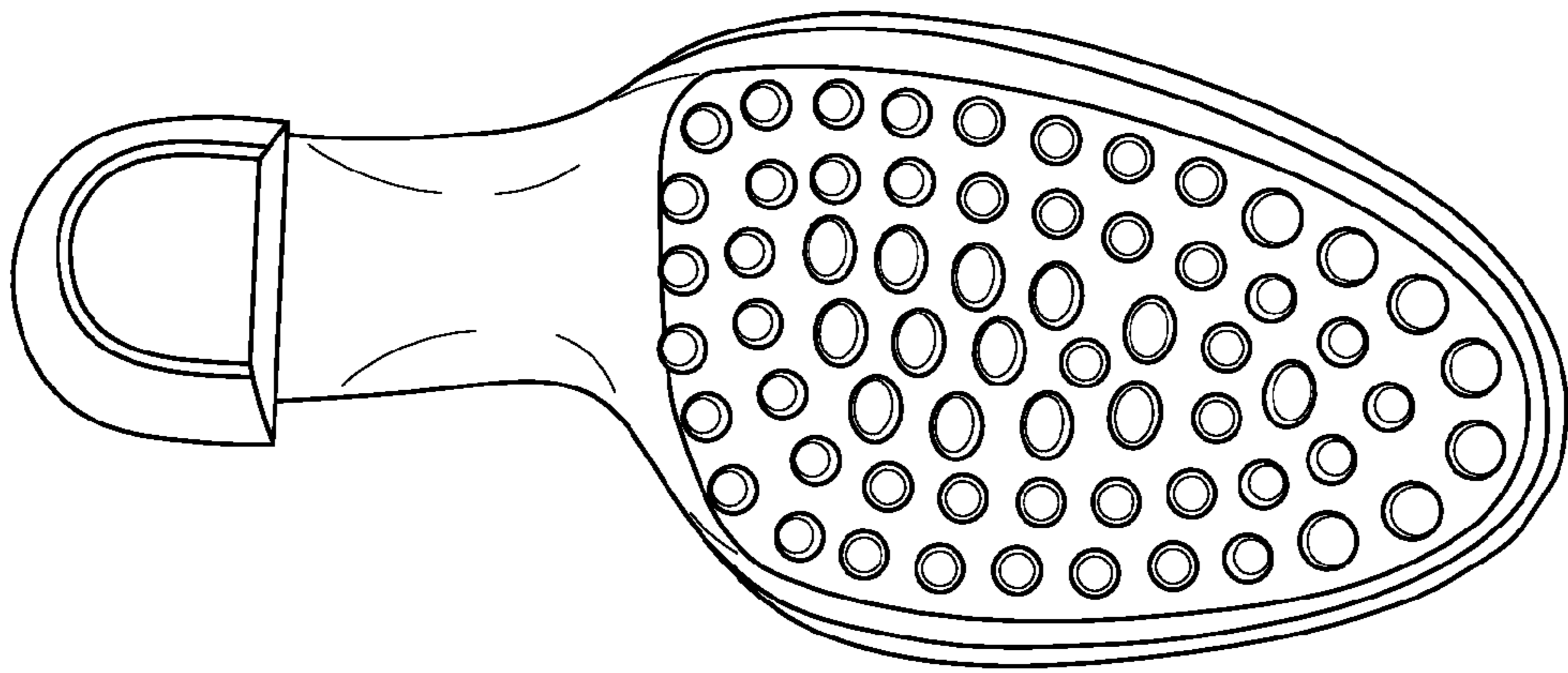
FIG. 4 is a front view thereof; and,

FIG. 5 is a rear view thereof.

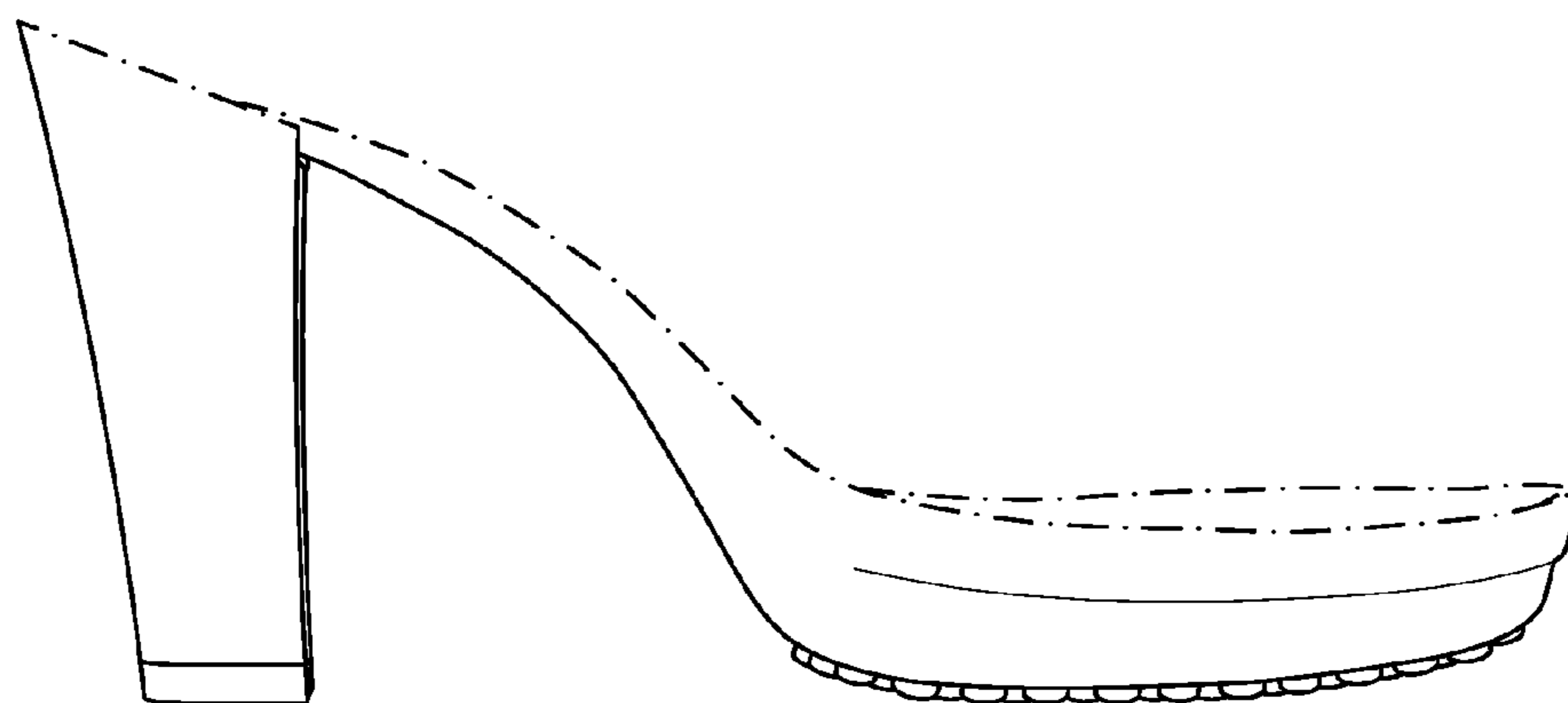
The broken dot-dash lines define the boundary of the design, with neither the lines nor the area within them forming any part of the claim.

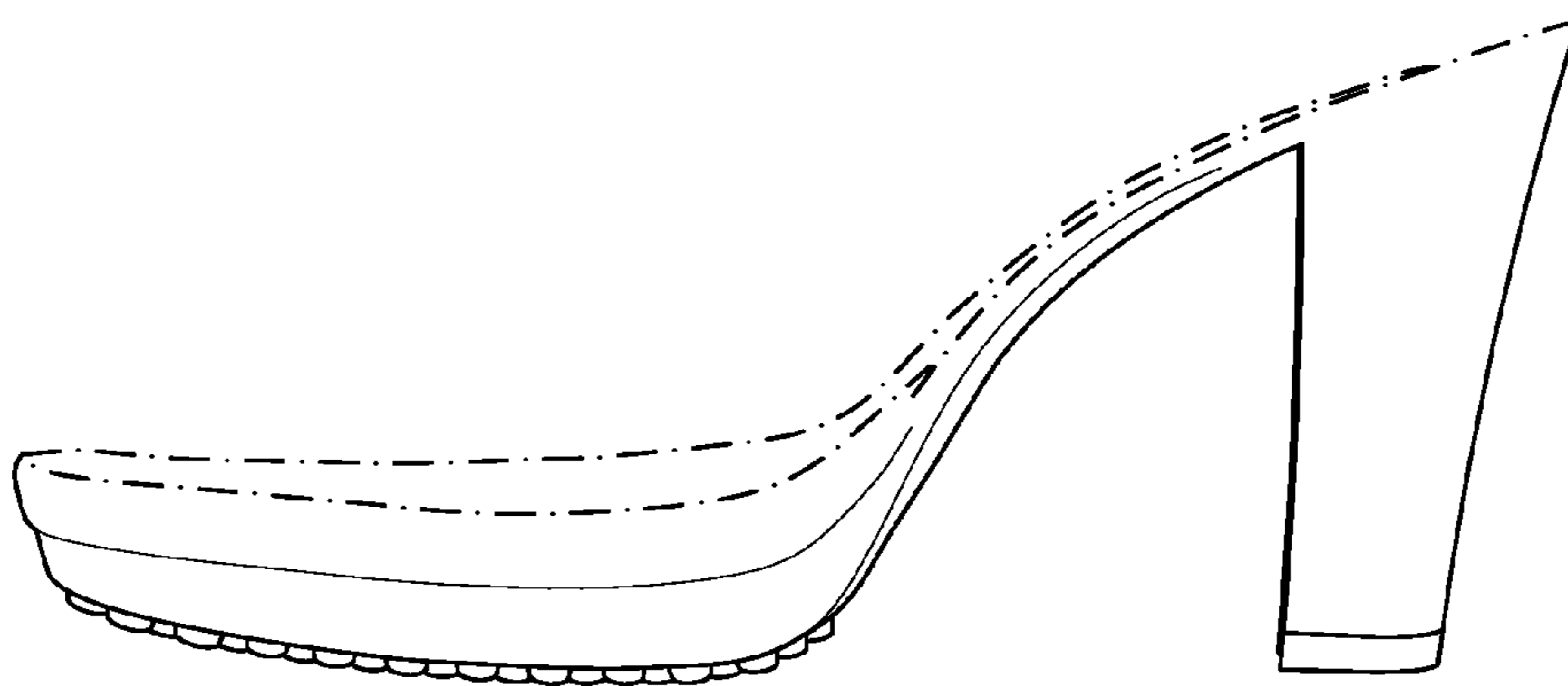




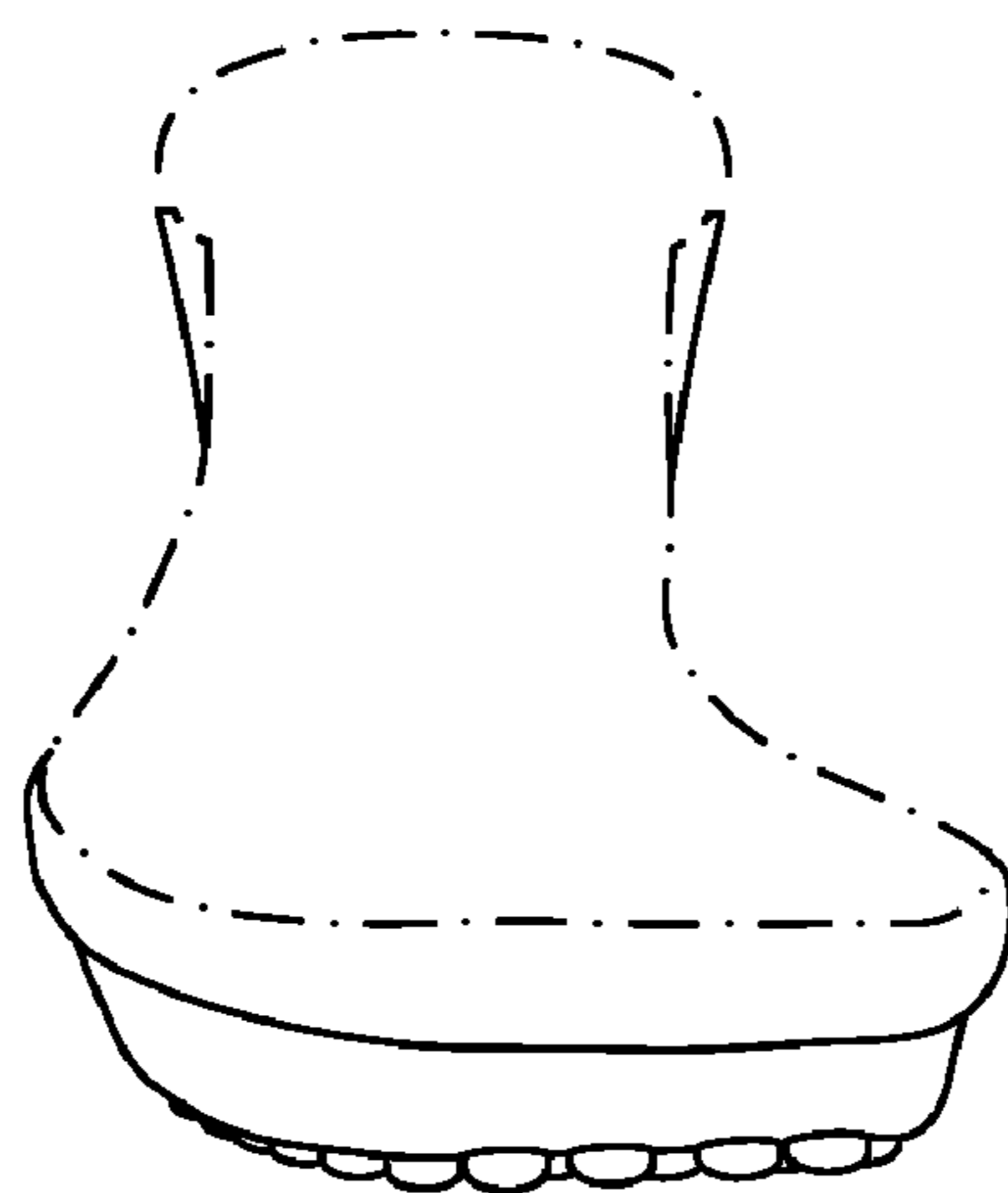

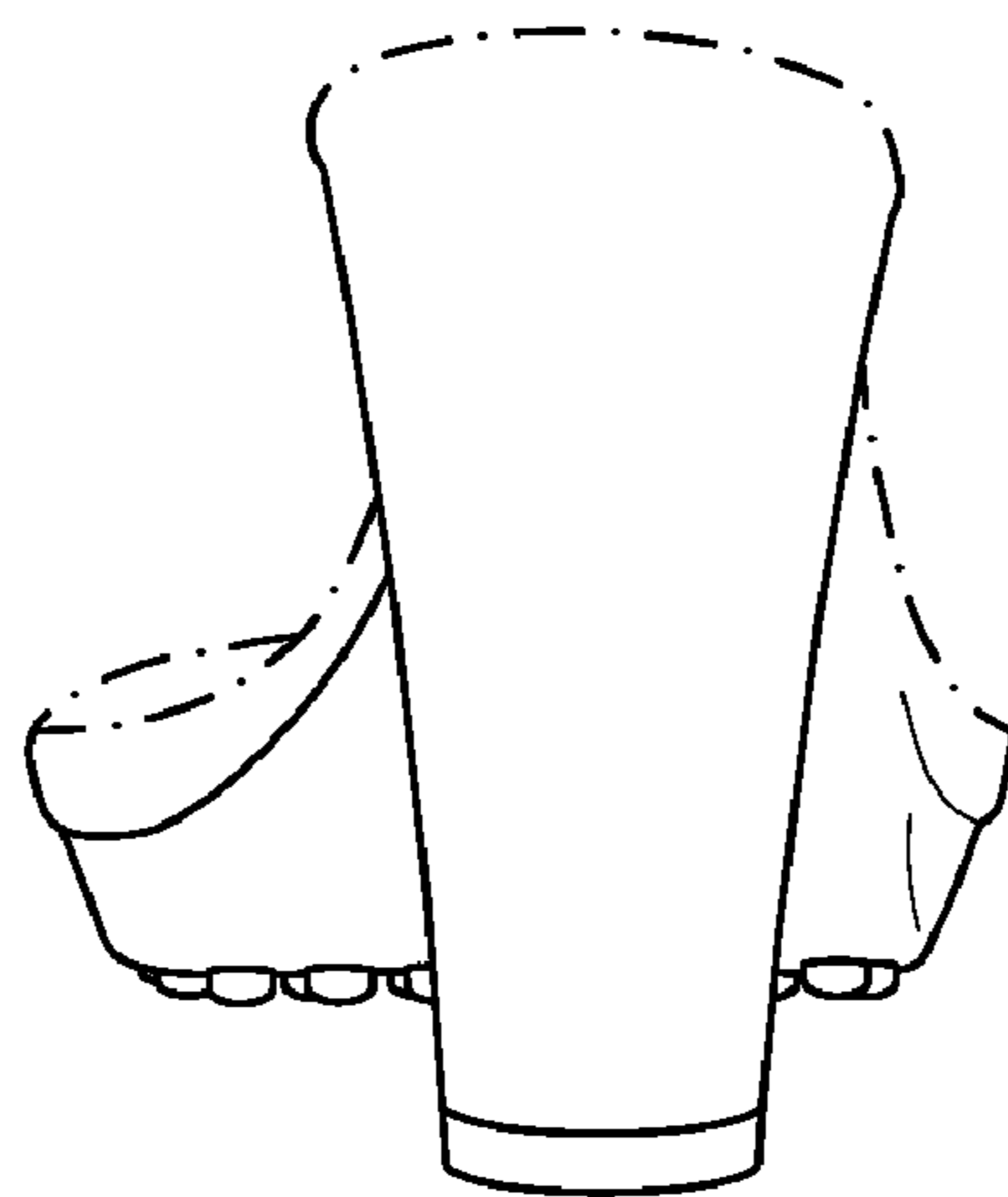
